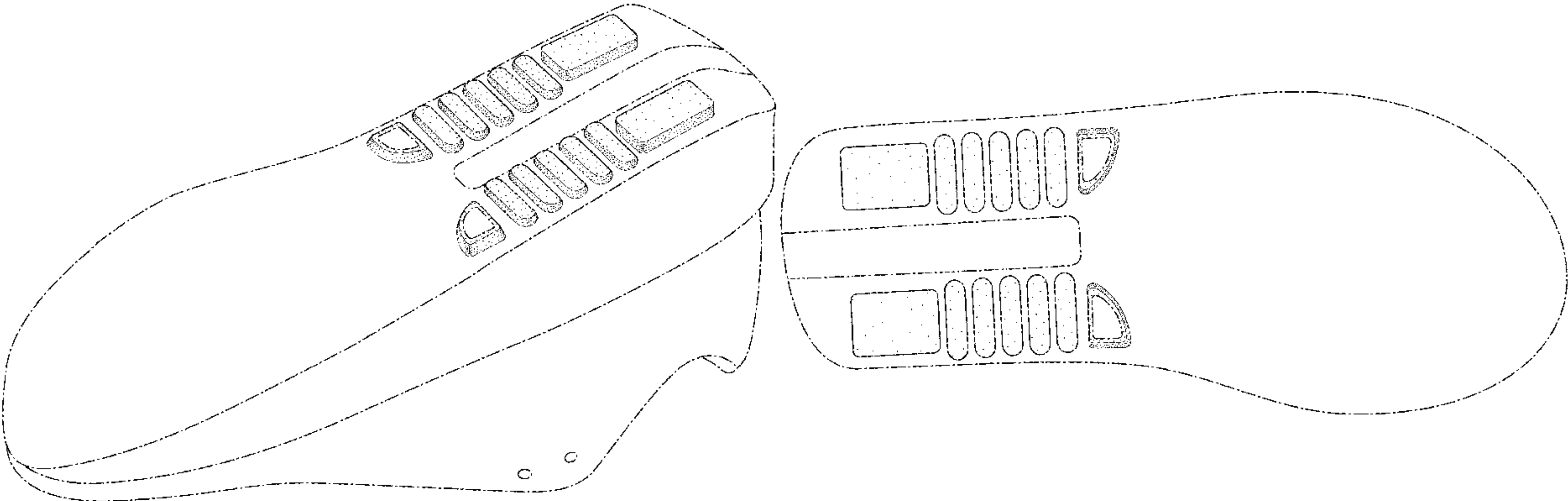
(57)CLAIM

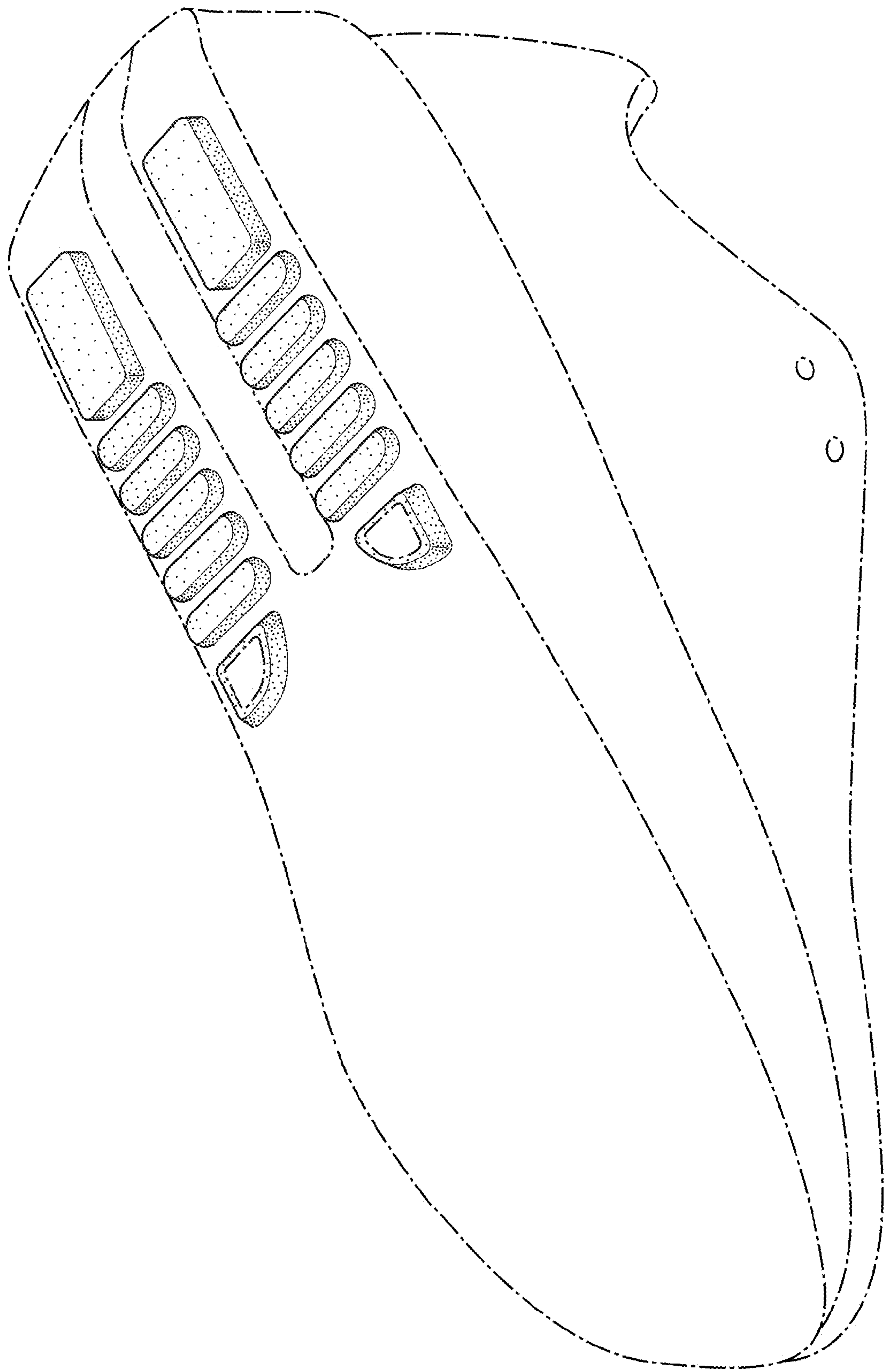

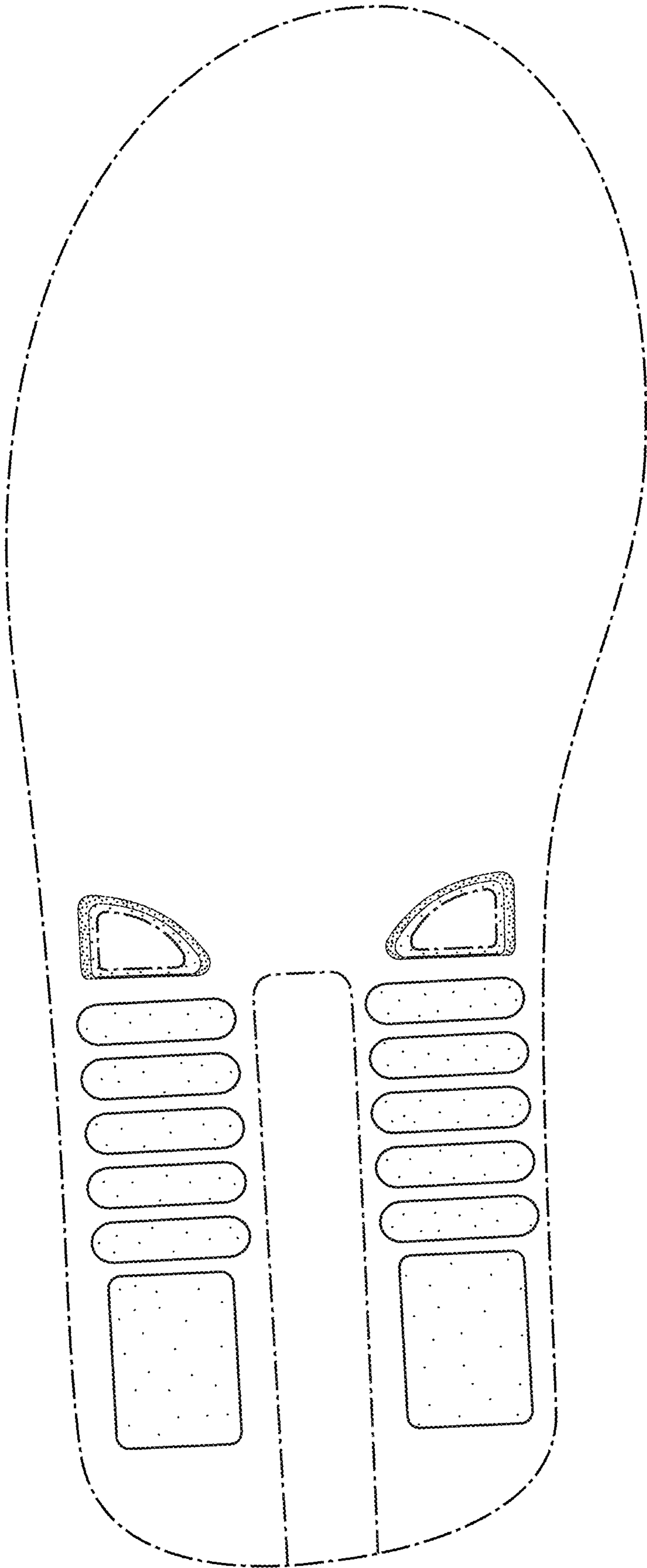

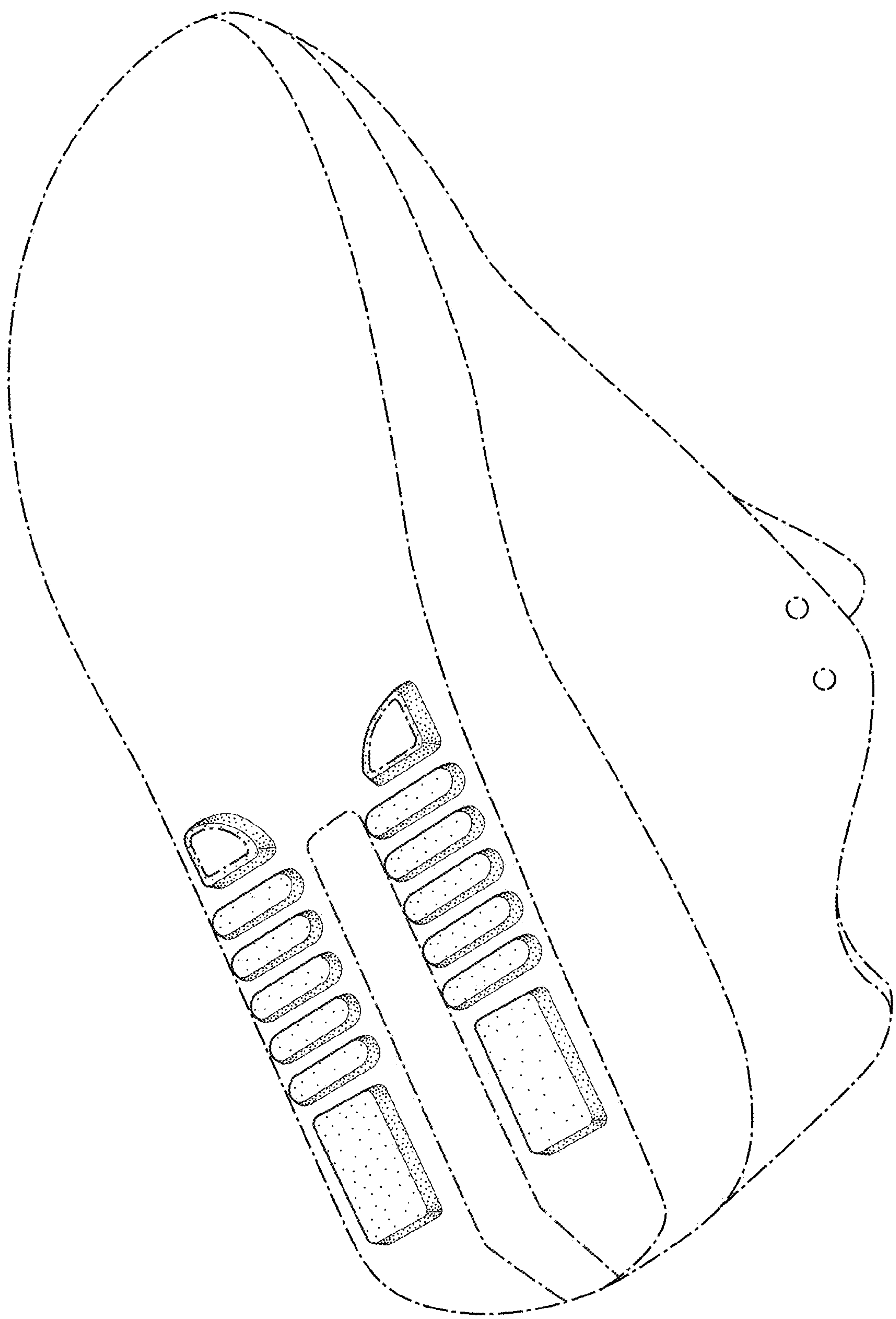
