FIG. 1 is a medial side view of a footwear sole. Portions of the footwear sole inside the dashed line form no part of the claimed design.

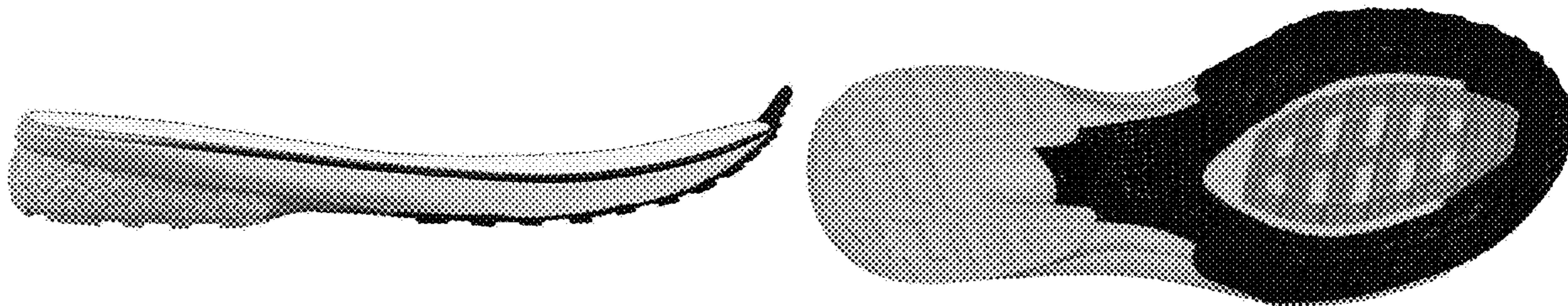
FIG. 2 is a lateral side view of the footwear sole of FIG. 1. Portions of the footwear sole inside the dashed line form no part of the claimed design.

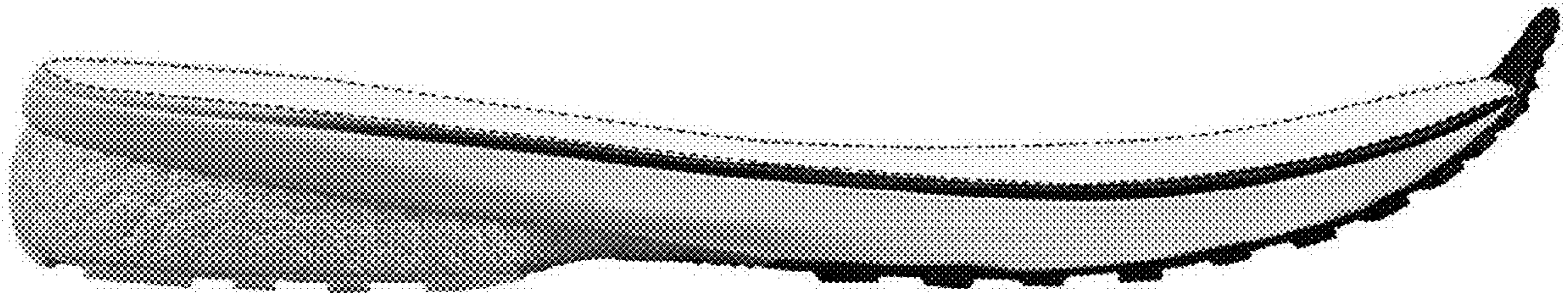

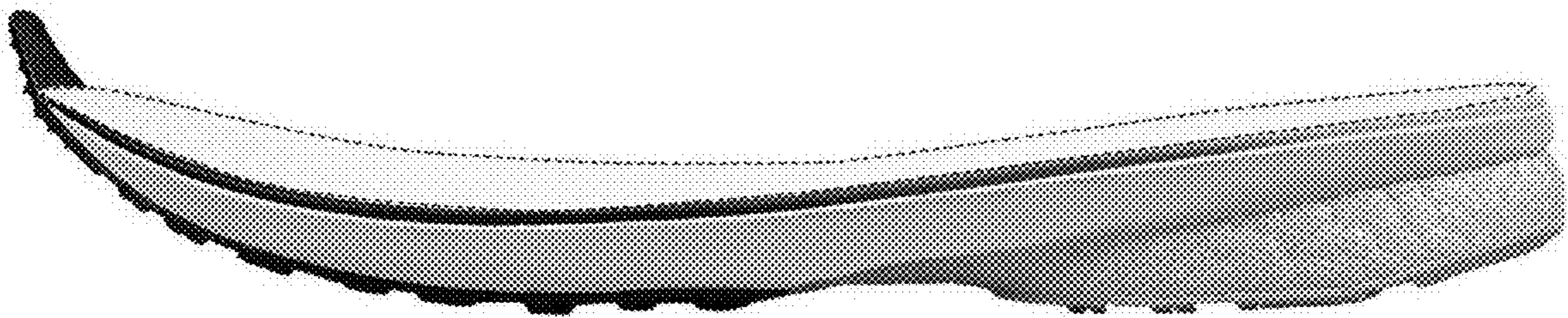

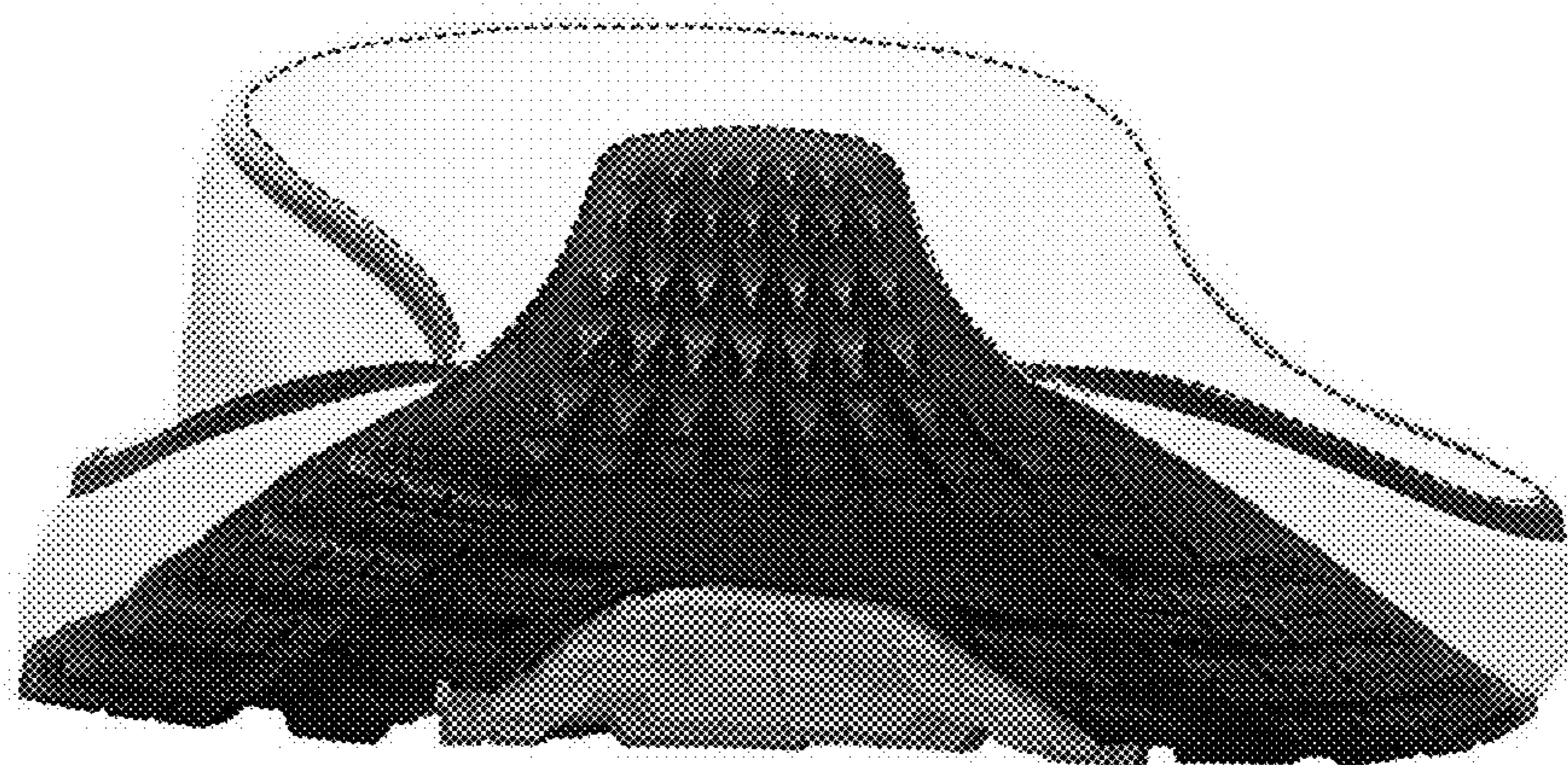

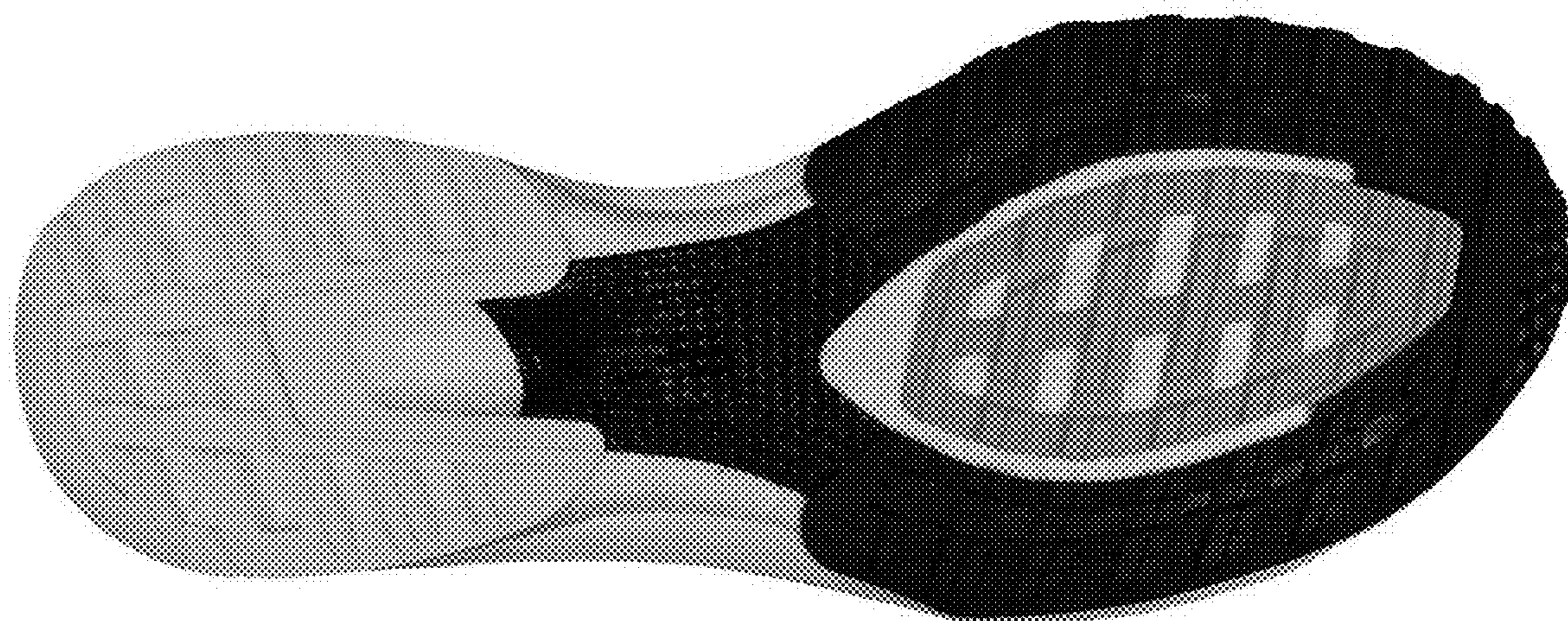
