DESCRIPTION

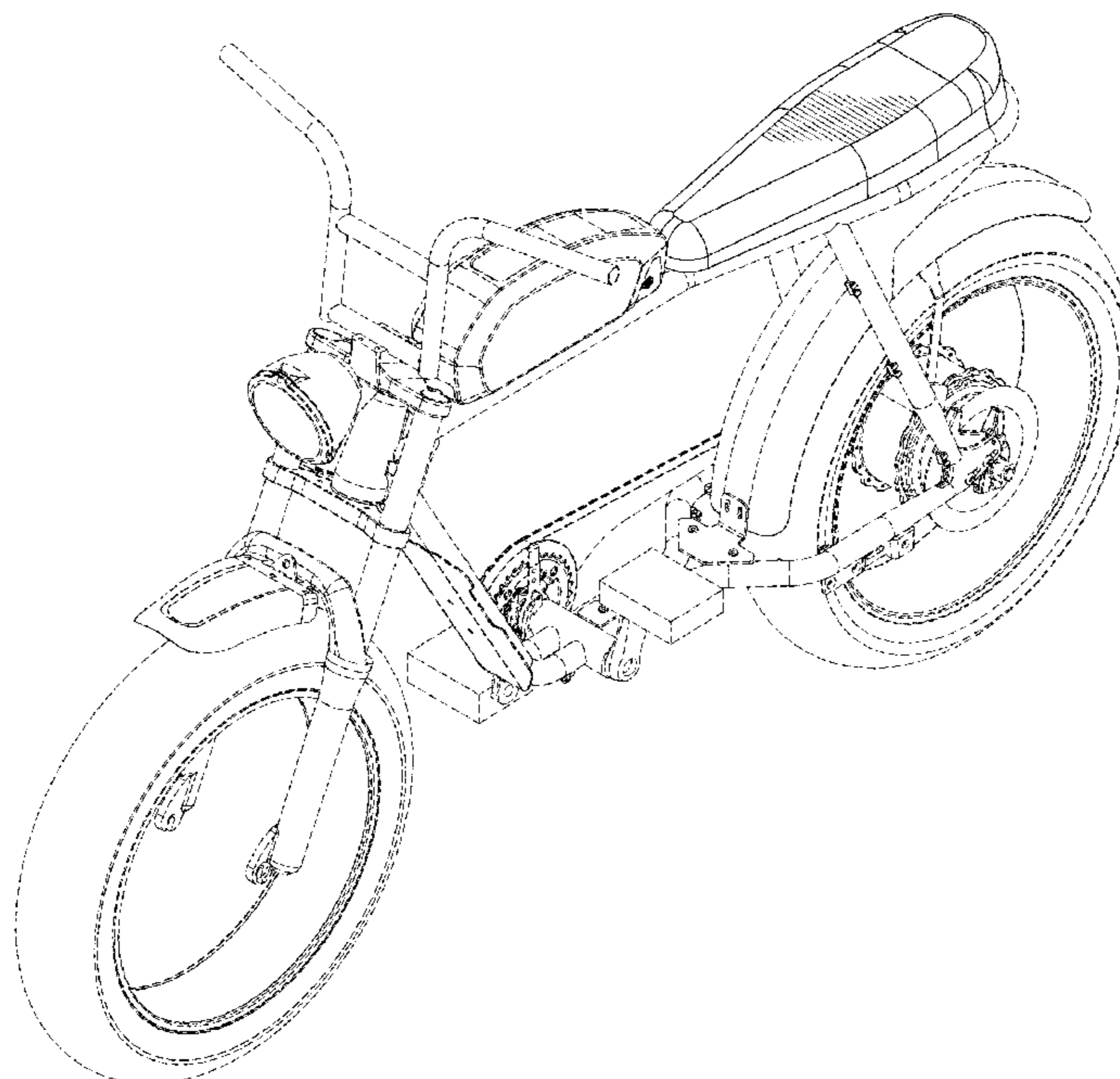

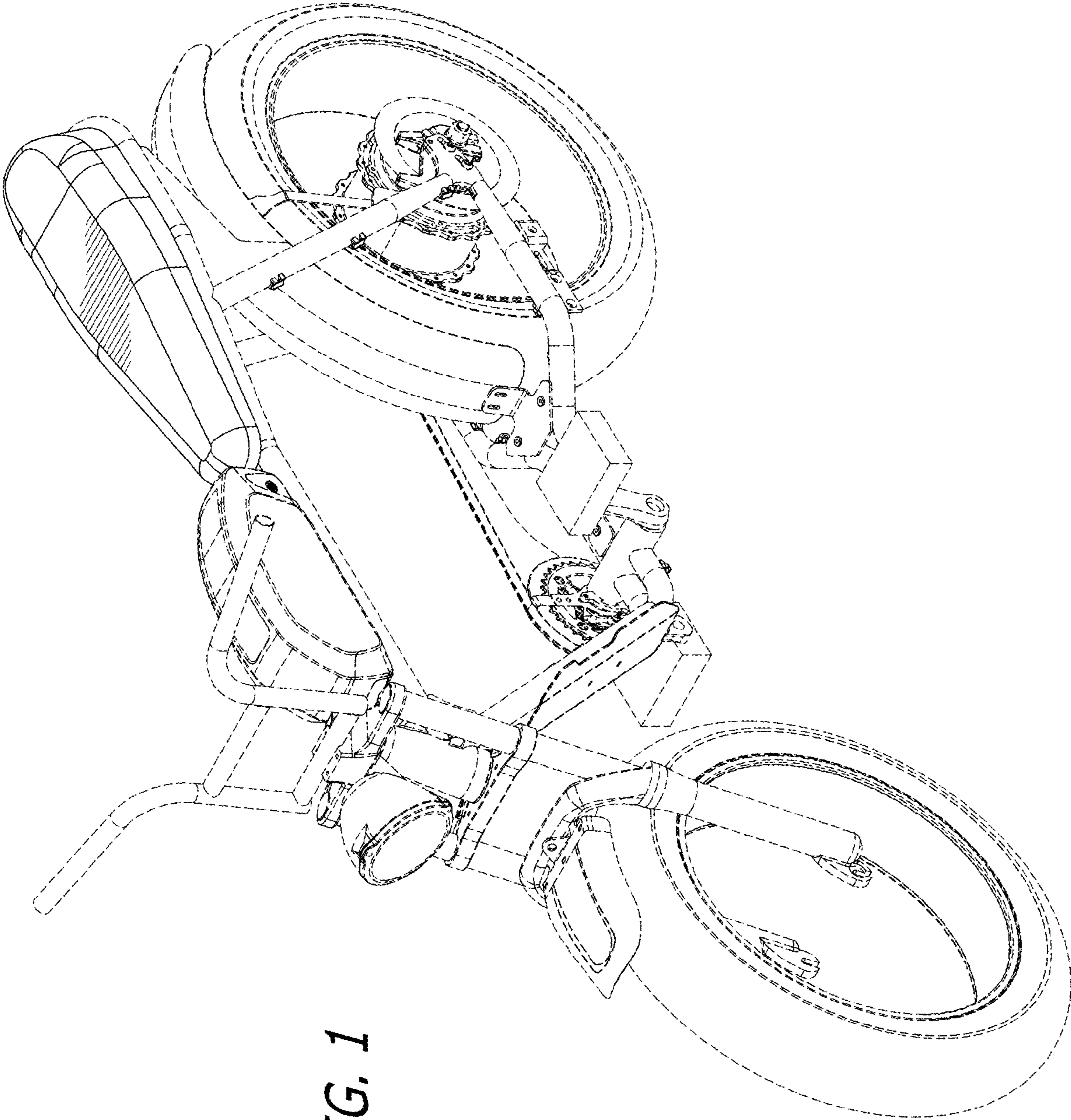

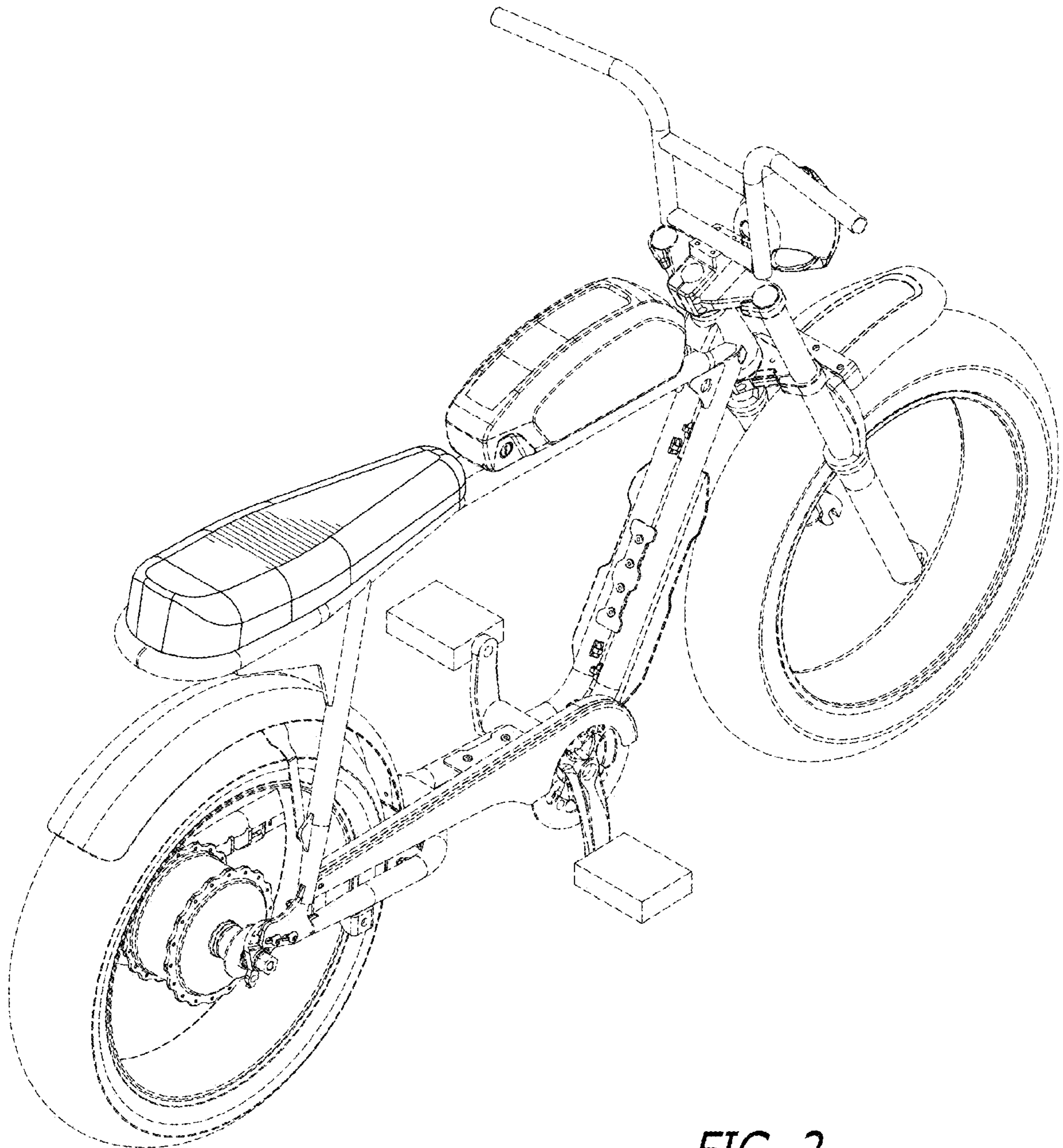

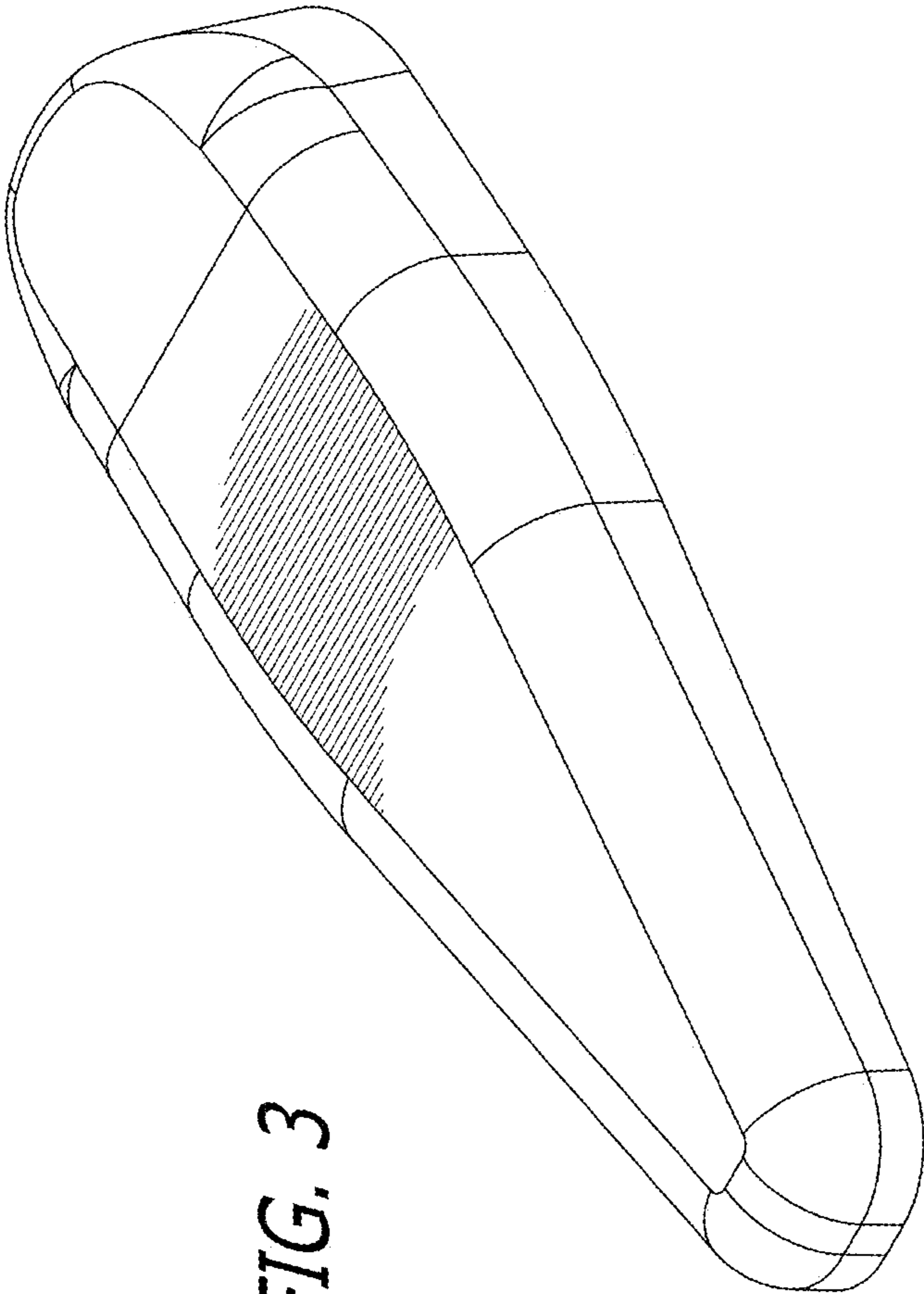

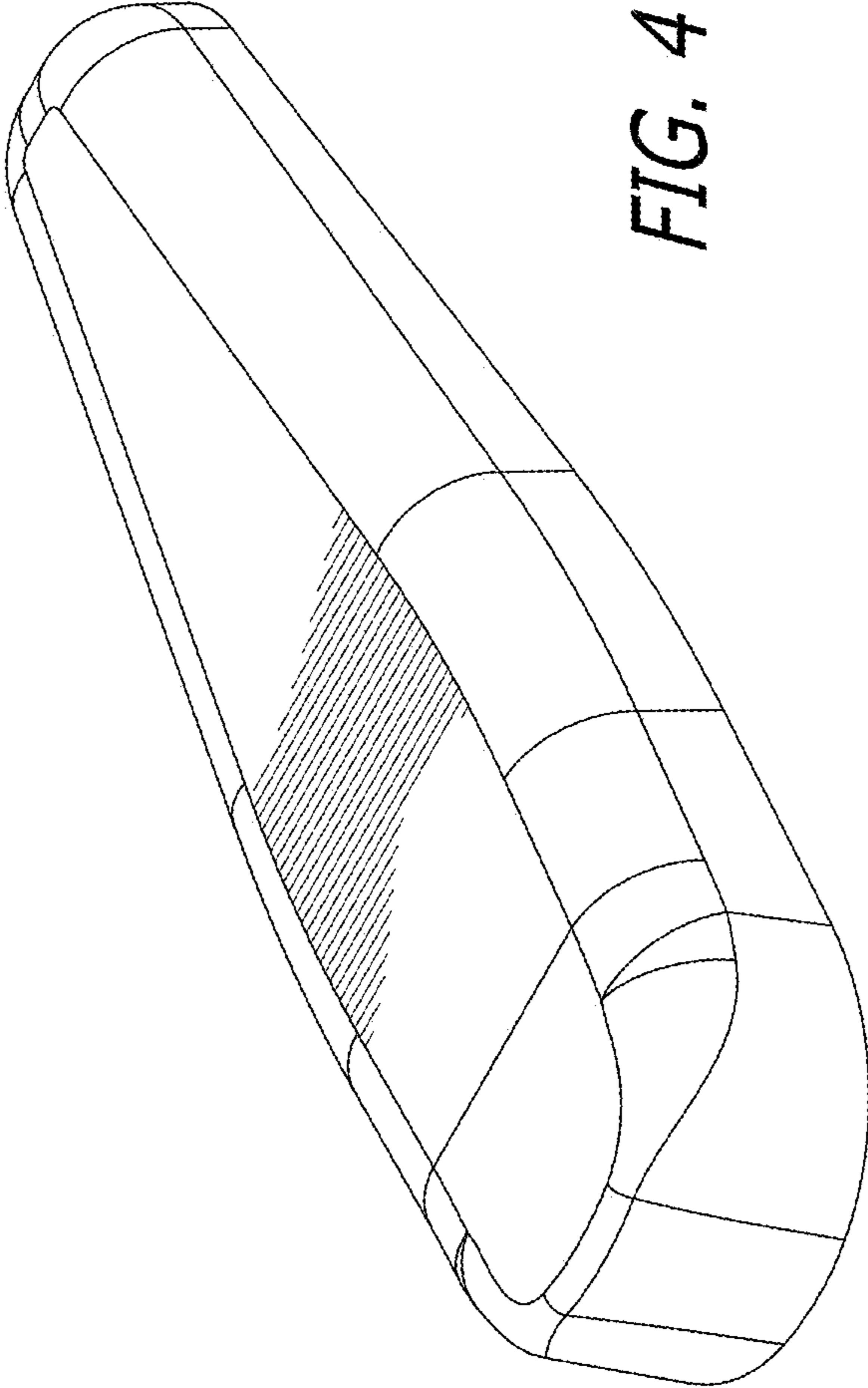

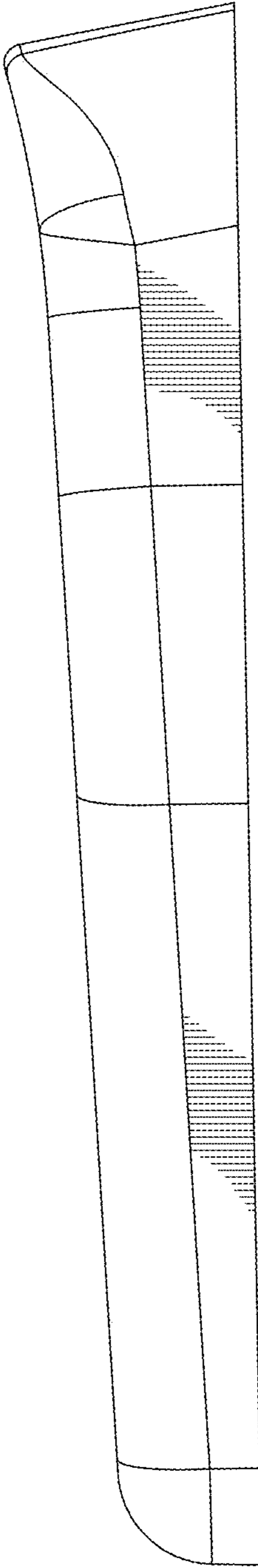

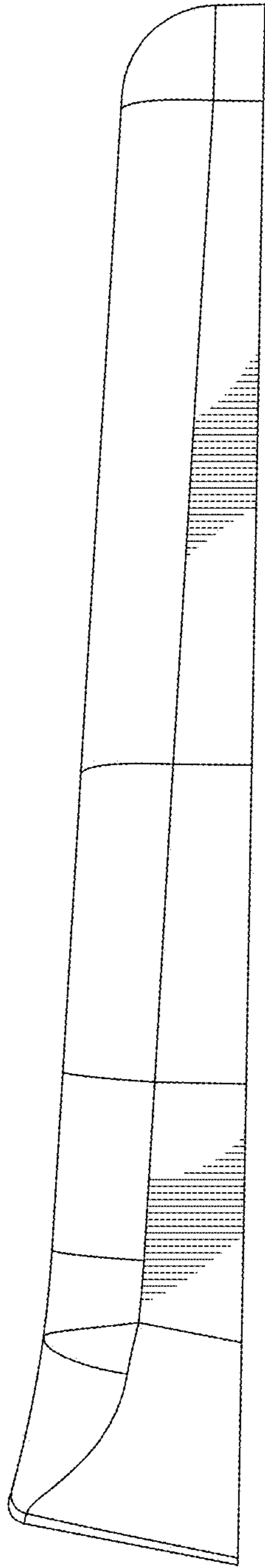

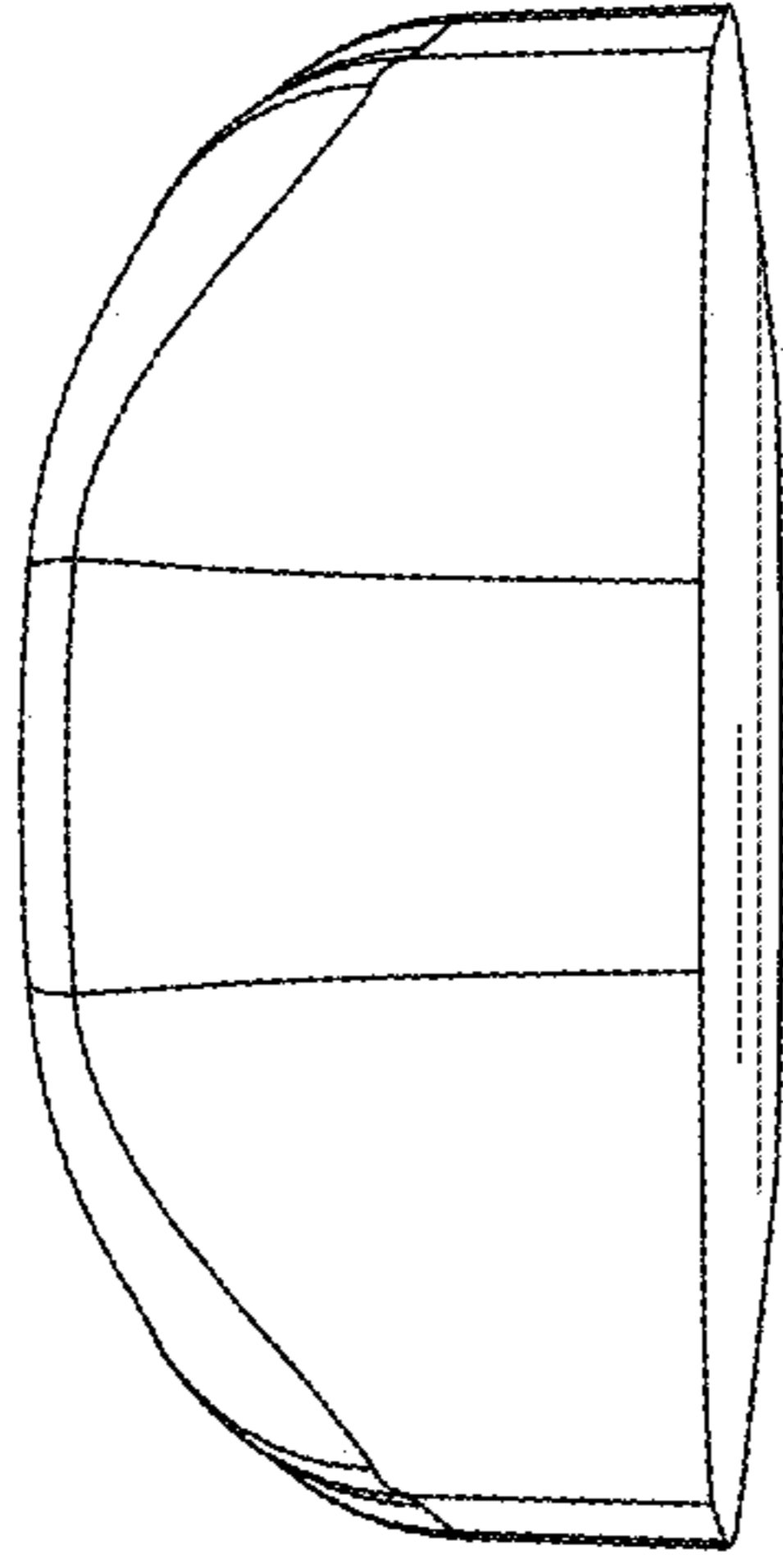

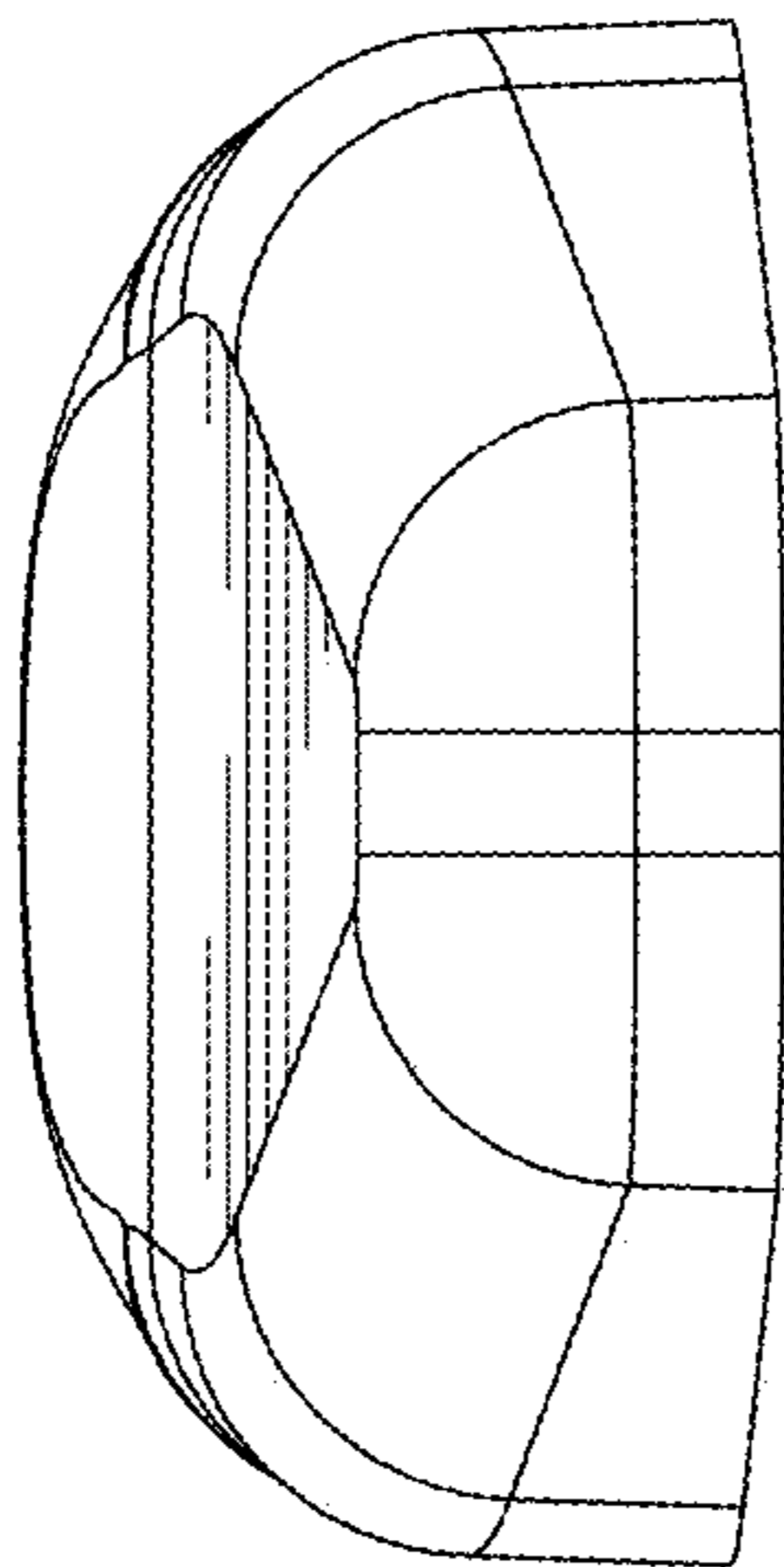

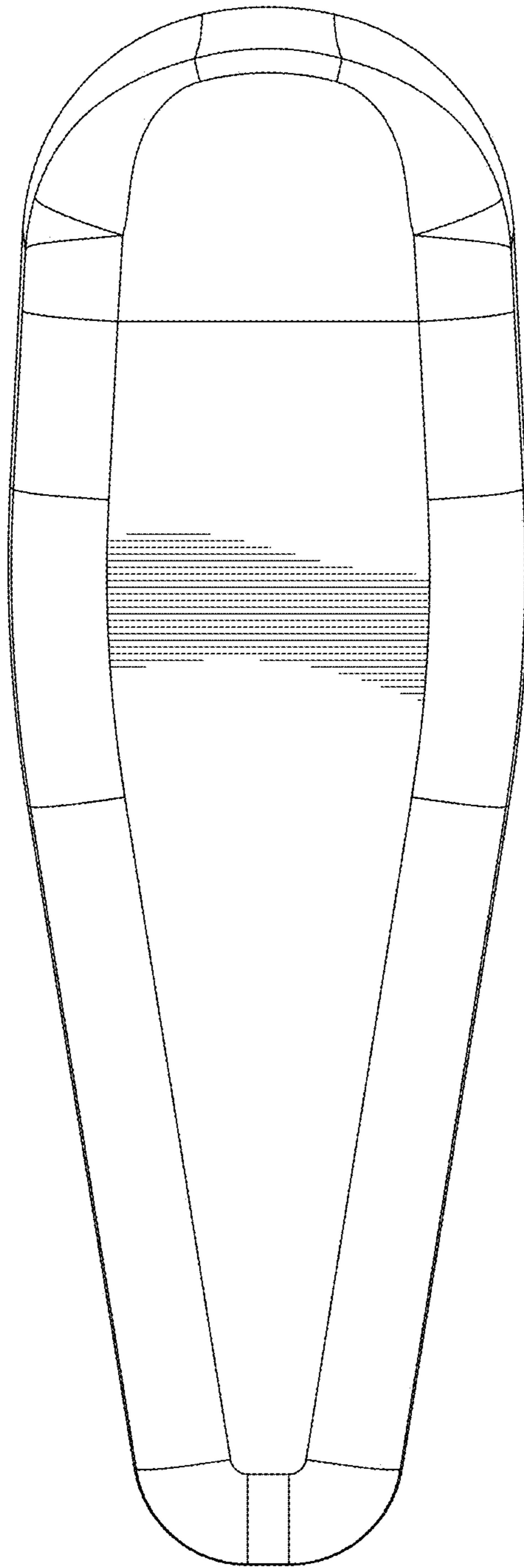

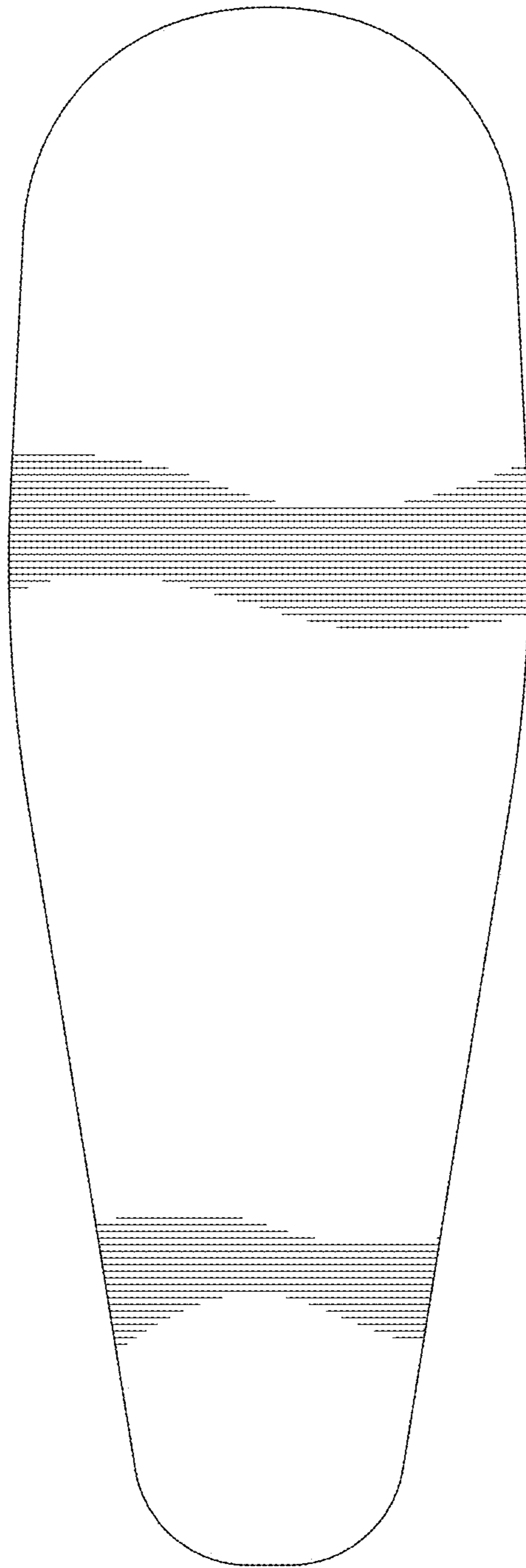
