The ornamental design for an exercise mat, as shown and described.

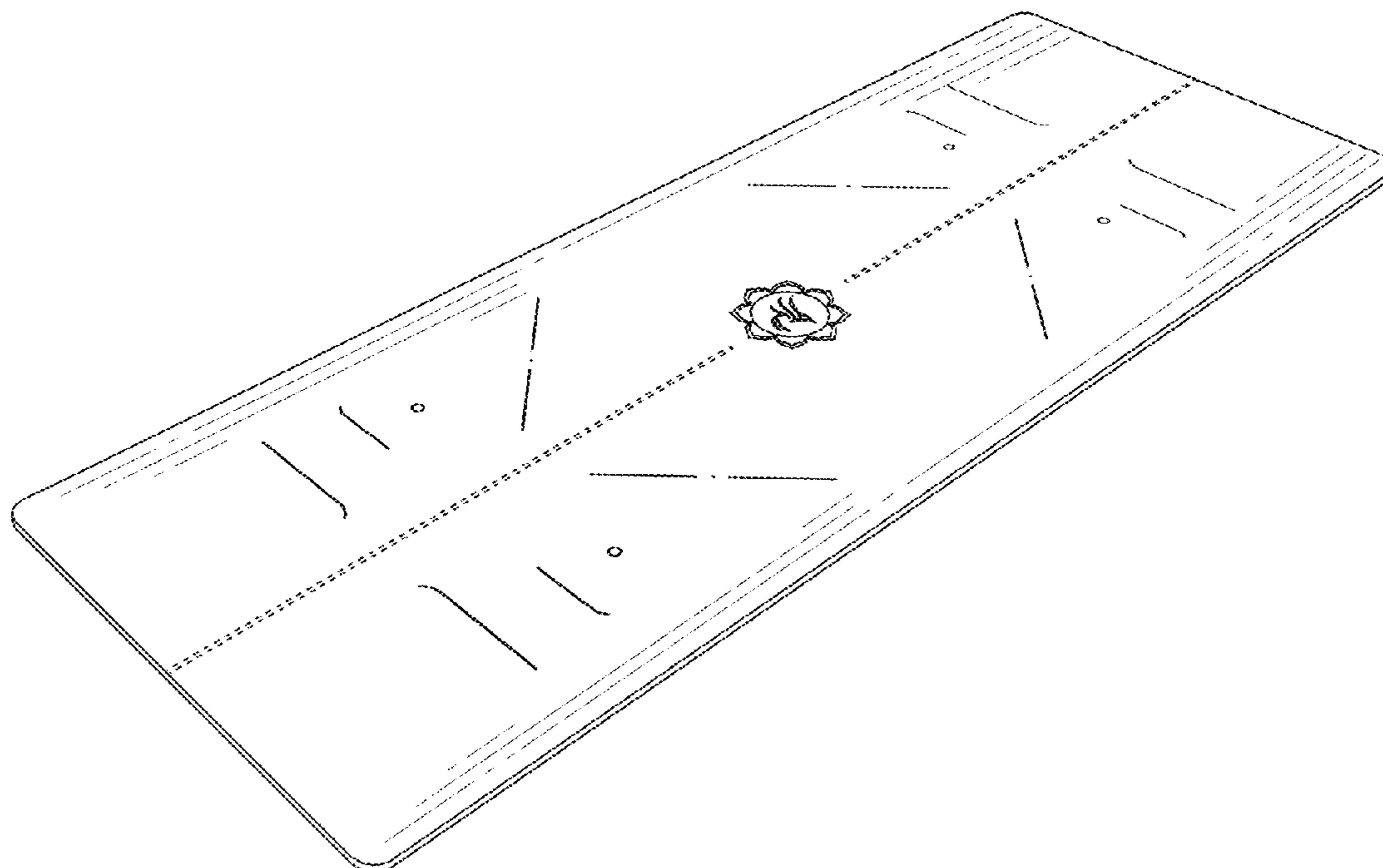
DESCRIPTION

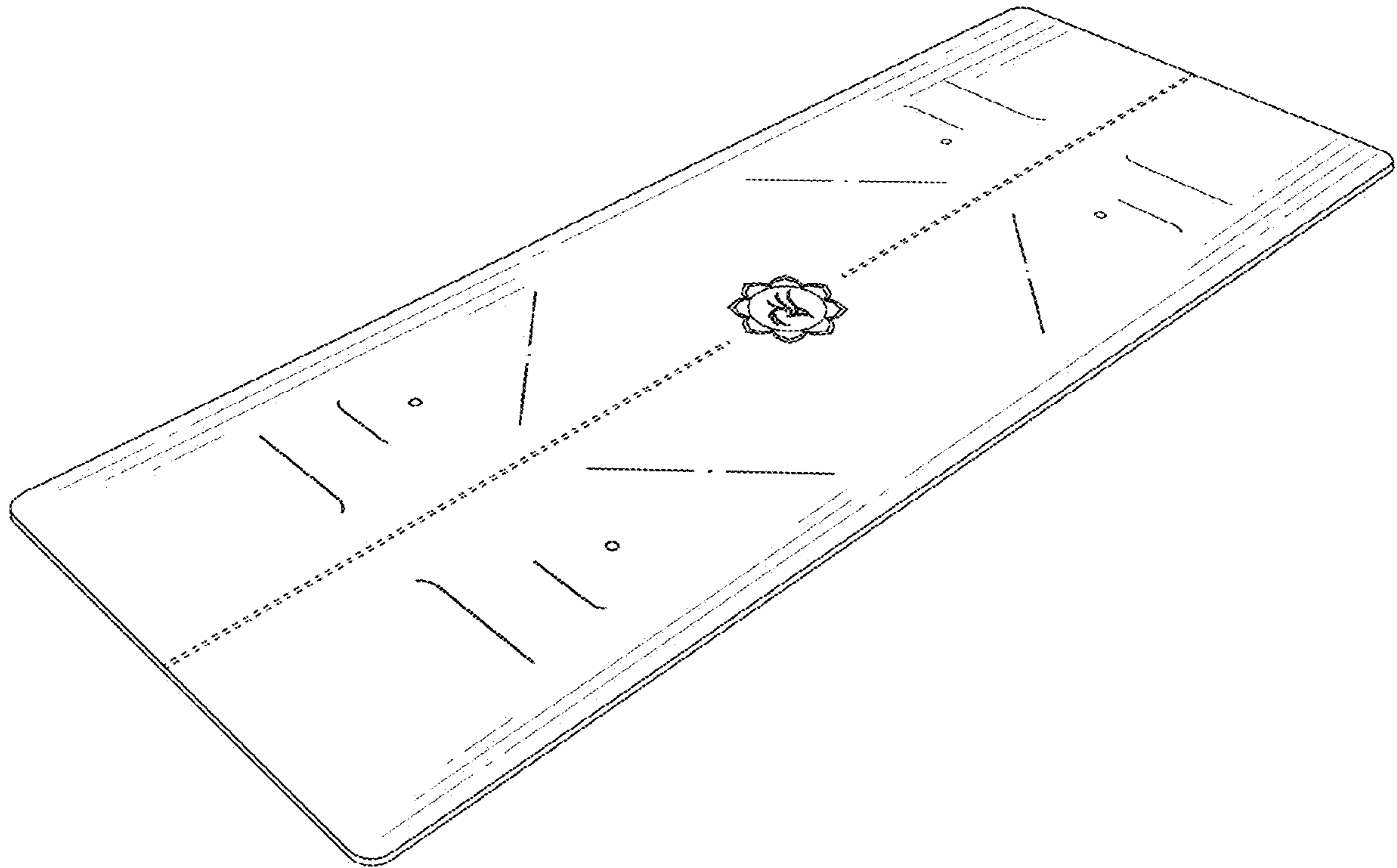

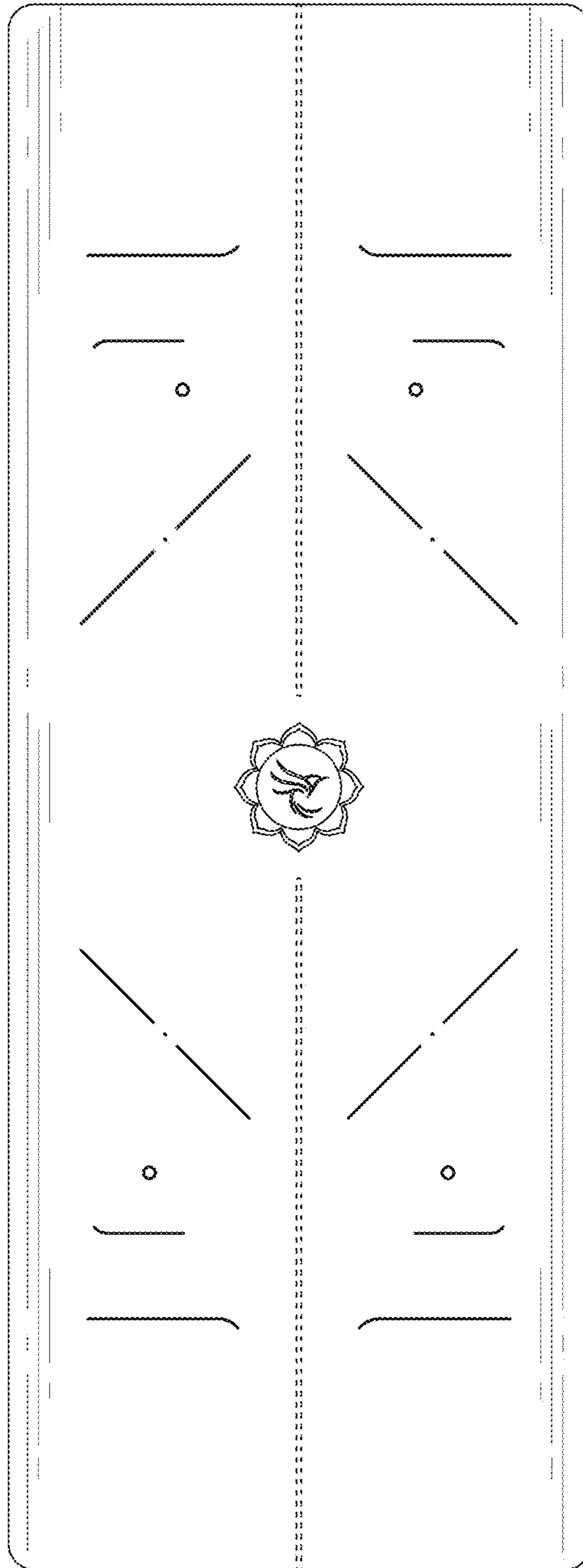

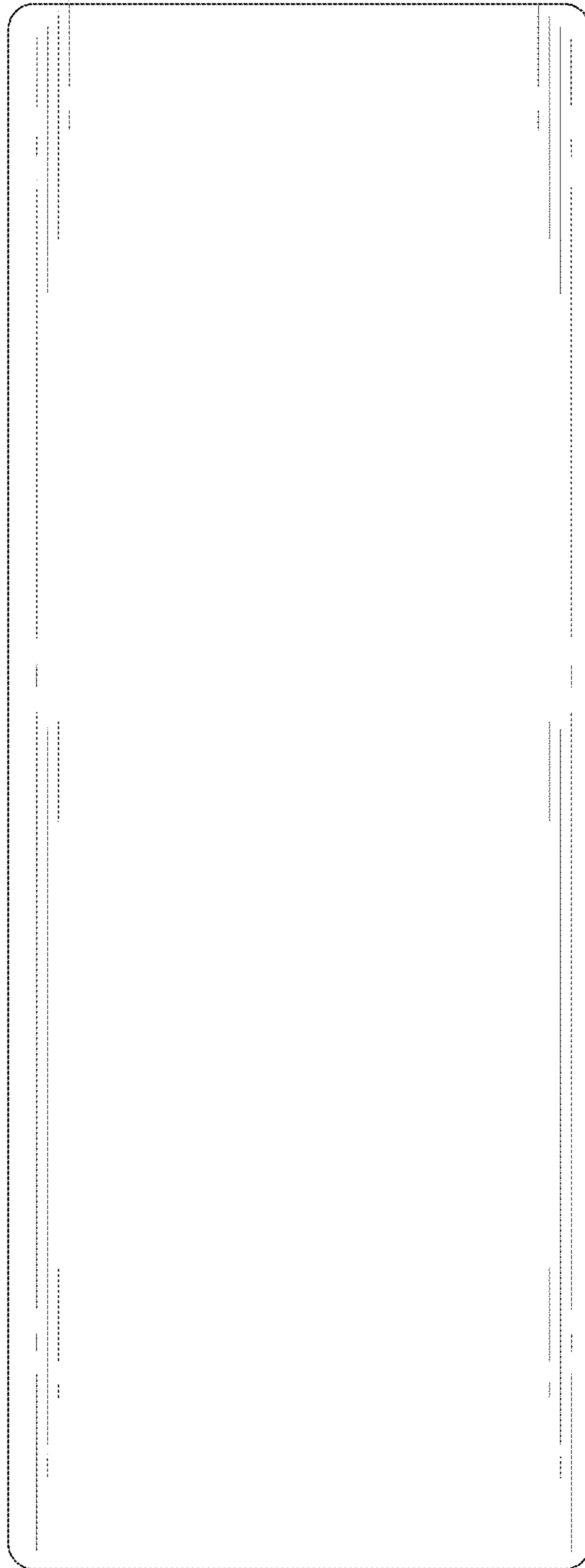

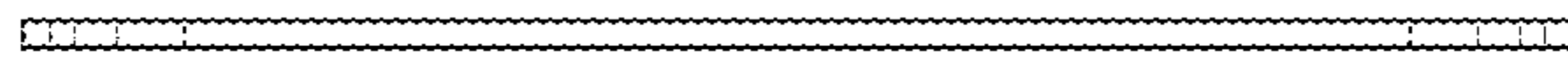

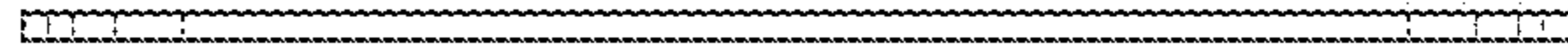
