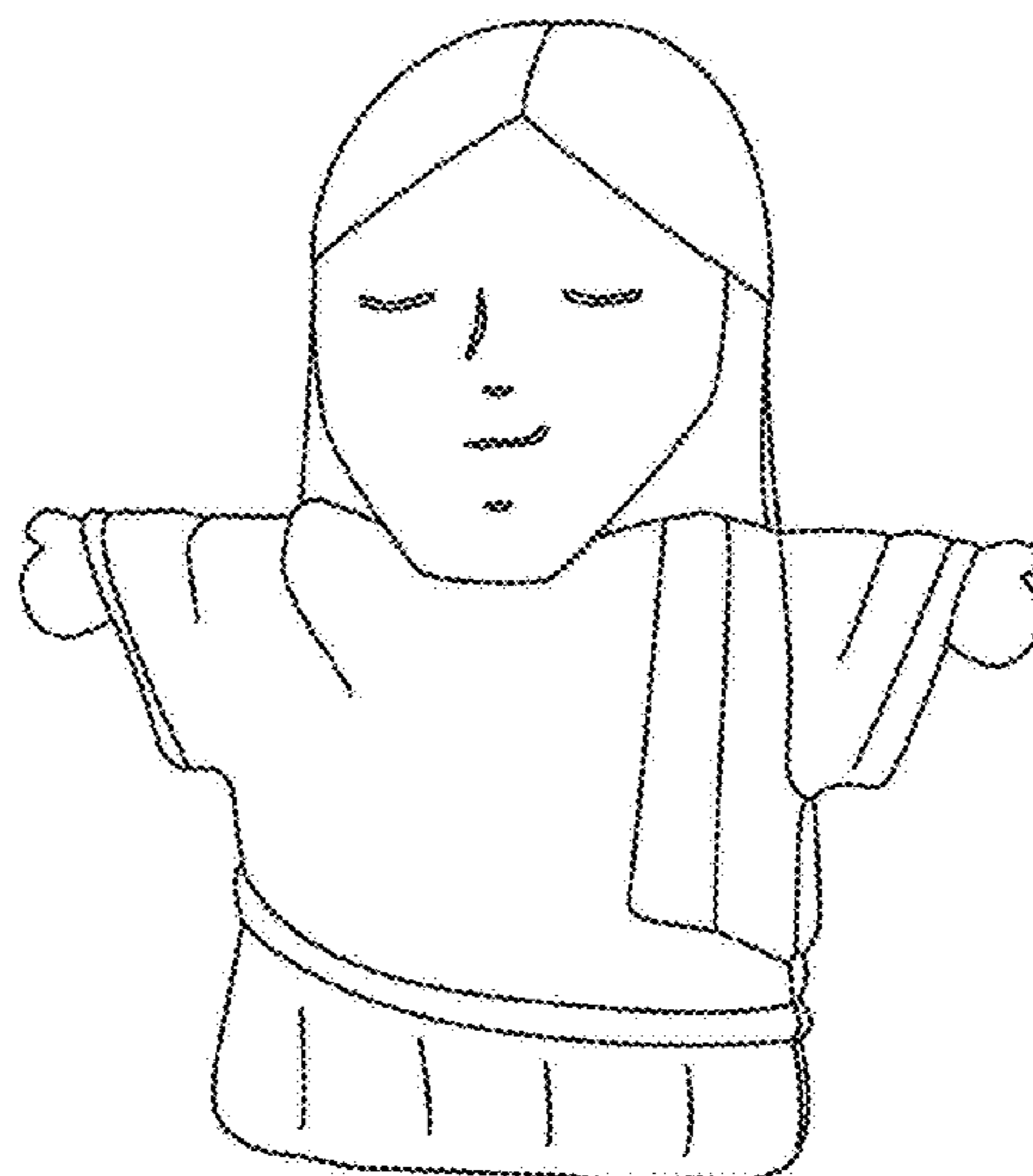

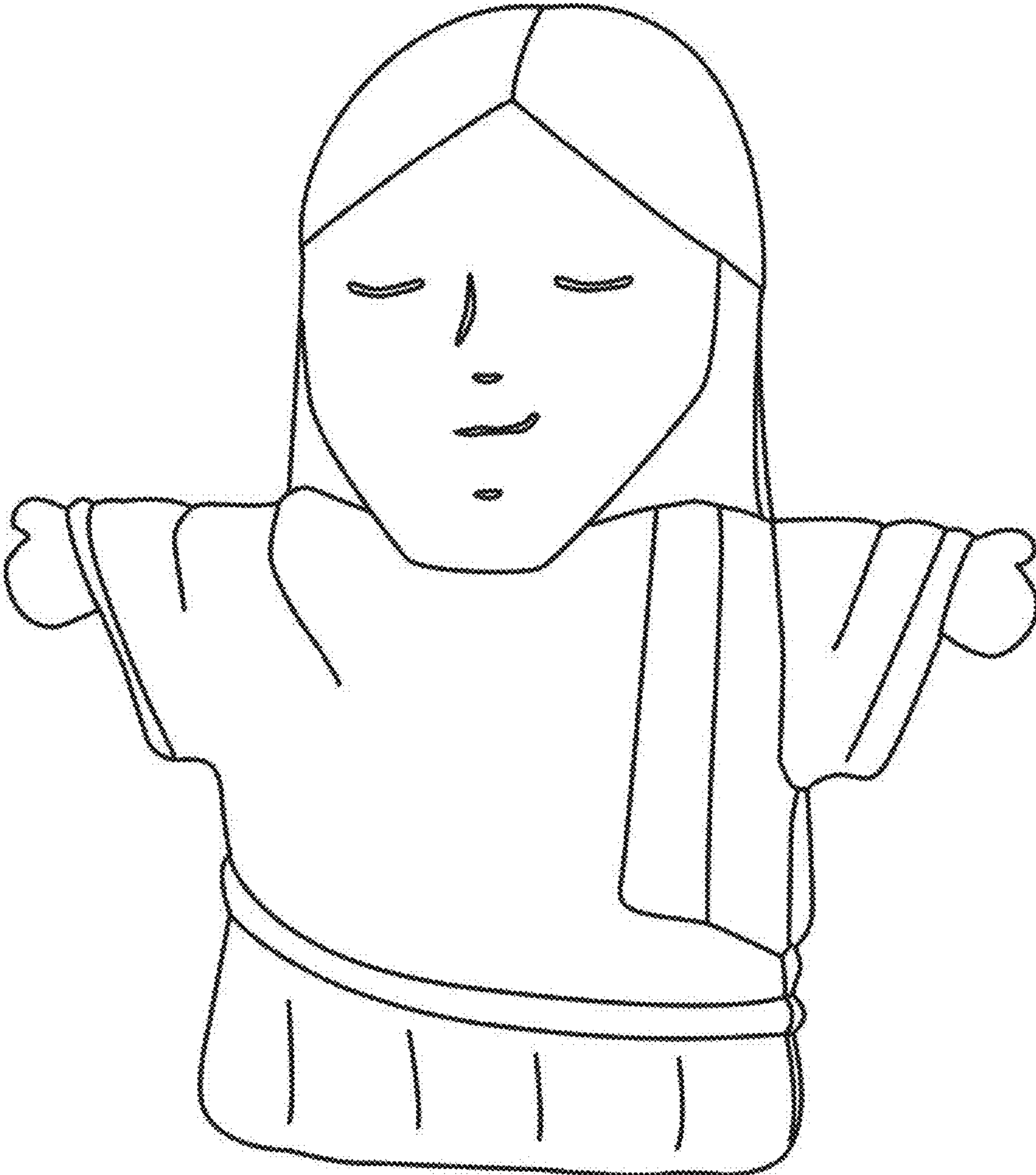
The ornamental design for a cushion, as shown and

**DESCRIPTION**

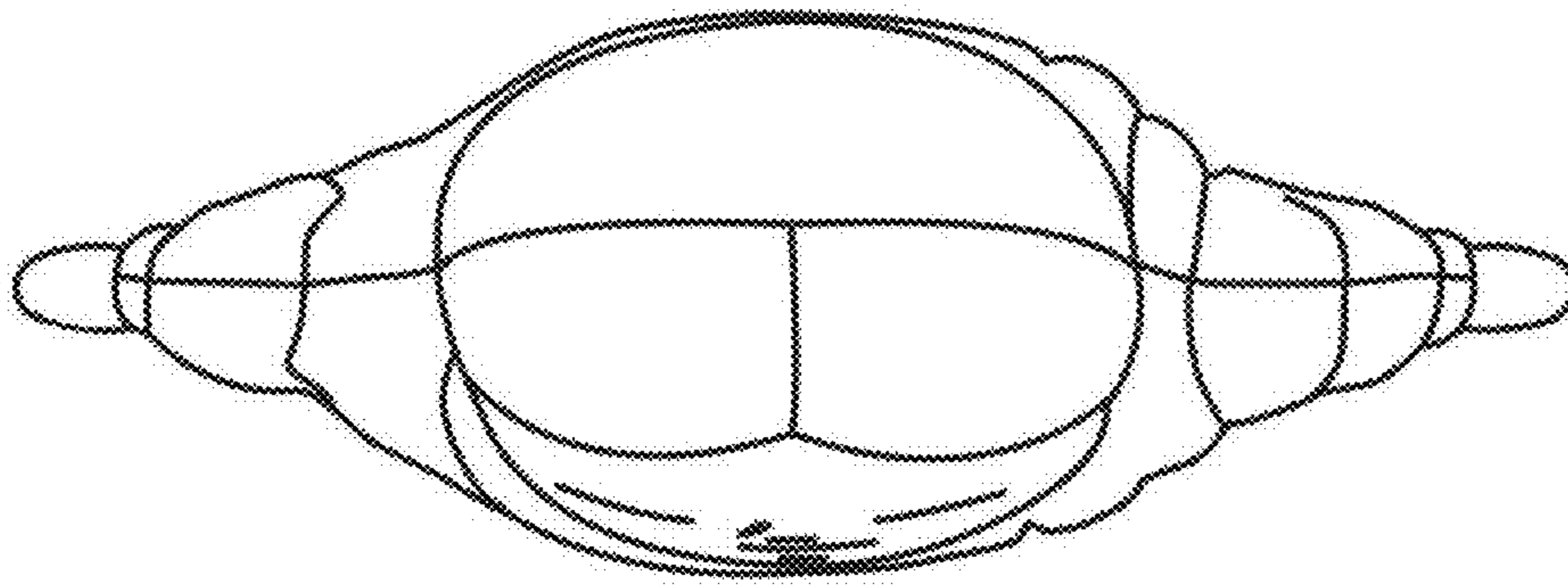
FIG. 1 is a perspective view showing my new design;

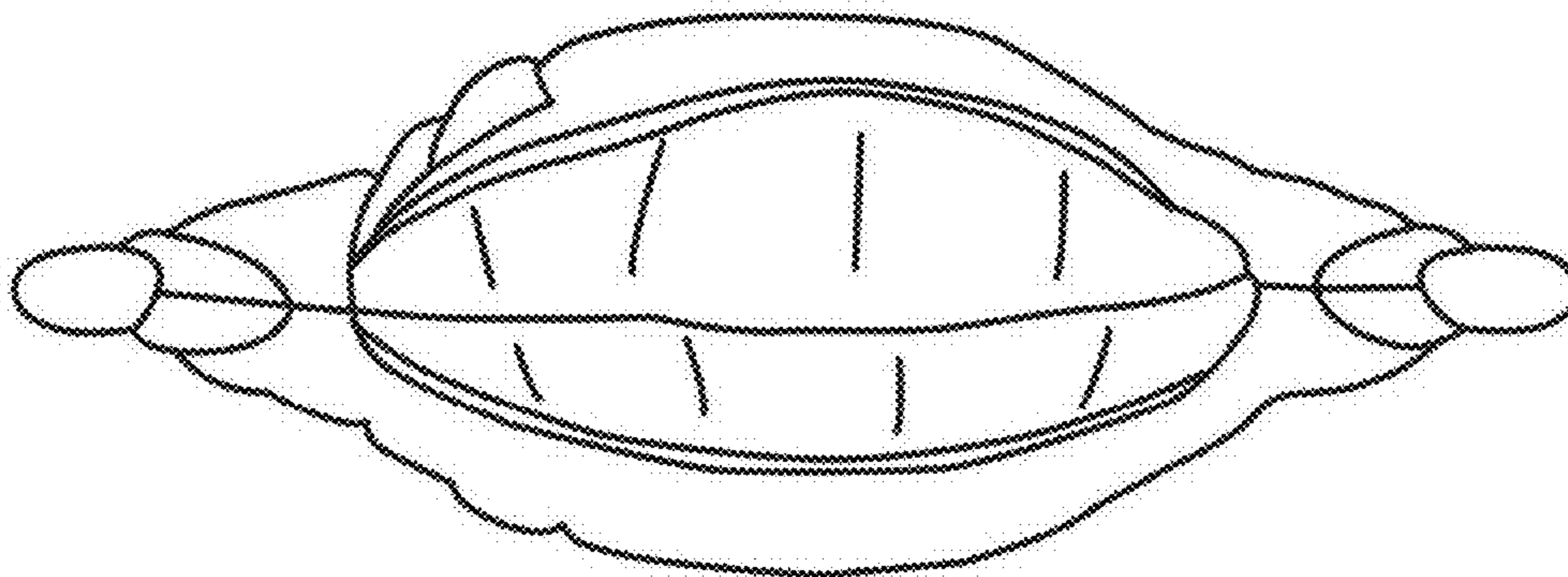




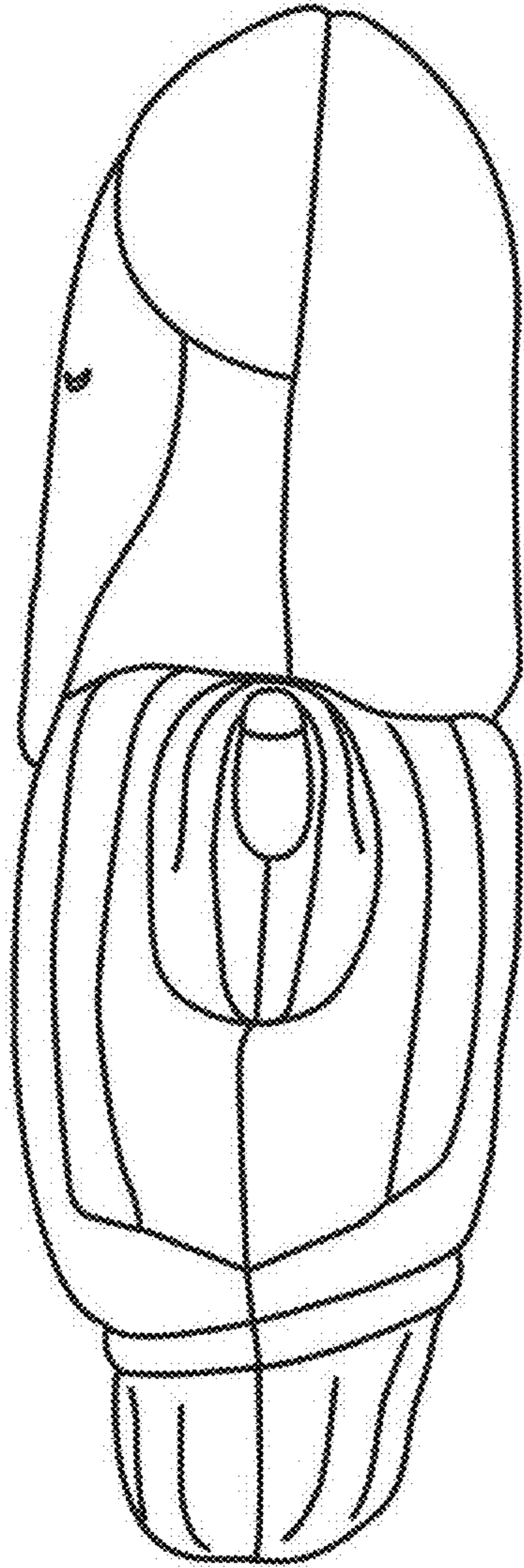

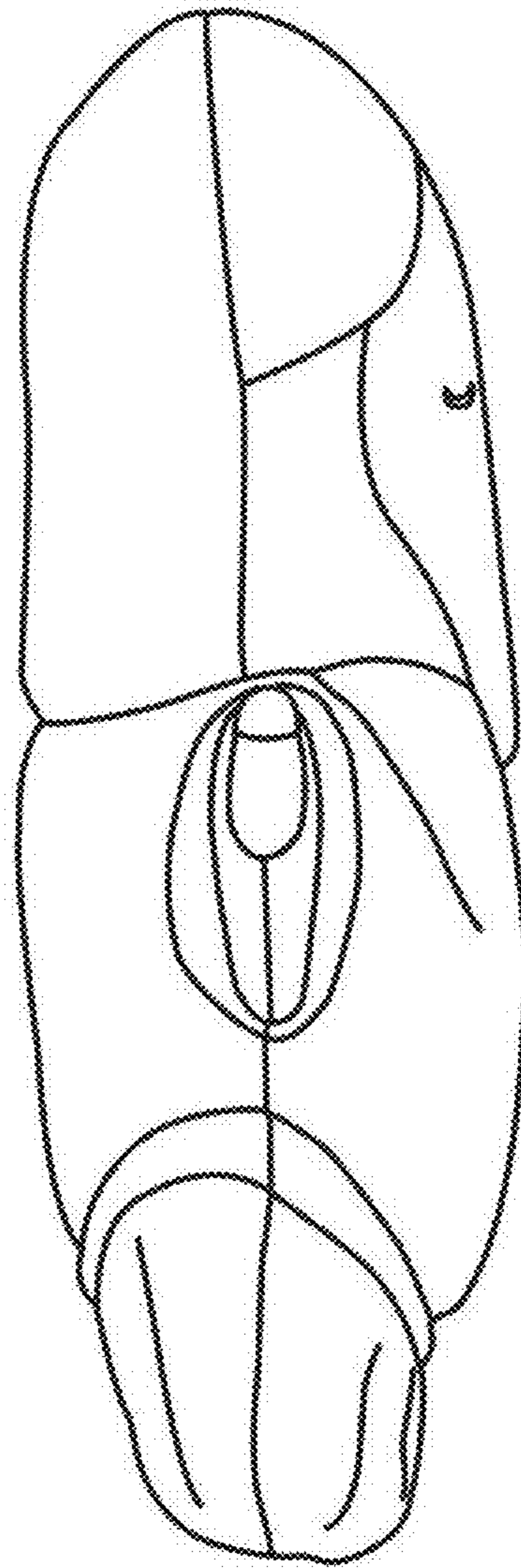

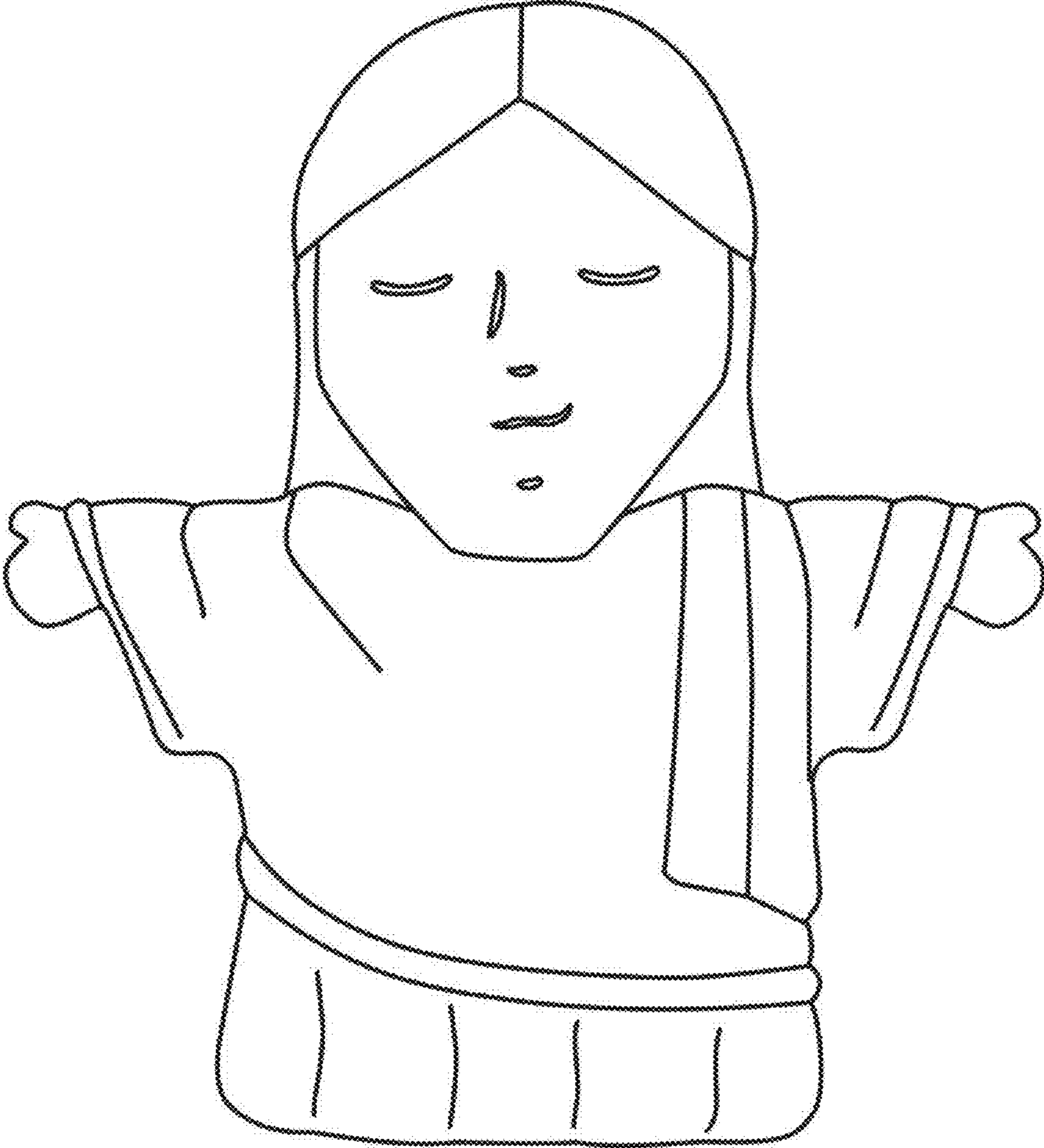

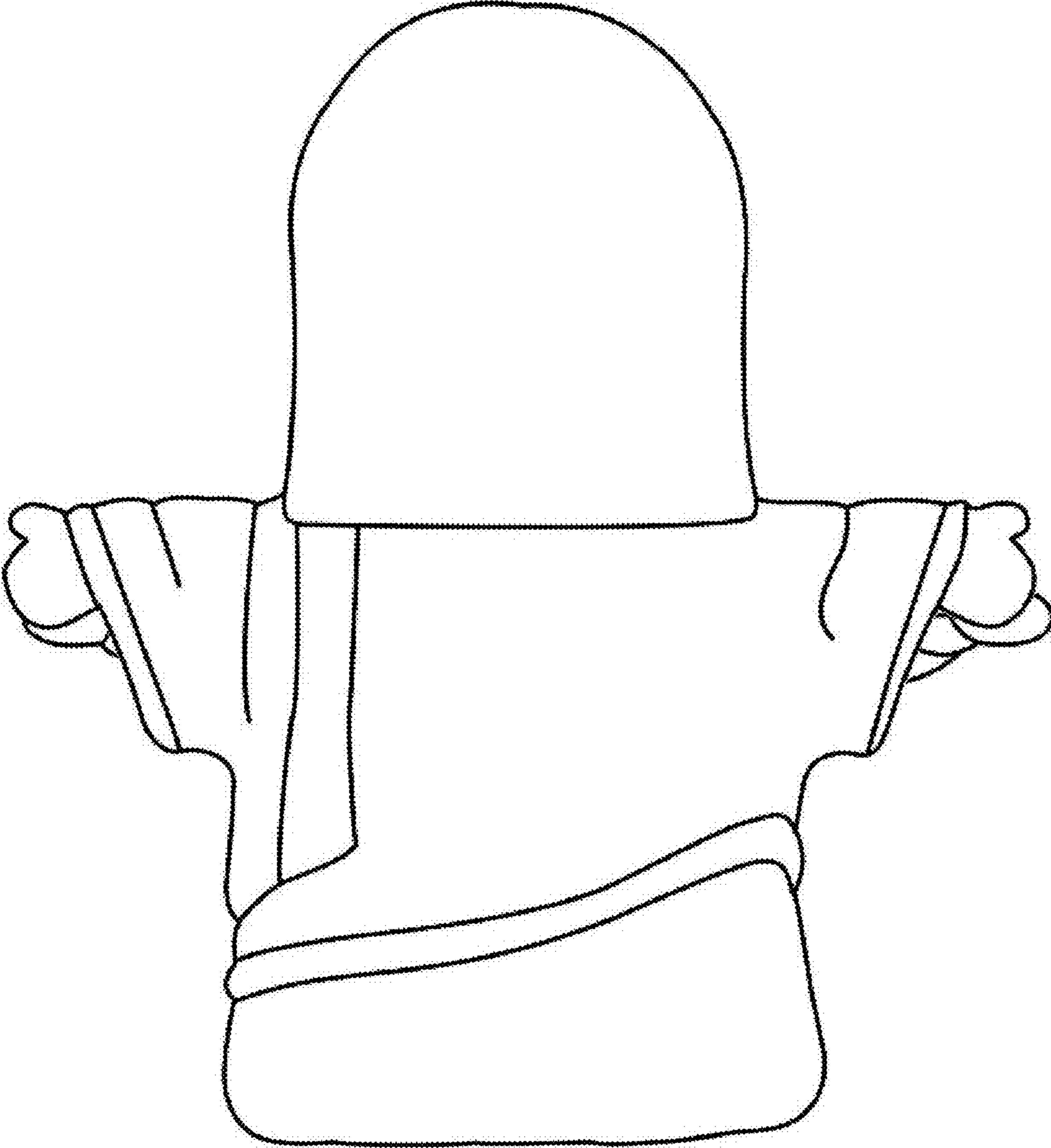
