The ornamental design for a handle for a medical pole assembly, as shown and described.

FIG. 4 is a rear view thereof;

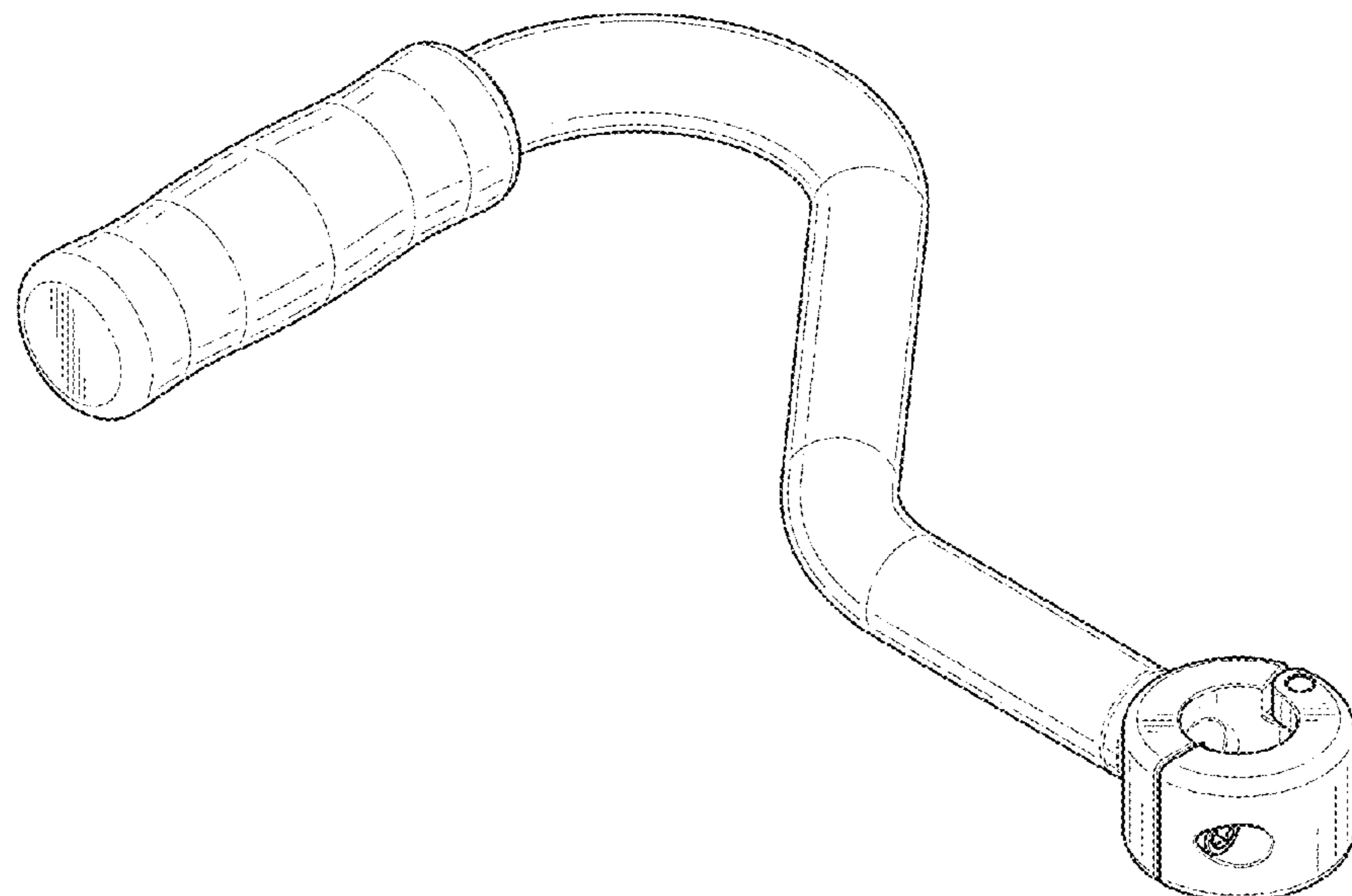
FIG. 5 is a front view thereof;

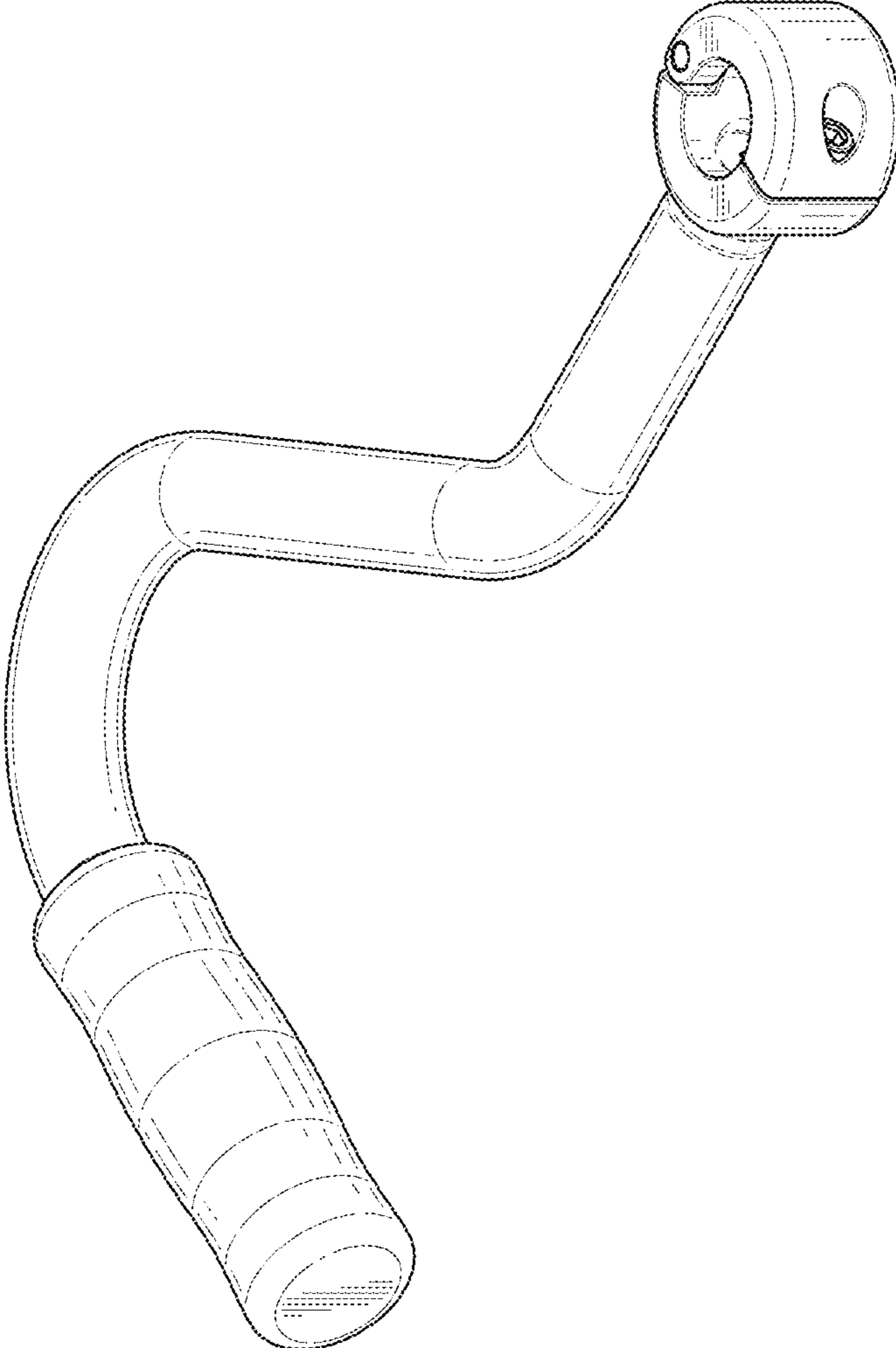

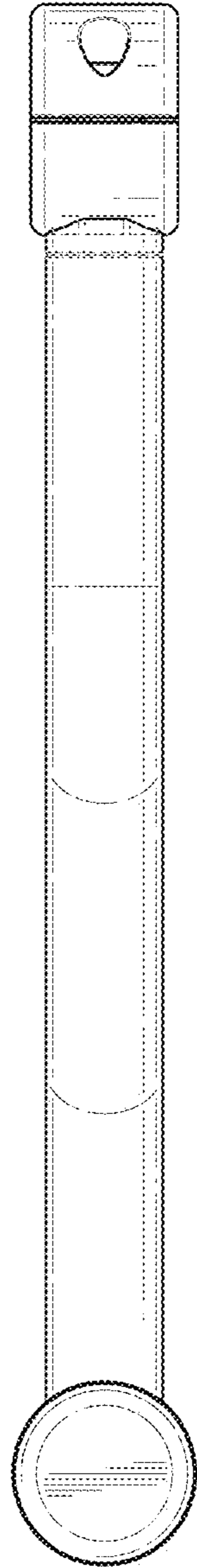

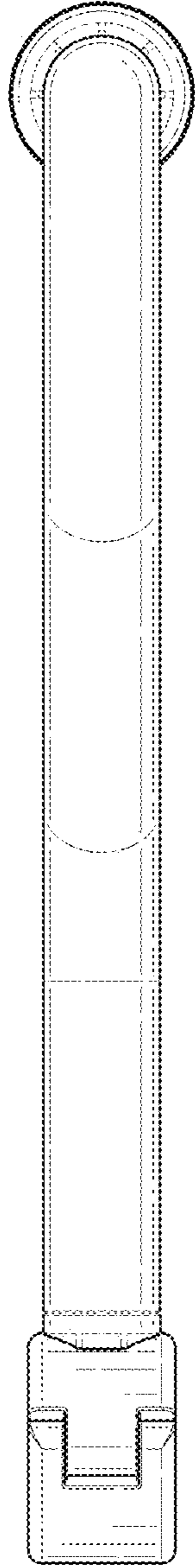

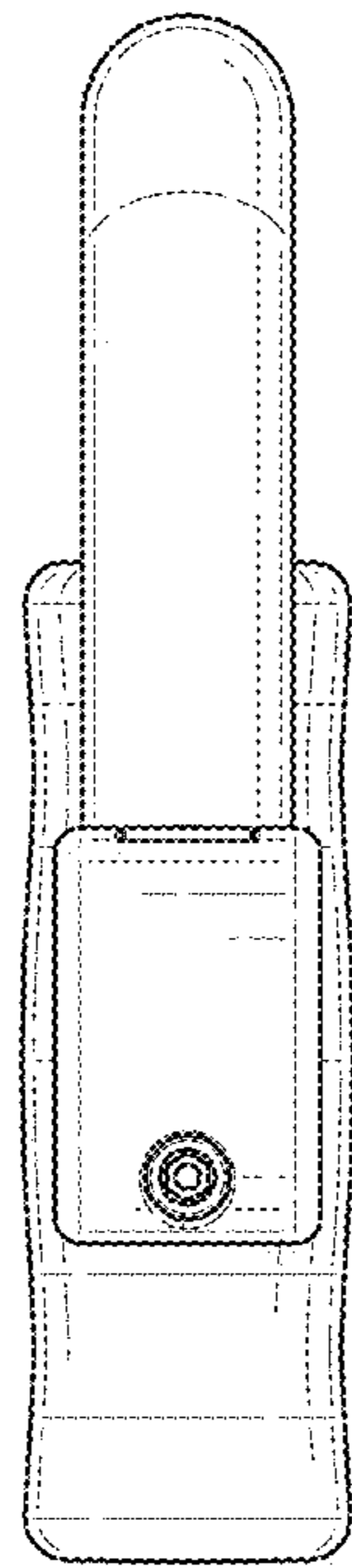

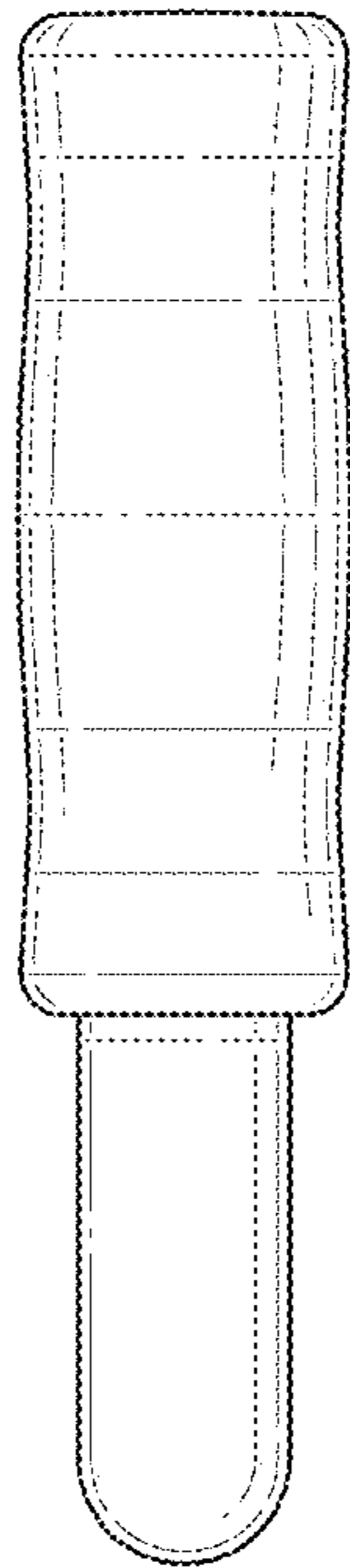

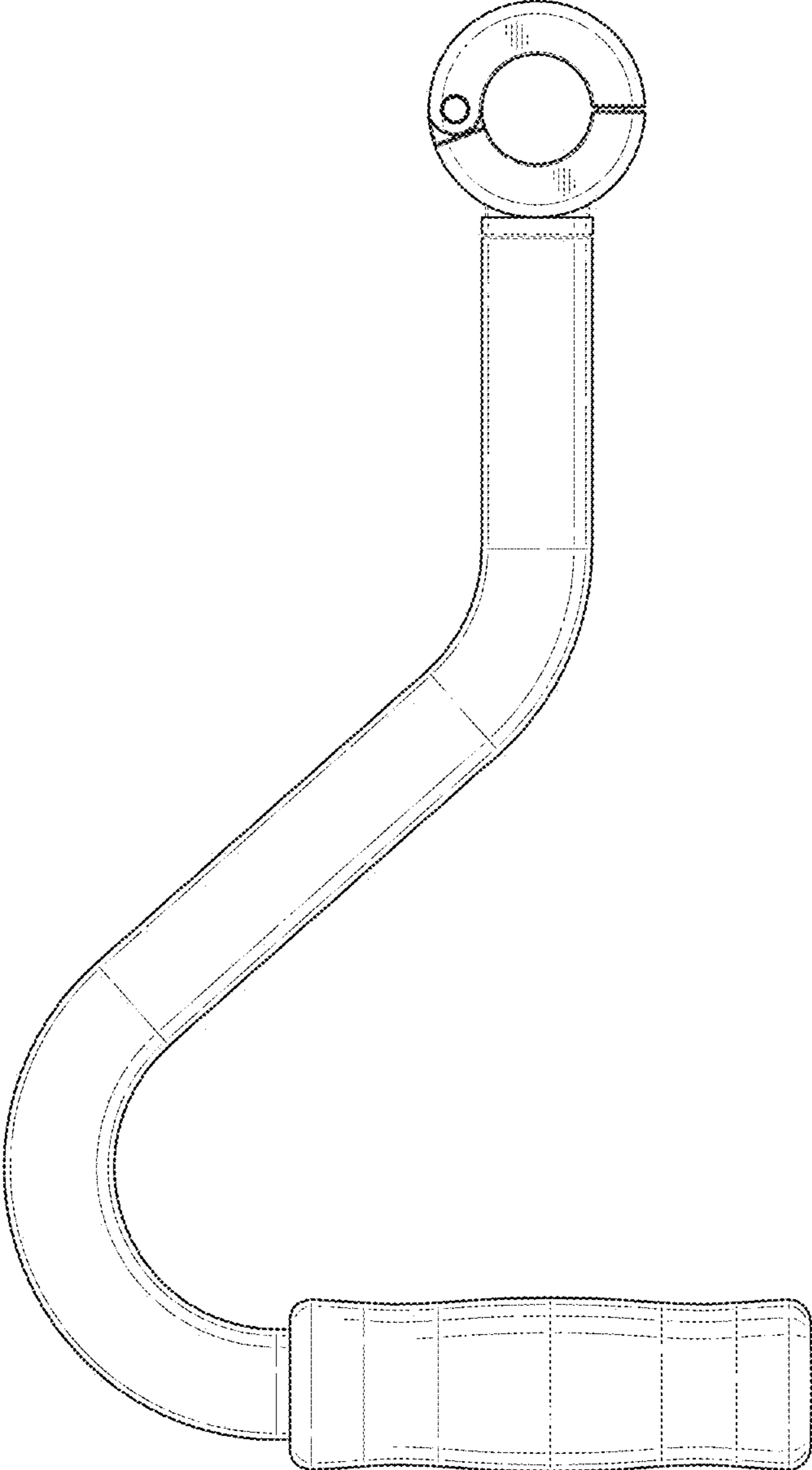

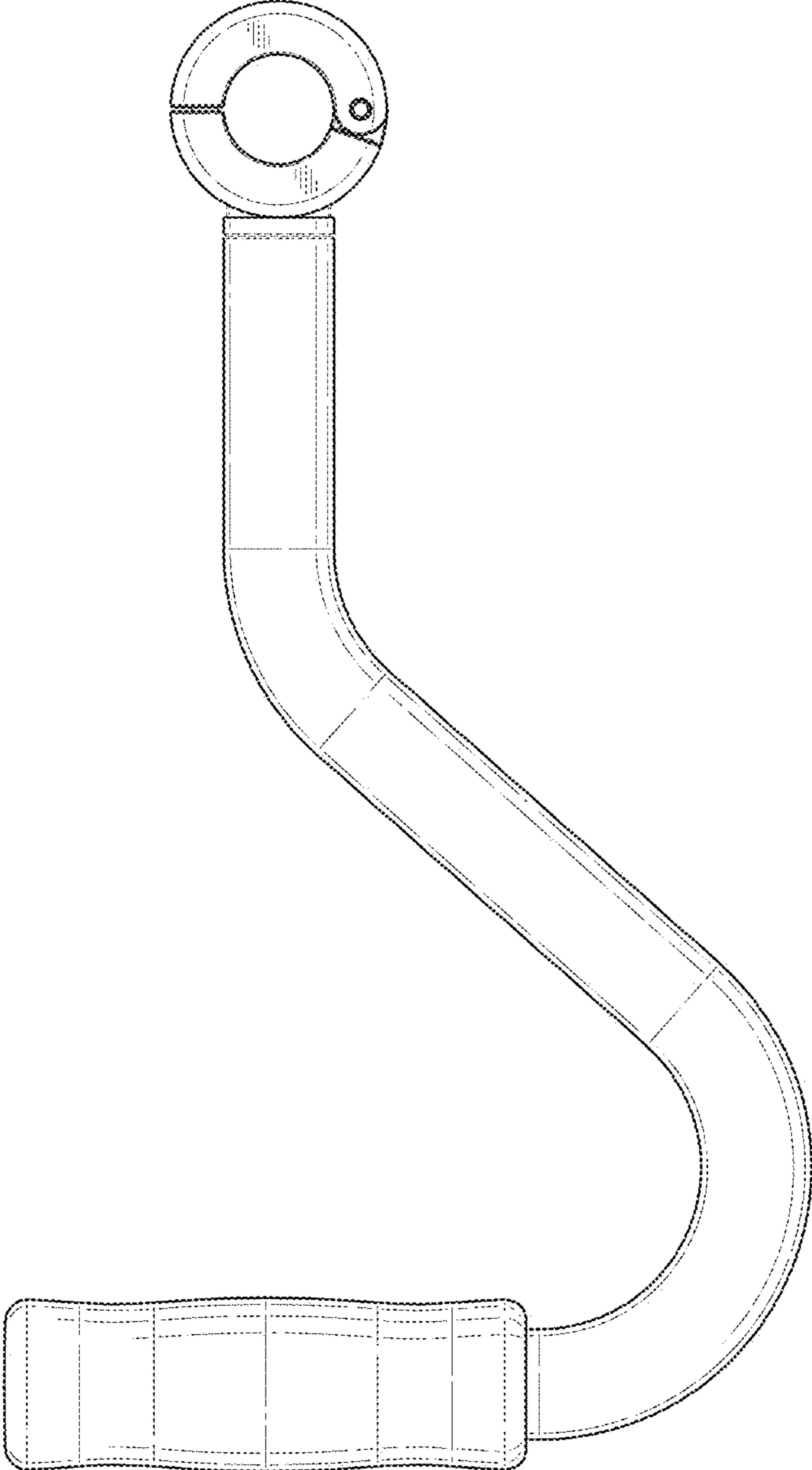
