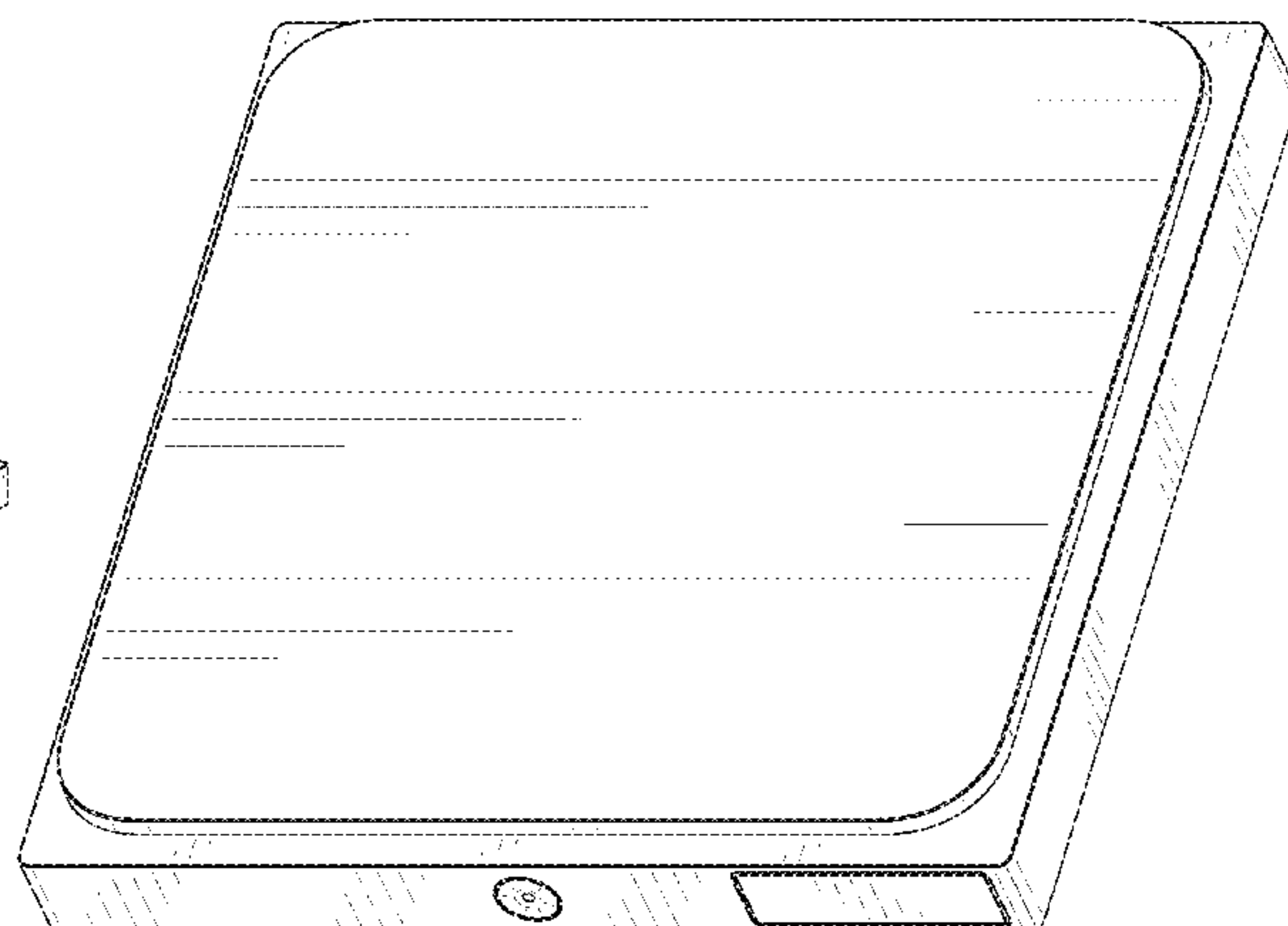
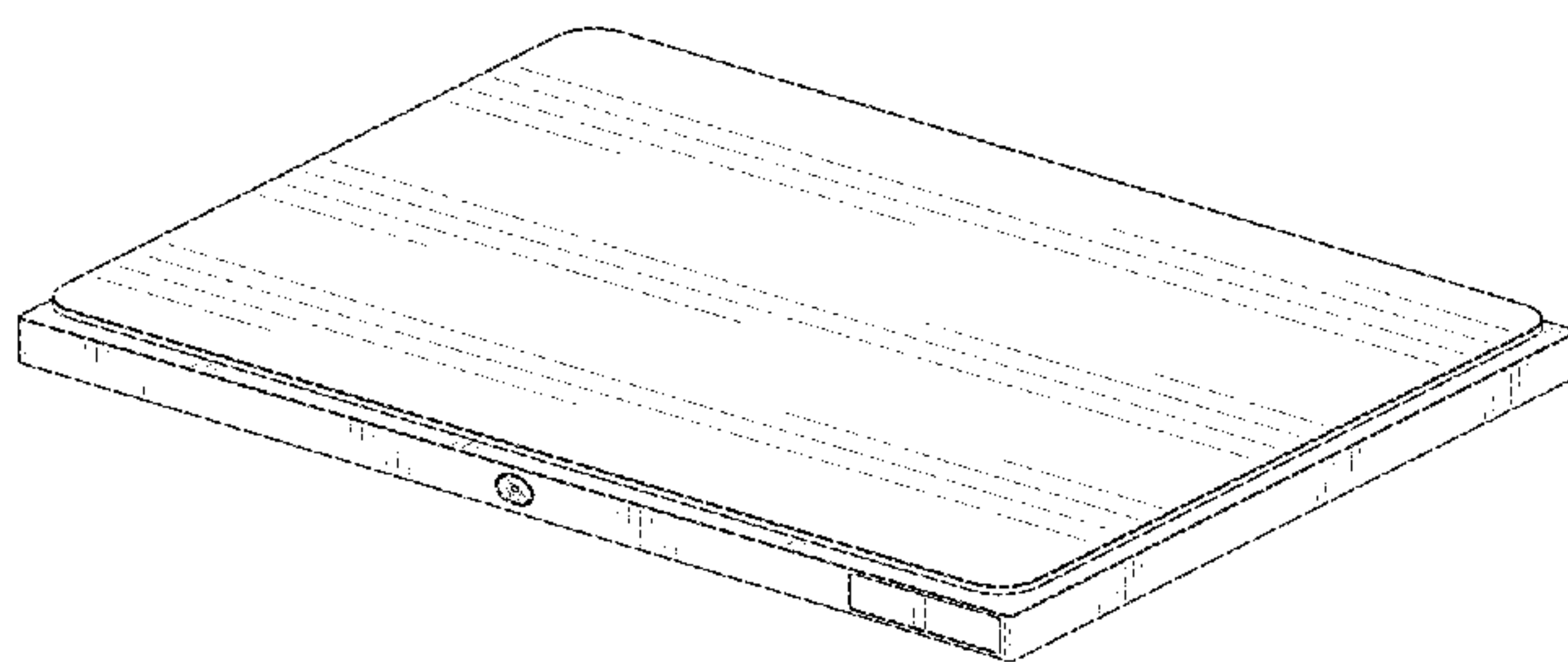
The ornamental design for a scale device, as shown and described.

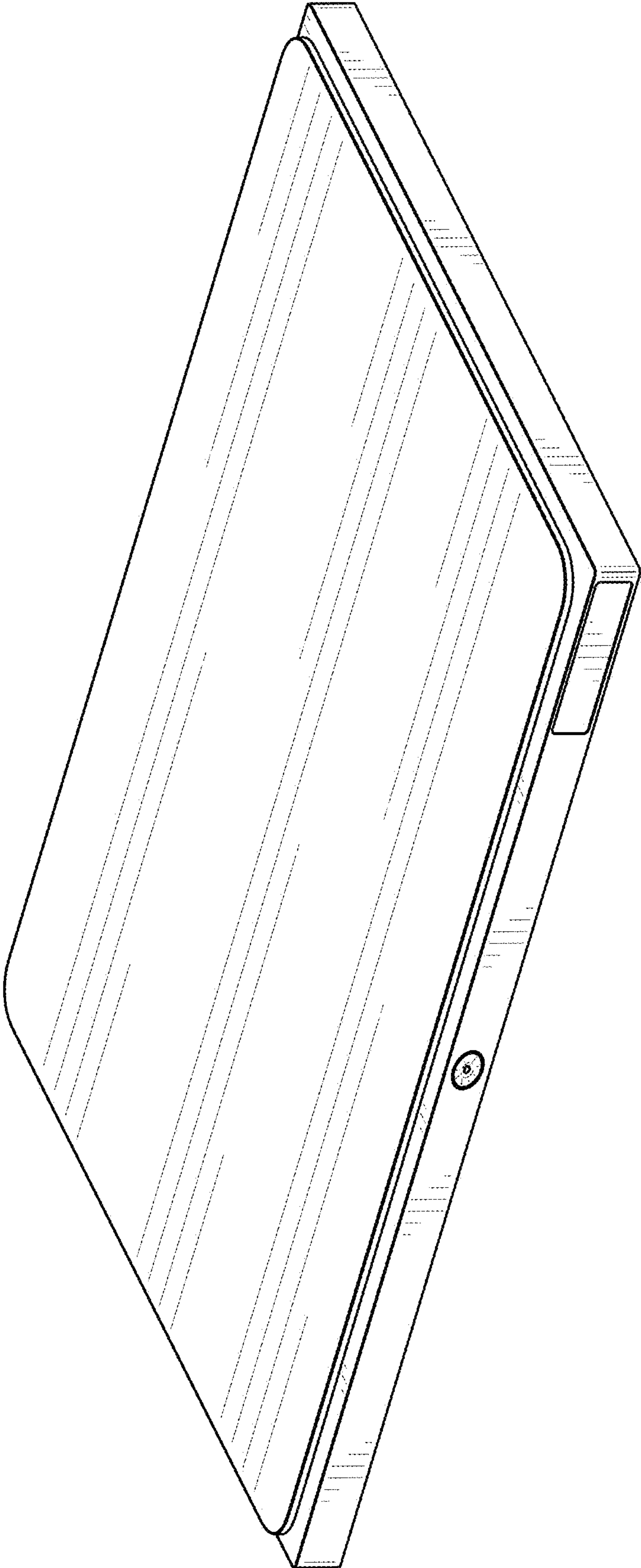

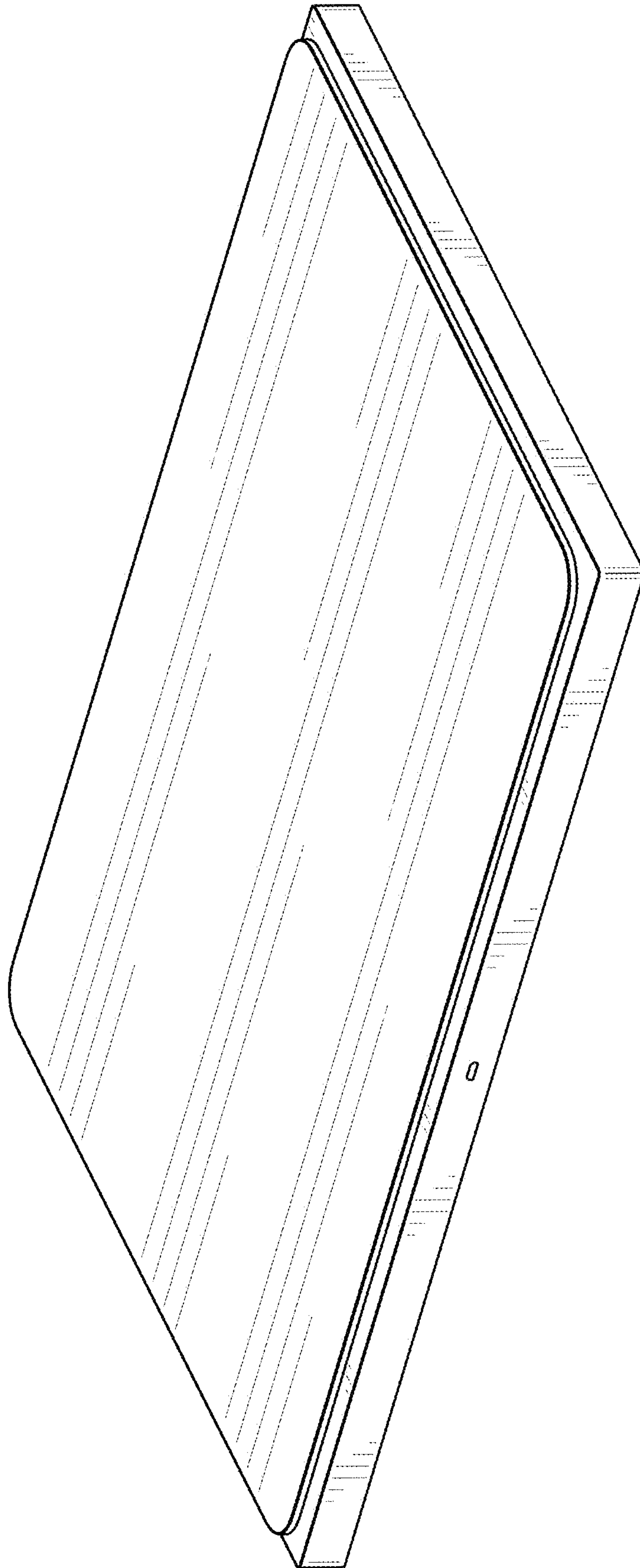

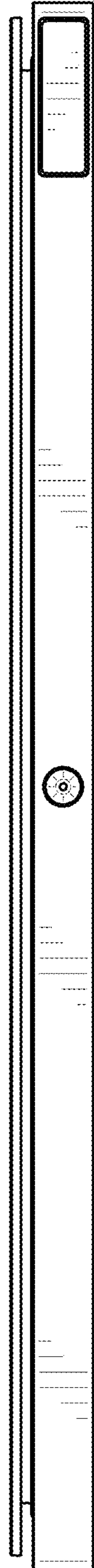

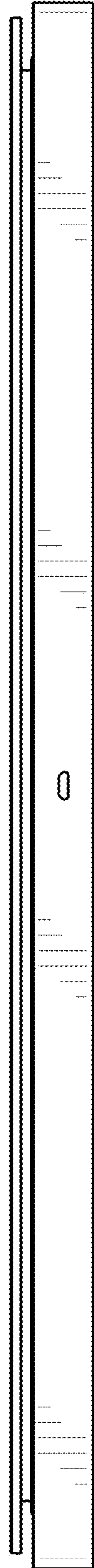

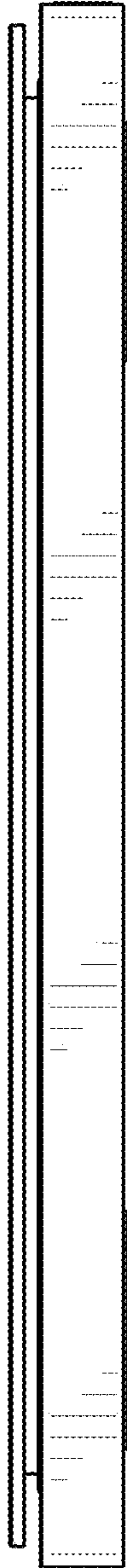

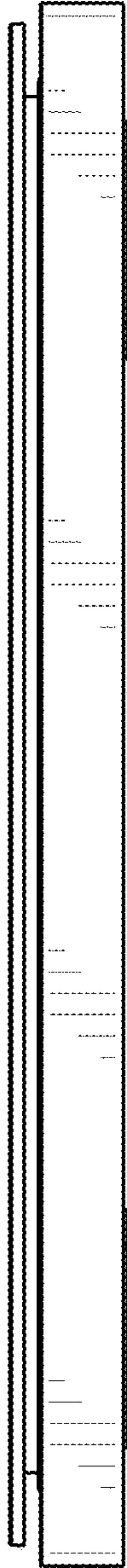

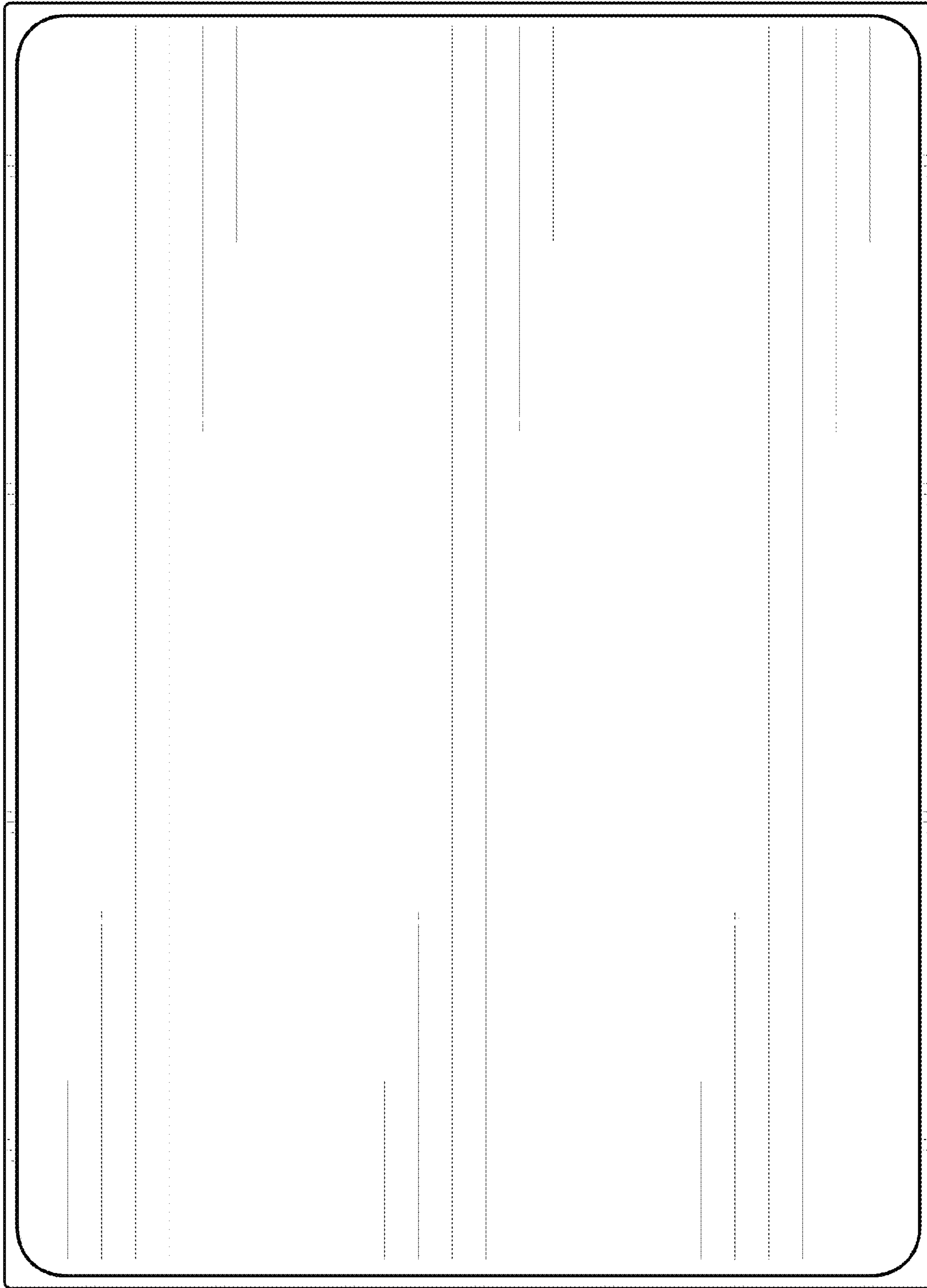

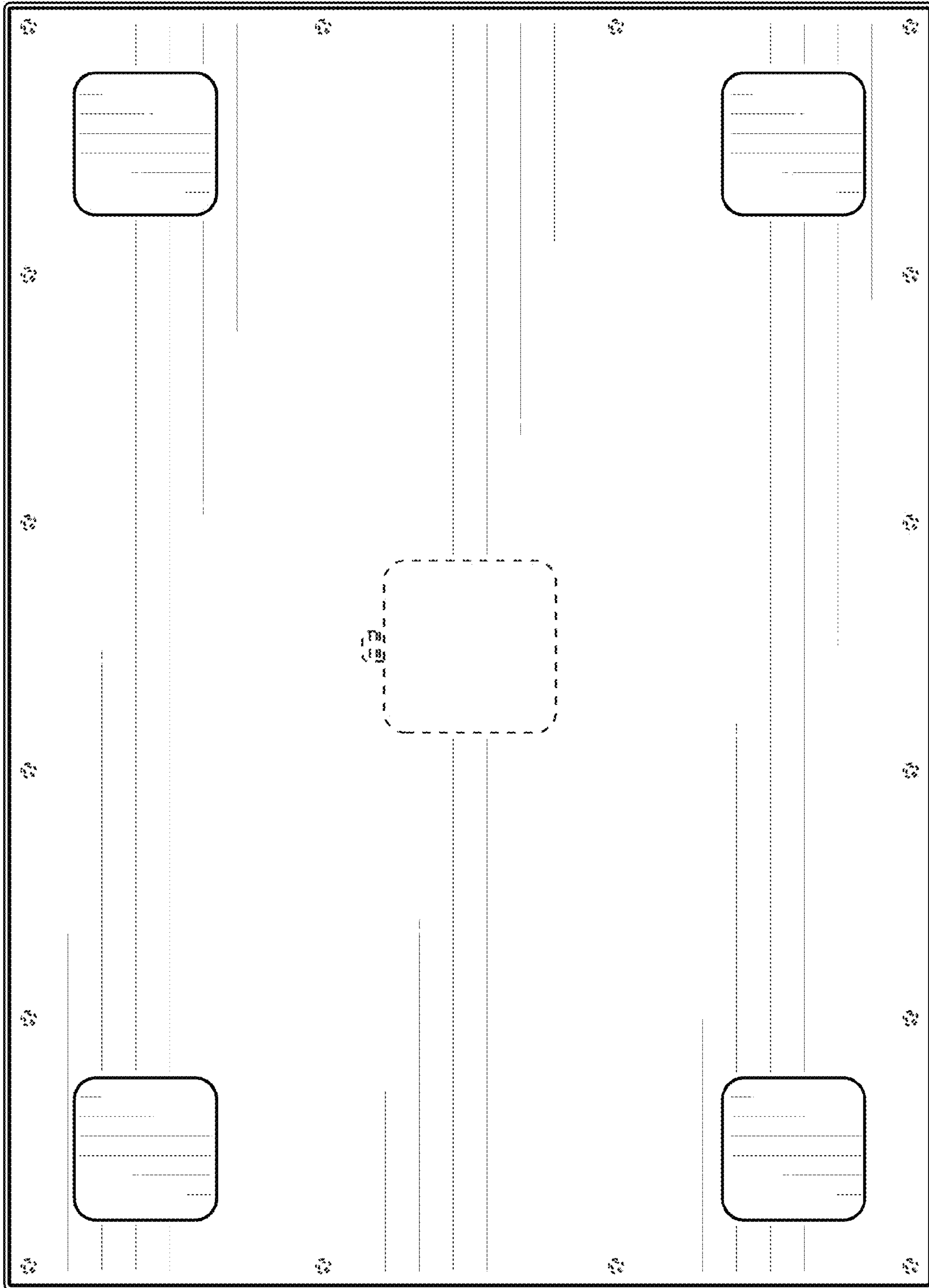

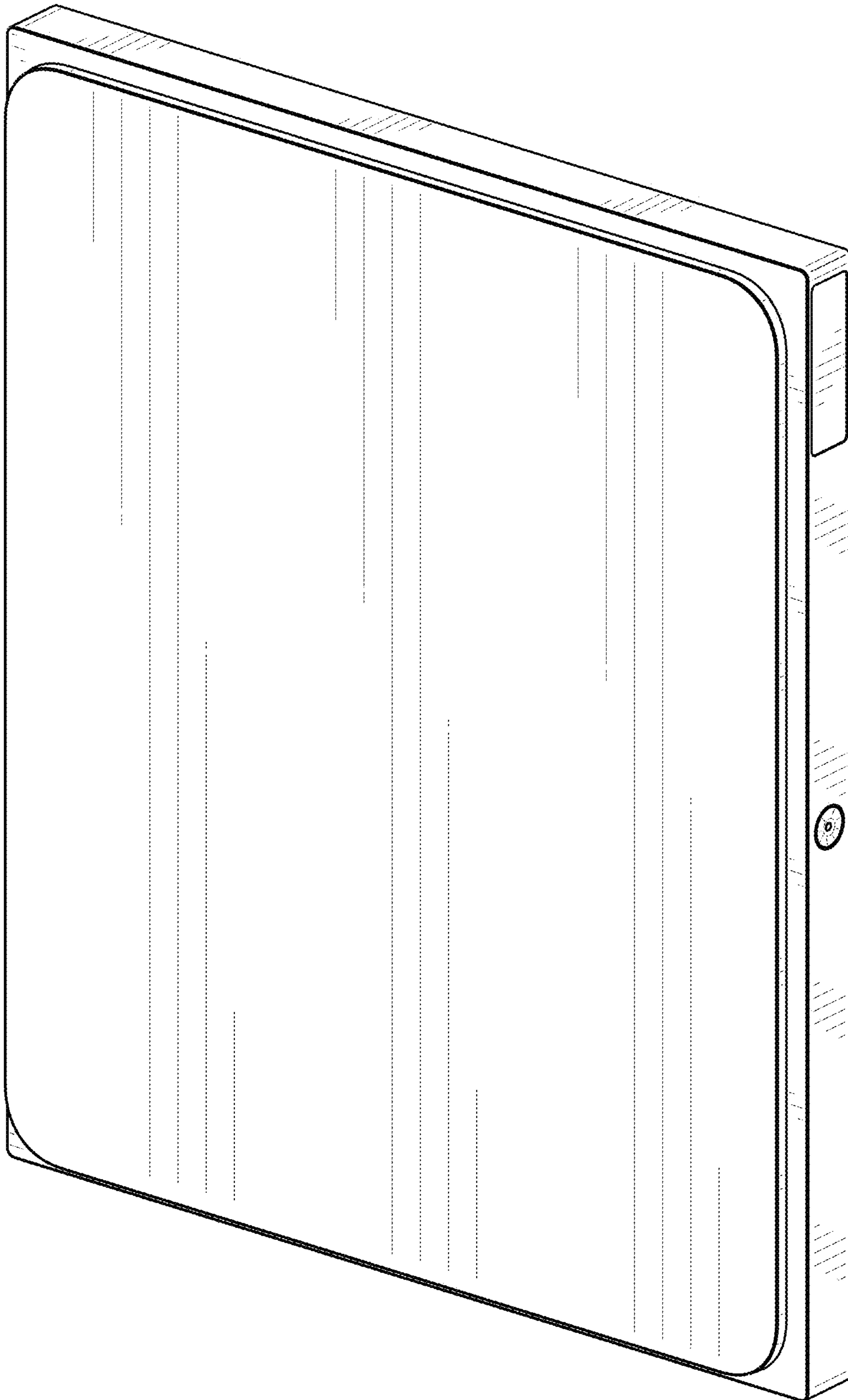

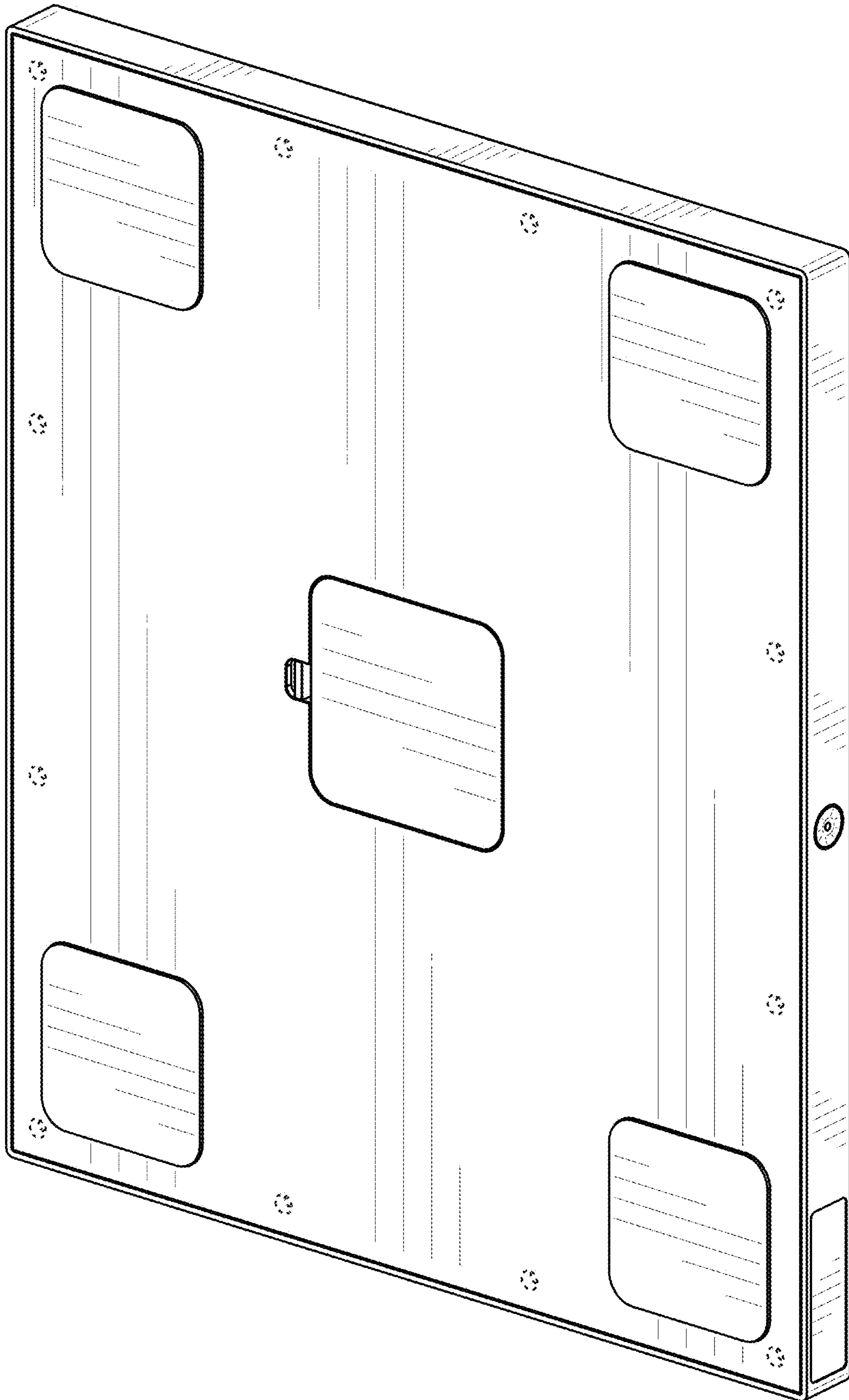

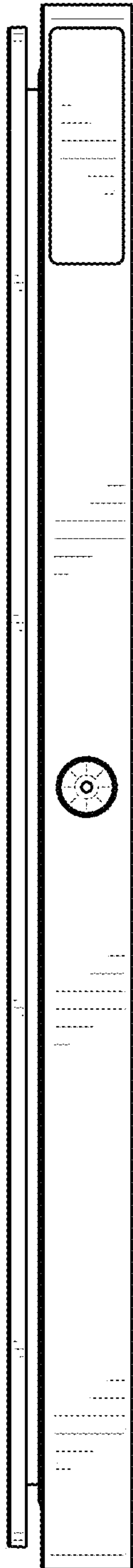

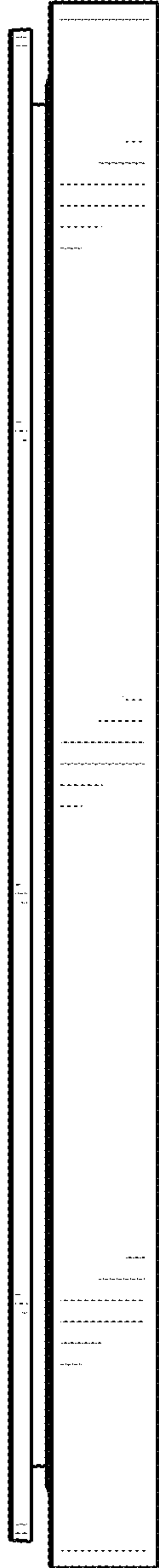

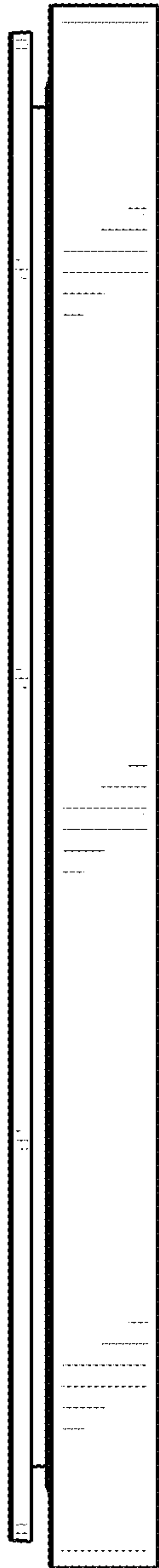

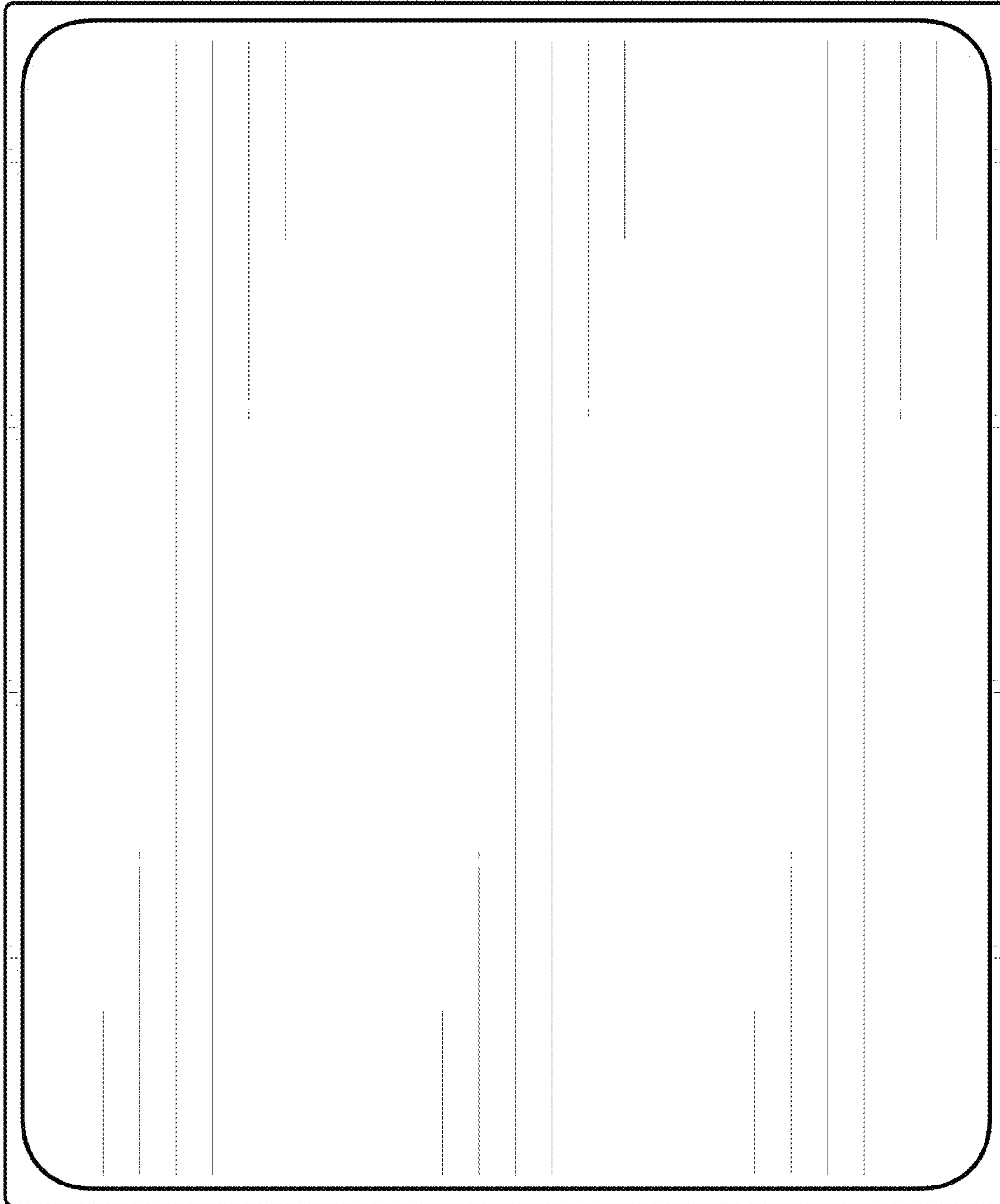

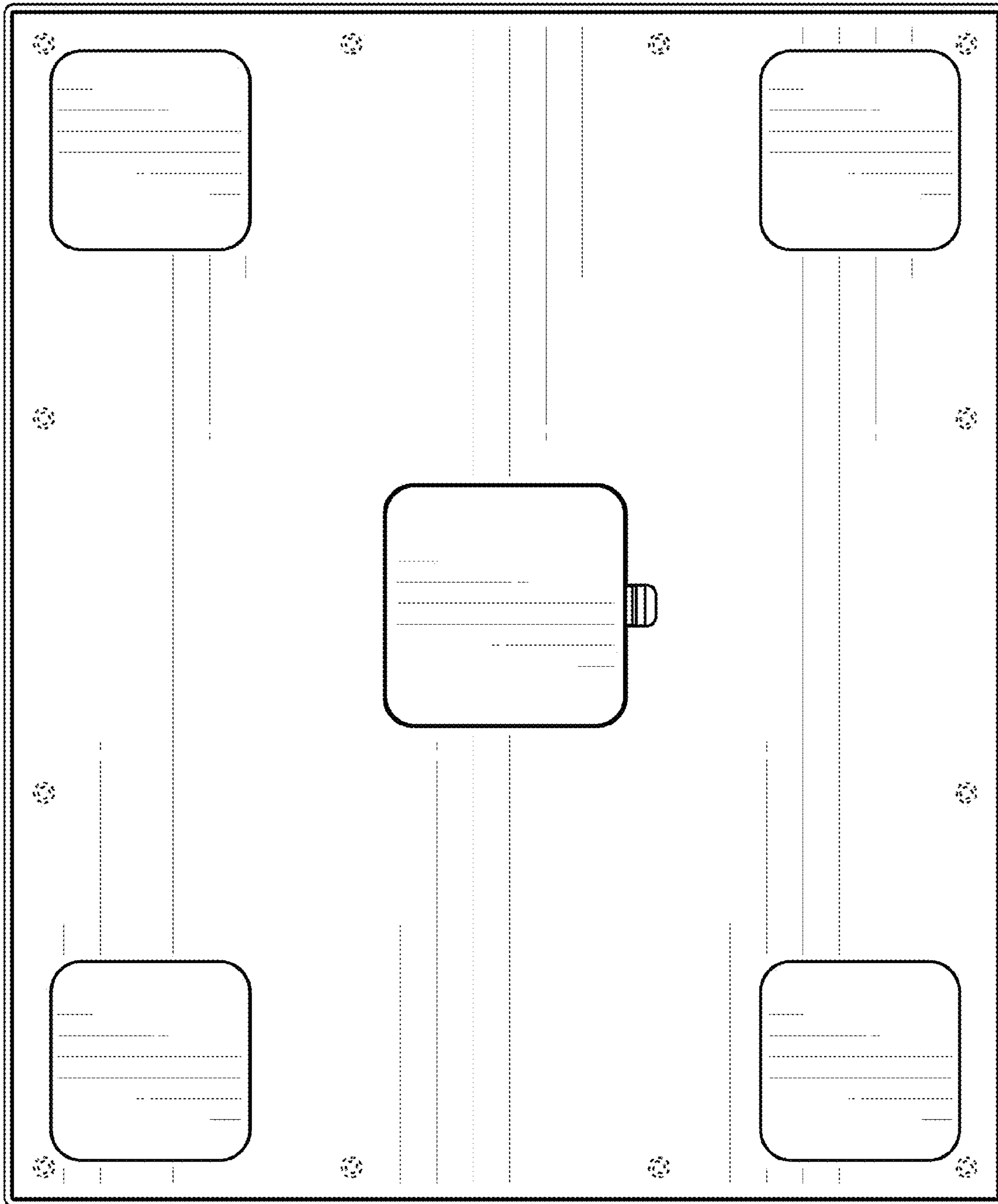

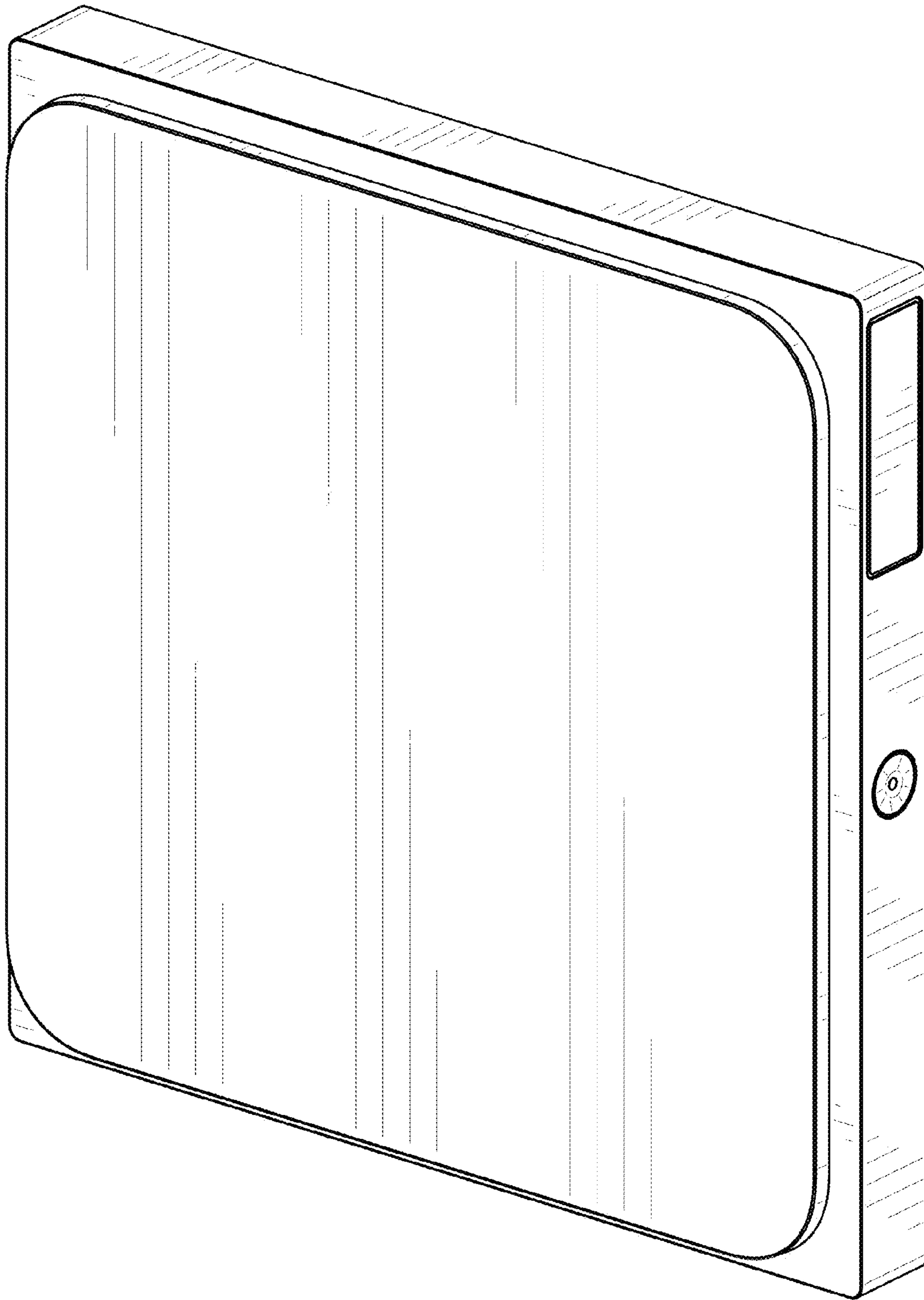

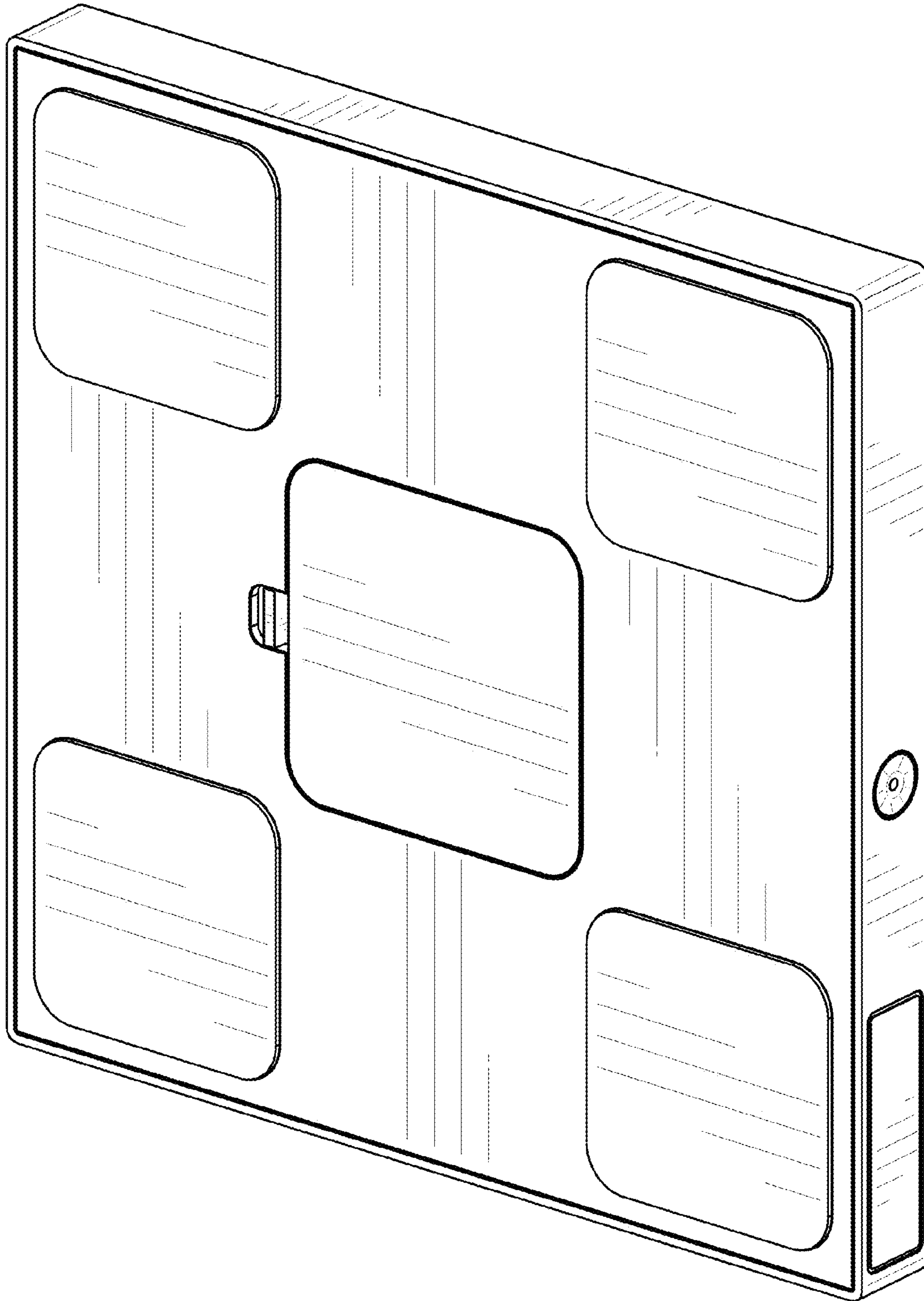

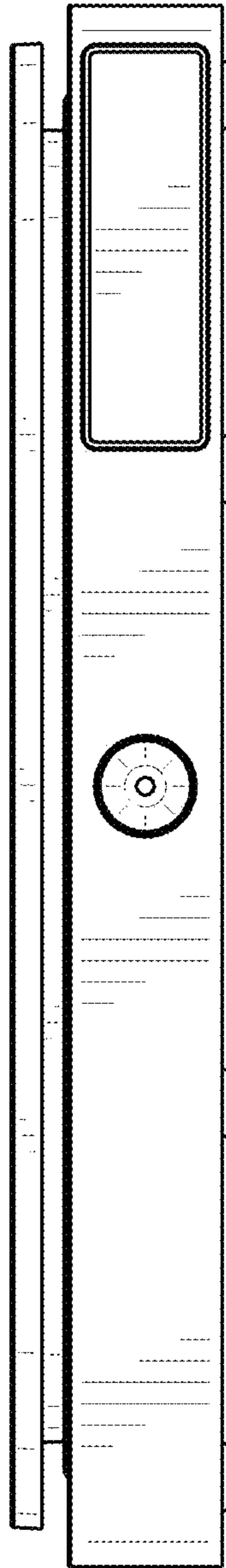

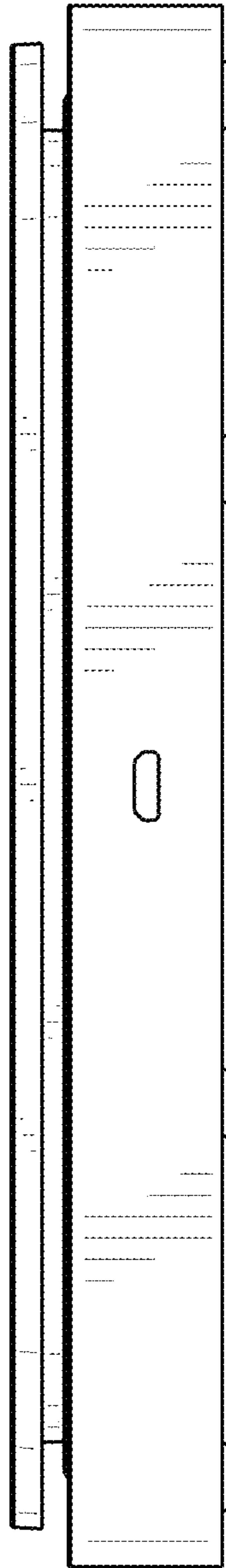

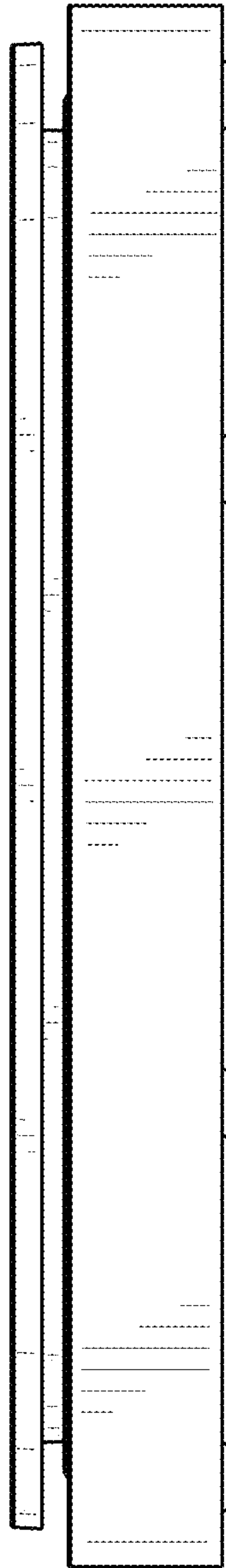

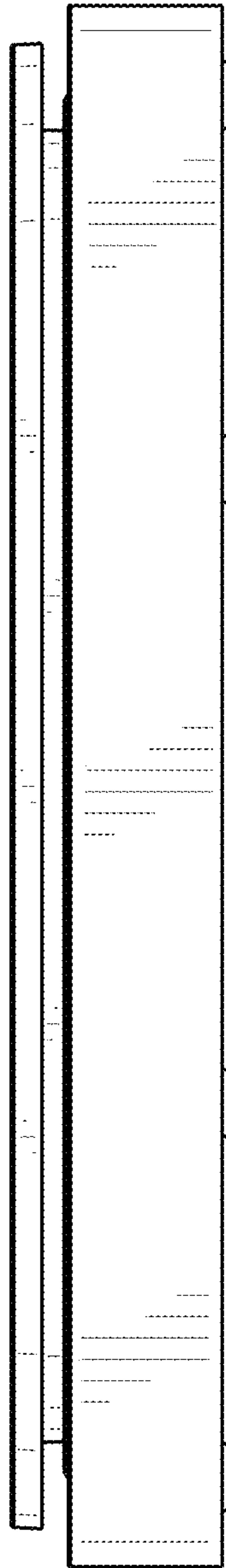

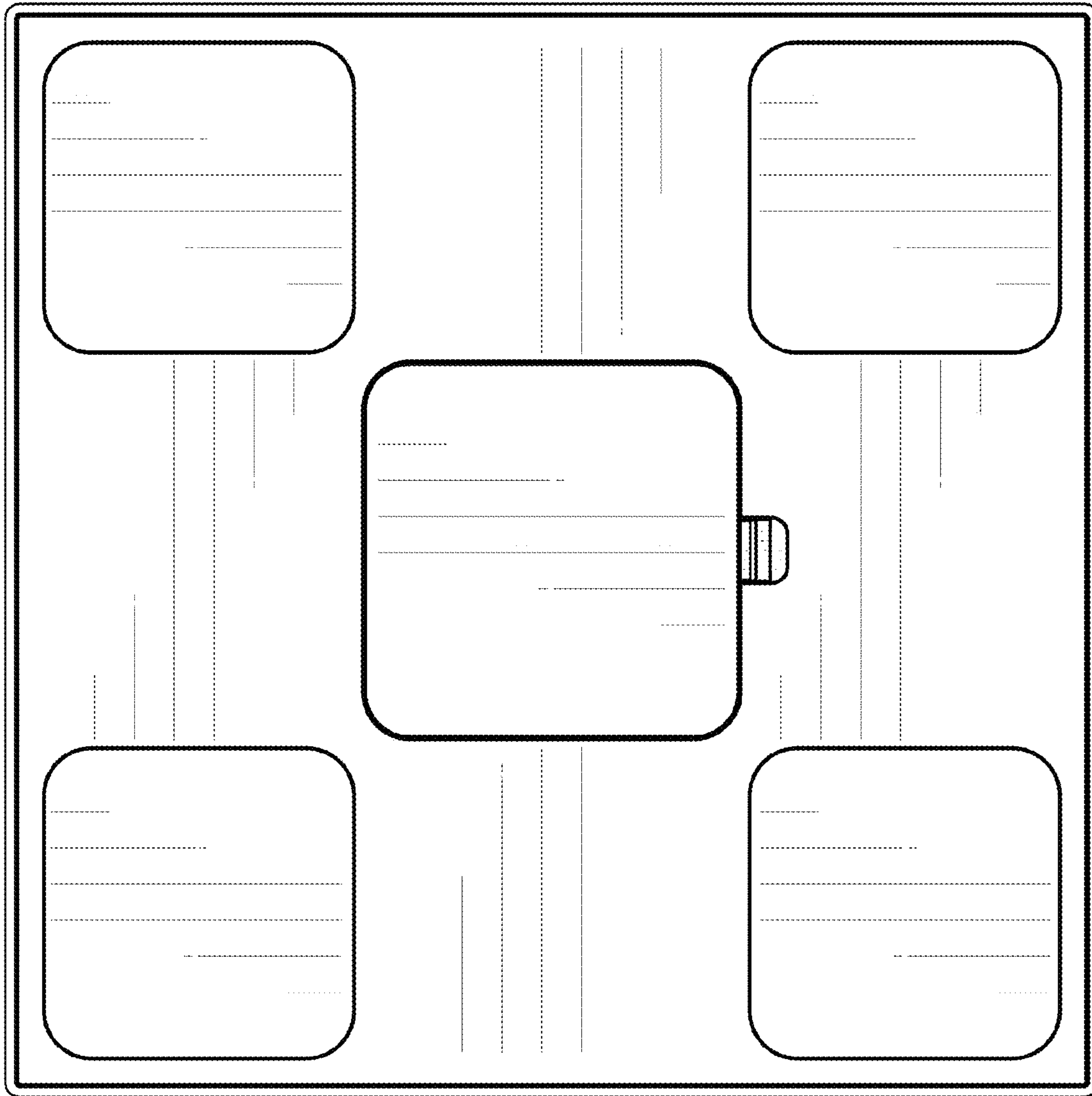
