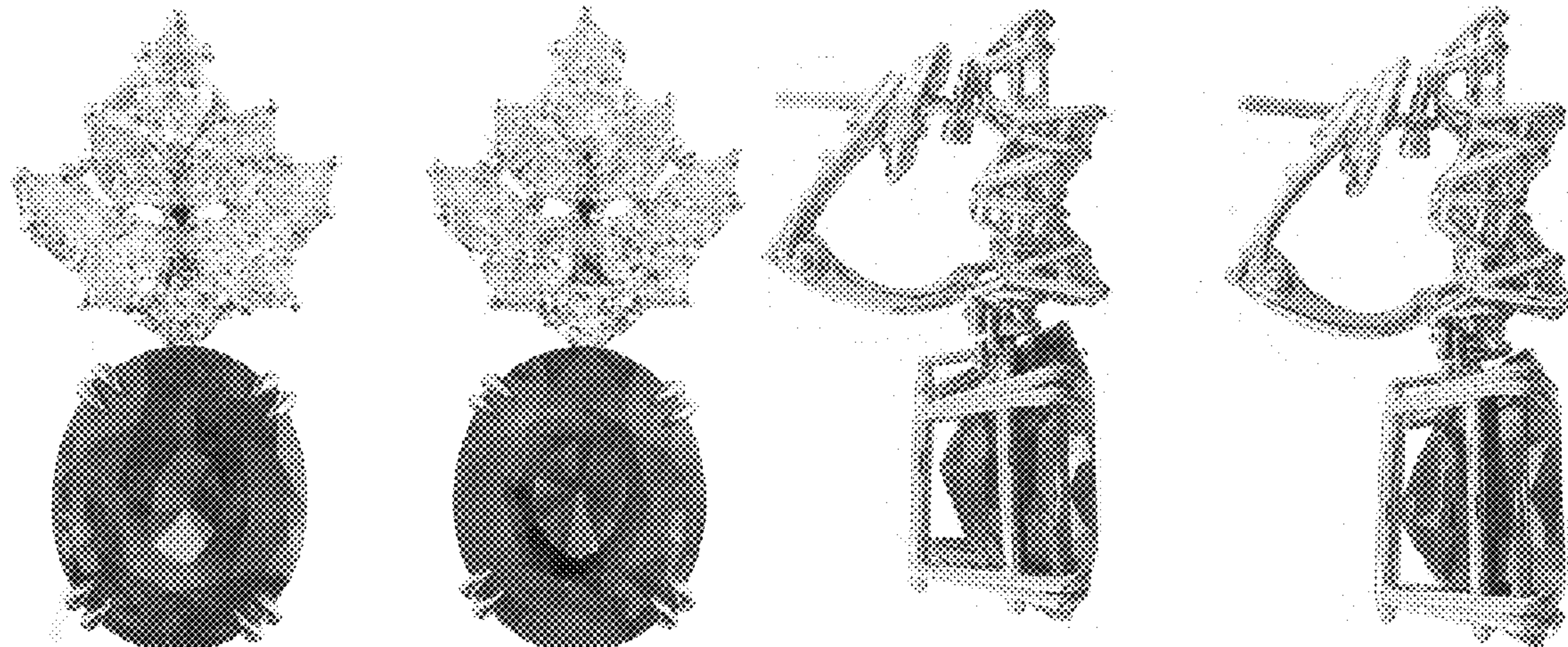


FIG. 7 is a front right perspective view thereof; and,

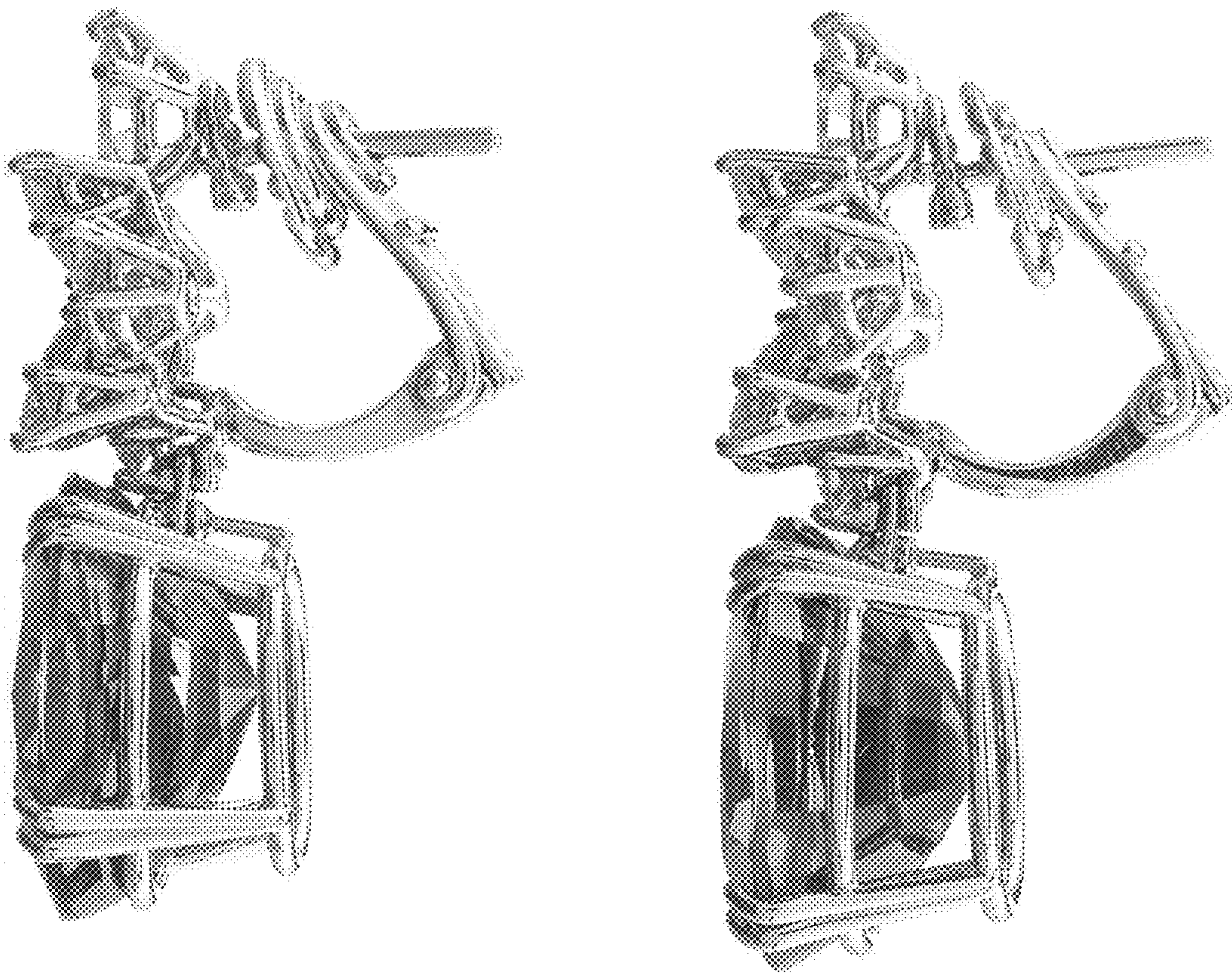

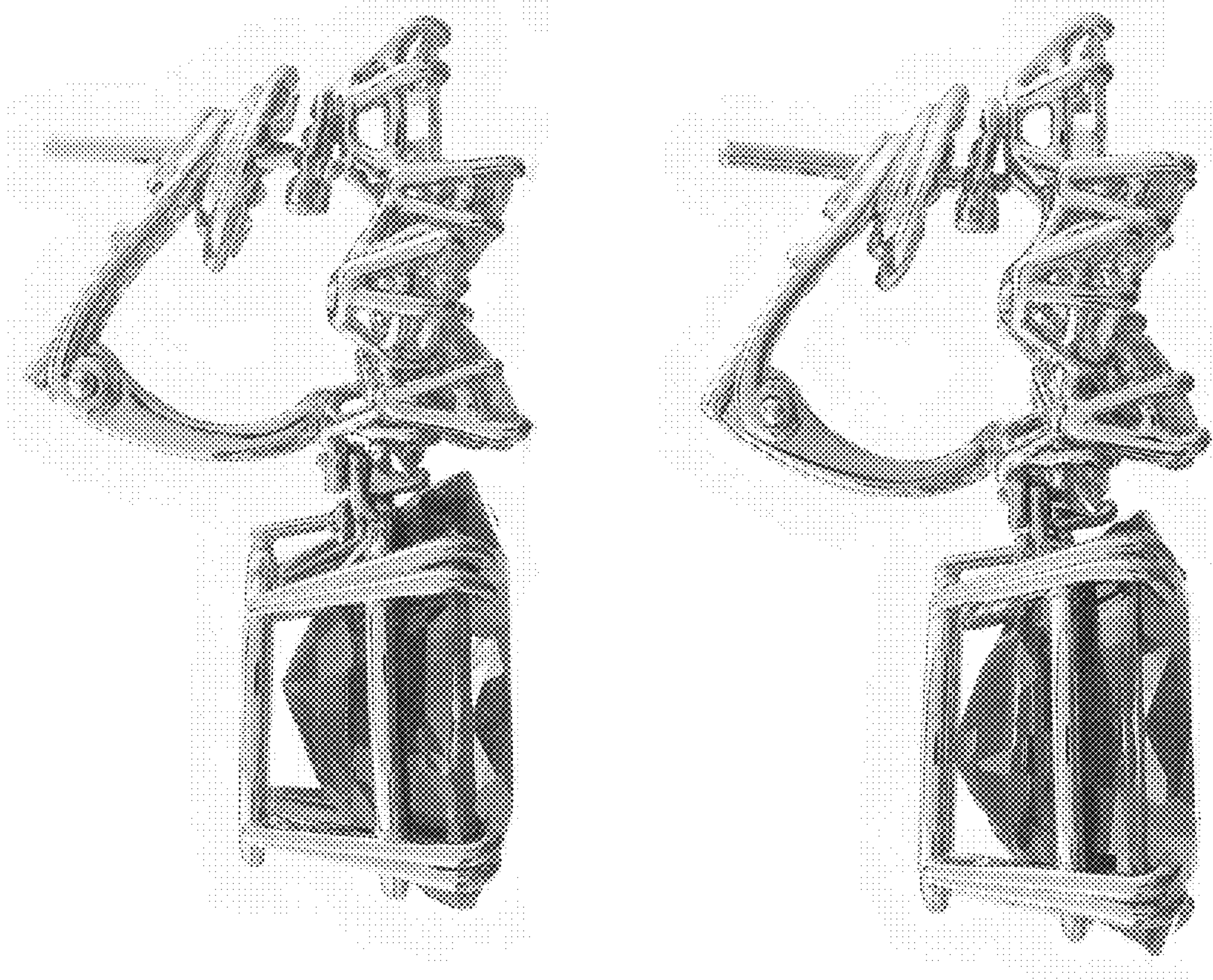

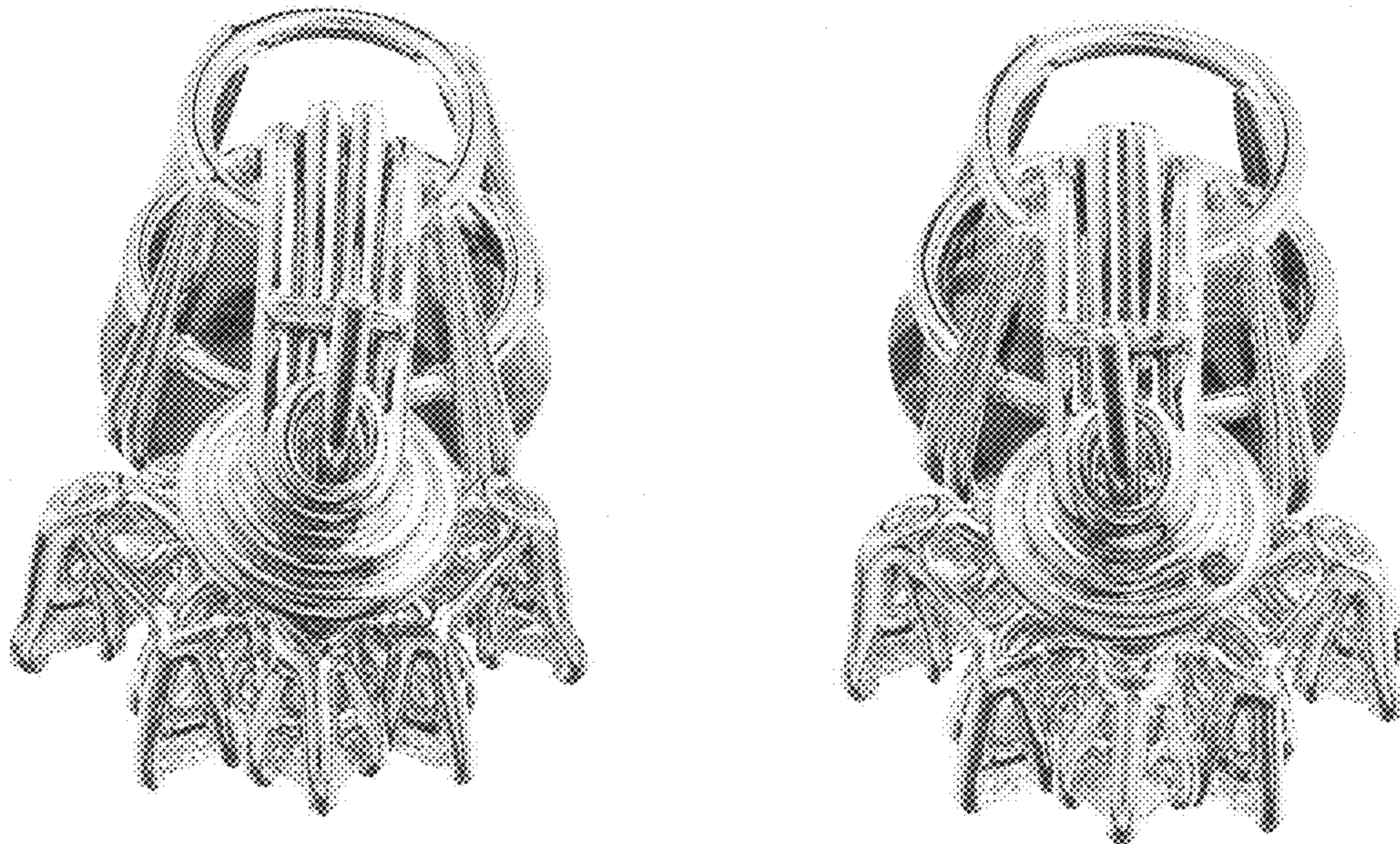

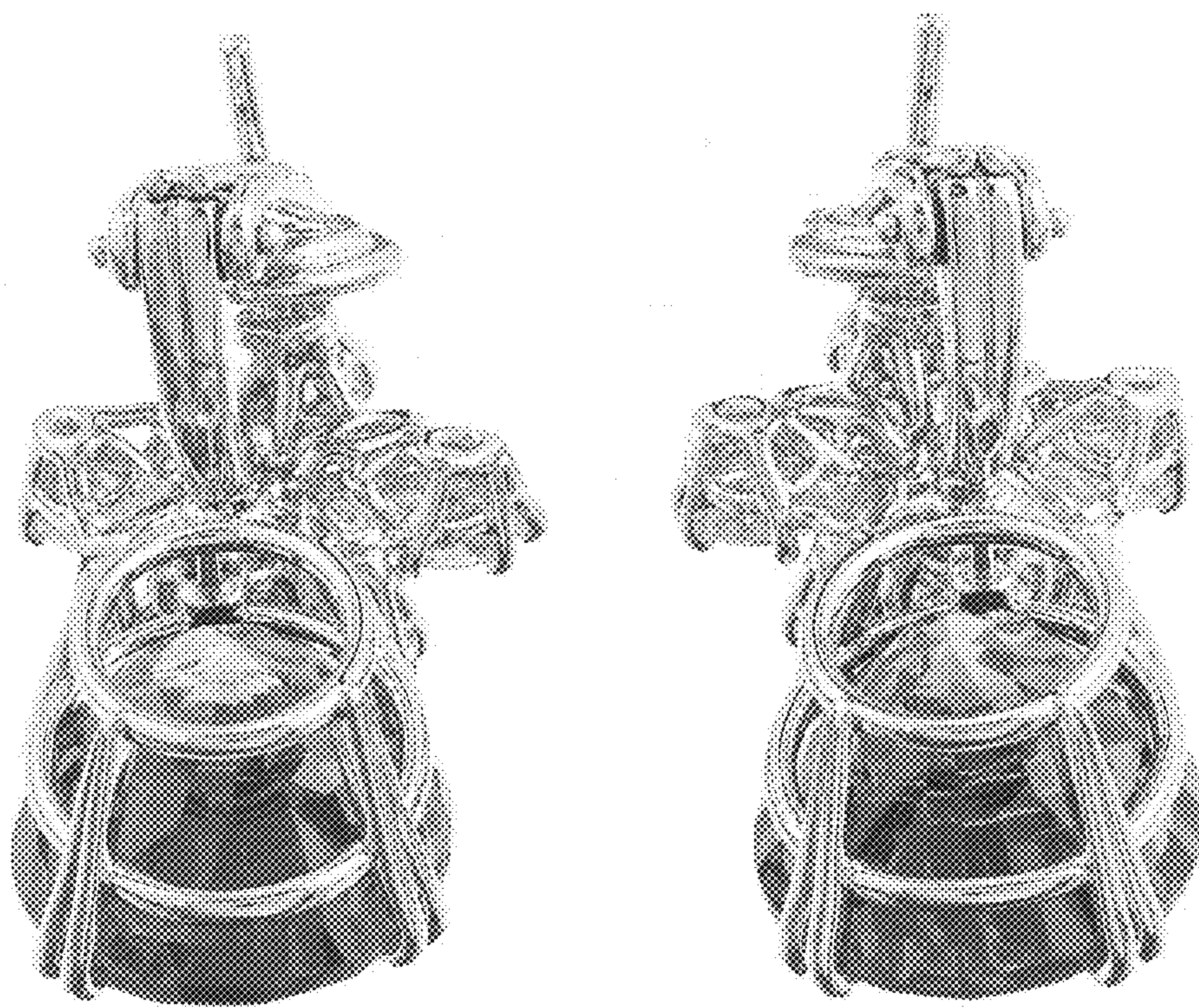

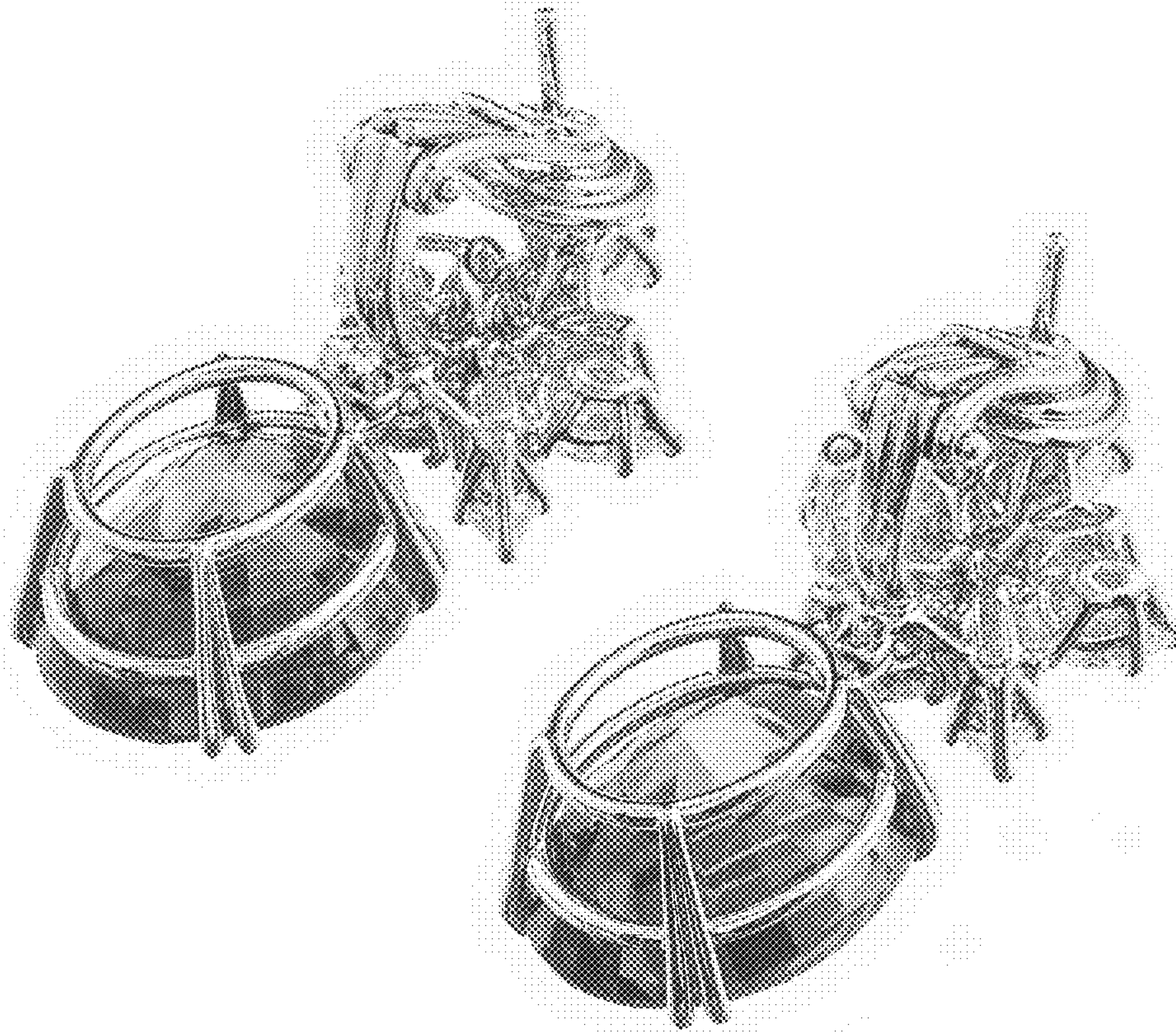
