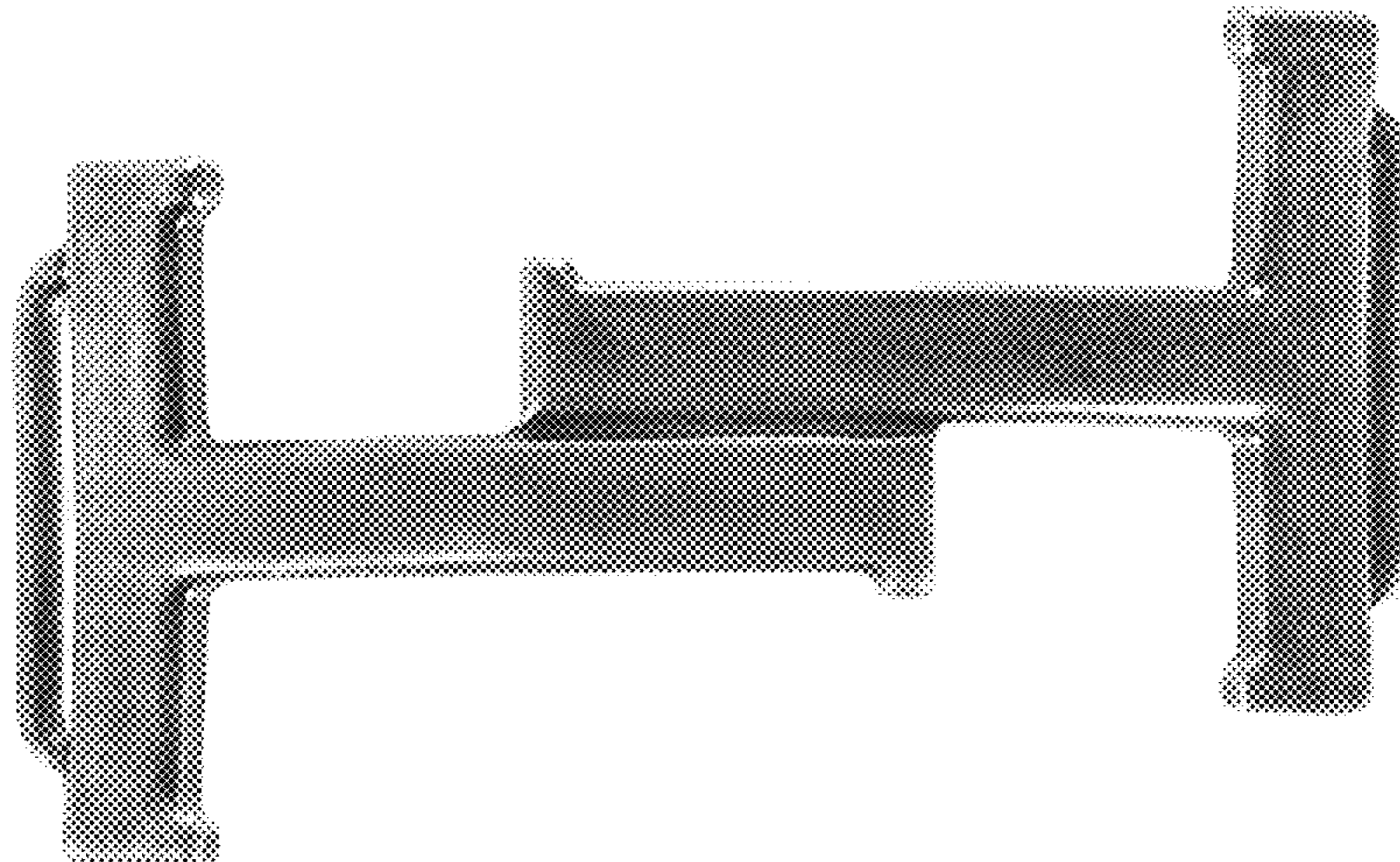
The ornamental design for a buckle, as shown and described.

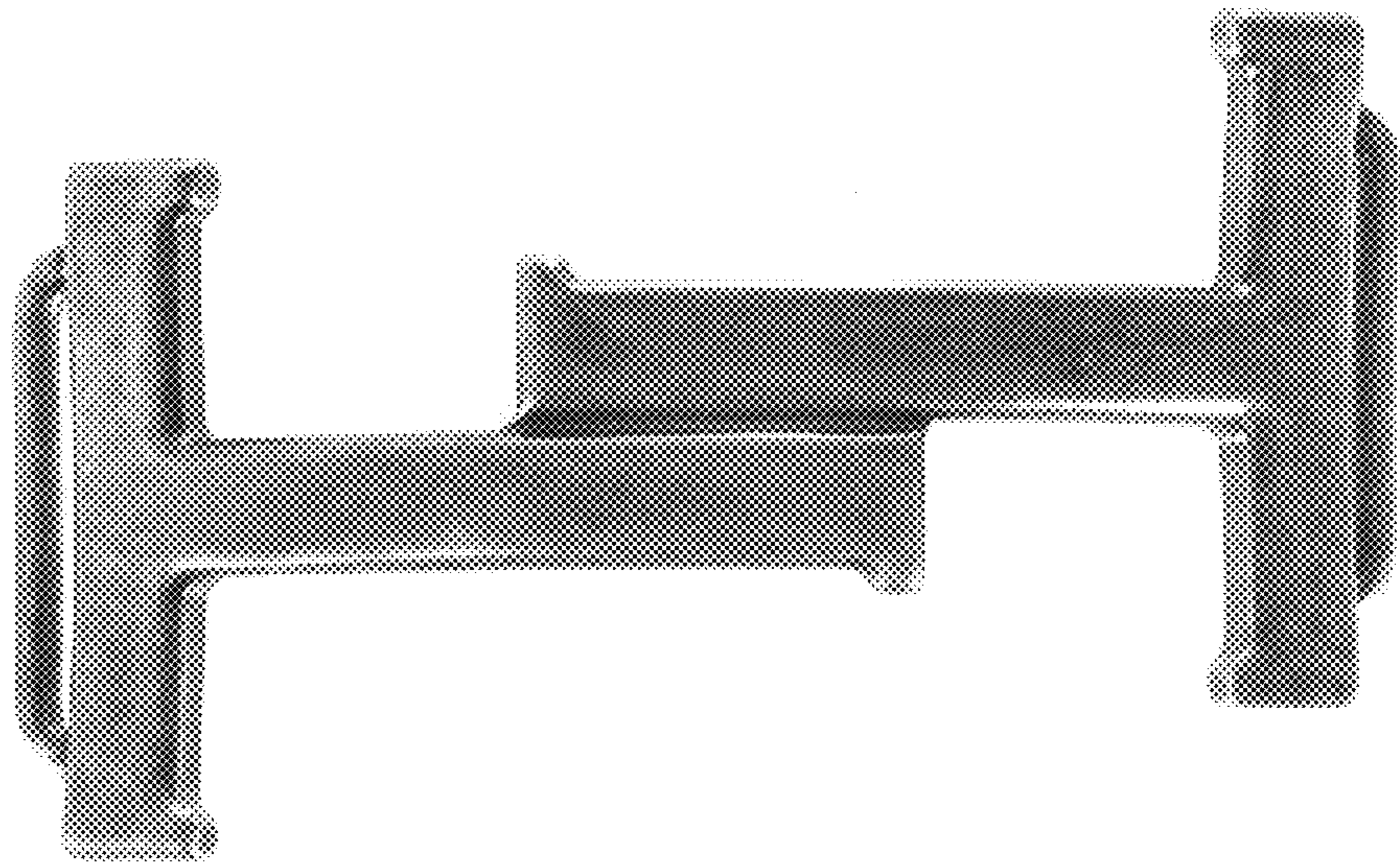

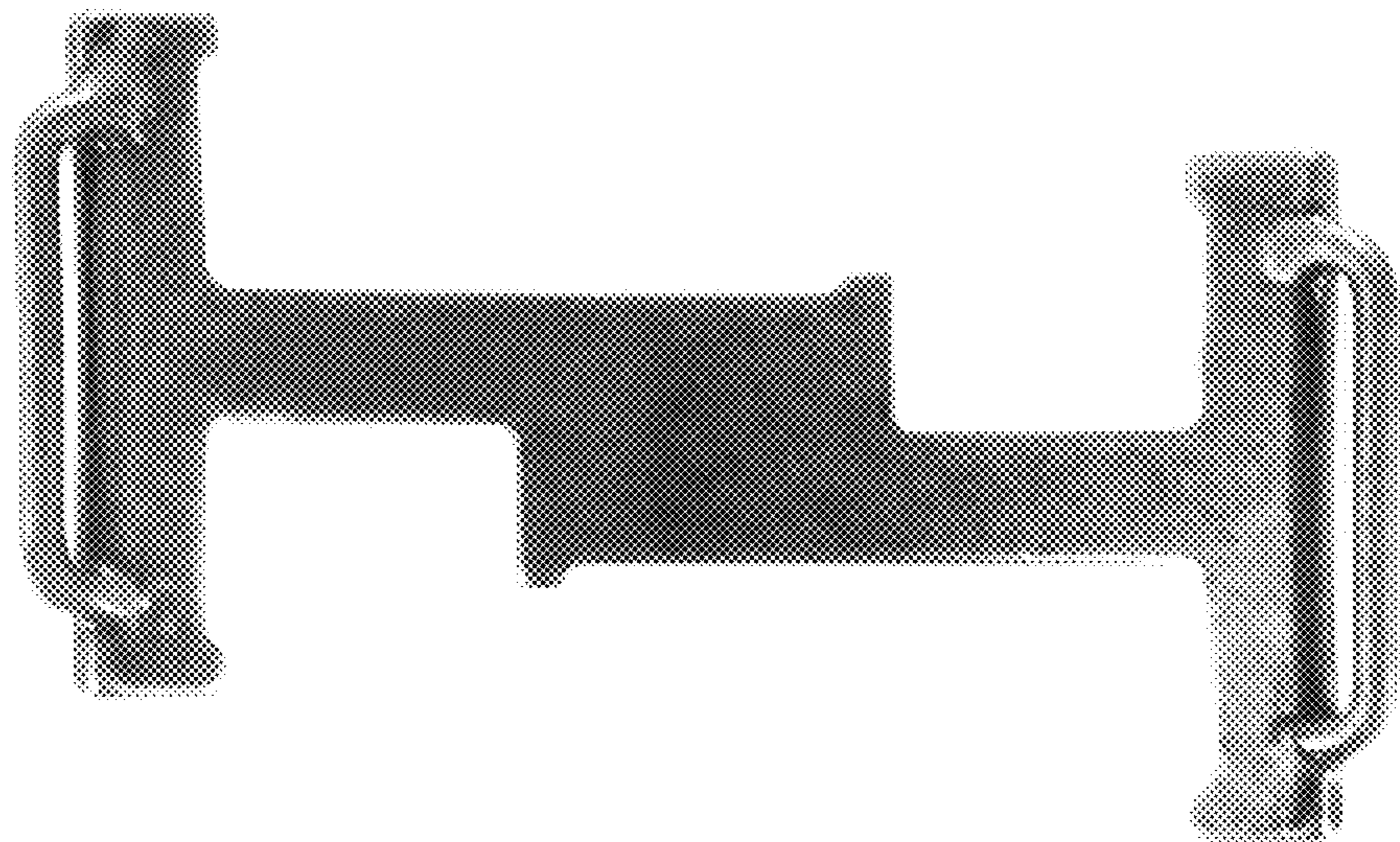

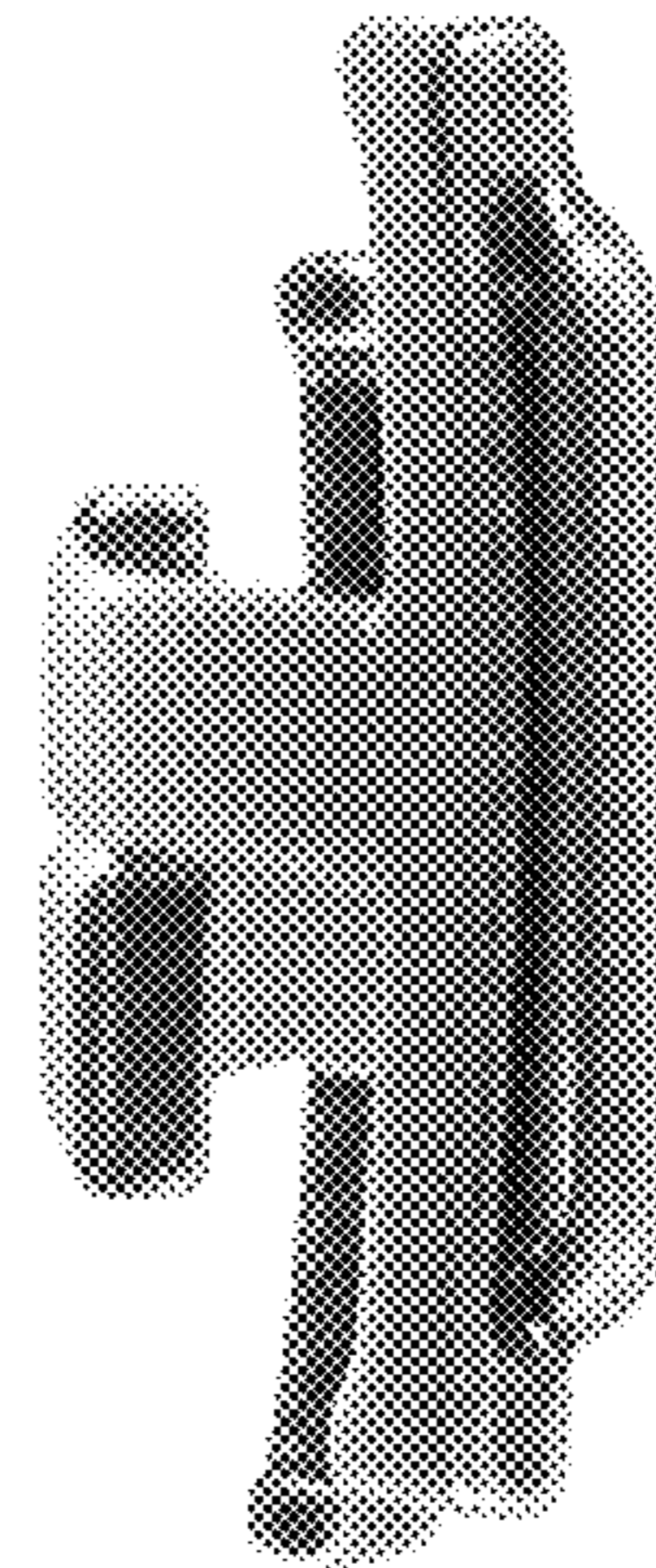

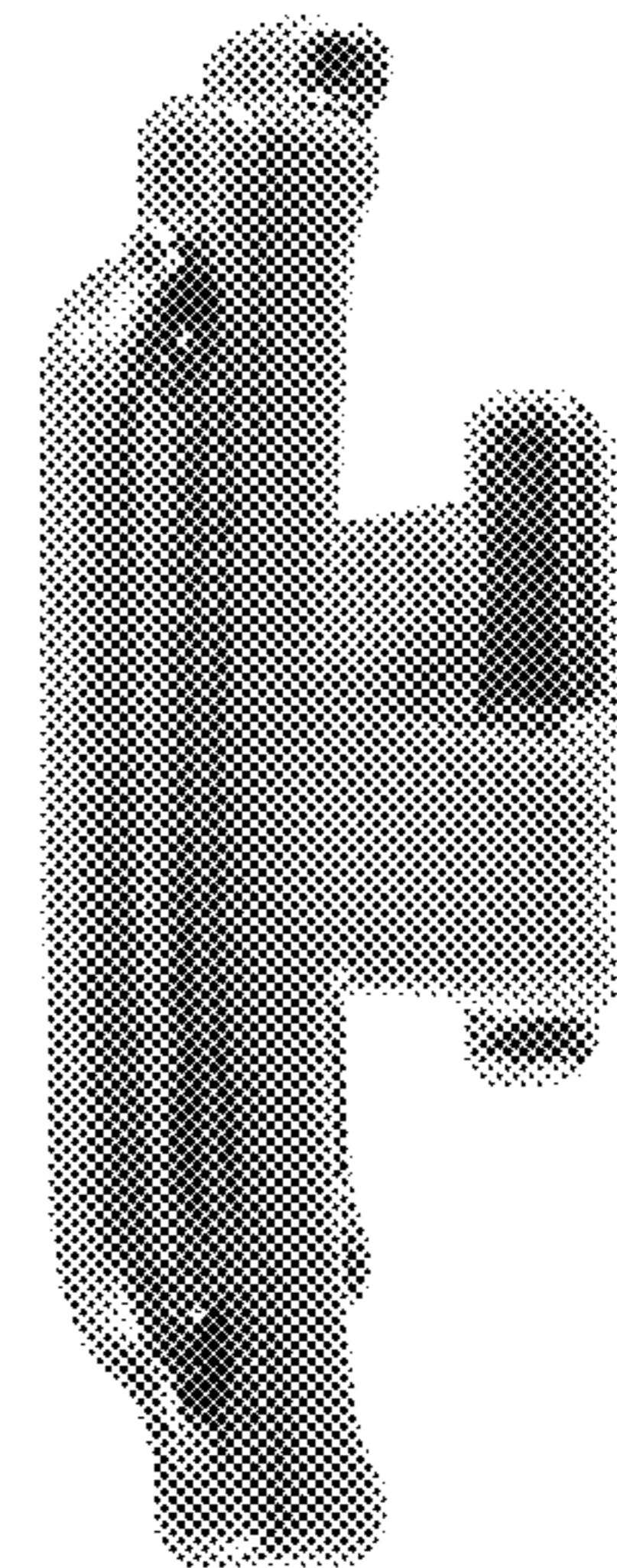
