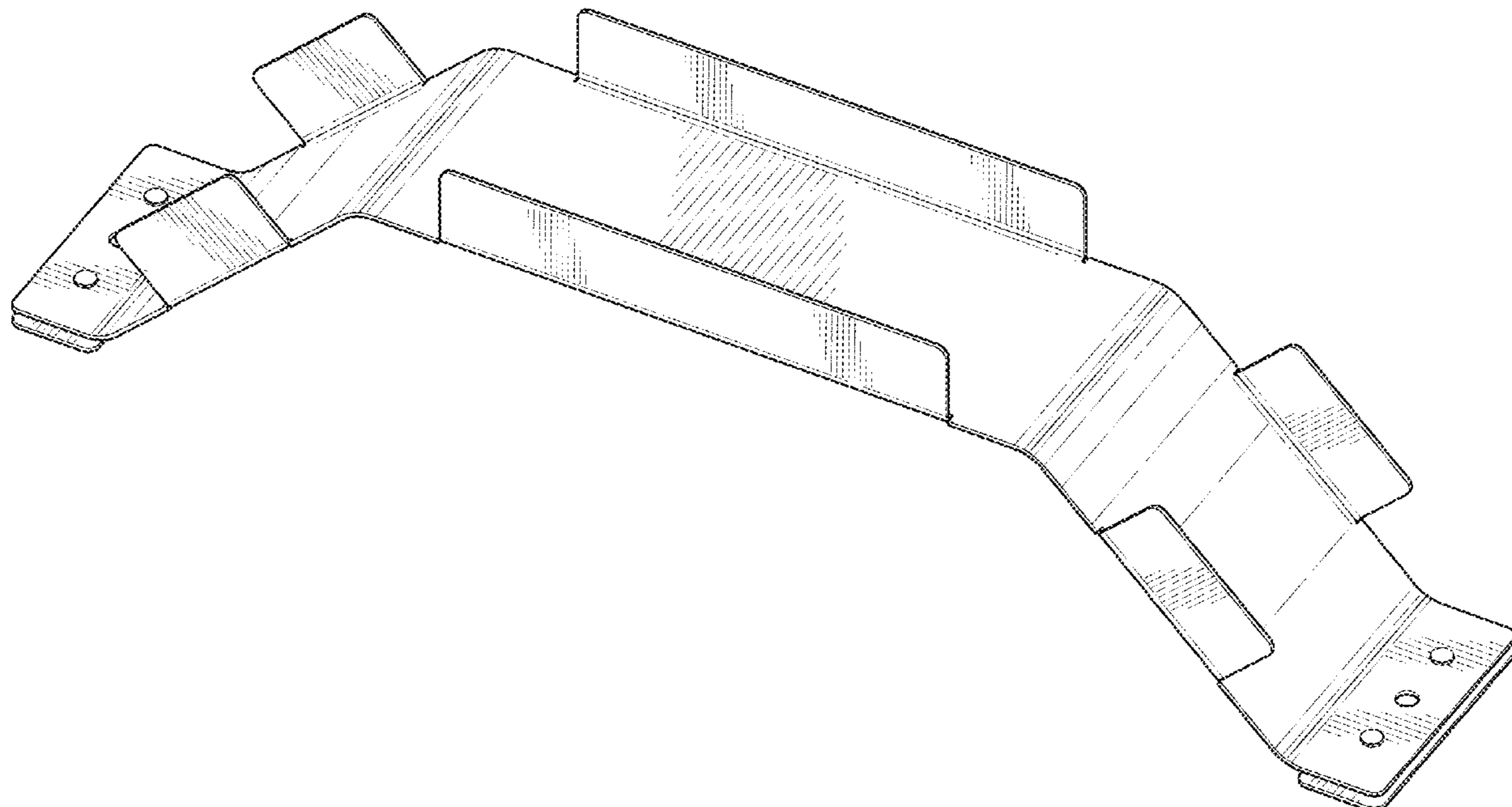
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of the cable management bridge in accordance with the present invention;
 FIG. 2 is a right elevational view of the cable distribution bridge of FIG. 1;
 FIG. 3 is a left elevational view of the cable distribution bridge of FIG. 1;
 FIG. 4 is a front elevational view of the cable distribution bridge of FIG. 1;

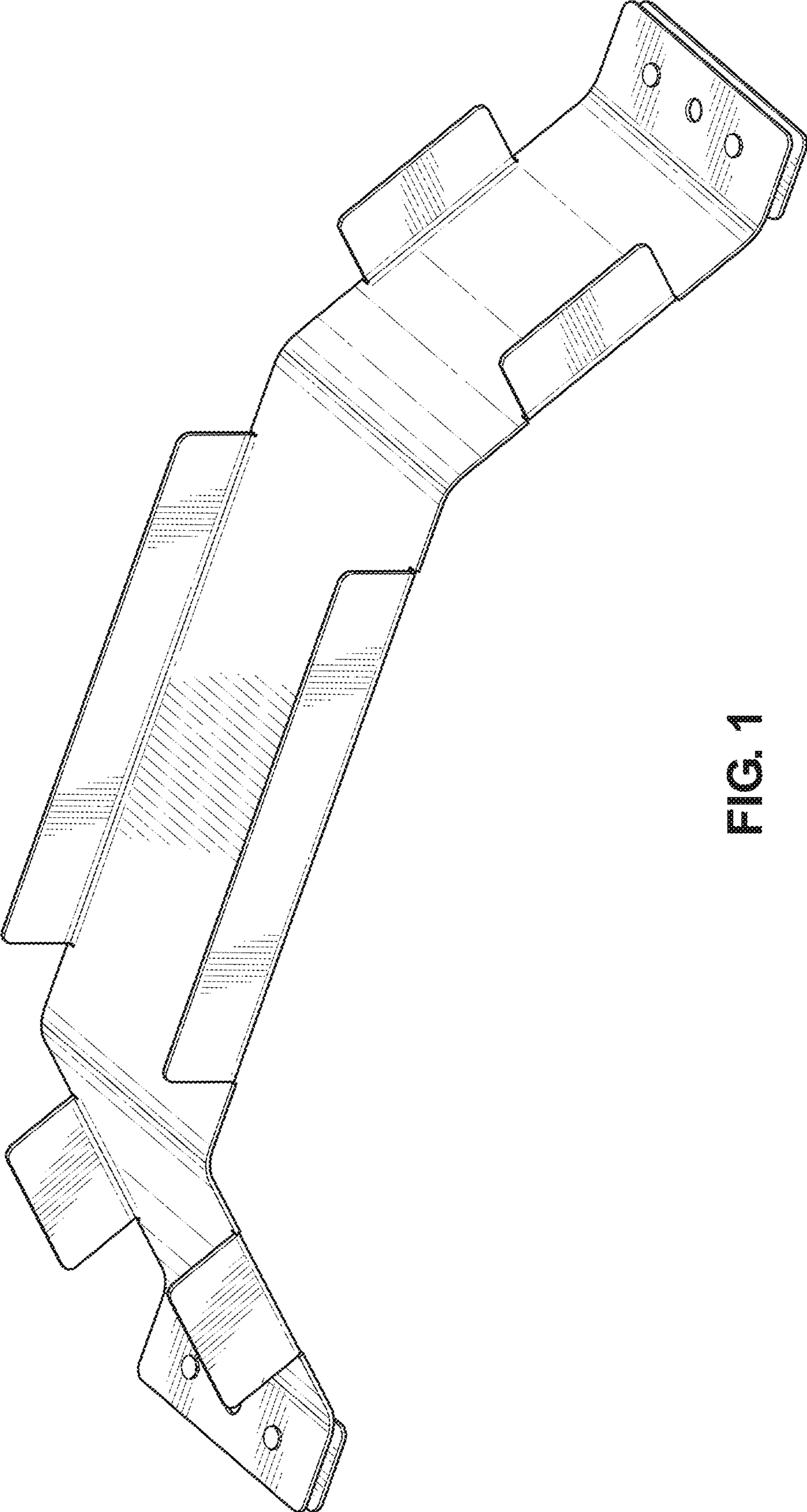

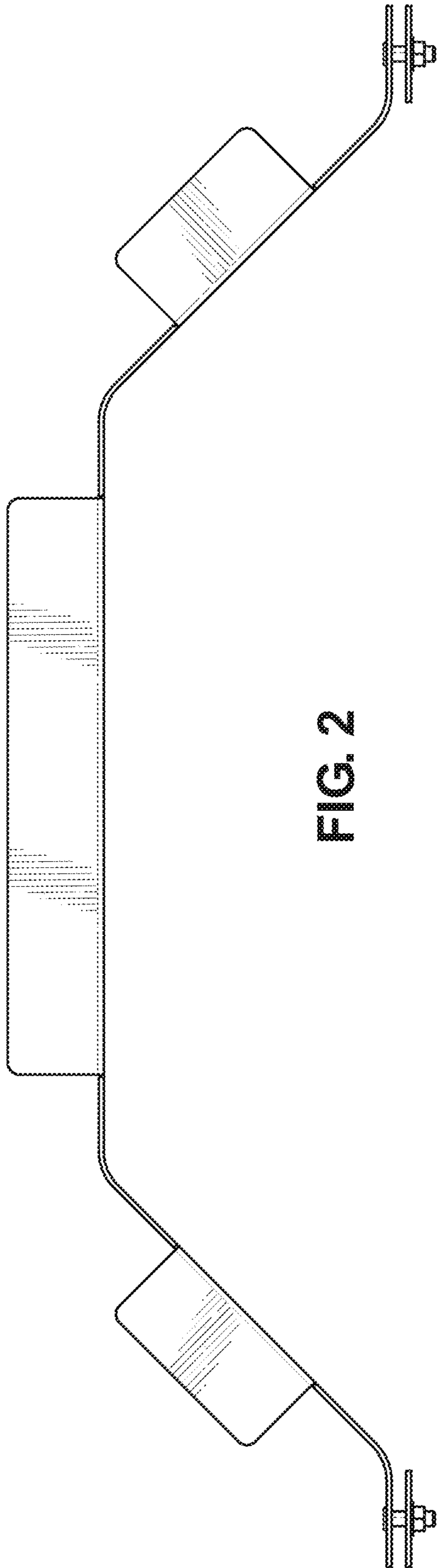

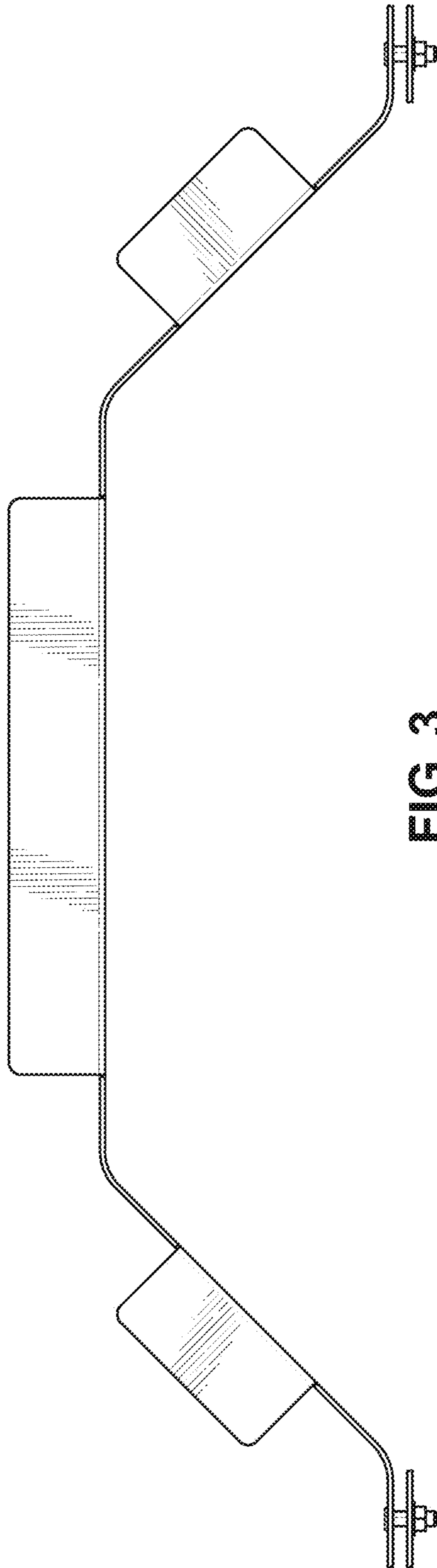

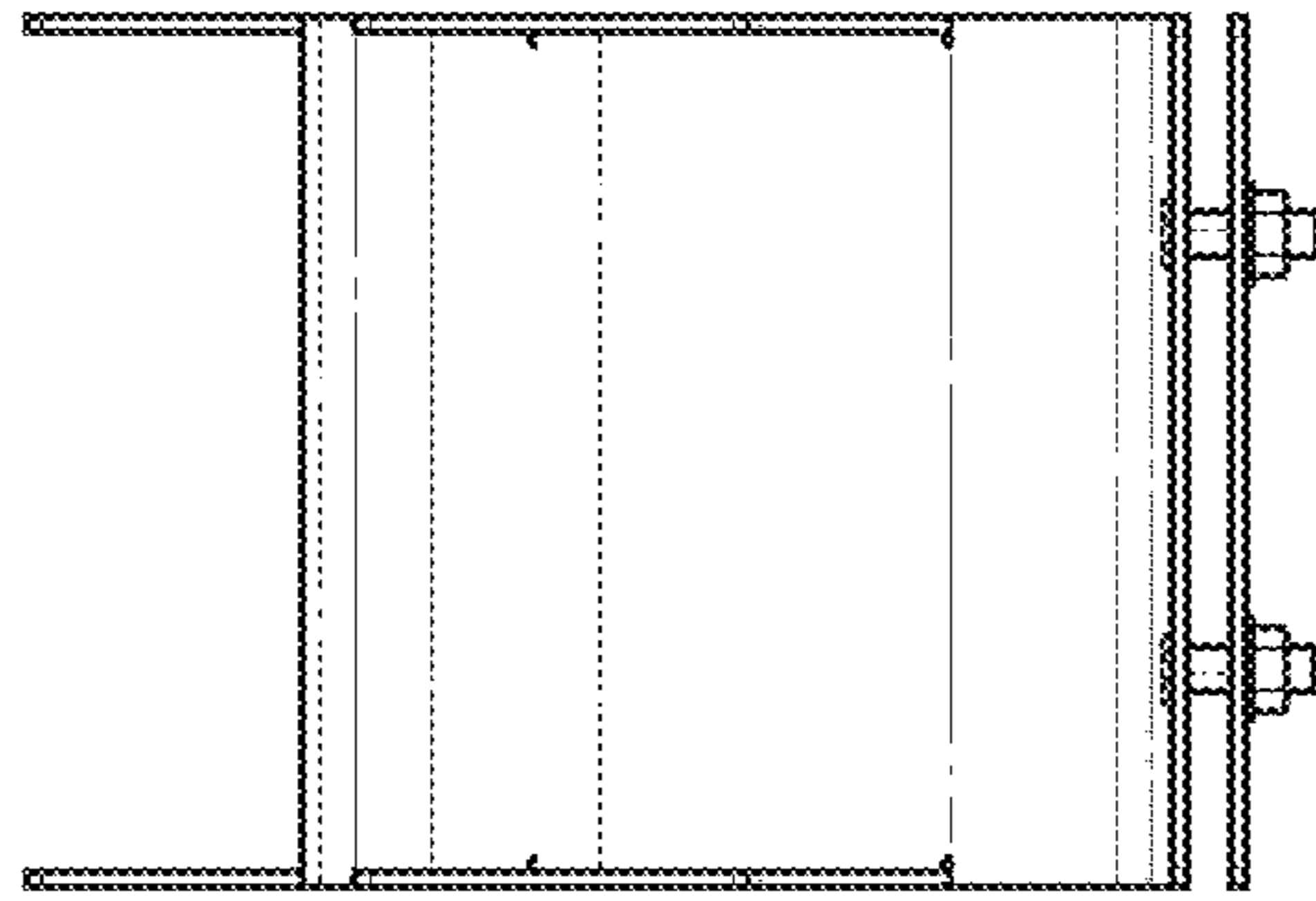

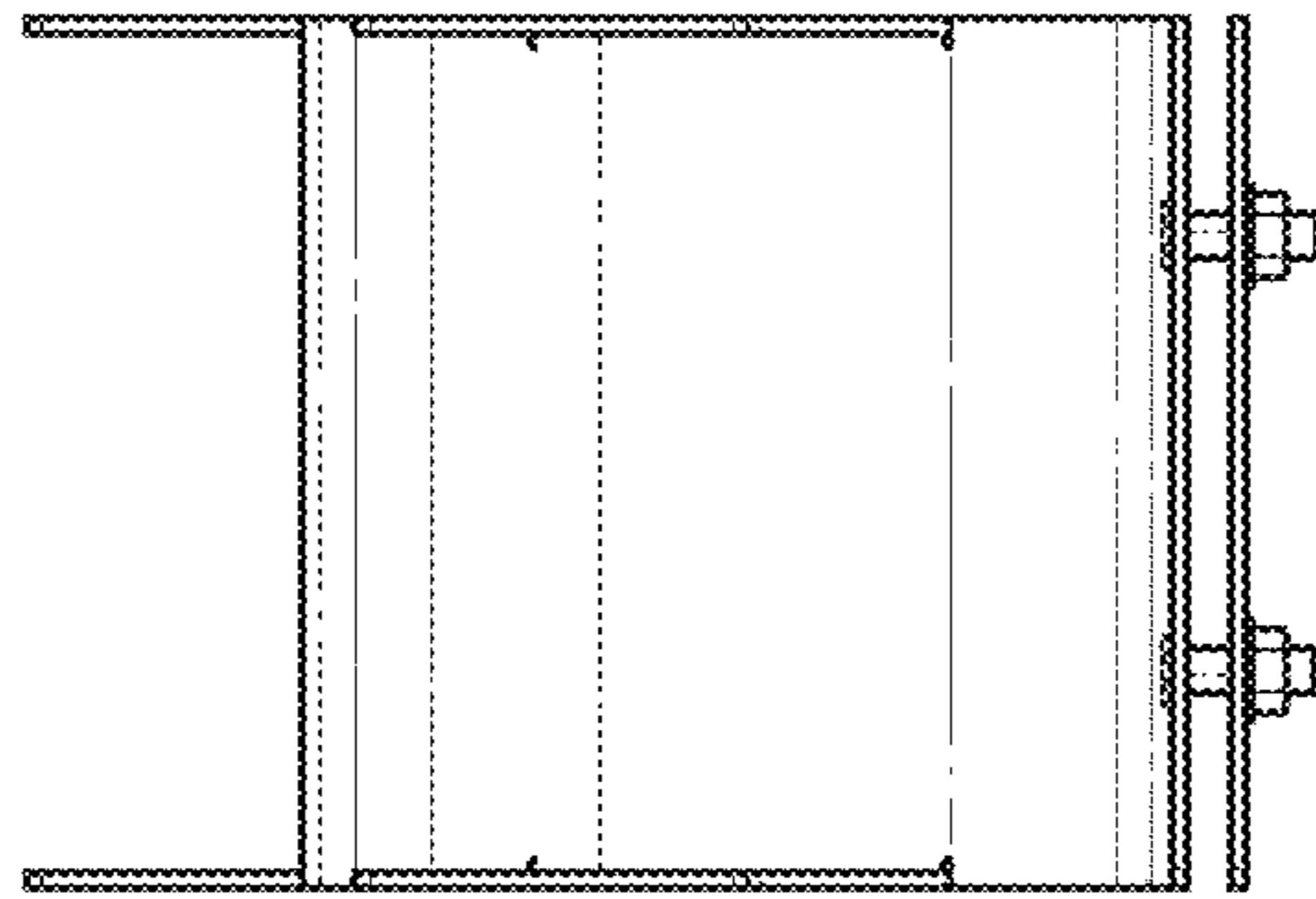

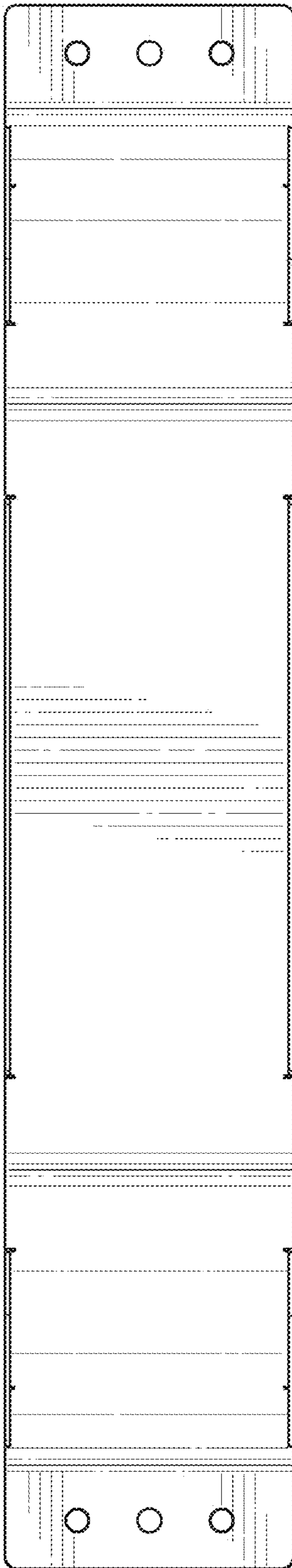

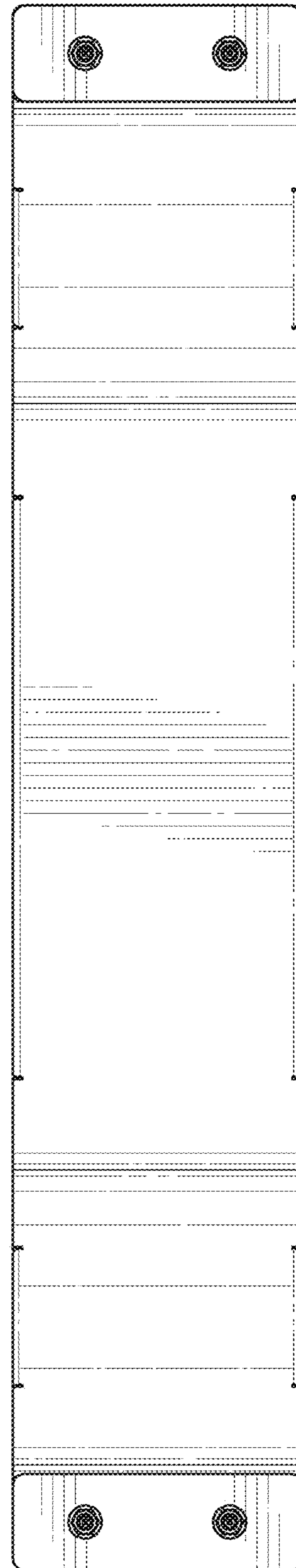
