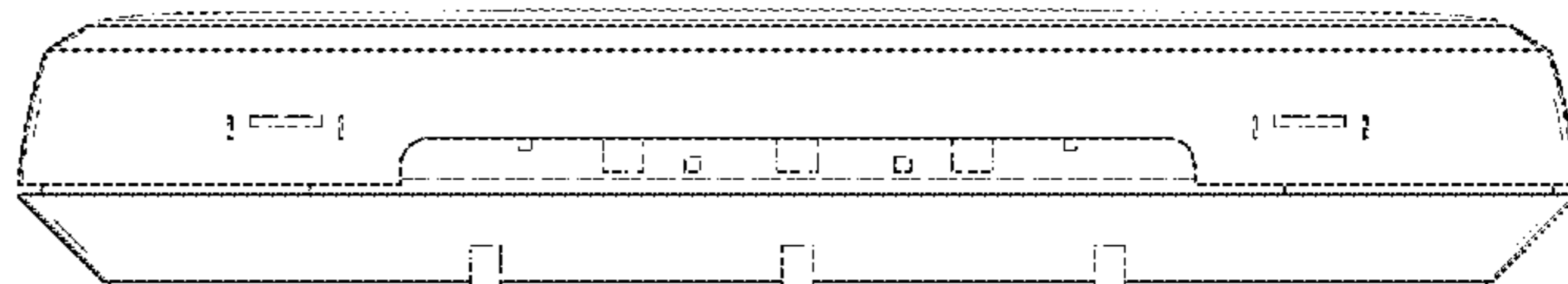
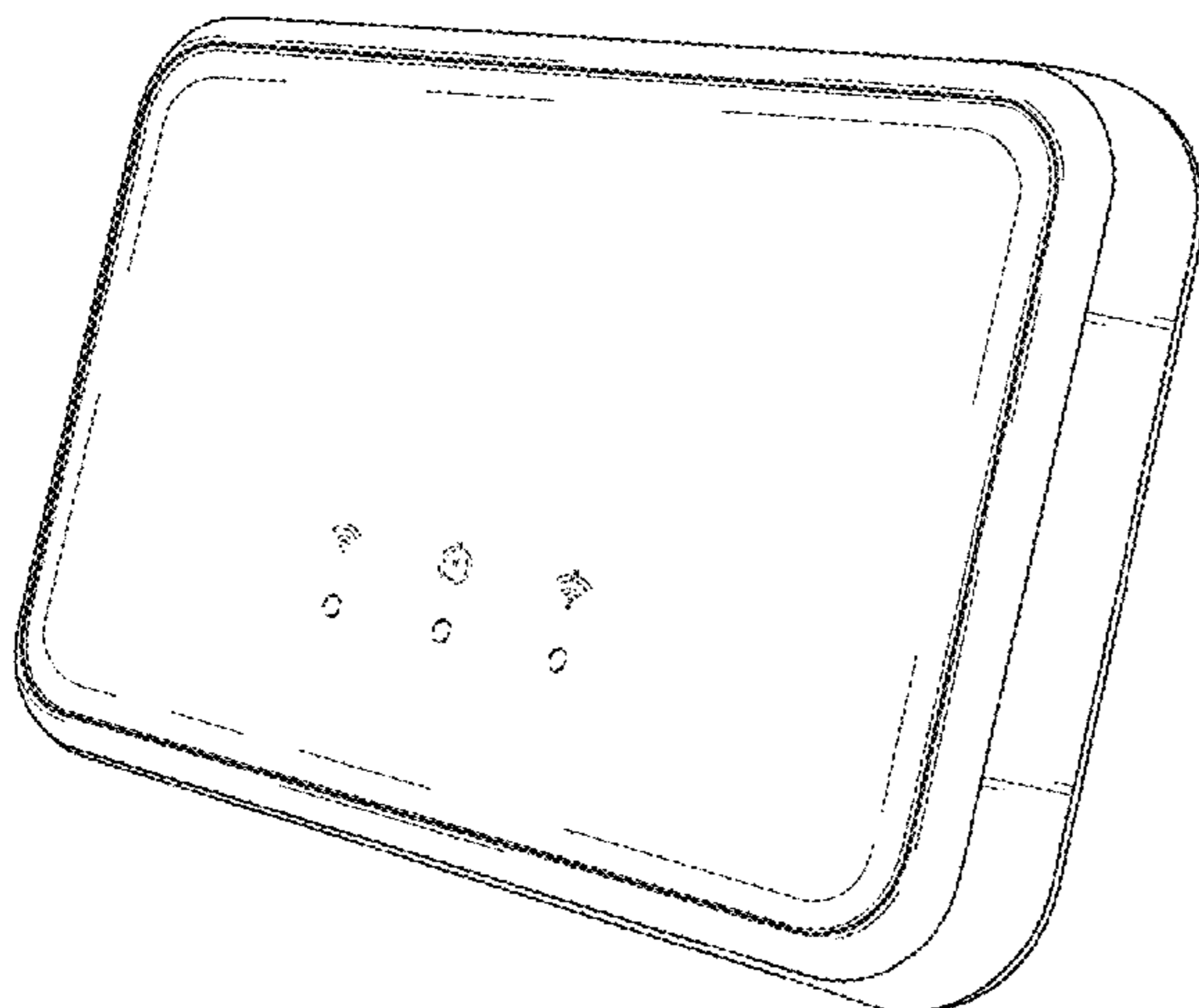
(57) **CLAIM**

An ornamental design for a wall mountable wireless network communication device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wall mountable wireless network communication device.
FIG. 2 is a front elevation view thereof.
FIG. 3 is a right side elevation view thereof, the left side being a mirror-image of the right side elevation view.
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines in the drawings depict portions of the wall mountable wireless network communication device in which the design is embodied that form no part of the claimed design.

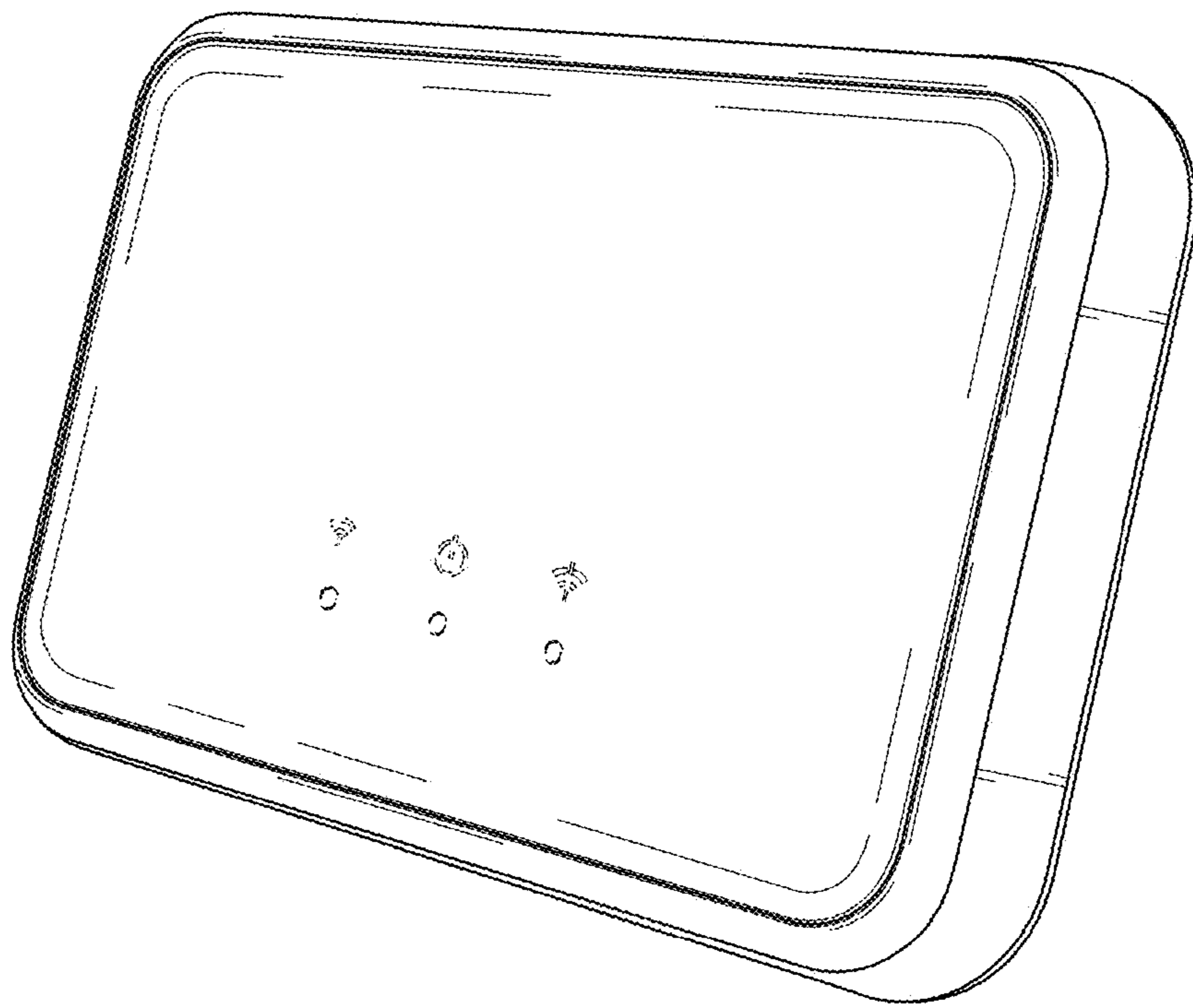

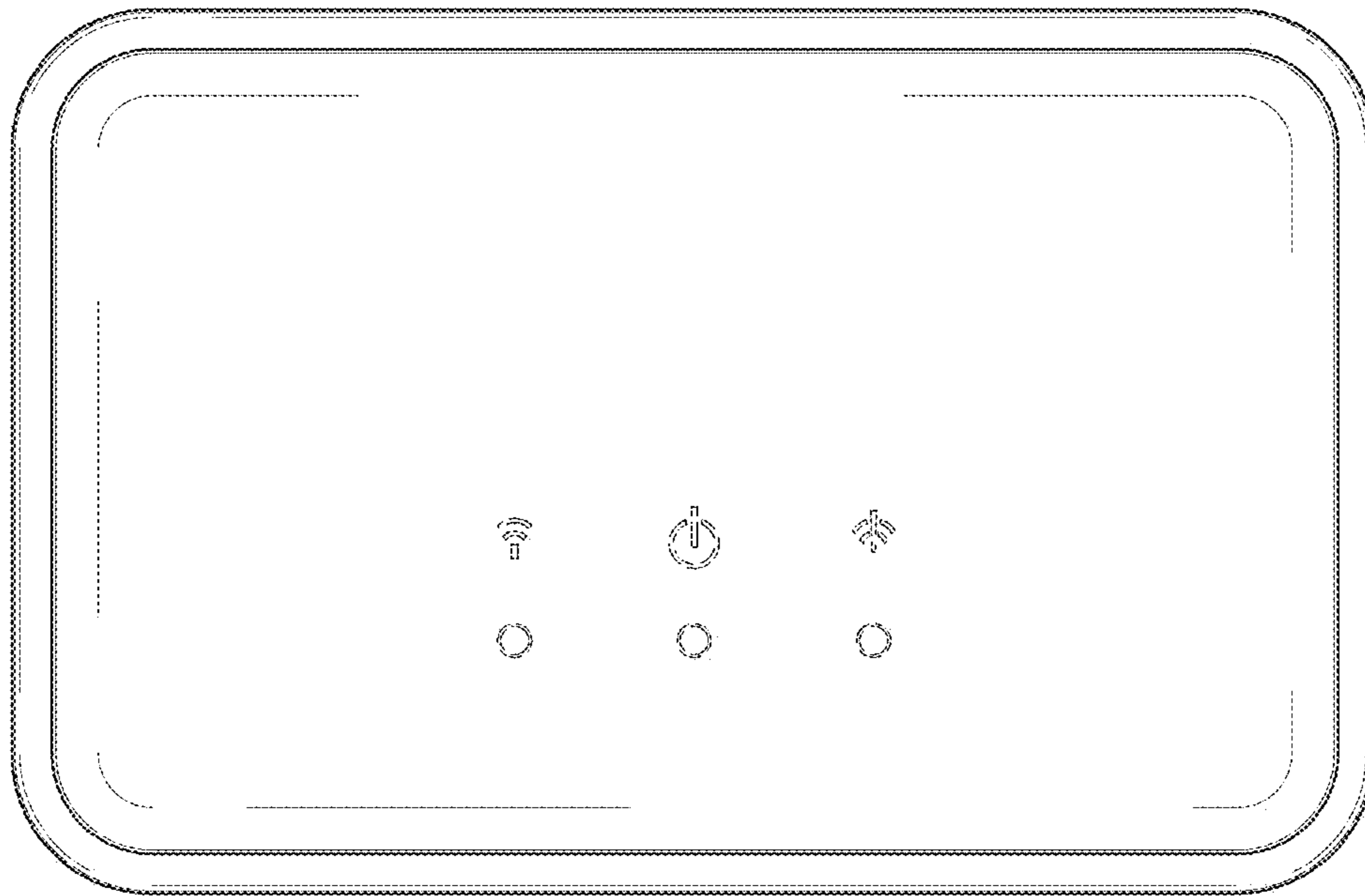

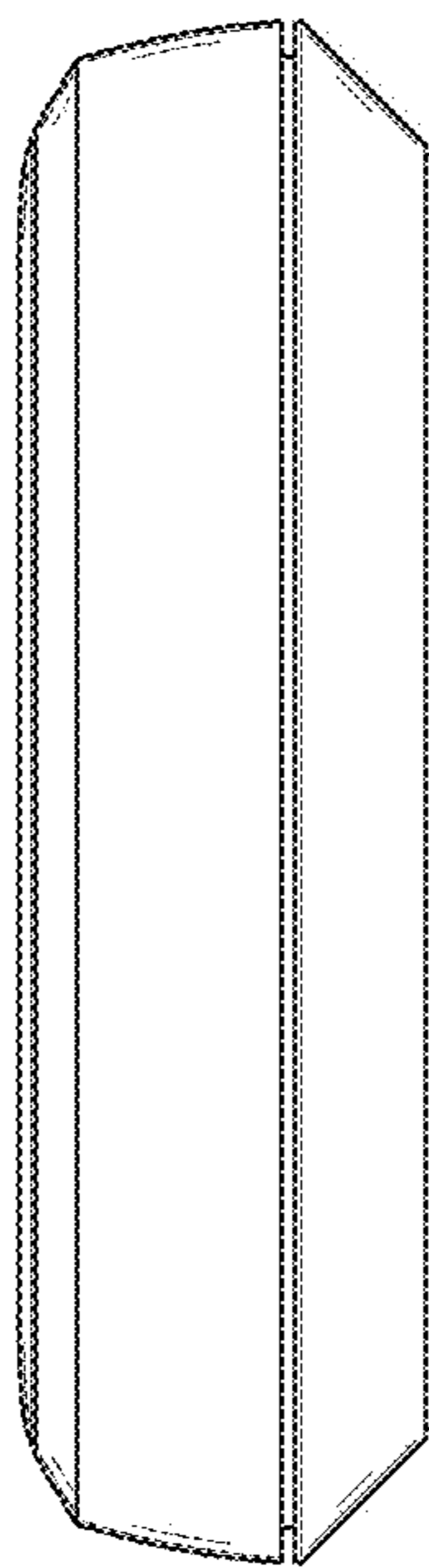

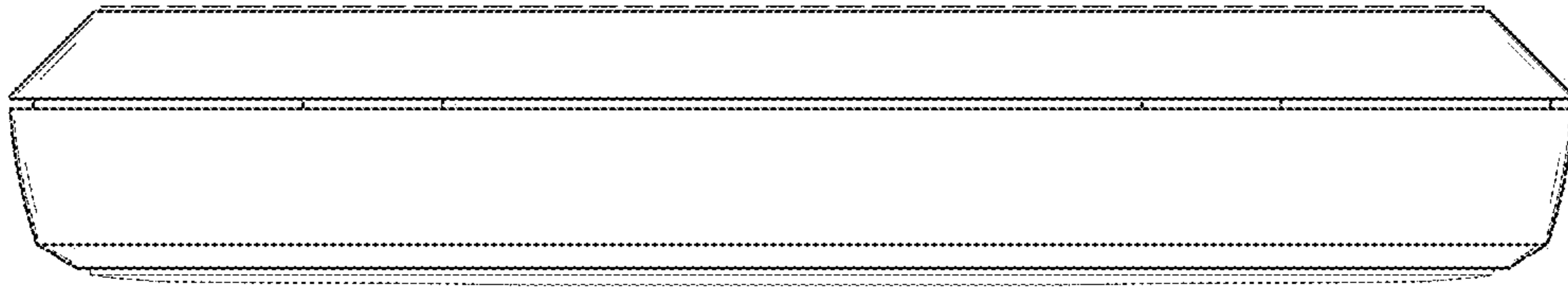

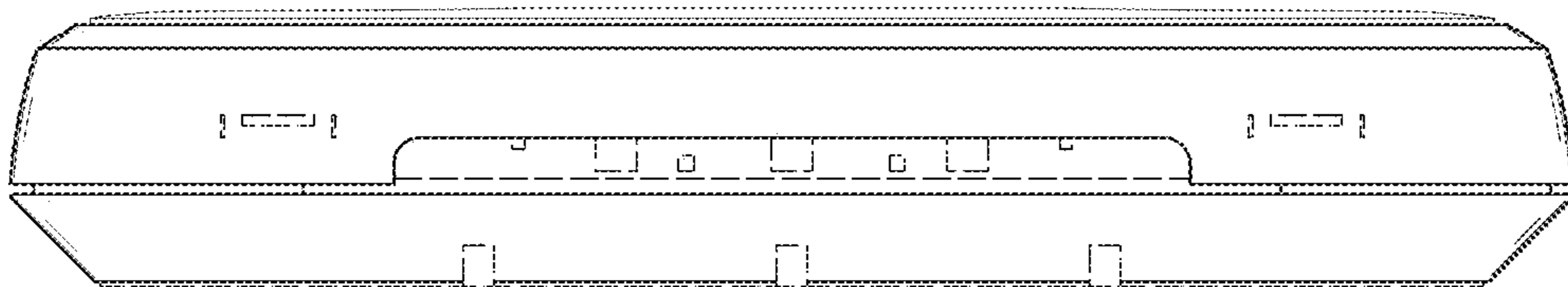
