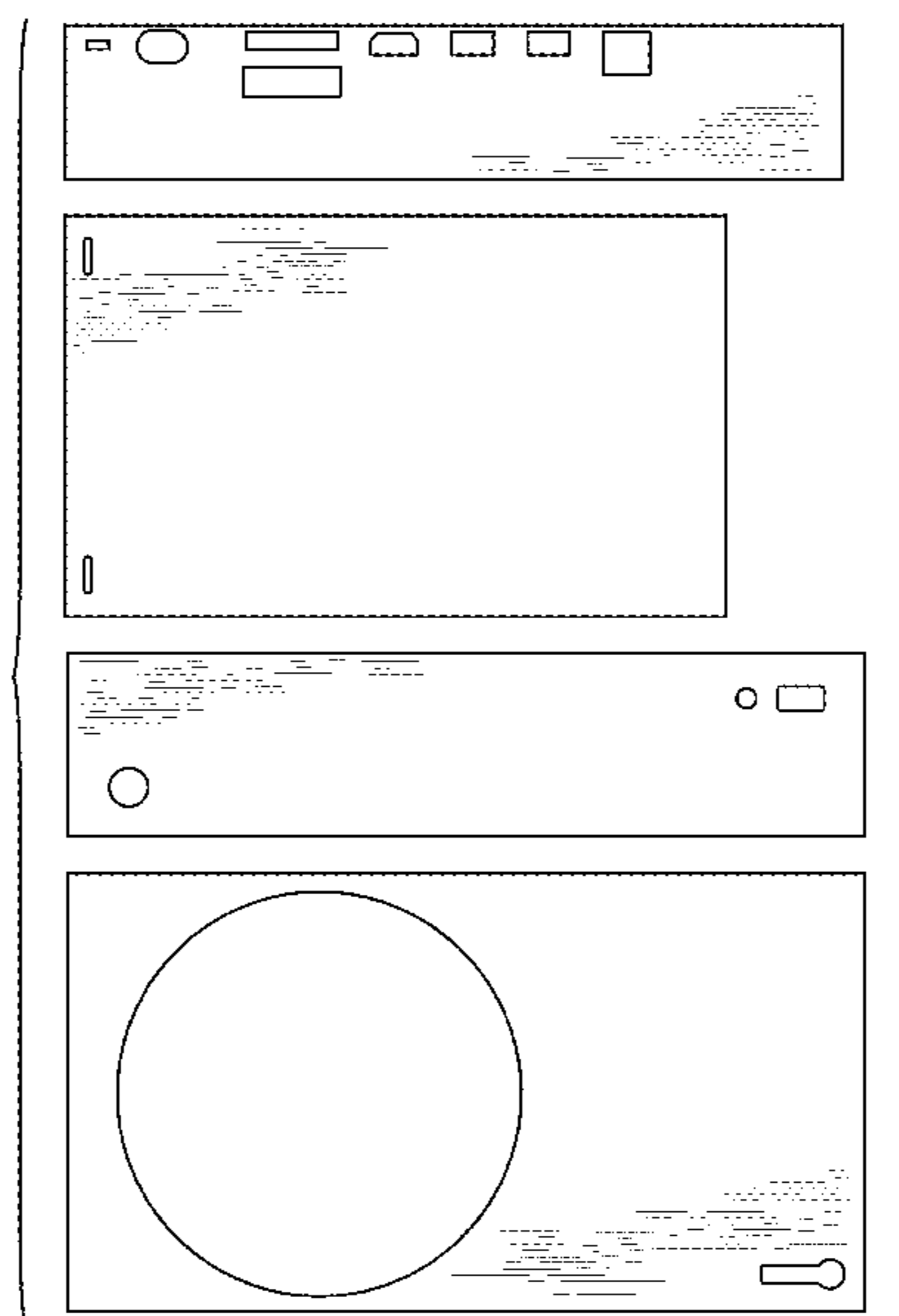
(57) **CLAIM**

The ornamental design for a skin cover set for a gaining console, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view for a skin cover set for a gaining console showing my new design; FIG. 2 is a left side elevation view; FIG. 3 is a right-side elevation view; FIG. 4 is a front elevation view in use. FIG. 5 is a rear elevation view in use; and, FIG. 6 is a top perspective view in an environment of use. The broken lines in FIG. 6 show the environmental feature of a gaining console and forms no part of the claimed design.

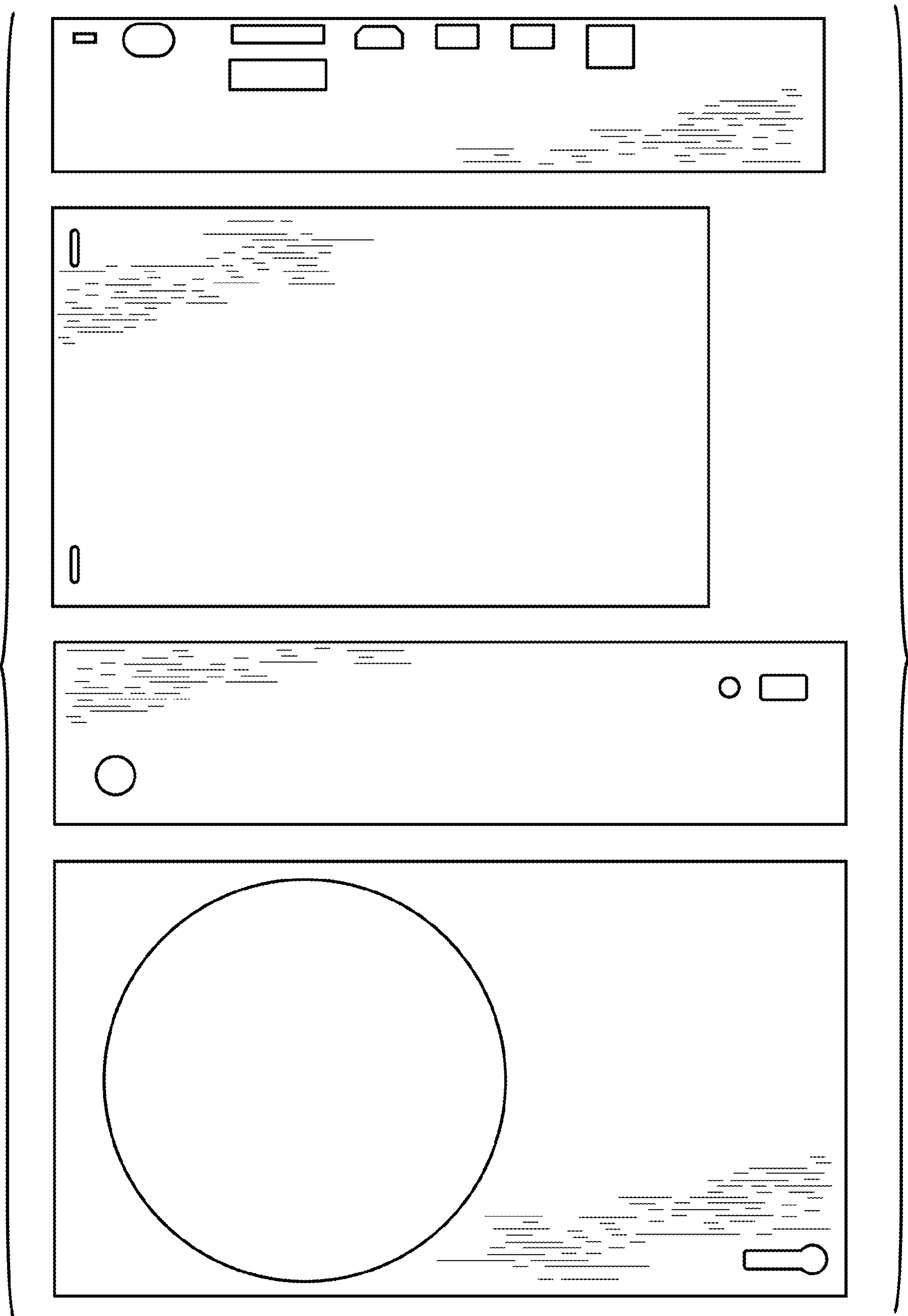

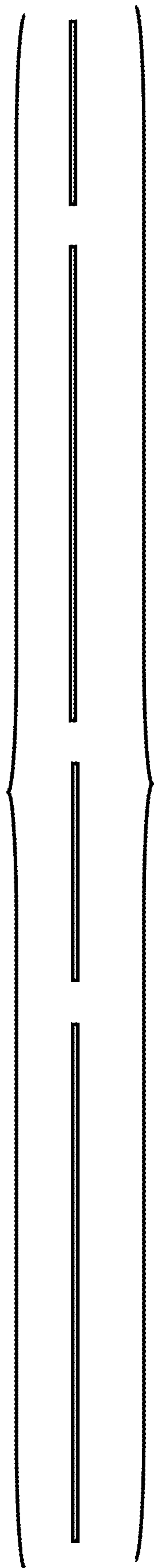

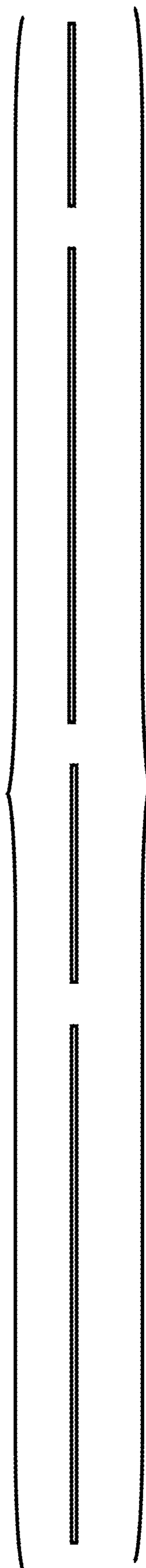

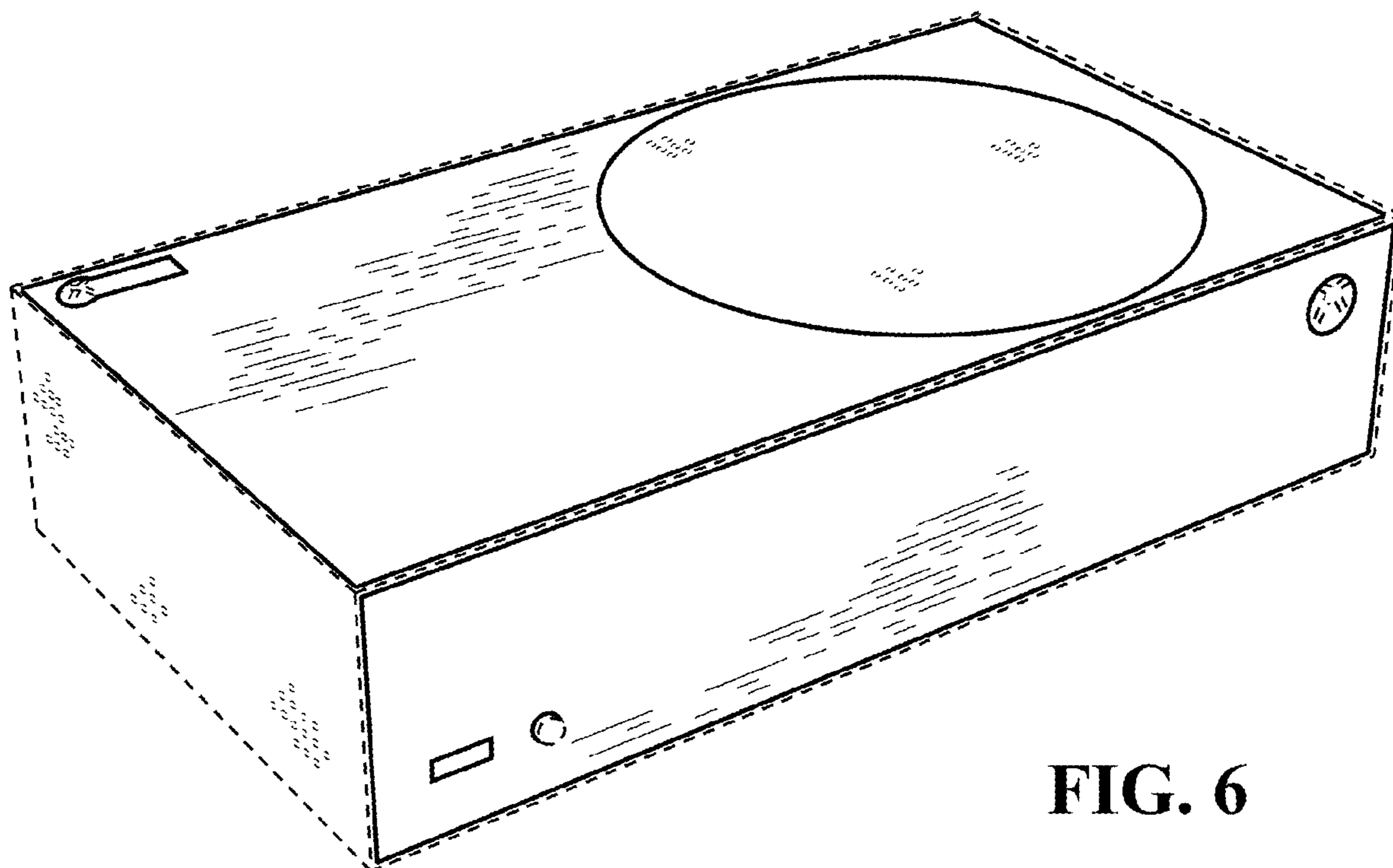
