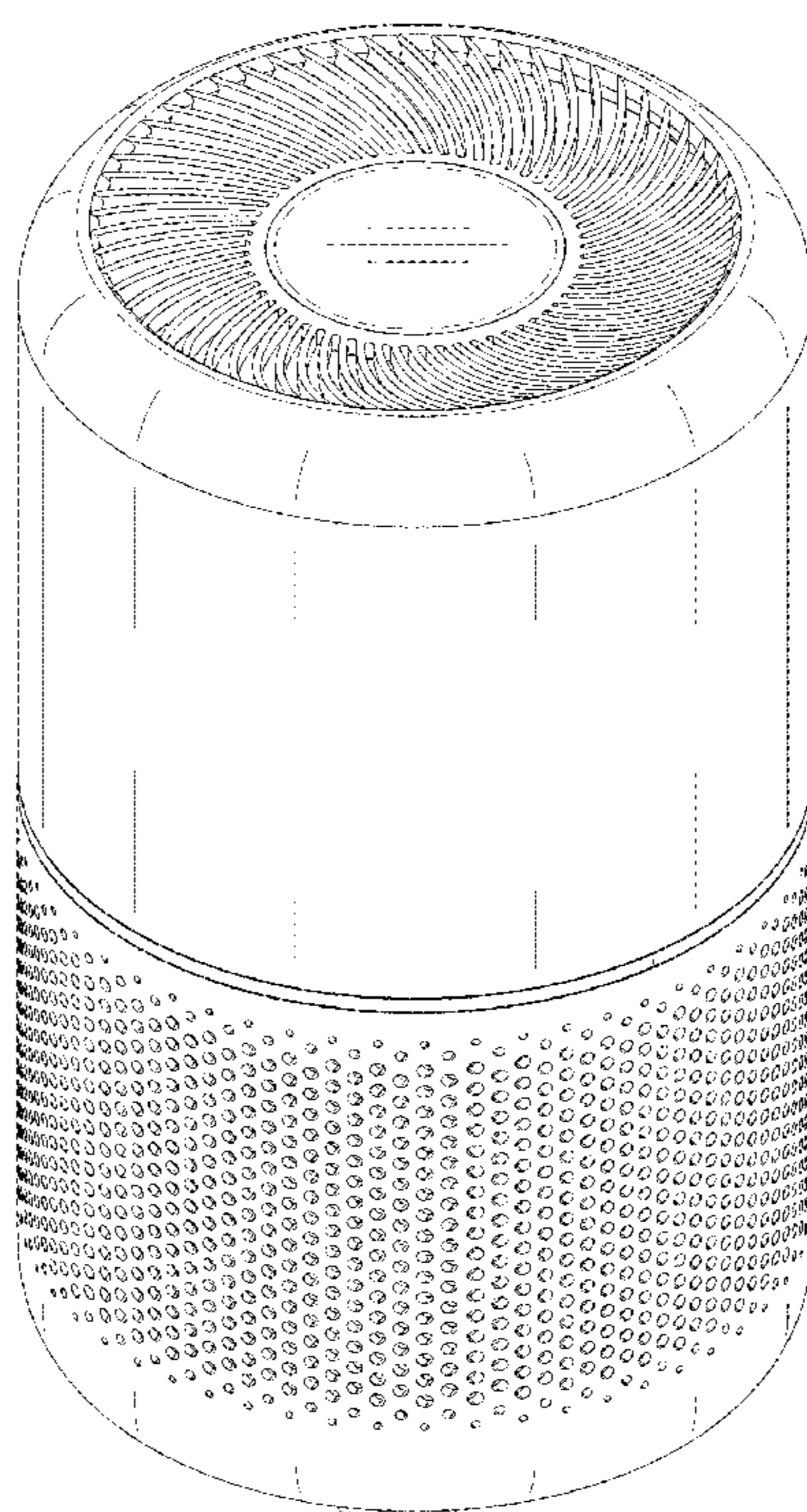

(57) **CLAIM**
The ornamental design for an air purifier, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of an air purifier showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.
In FIG. 1 and FIG. 6, the oval element in broken lines are visible through the transparent oval element on top. The broken lines depict portions of the air purifier that form no part of the claimed design.

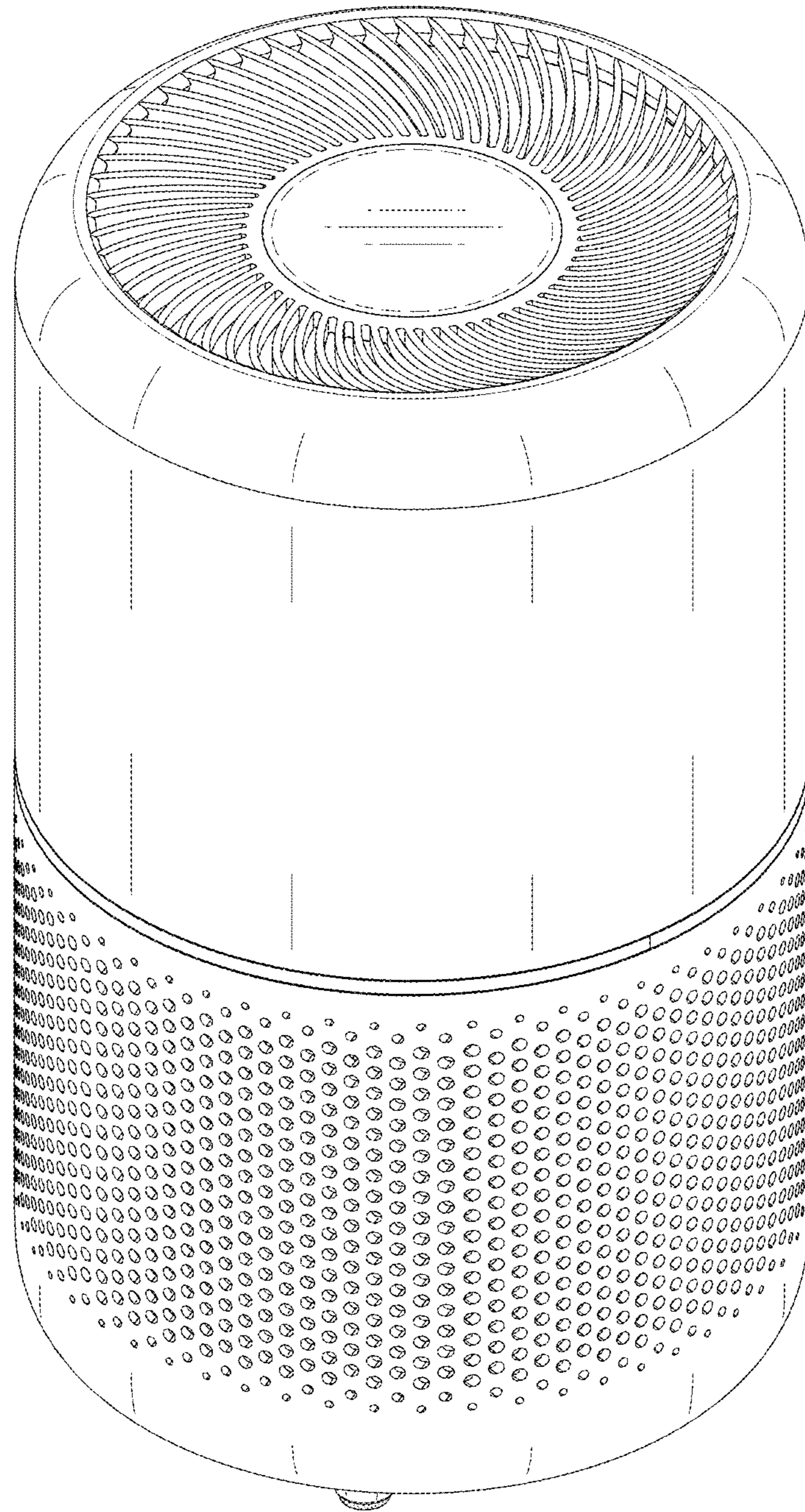

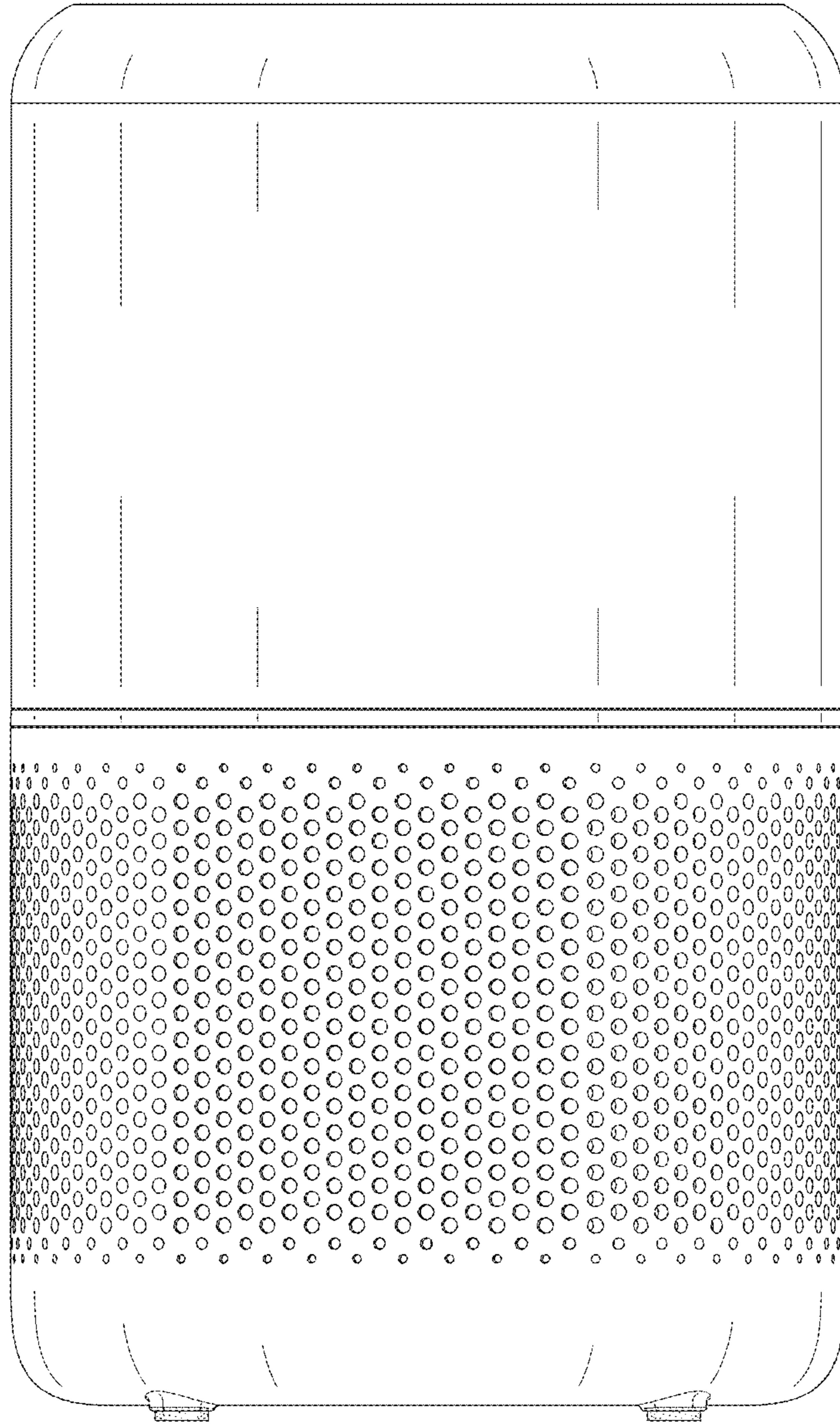

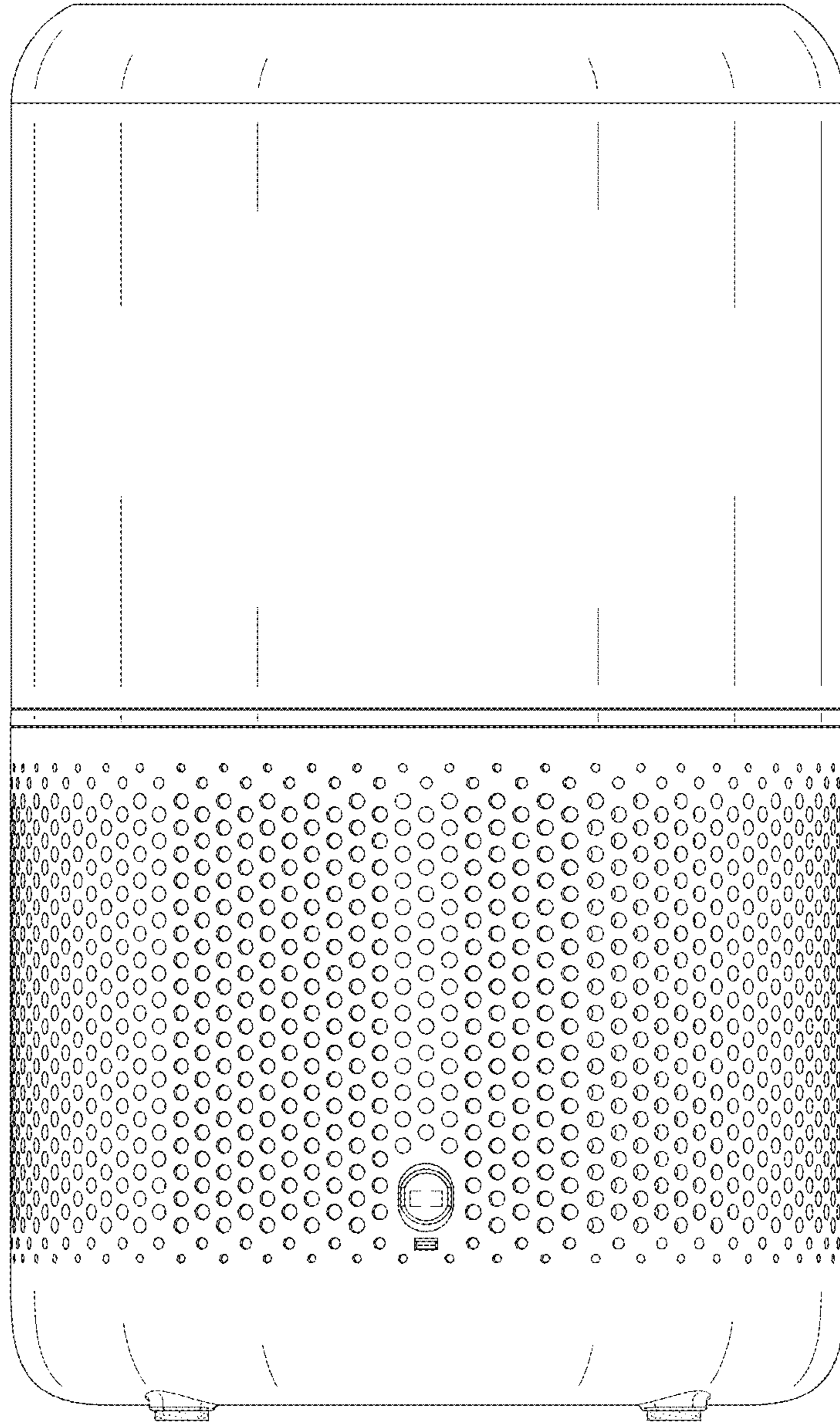

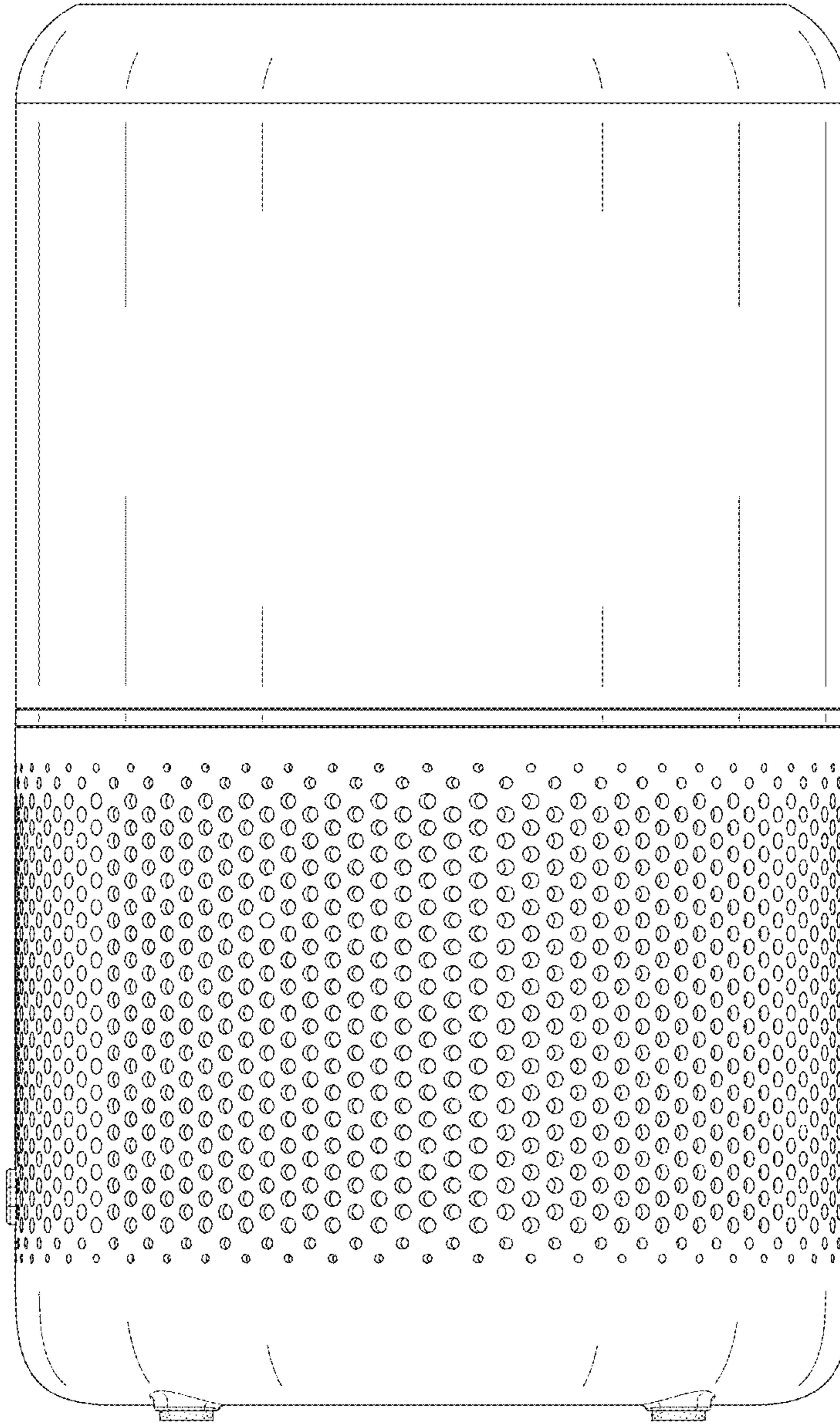

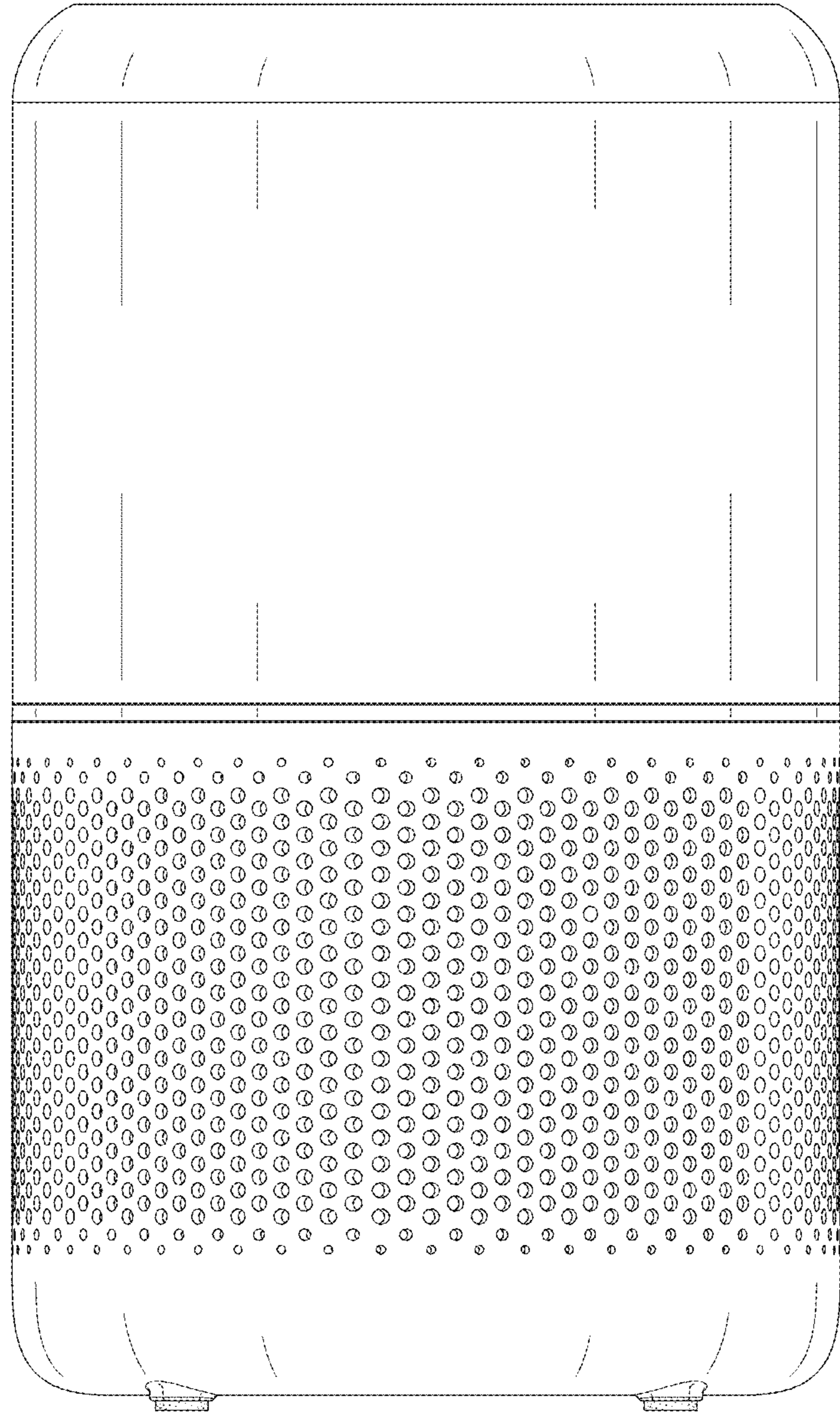

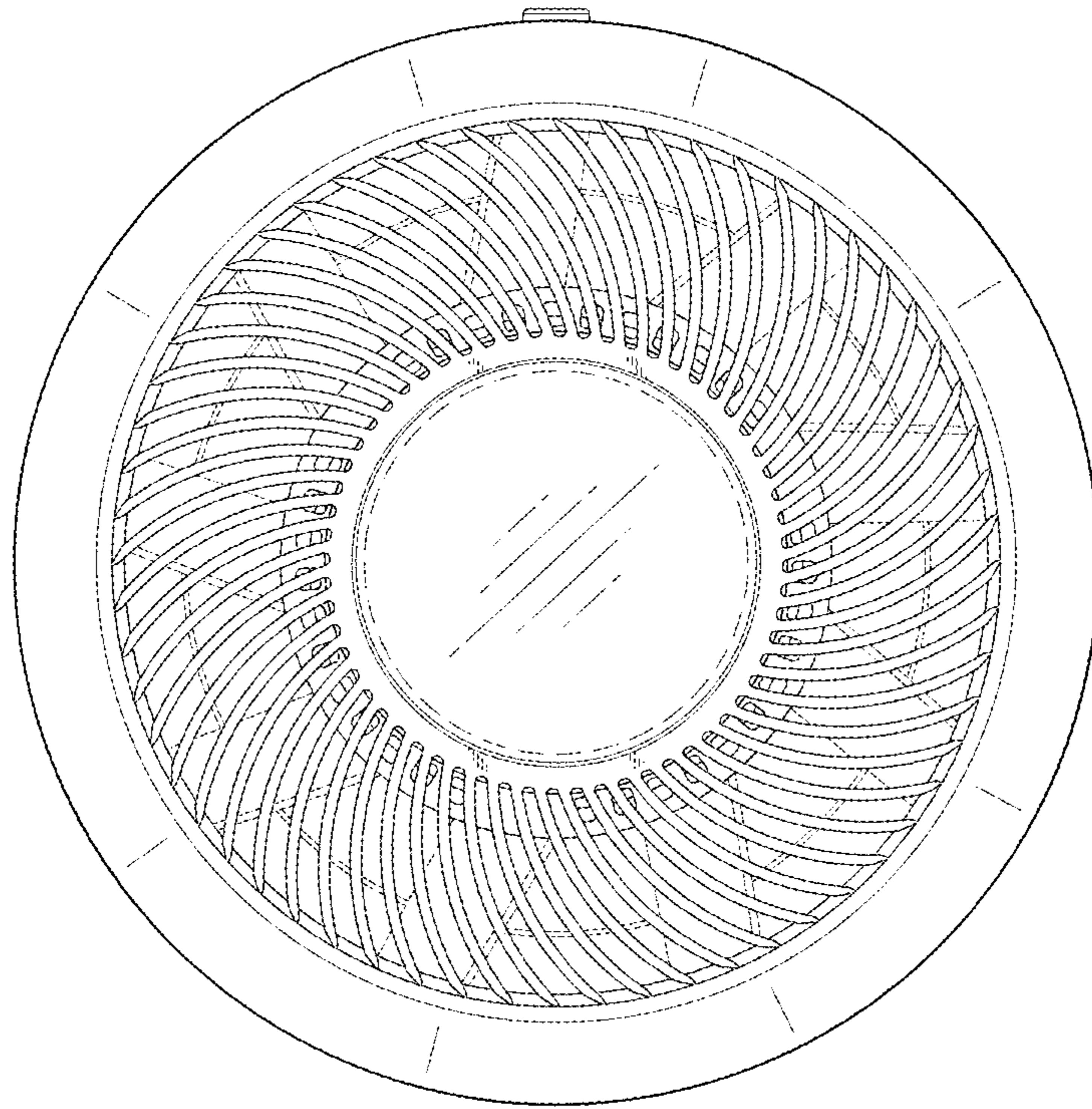

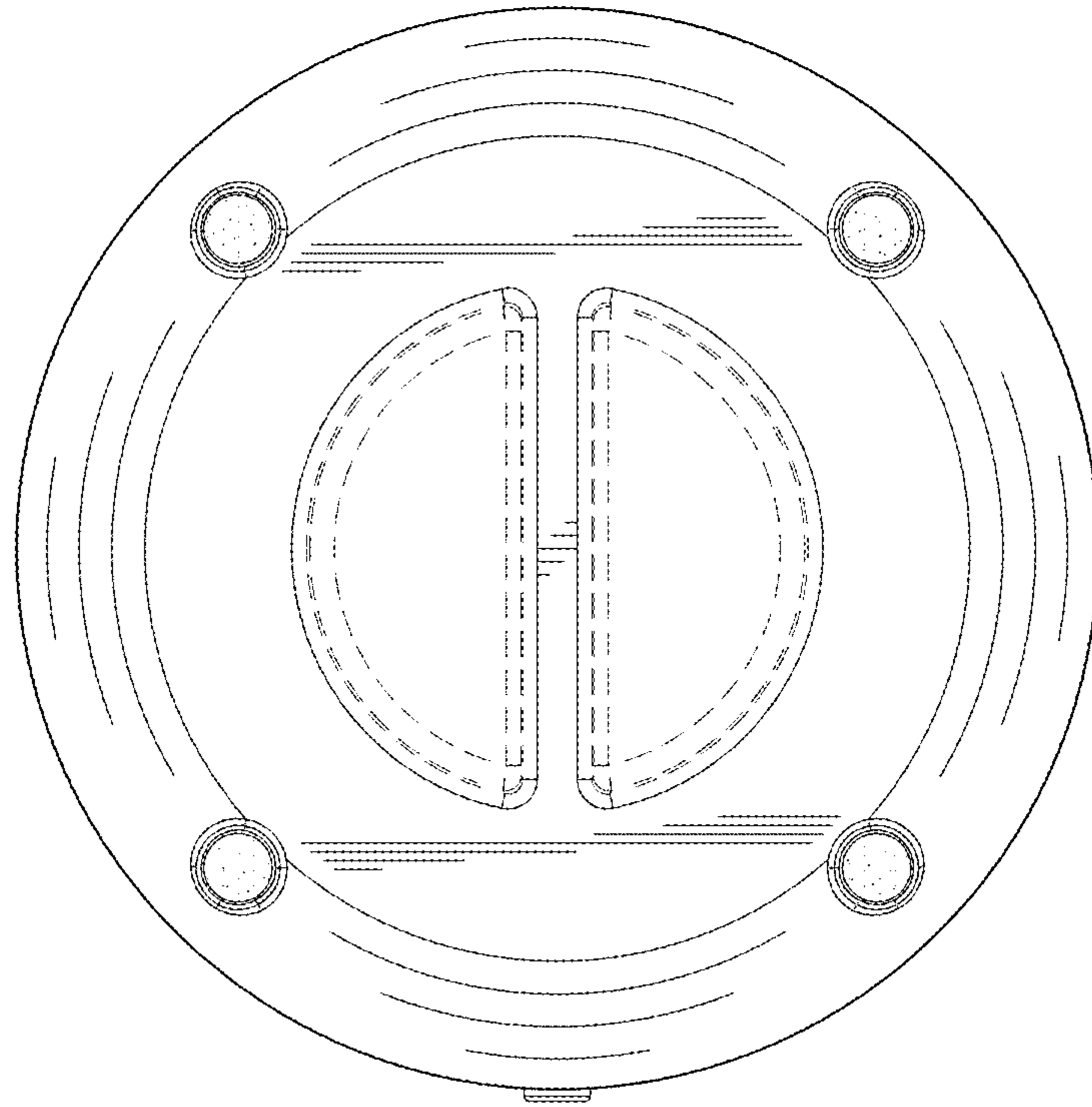
