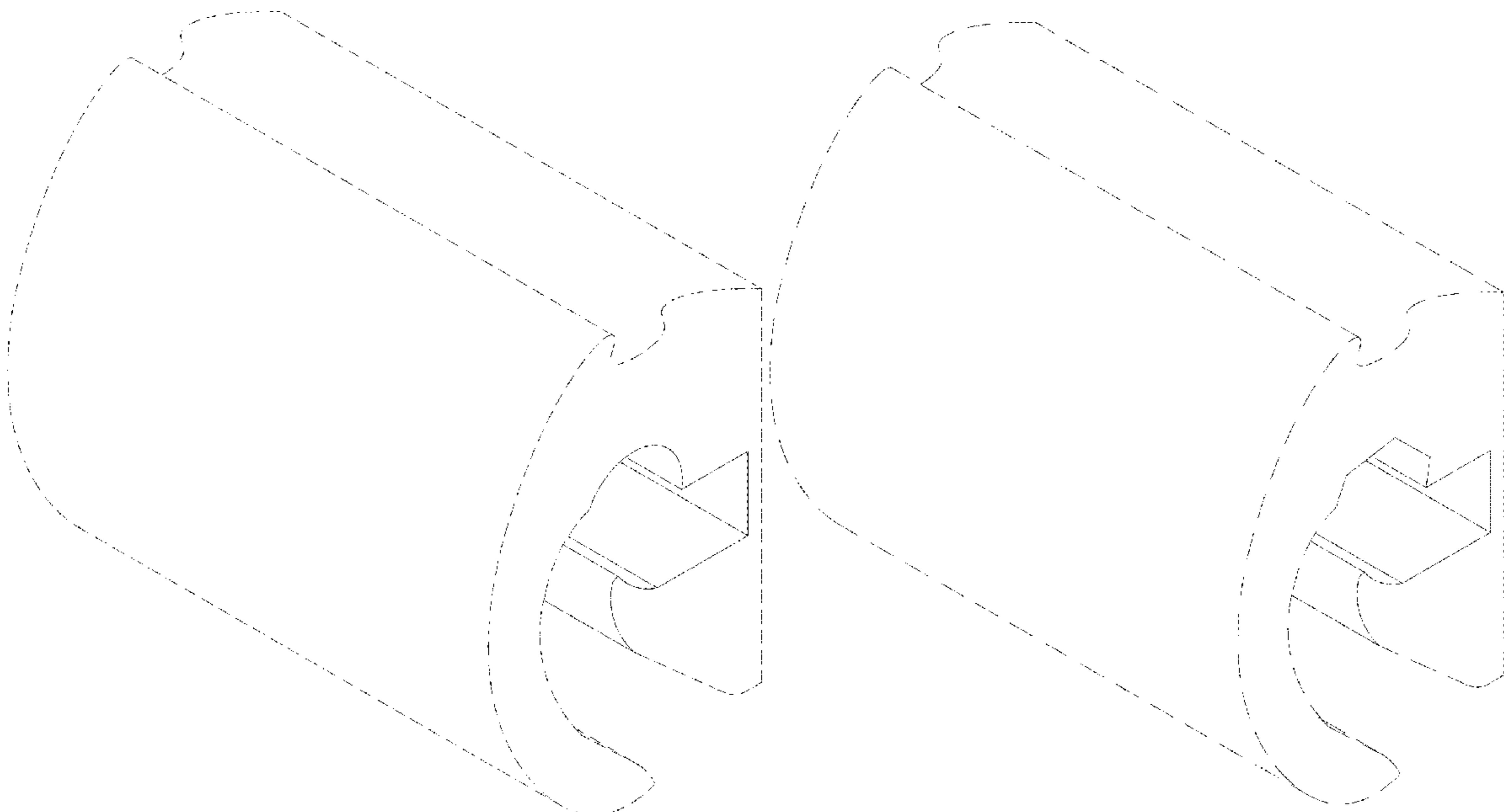
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of an orthodontic bracket, showing my new design;

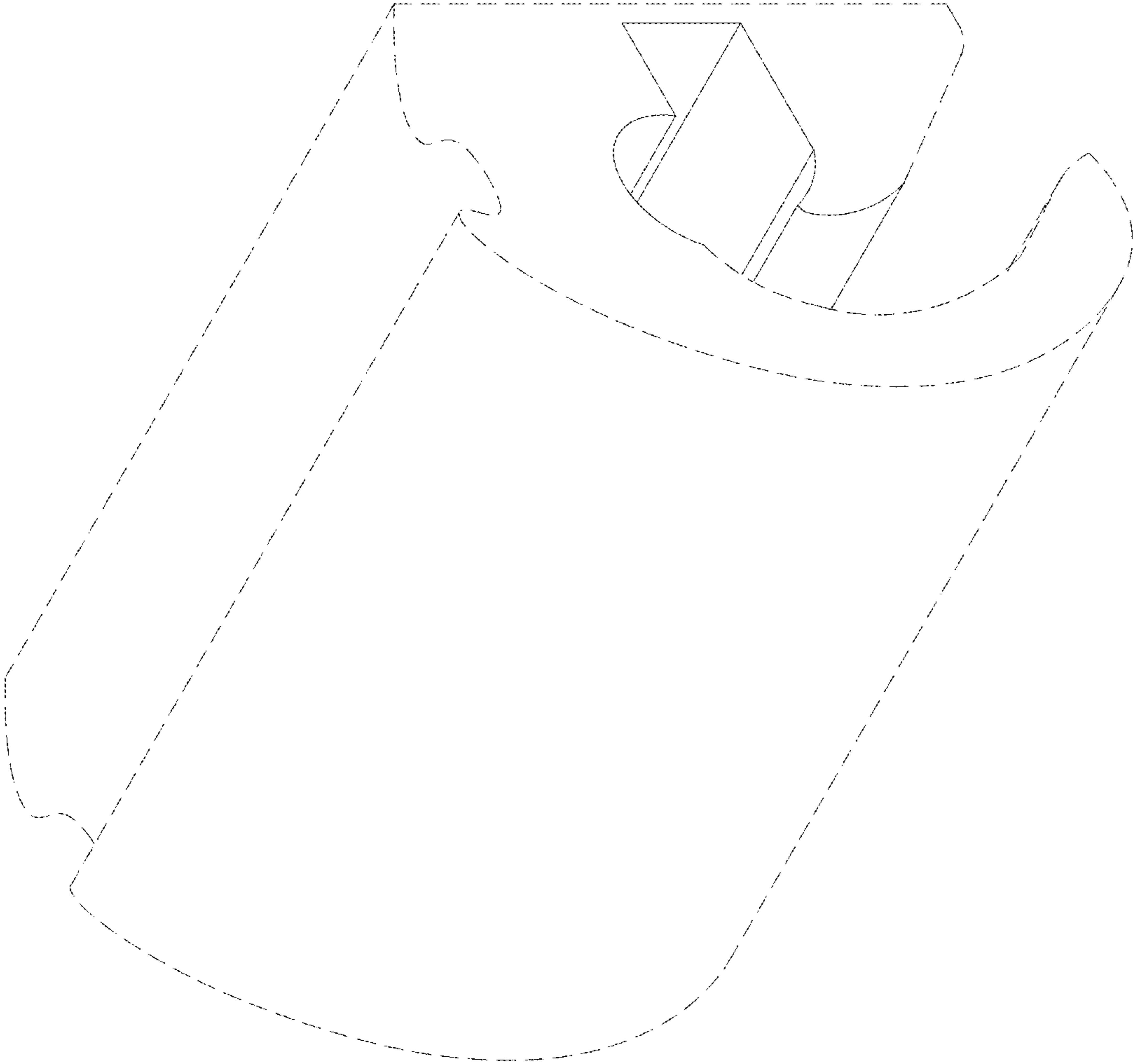

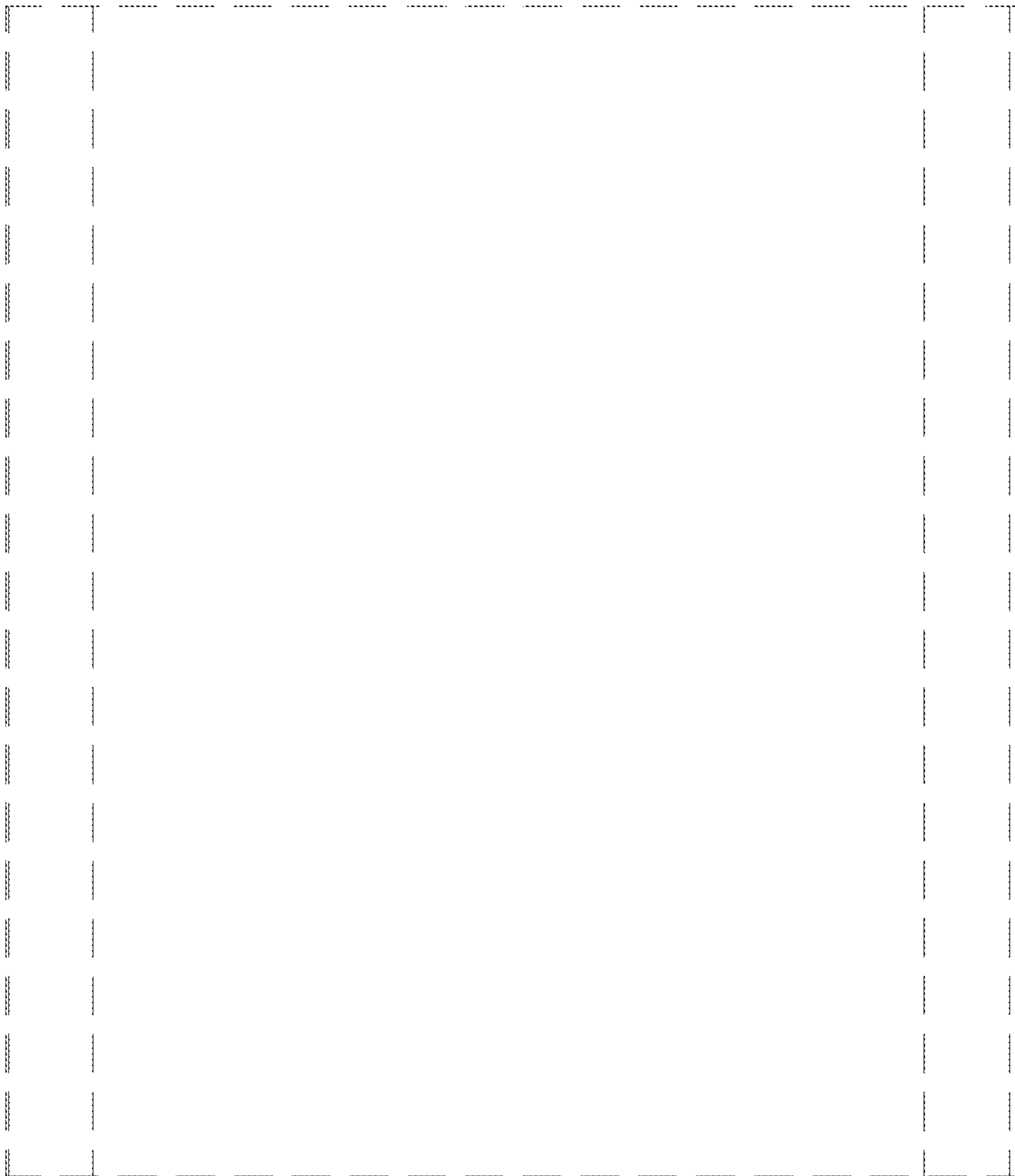

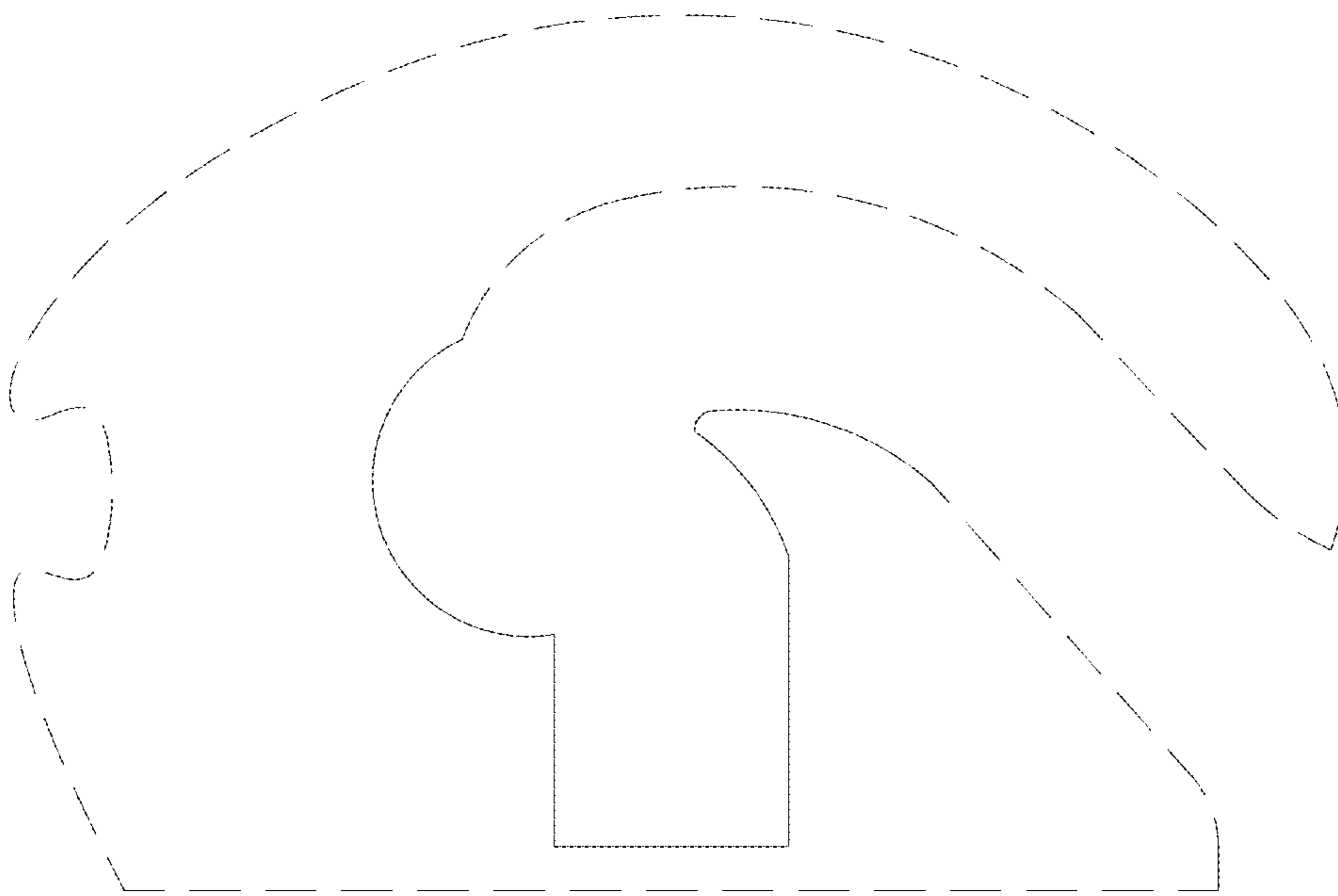

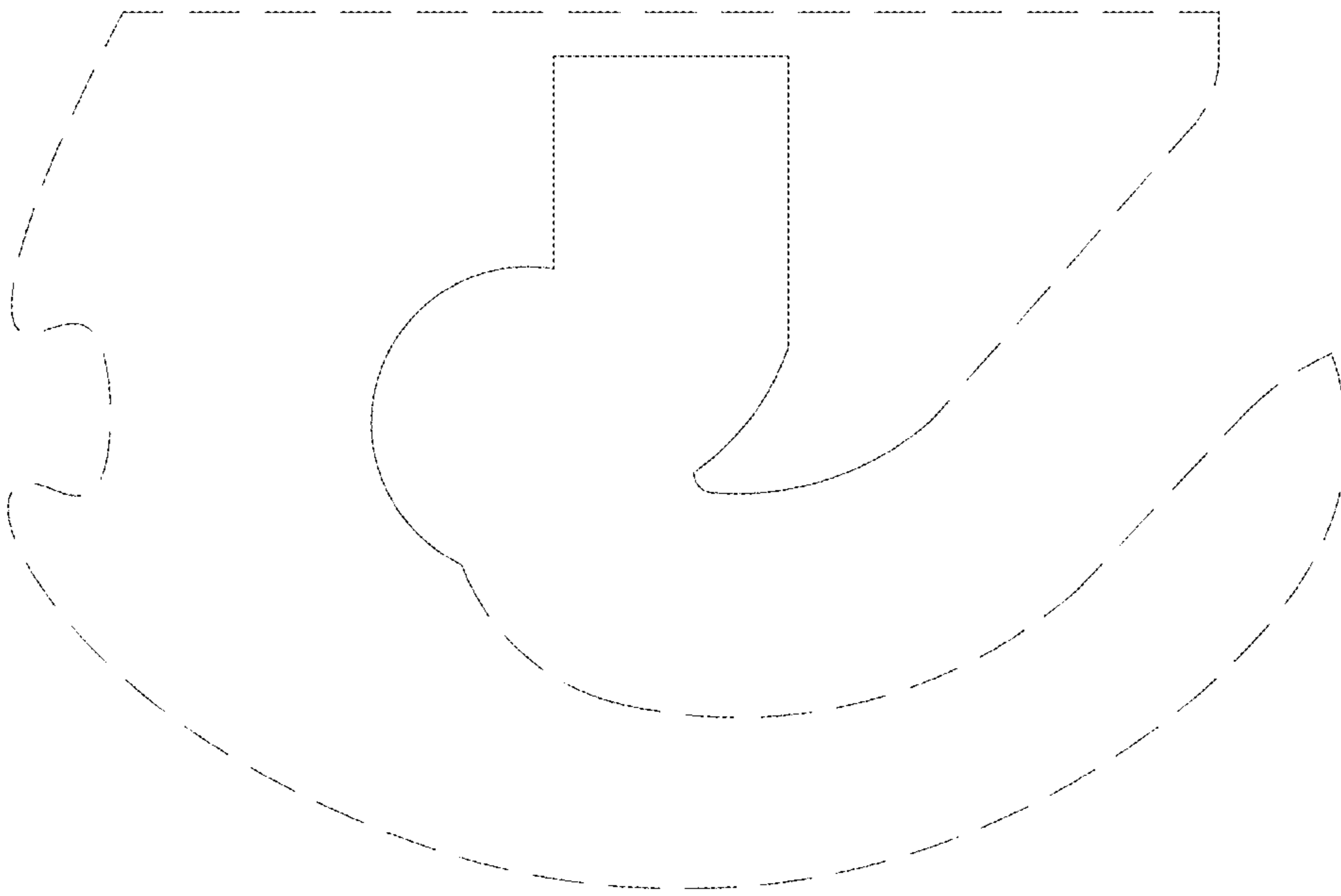

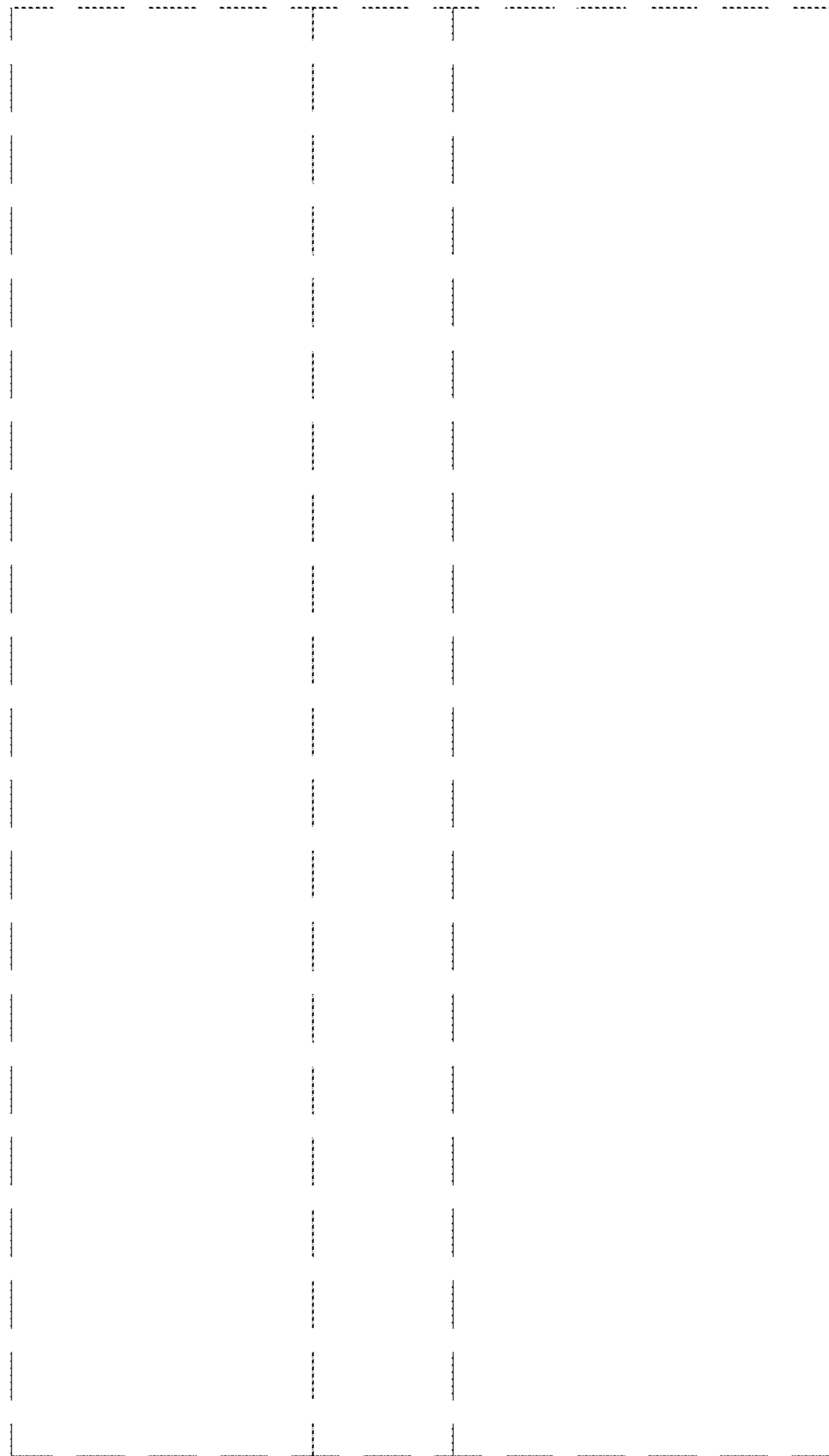

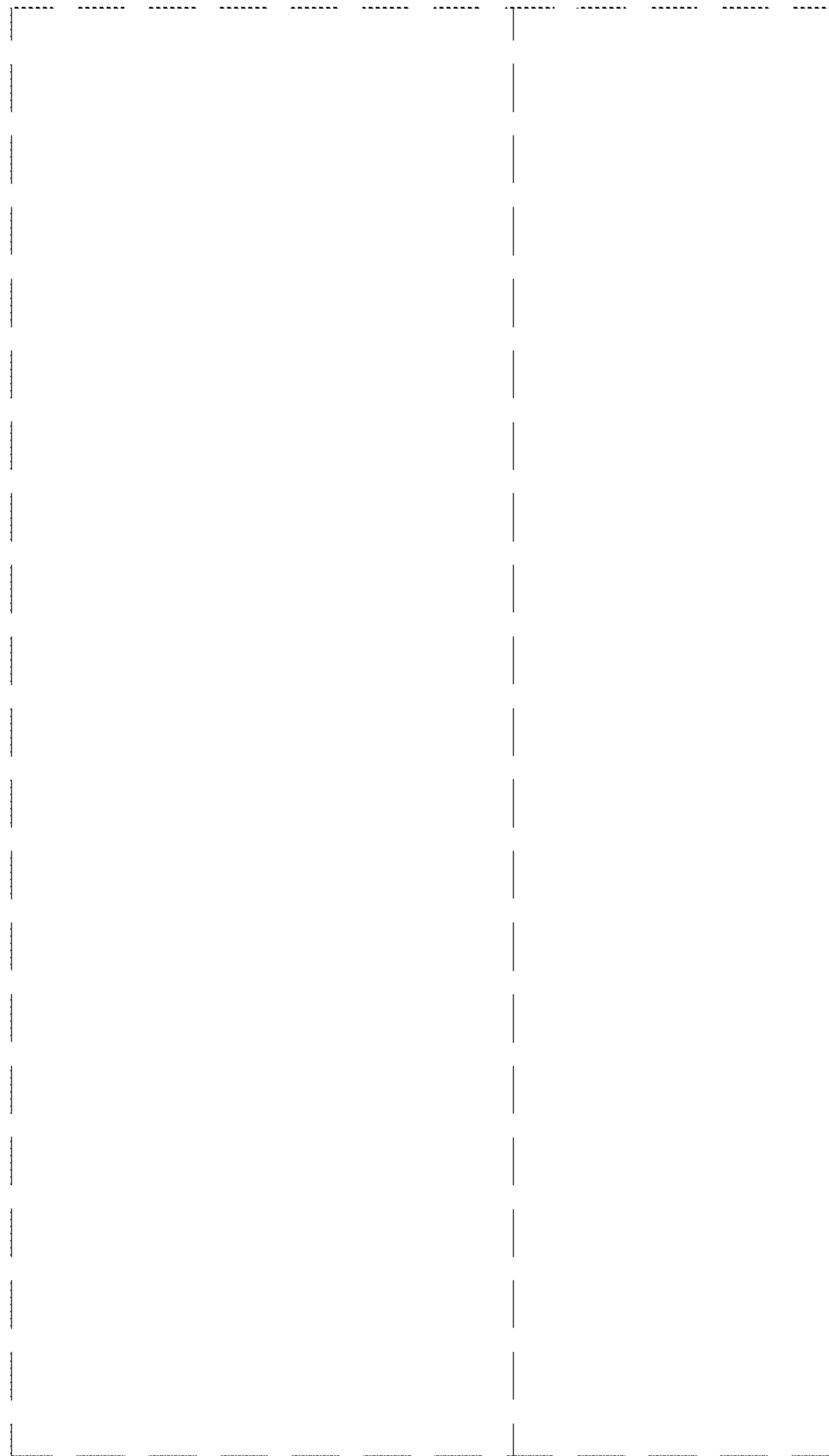

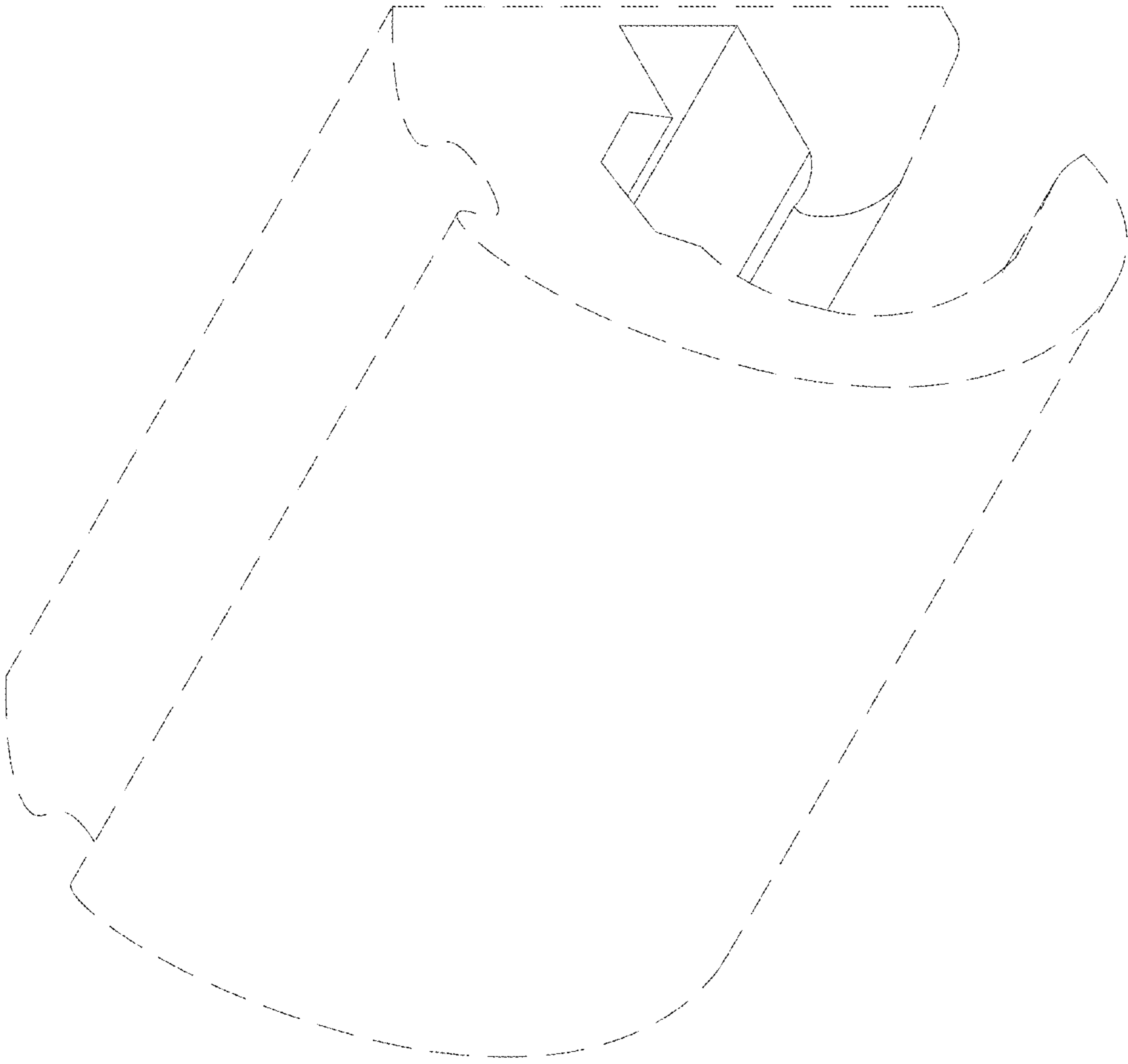

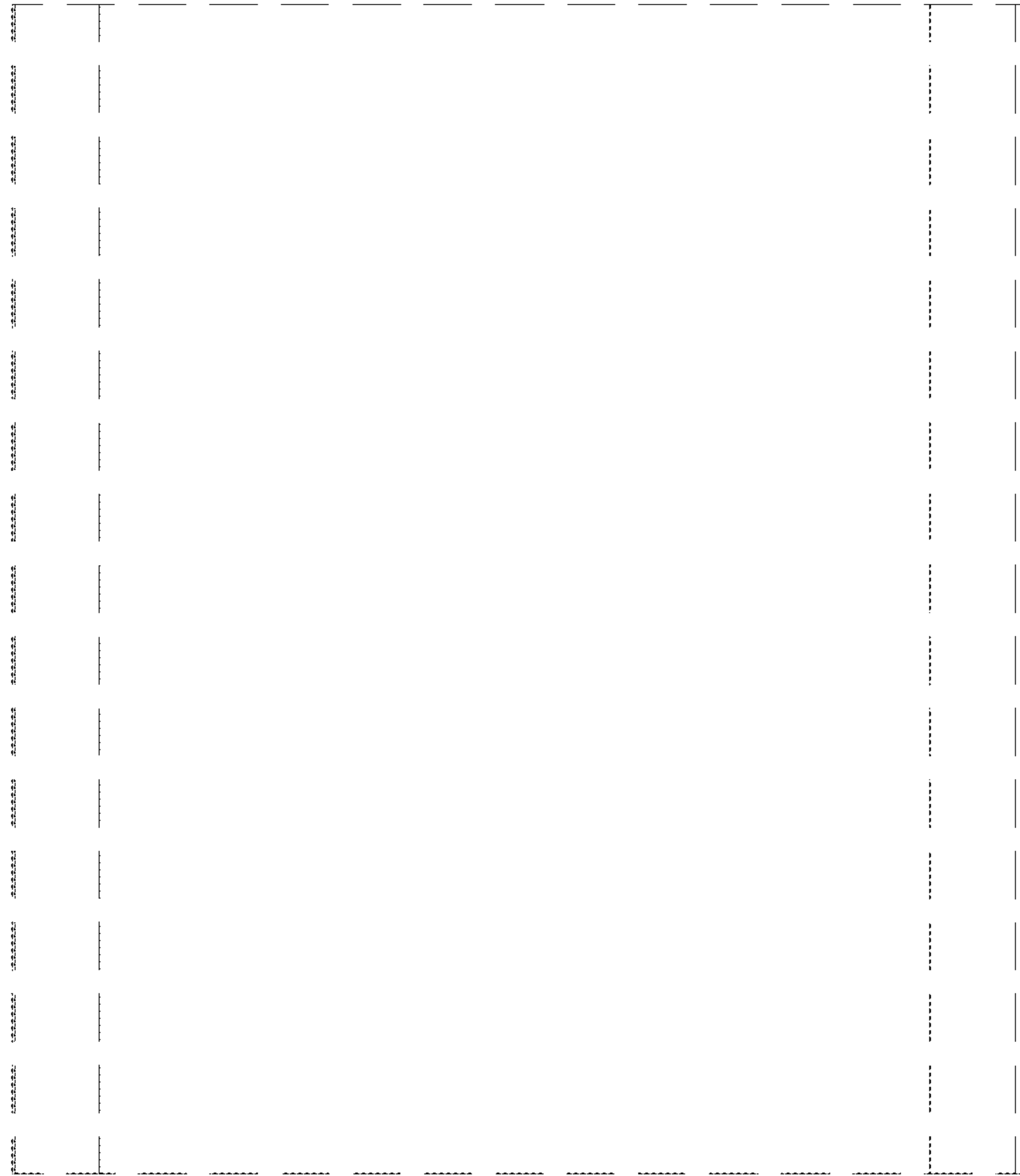

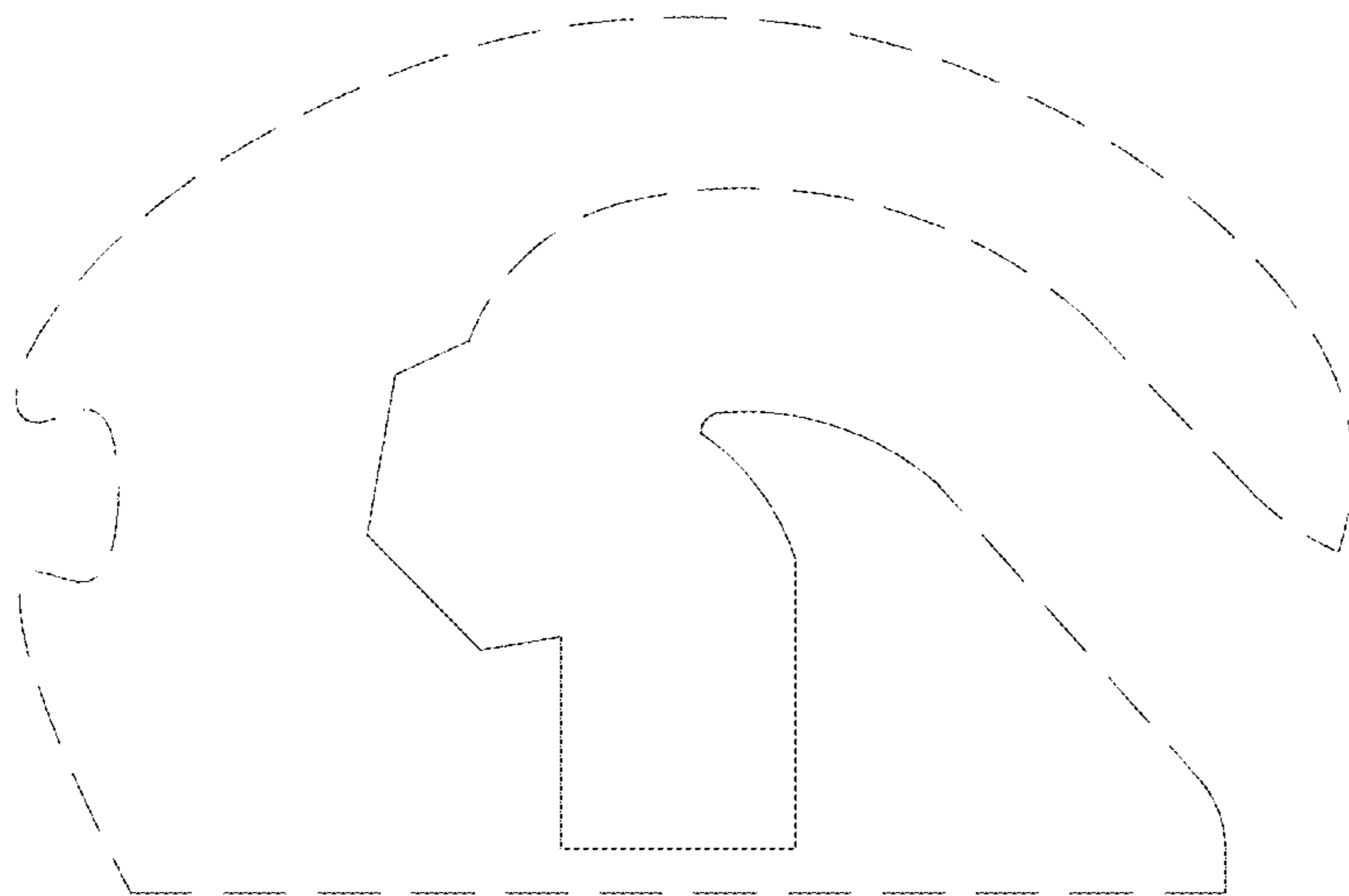

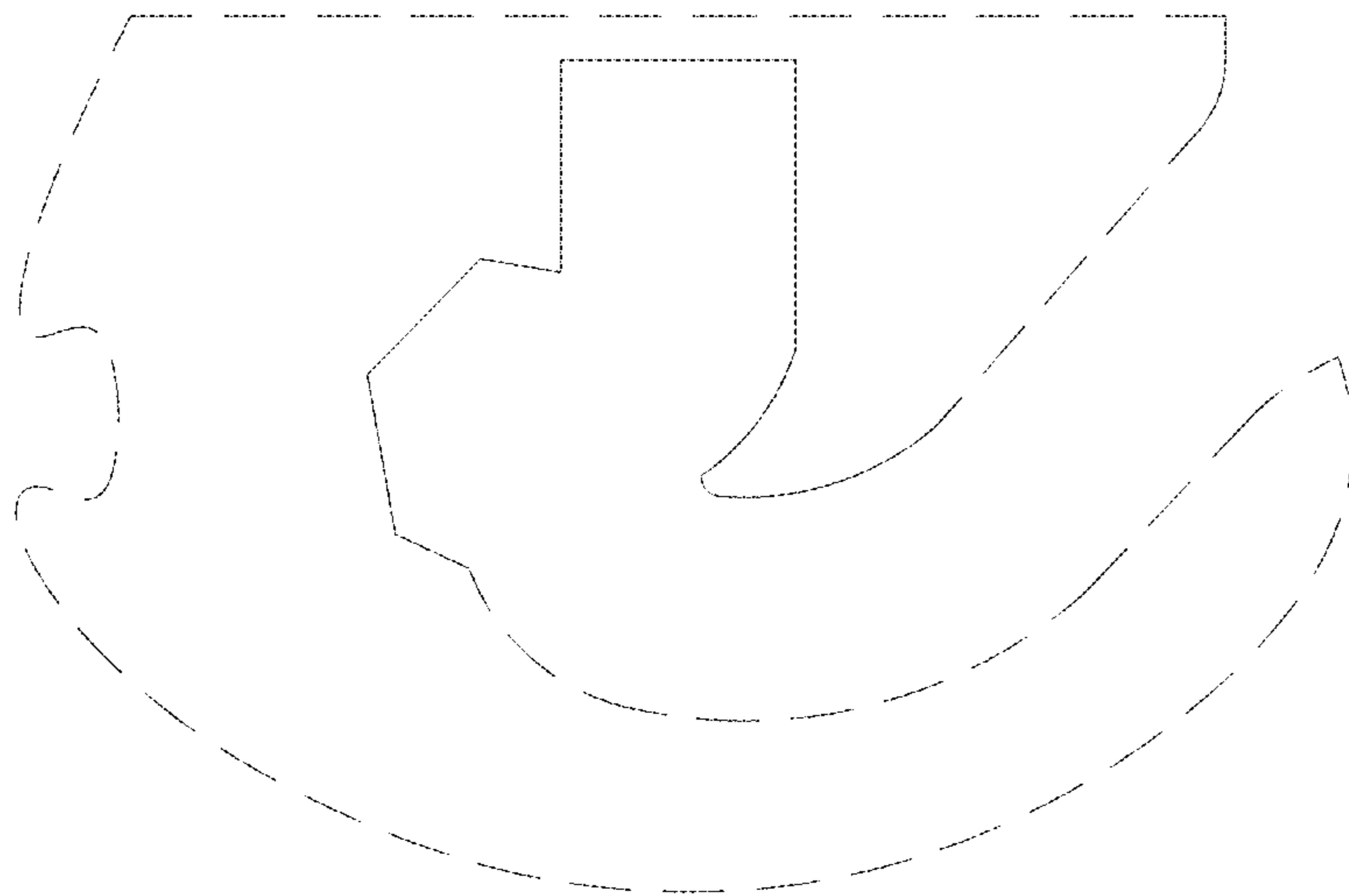

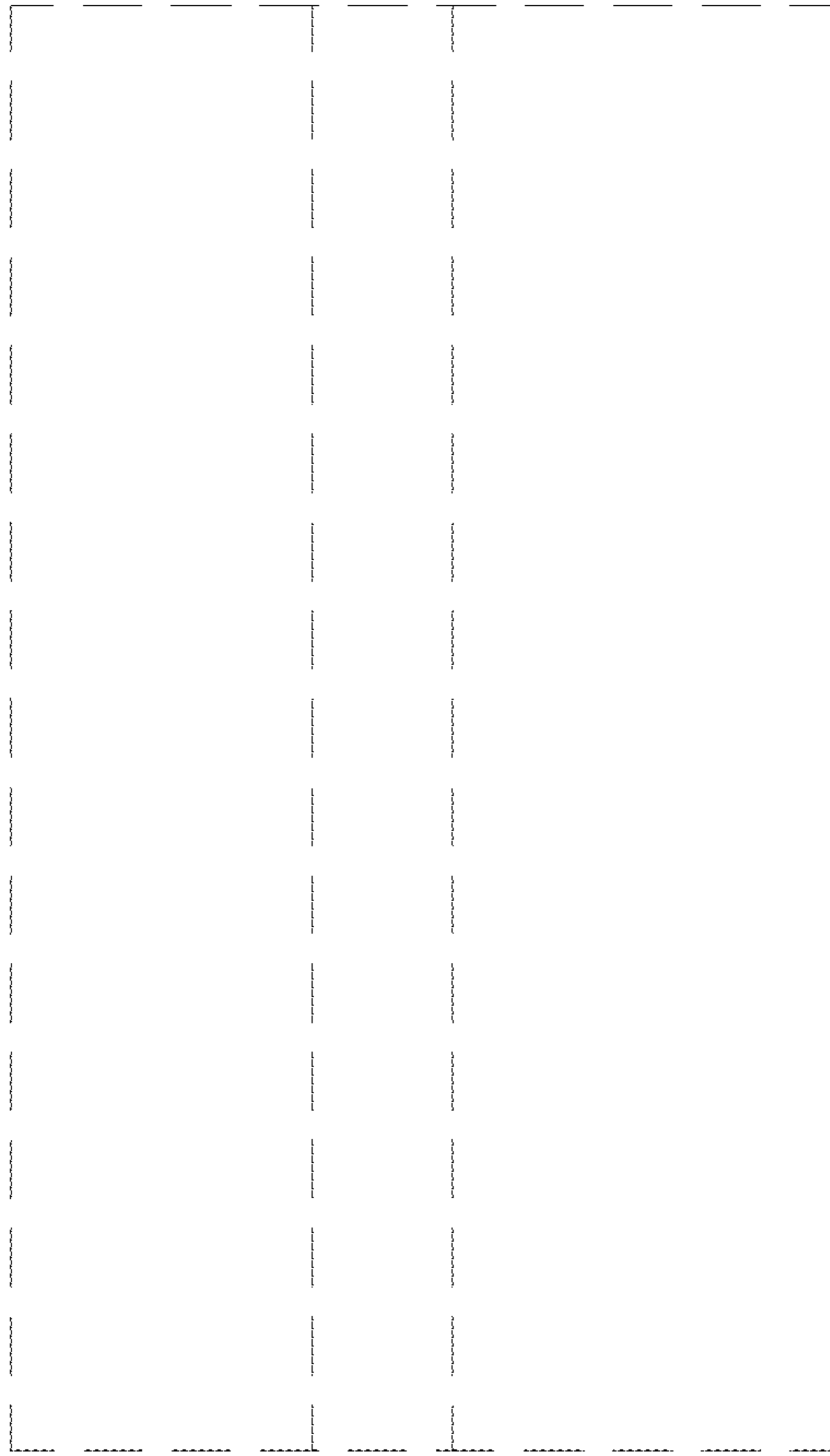
