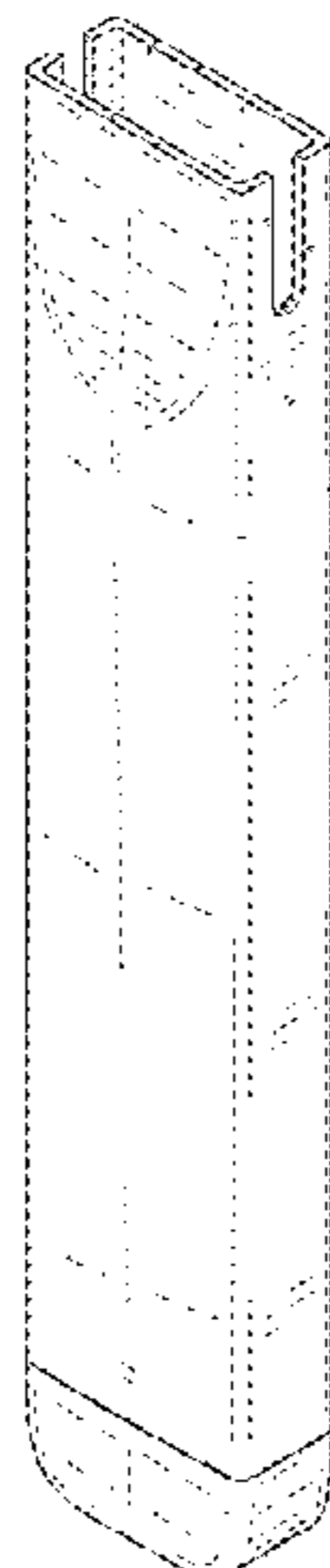
We claim the ornamental design for a main body for electronic cigarette, as shown and described.

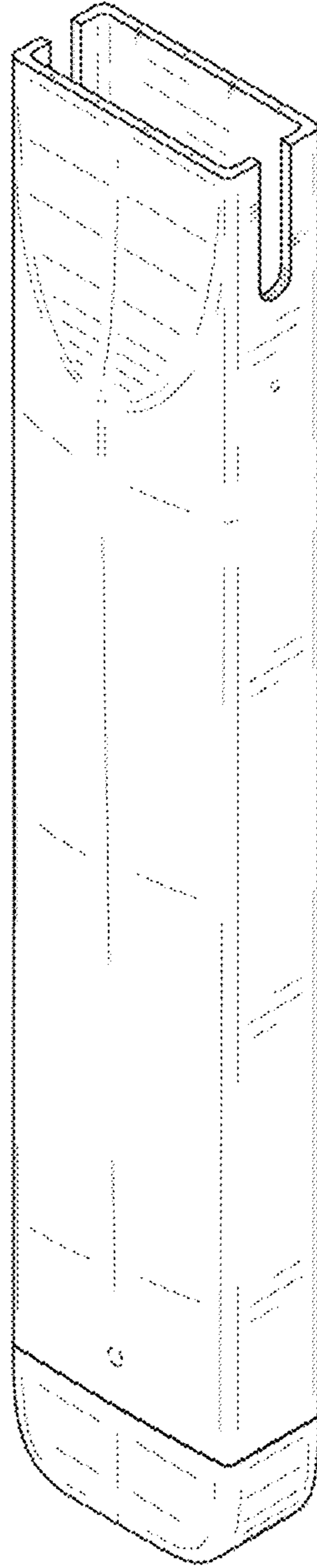

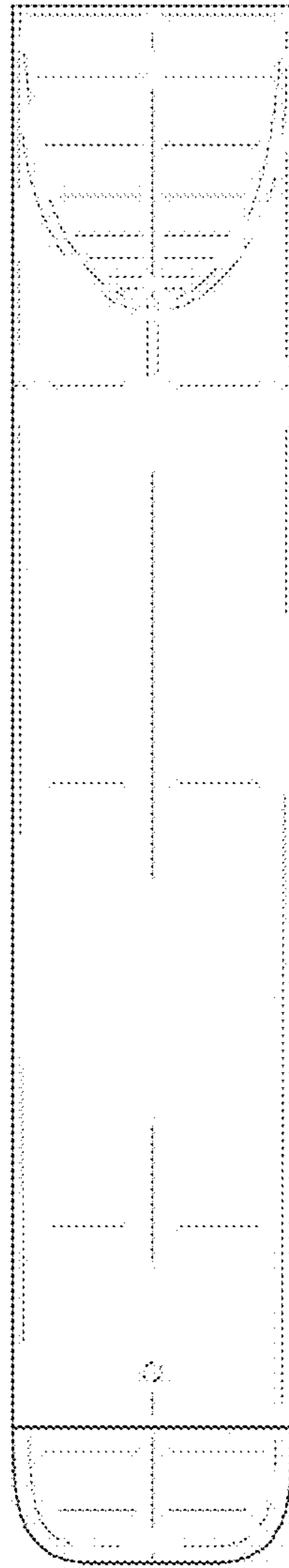

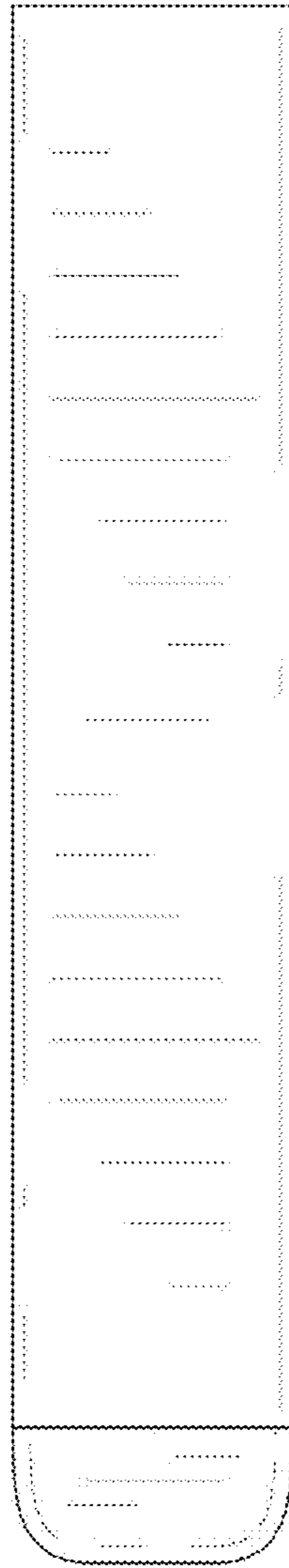

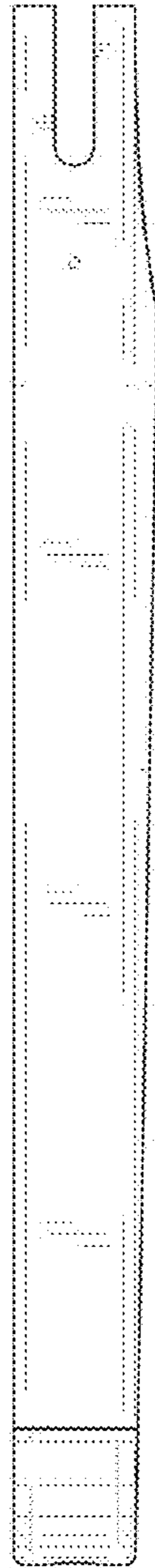

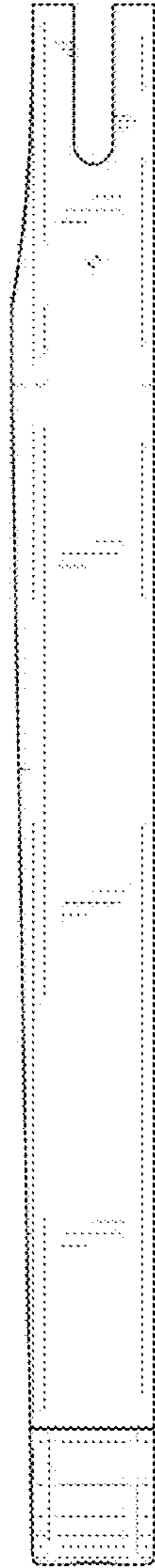

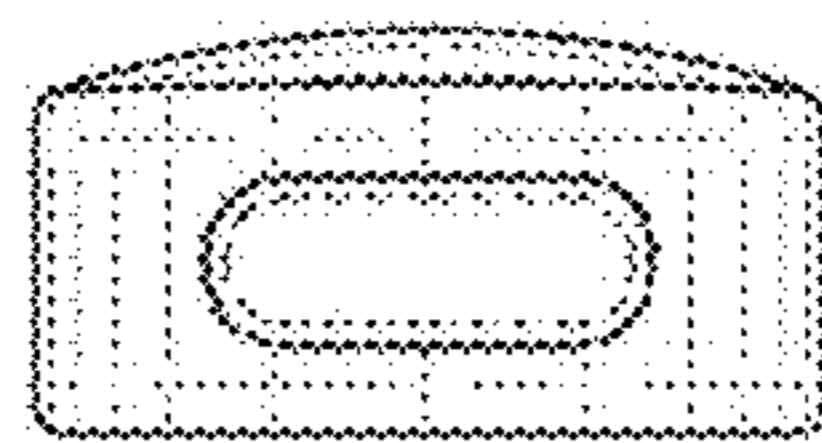
