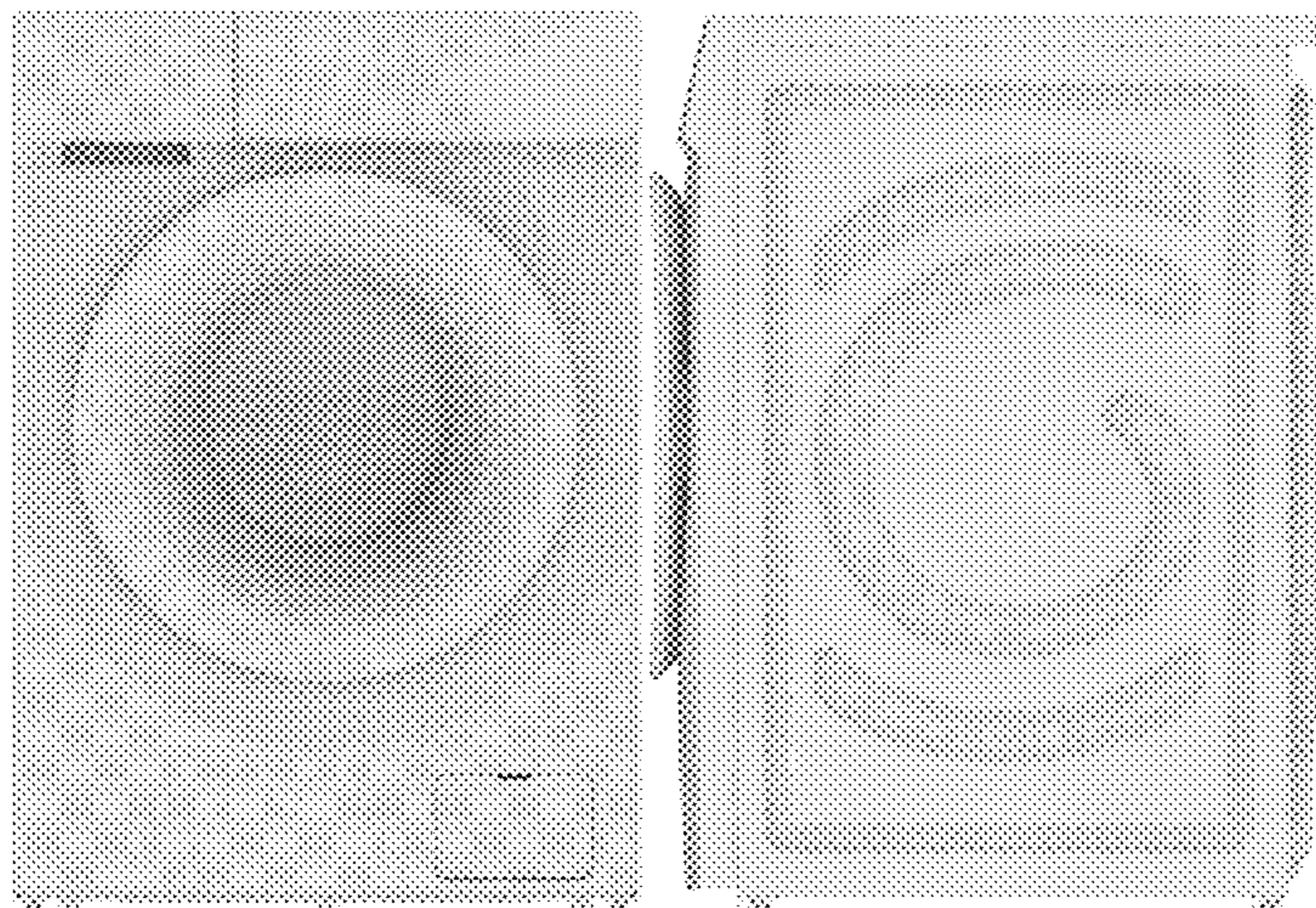
(57) **CLAIM**

The ornamental design for a shell for washing machine, as shown and described.

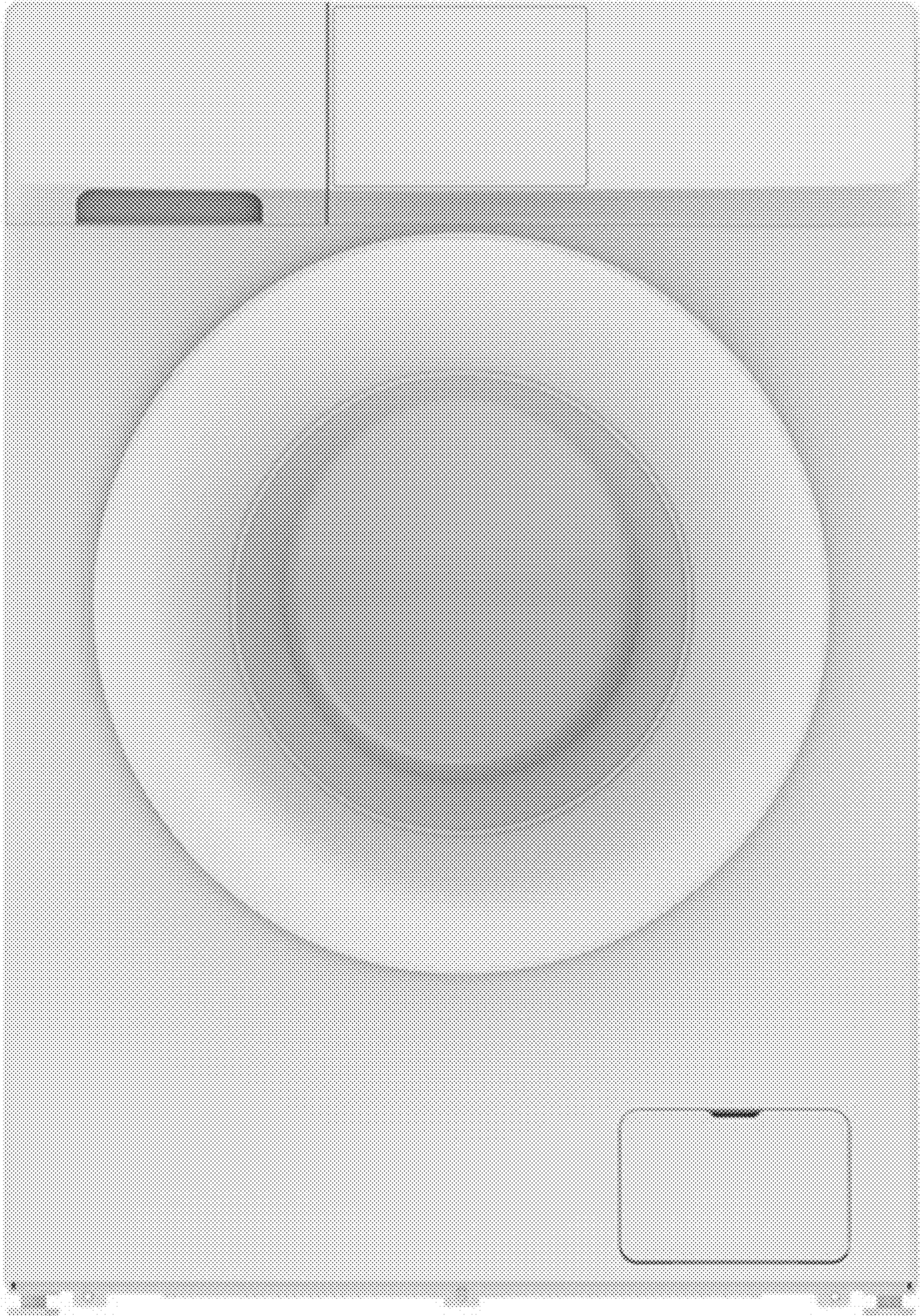
DESCRIPTION

1.8 is another perspective view thereof.
The interior features which are only visible through the openings in the shell for washing machine in Figs. **1.2** and **1.6** form no part of the claimed design.

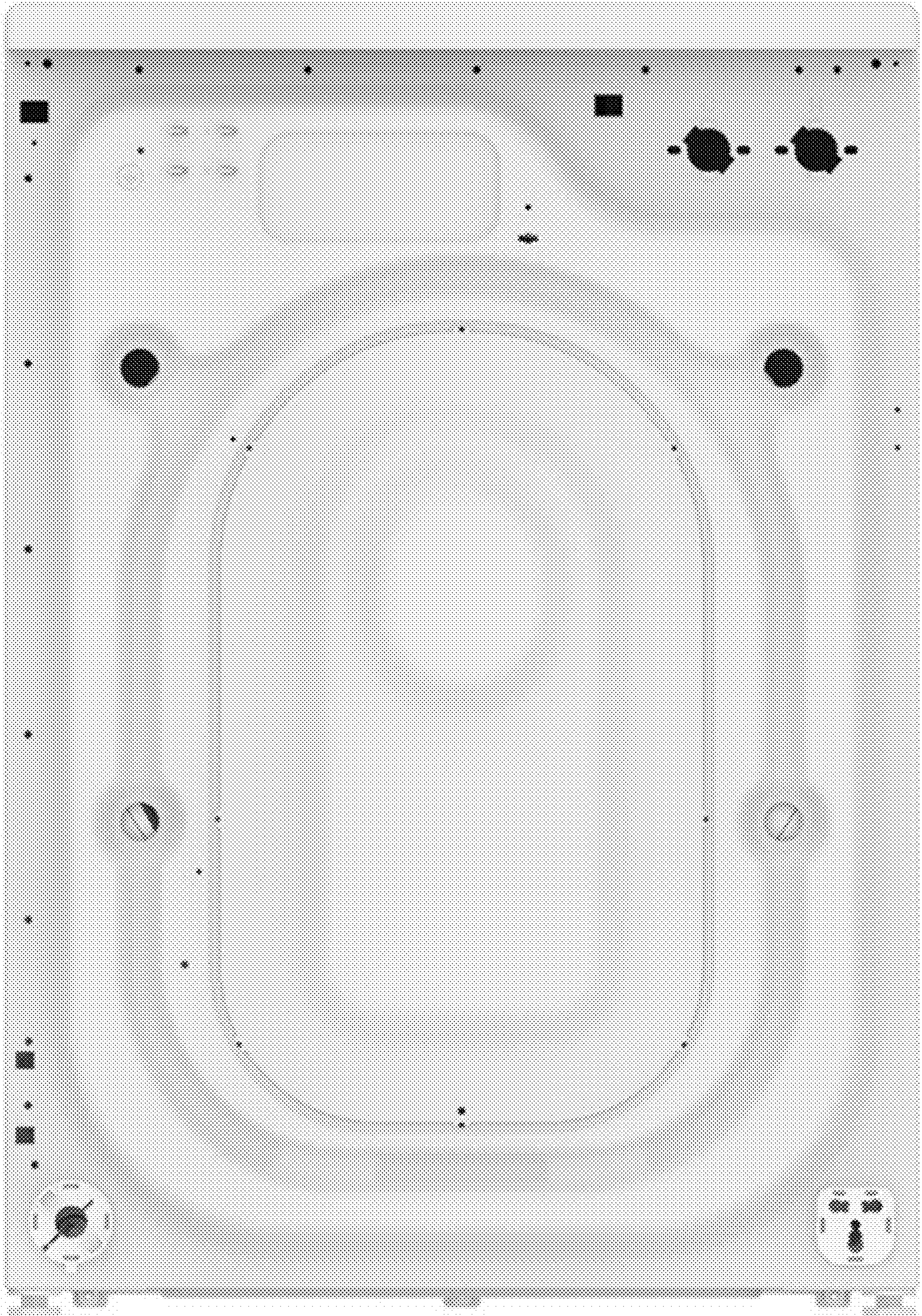

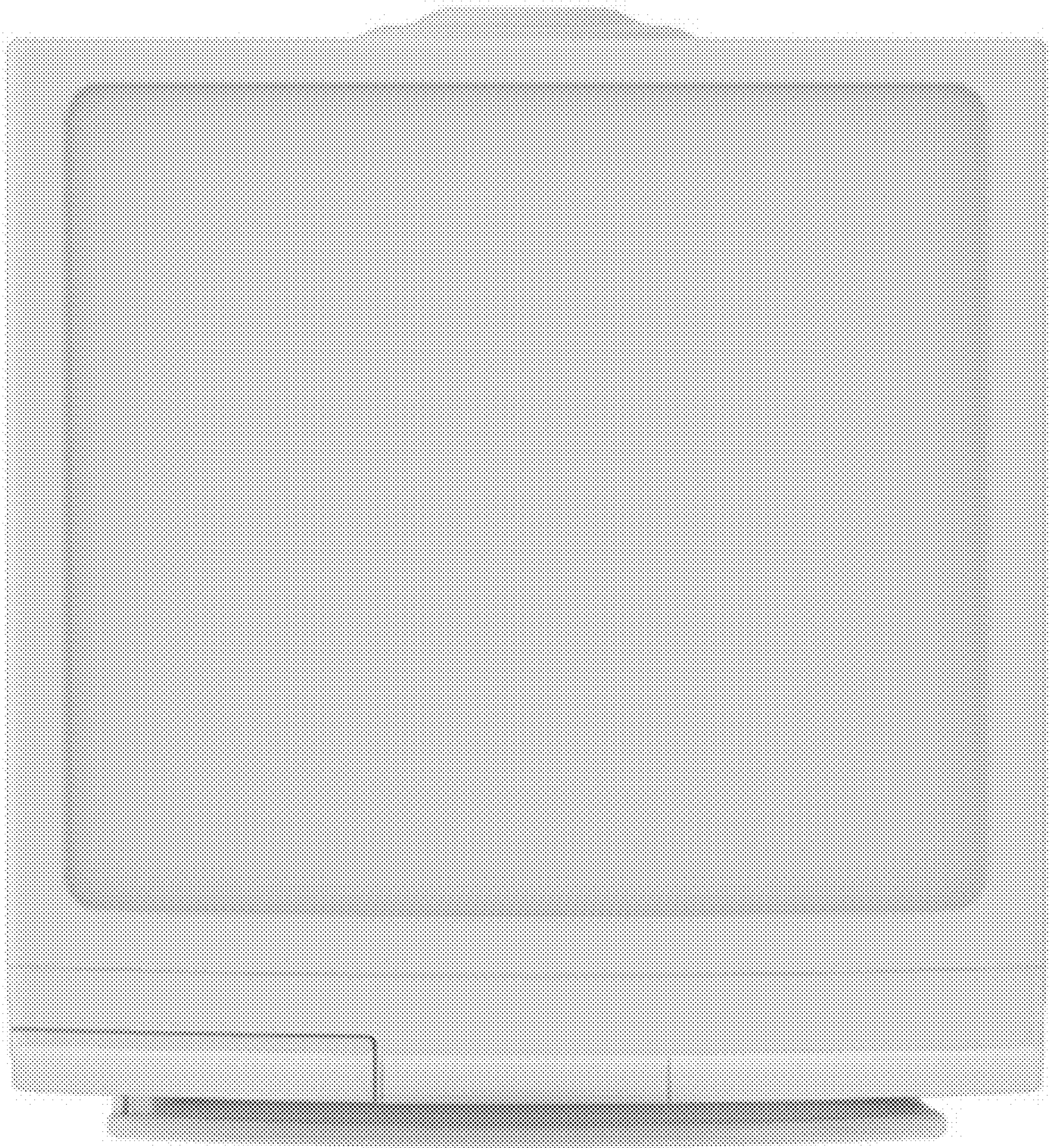

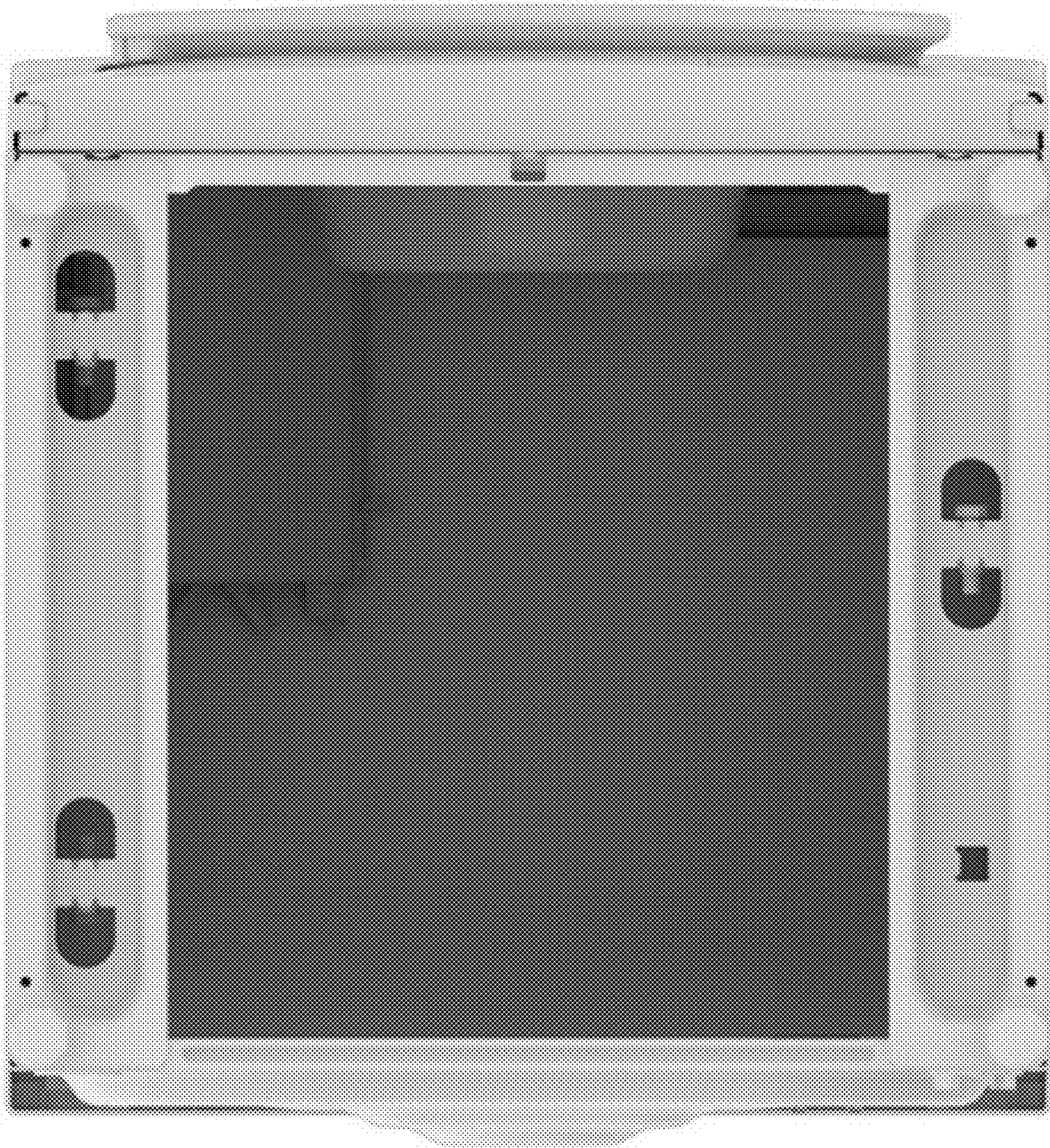
