(57) **CLAIM**

The ornamental design for a broad headband with attached holder for hair, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a broad headband with attached holder for hair of the present invention, shown being worn by a user;

FIG. 2 is a top perspective view of the headband with attached holder for hair of FIG. 1;

FIG. 3 is a left-side perspective view of the headband with attached holder for hair of FIG.1;

FIG. 4 is a right-side perspective view of the headband with attached holder for hair of FIG. 1;

FIG. 5 is a front perspective view of the headband with attached holder for hair of FIG. 1;

FIG. 6 is a rear perspective view of the headband with attached holder for hair of FIG. 1;

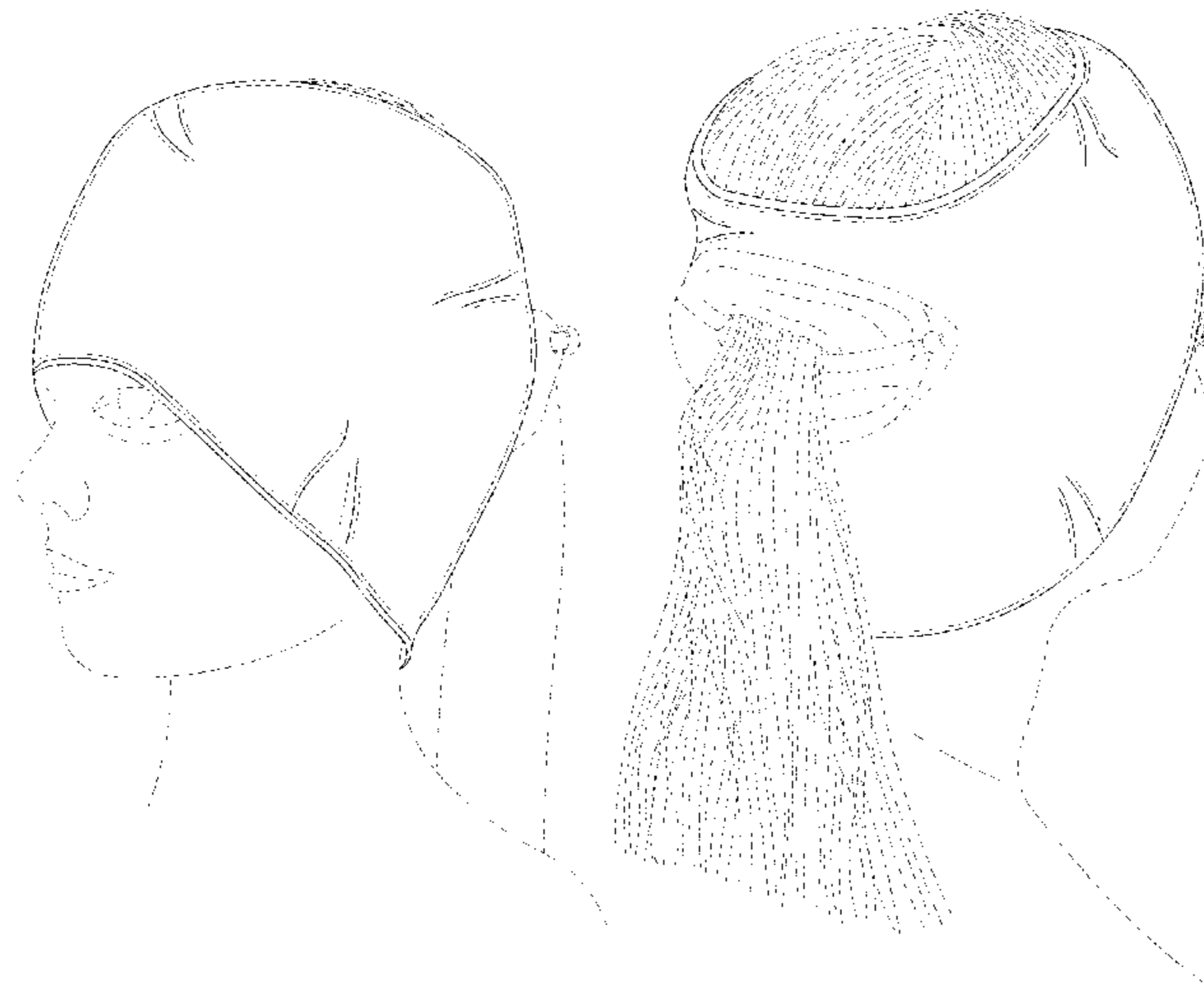
FIG. 7 is a top plan view of the headband with attached holder for hair of FIG. 1;

FIG. 8 is a bottom plan view of the headband with attached holder for hair of FIG. 1; and,

FIG. 9 is a top perspective view of the headband with attached holder for hair of FIG. 1, as shown being worn by a user with the portion of the attached holder for hair in a rolled up configuration.

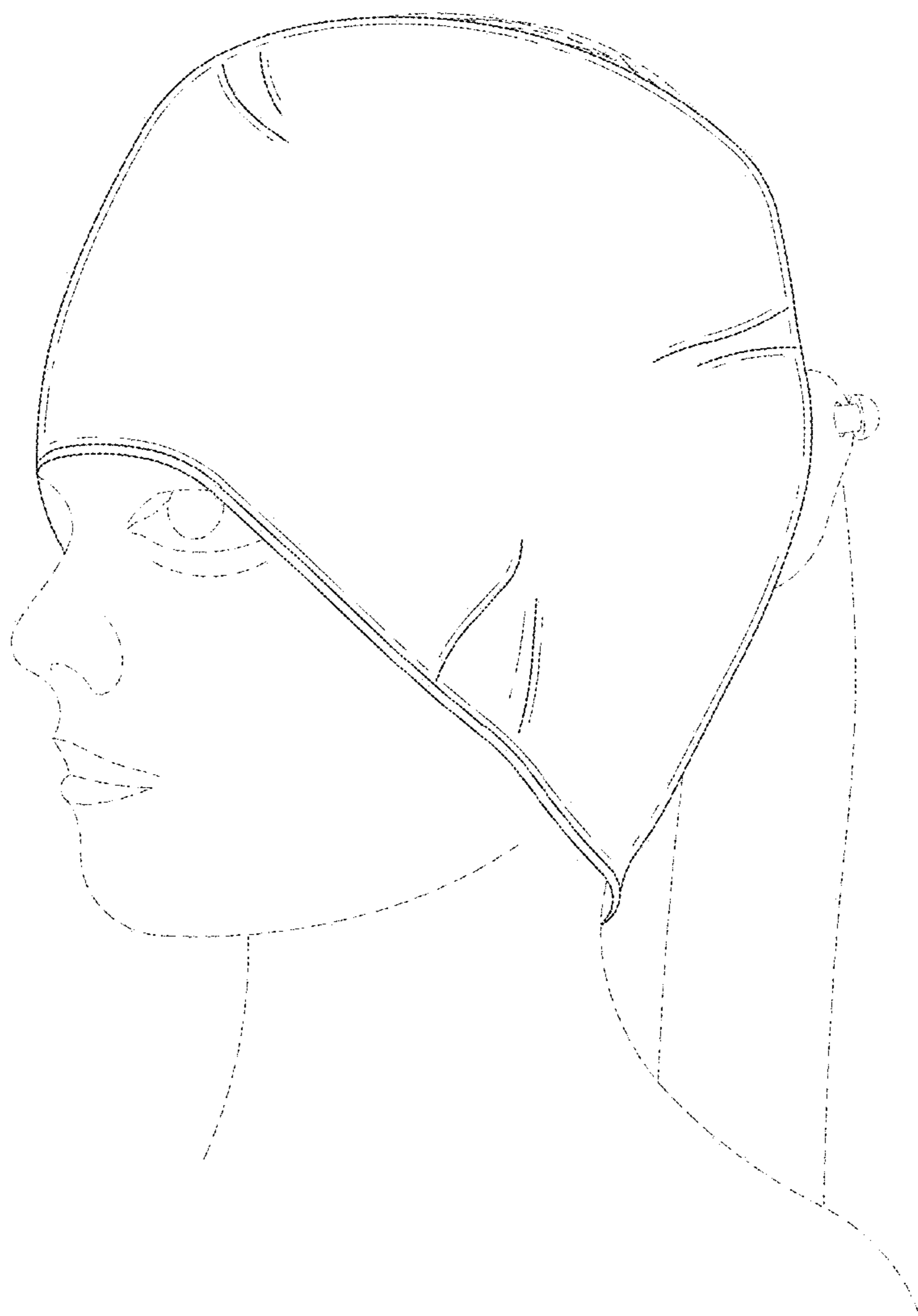

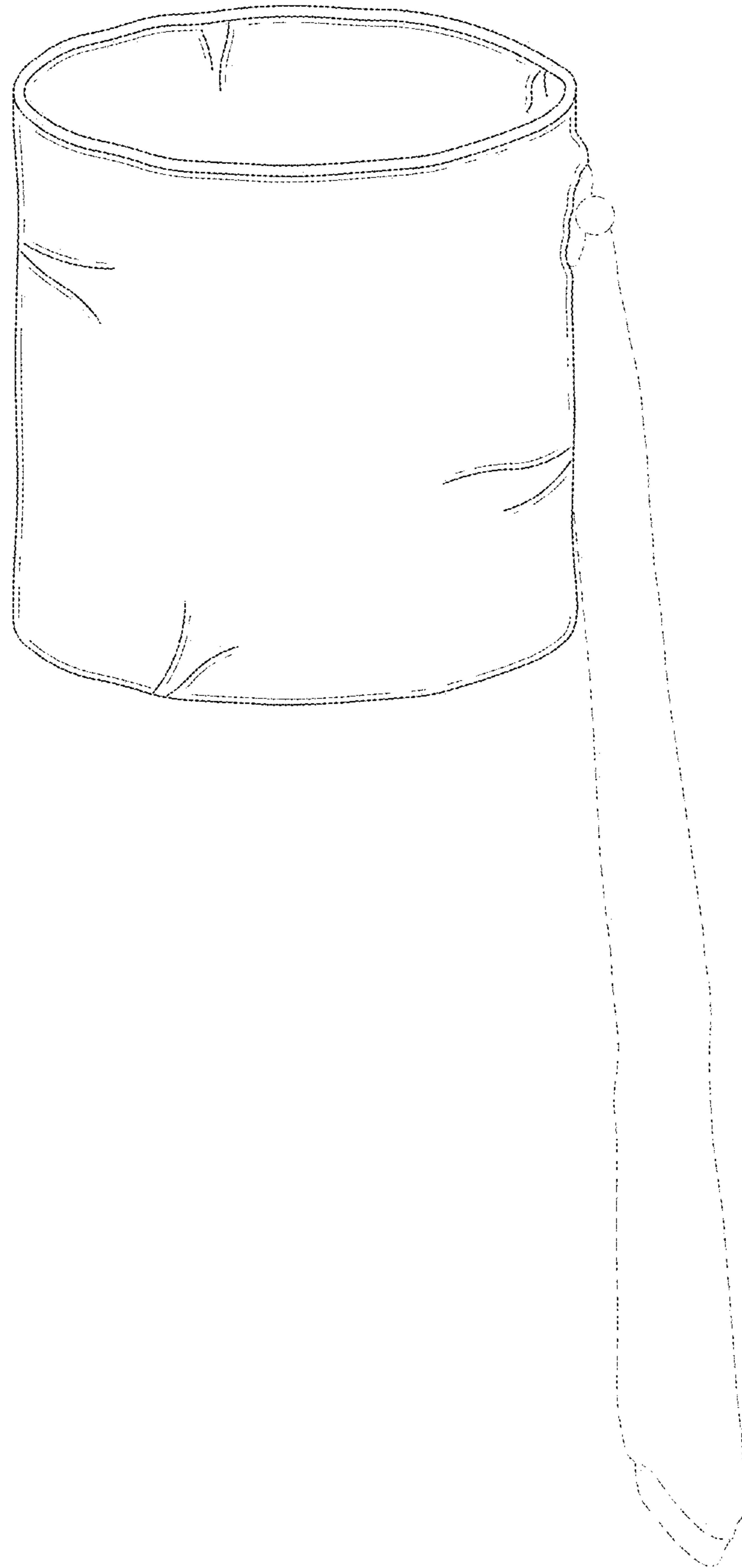

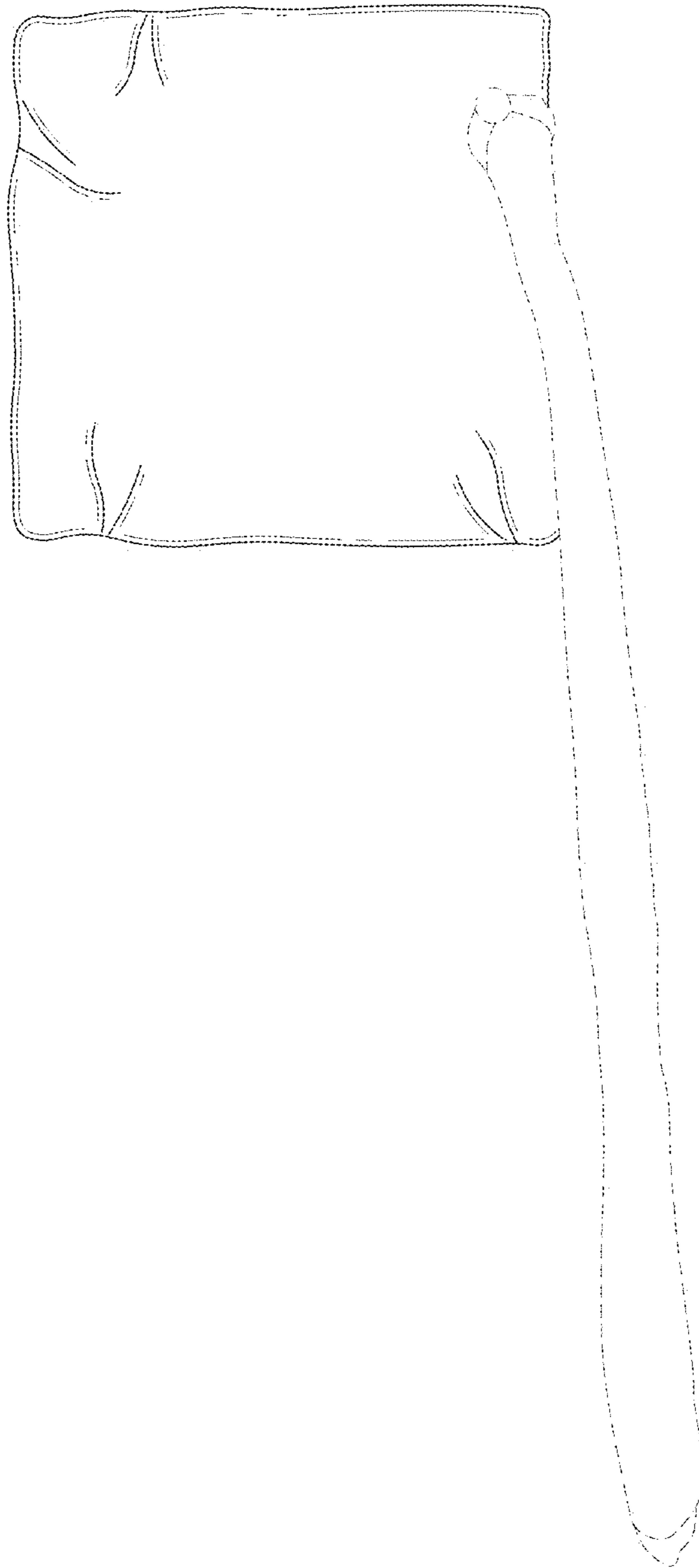

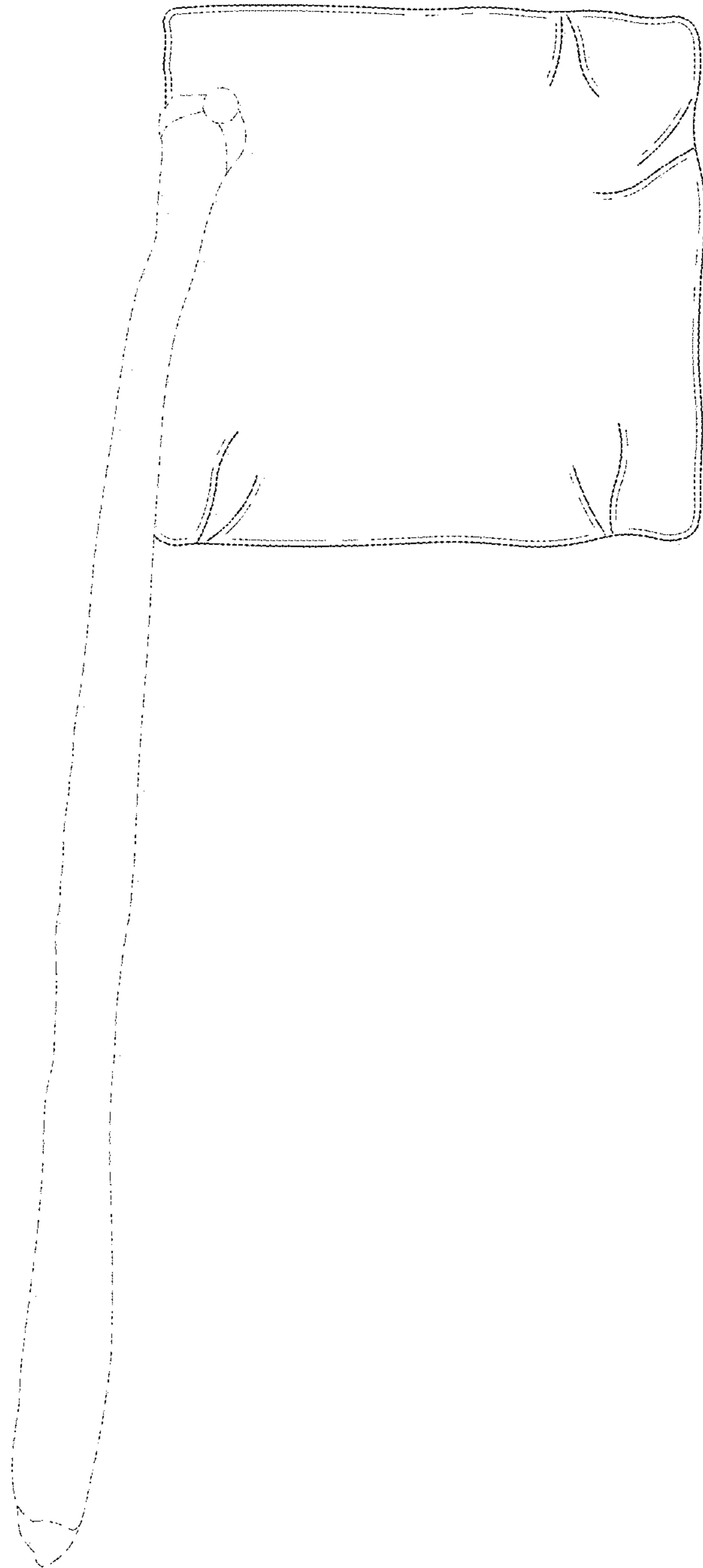

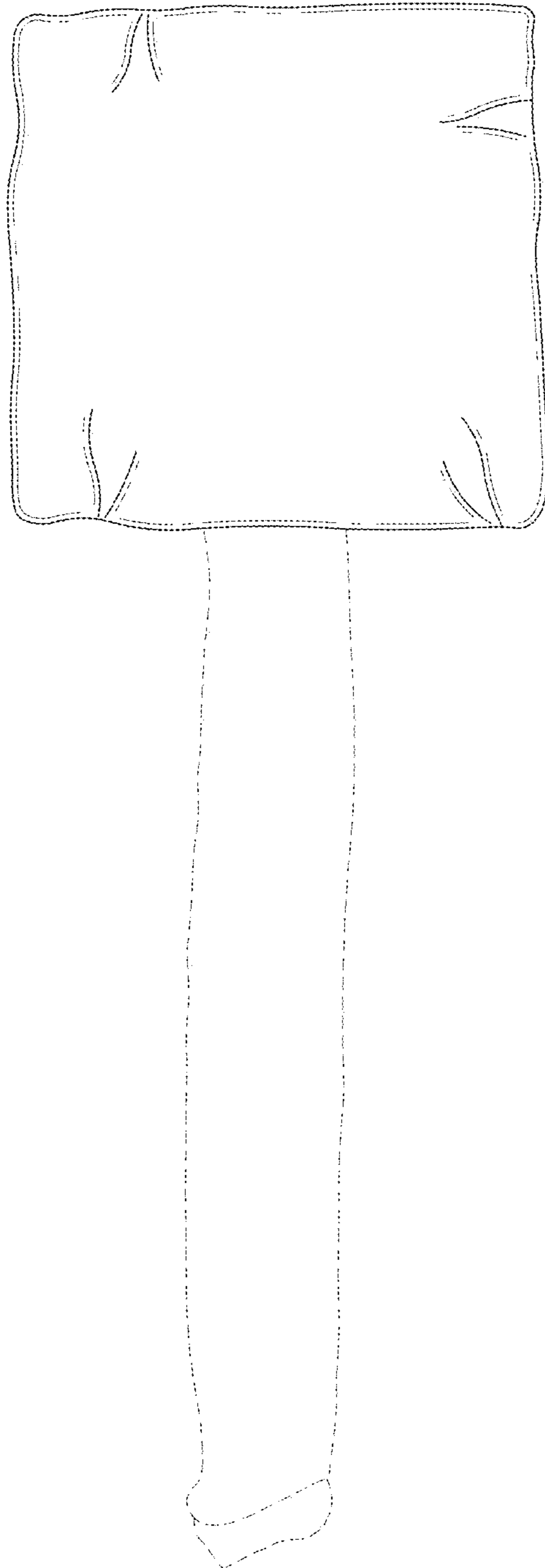

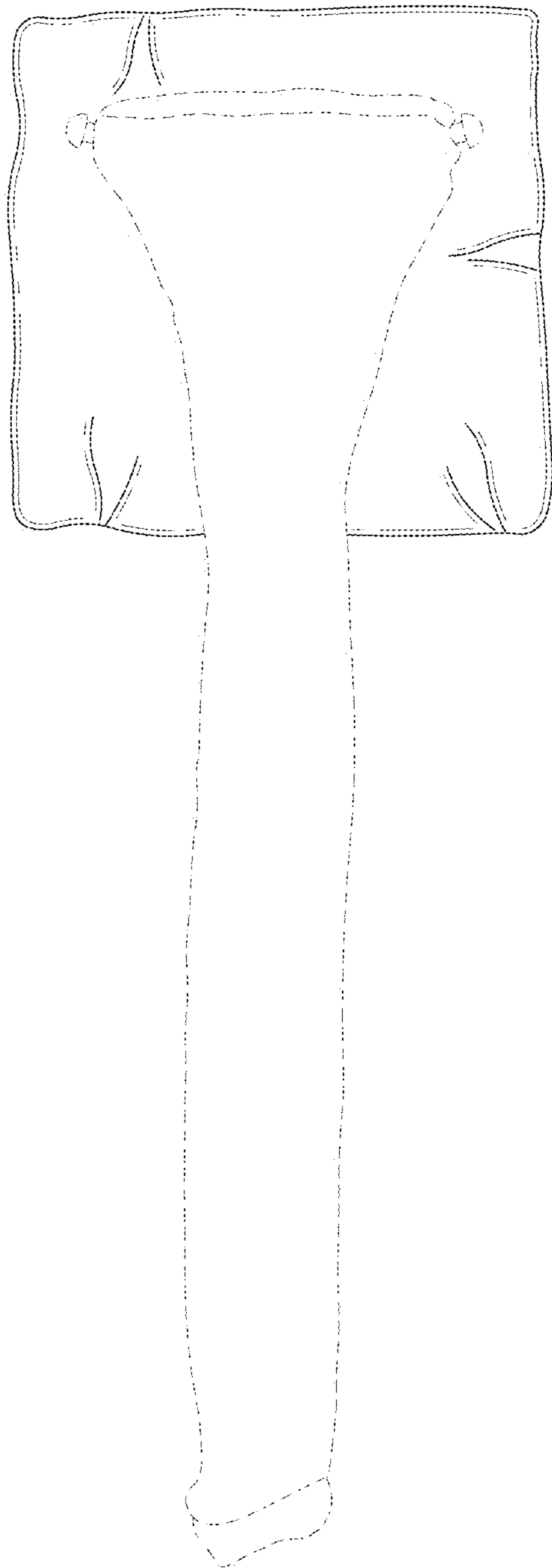

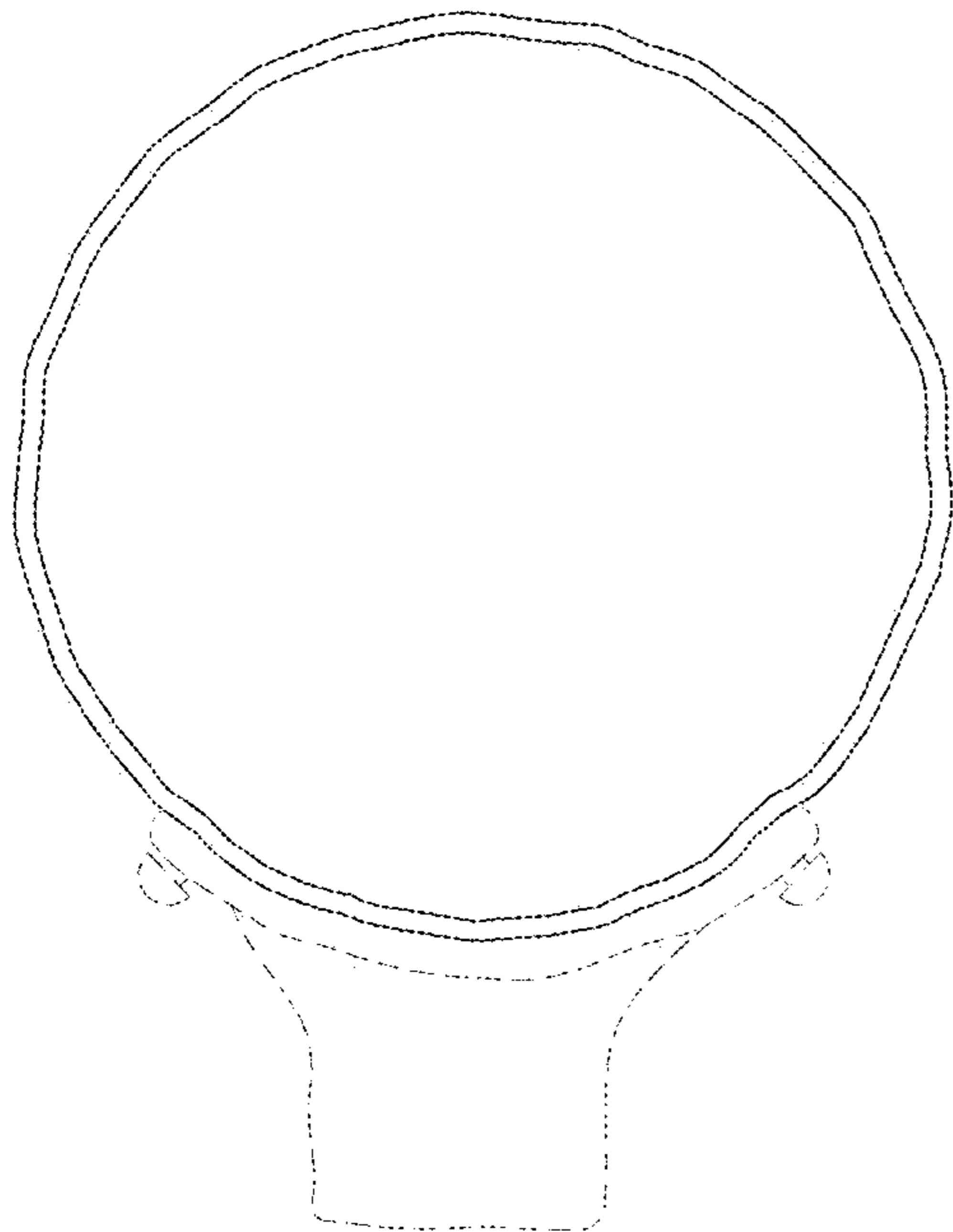

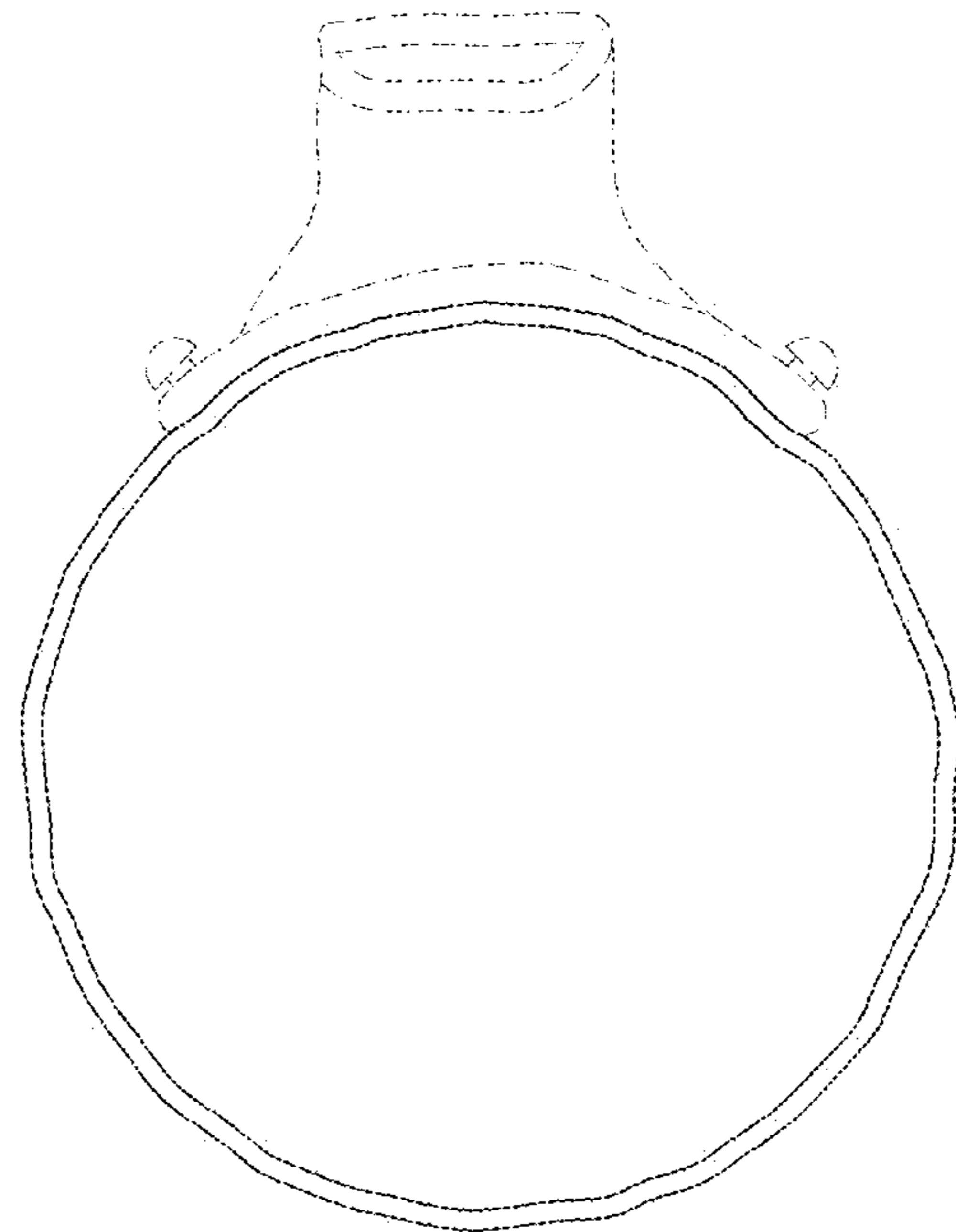

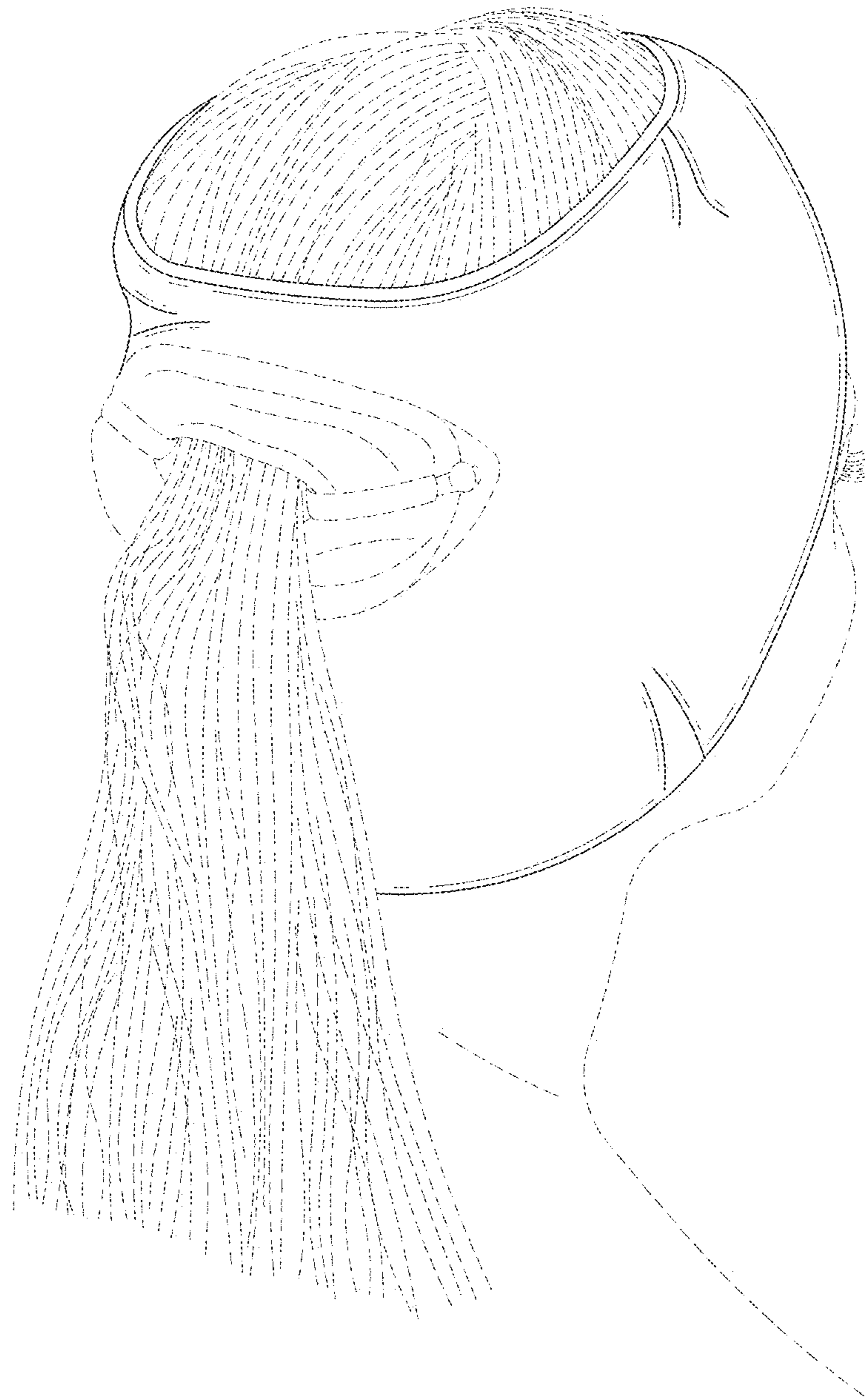
