(57) **CLAIM**

The ornamental design for a golf bag, as shown and described.

DESCRIPTION

FIG. 11 is a front view of a second embodiment of the golf bag, thereof;

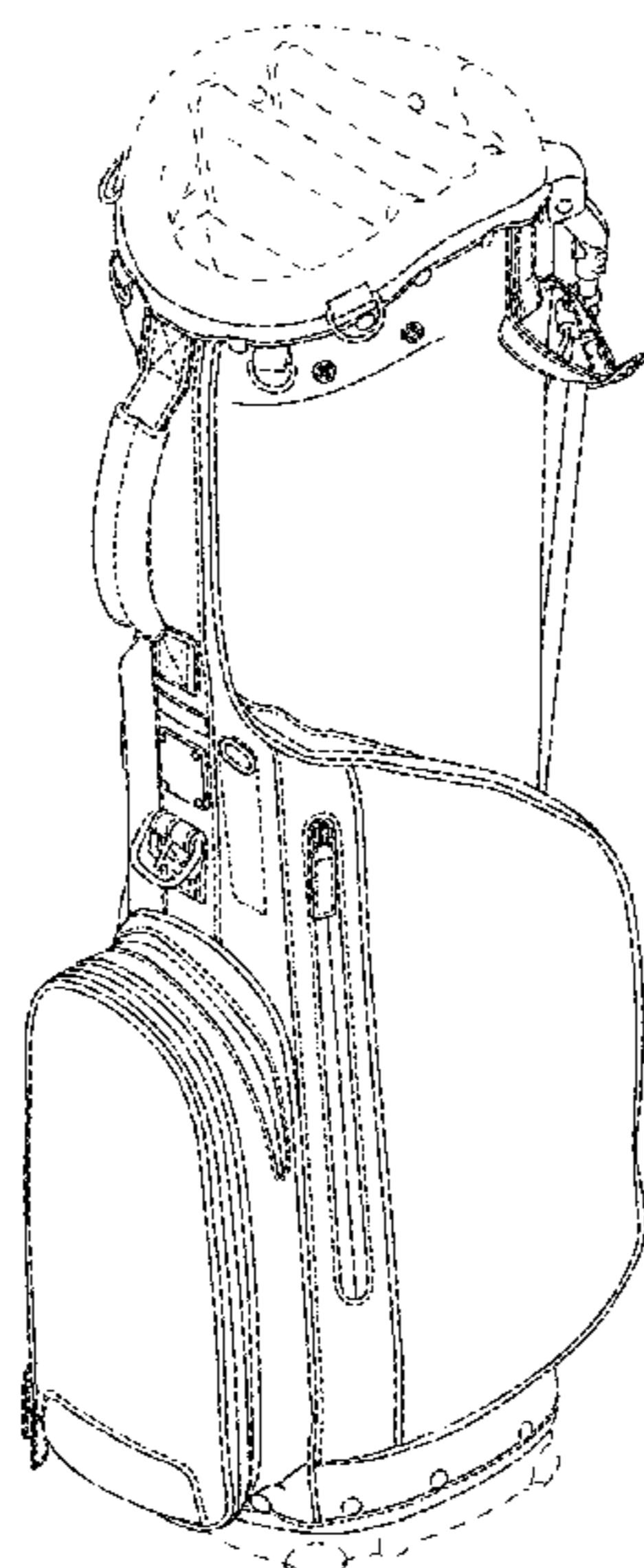
FIG. 12 is a second side view of a second embodiment of the golf bag, thereof;

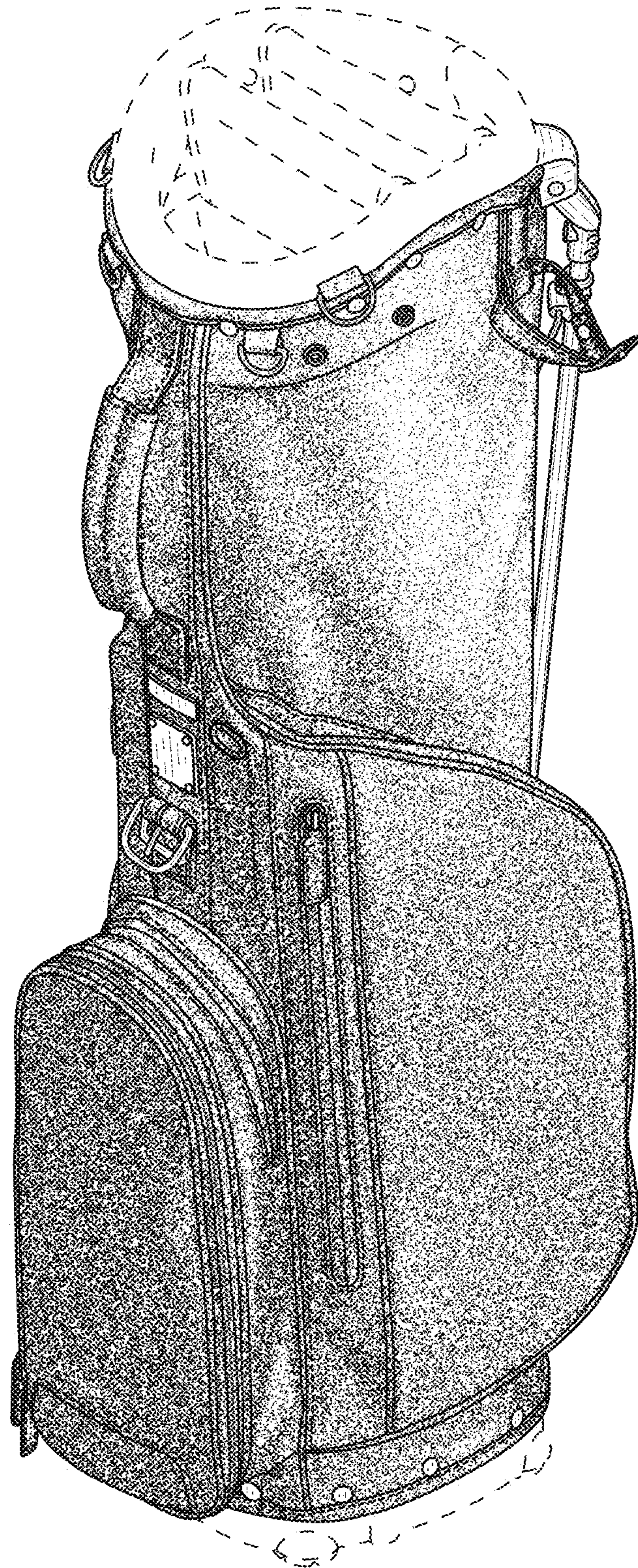

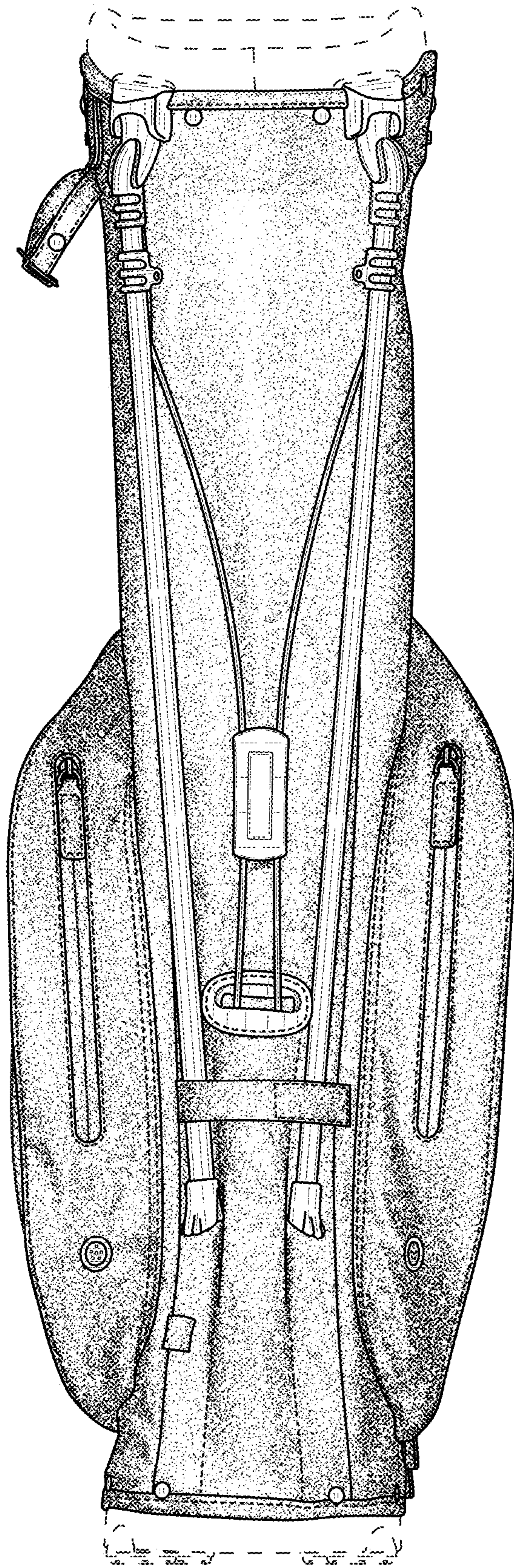

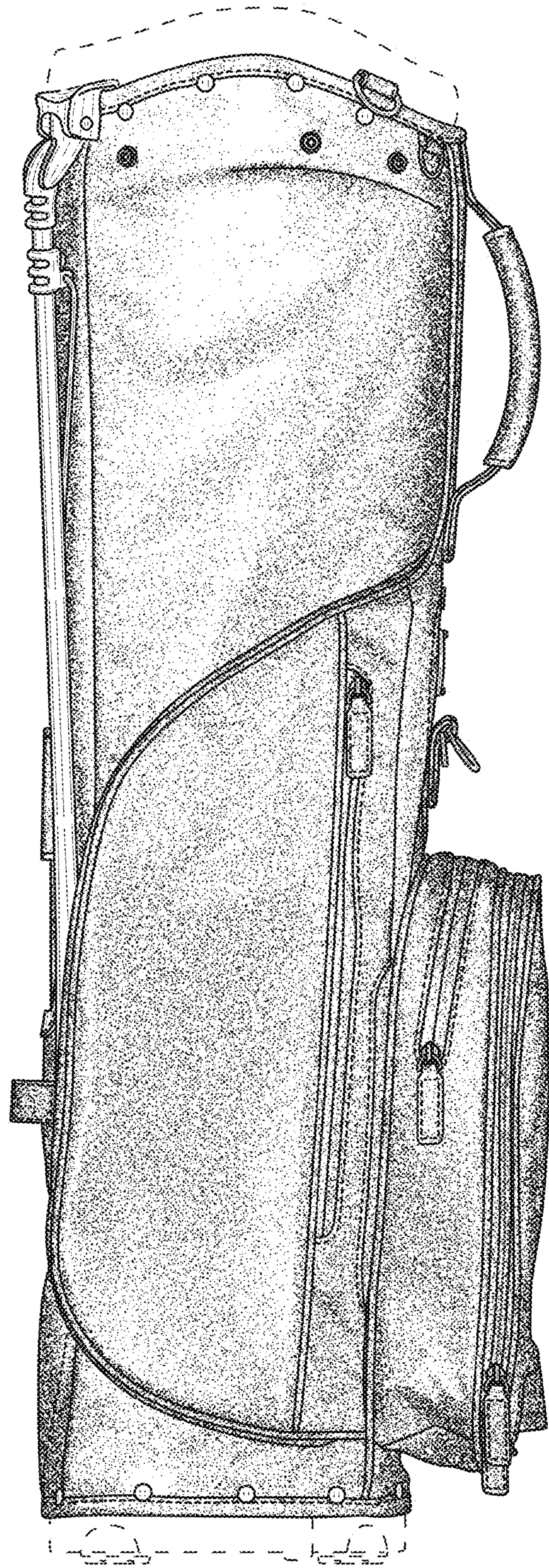

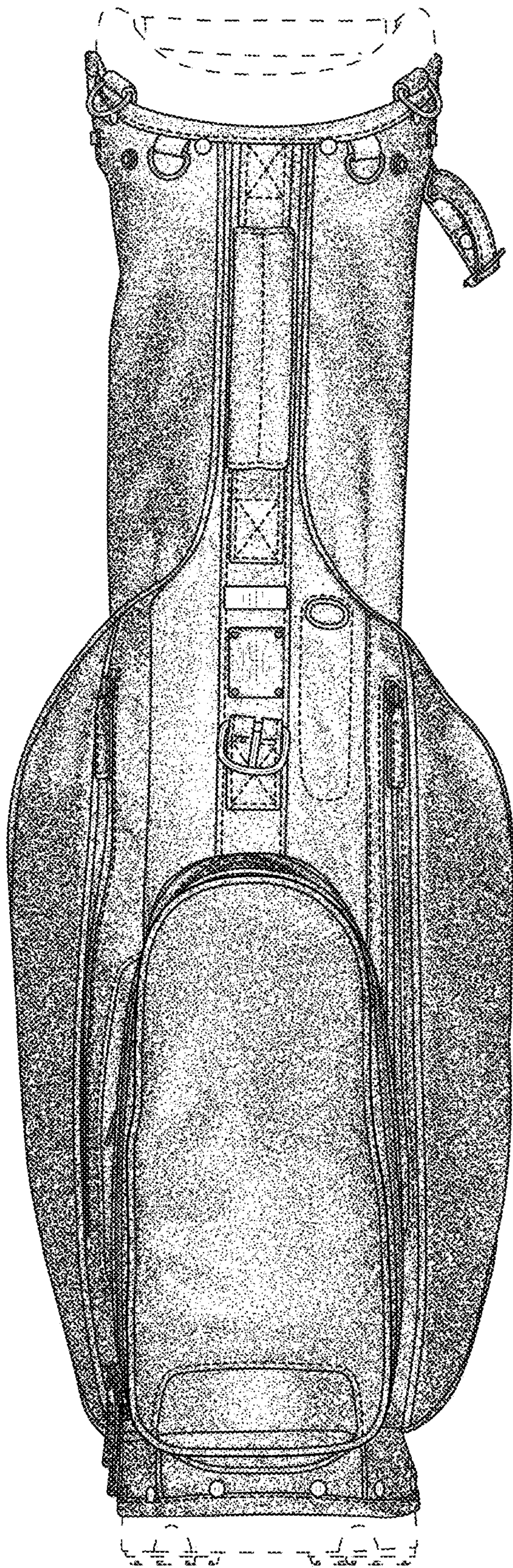

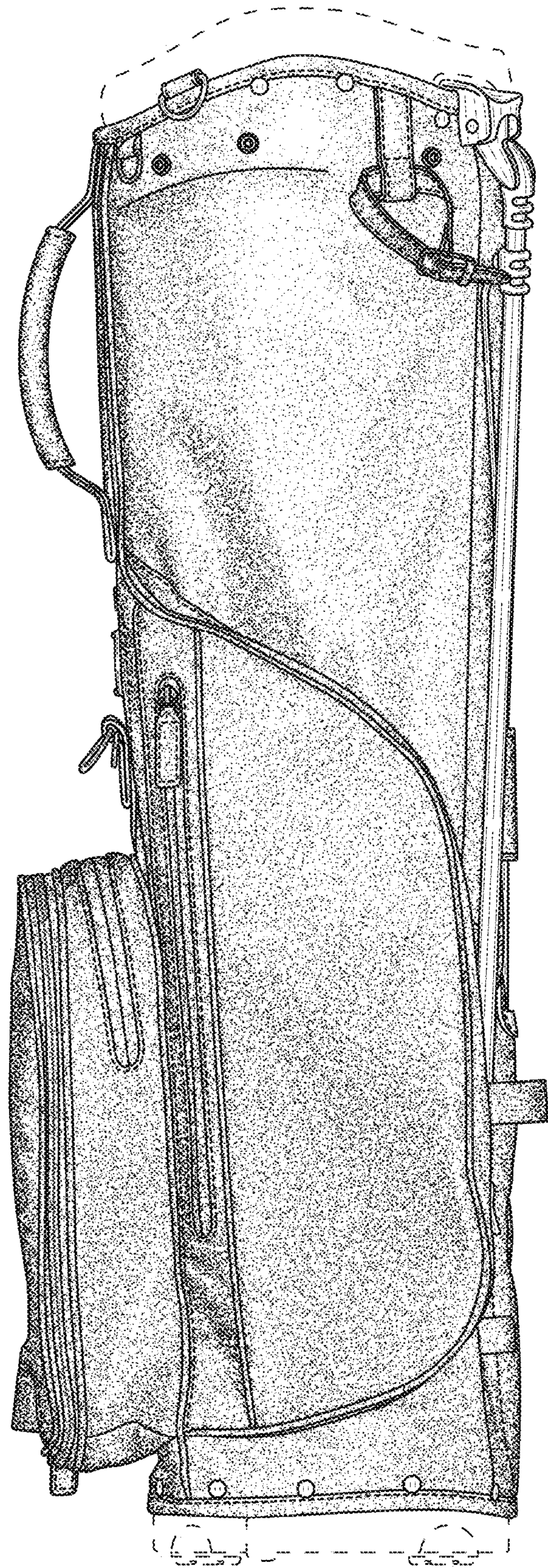

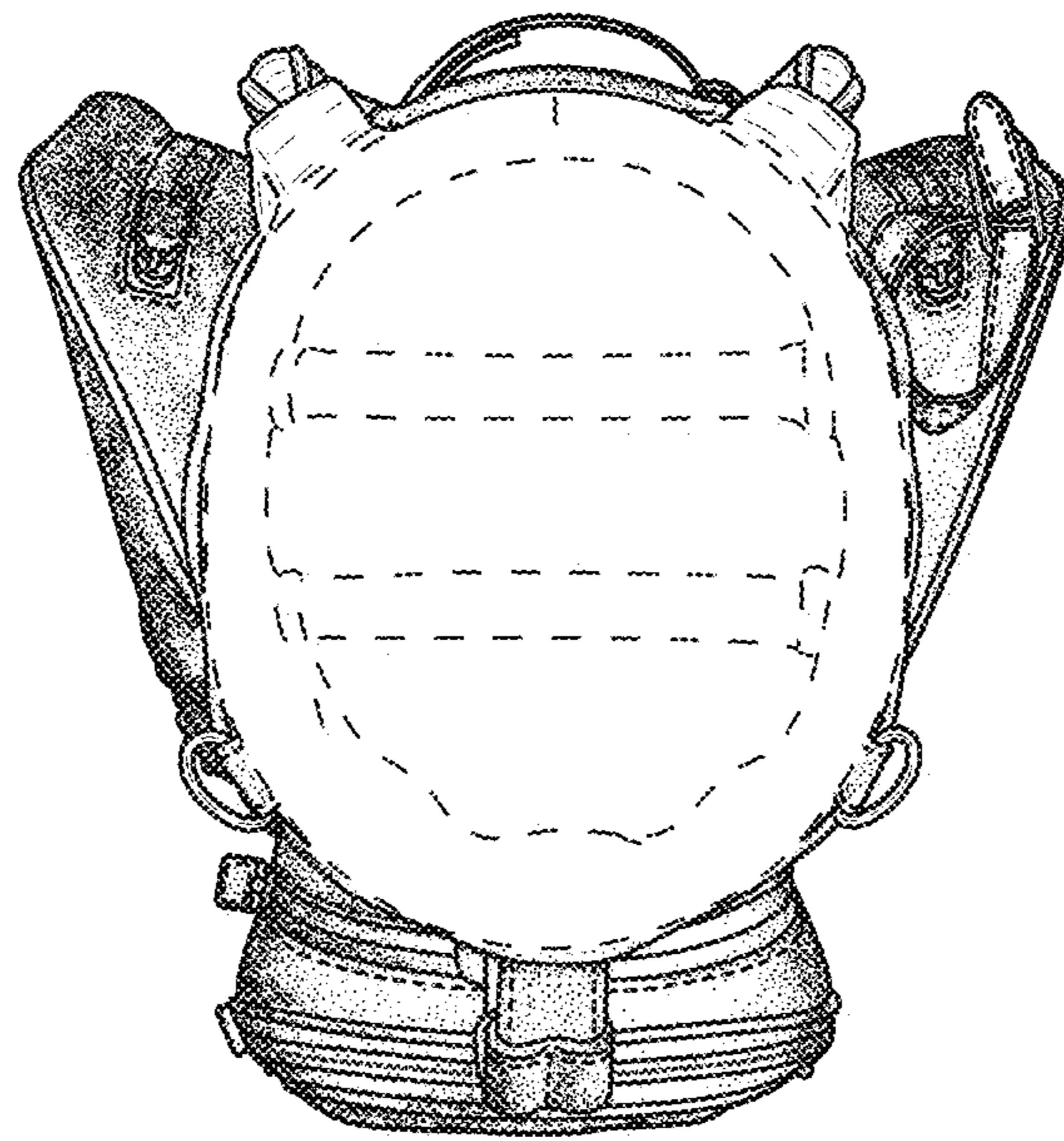

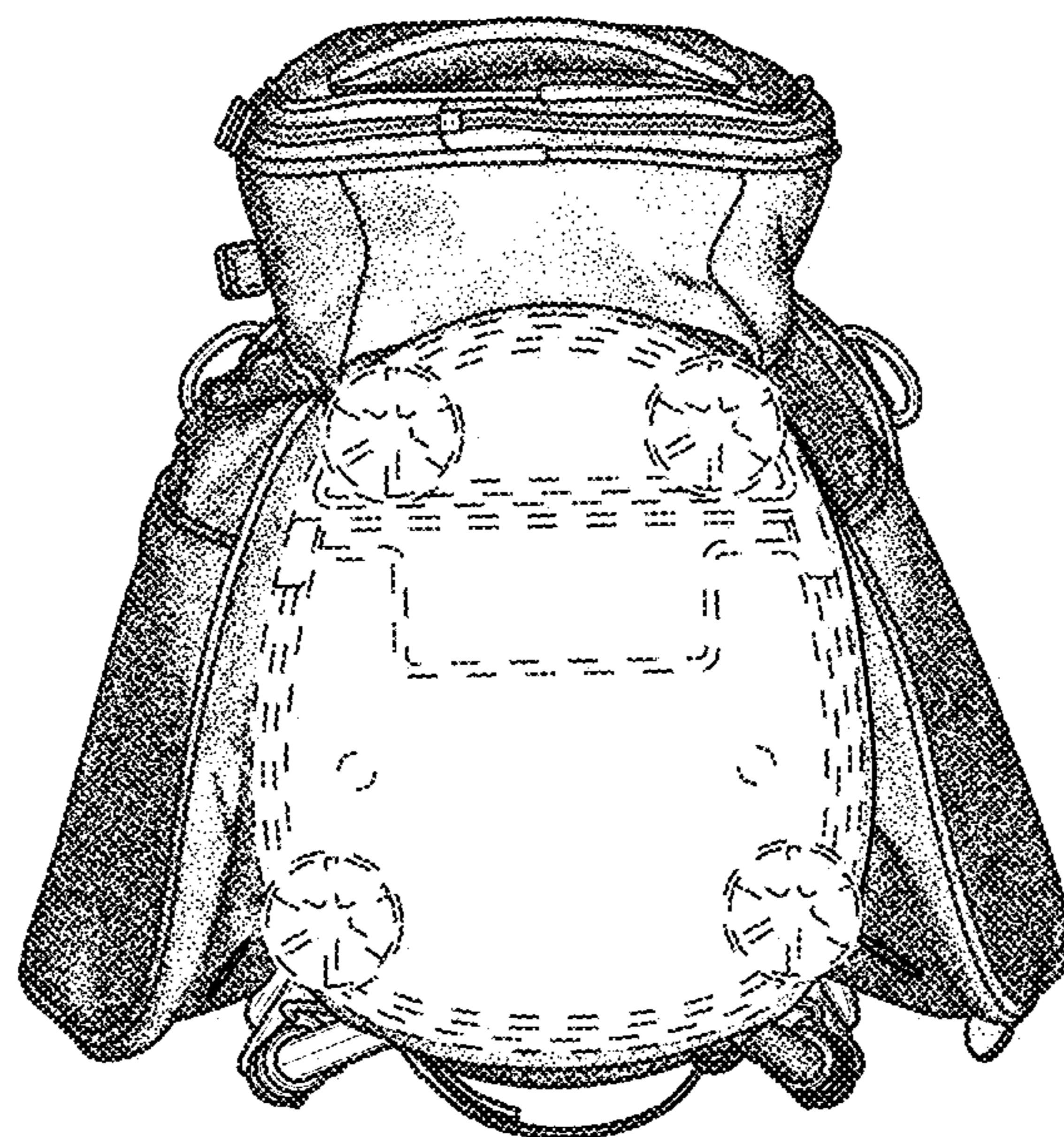

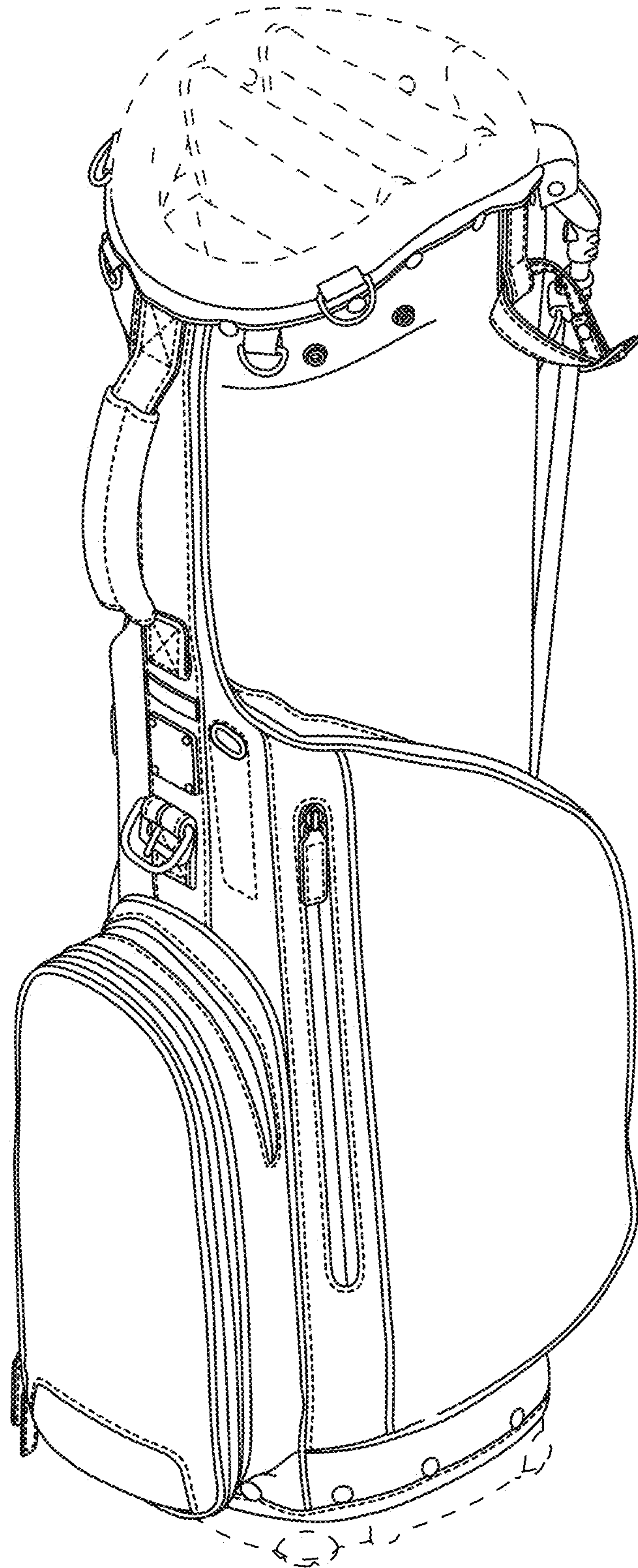

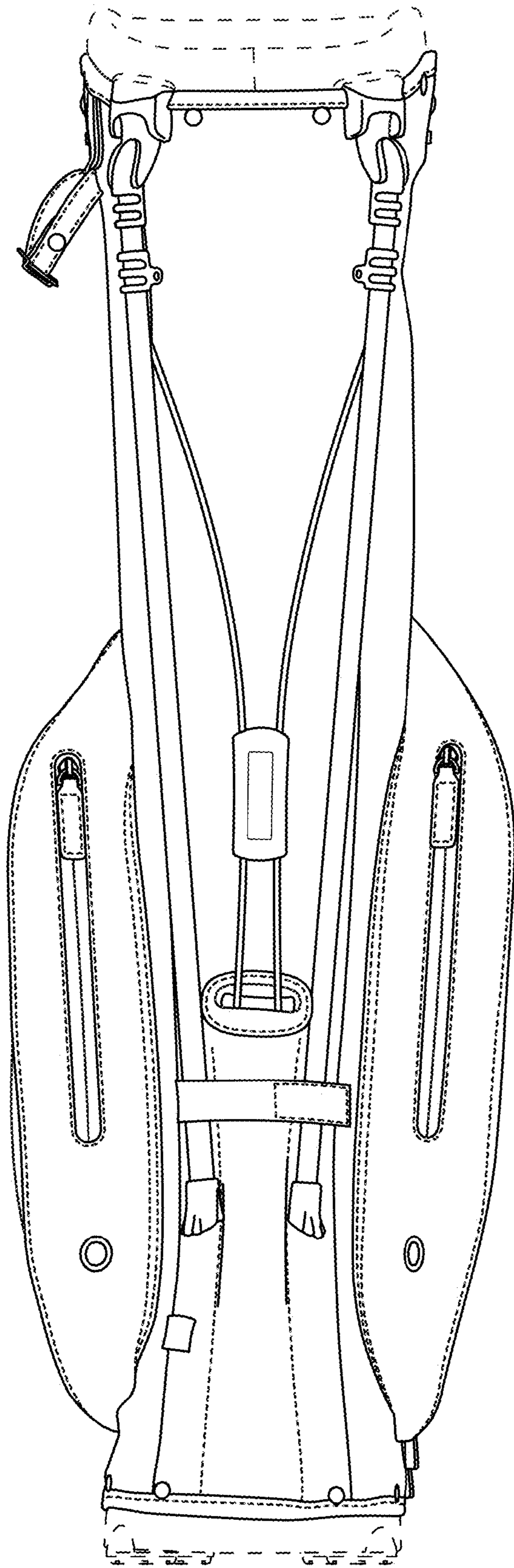

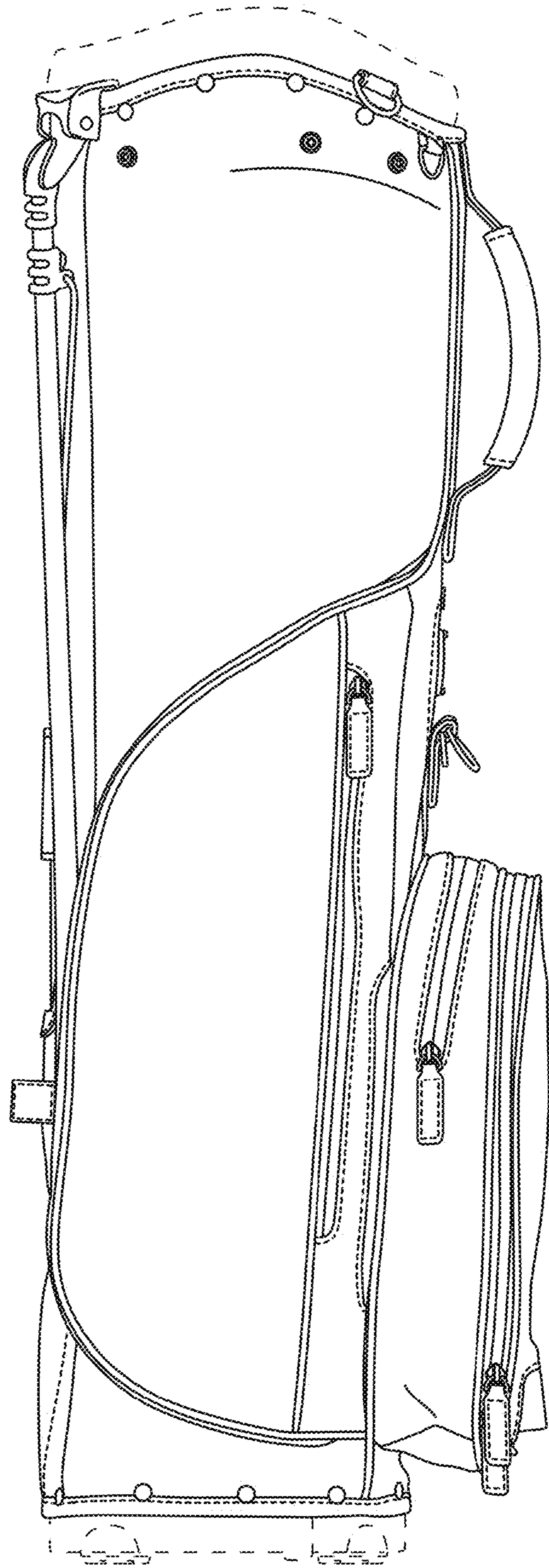

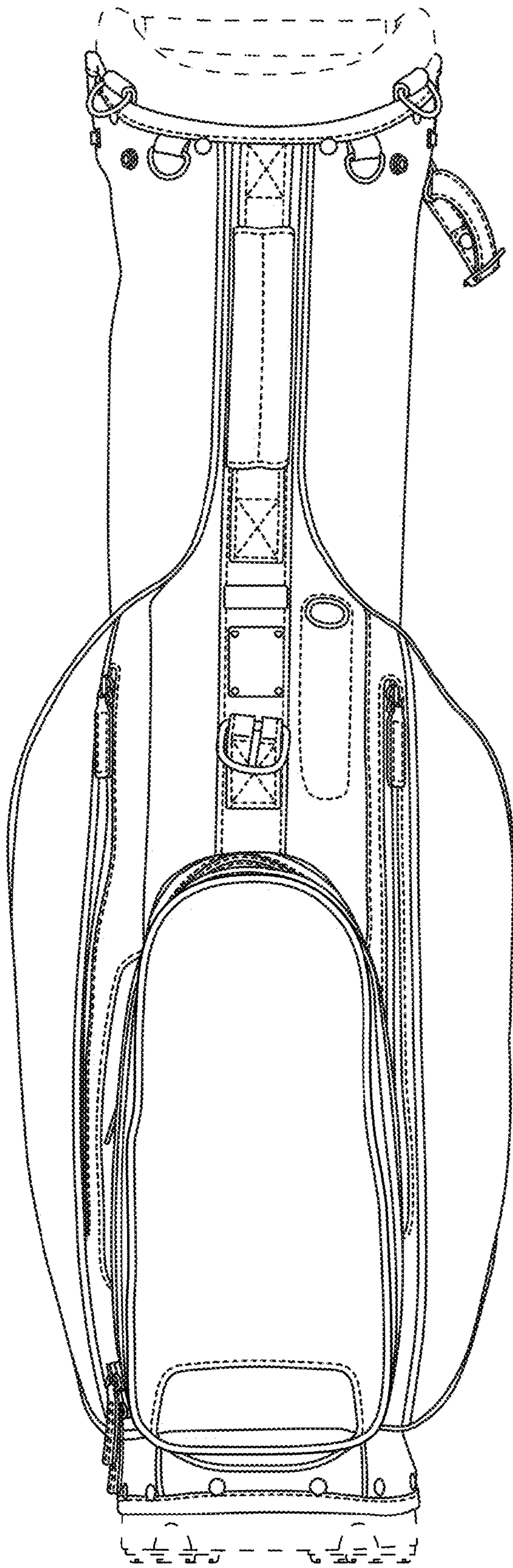

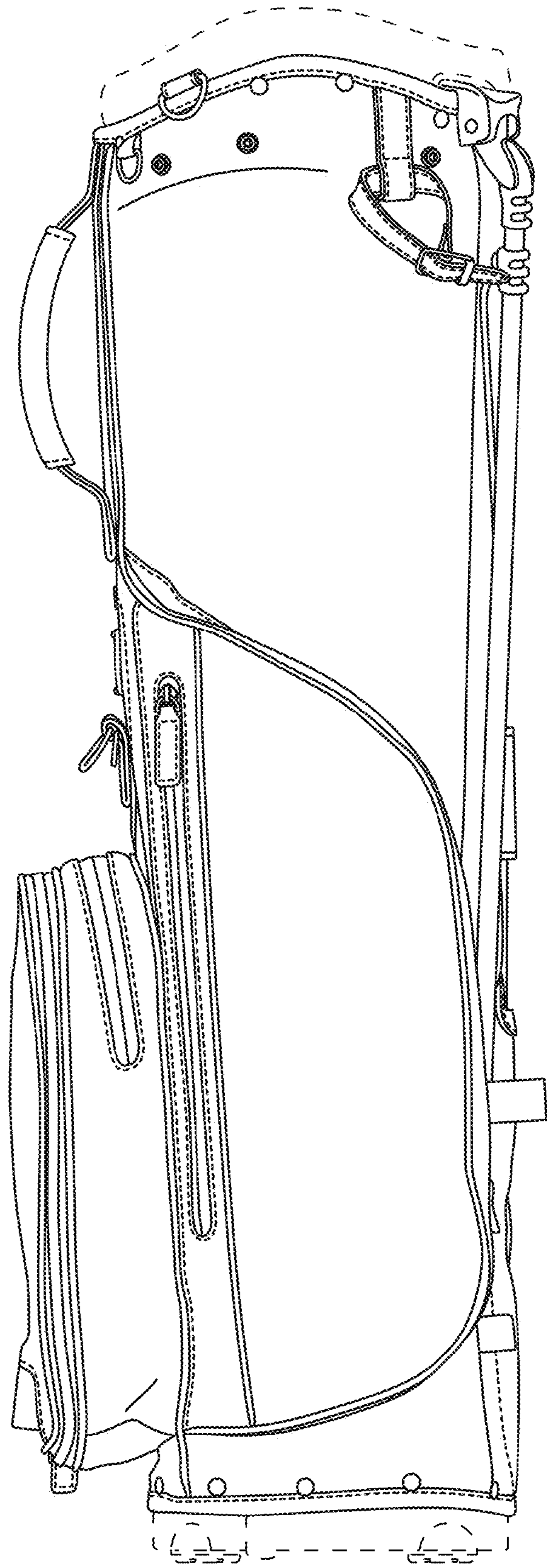

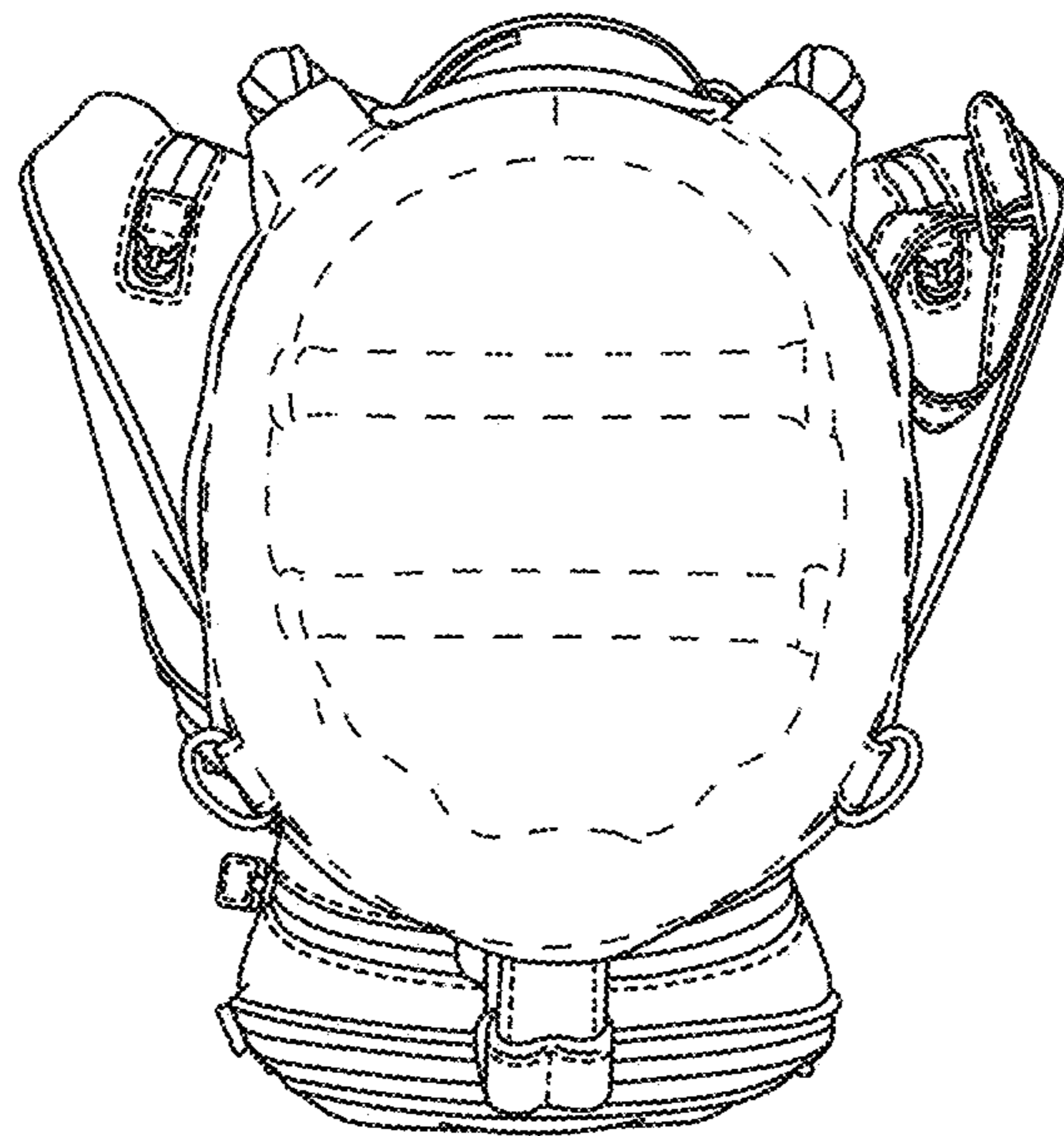

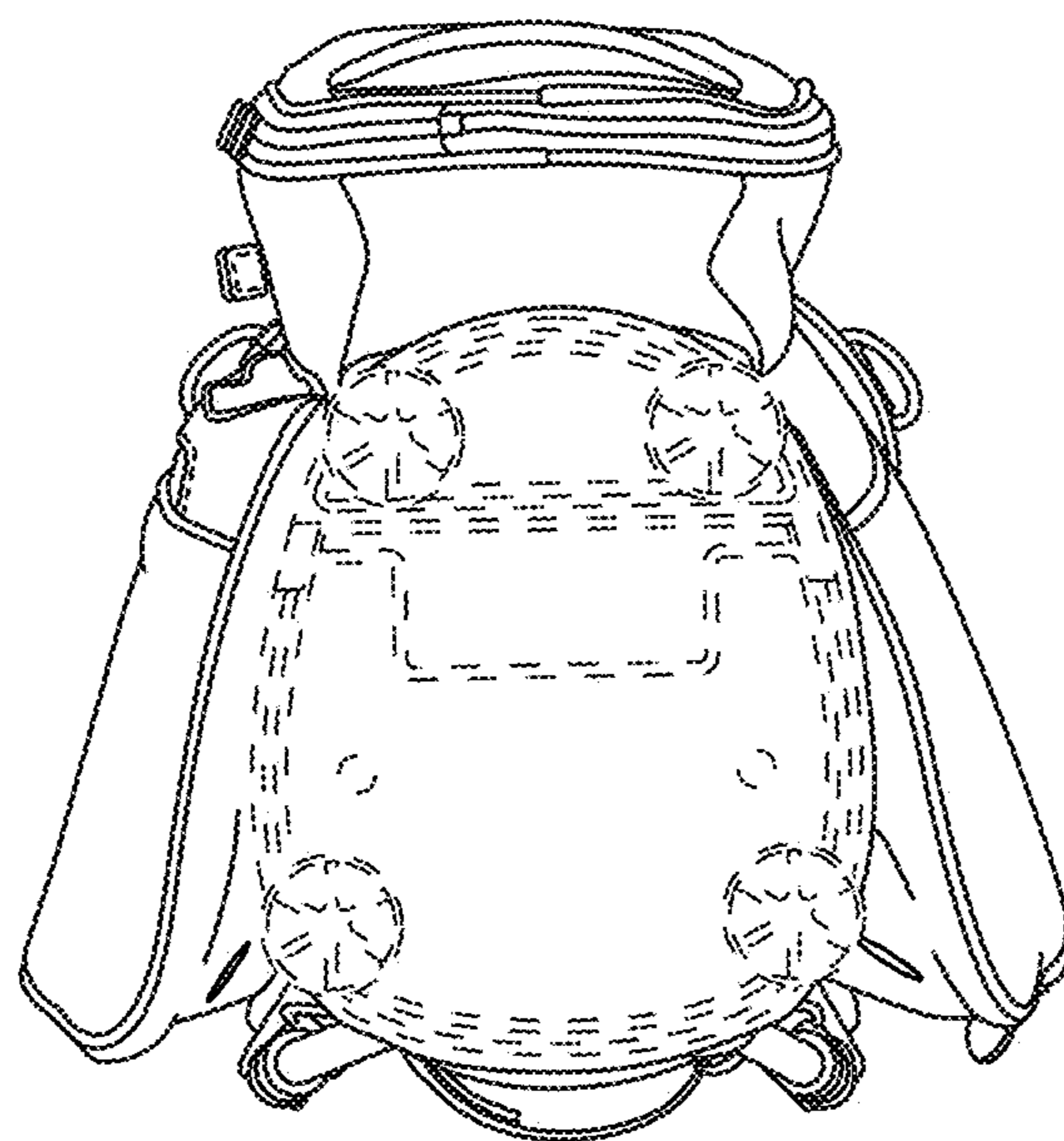
