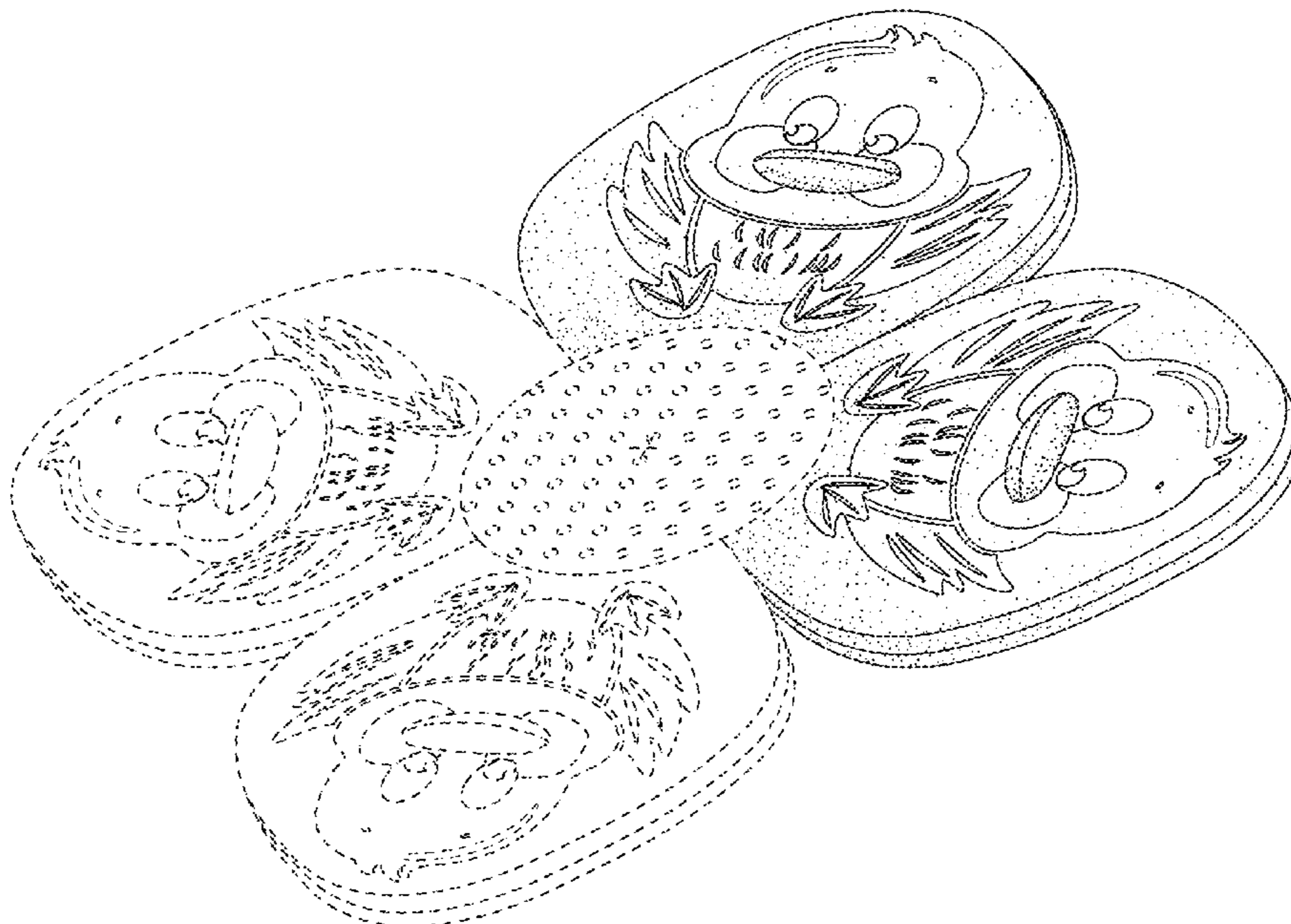
(57) **CLAIM**

The ornamental design for a bathing basin insert, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a bath basin insert showing the claimed design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a rear side view thereof;
FIG. 5 is a front side view thereof;
FIG. 6 is a right side view thereof; and,
FIG. 7 is a left side view thereof.

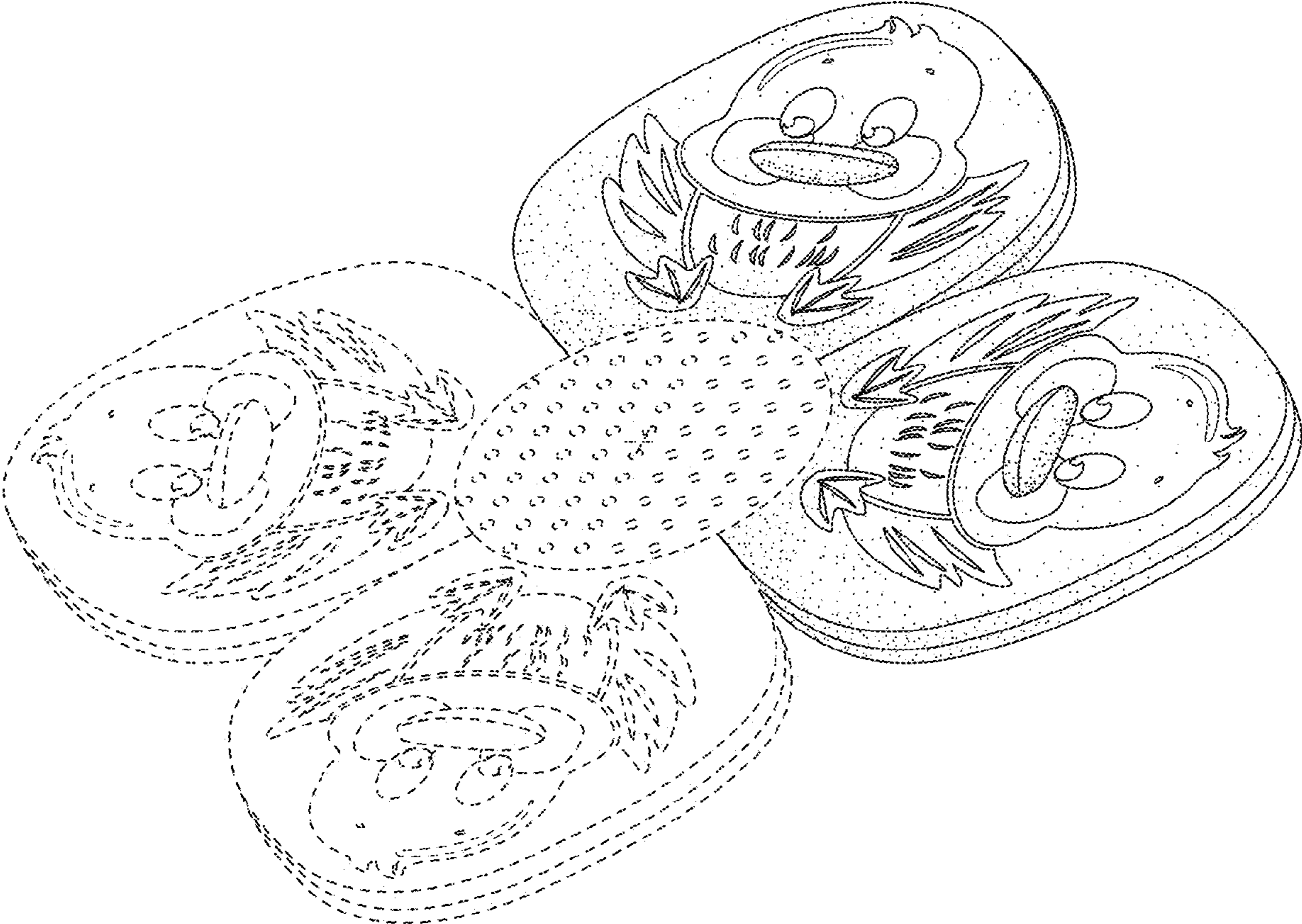

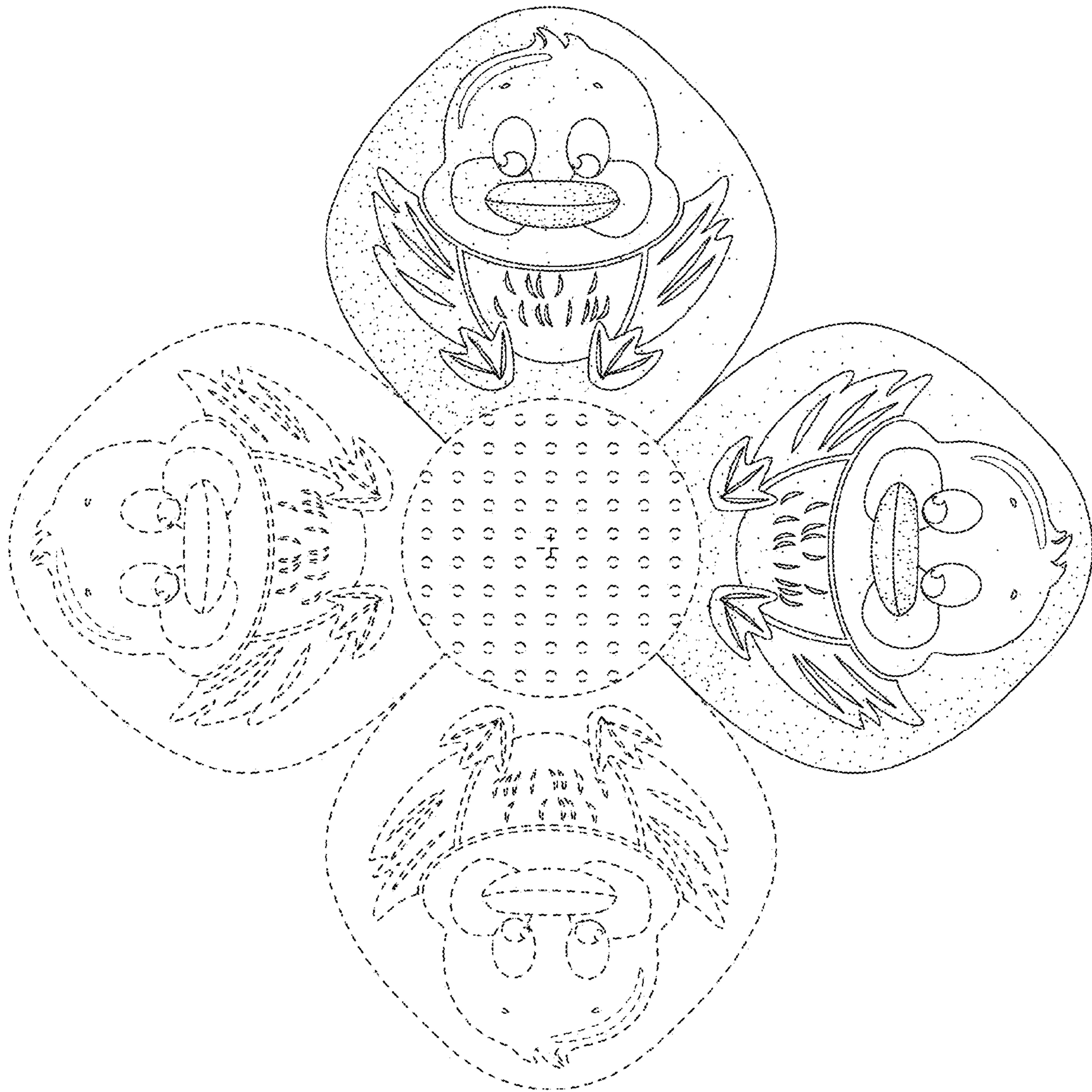

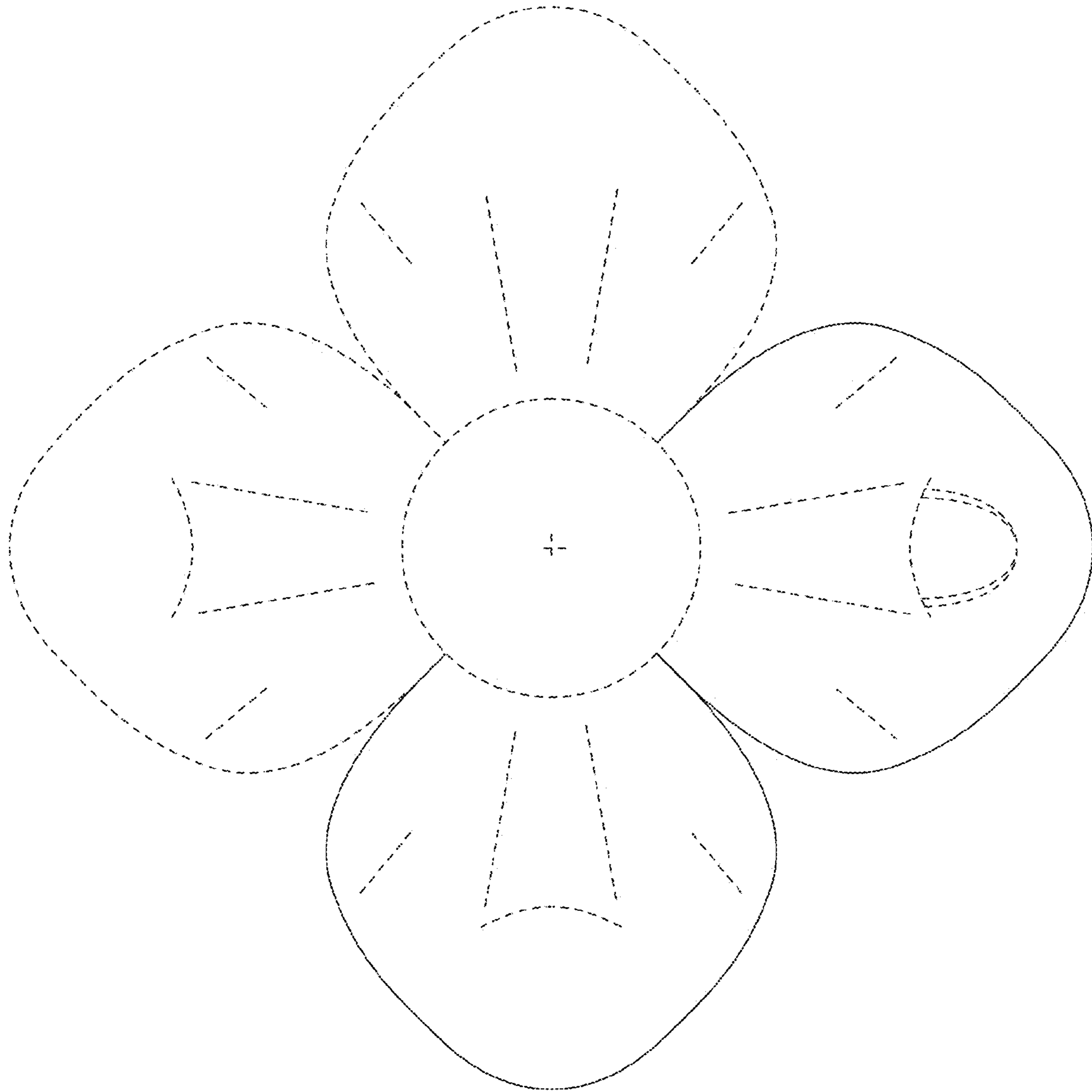

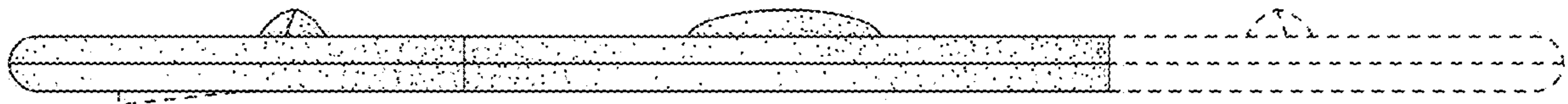

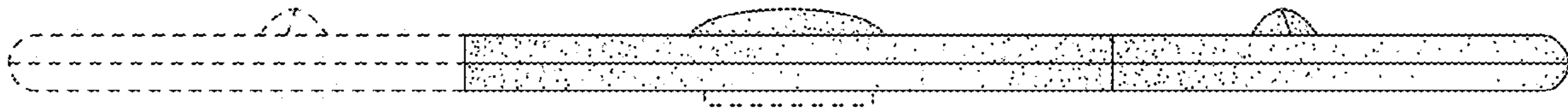
