(57) **CLAIM**

The ornamental design for a drinking straw, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom, front perspective view of a drinking straw, showing my new design;

FIG. 8 is a bottom plan view thereof;

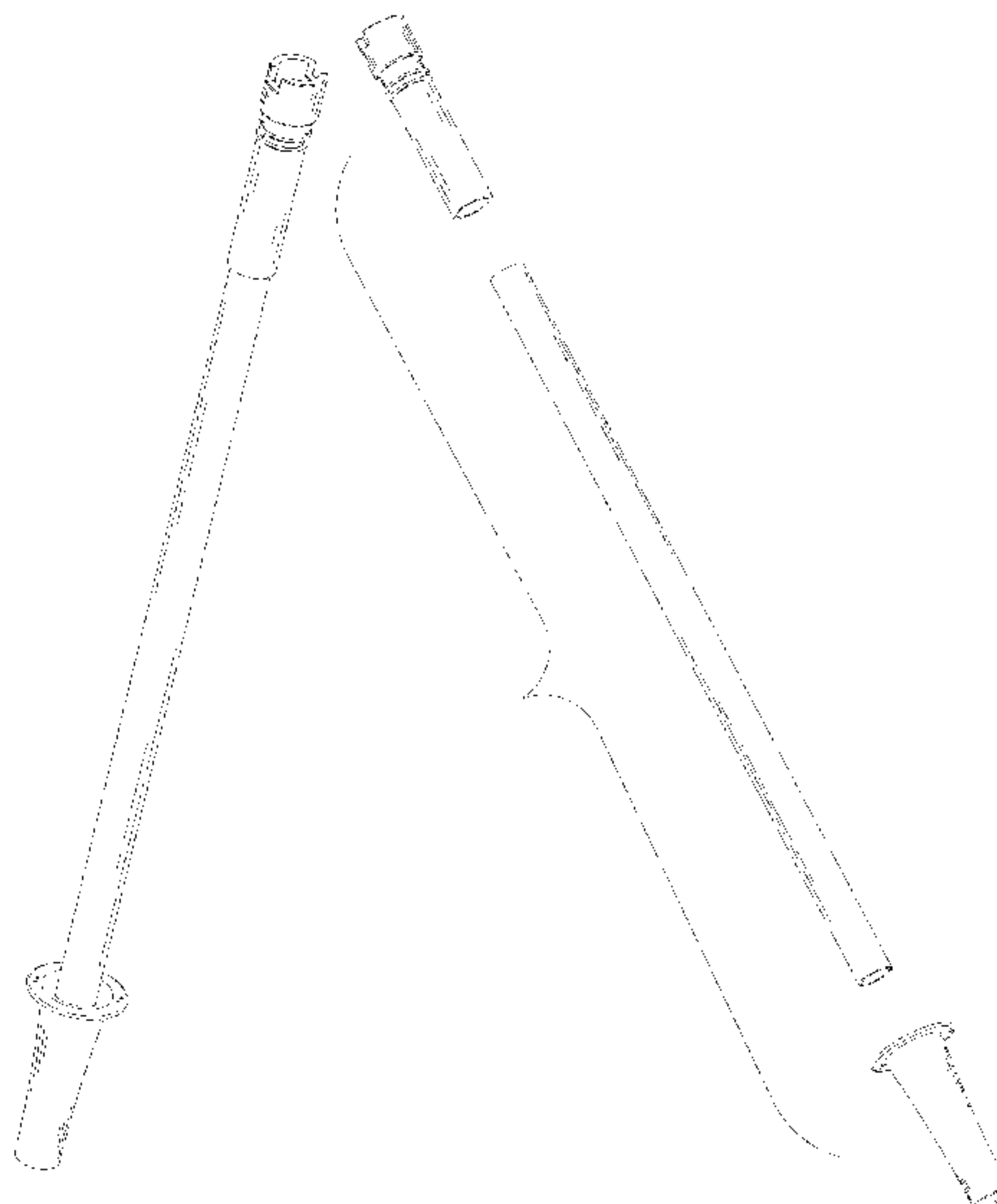
FIG. 9 is a top plan view of the drinking straw of FIG. 1, shown enlarged for clarity of disclosure;

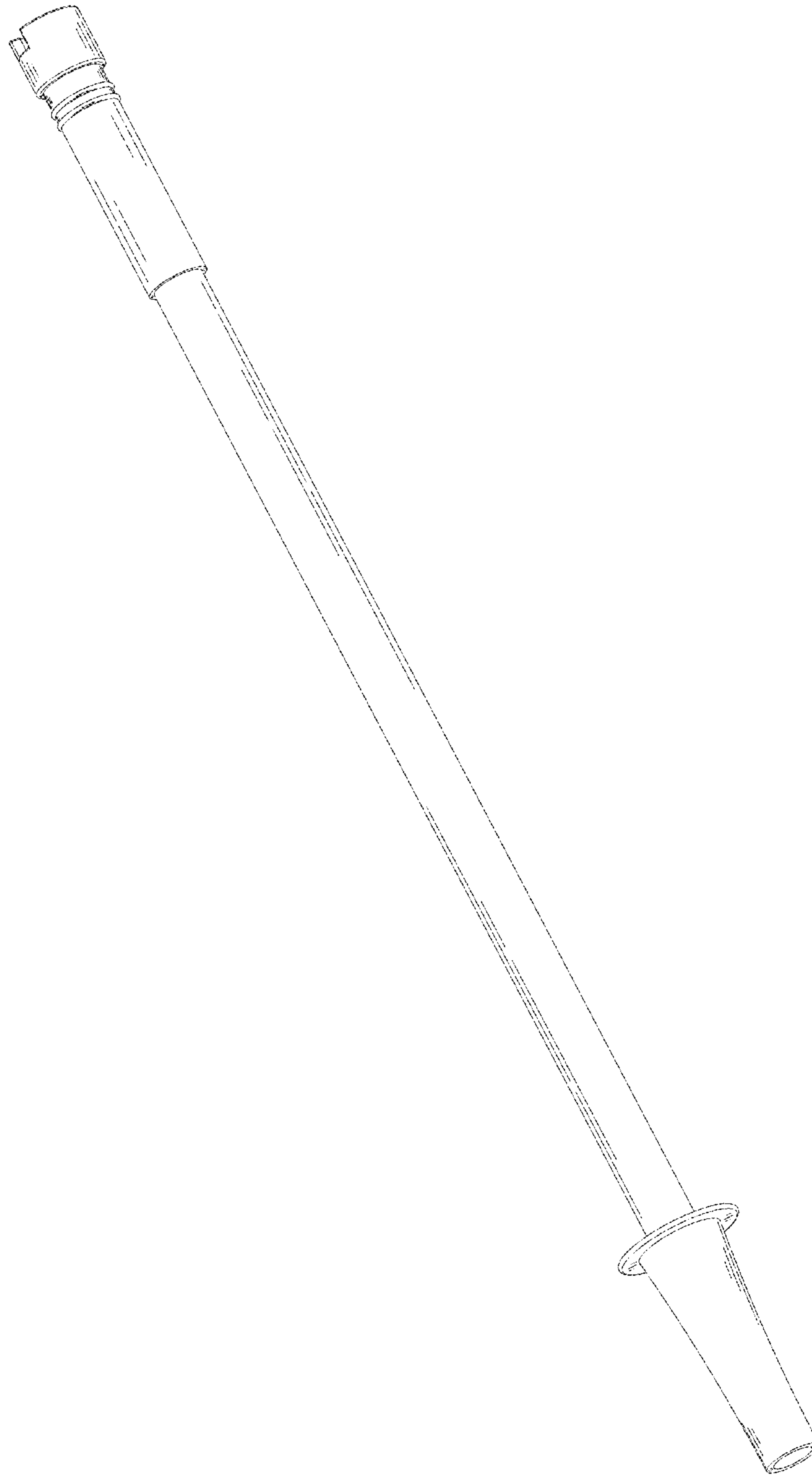

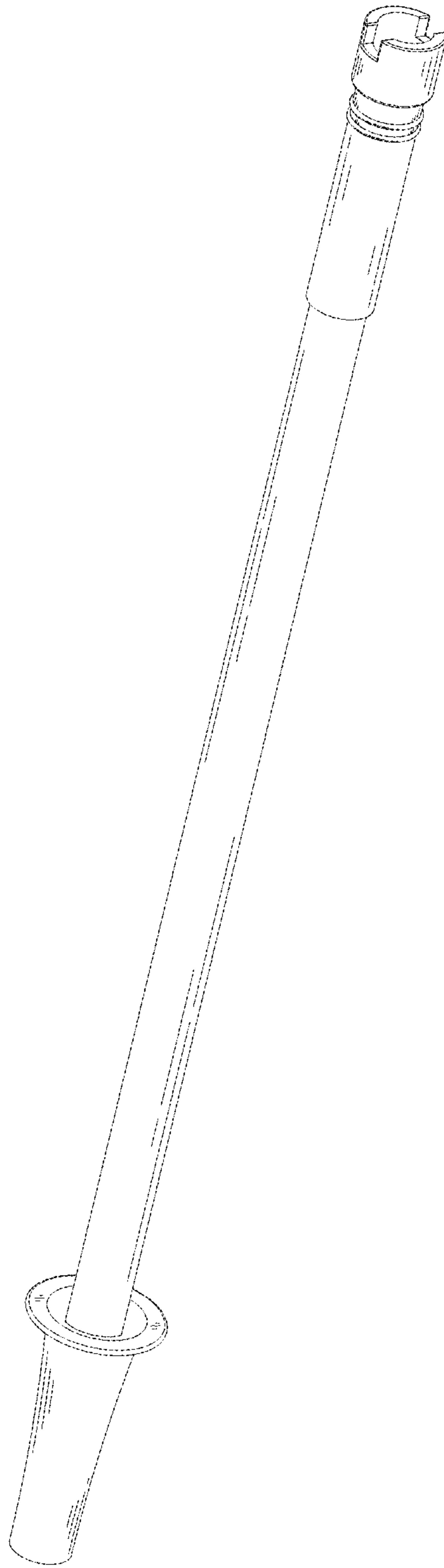

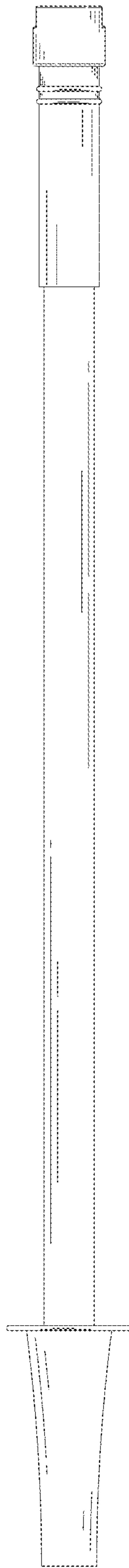

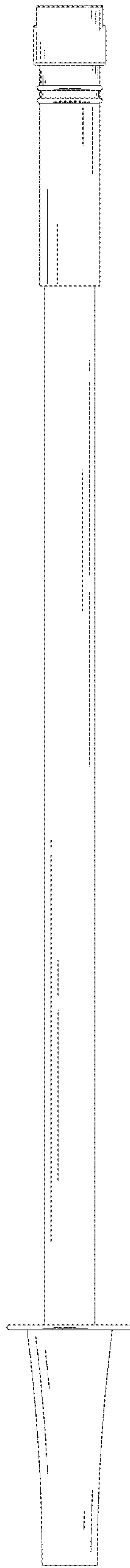

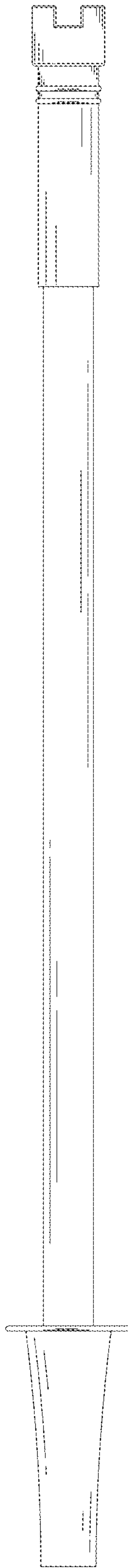

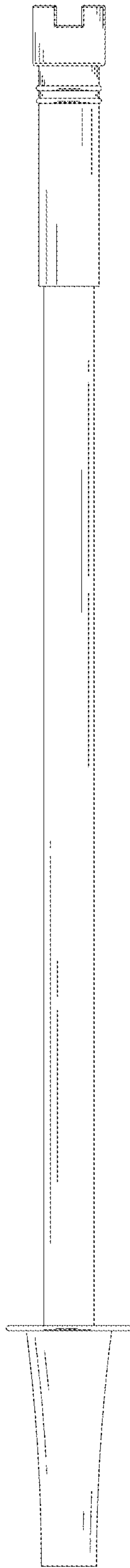

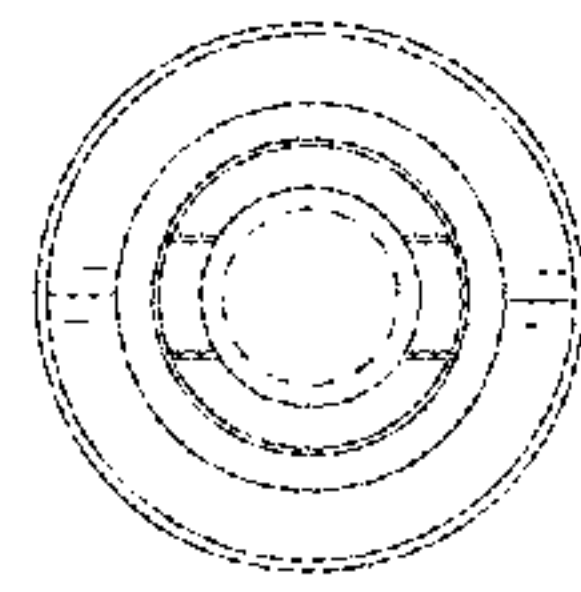

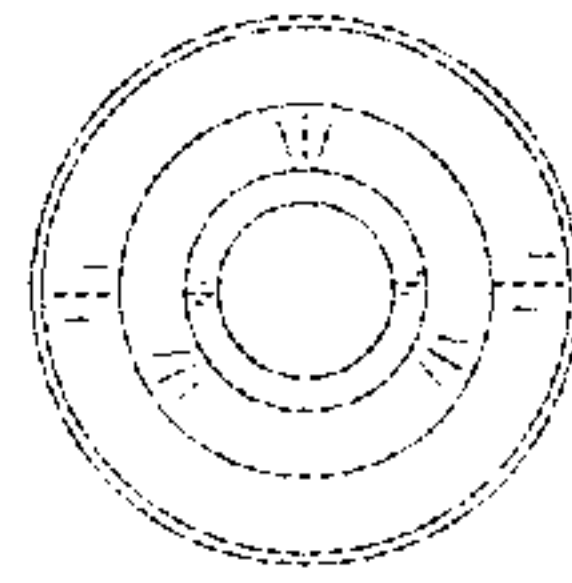

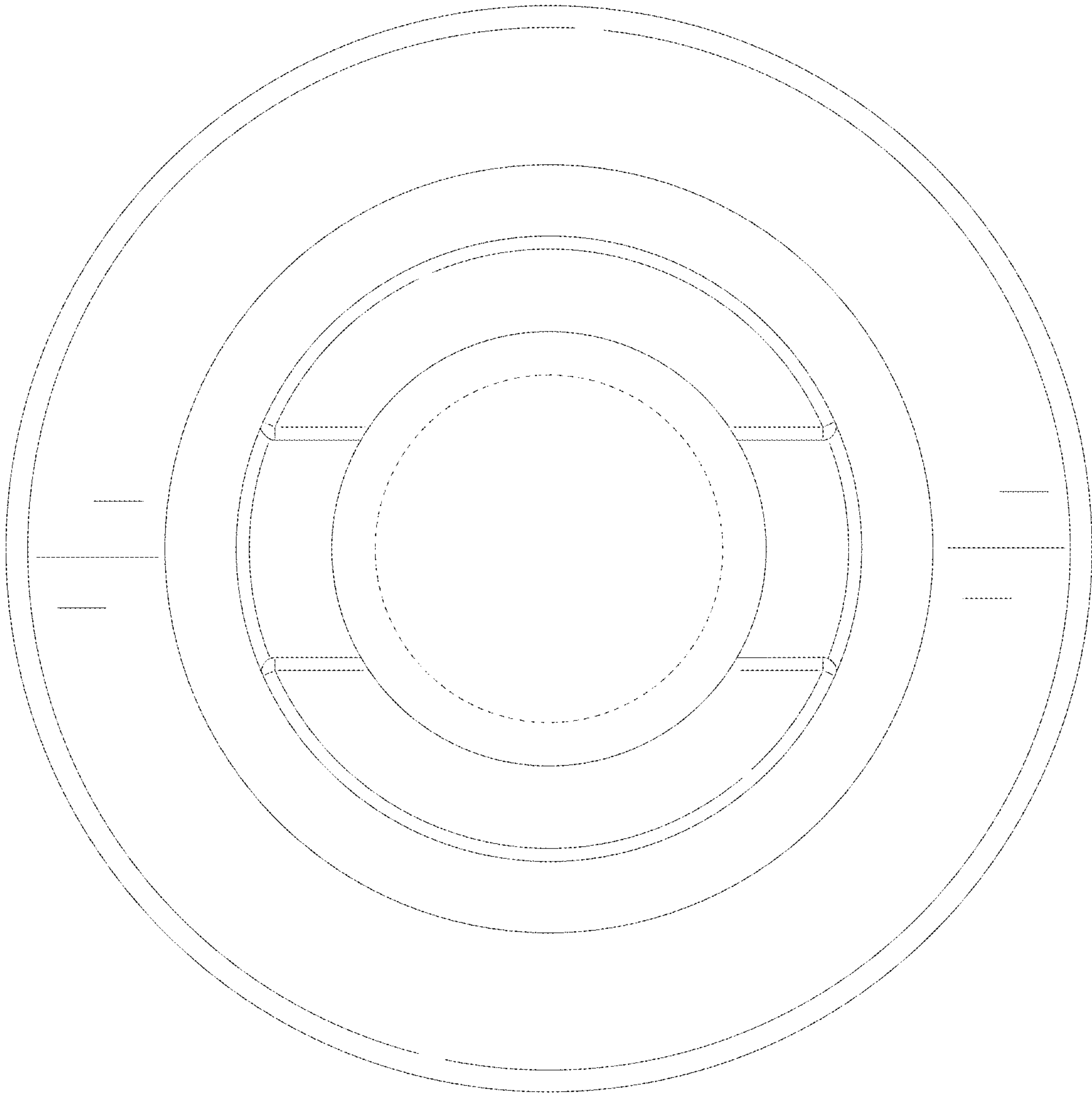

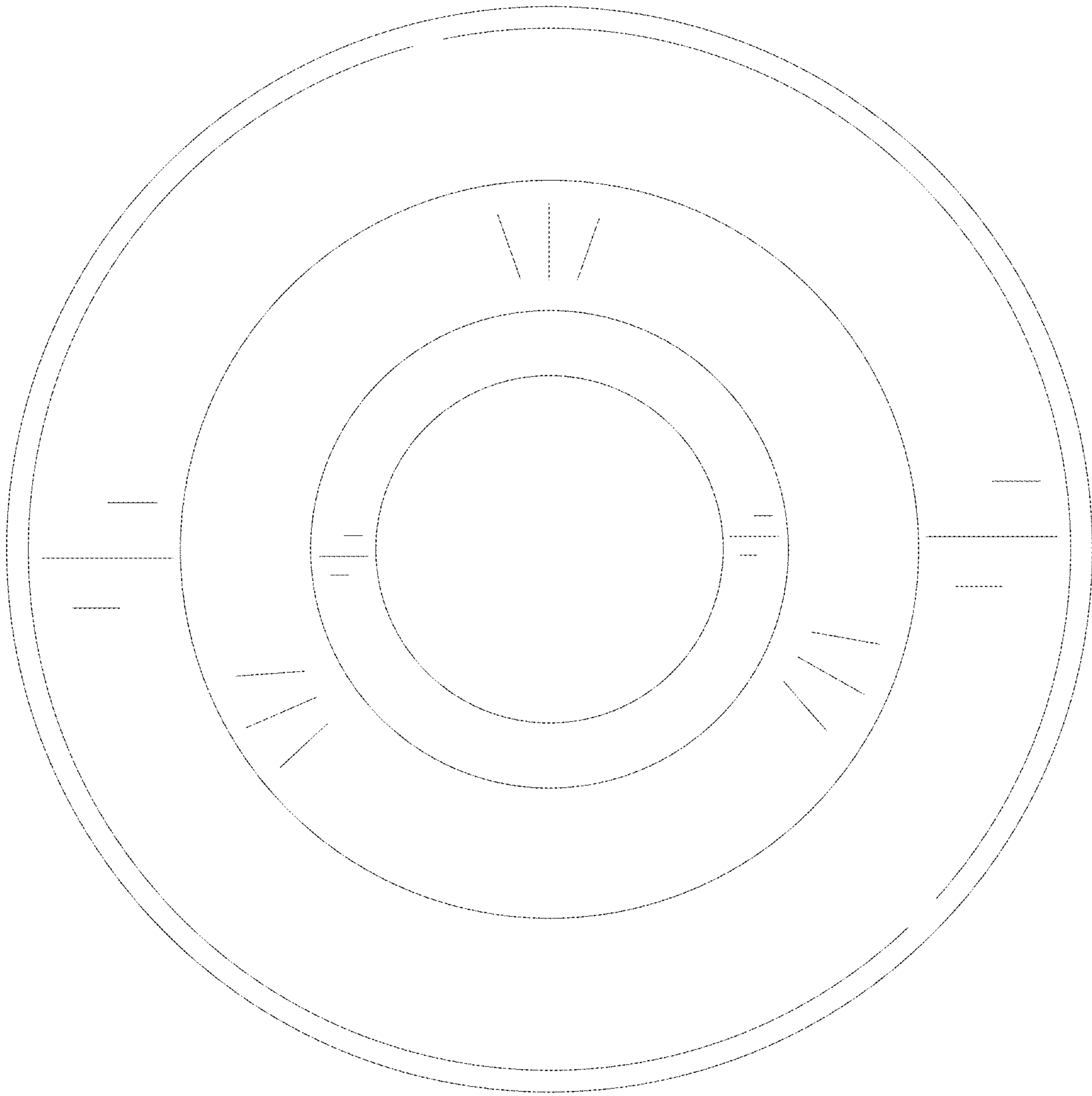

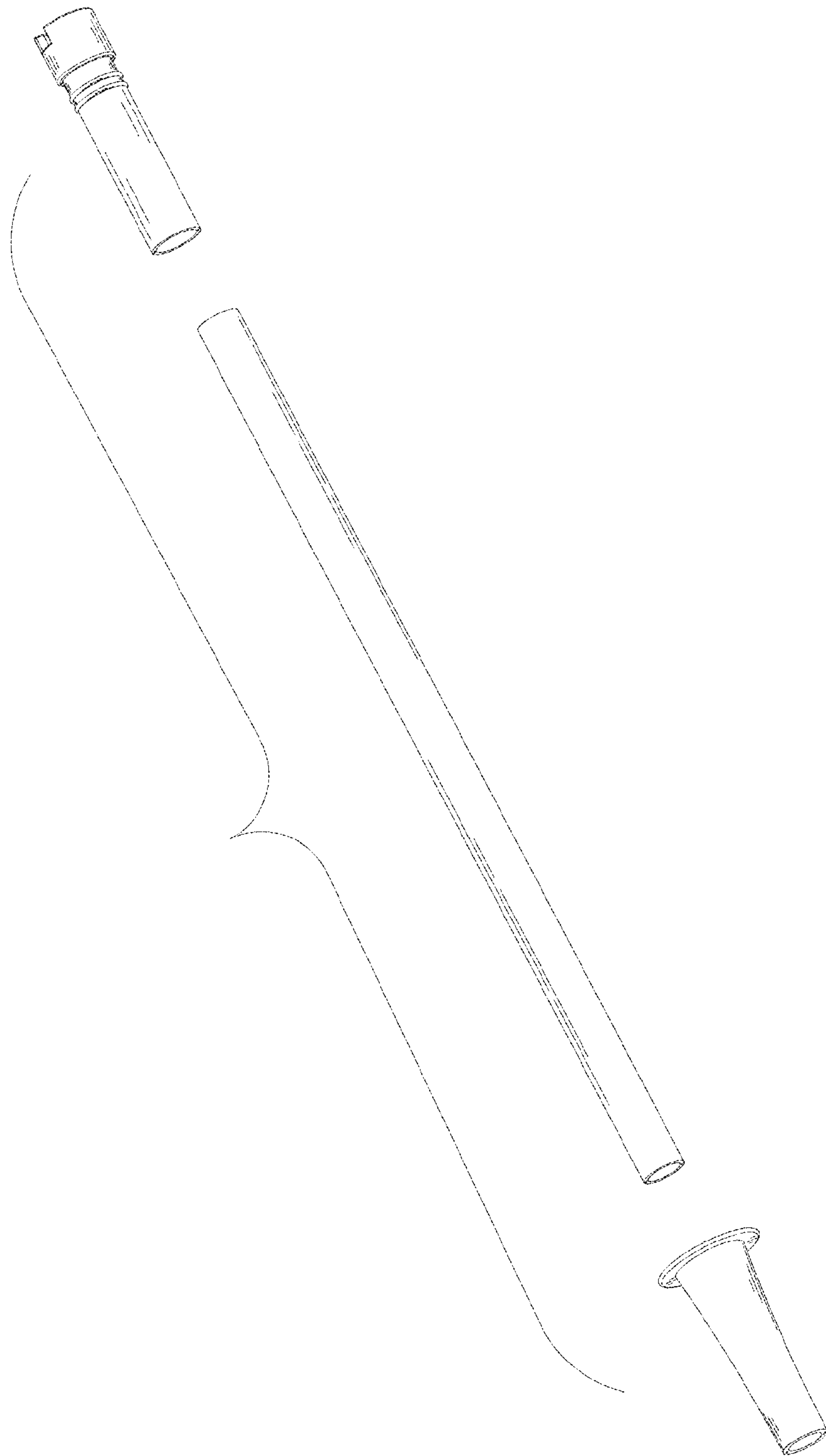
