DESCRIPTION

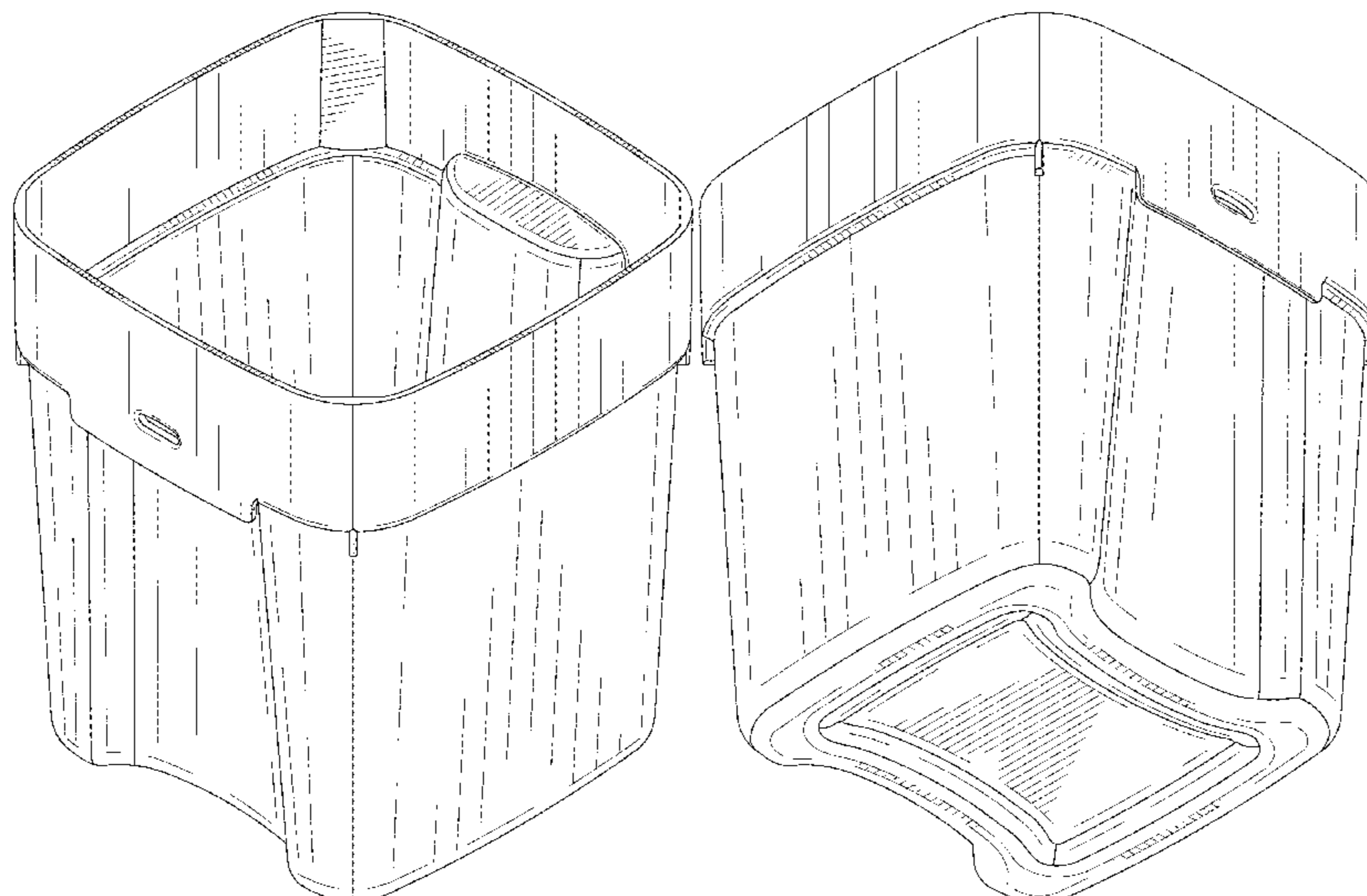
FIG. 1 is a top front perspective view of the deep food pan with handles;

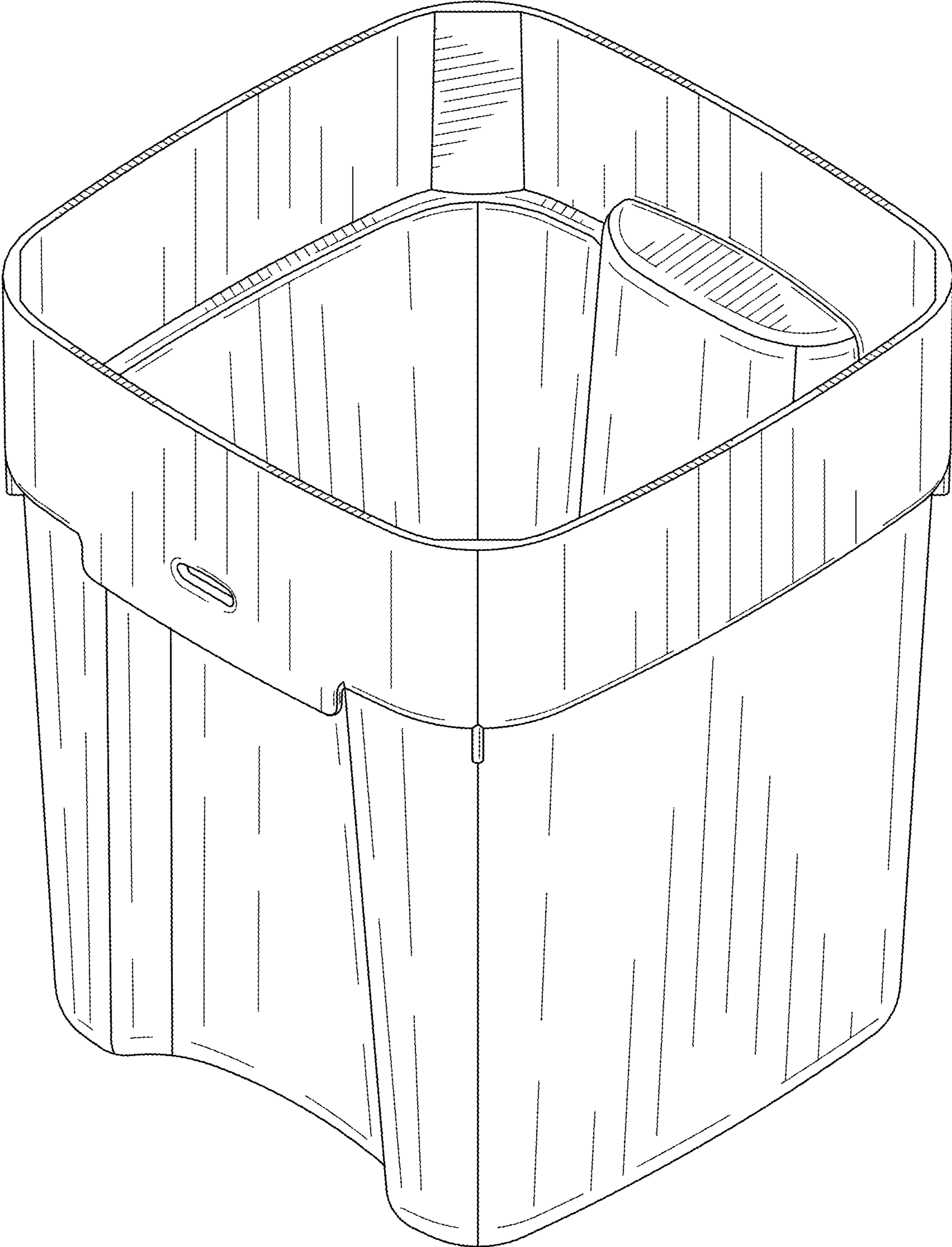

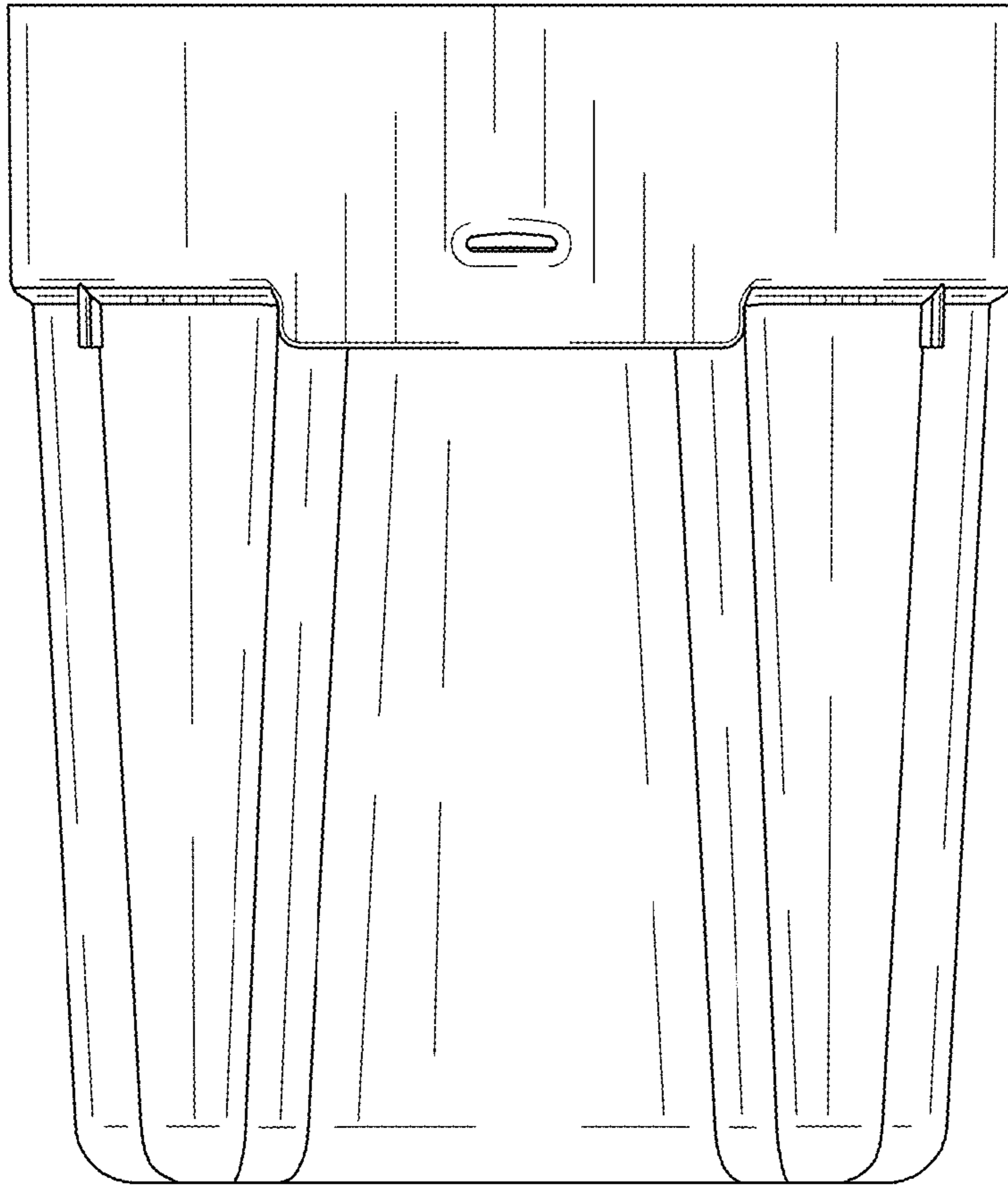

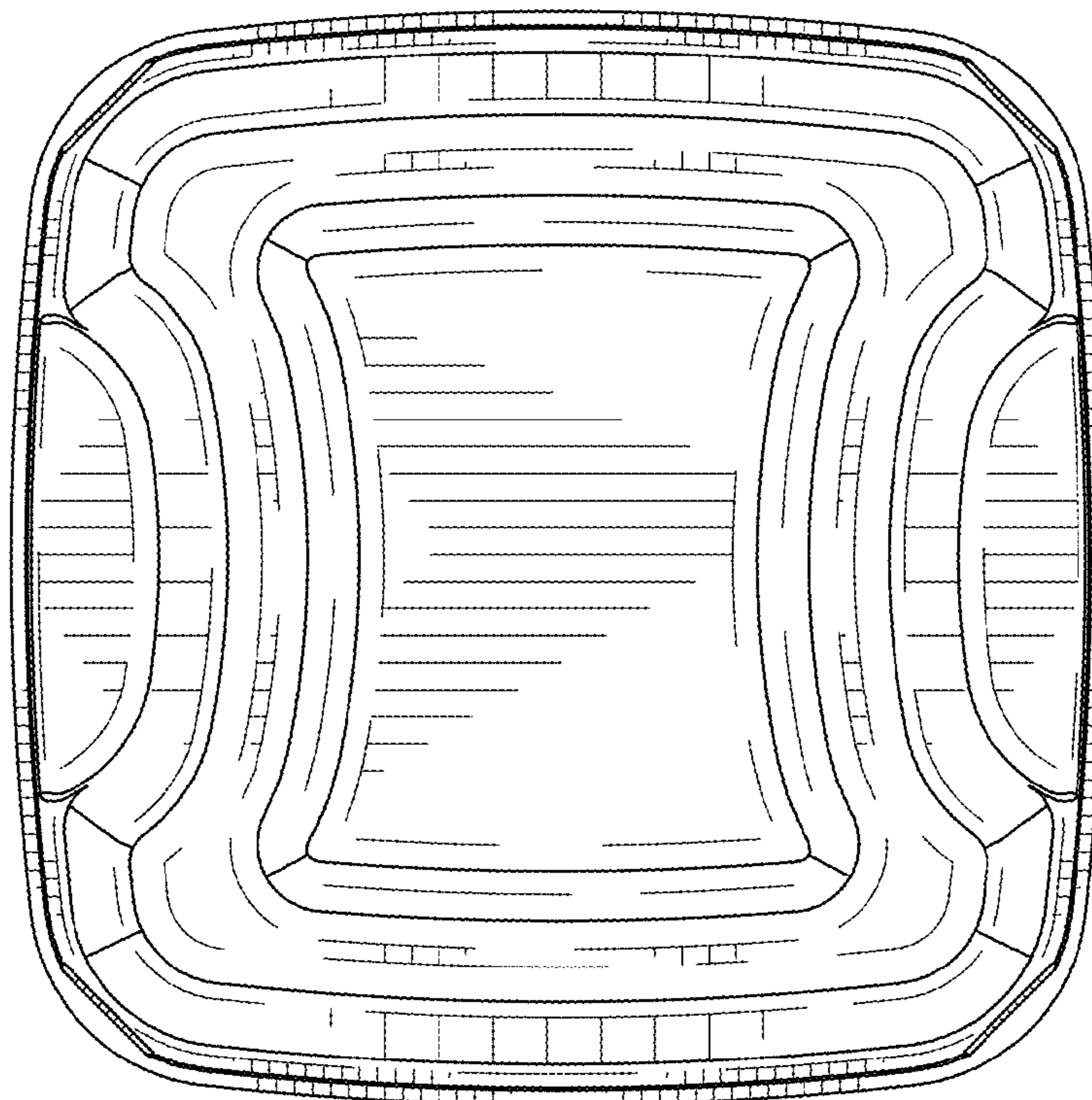

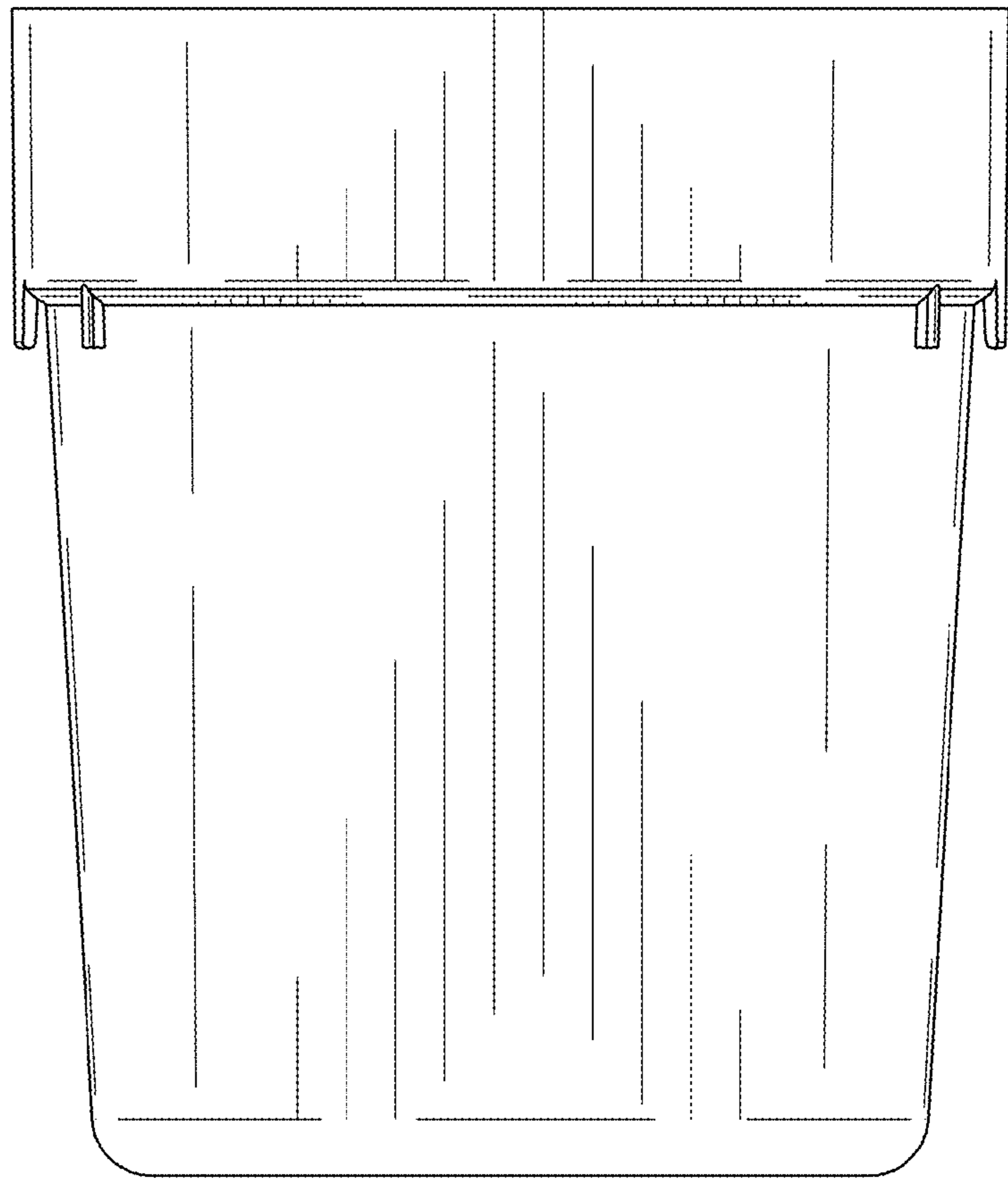

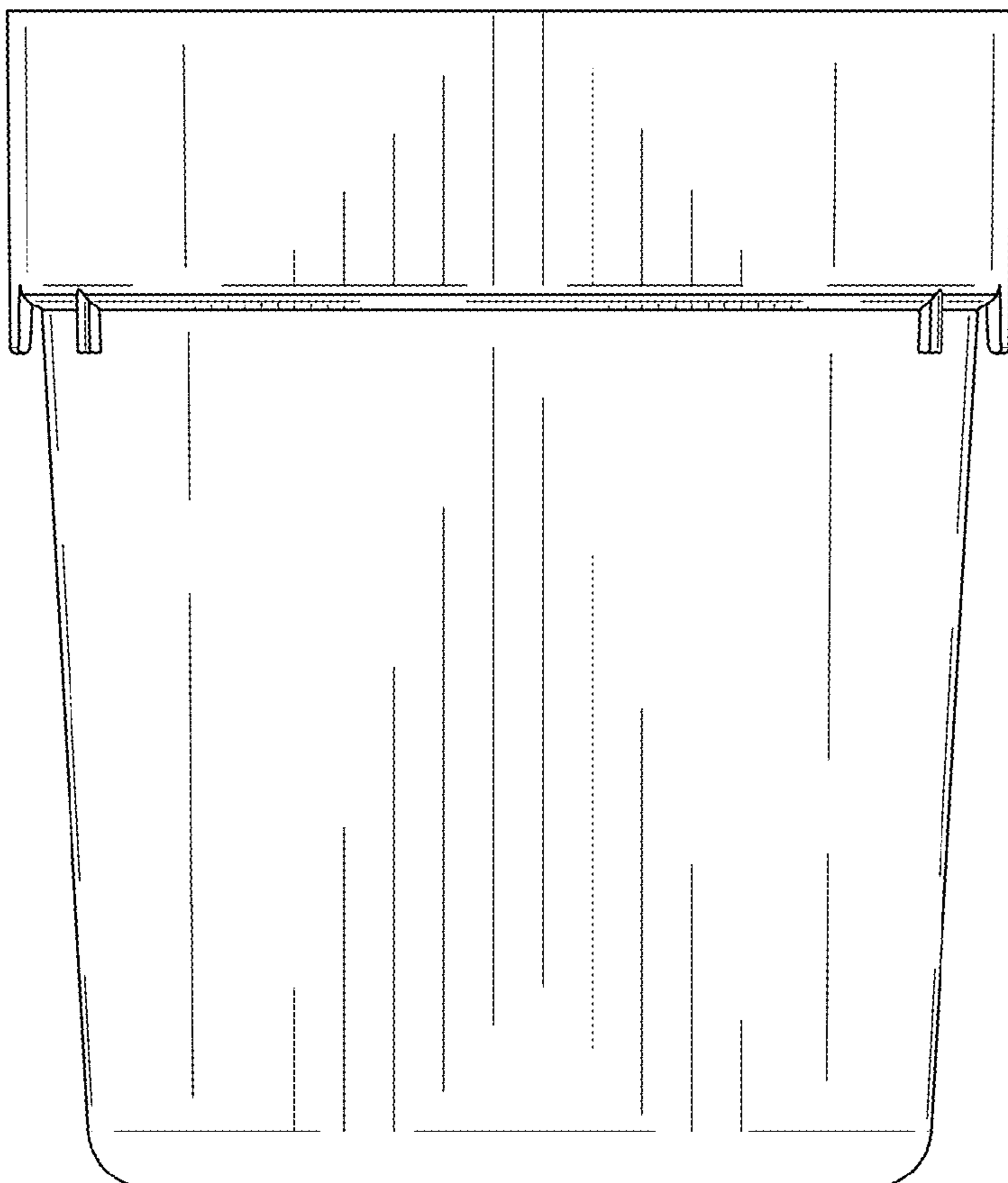

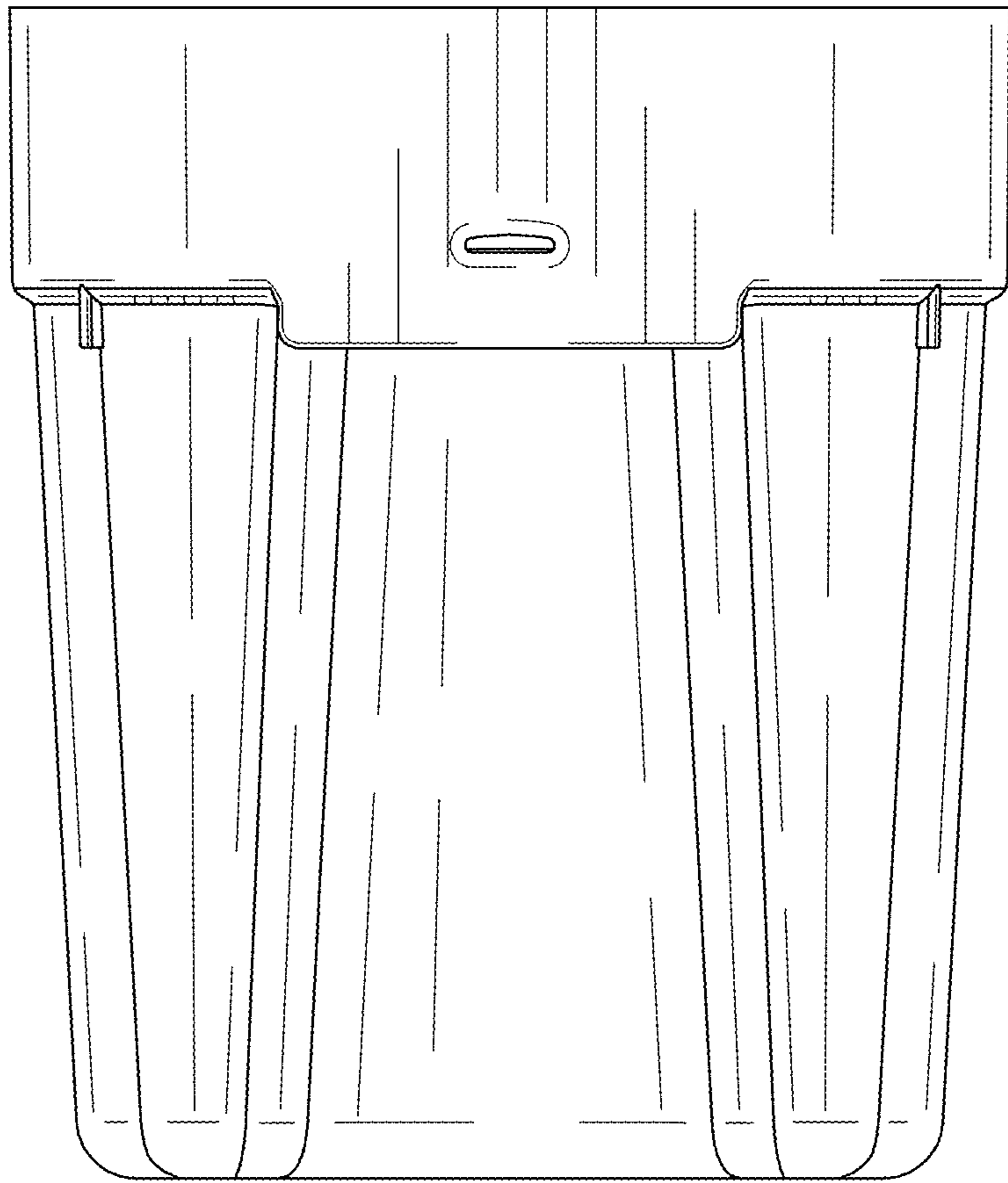
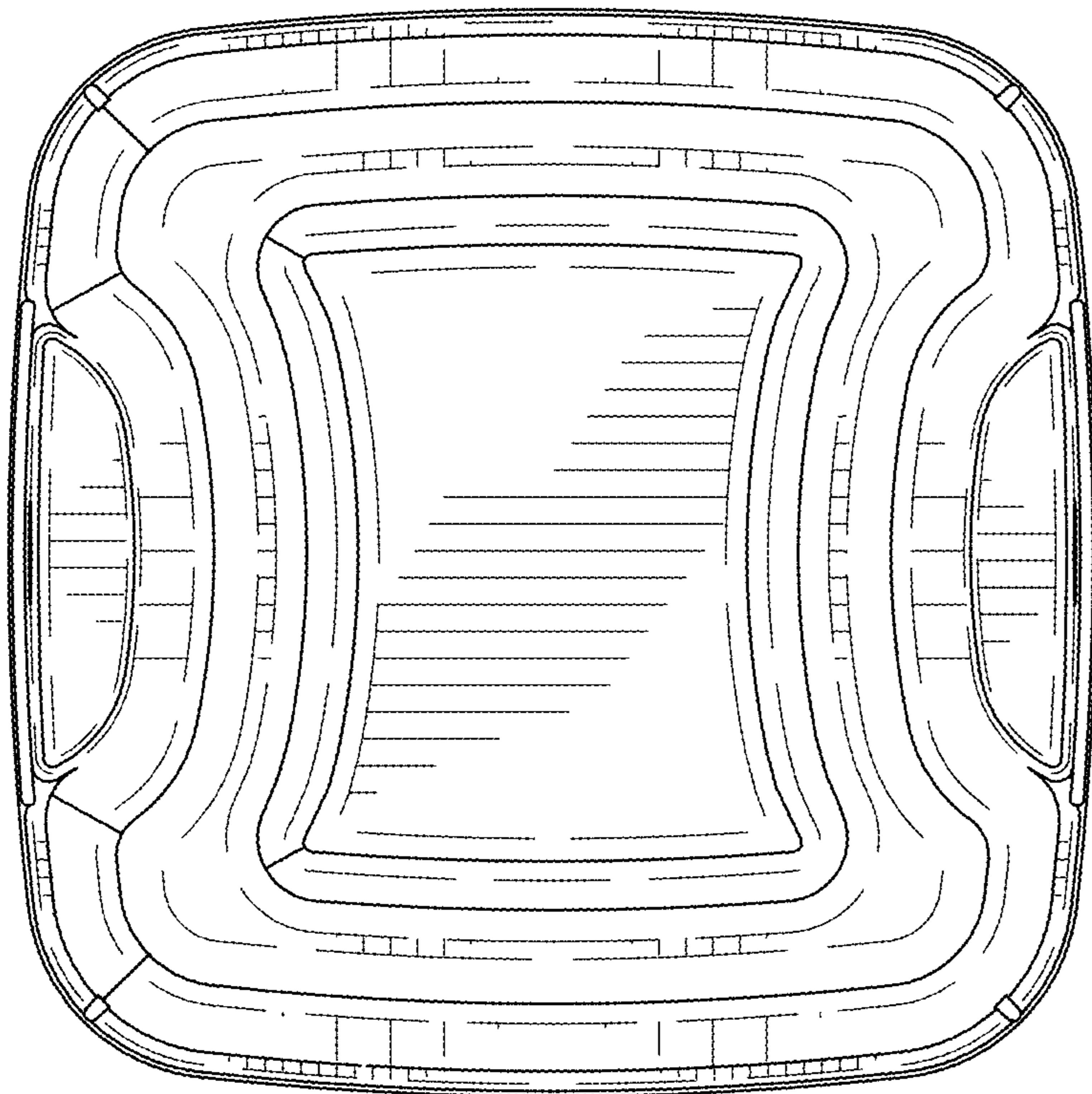

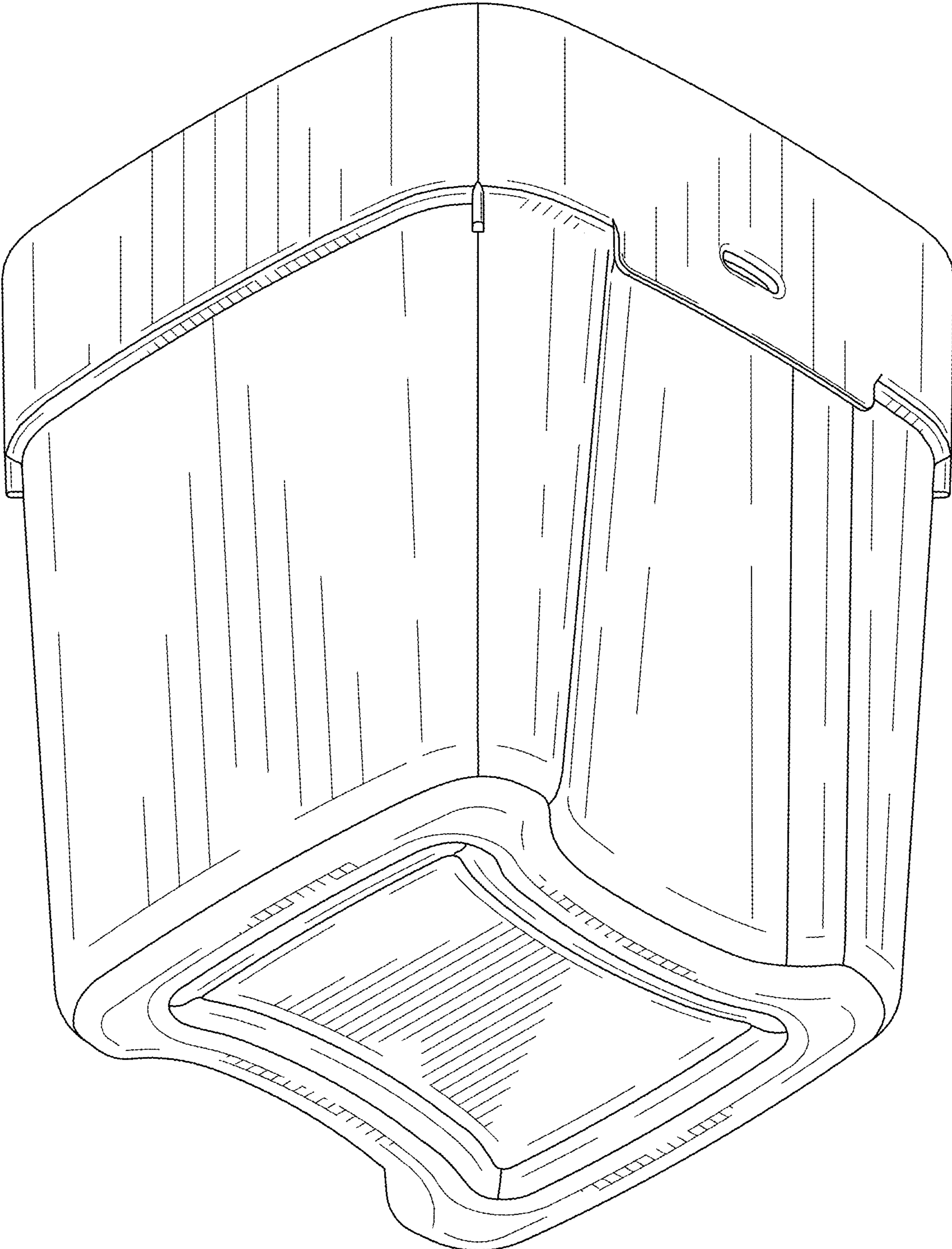
