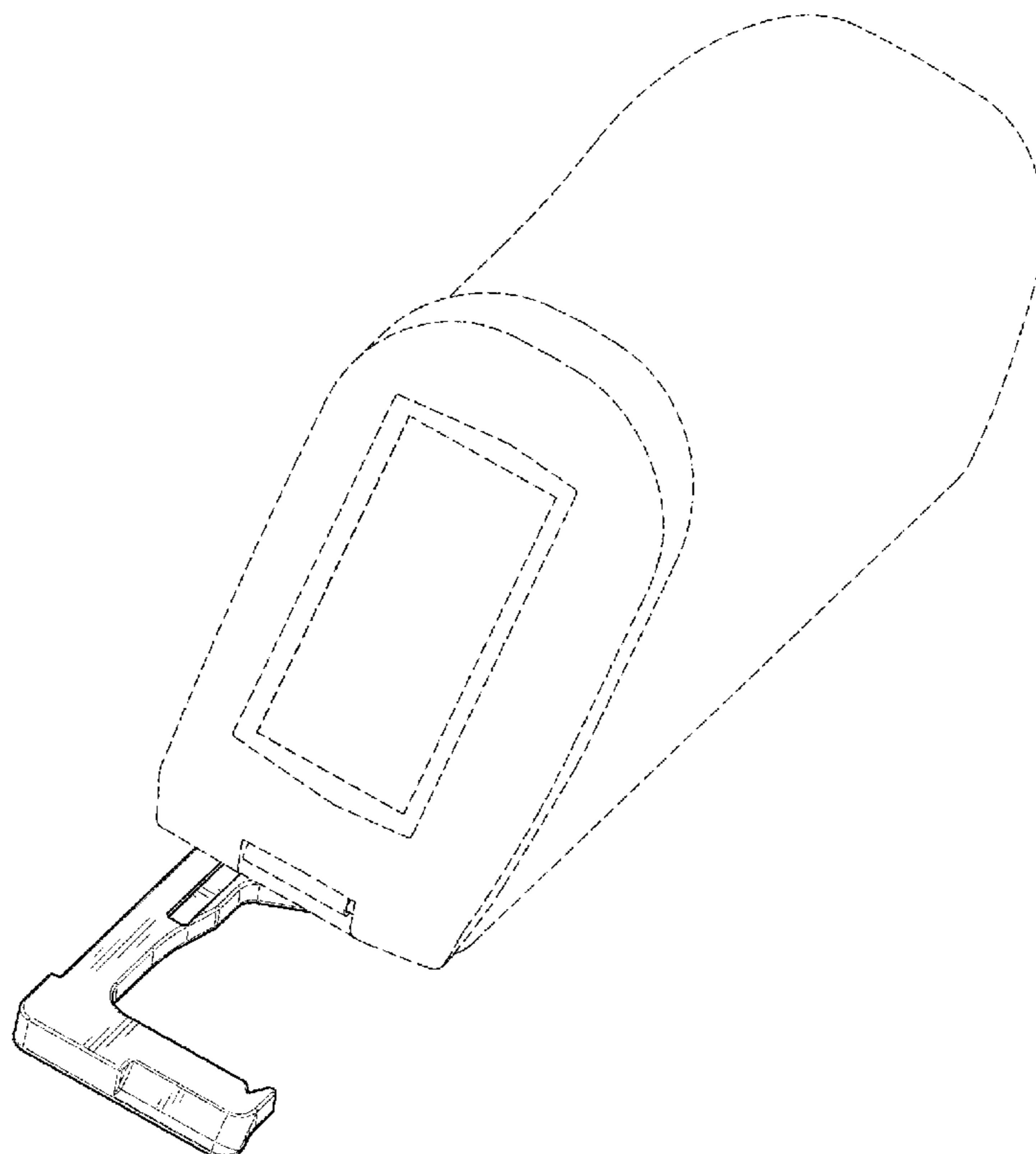
(57) **CLAIM**

The ornamental design for a tape measure hook, as shown and described.

**DESCRIPTION**

FIG. 1 is a front top right perspective view showing our new design for a tape measure hook, which is shown in an extended position.  
FIG. 2 is a top view thereof.  
FIG. 3 is a right side view thereof.  
FIG. 4 is a left side view thereof.  
FIG. 5 is a front view thereof.  
FIG. 6 is a bottom view thereof.  
FIG. 7 is a cross-sectional view taken along line 7-7 in FIG. 6.  
FIG. 8 is a cross-sectional view taken along line 8-8 in FIG. 6.  
FIG. 9 is a front top right perspective view of the tape measure hook shown in a retracted position.  
FIG. 10 is a right side view of the tape measure hook shown in the retracted position.  
FIG. 11 is a left side view of the tape measure hook shown in the retracted position; and,  
FIG. 12 is a bottom view of the tape measure hook shown in a retracted position.  
The broken lines in the drawings depict the environment of the tape measure hook that forms no part of the claimed design.

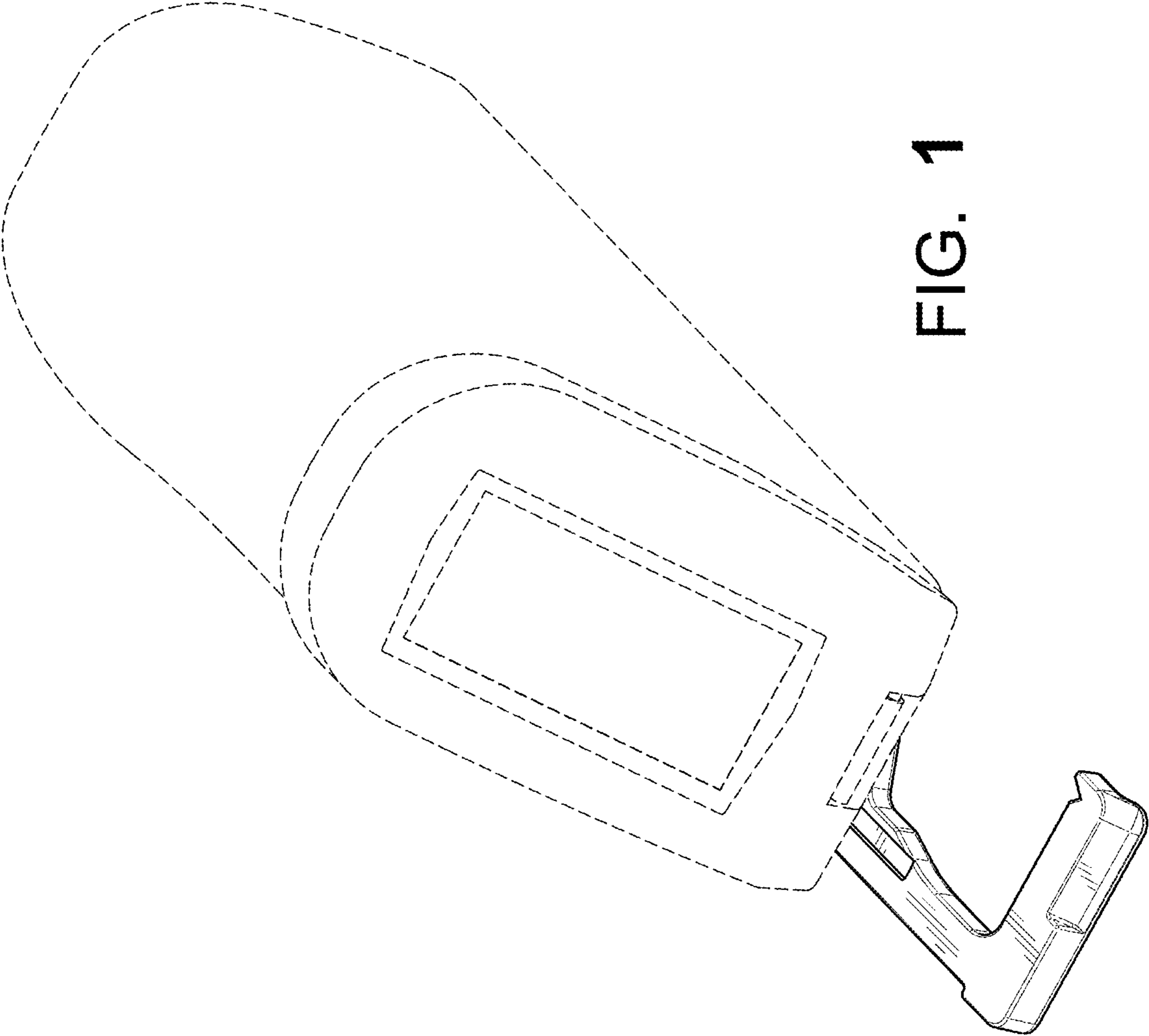

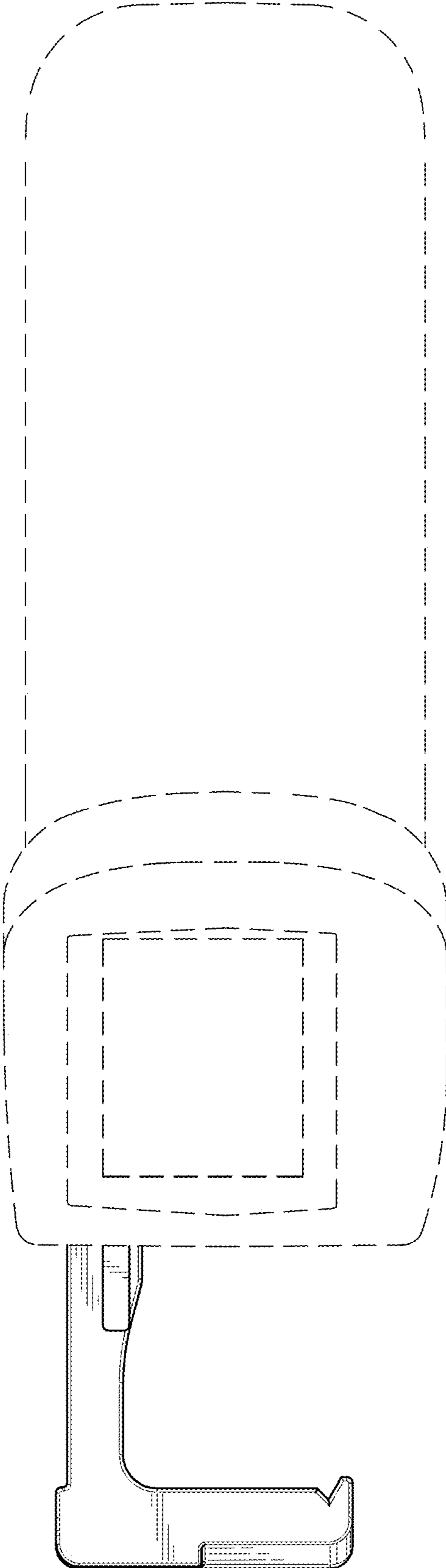

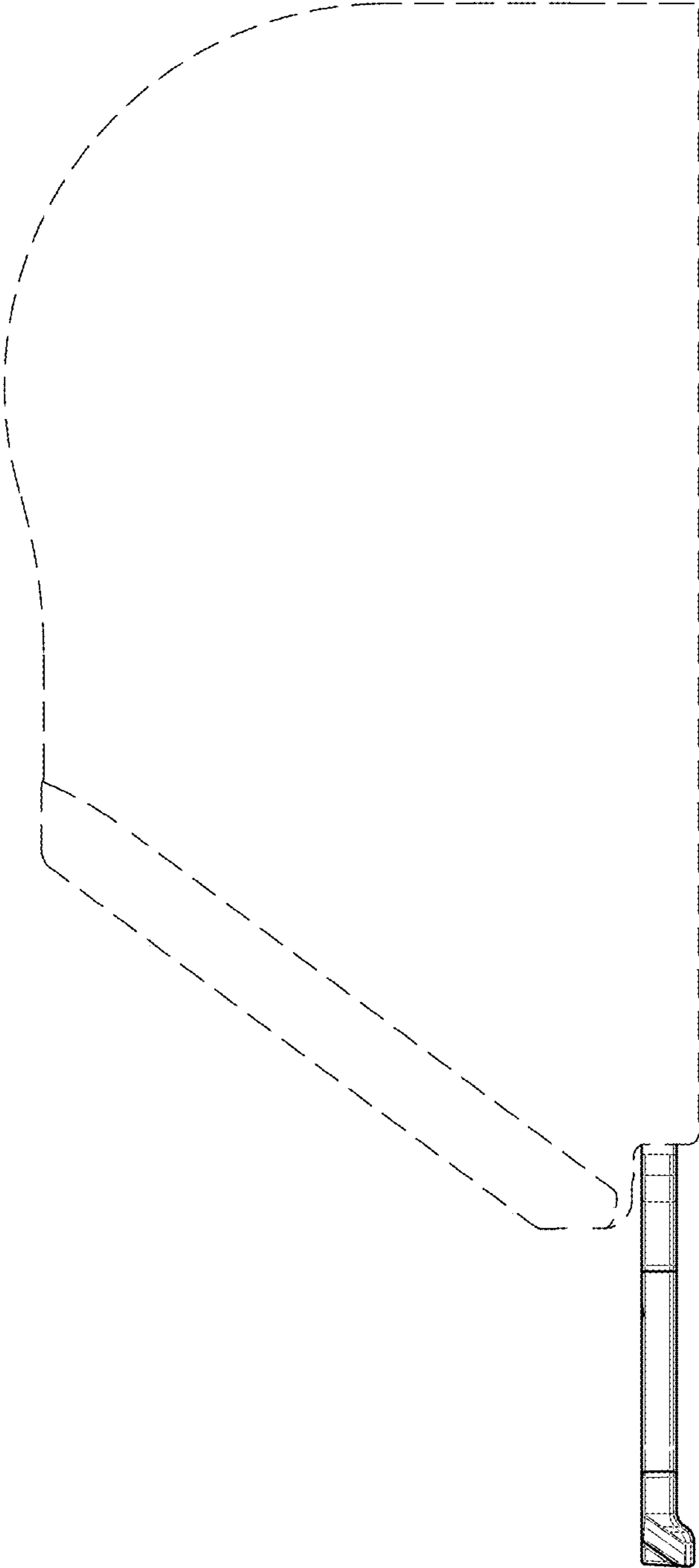

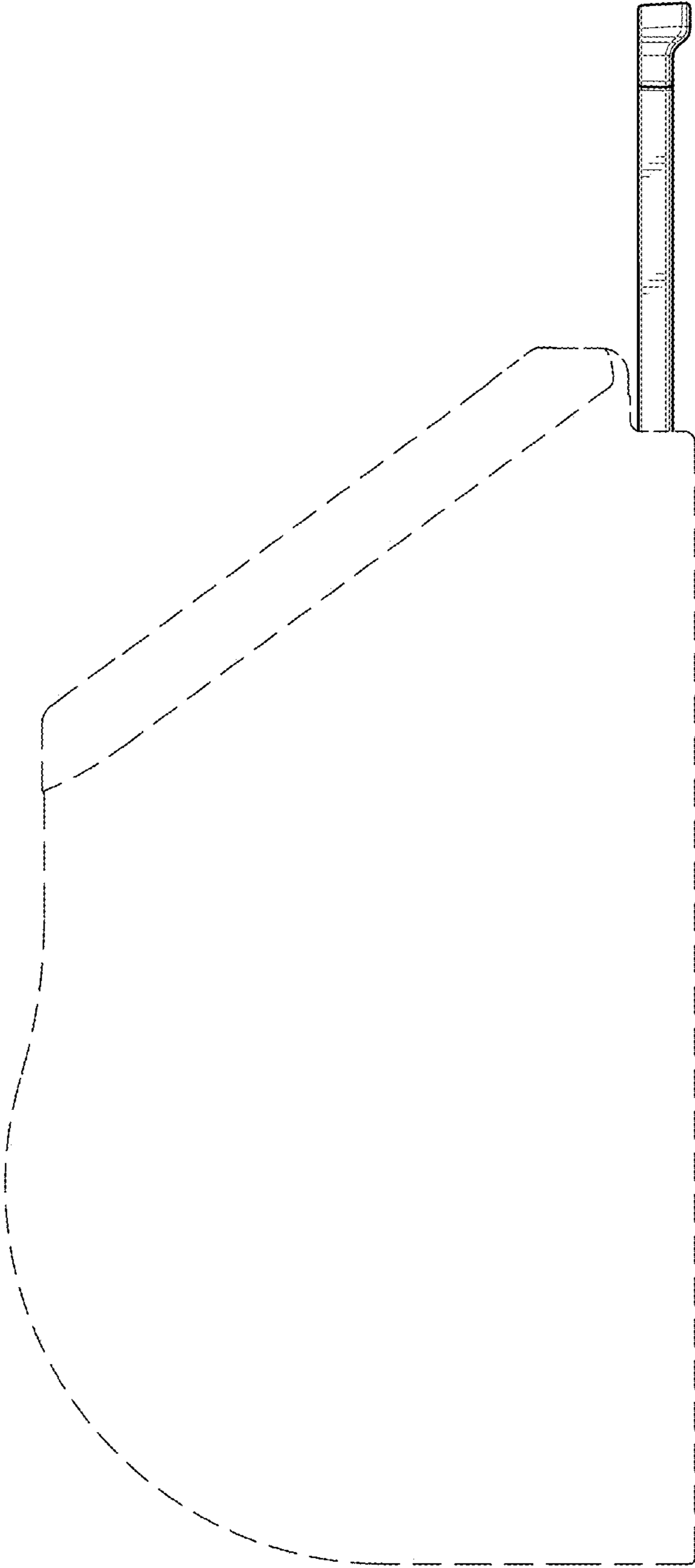

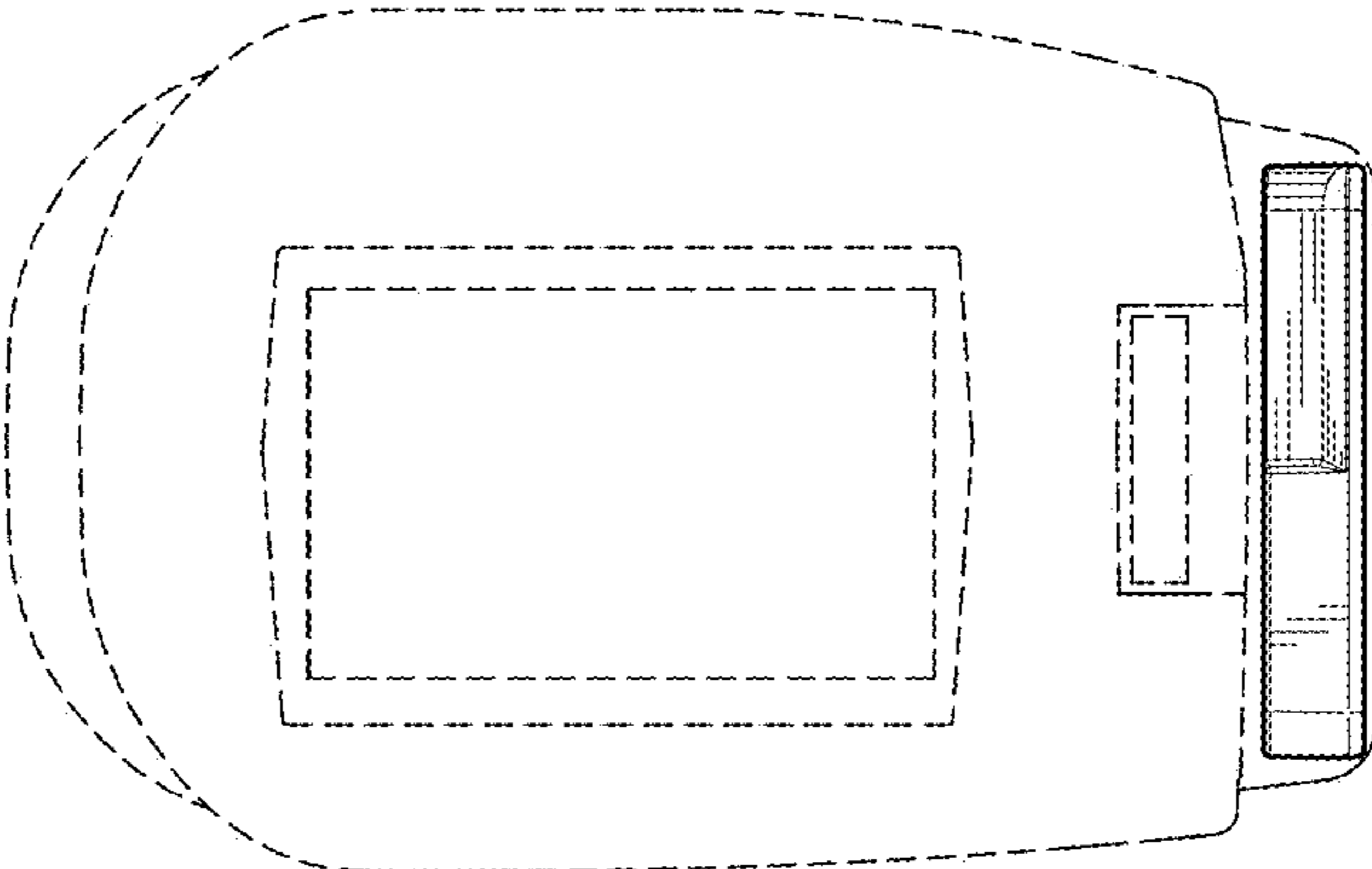

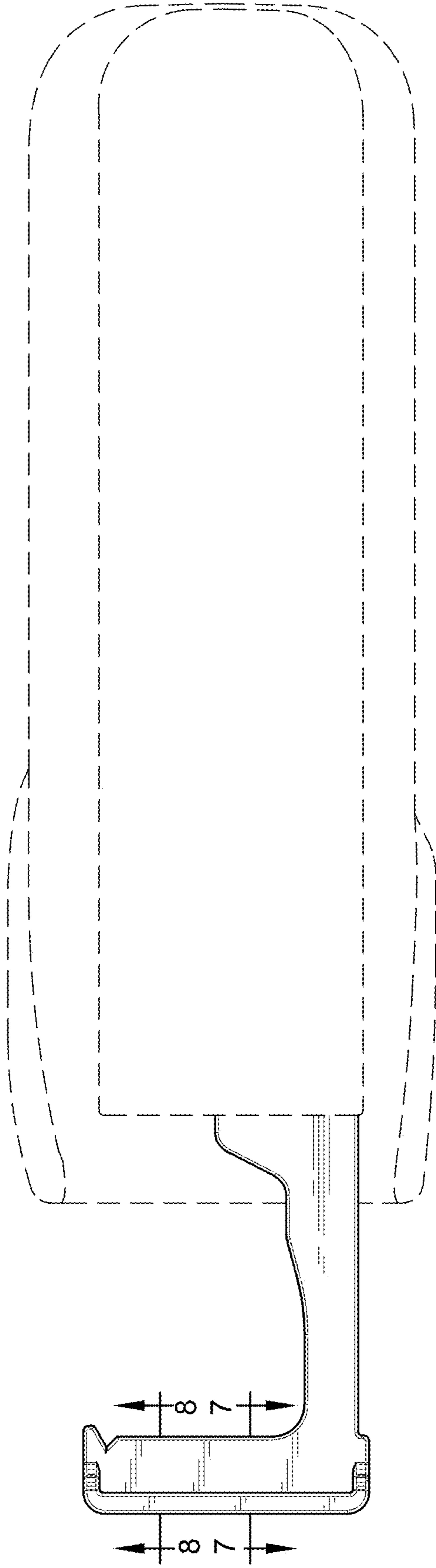

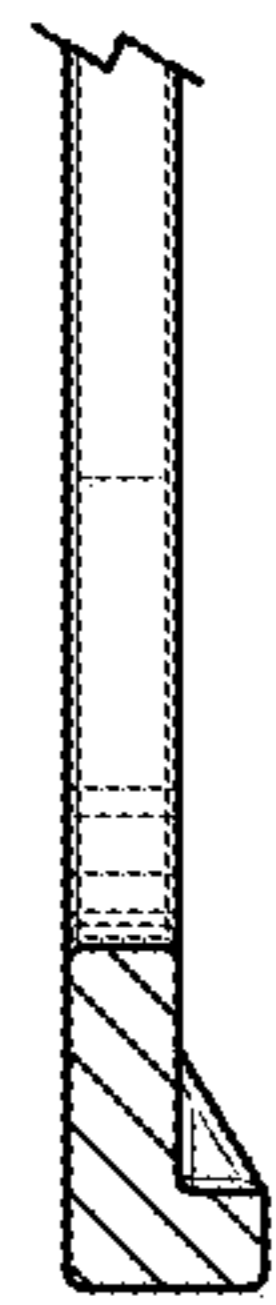

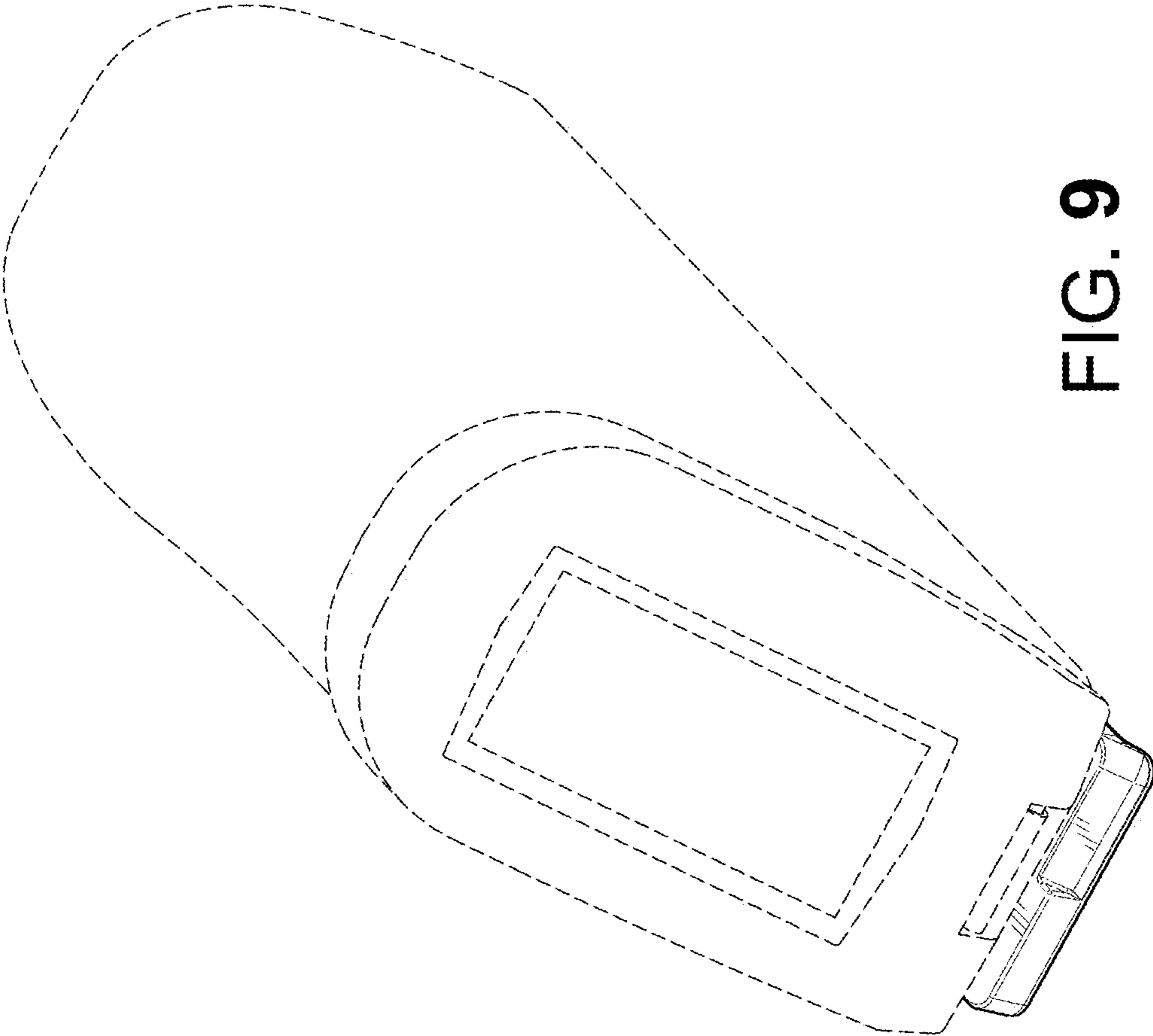

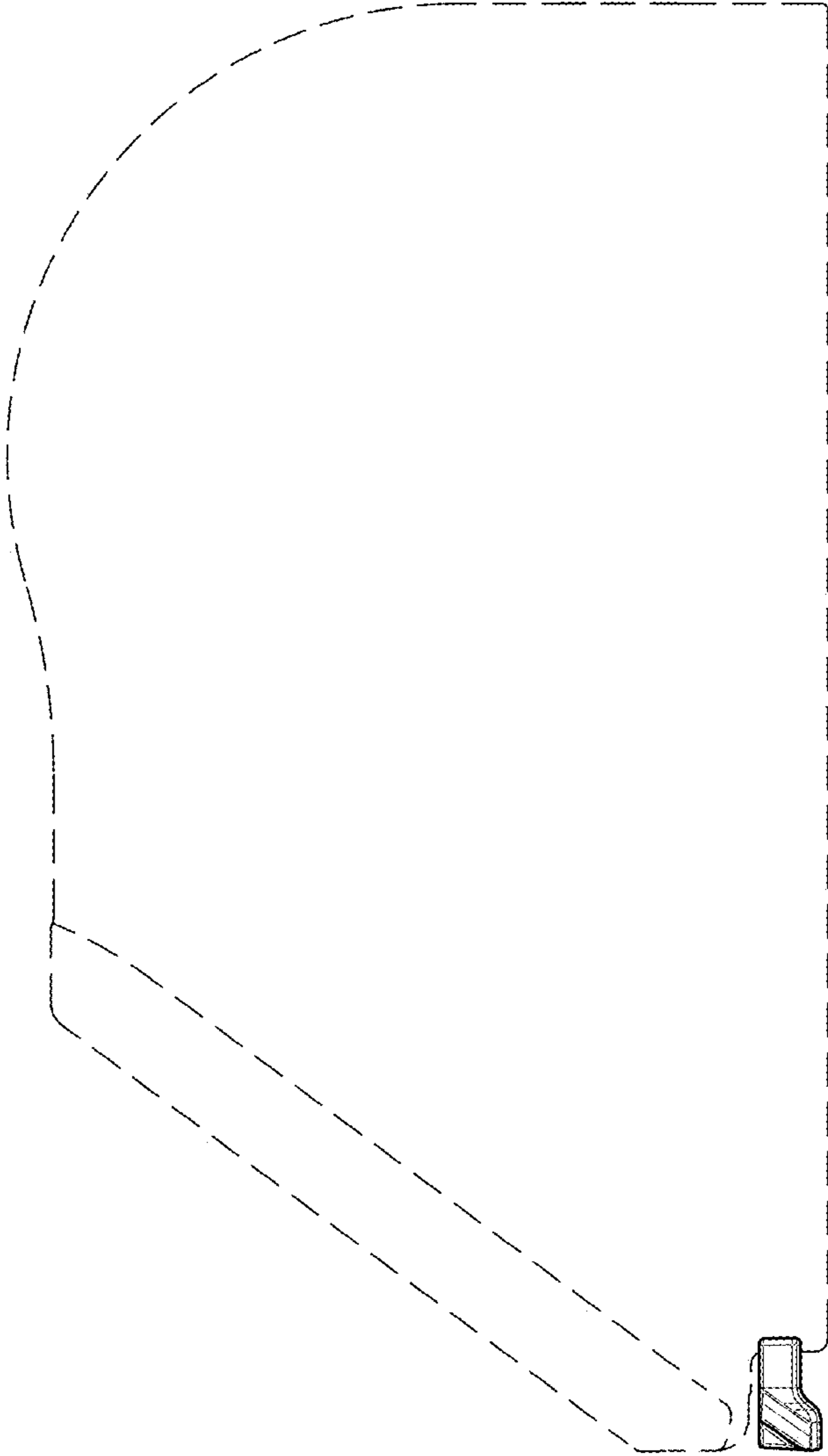

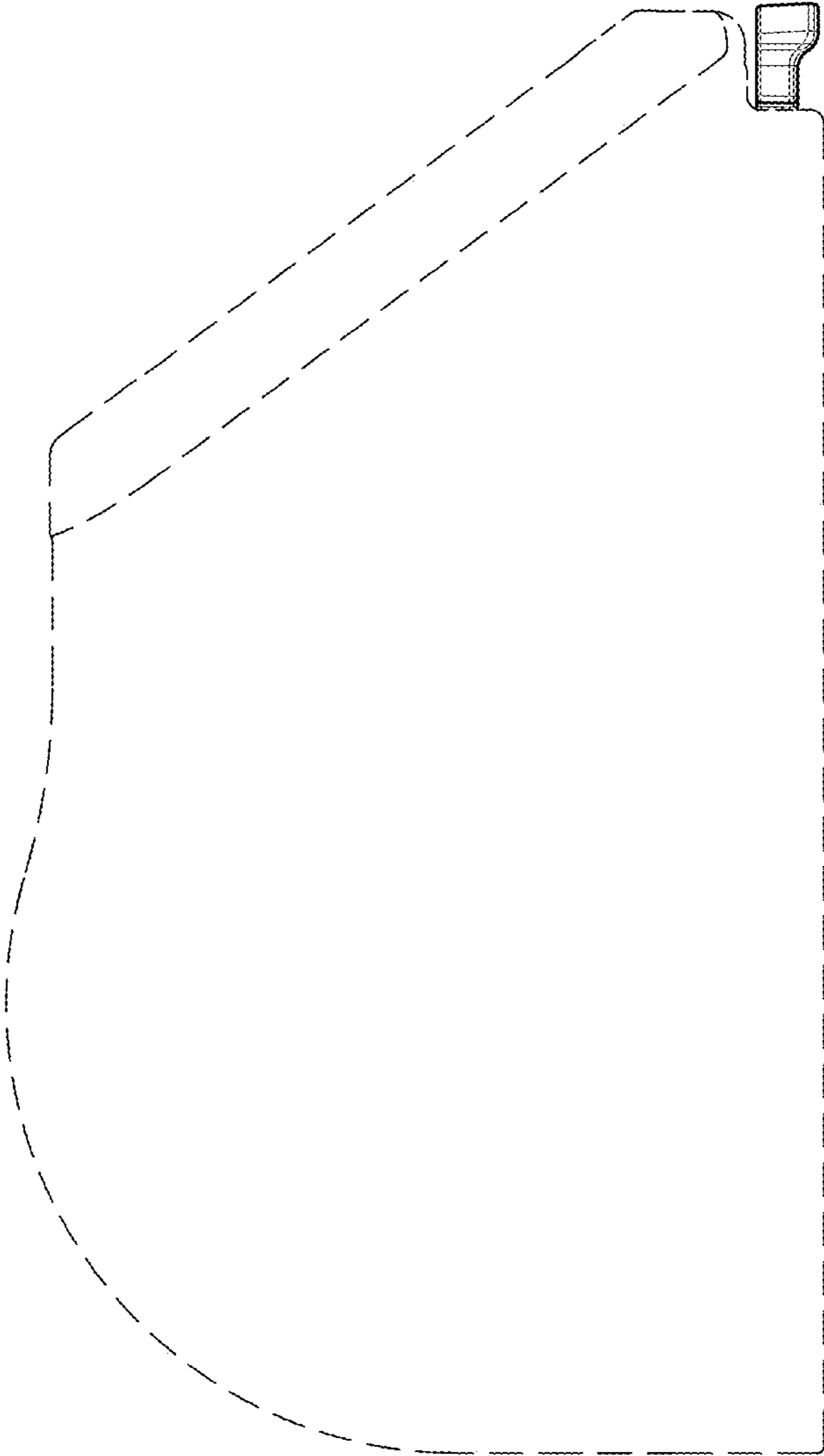

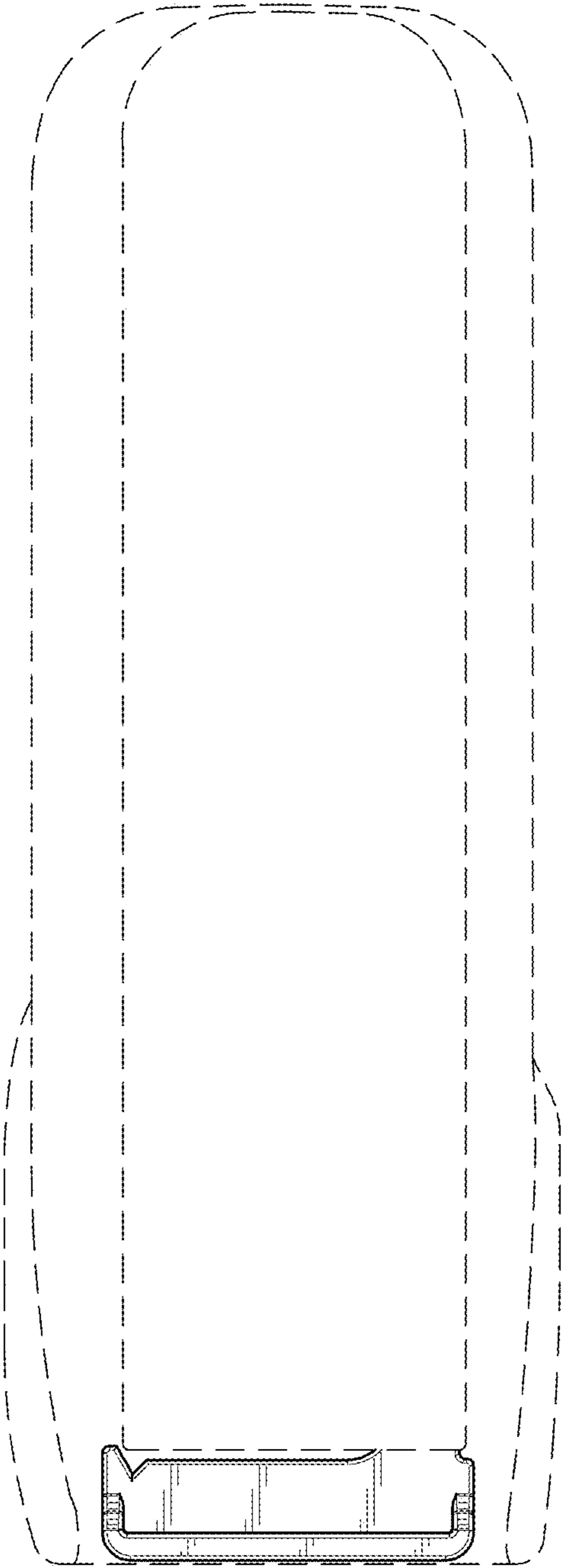
