DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of a coil component, showing the new design, the rear elevational view (not provided) being a mirror image thereof; FIG. 2 is a left-side elevational view thereof; FIG. 3 is a right-side elevational view thereof; FIG. 4 is a top plan view thereof; and FIG. 5 is a bottom plan view thereof. FIG. 6 is a front elevational view of a second embodiment of a coil component, showing the new design, the rear elevational view (not provided) being a mirror image thereof; FIG. 7 is a left-side elevational view thereof; FIG. 8 is a right-side elevational view thereof; FIG. 9 is a top plan view thereof; and, FIG. 10 is a bottom plan view thereof.

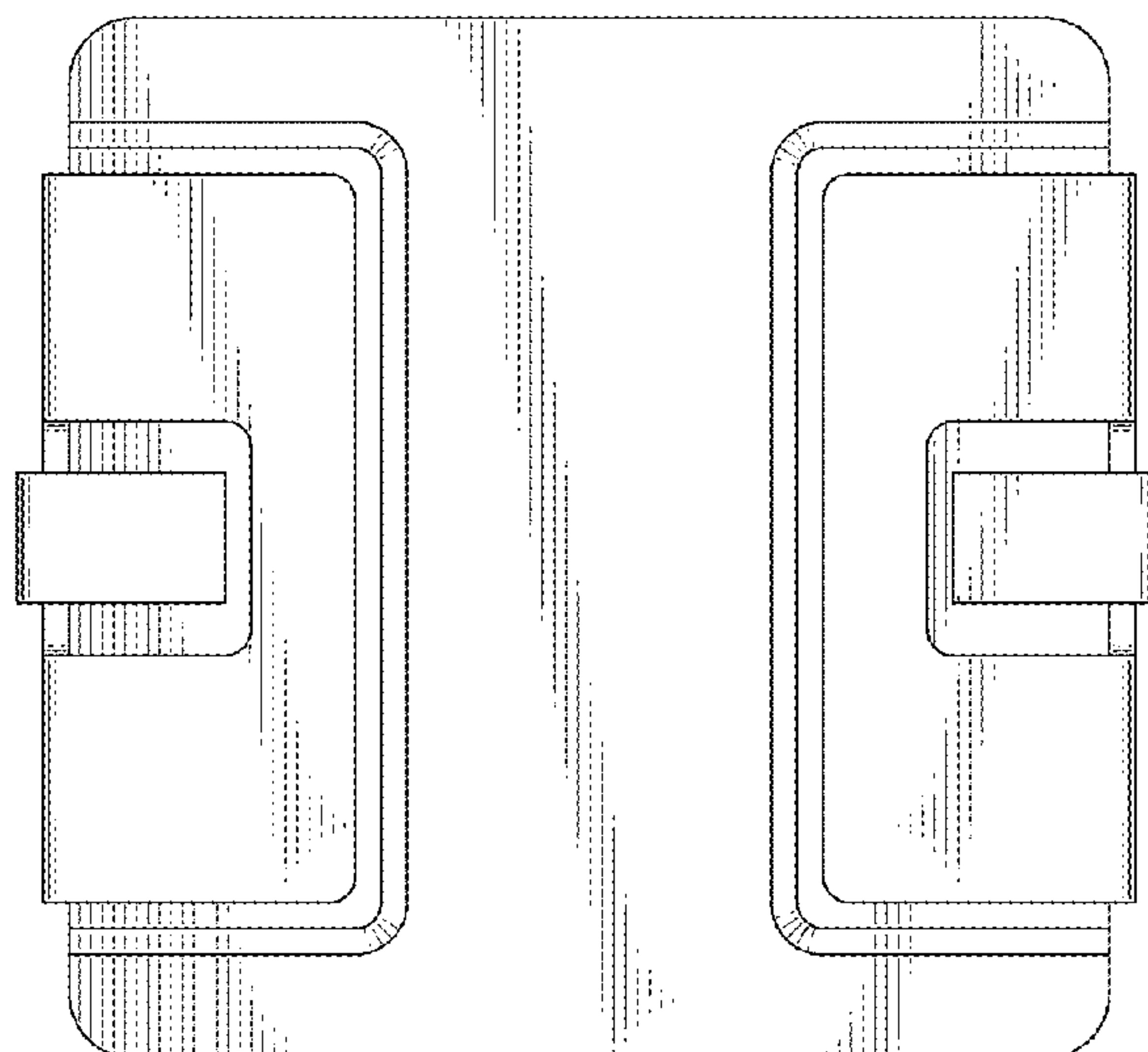

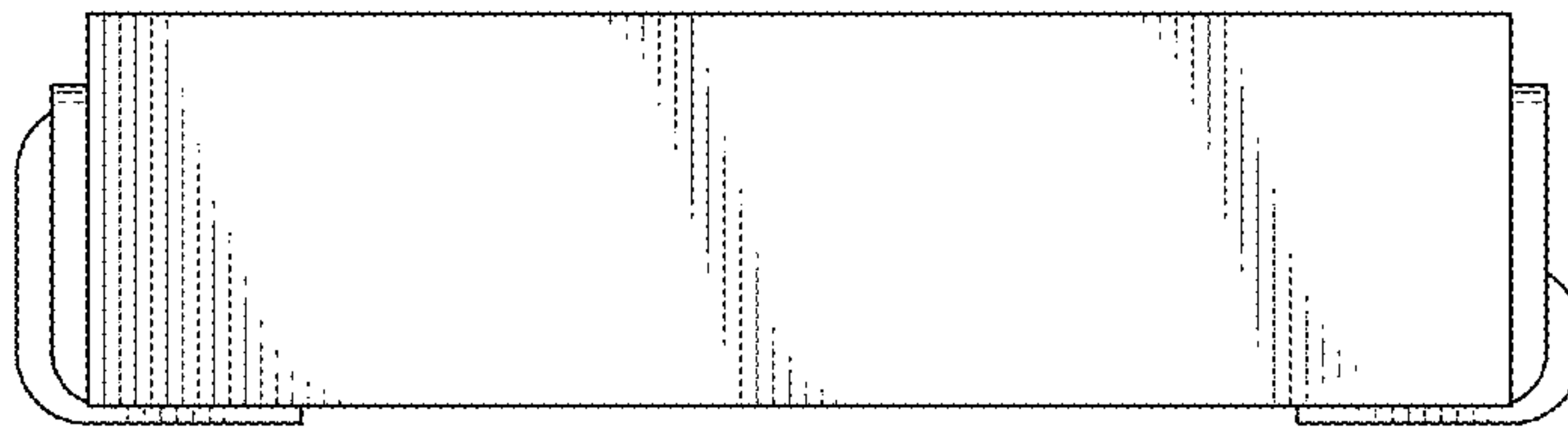

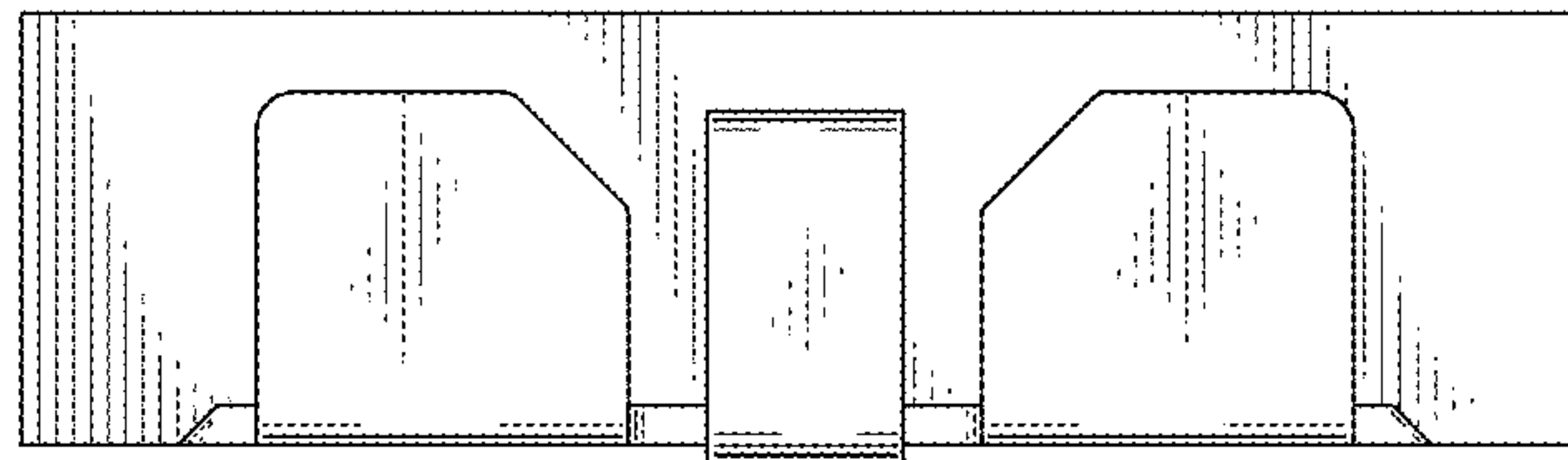

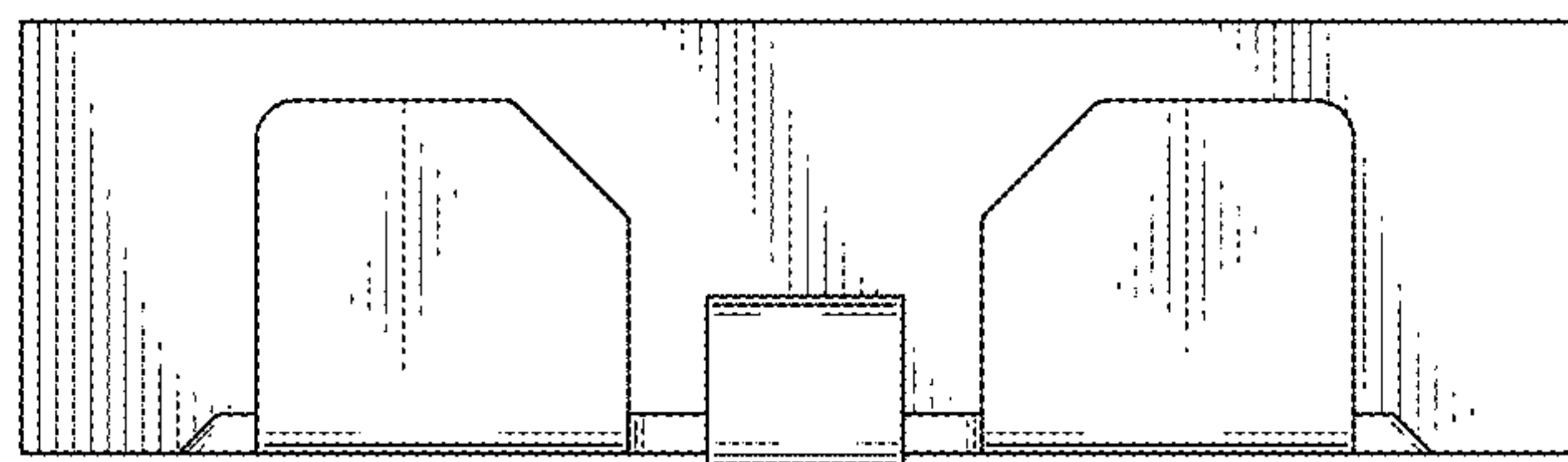

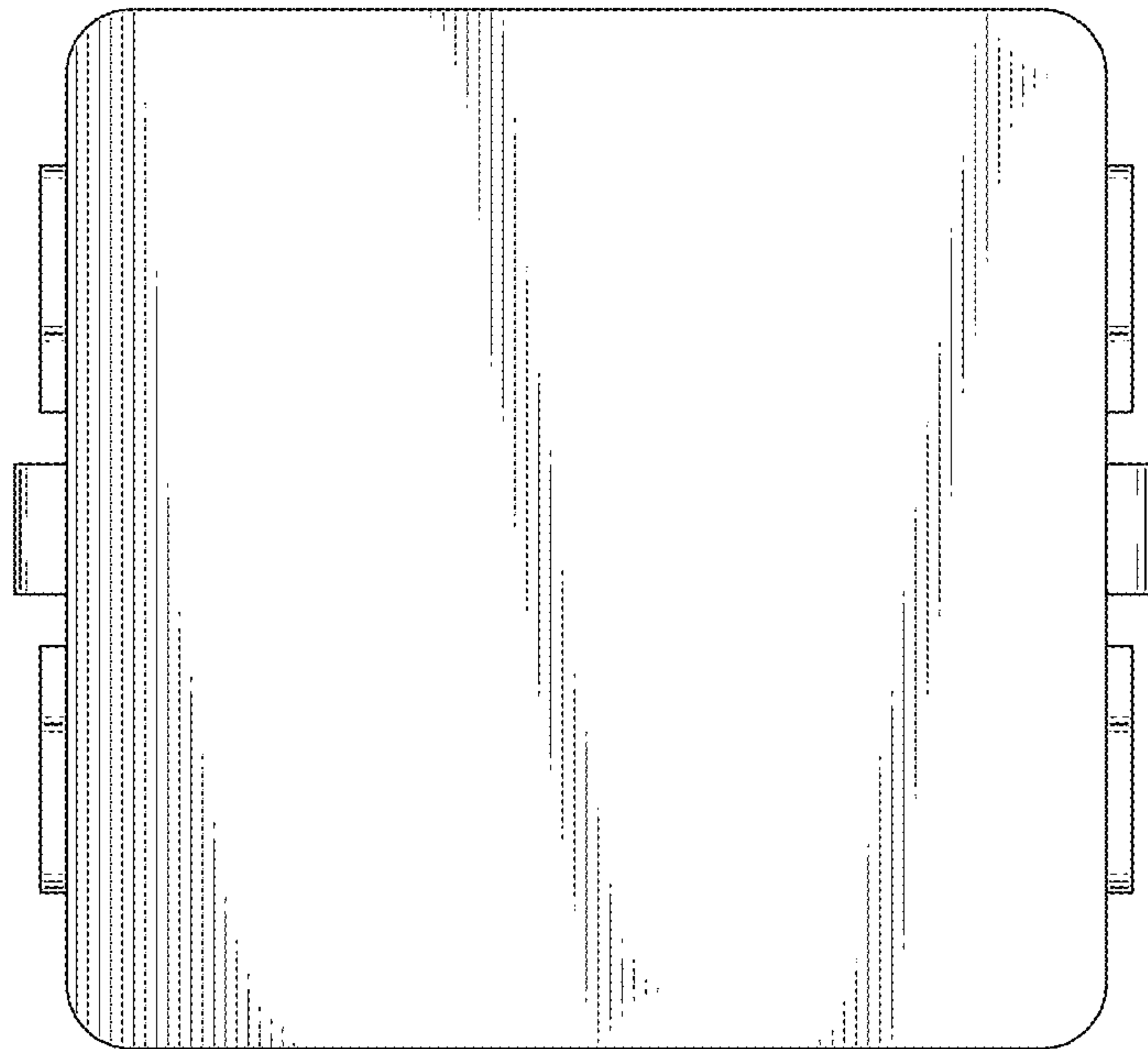

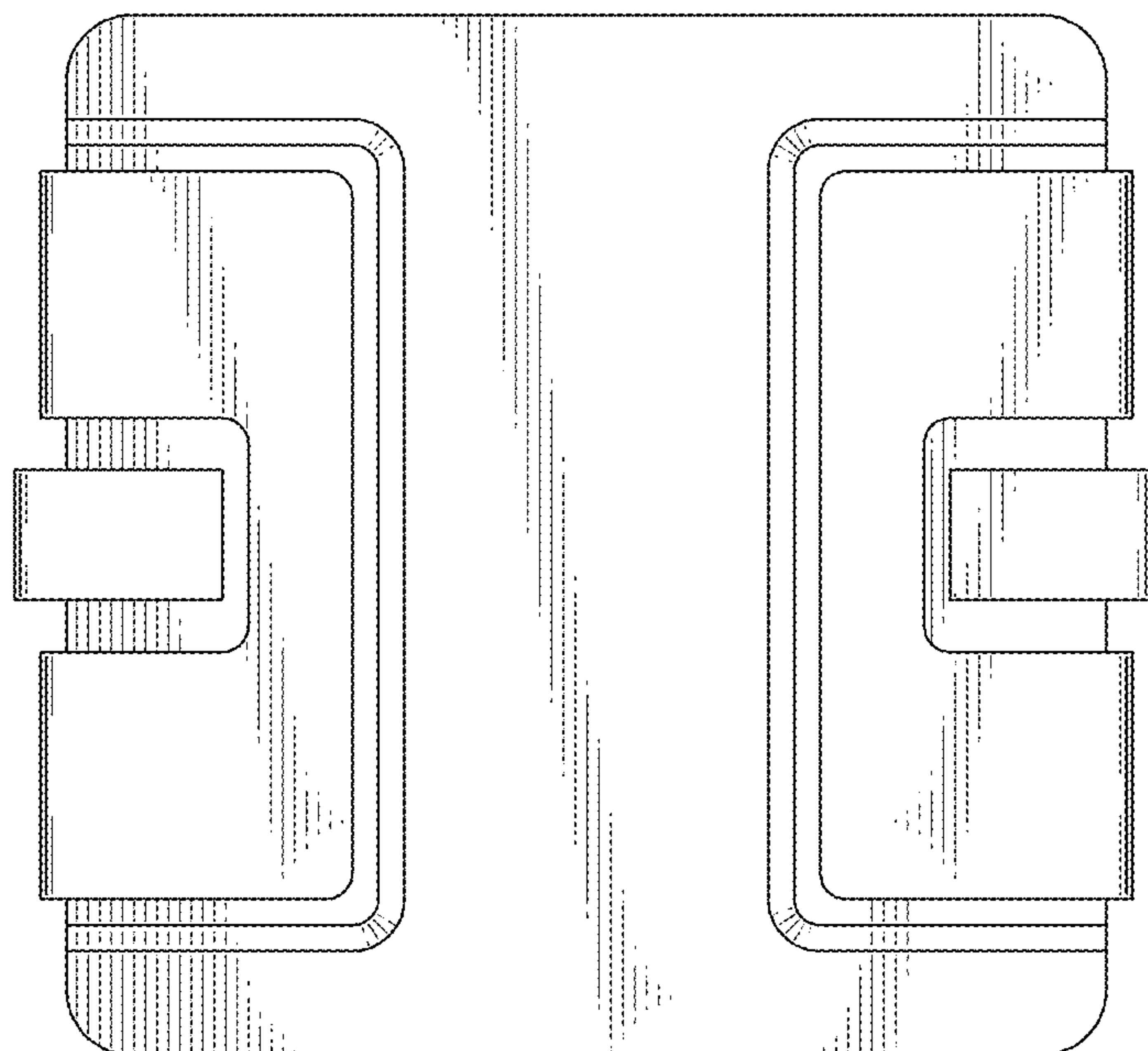

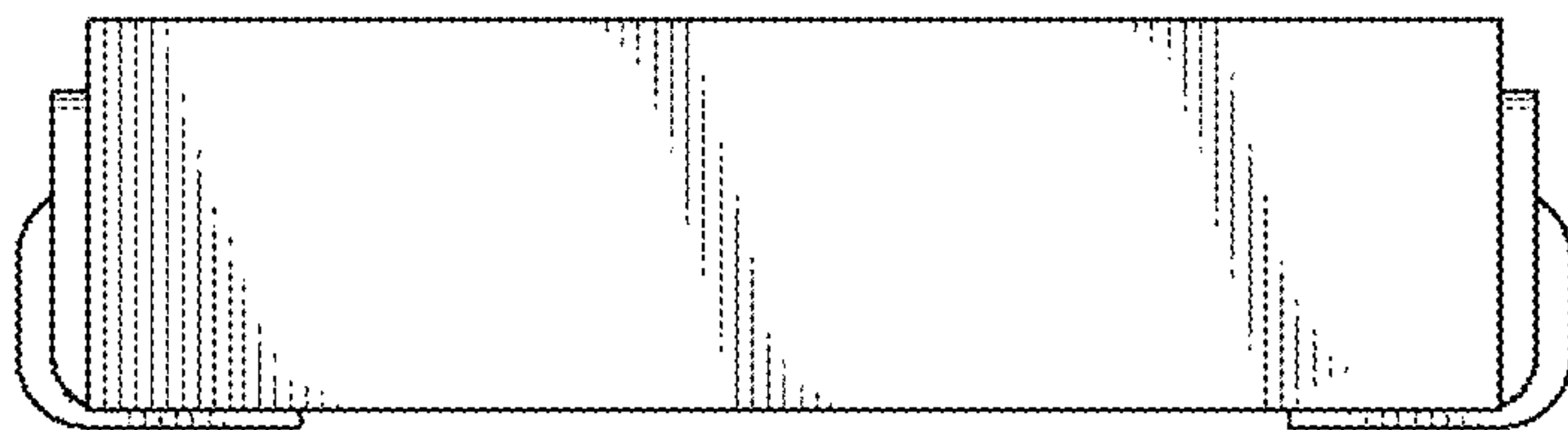

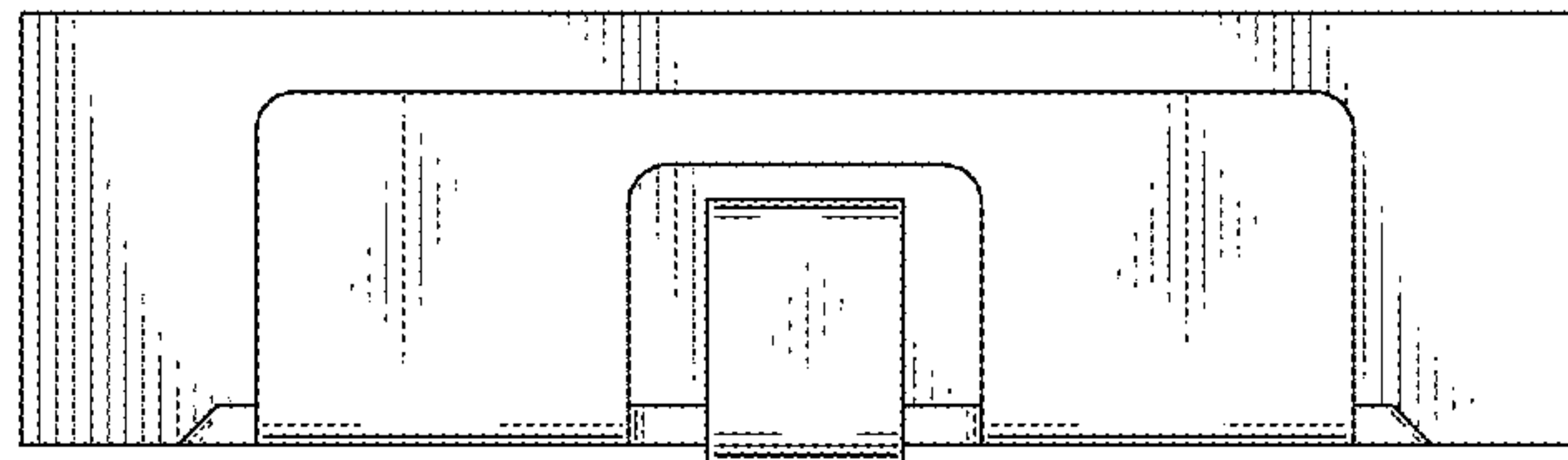

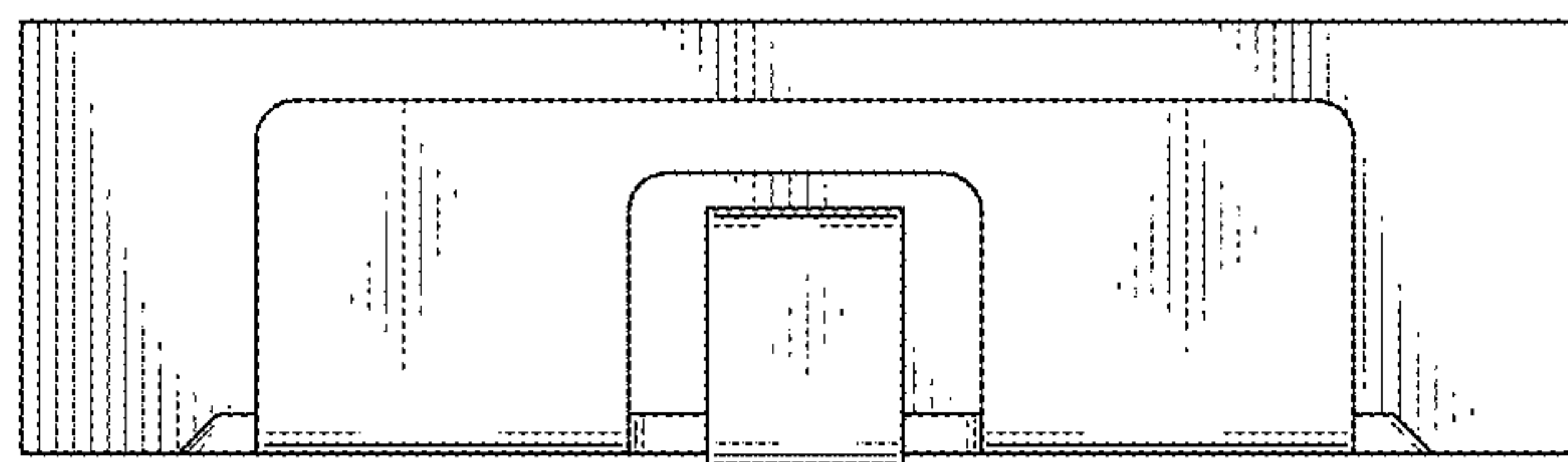

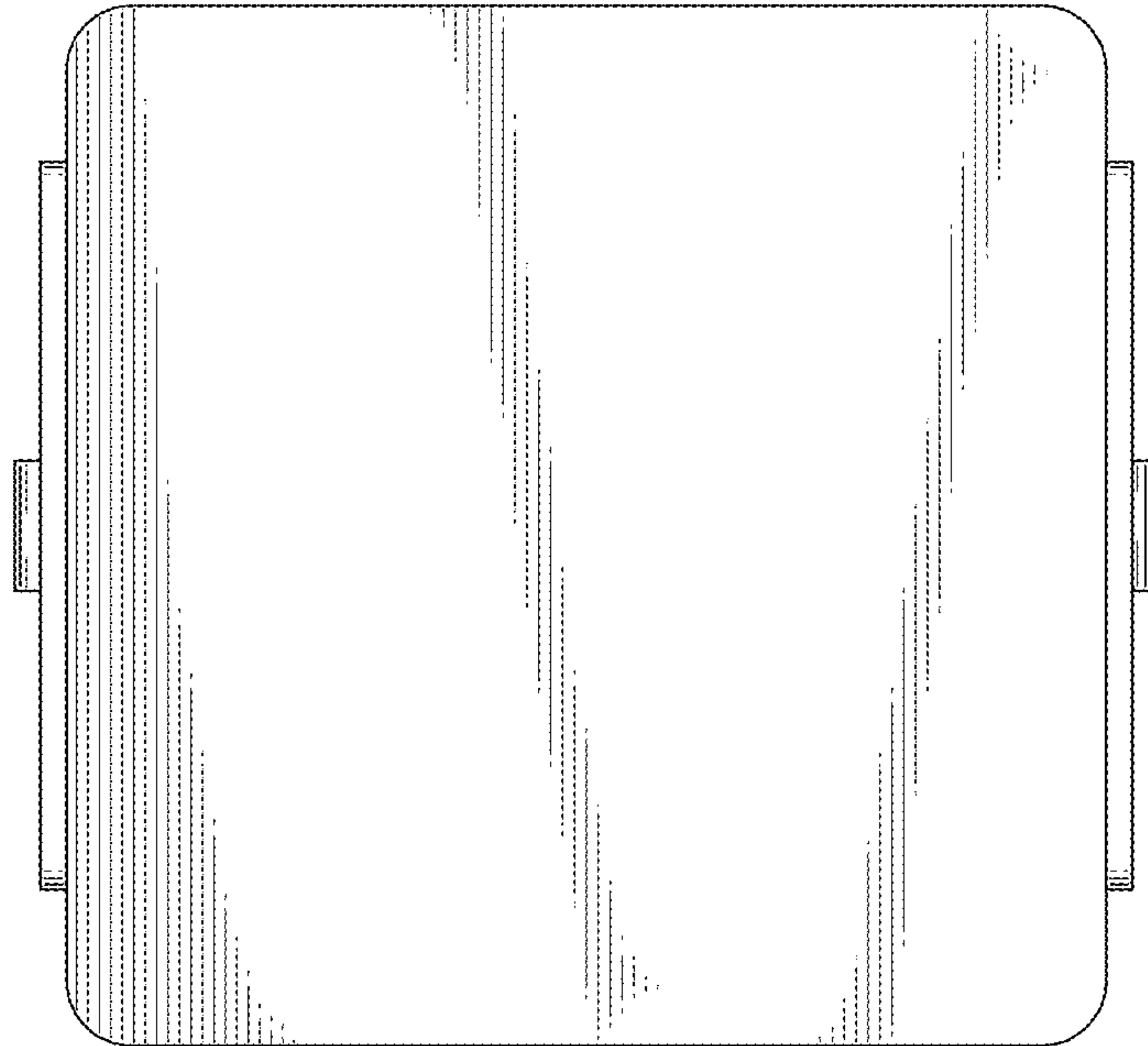
