FIG. 7 is a seventh image in the sequence thereof. FIG. 8 is an eighth image in the sequence thereof; and, FIG. 9 is a ninth image in the sequence thereof.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-9. The process or period in which one image transitions to another image forms no part of the claimed design.

The broken lines showing a portion of a display panel and portions of the animated computer icon, including stippled portions, in FIGS. 1-9 form no part of the claimed design.

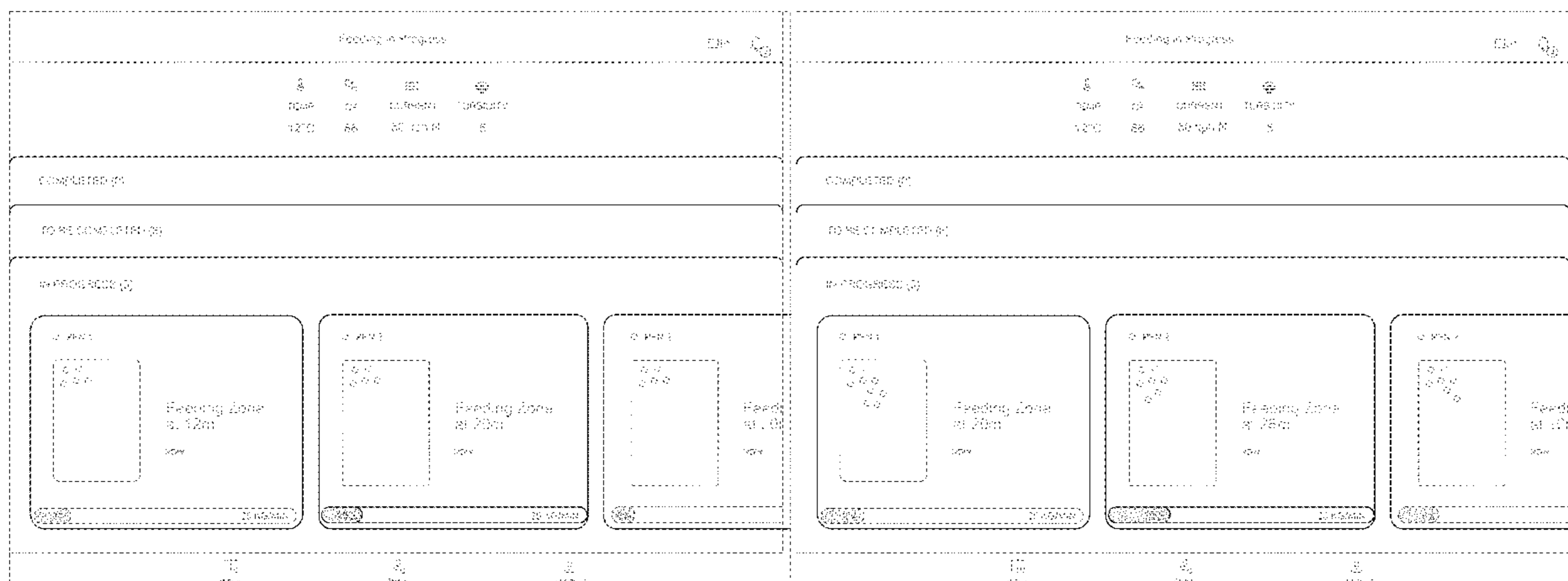

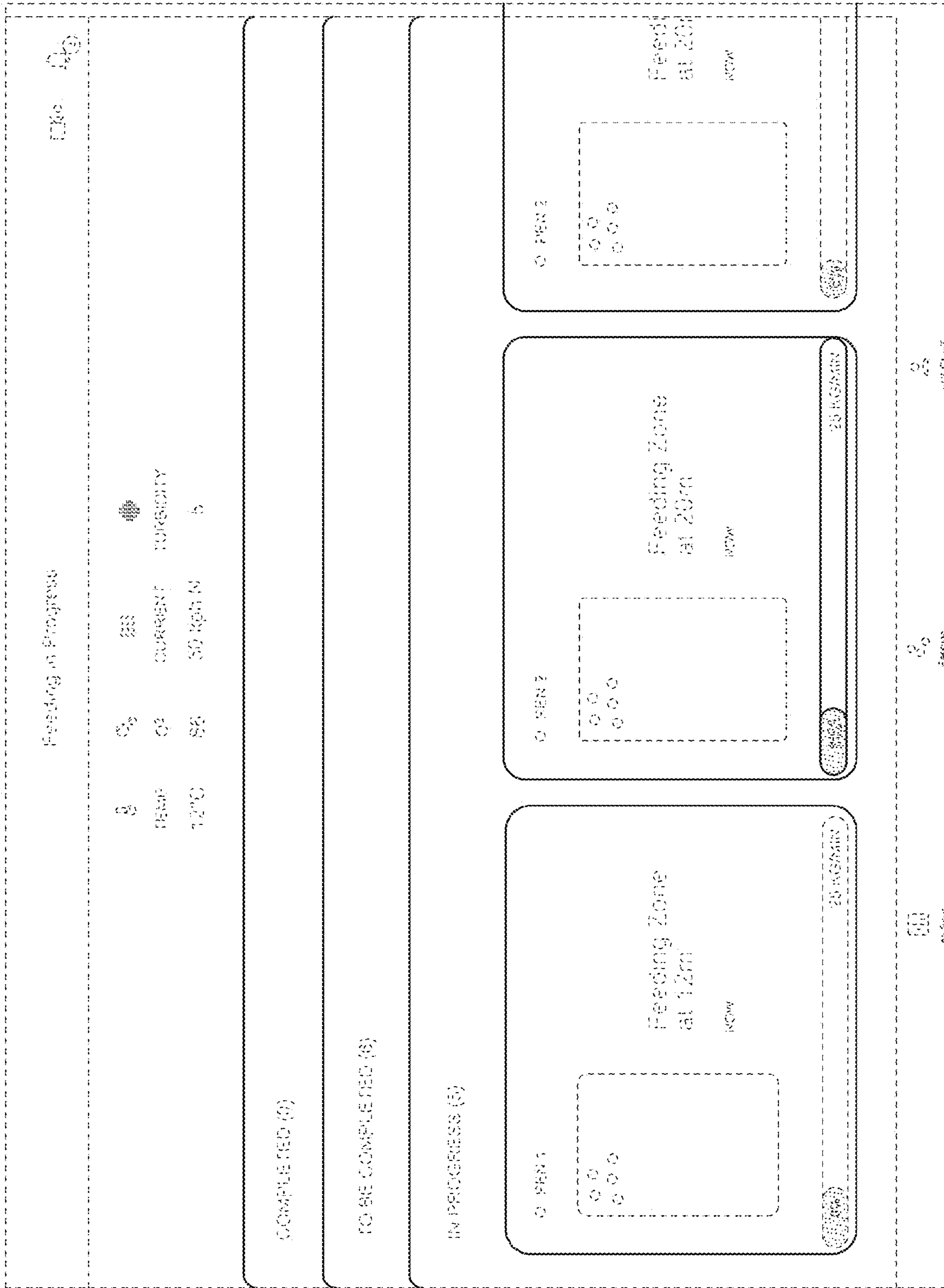

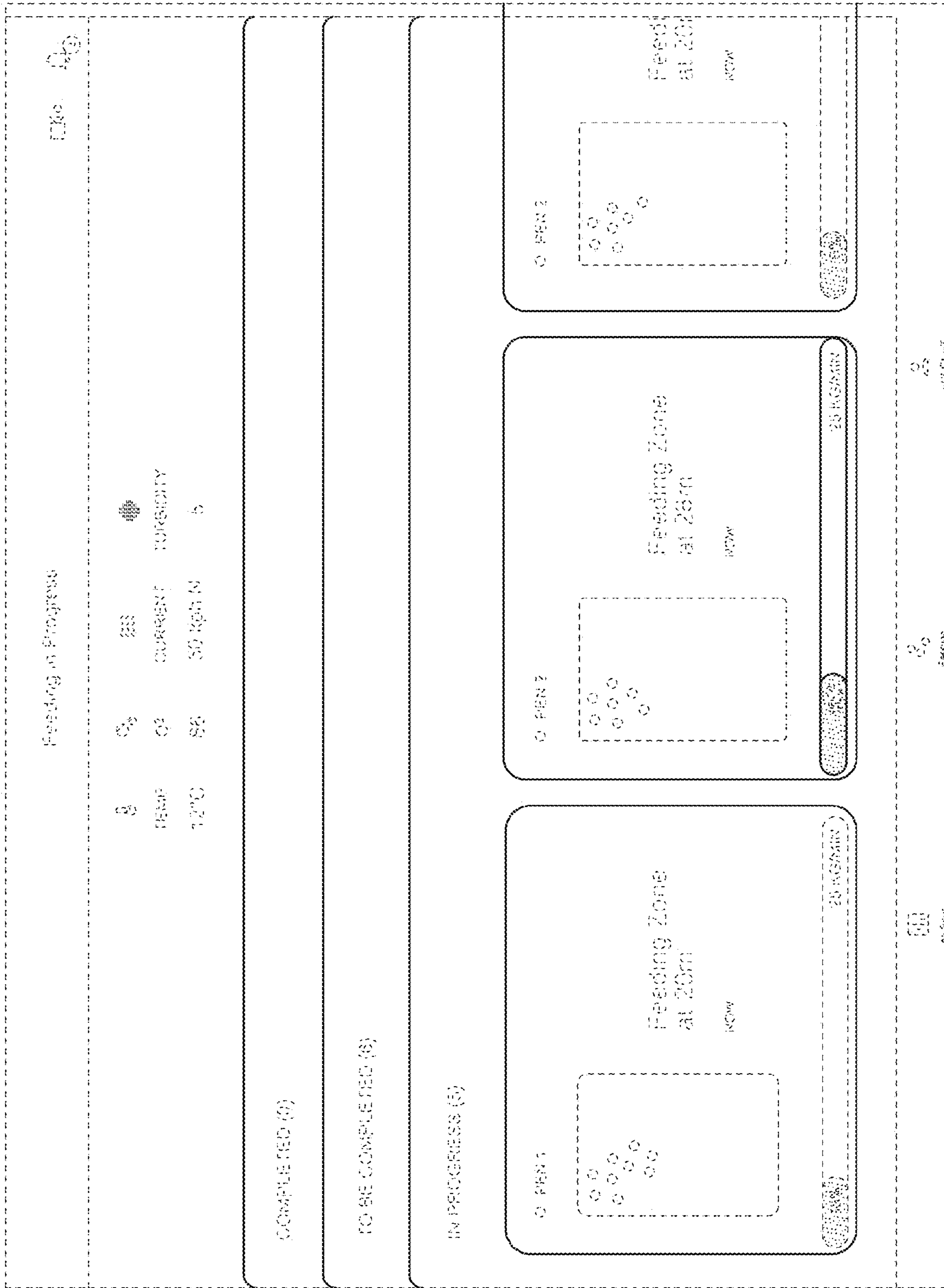

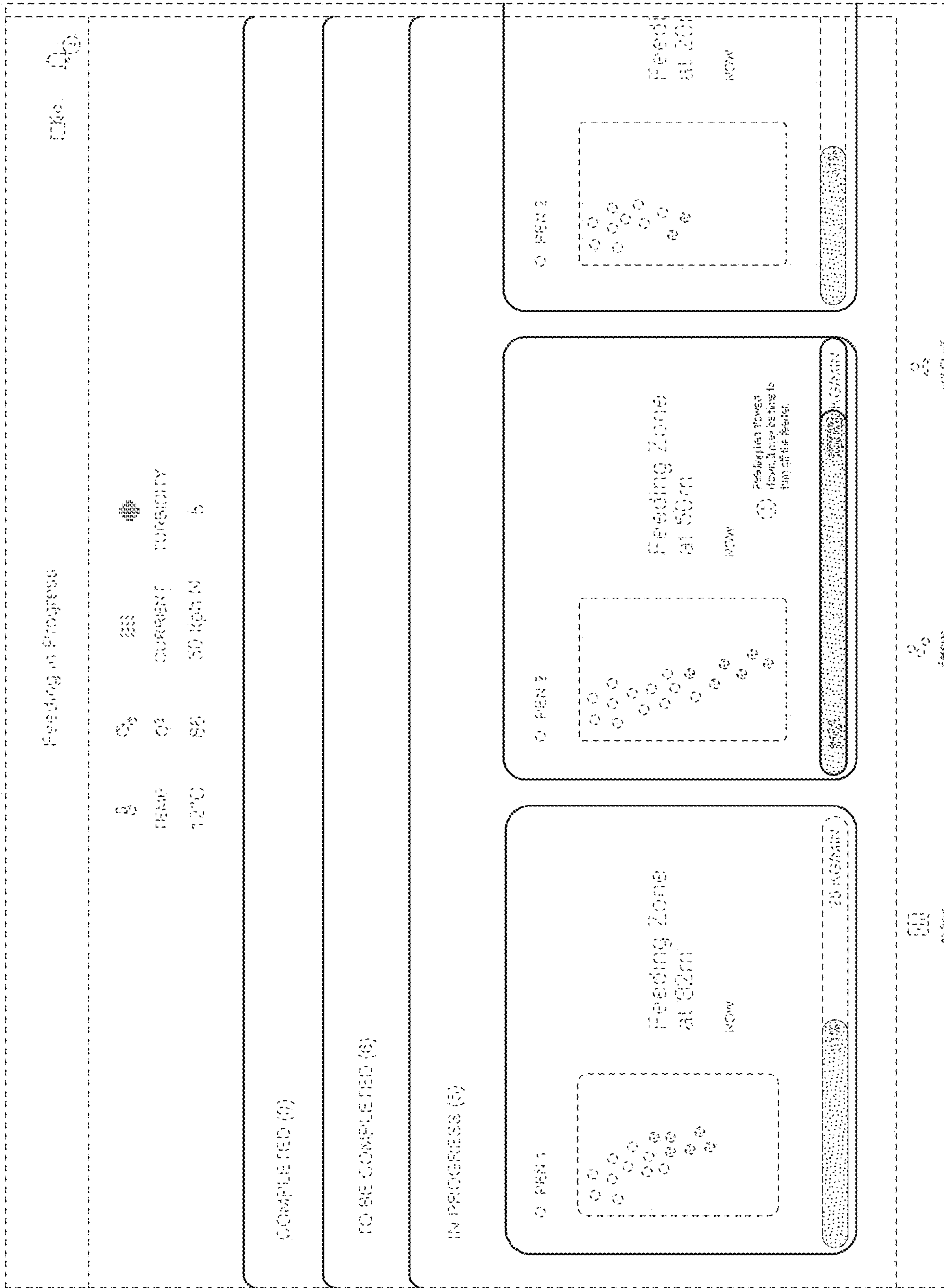

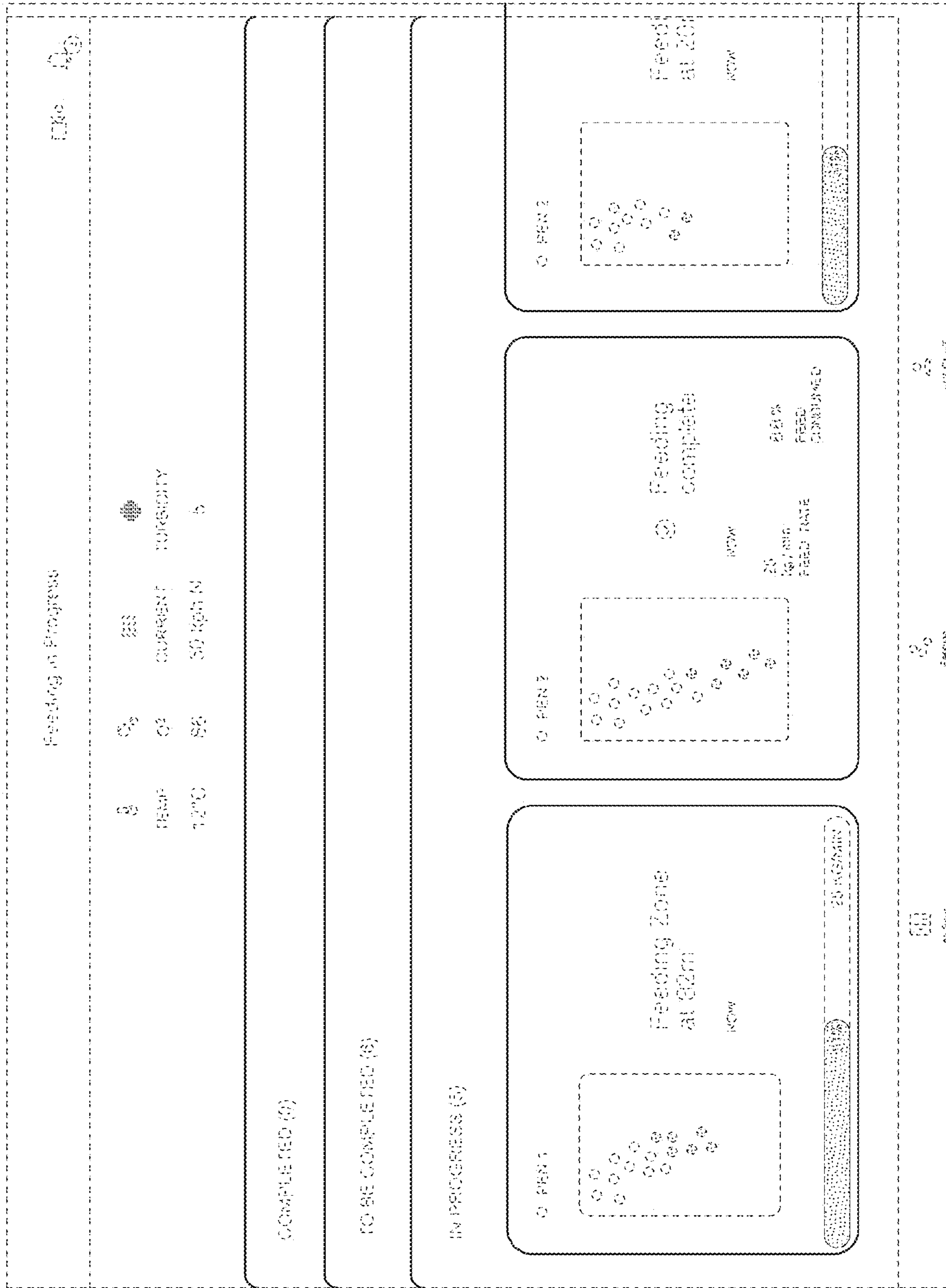

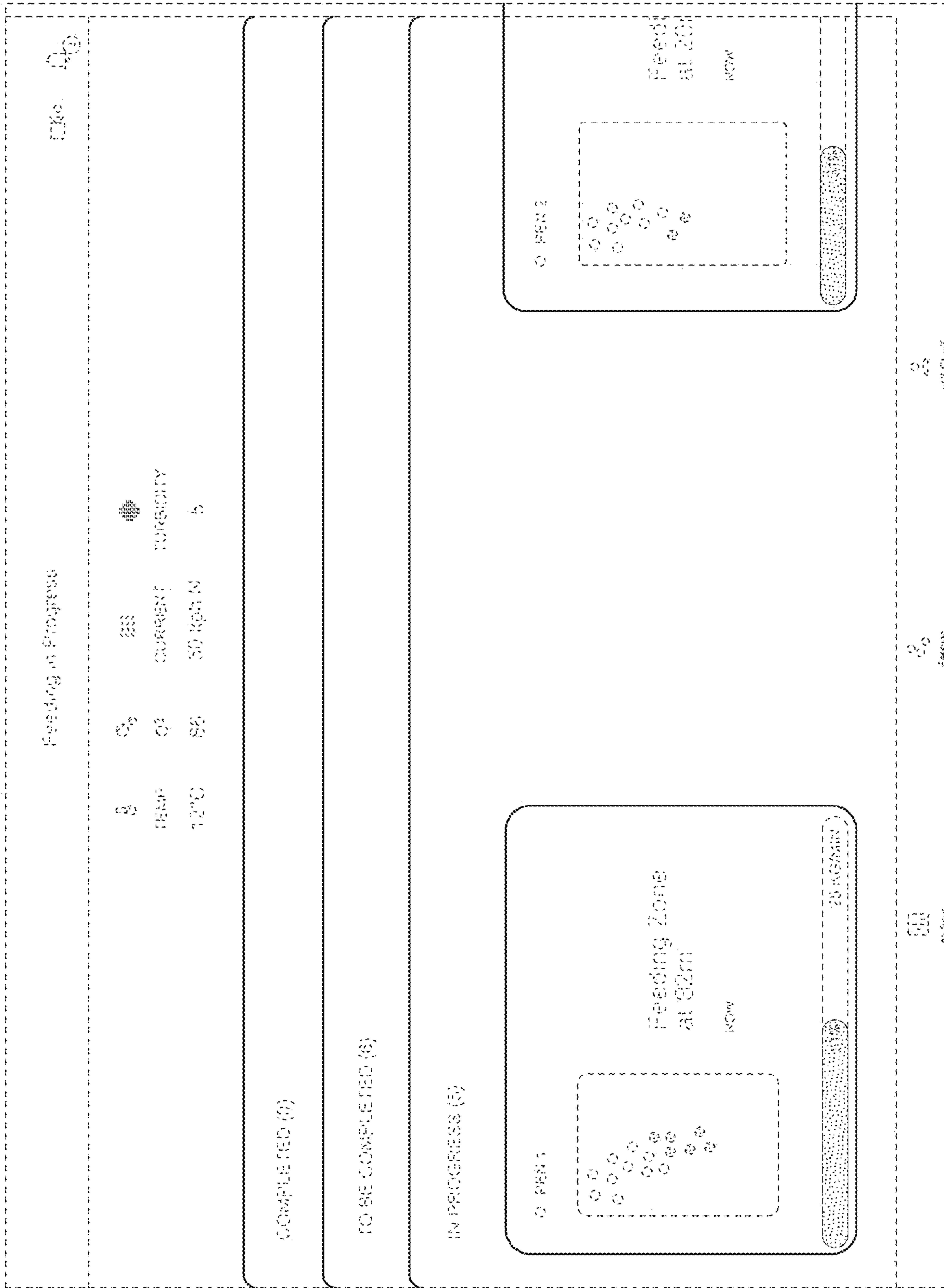

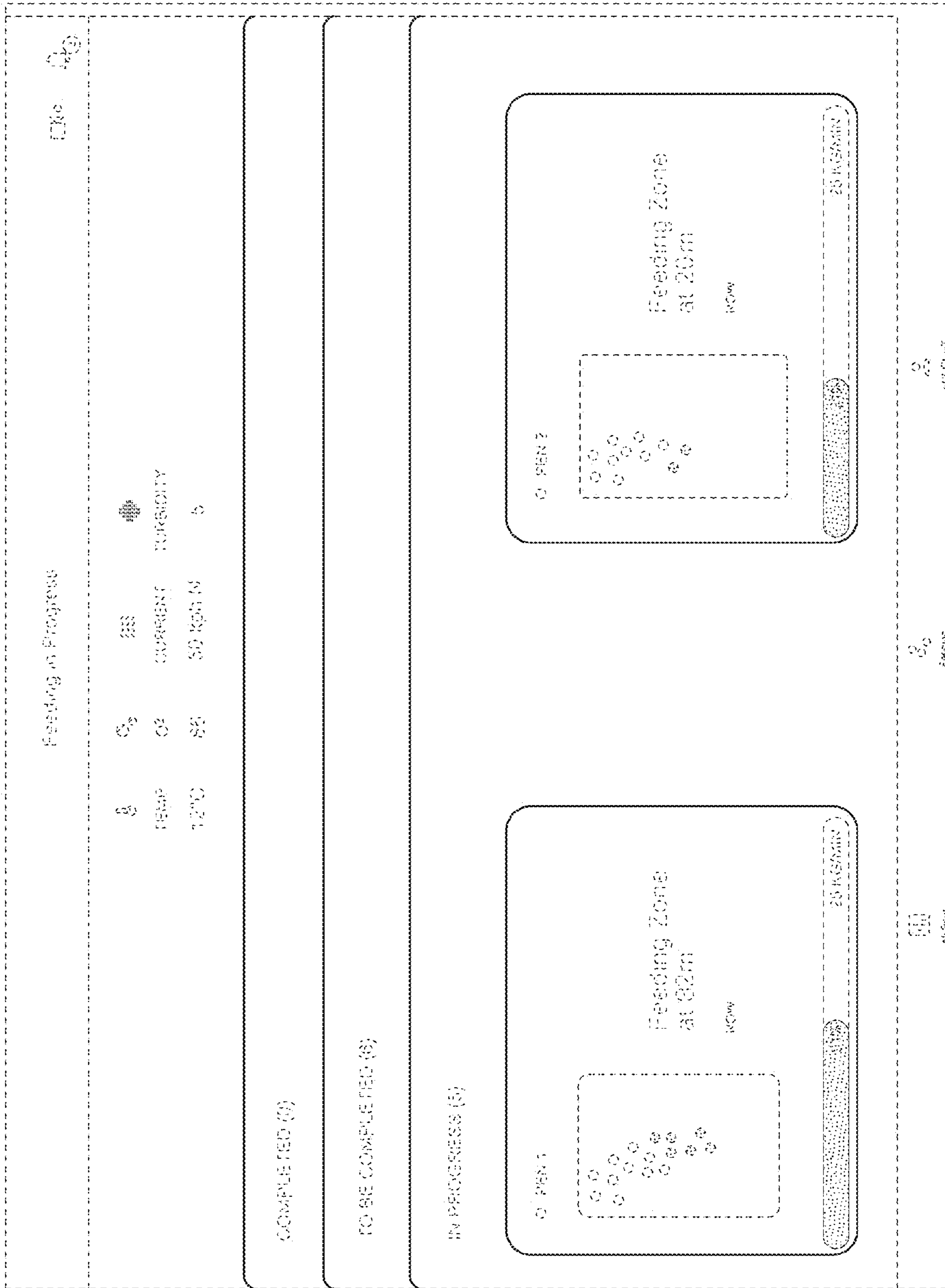

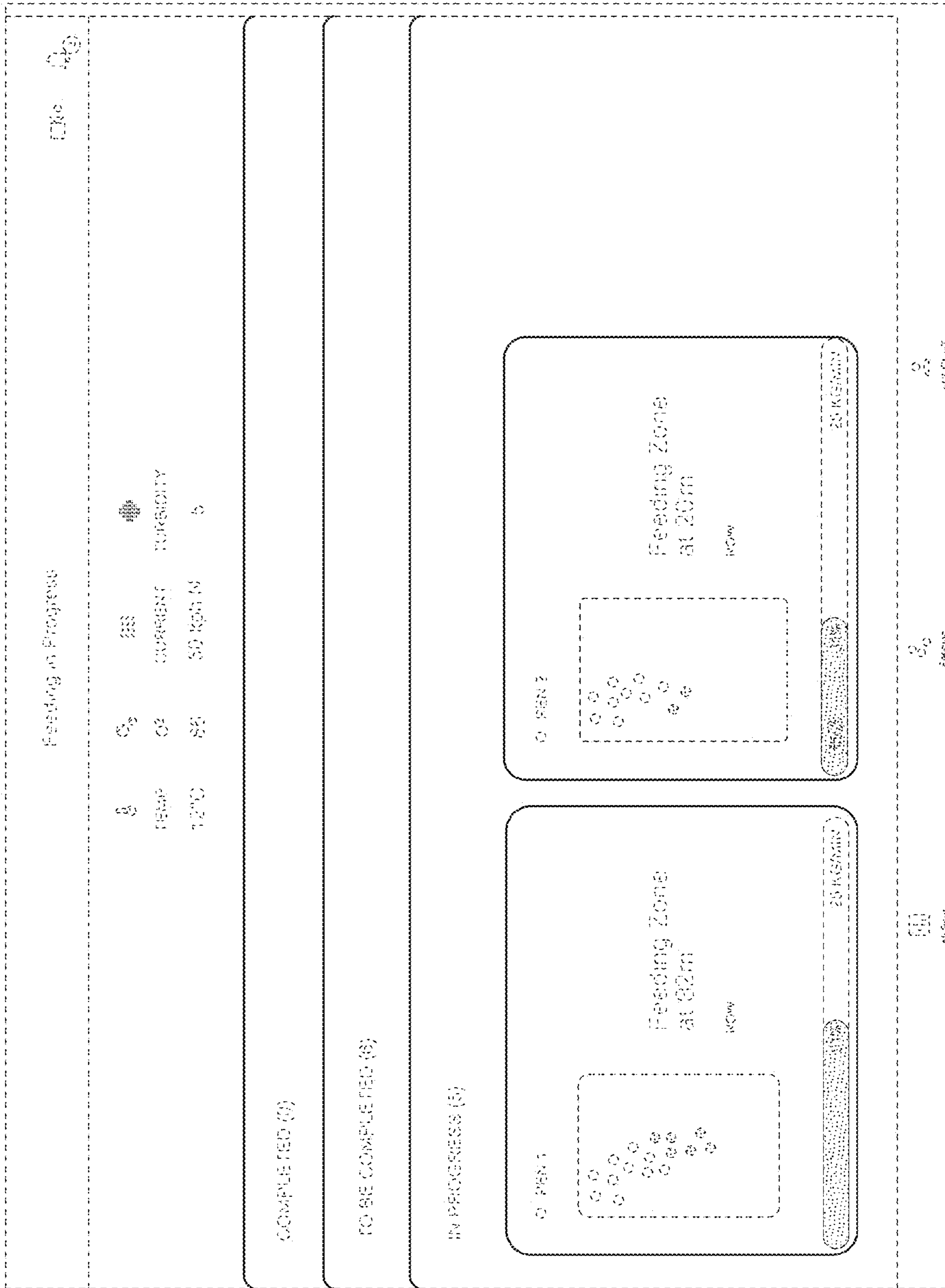

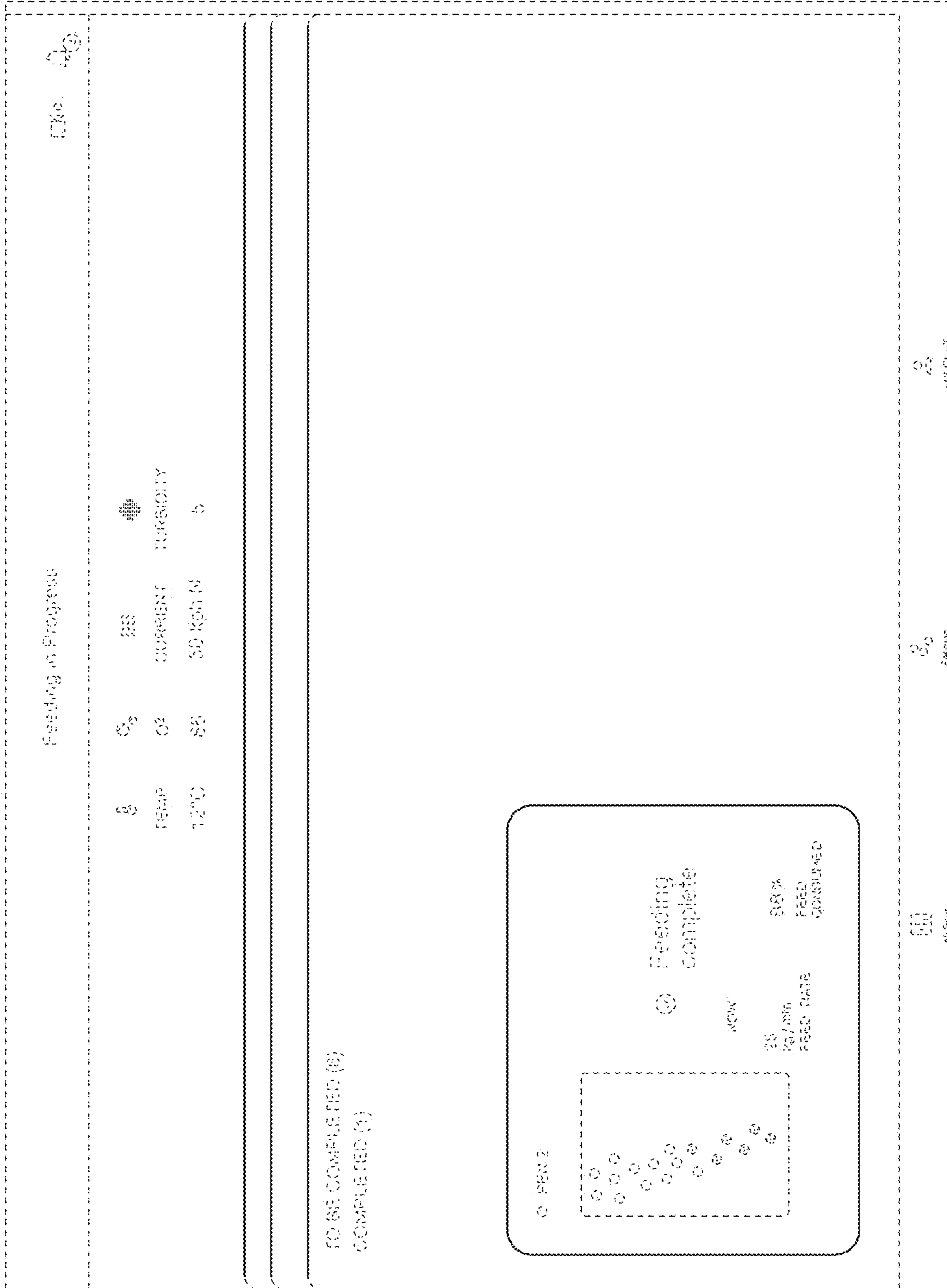

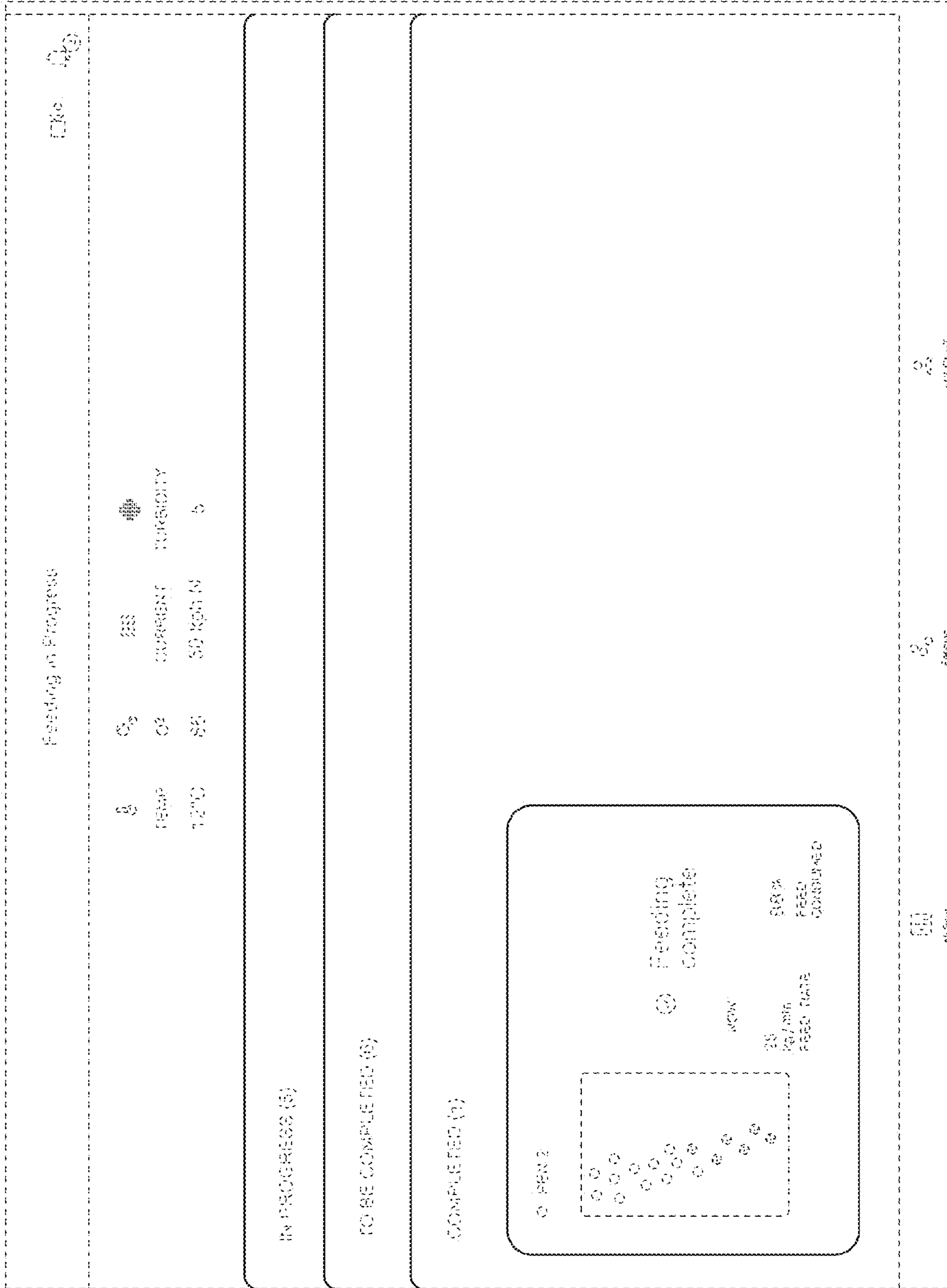
