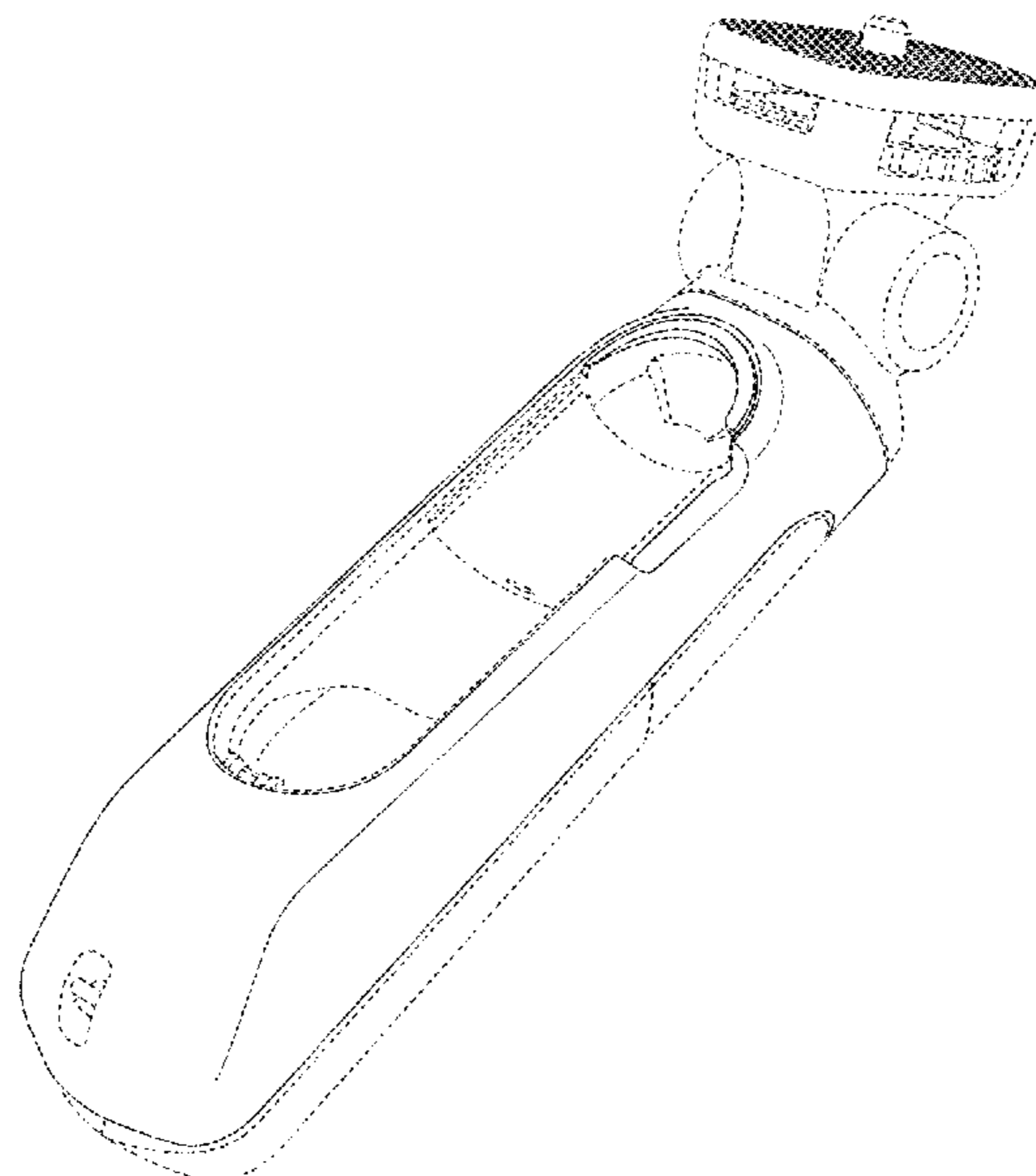

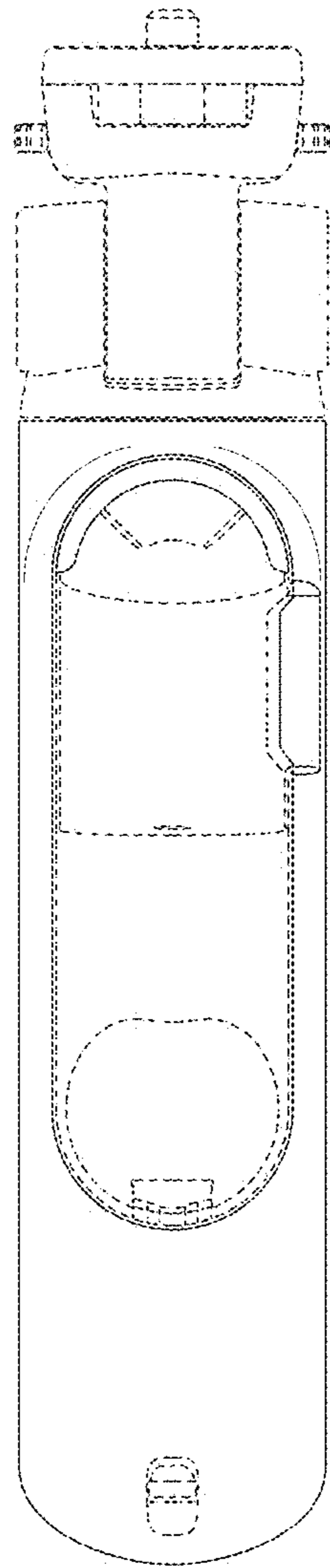
The ornamental design for a camera grip, as shown and described.

DESCRIPTION

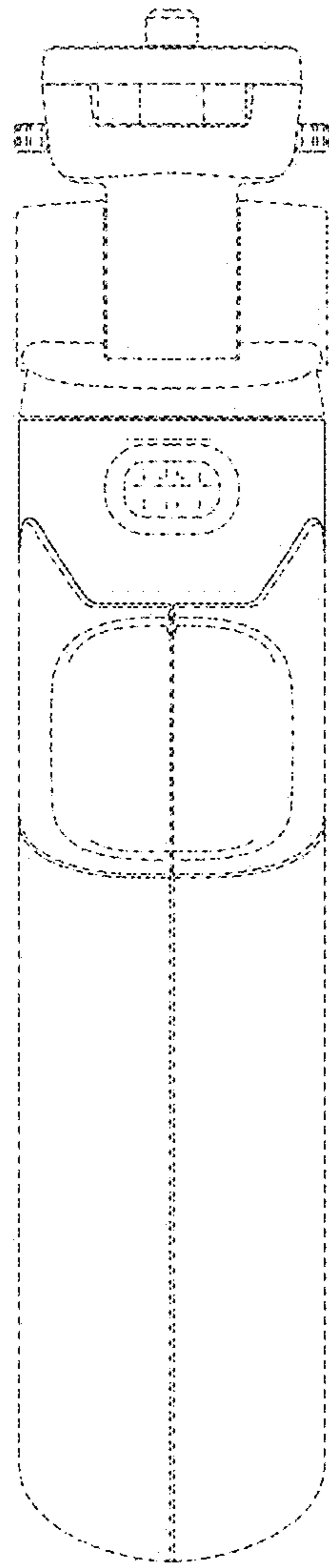
1. Camera grip

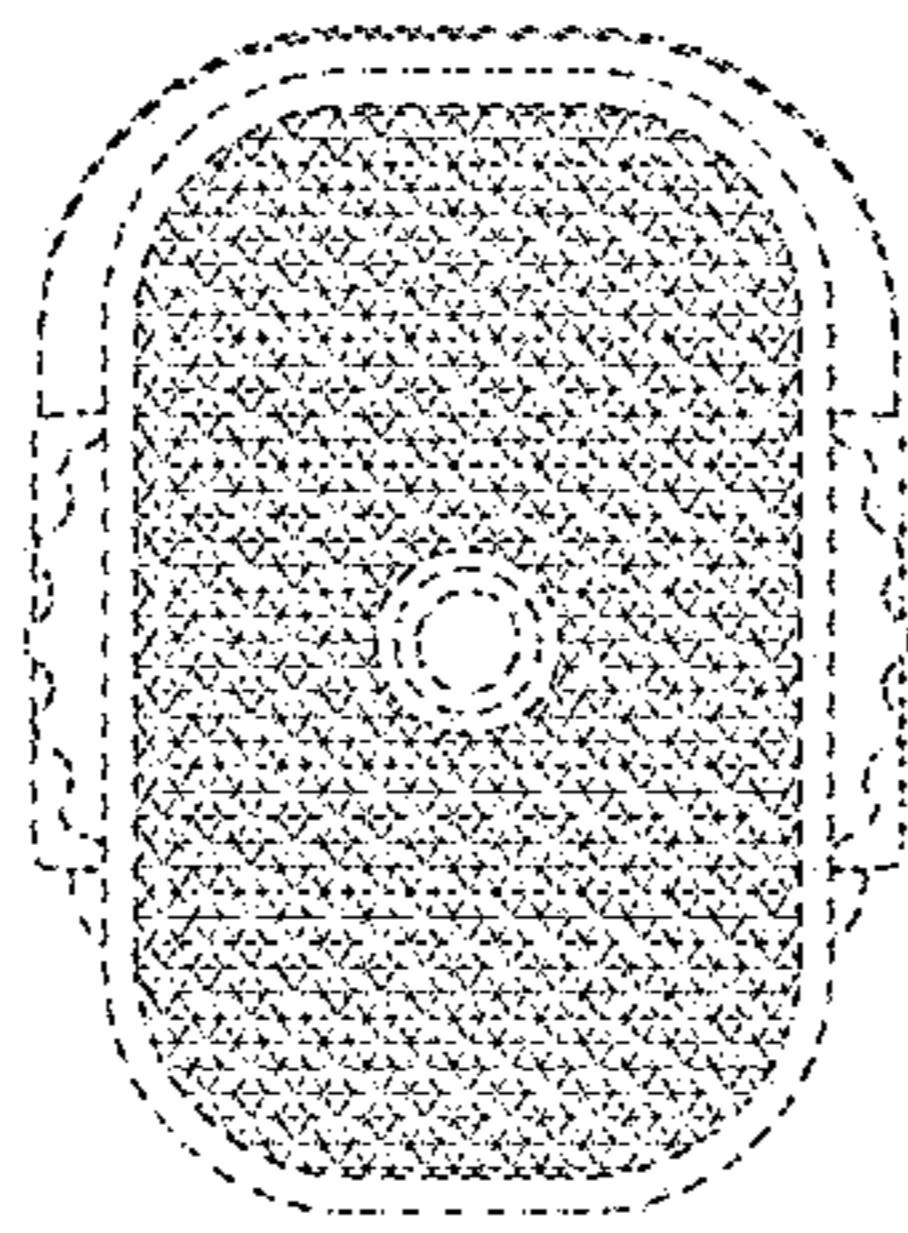




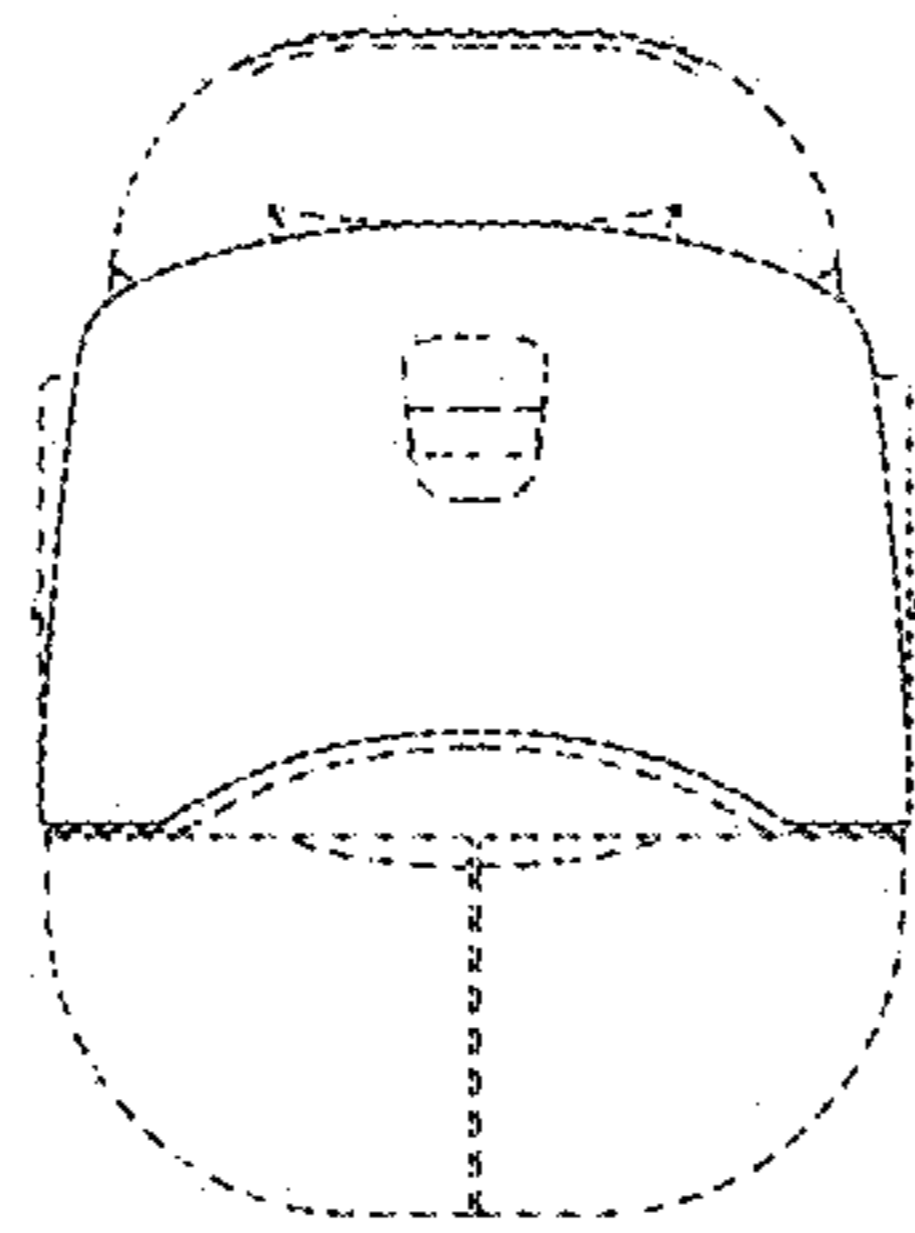

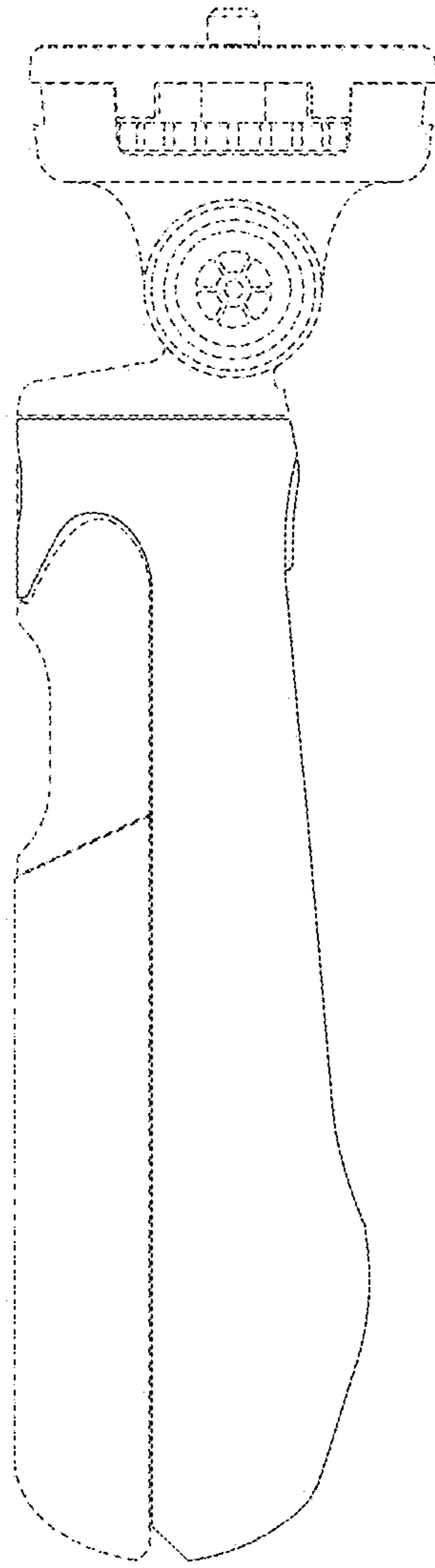

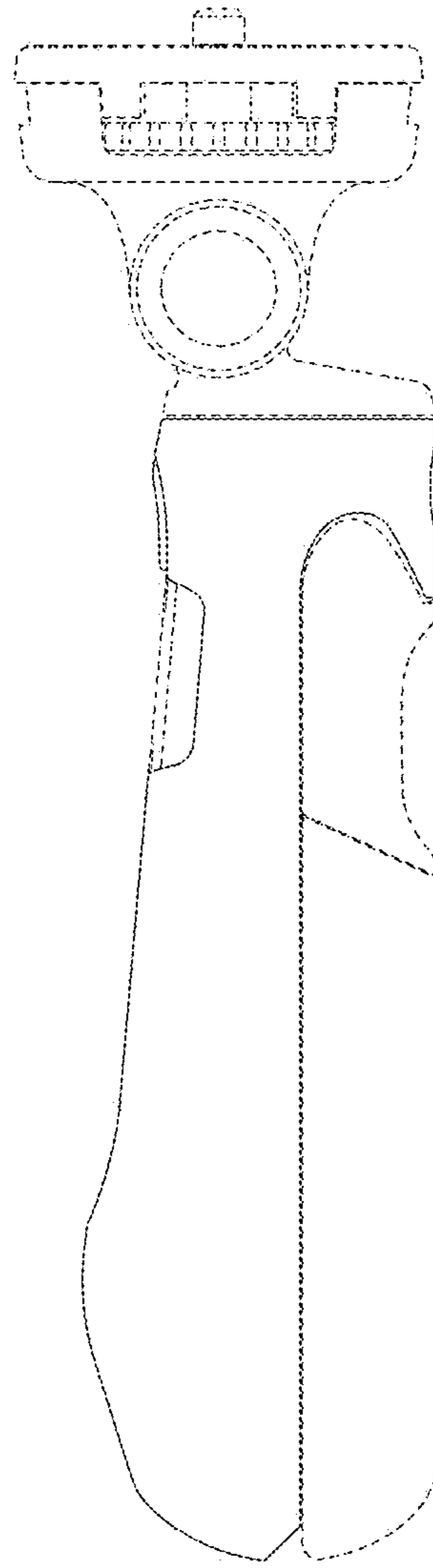

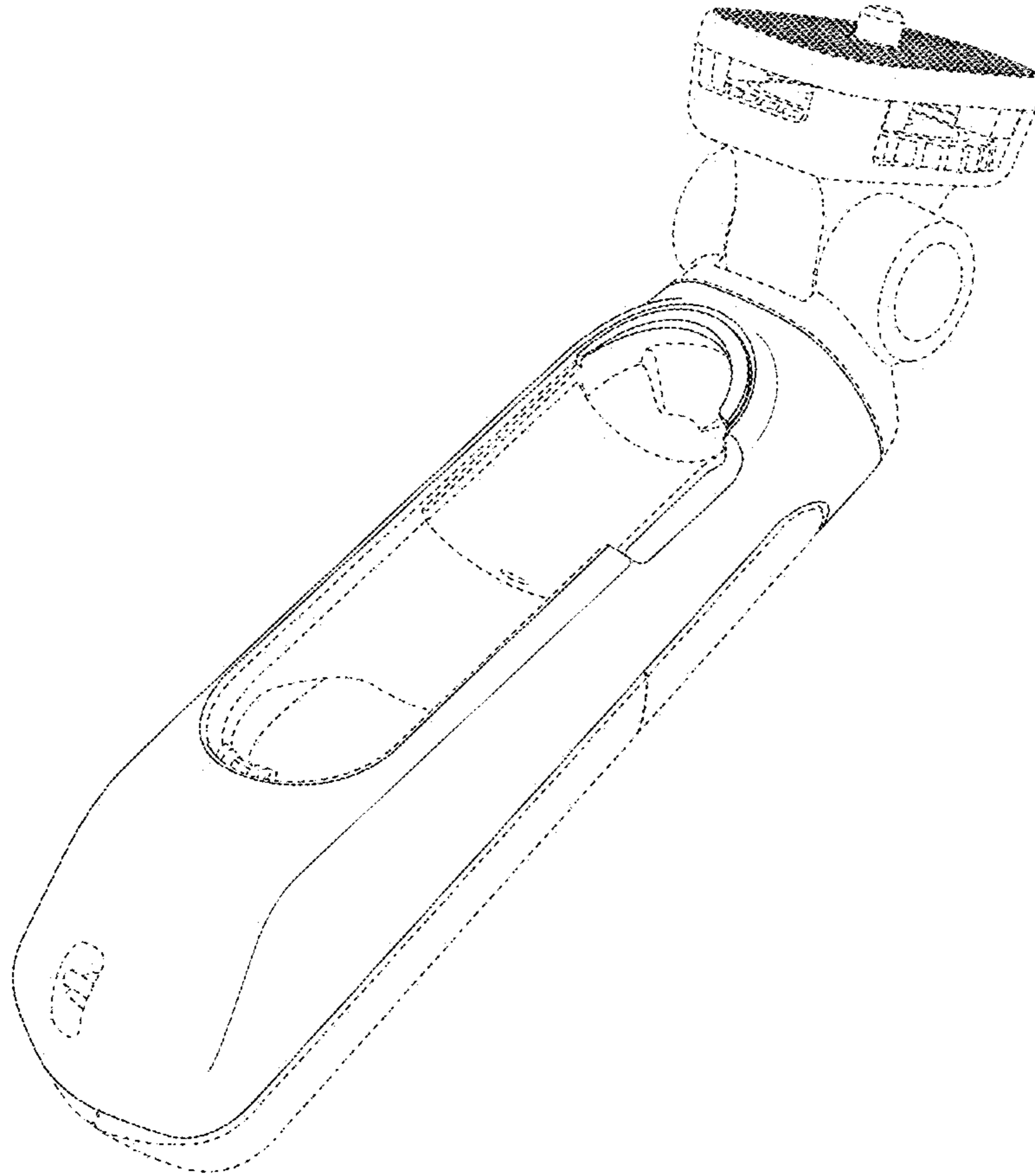

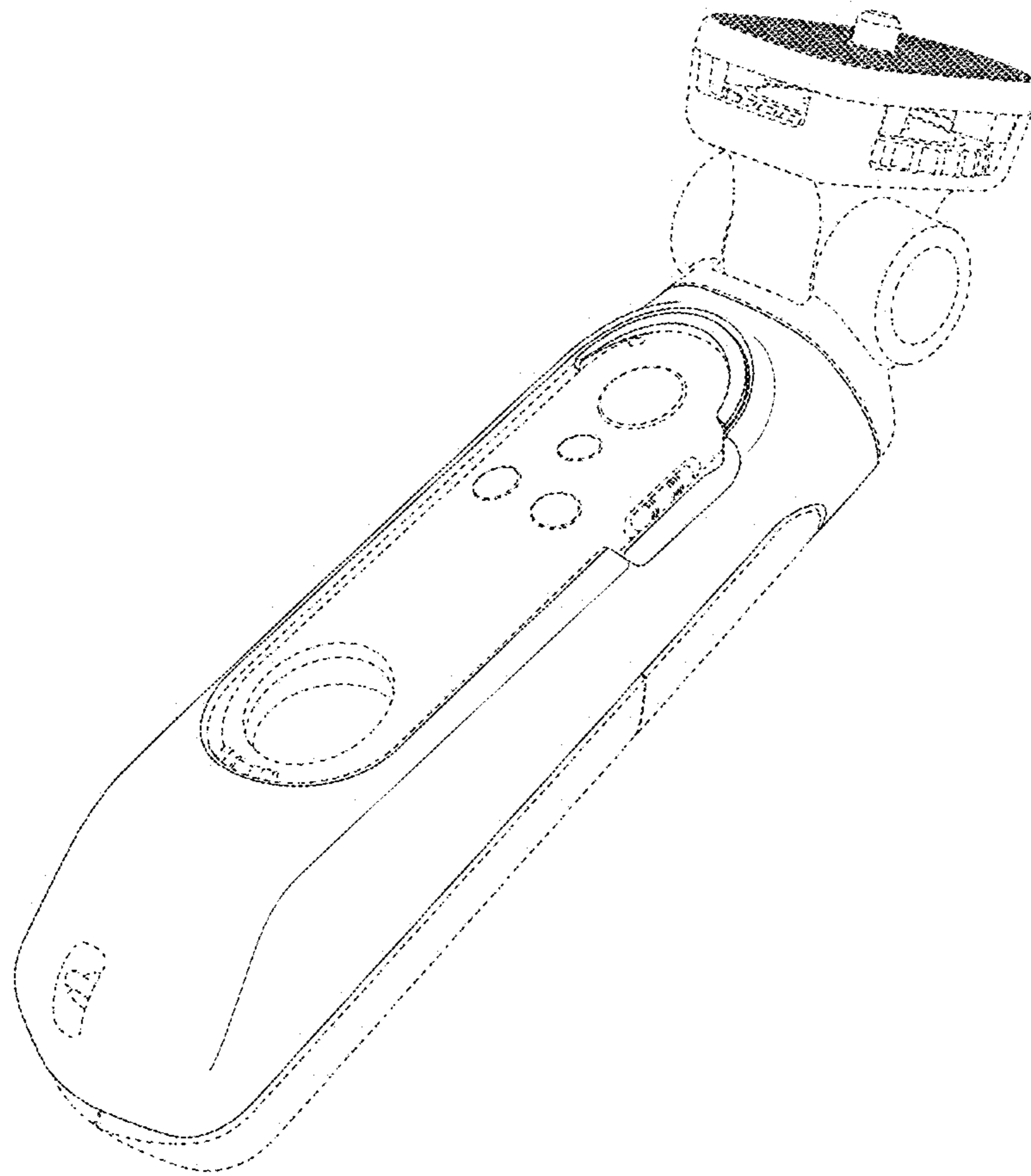
