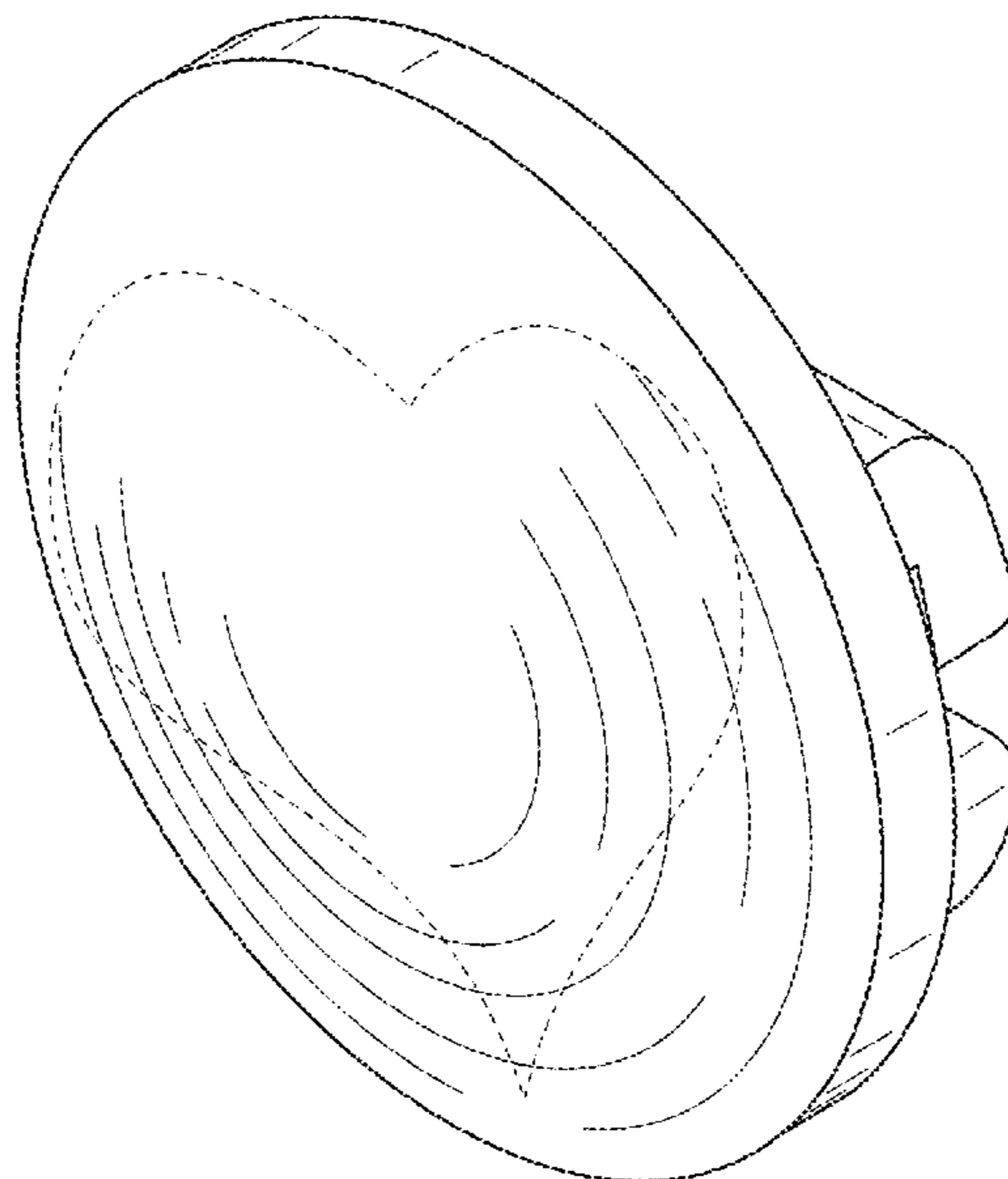
The ornamental design for a clip for goggles strap, as shown and described.

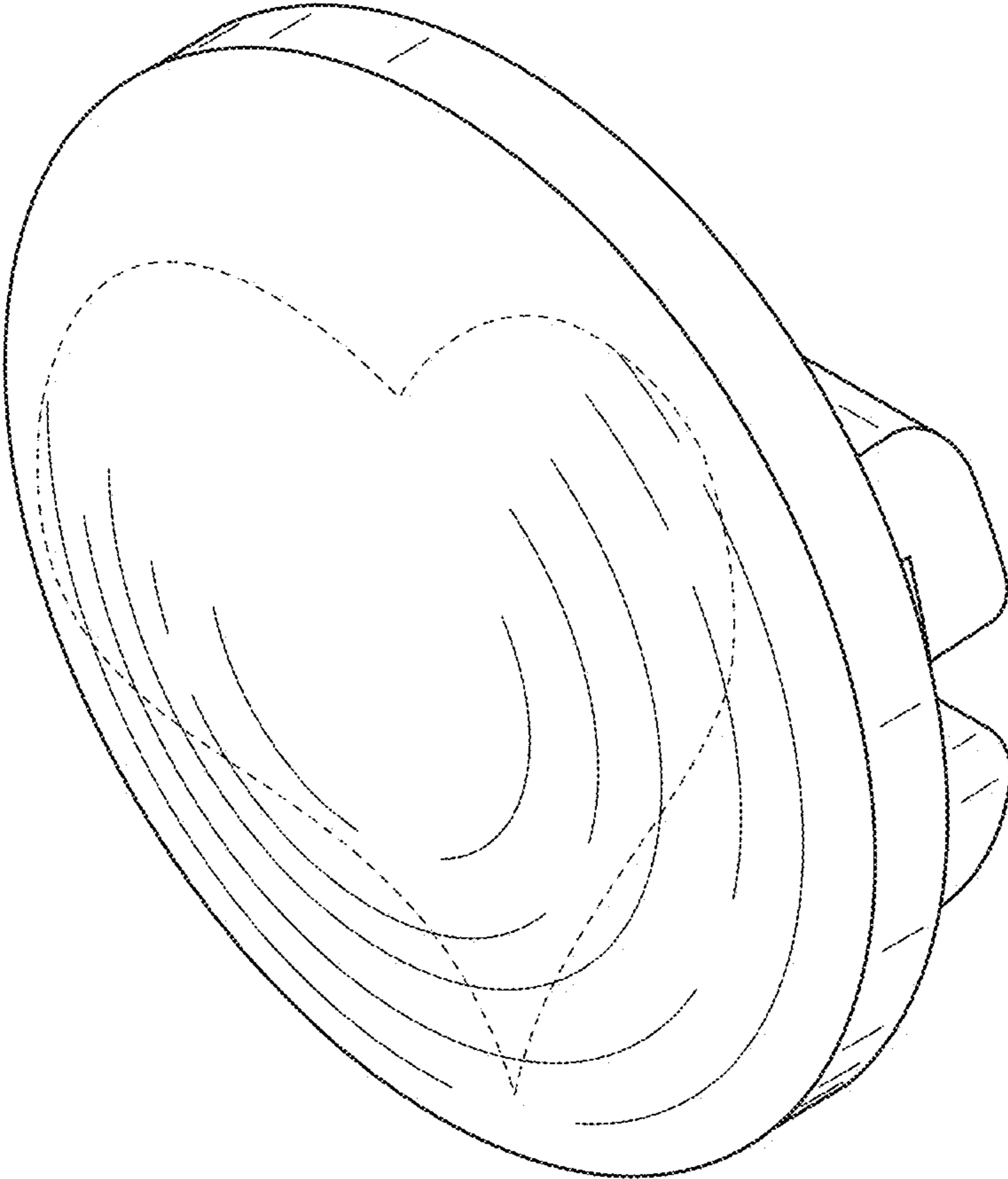

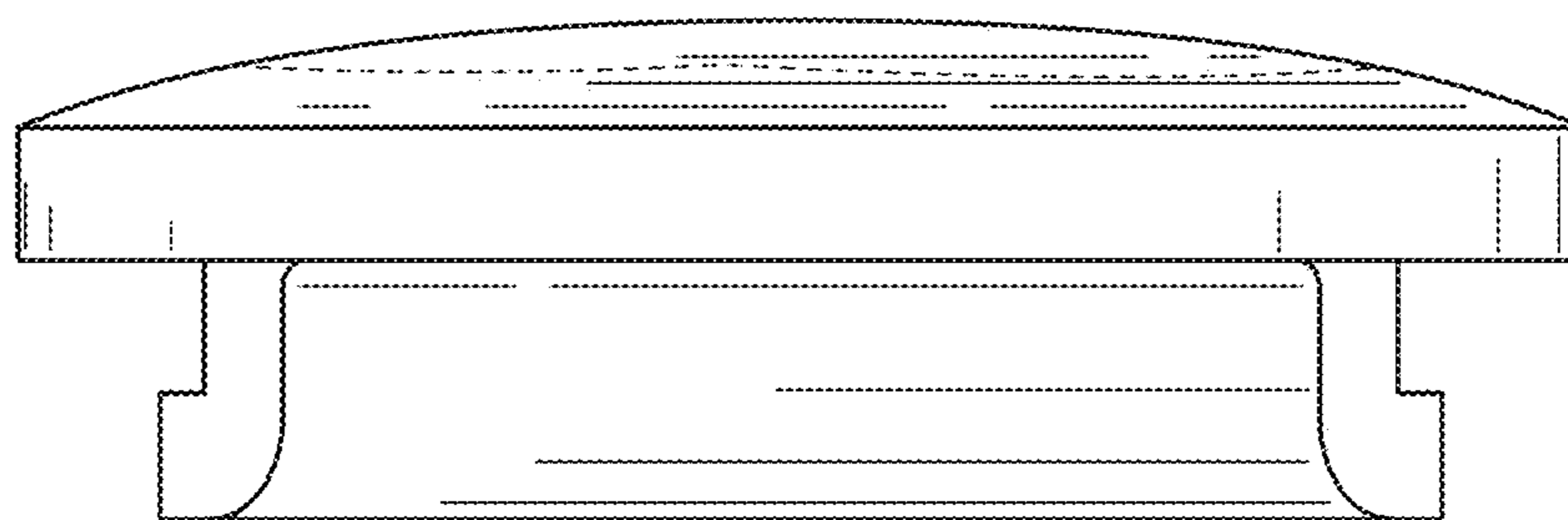

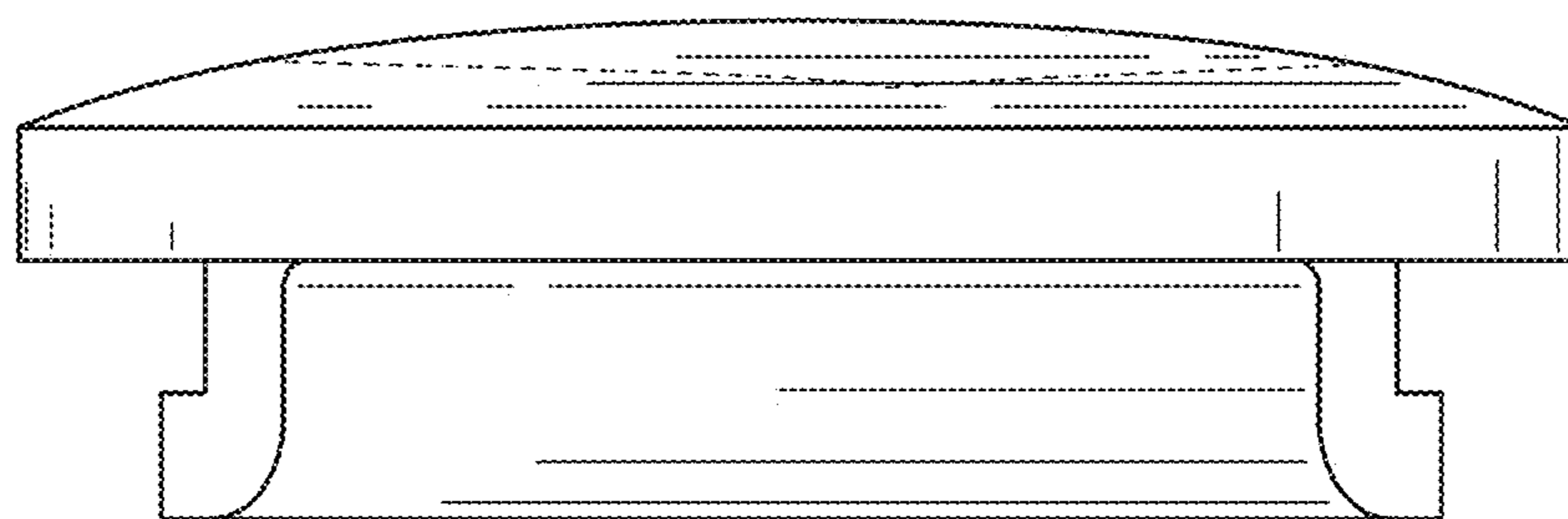

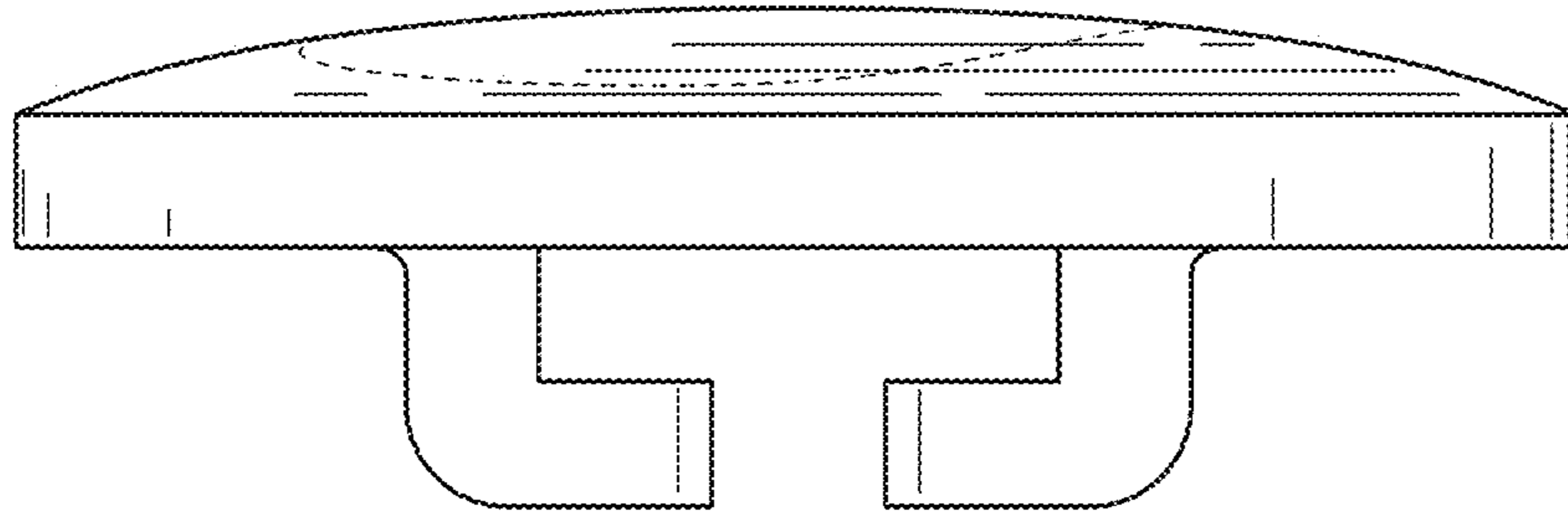

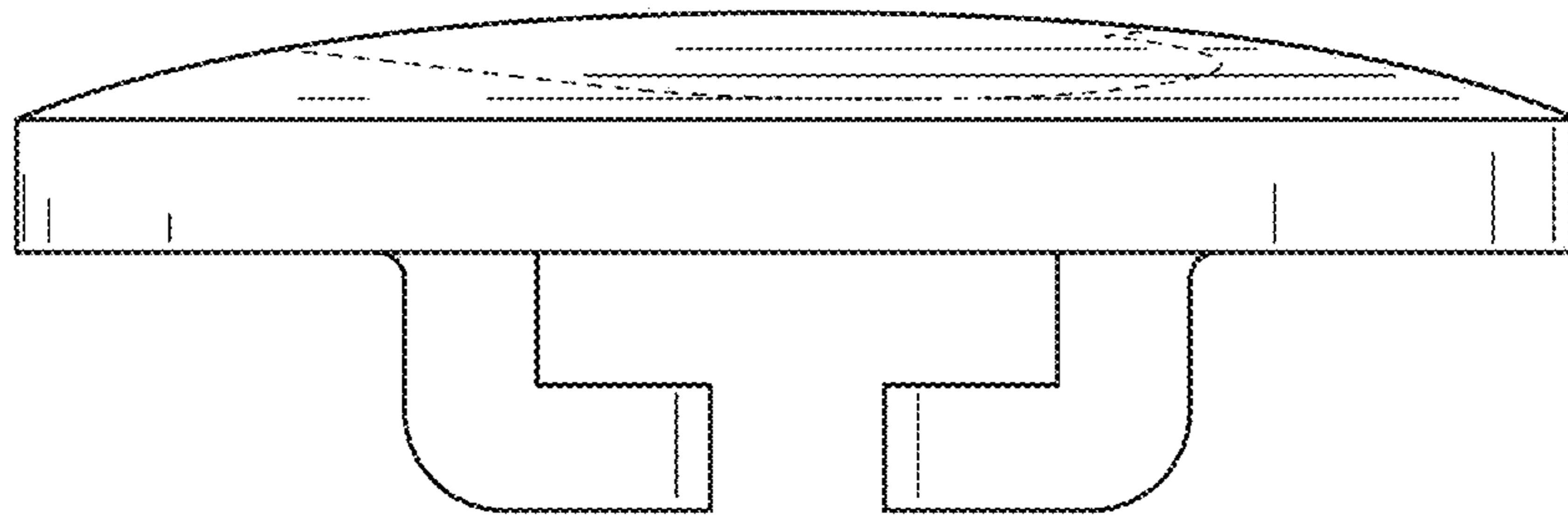

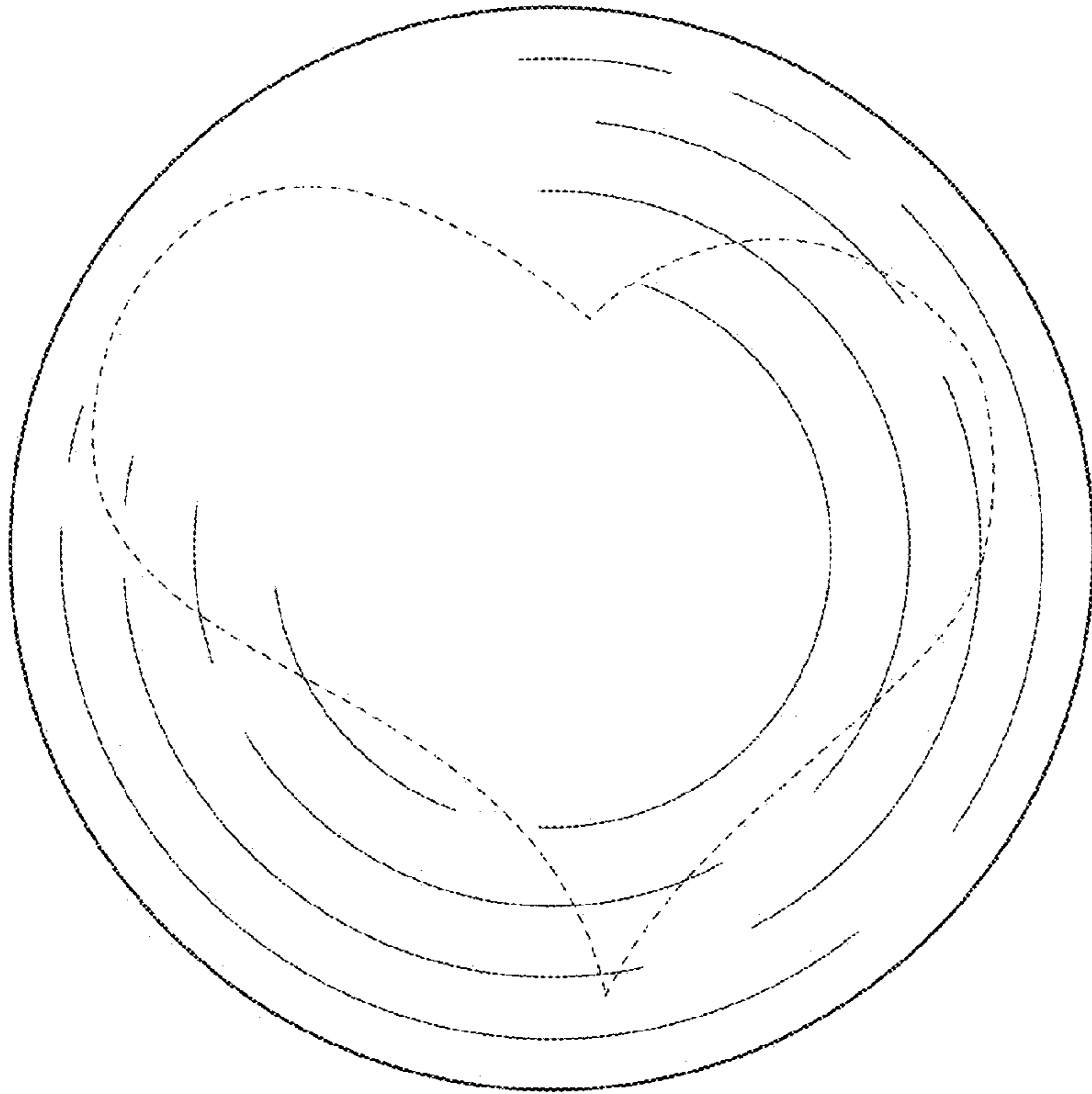

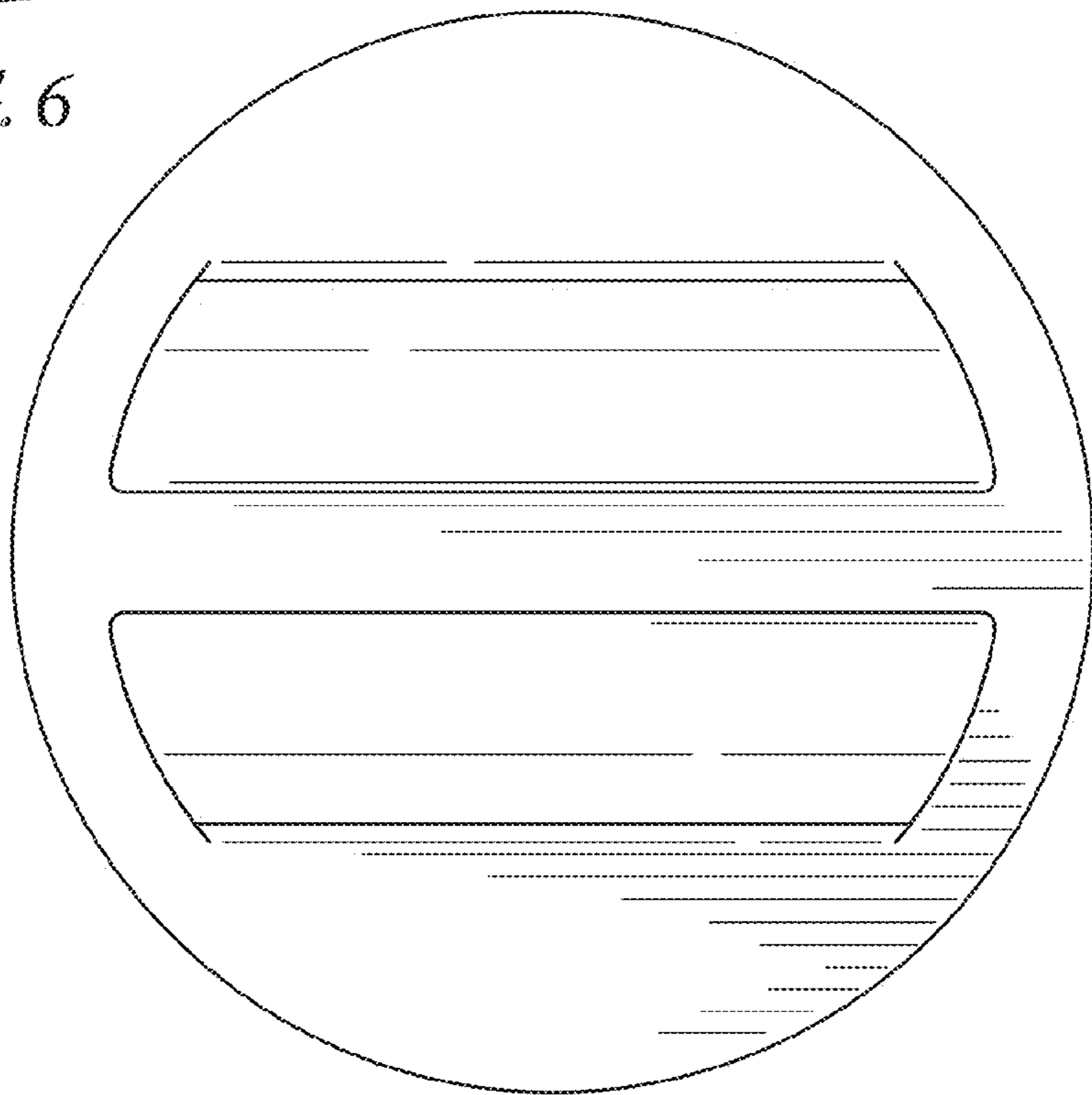

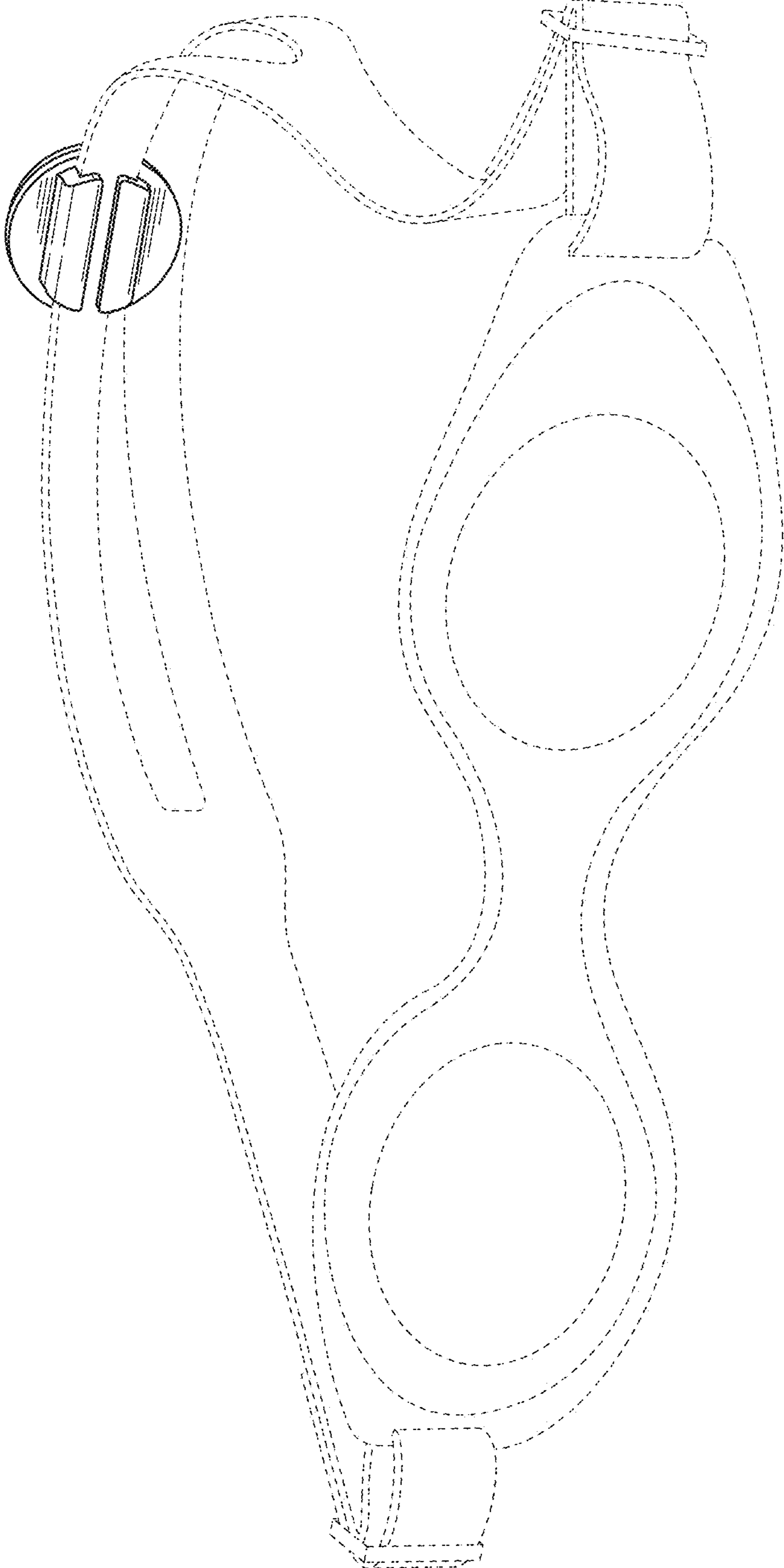
