CLAIM

The ornamental design for a file, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a file showing our new design;

FIG. 2 is a rear elevation view thereof;

FIG. 3 is a top plan elevation view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a left side elevation view thereof;

FIG. 7 is an enlarged view thereof taken at line 7 shown in FIG. 5;

FIG. 8 is a cross-section view thereof taken along the line 8-8 in FIG. 7;

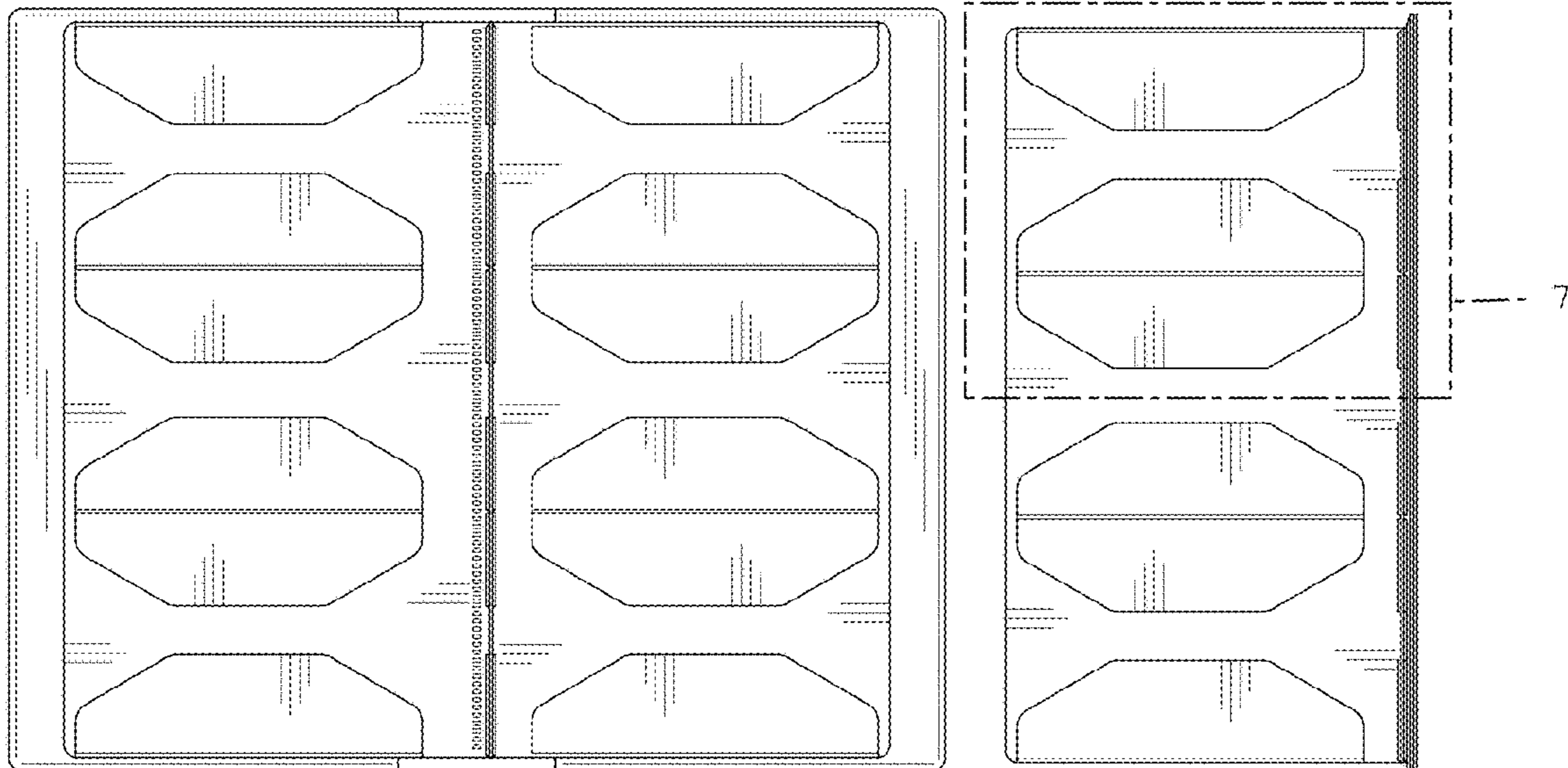
FIG. 9 is a cross-section view showing the area in FIG. 8 in an open state;

FIG. 10 is a front view of the file in a state wherein all of the file pages are standing upright; and,

FIG. 11 is a cross-section view taken along the line 11-11 in FIG. 10.

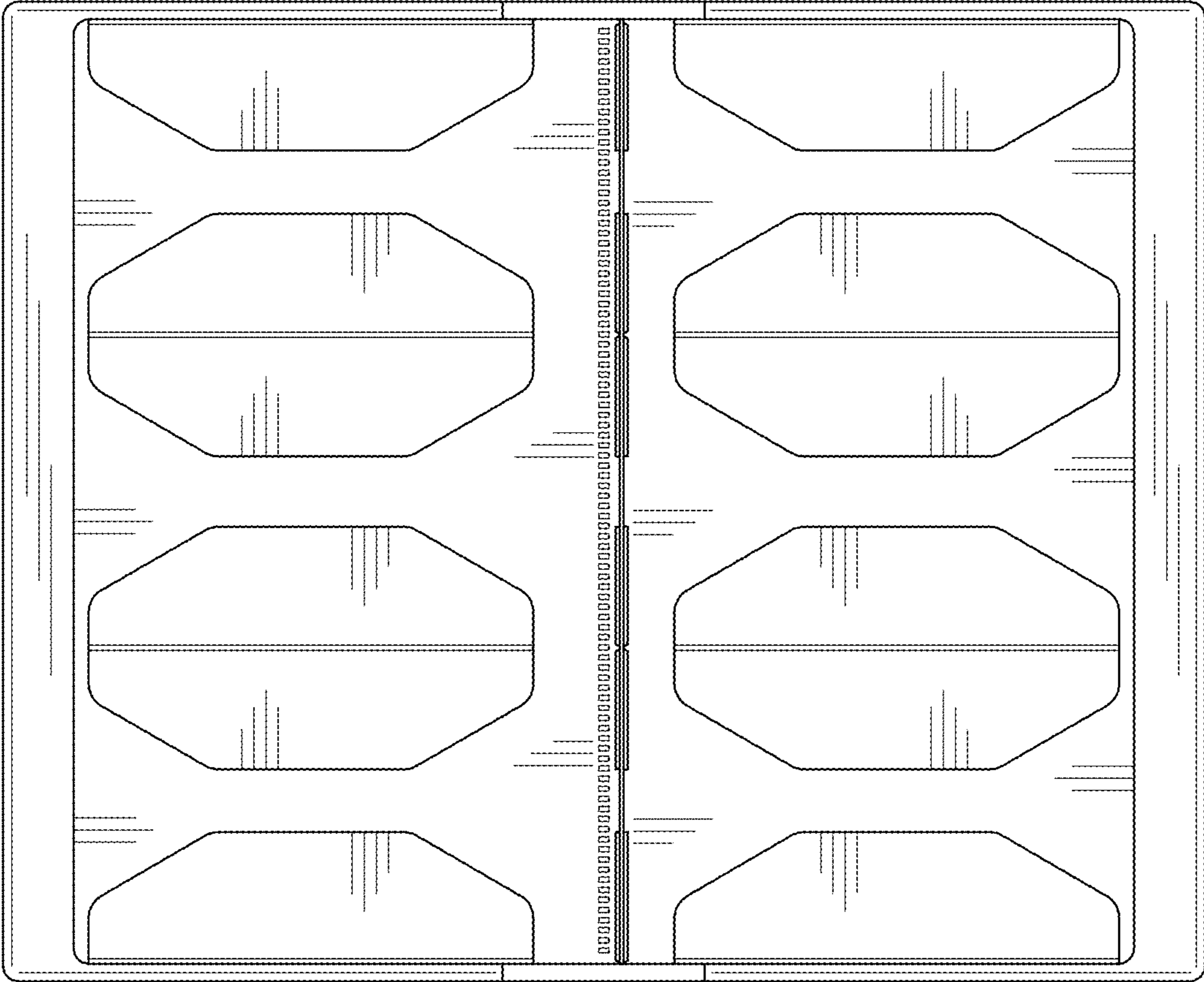

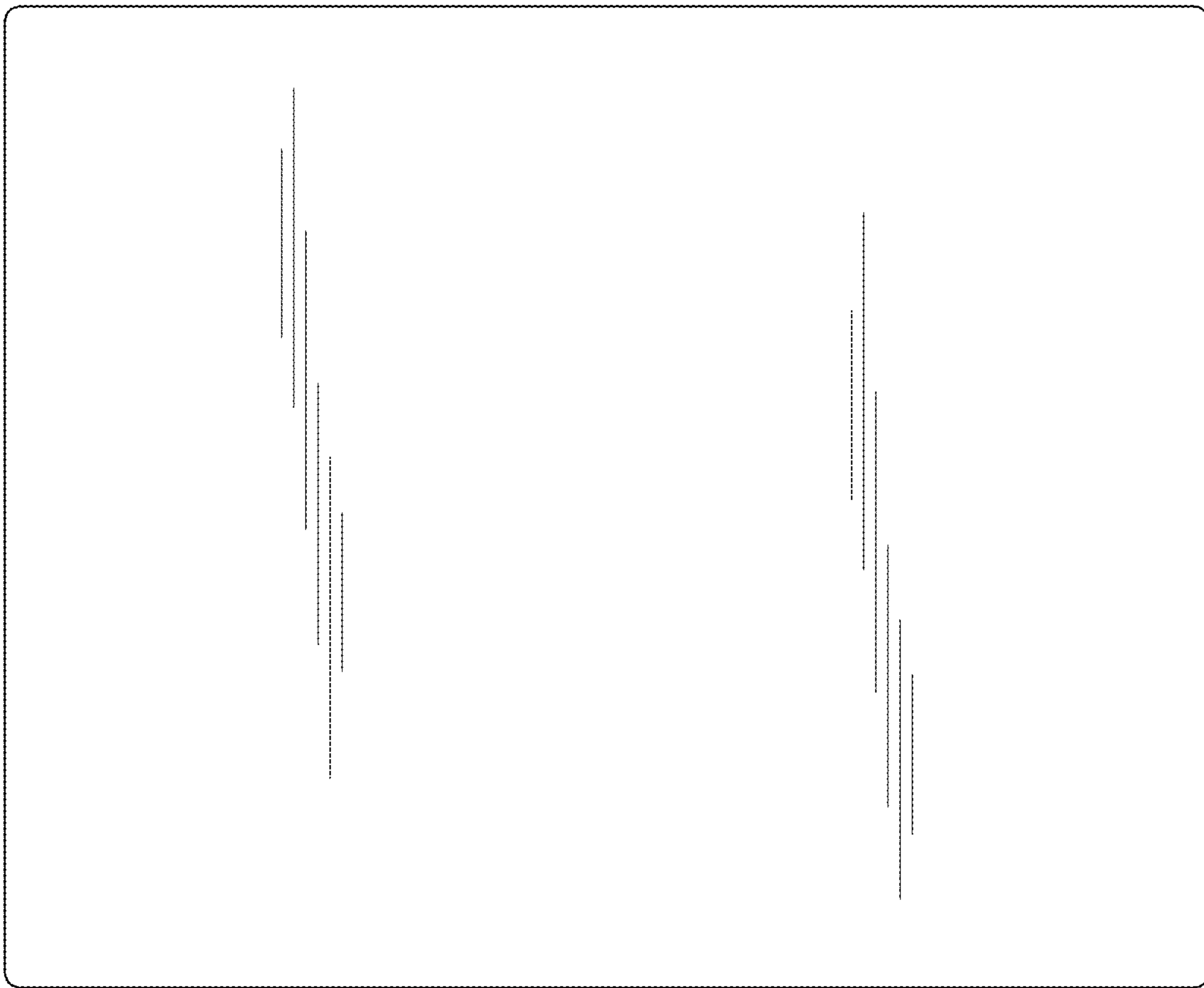

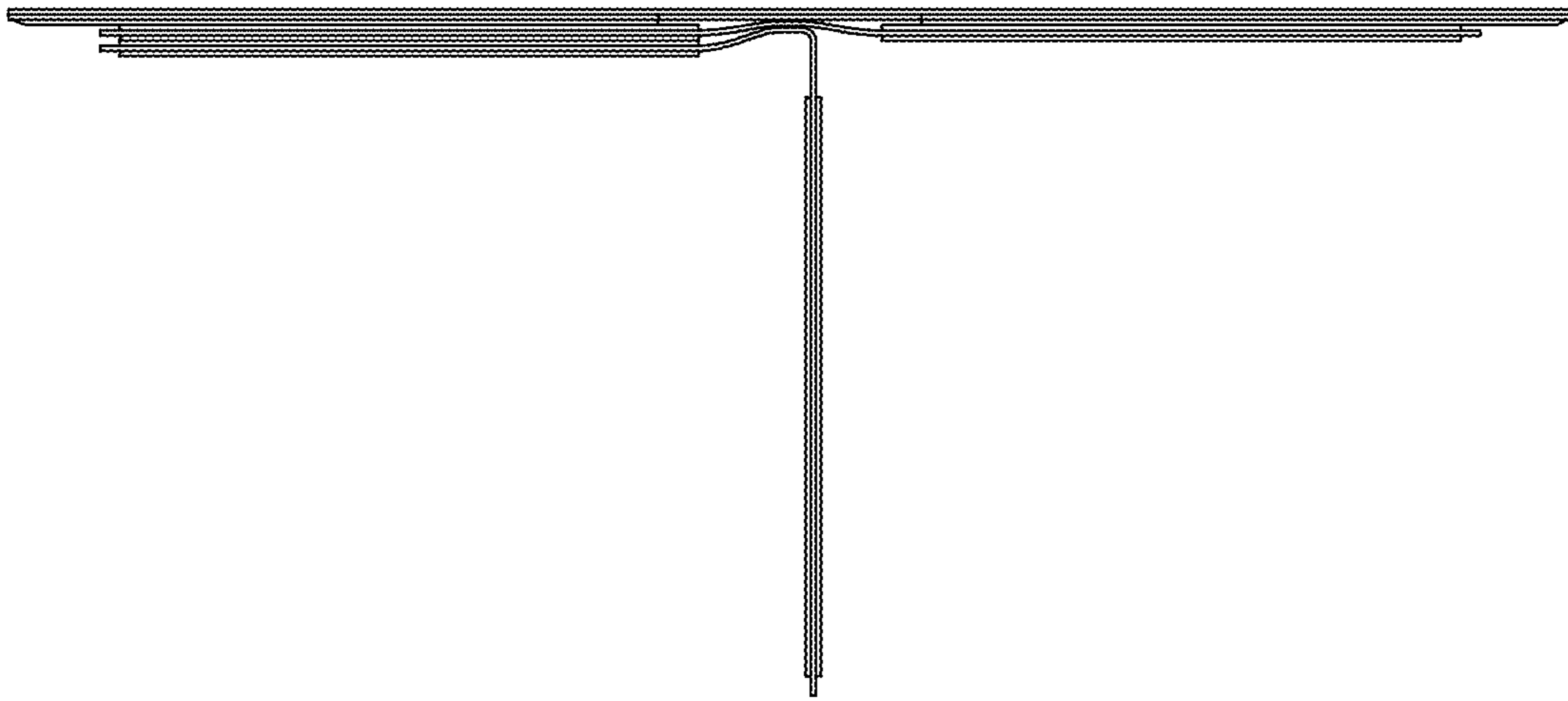

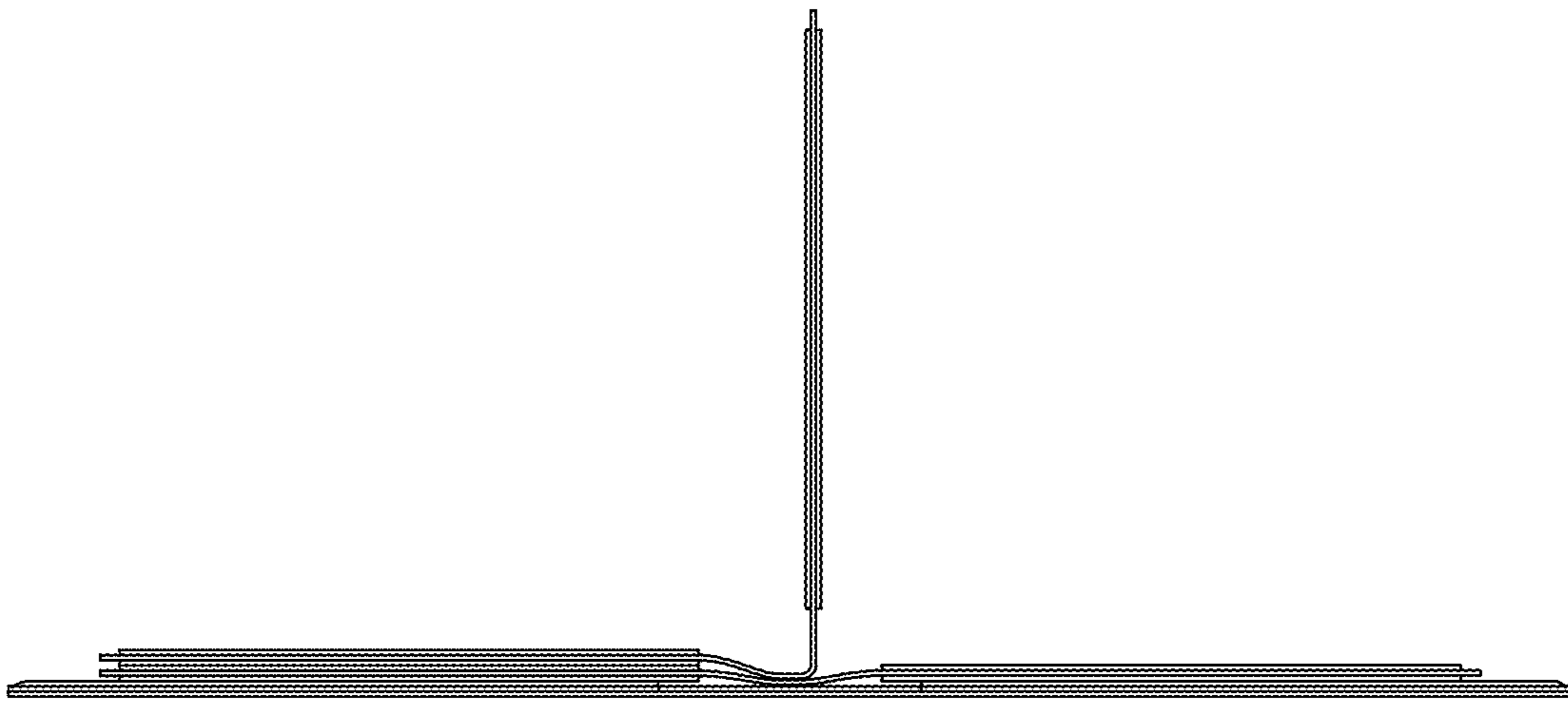

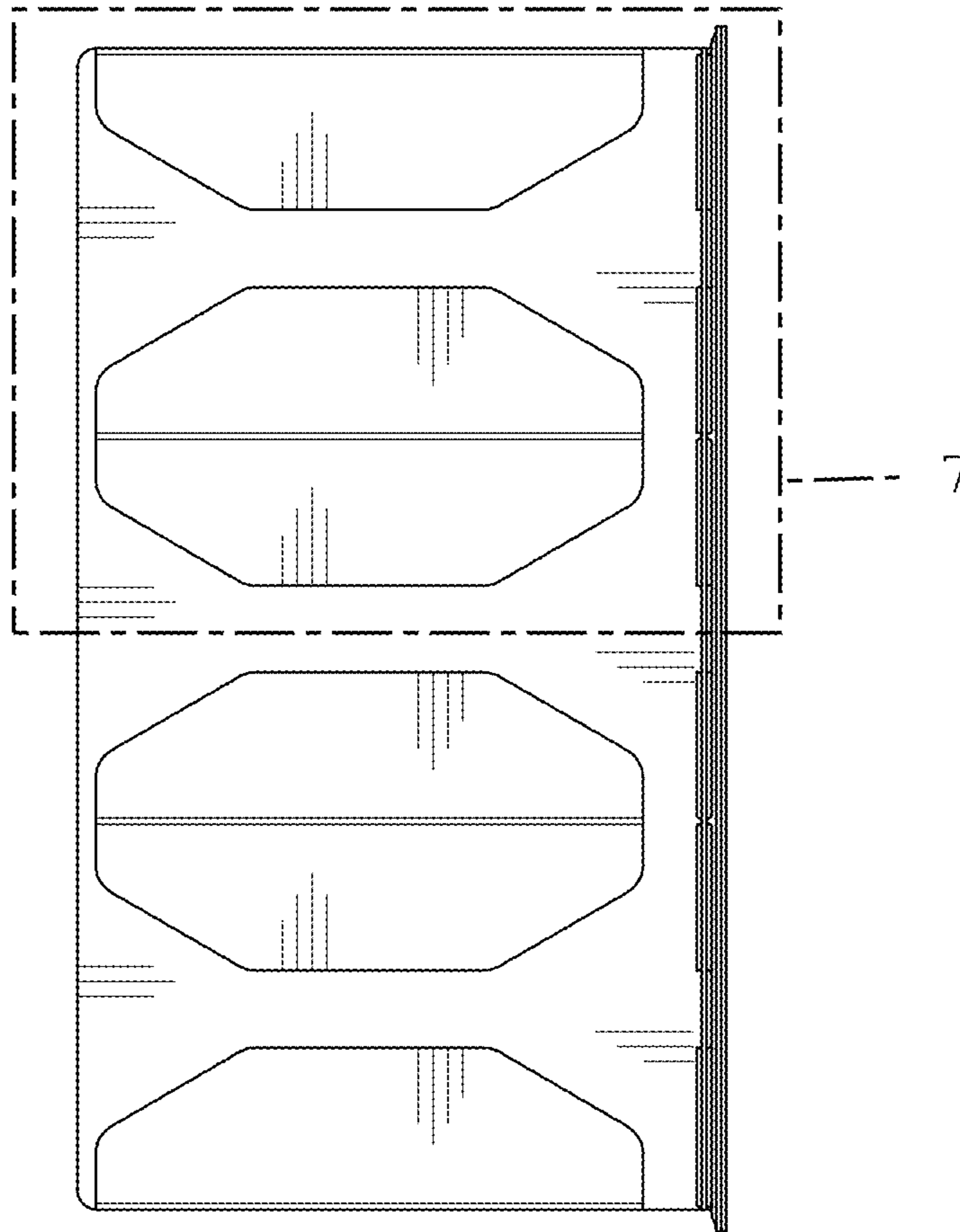

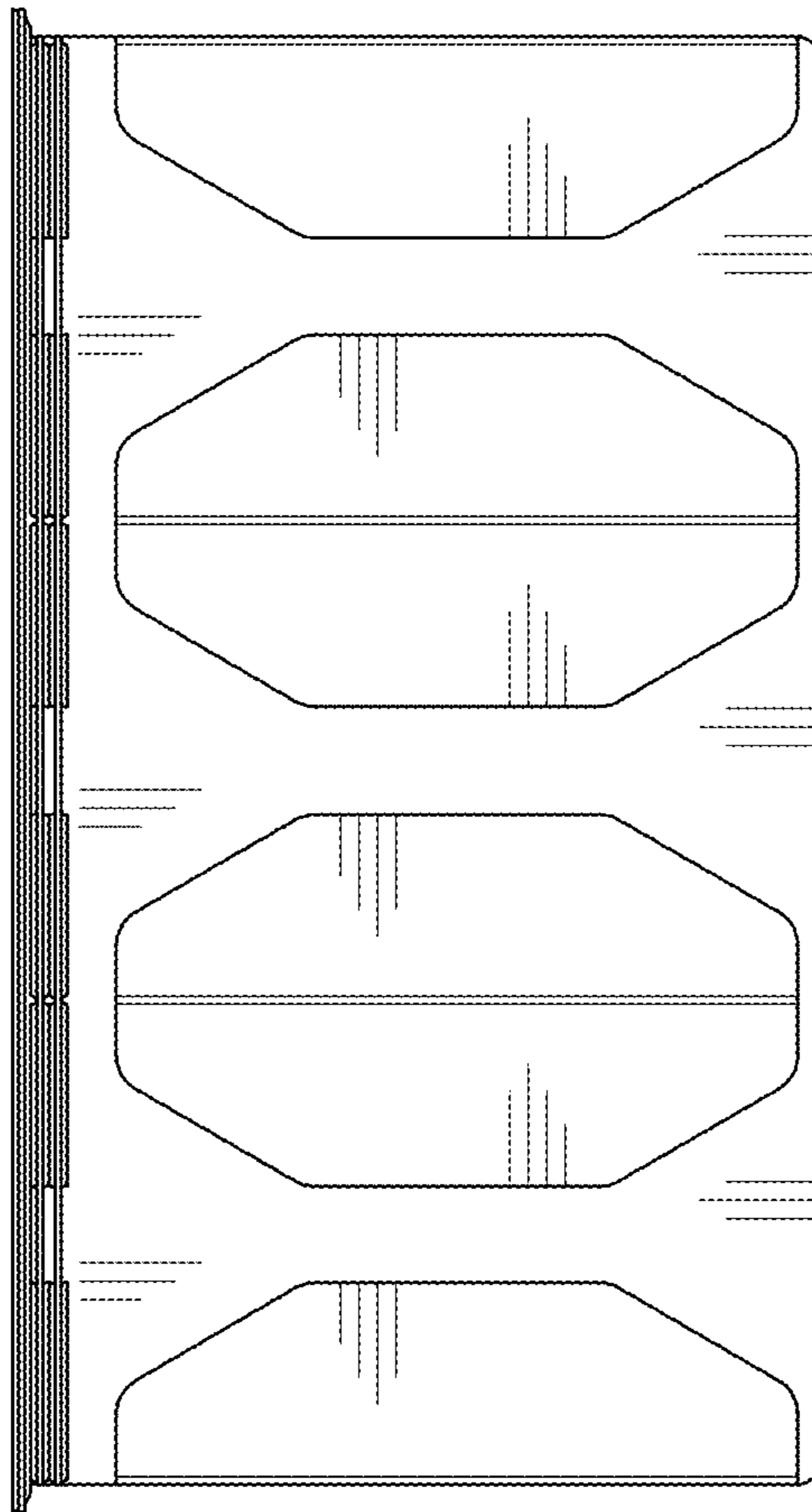

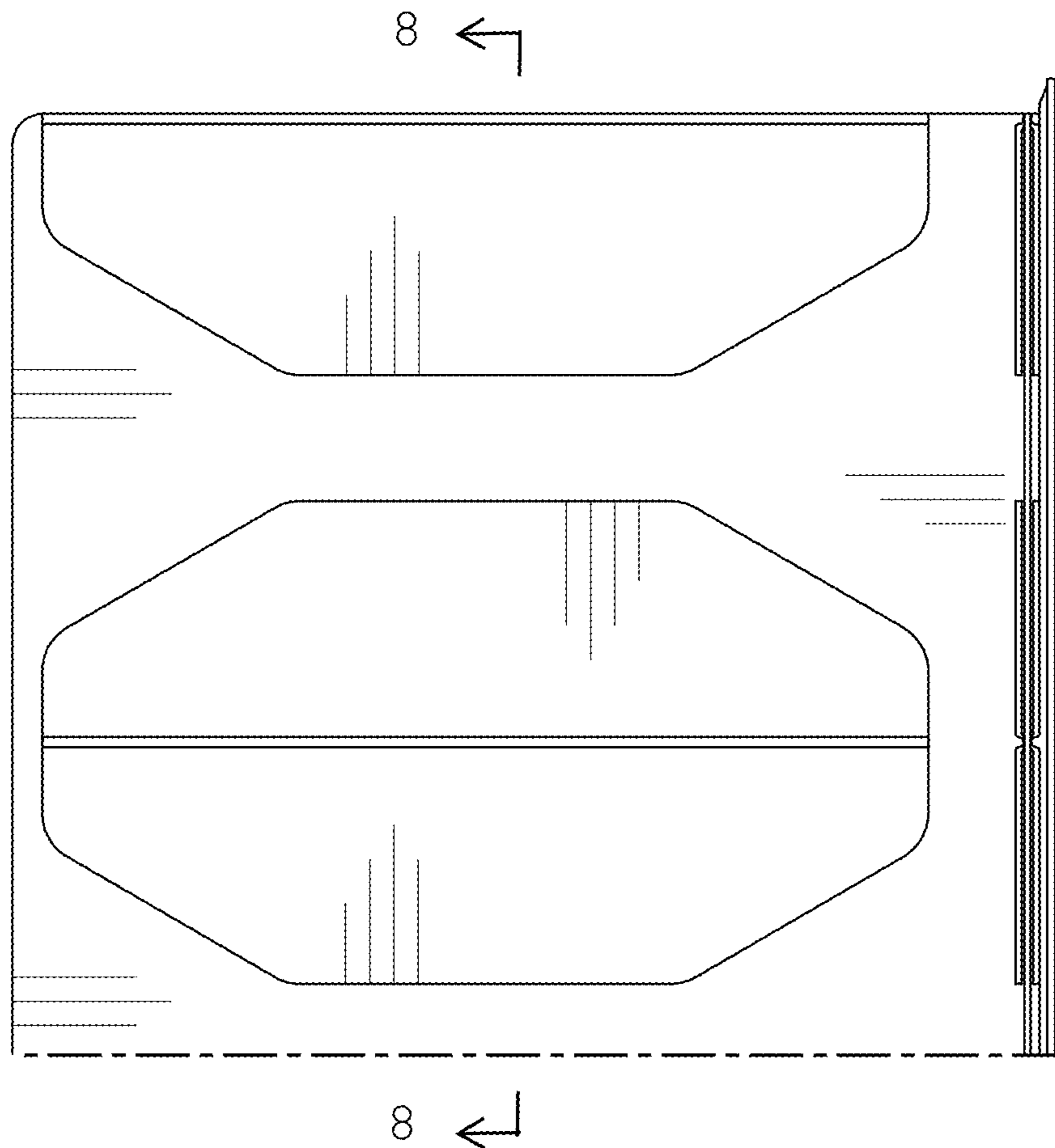

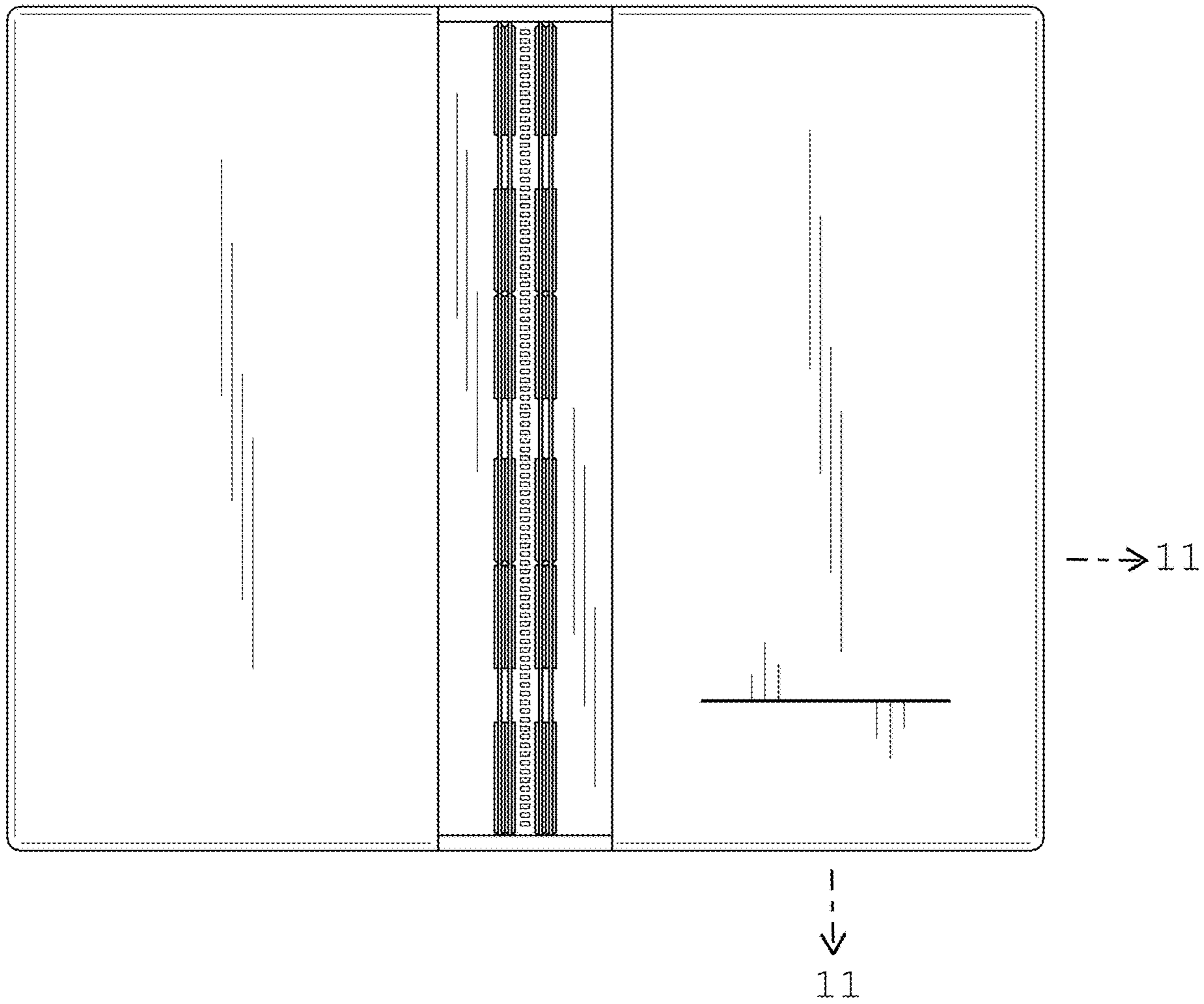
