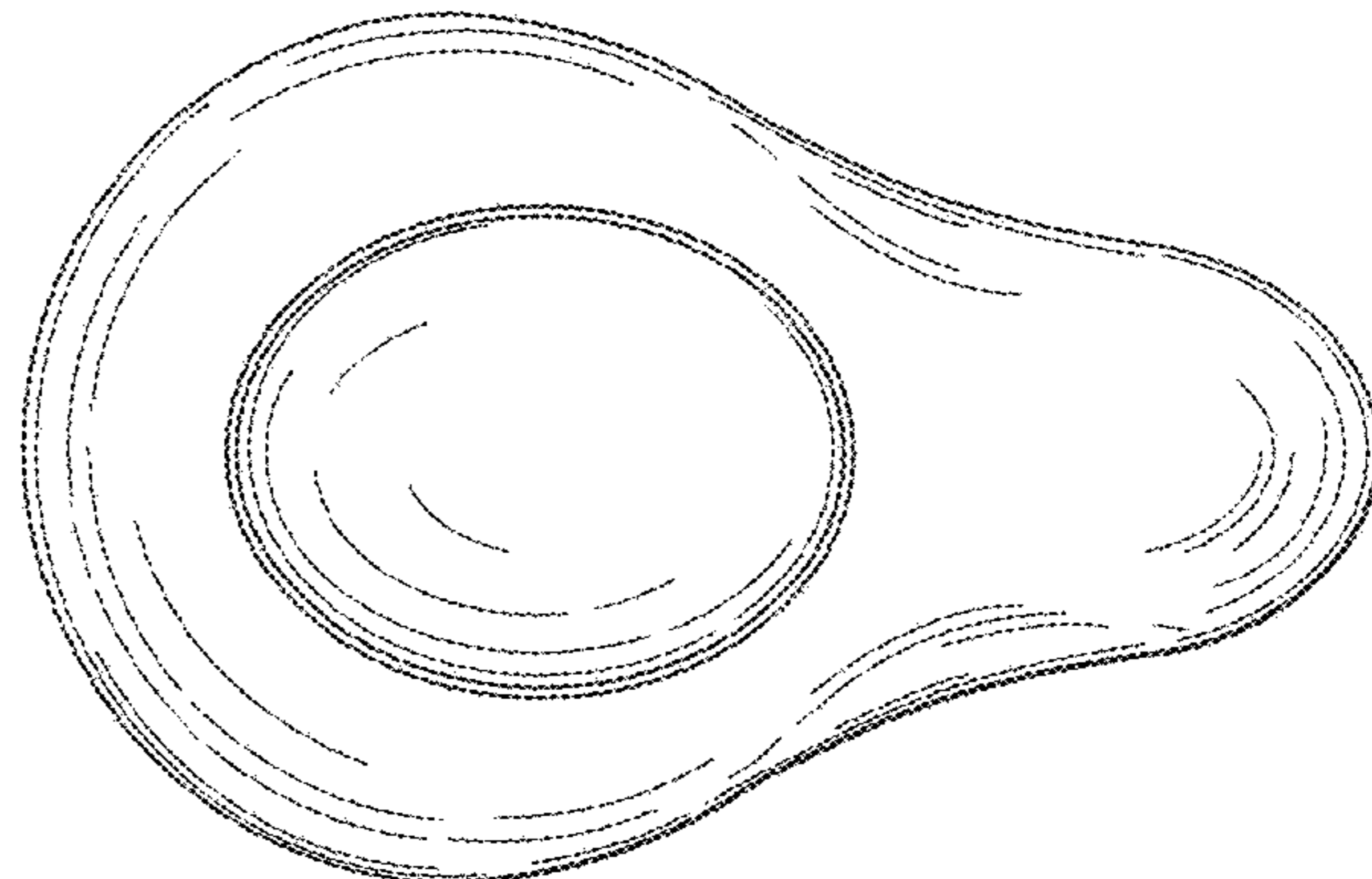
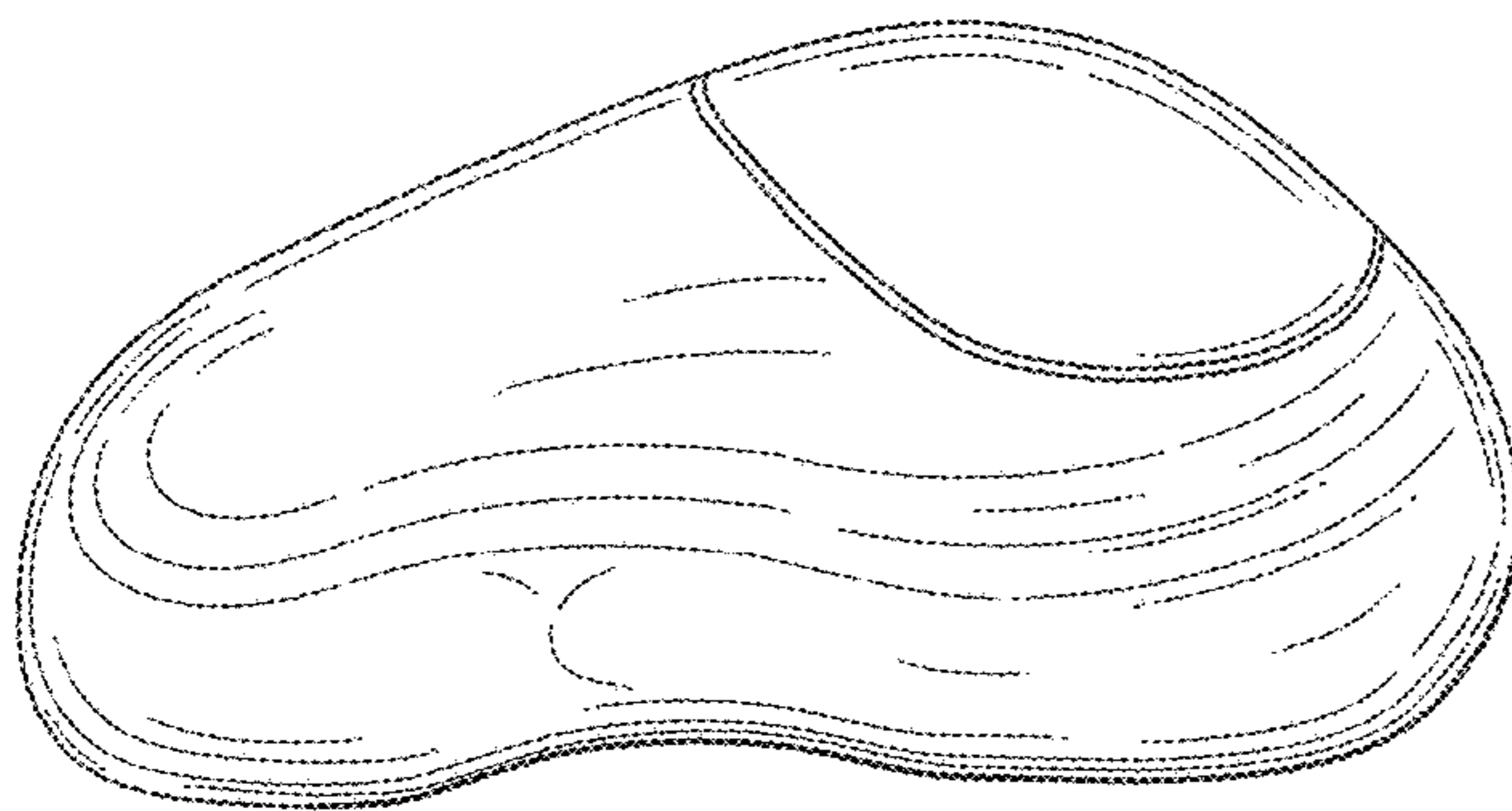
(57) **CLAIM**

The ornamental design for a lactation breast massager, as shown and described.

DESCRIPTION

FIG. 1 is a front, side, and top perspective view of a lactation breast massager showing my new design;
FIG. 2 is an elevation view thereof from the side opposite that in FIG. 1;
FIG. 3 is an elevation view thereof from the same side as in FIG. 1;
FIG. 4 is a front elevation view thereof;
FIG. 5 is a rear elevation view thereof;

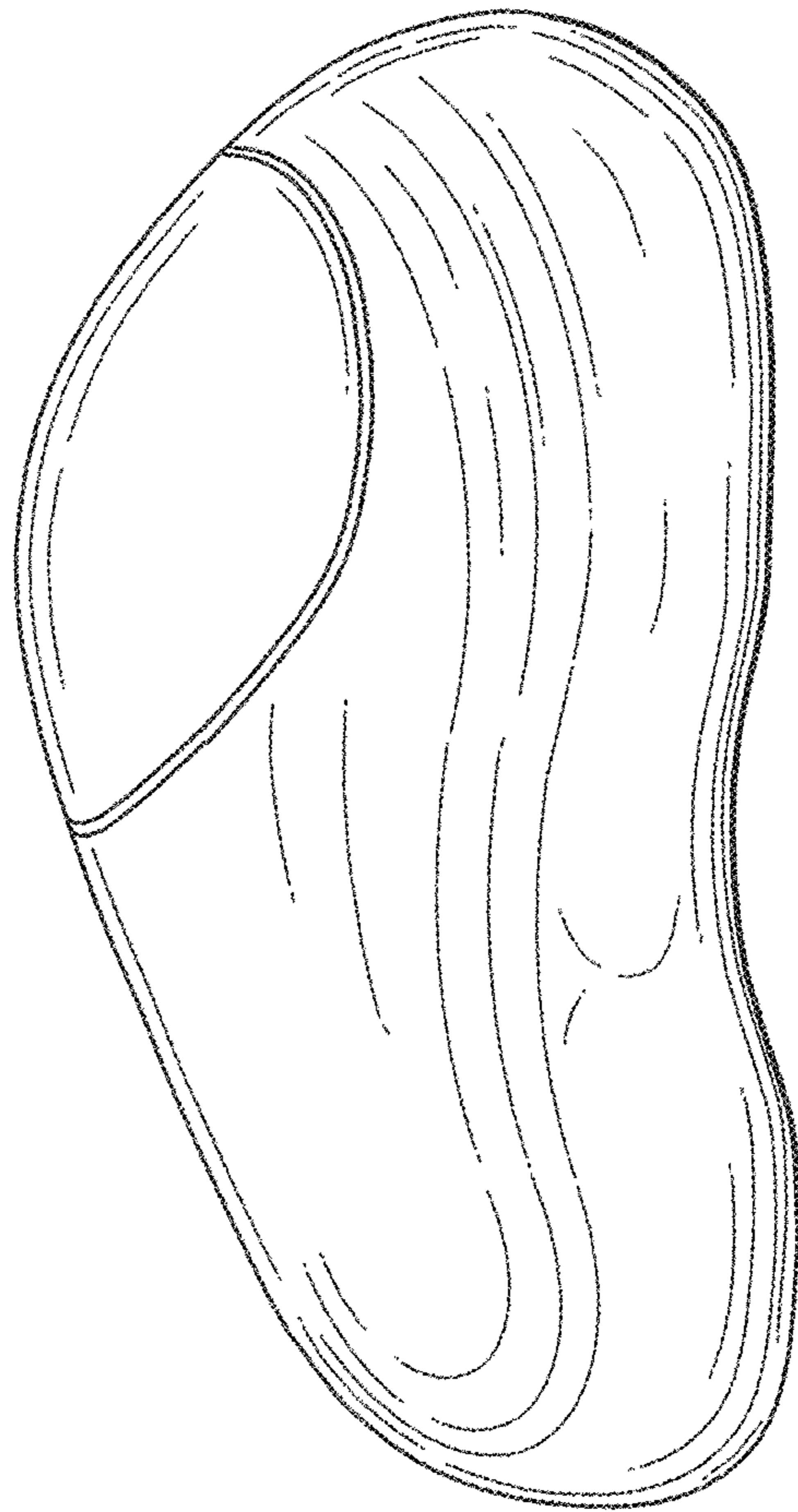

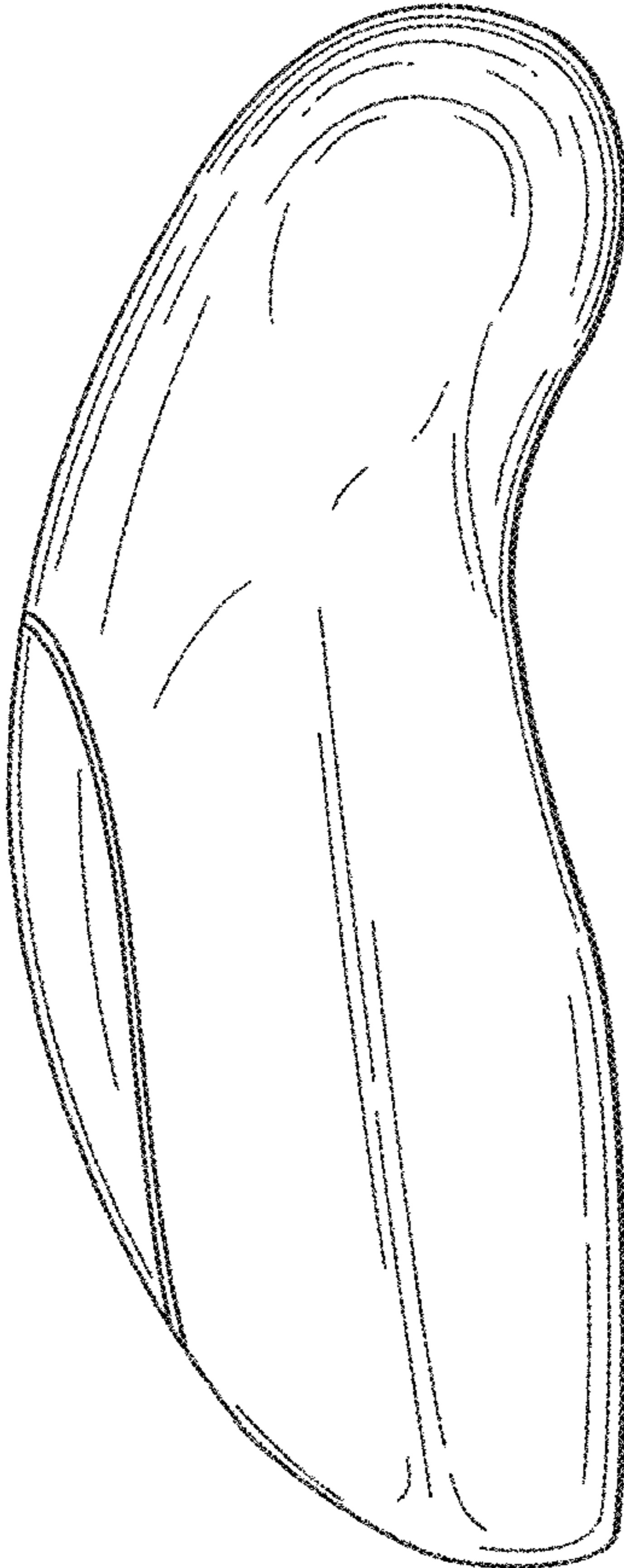

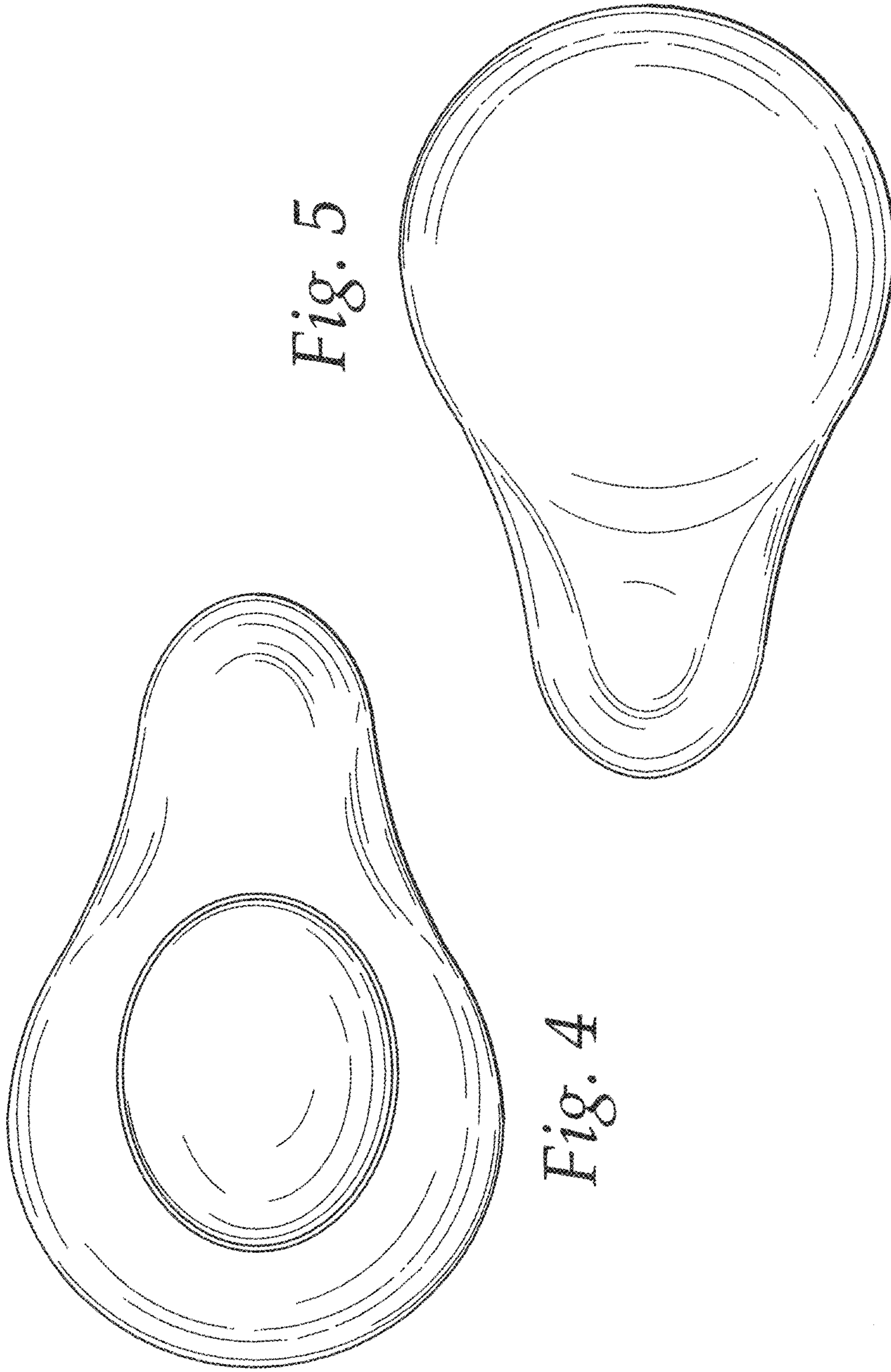

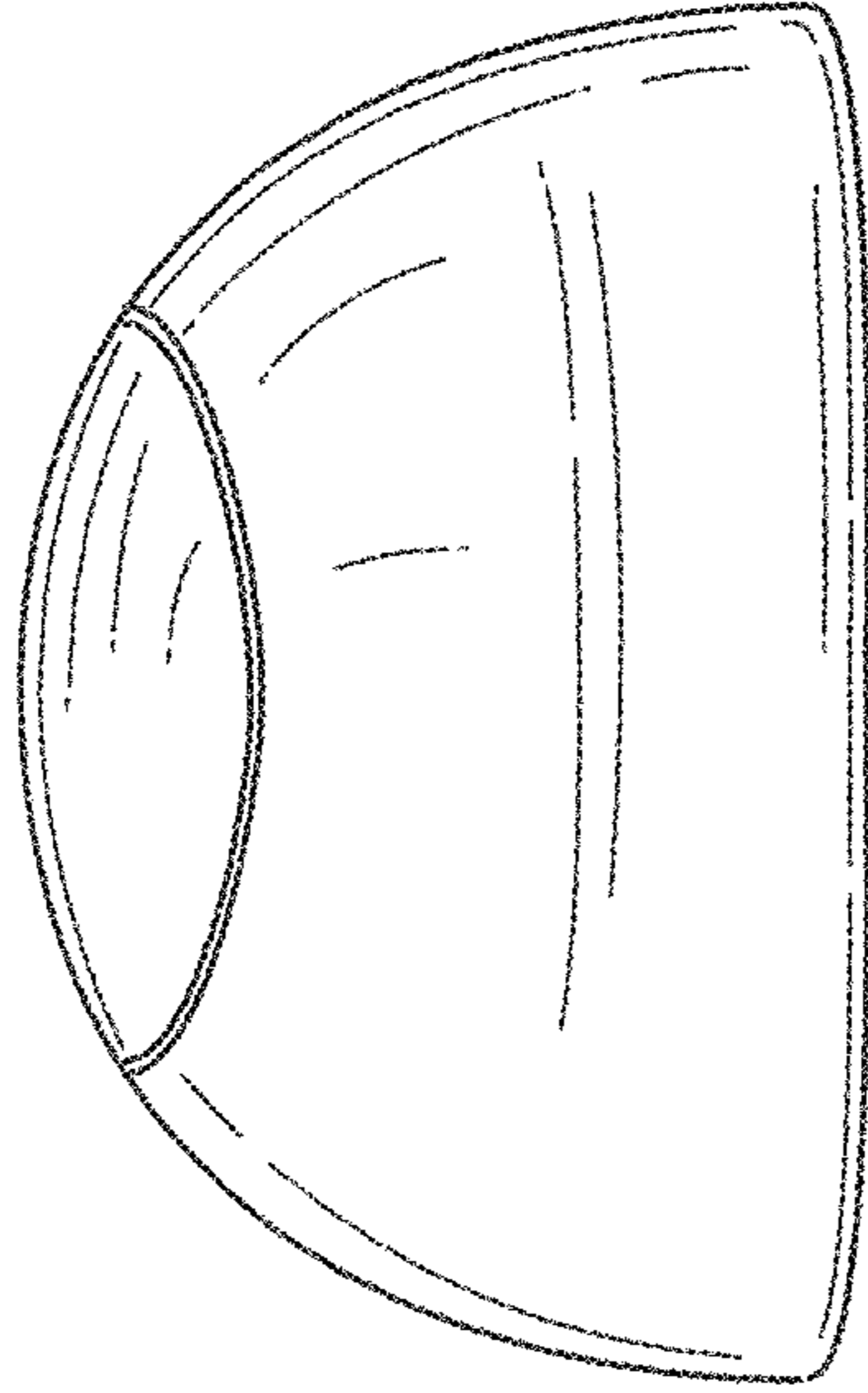

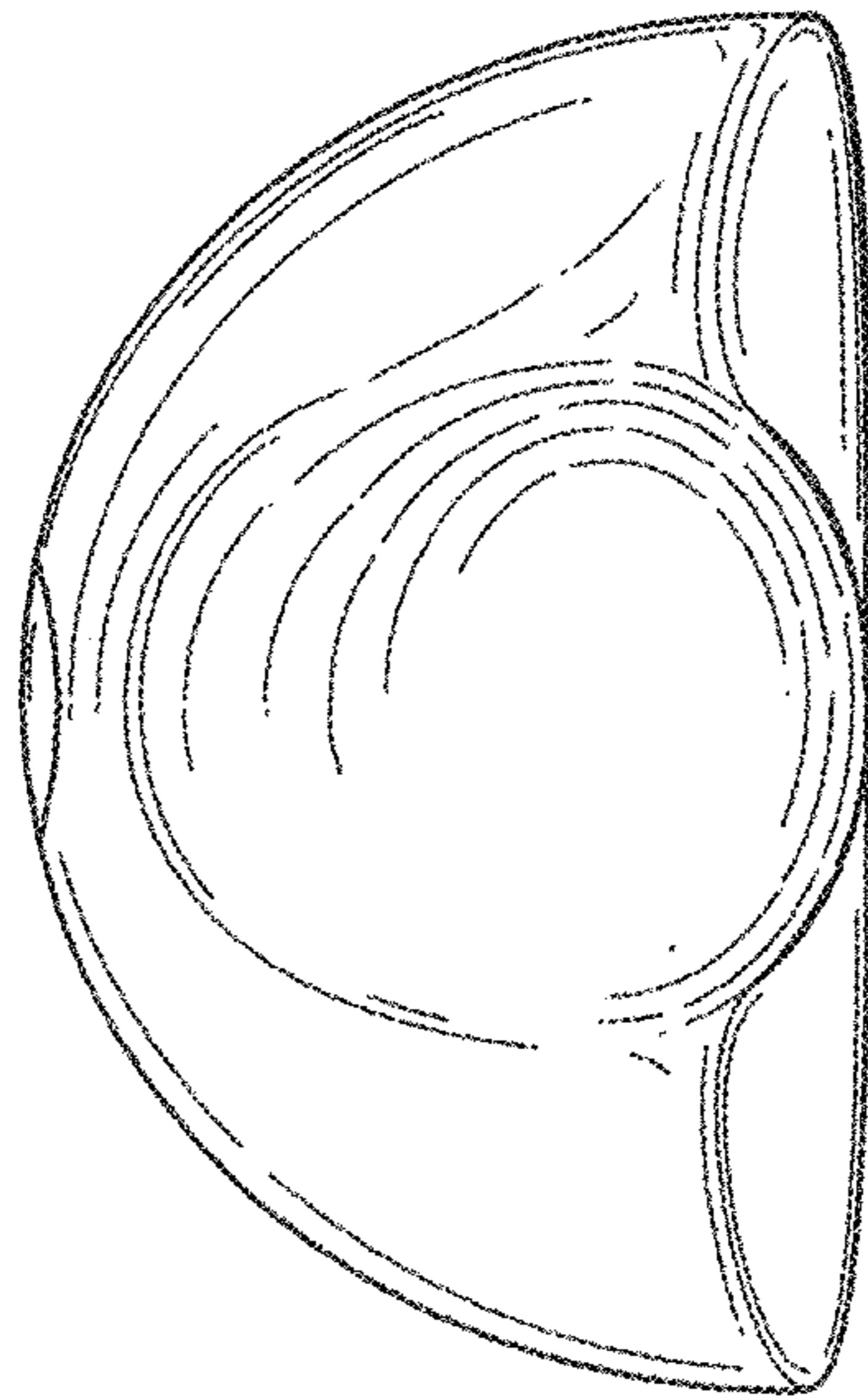
