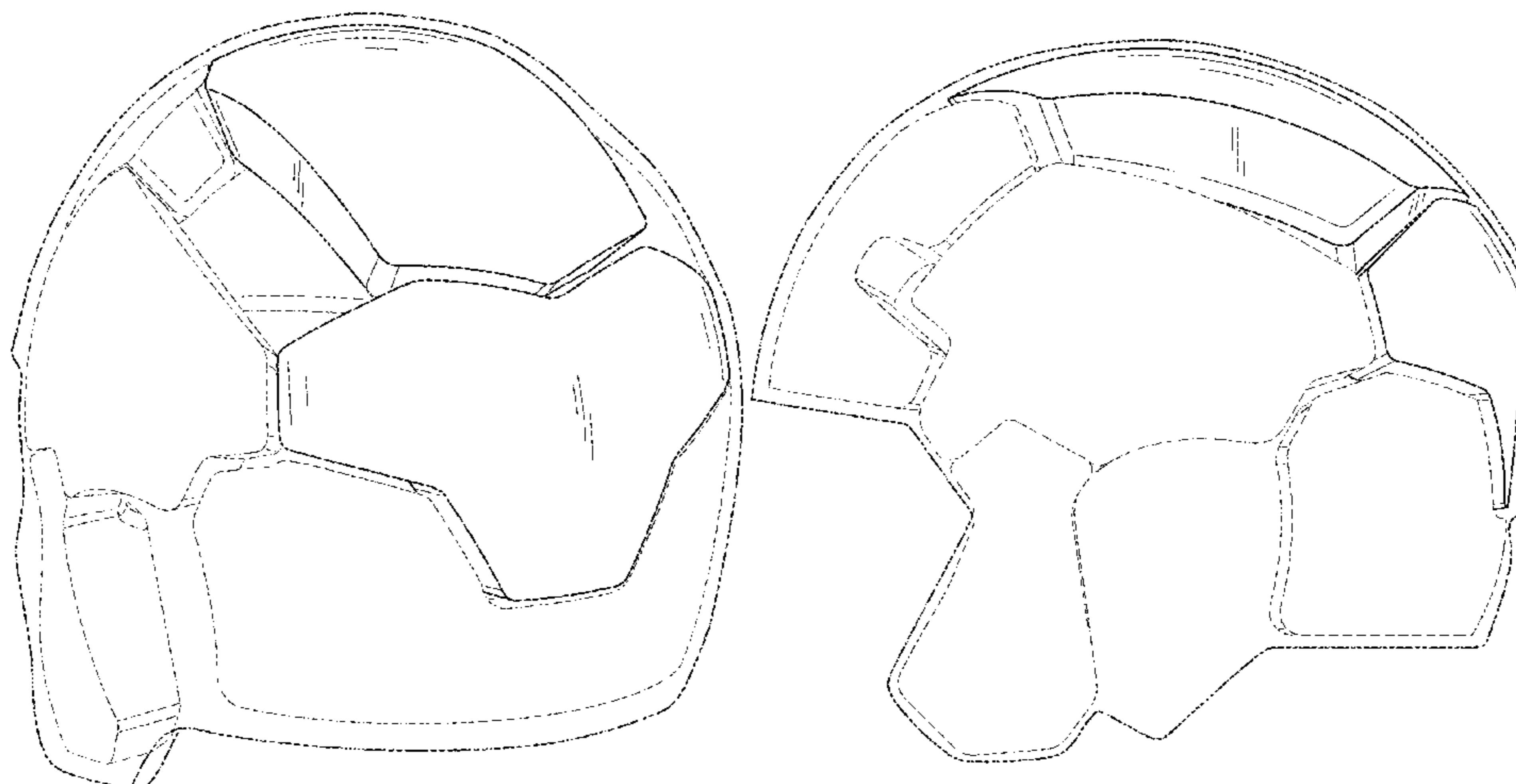

(57) CLAIM

We claim the ornamental design for an internal padding assembly of a protective sports helmet, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of an internal padding assembly of a protective sports helmet showing our new design.
FIG. 2 is a rear perspective view of the internal padding assembly of the protective sports helmet of FIG. 1.
FIG. 3 is a bottom perspective view of the internal padding assembly of the protective sports helmet of FIG. 1.
FIG. 4 is a front view of the internal padding assembly of the protective sports helmet of FIG. 1.
FIG. 5 is a rear view of the internal padding assembly of the protective sports helmet of FIG. 1.
FIG. 6 is a left side view of the internal padding assembly of the protective sports helmet of FIG. 1.
FIG. 7 is a right side view of the internal padding assembly of the protective sports helmet of FIG. 1.
FIG. 8 is a top view of the internal padding assembly of the protective sports helmet of FIG. 1.
FIG. 9 is a bottom view of the internal padding assembly of the protective sports helmet of FIG. 1.
FIG. 10 is a front perspective view of a second embodiment of an internal padding assembly of a protective sports helmet showing our new design.
FIG. 11 is a rear perspective view of the internal padding assembly of the protective sports helmet of FIG. 10.
FIG. 12 is a bottom perspective view of the internal padding assembly of the protective sports helmet of FIG. 10.
FIG. 13 is a front view of the internal padding assembly of the protective sports helmet of FIG. 10.
FIG. 14 is a rear view of the internal padding assembly of the protective sports helmet of FIG. 10.
FIG. 15 is a left side view of the internal padding assembly of the protective sports helmet of FIG. 10.
FIG. 16 is a right side view of the internal padding assembly of the protective sports helmet of FIG. 10.
FIG. 17 is a top view of the internal padding assembly of the protective sports helmet of FIG. 10; and,
FIG. 18 is a bottom view of the internal padding assembly of the protective sports helmet of FIG. 10.
The uneven, dot-dash-dot broken lines (“- — -”) in the Figures depict borders of a helmet shell representing environmental subject matter that forms no part of the claimed design. The even, dotted lines (“- · -”) depict portions of the internal padding assembly of a protective sports helmet that form no part of the claimed design. Moreover, any shading presented in the accompanying drawings is provided merely

to highlight the contour of the invention and is not intended to be illustrative of texture or gloss.

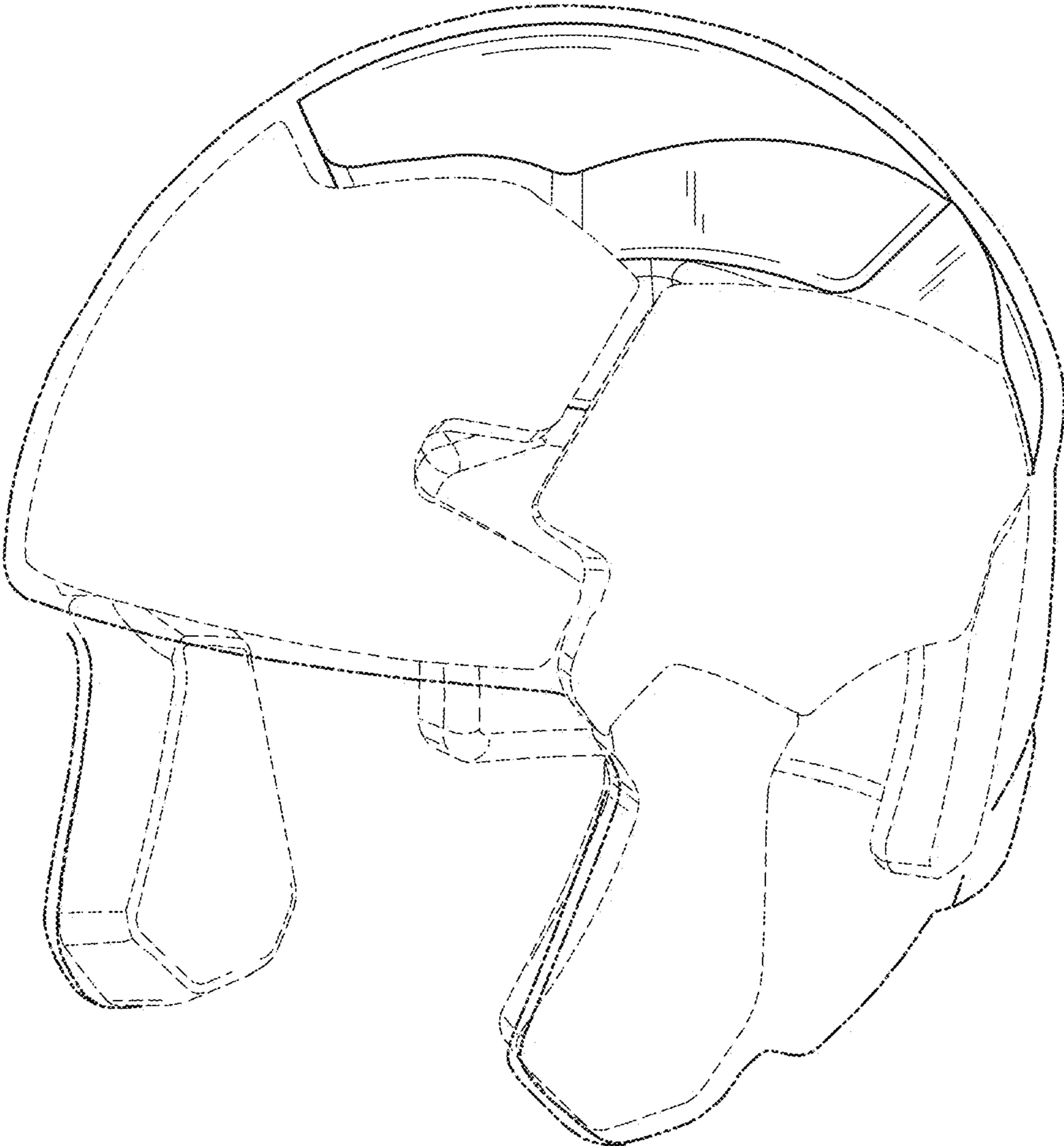

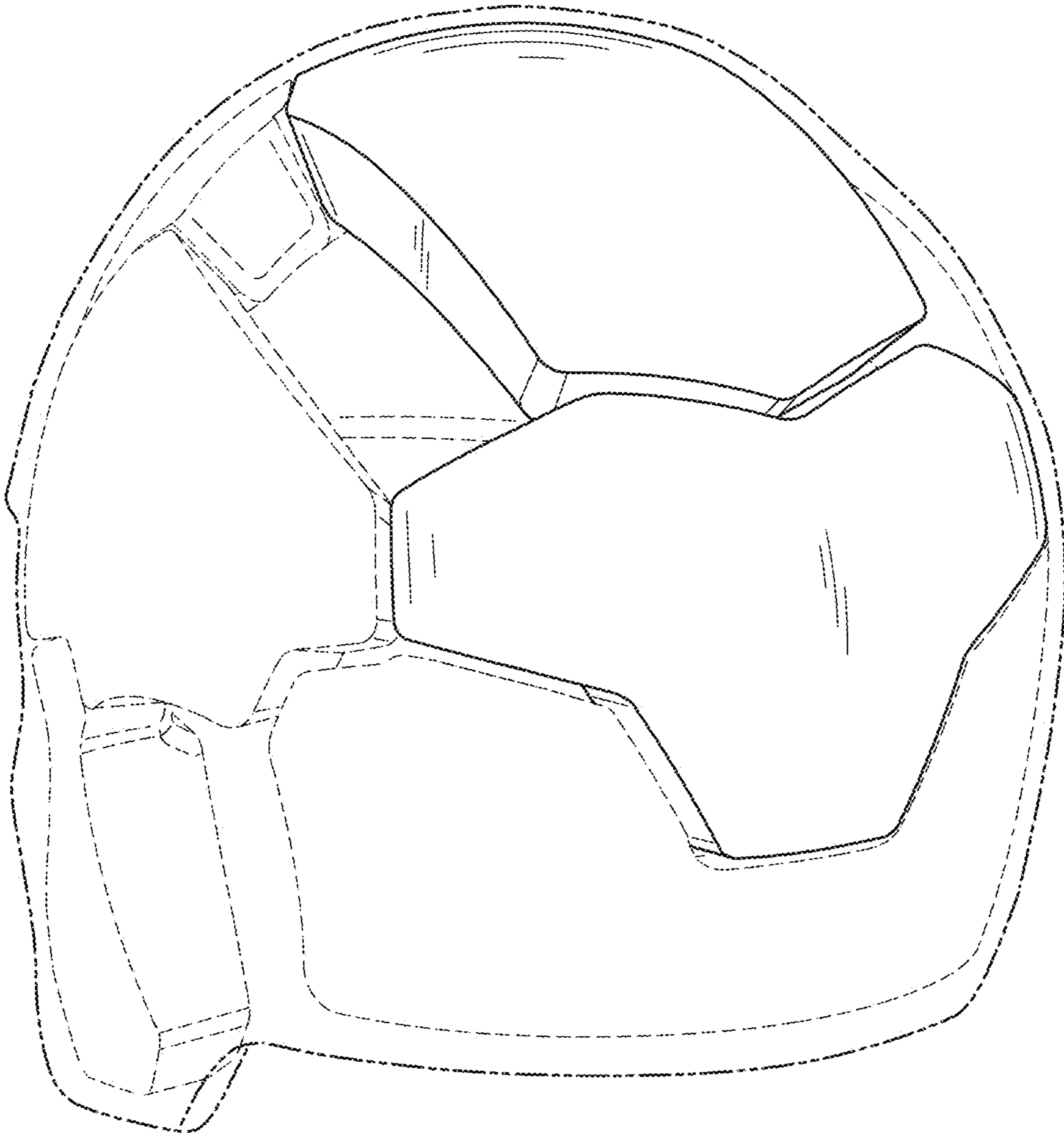

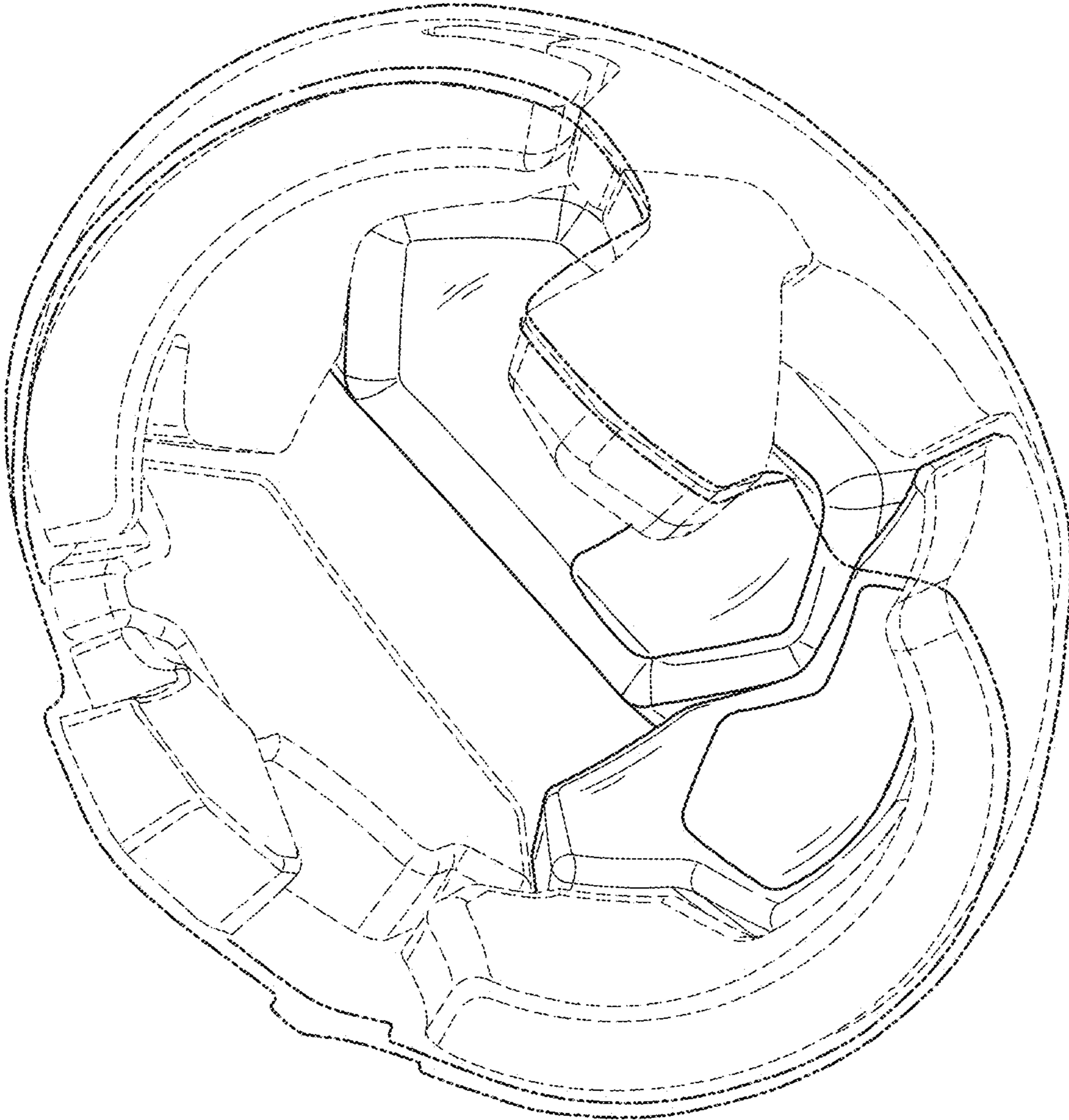

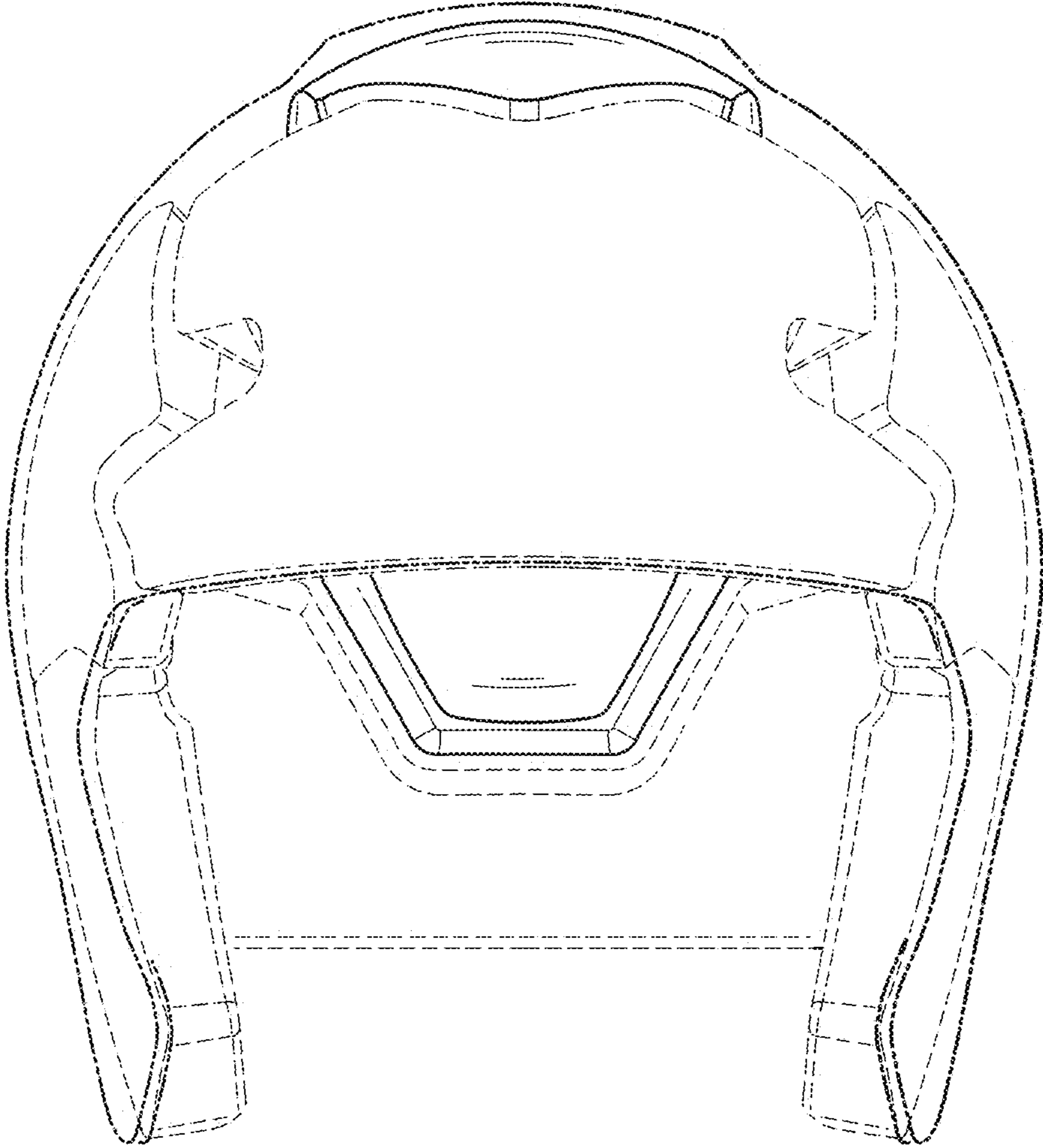

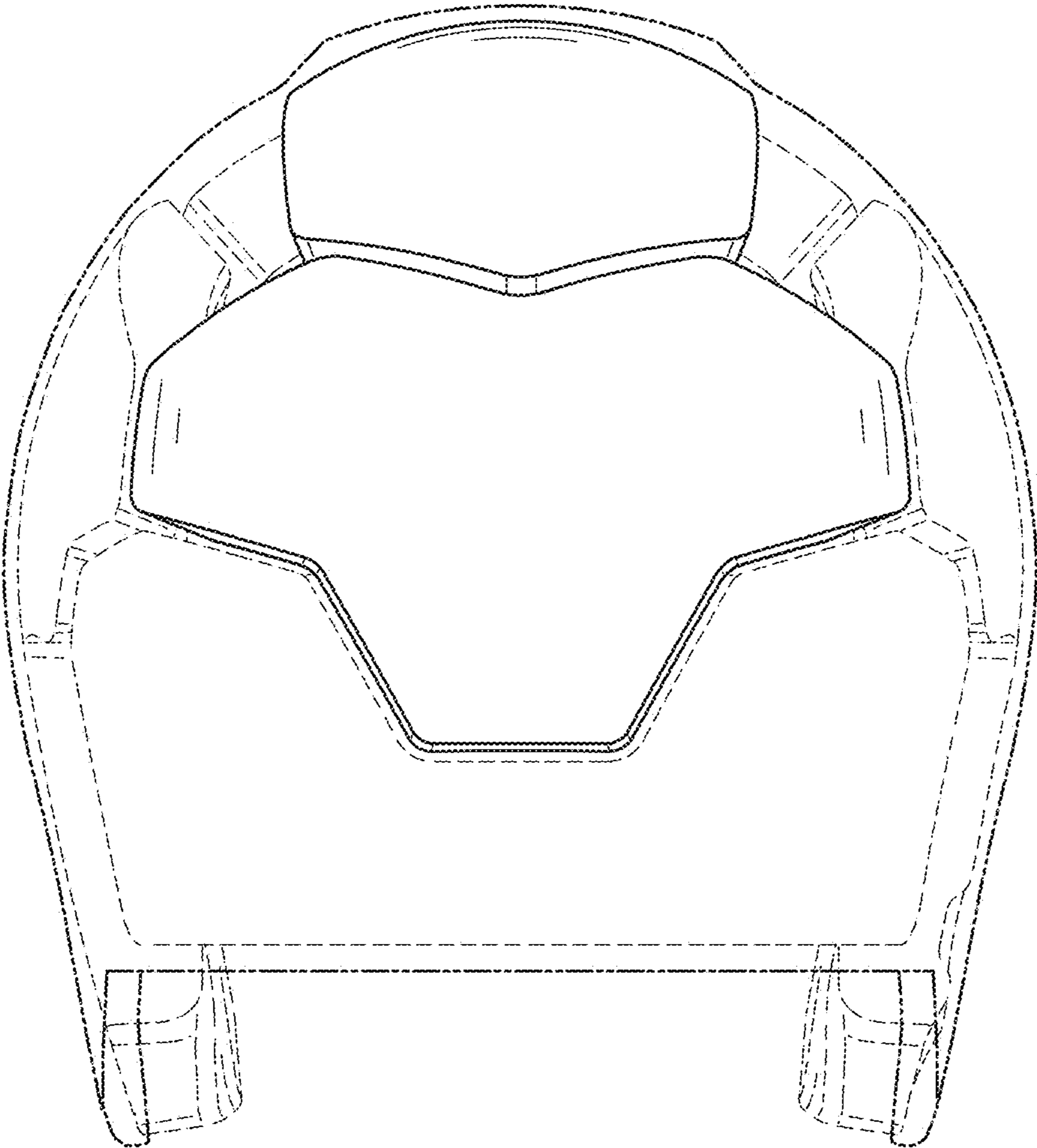

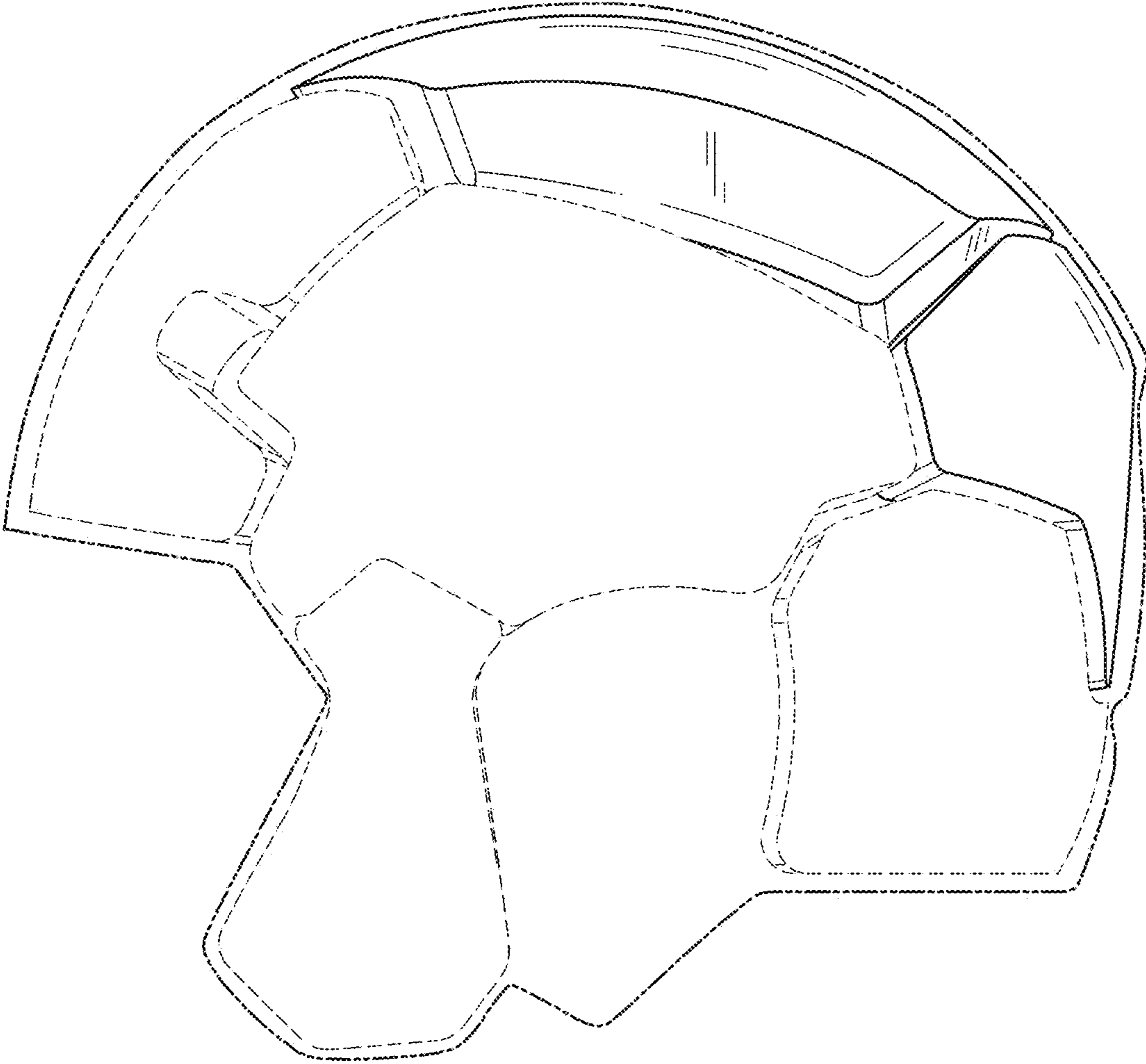

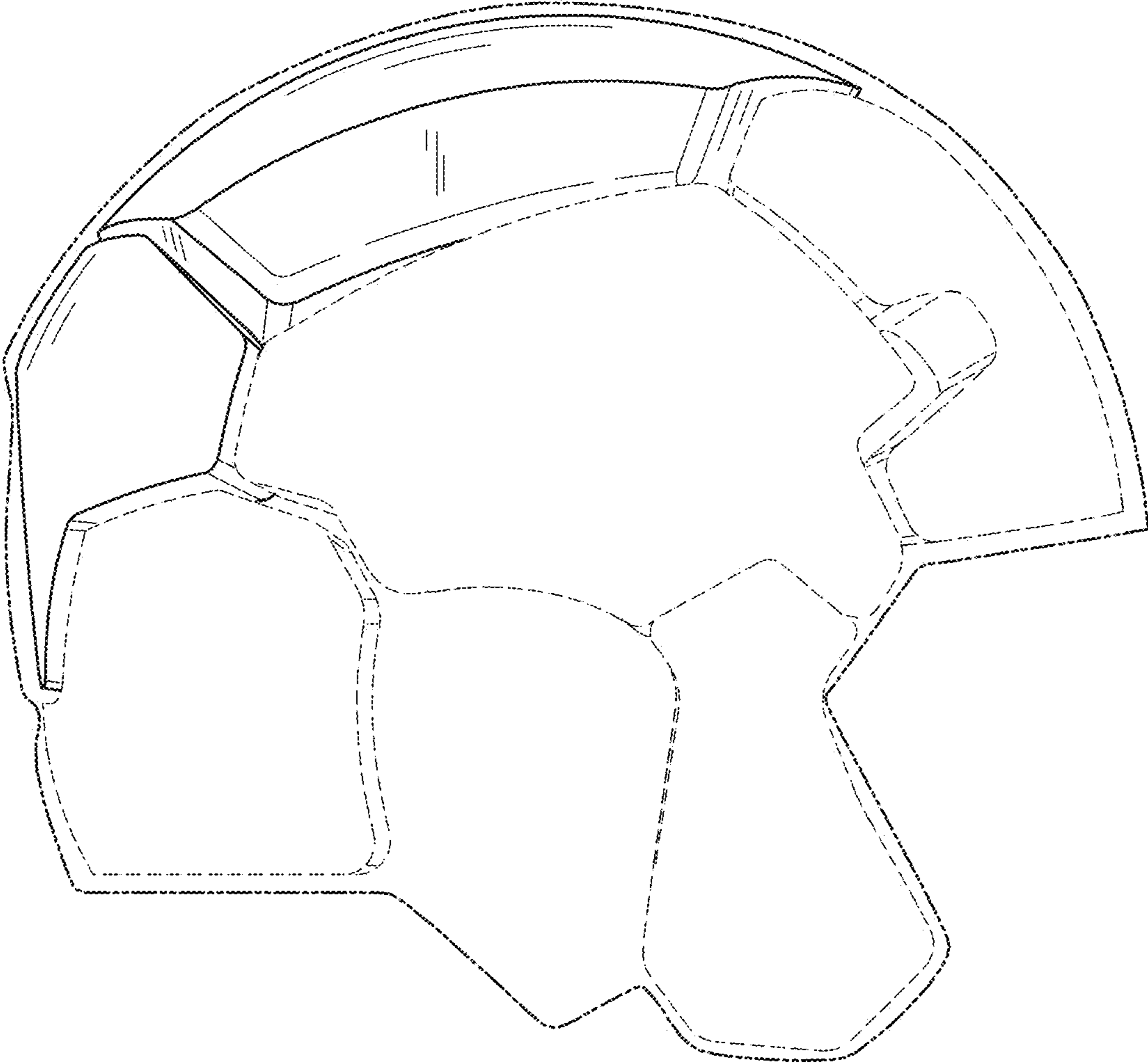

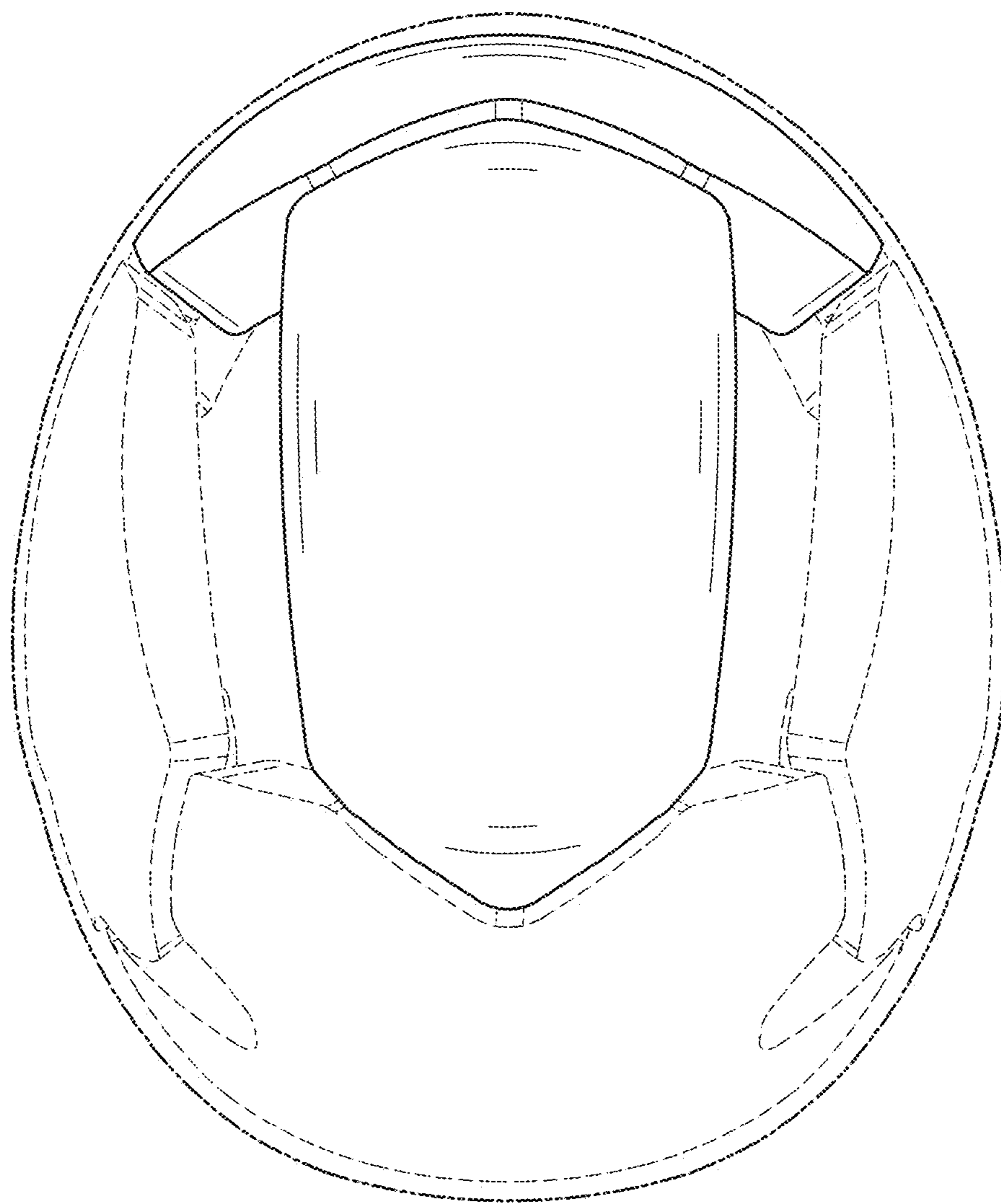

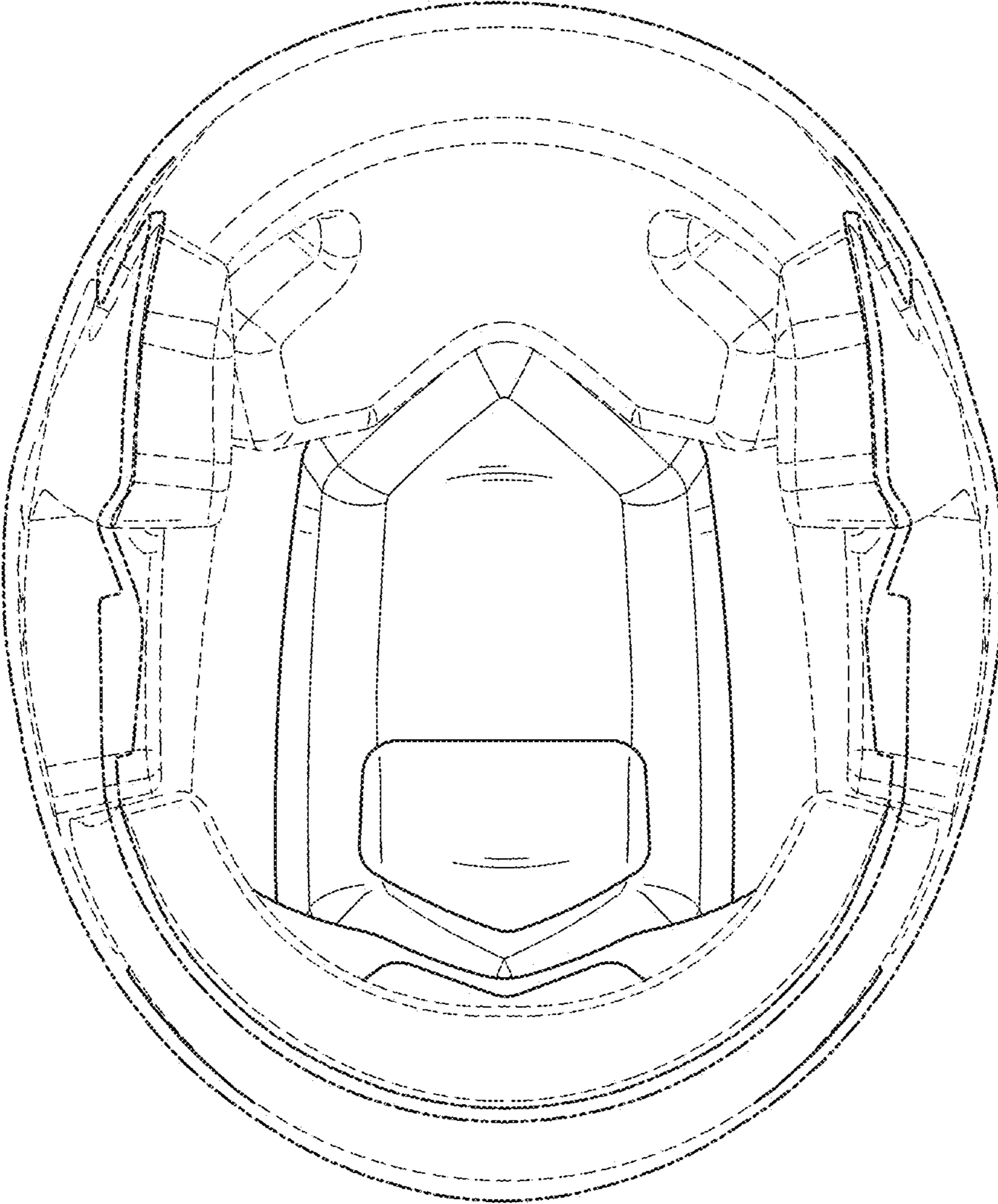

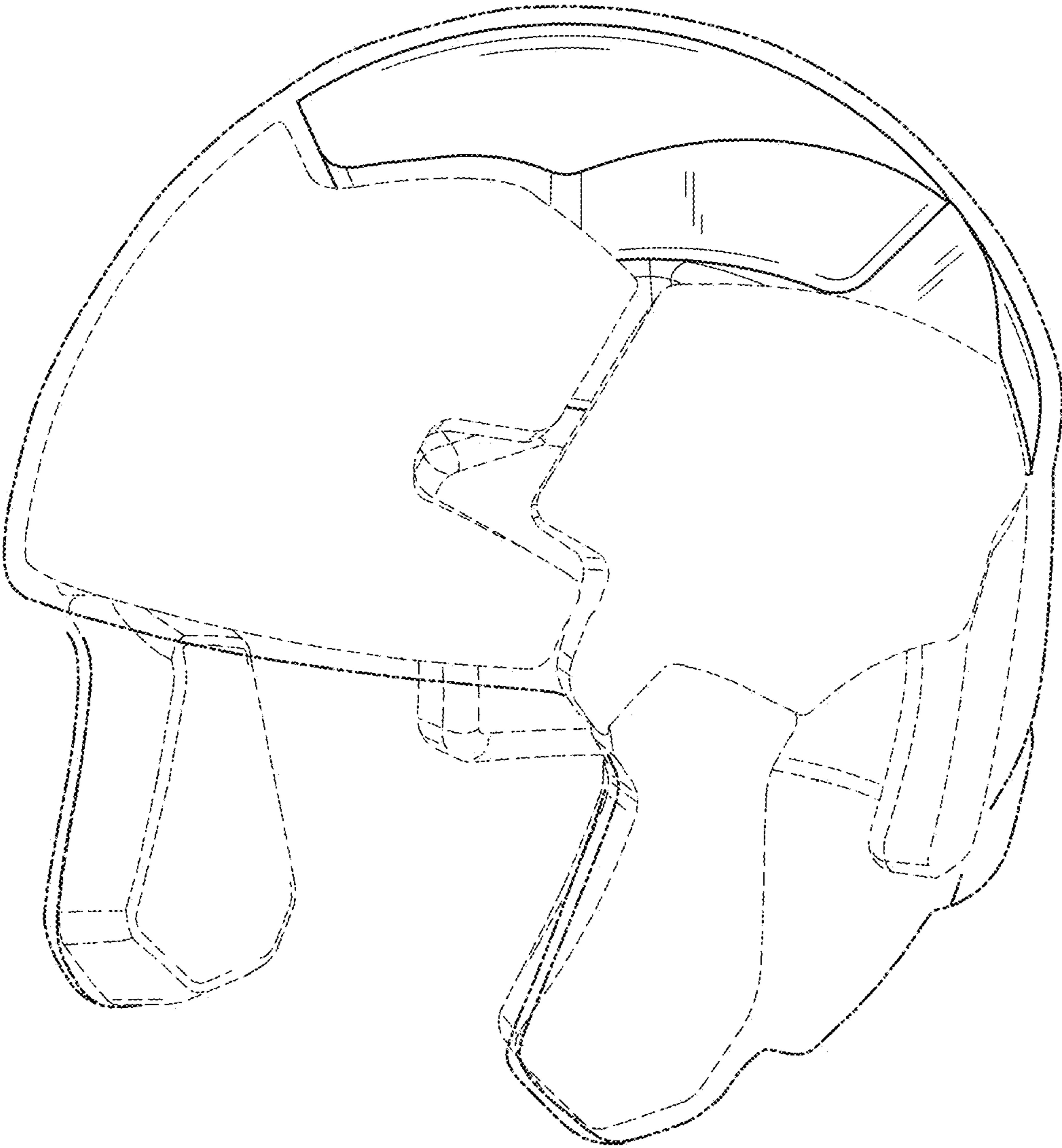

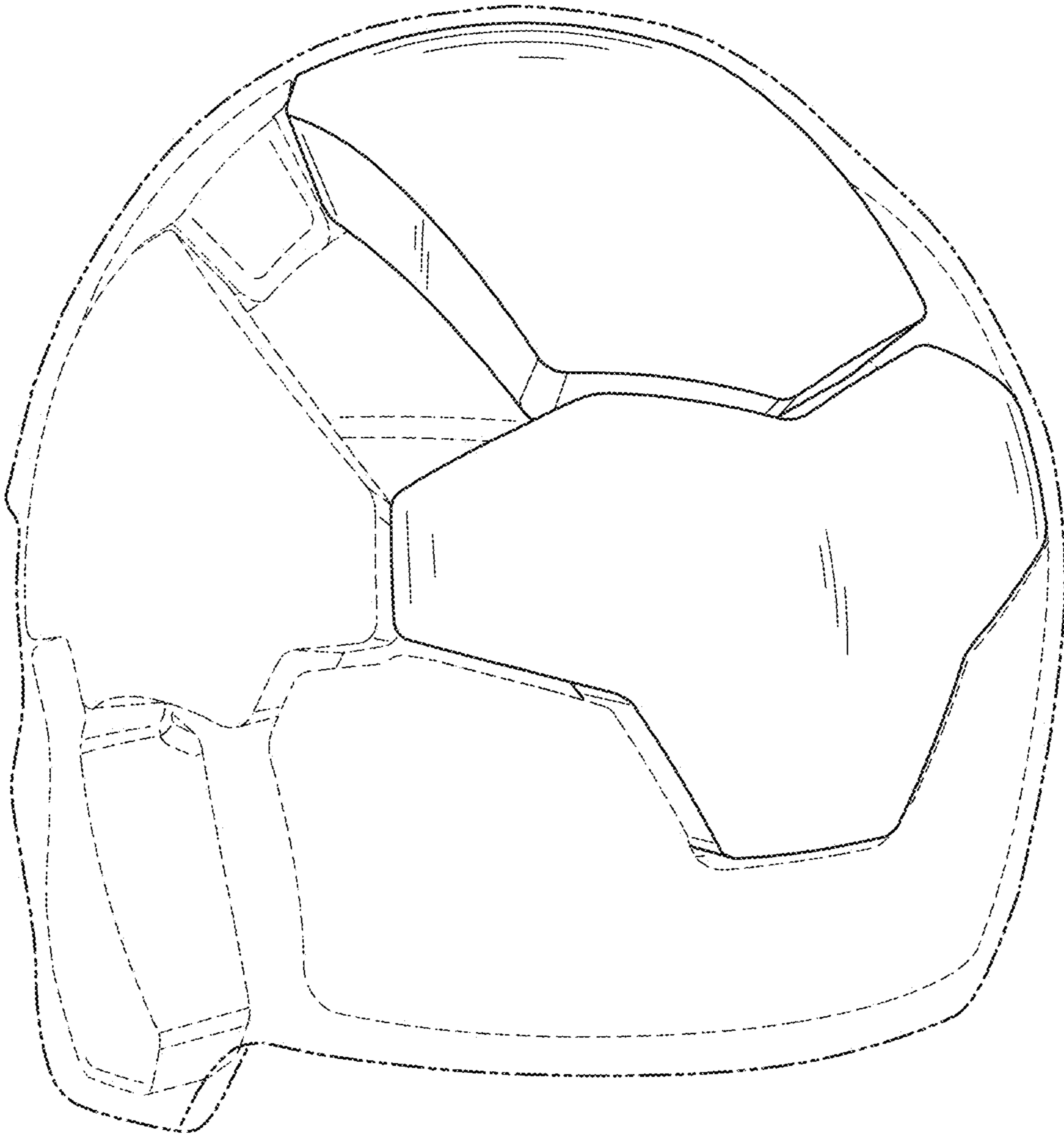

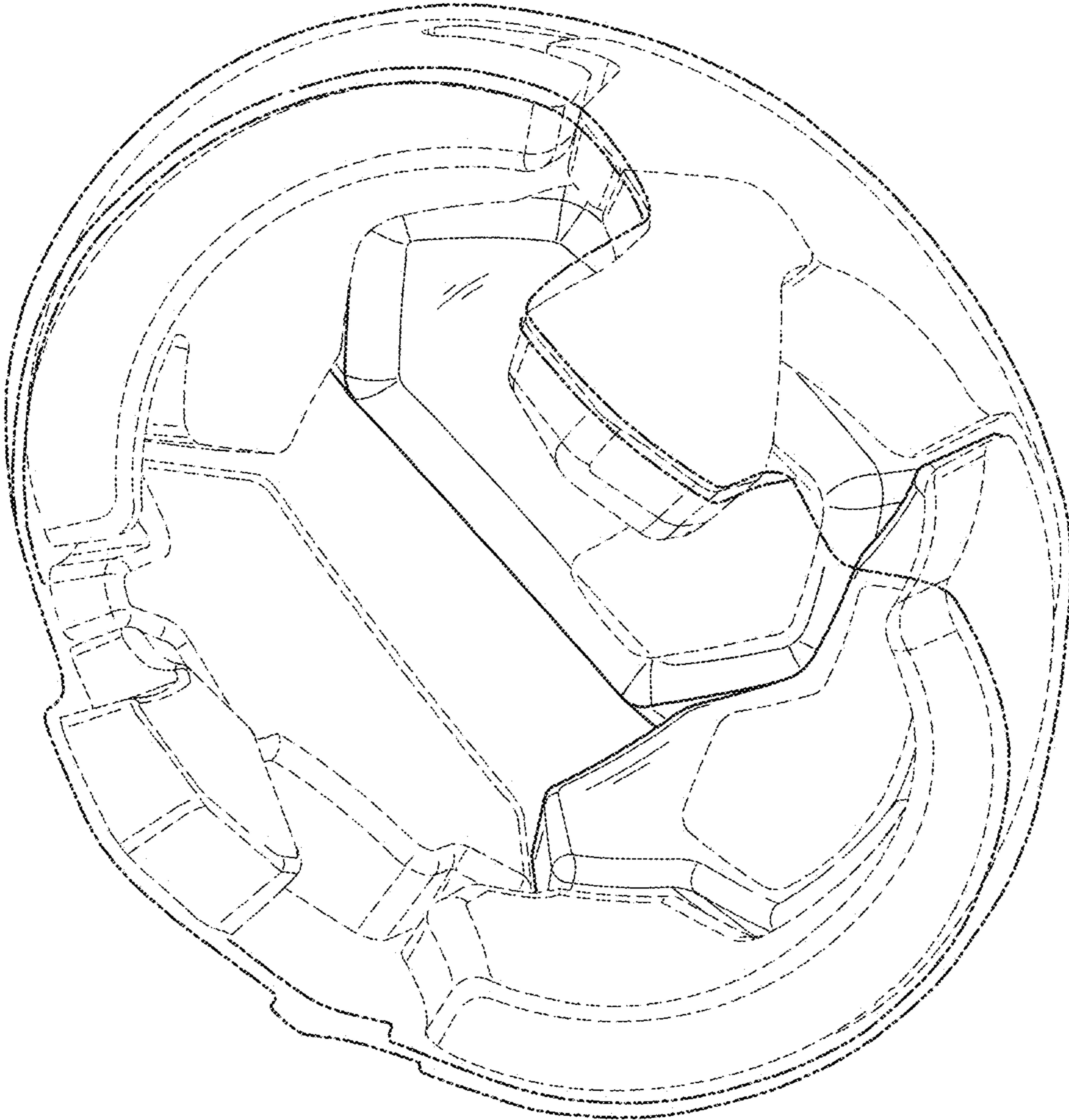

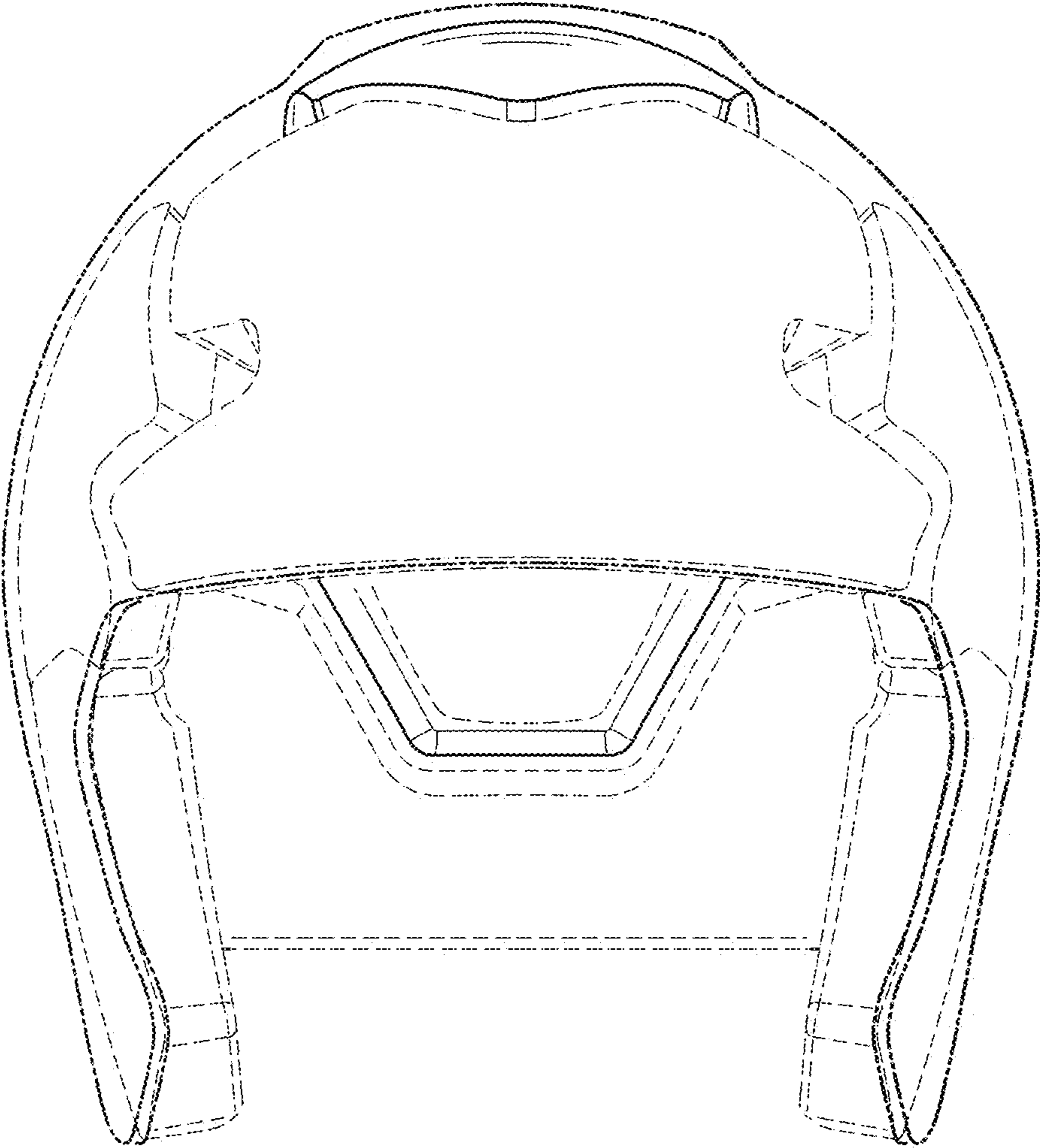

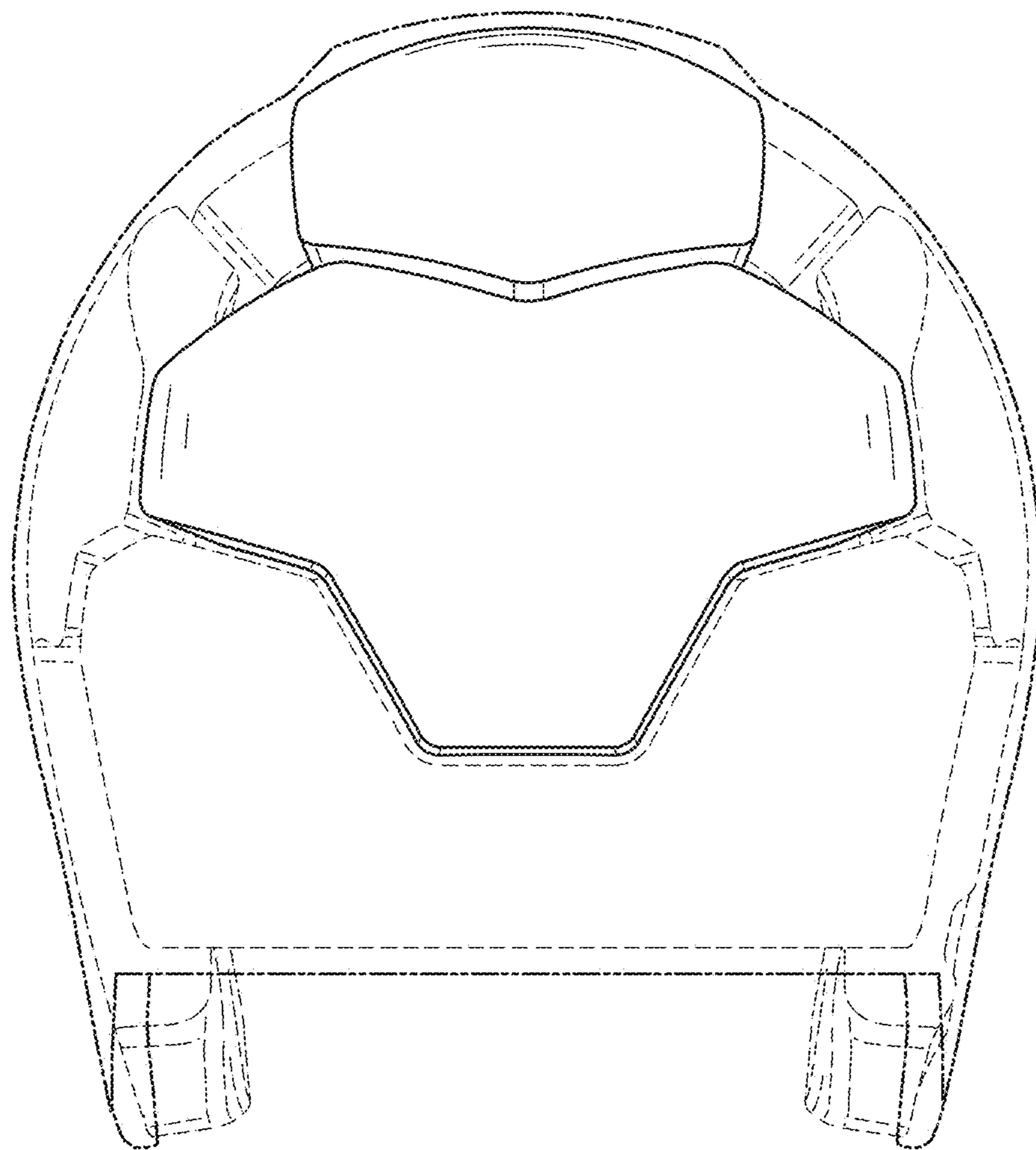

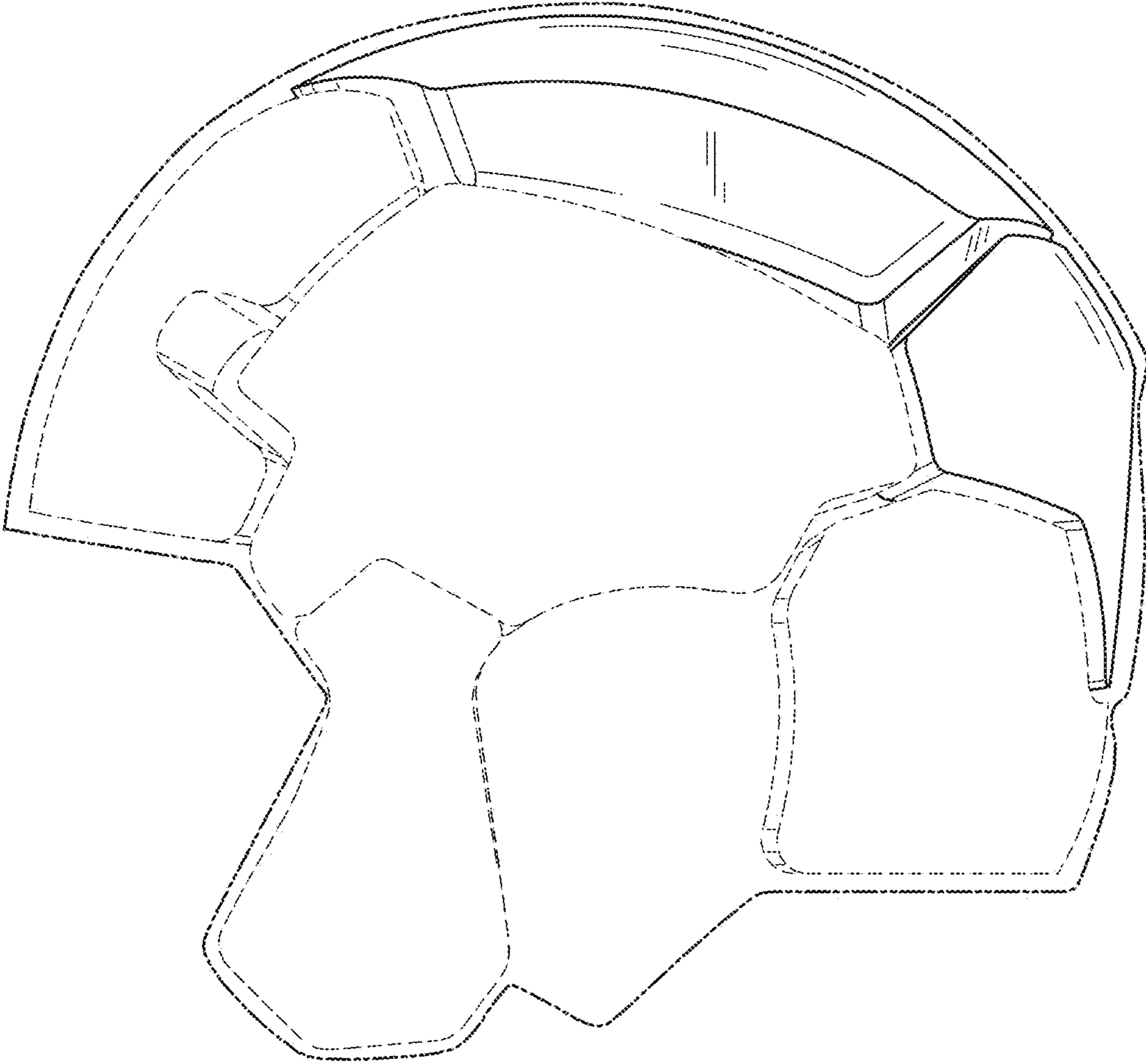

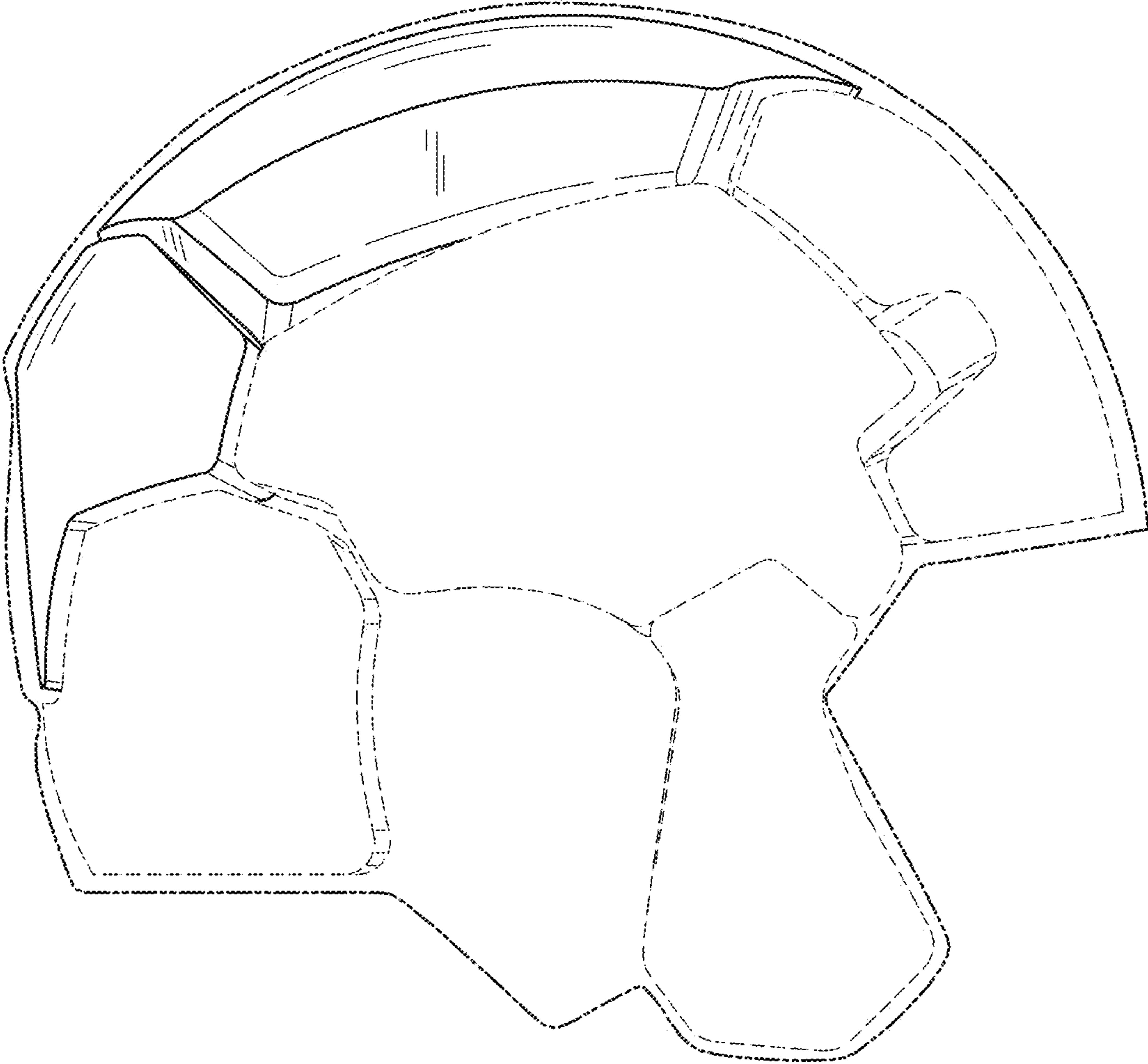

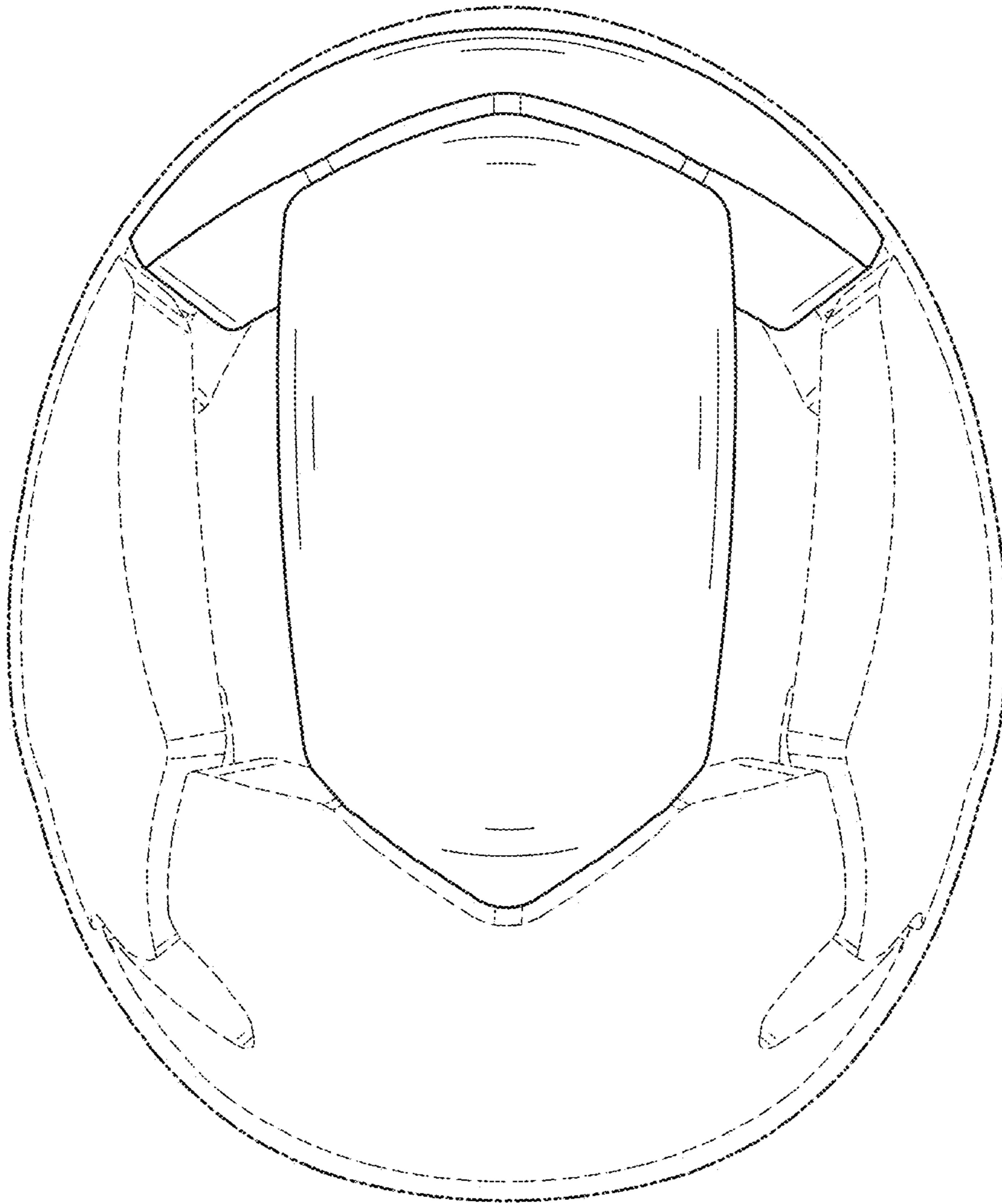

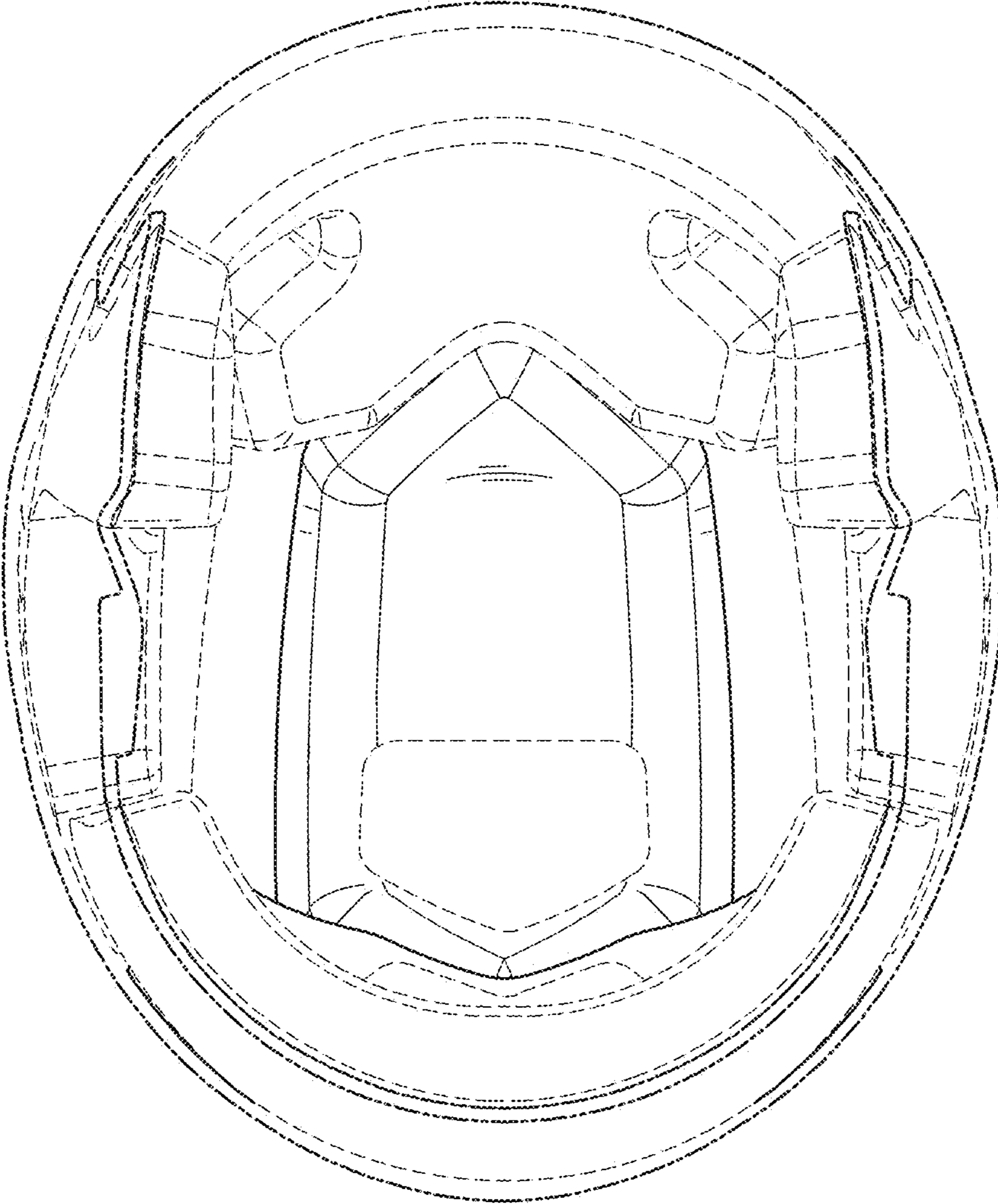
