(57) **CLAIM**

The ornamental design for a cereal food piece, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side perspective view of a cereal food piece according to our design shown in an environment of use;

FIG. 2 is a front, left side perspective view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a right side elevation view thereof;

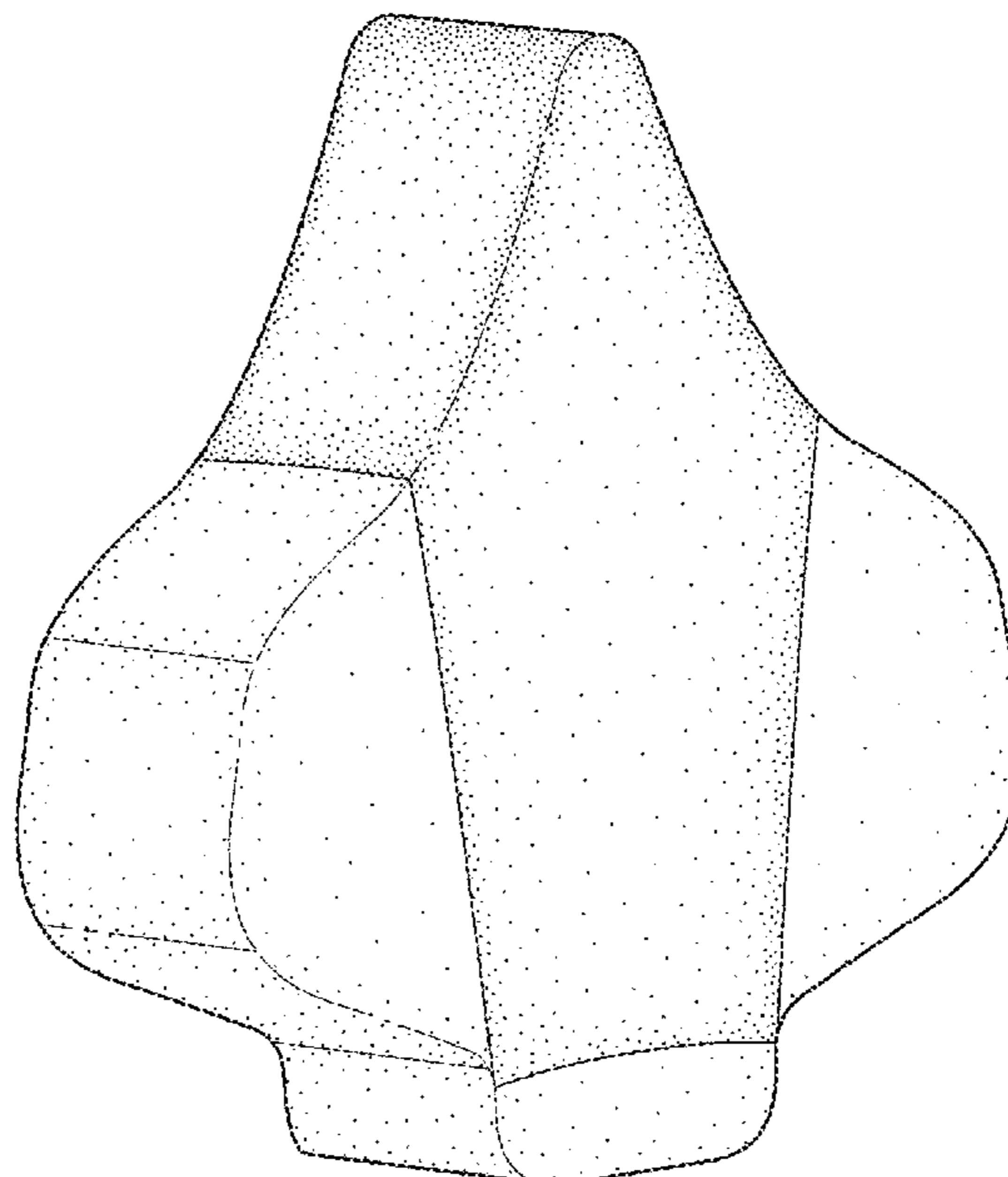
FIG. 6 is a left side elevation view thereof;

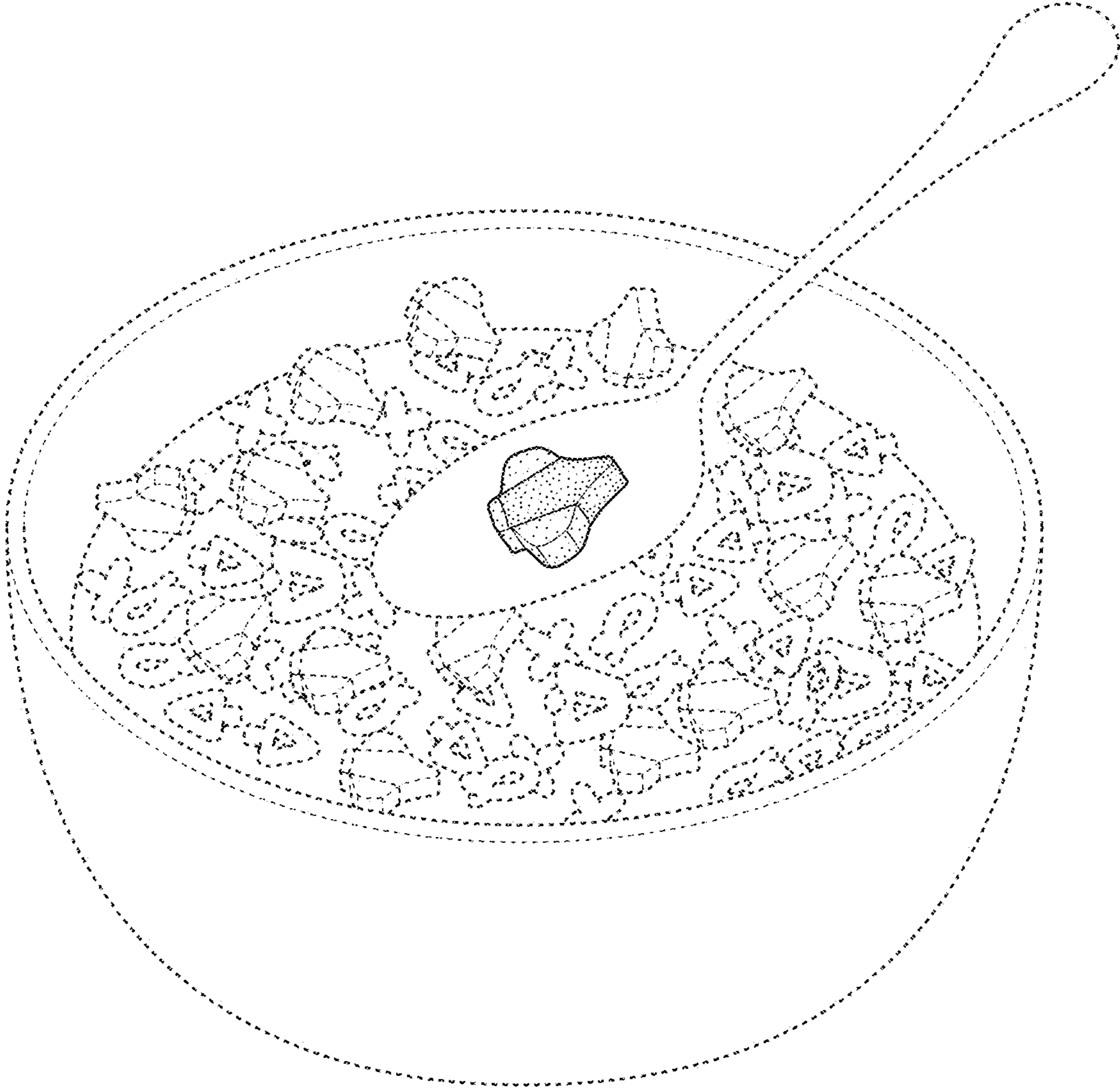

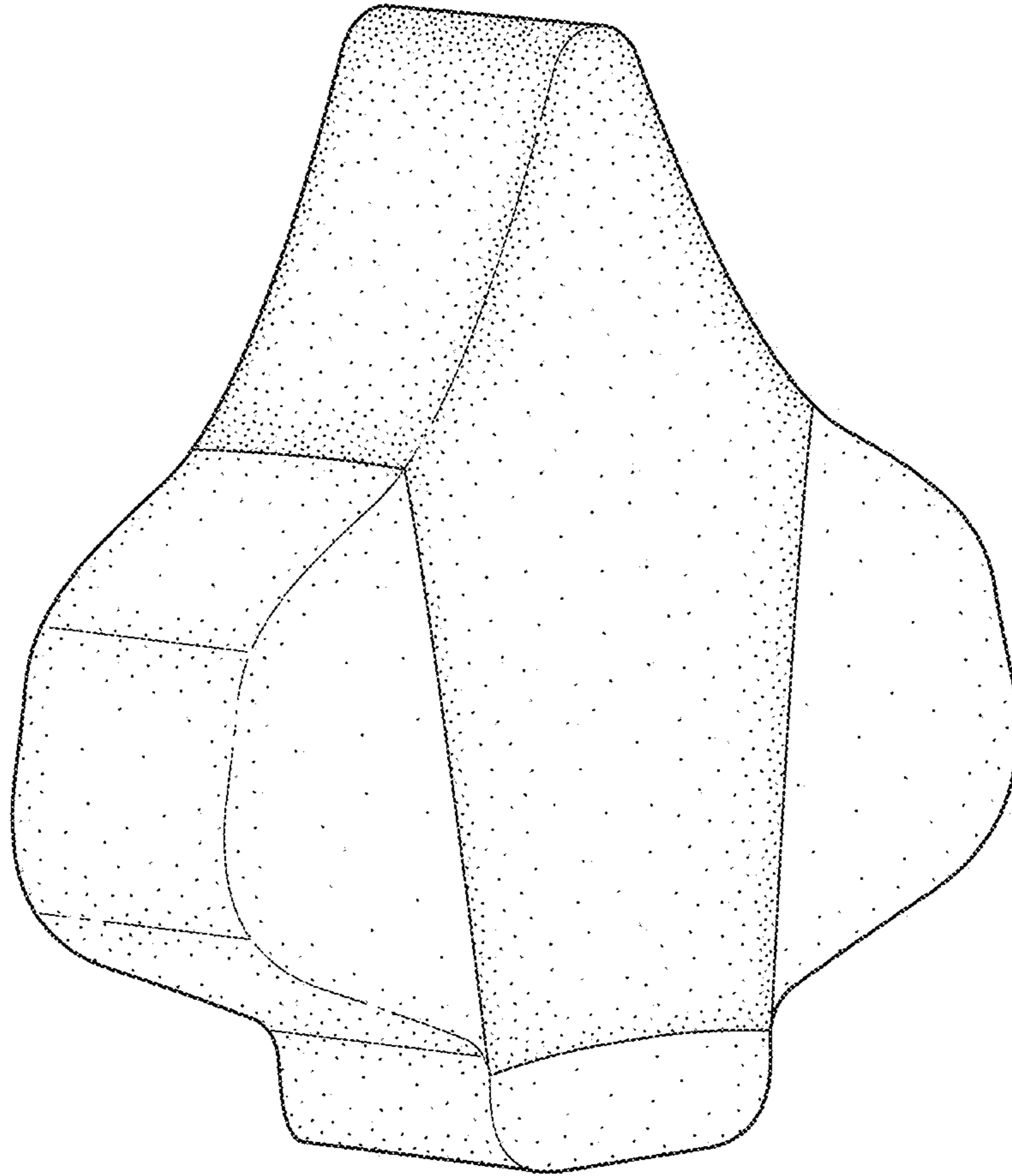

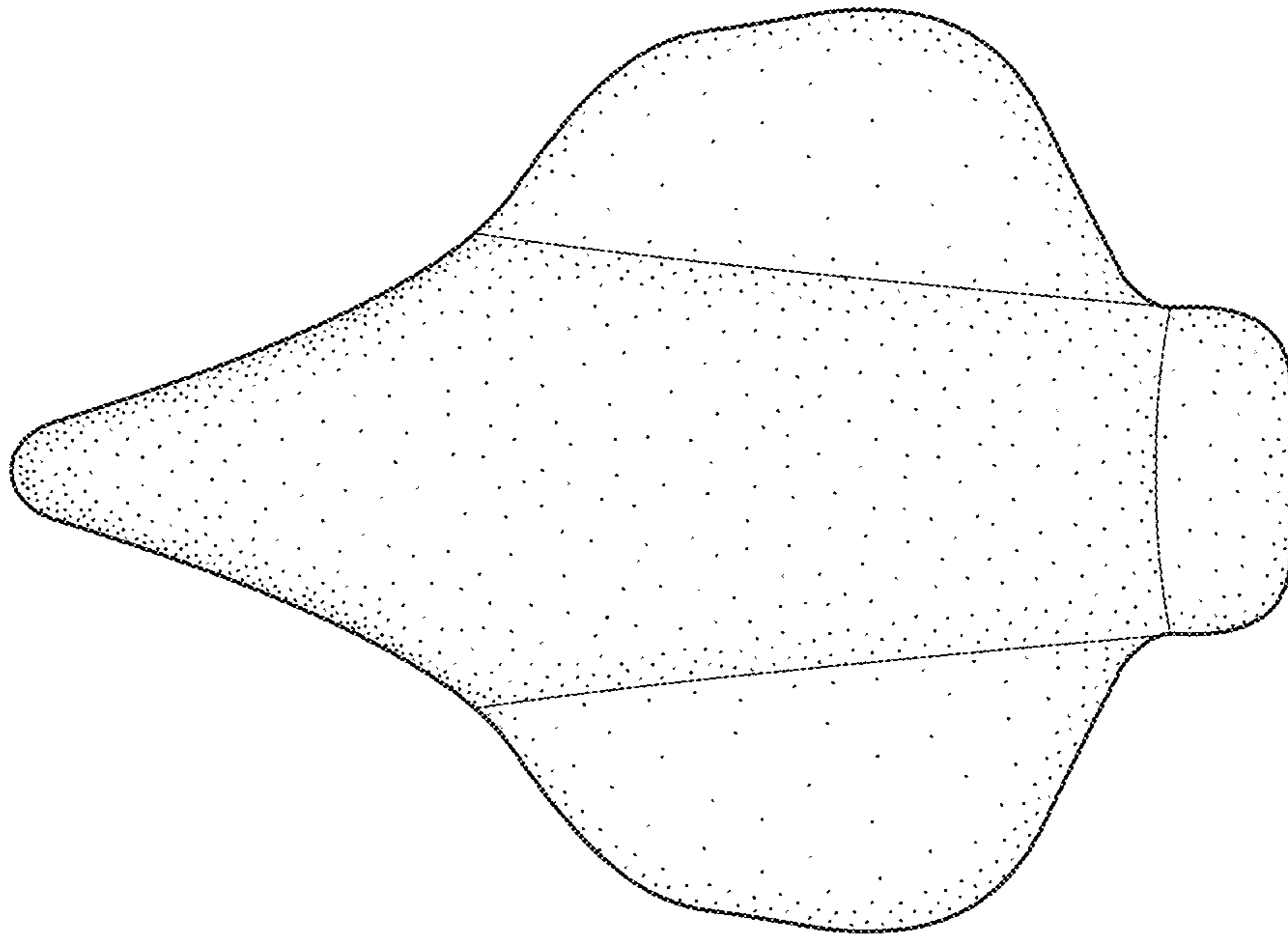

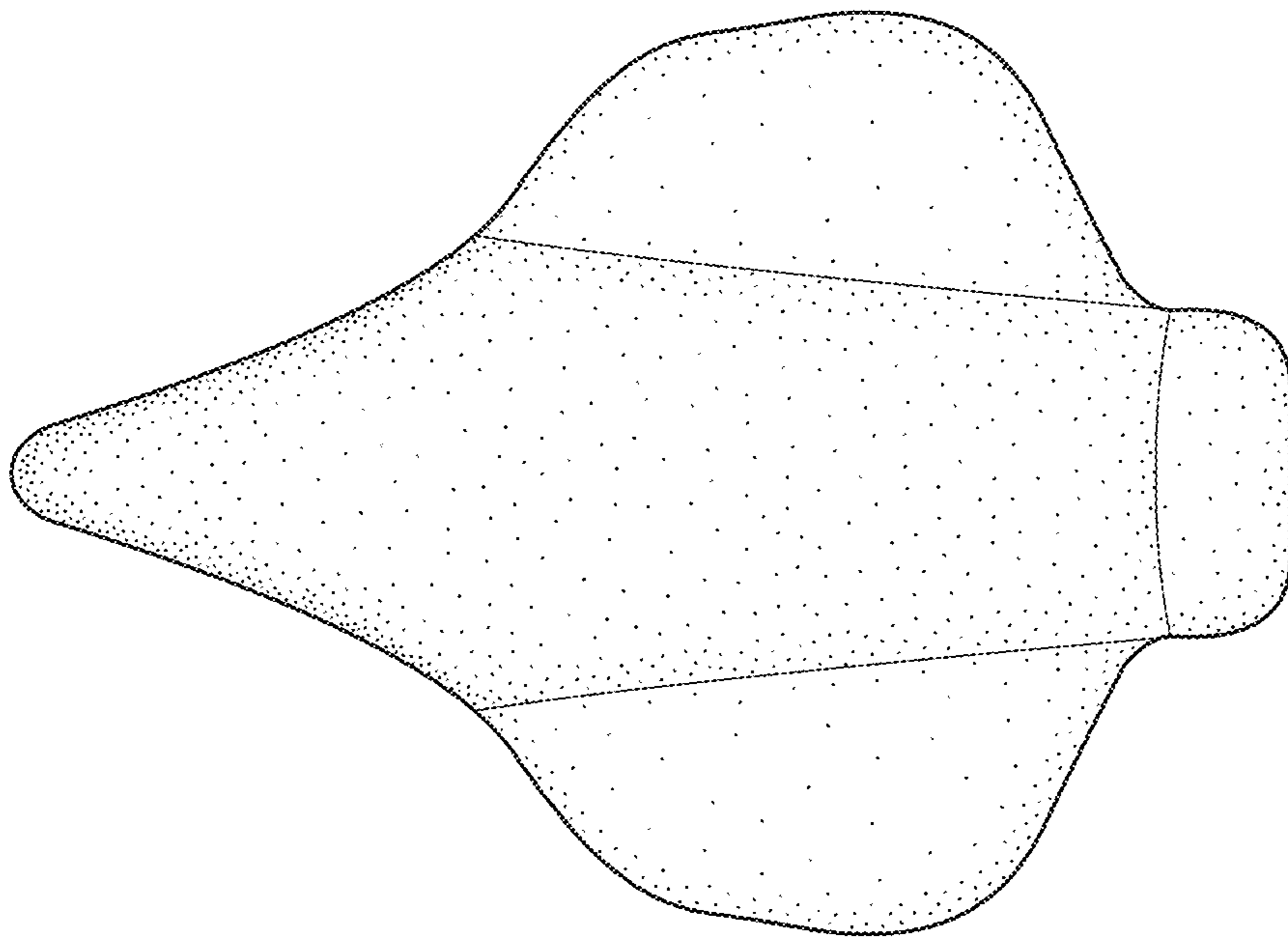

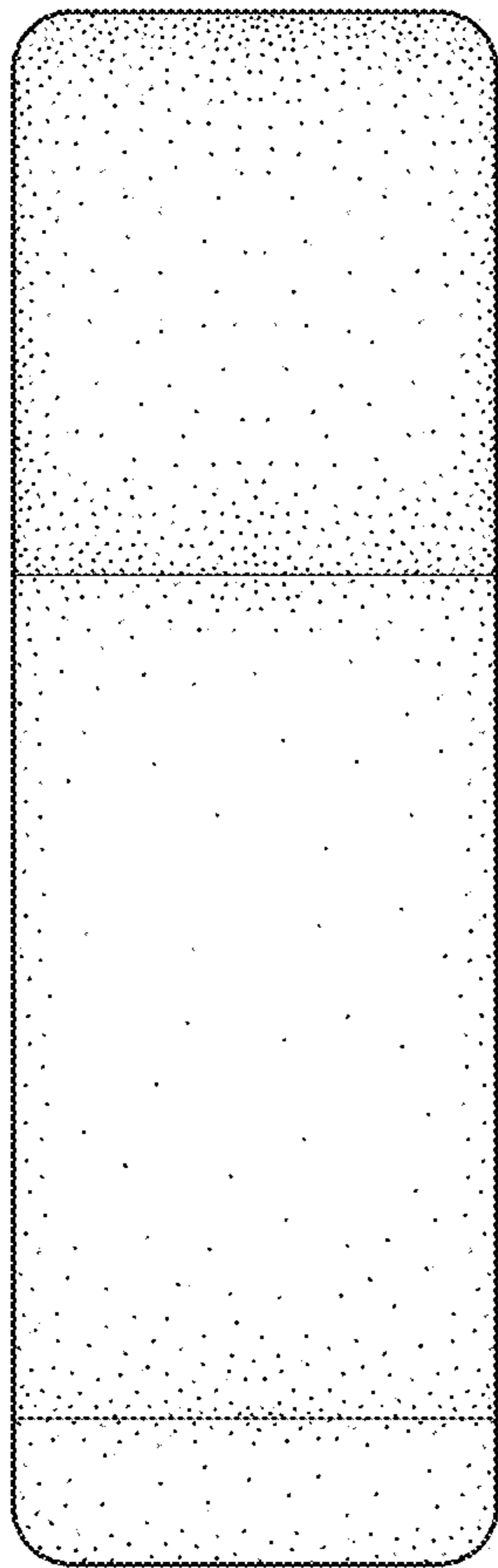

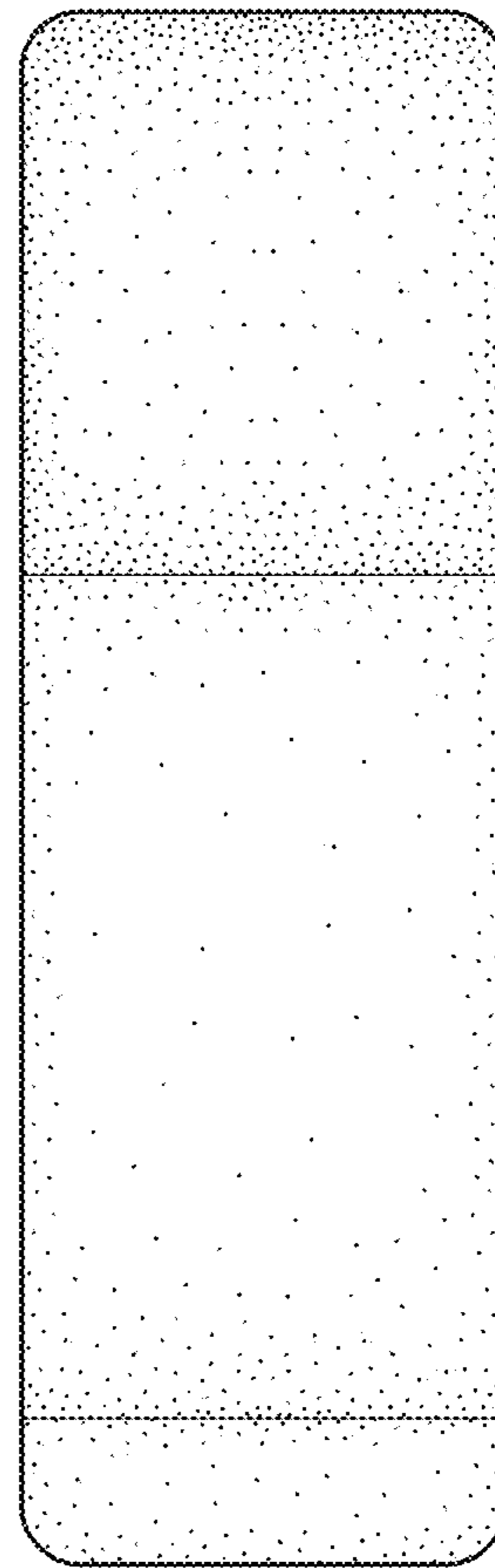

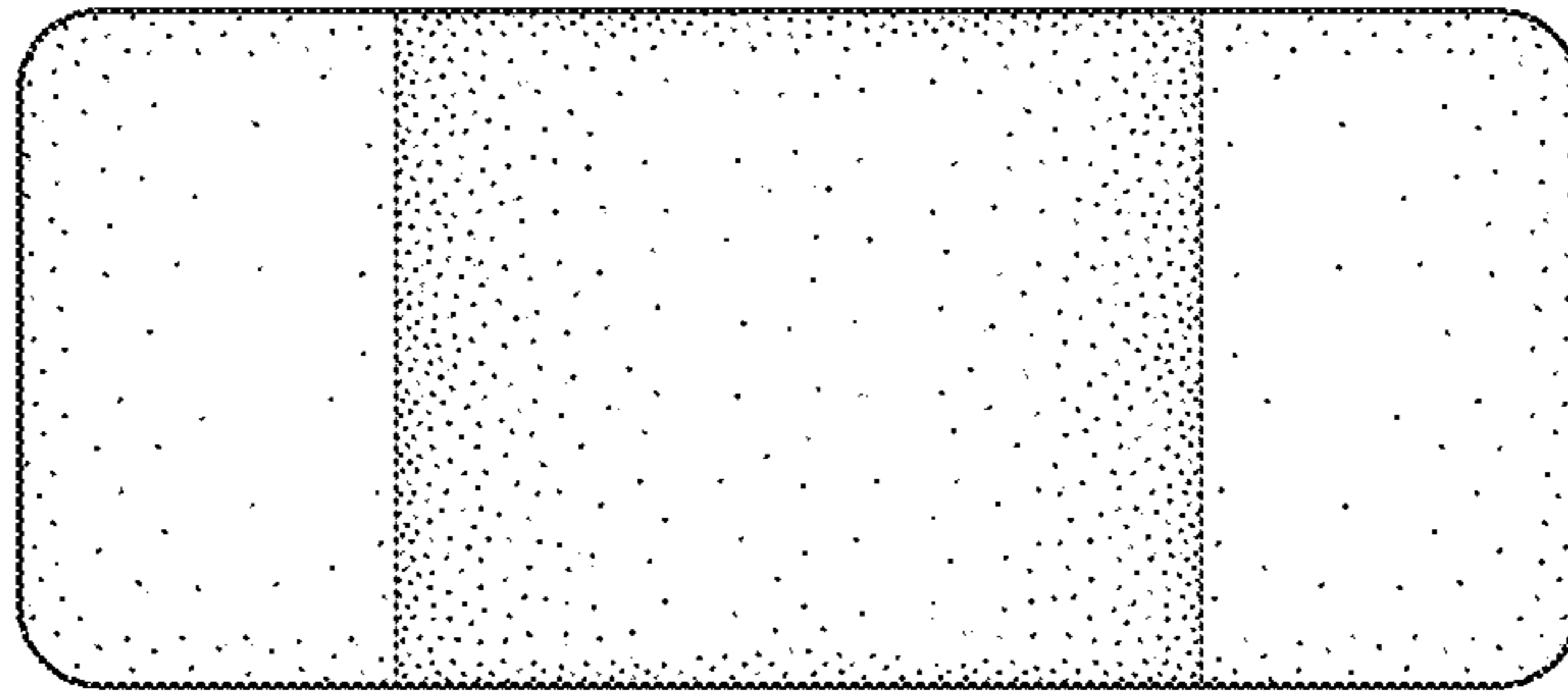

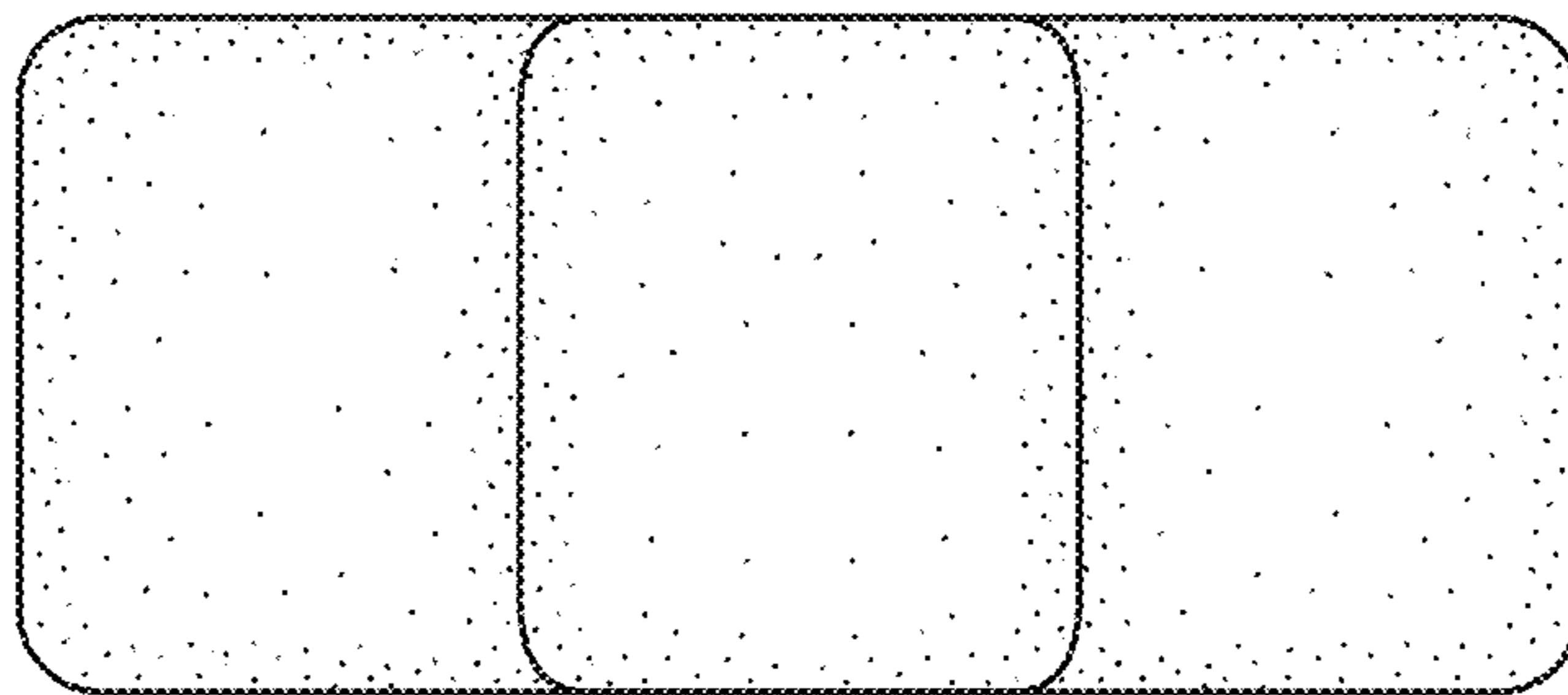
