(57) **CLAIM**

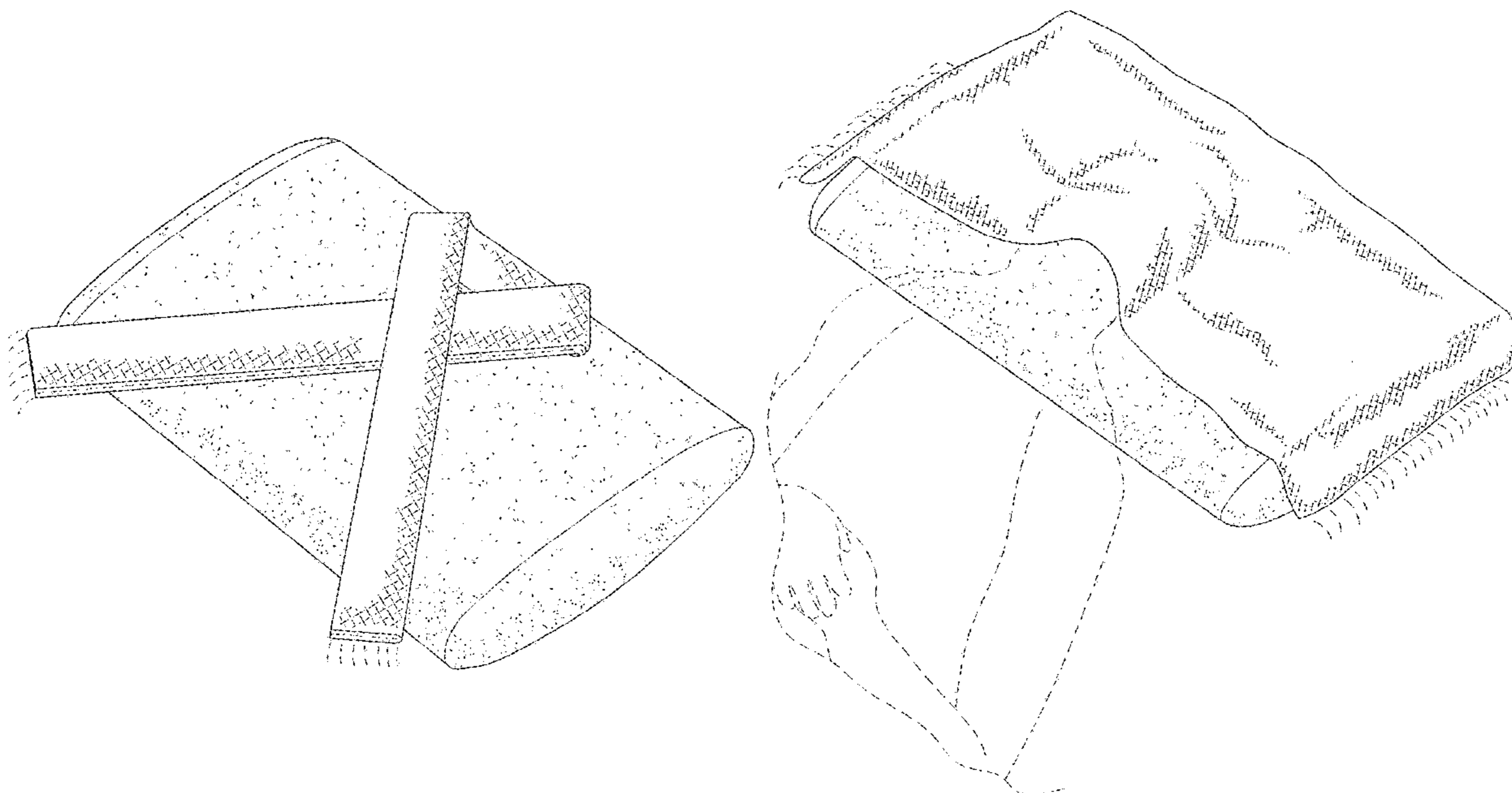
The ornamental design for a combined scarf and pillow, as shown and described.

DESCRIPTION

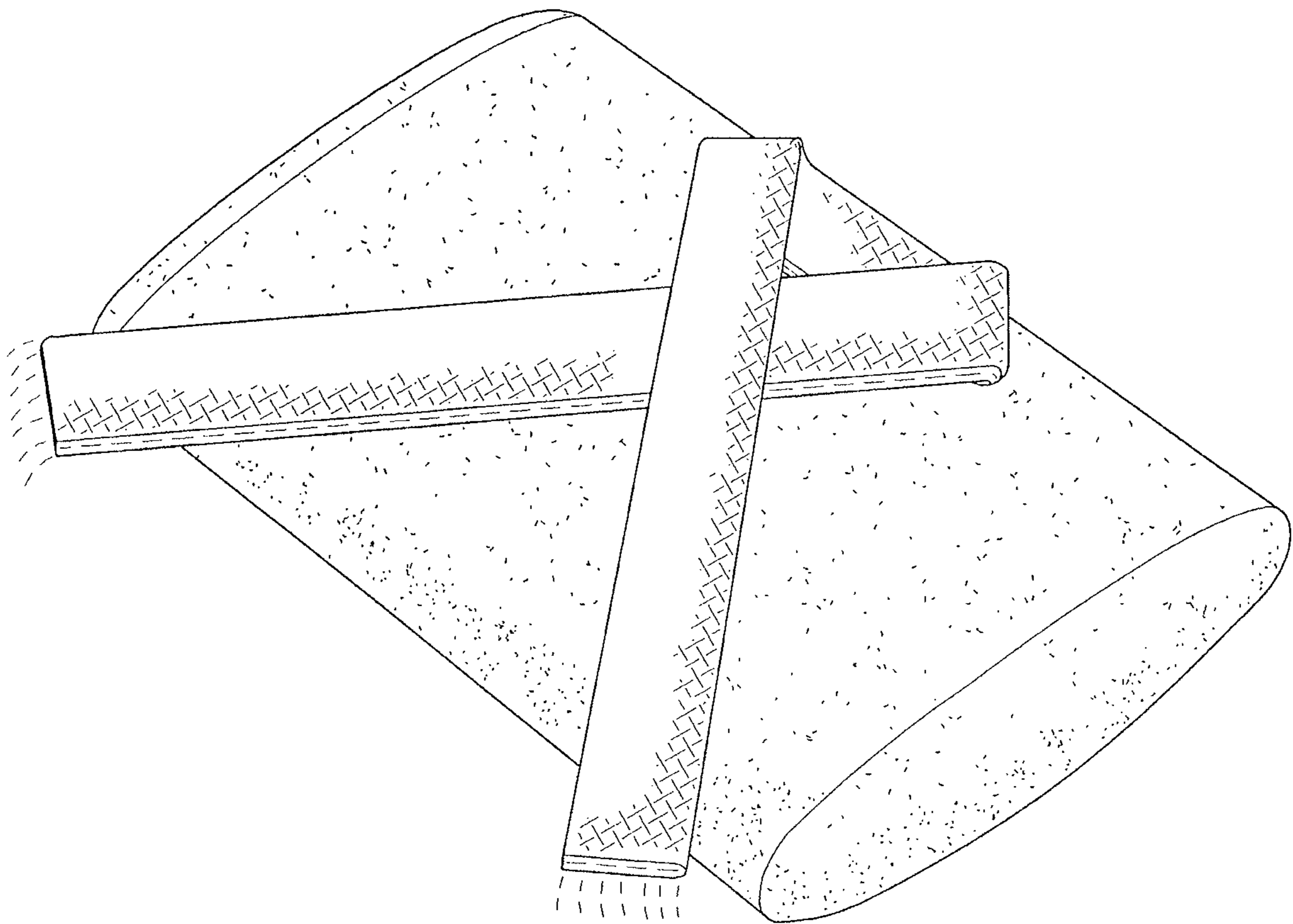

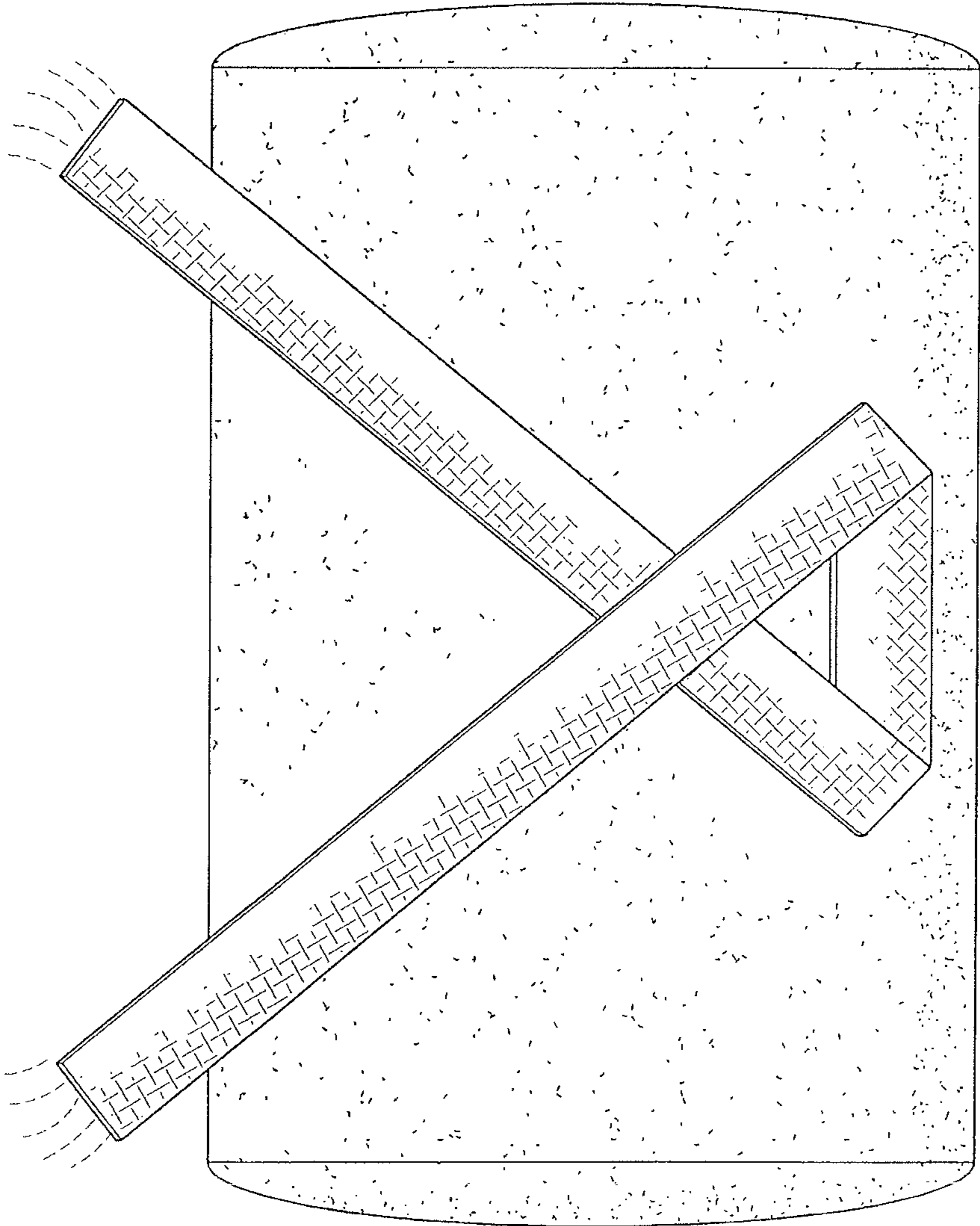

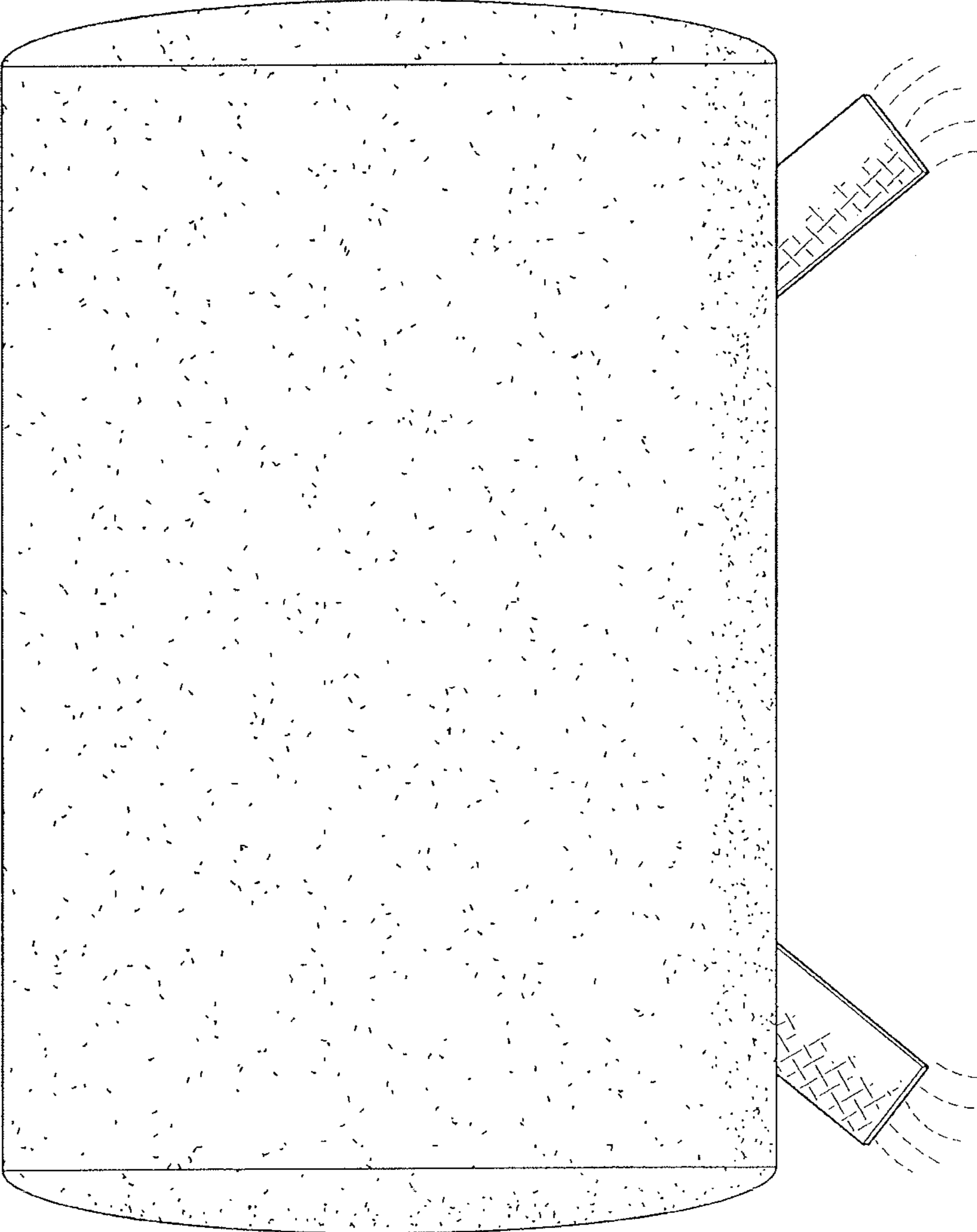

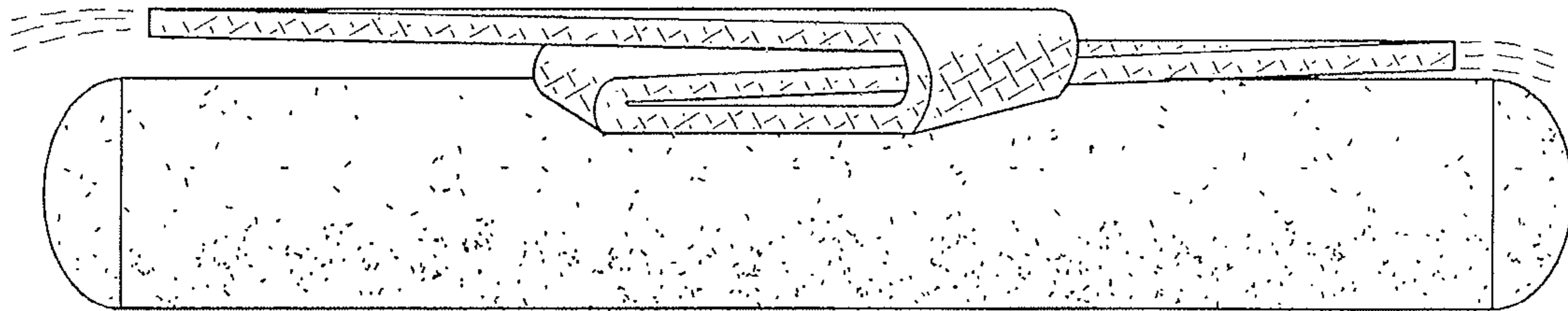

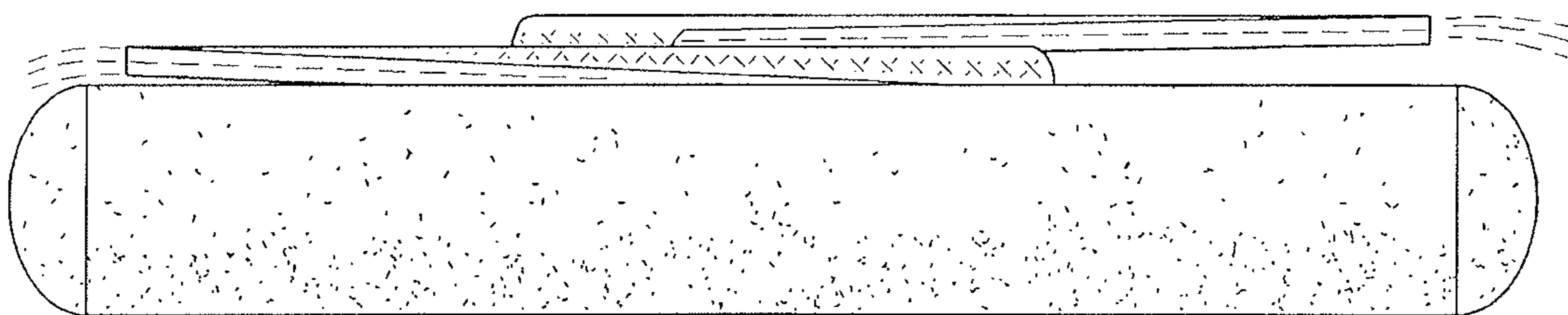

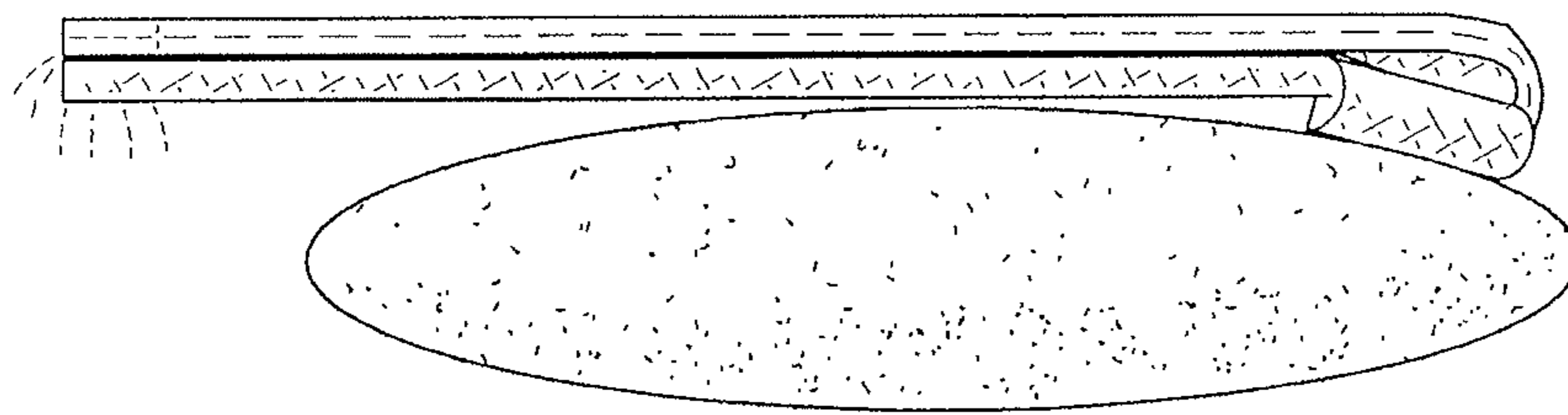

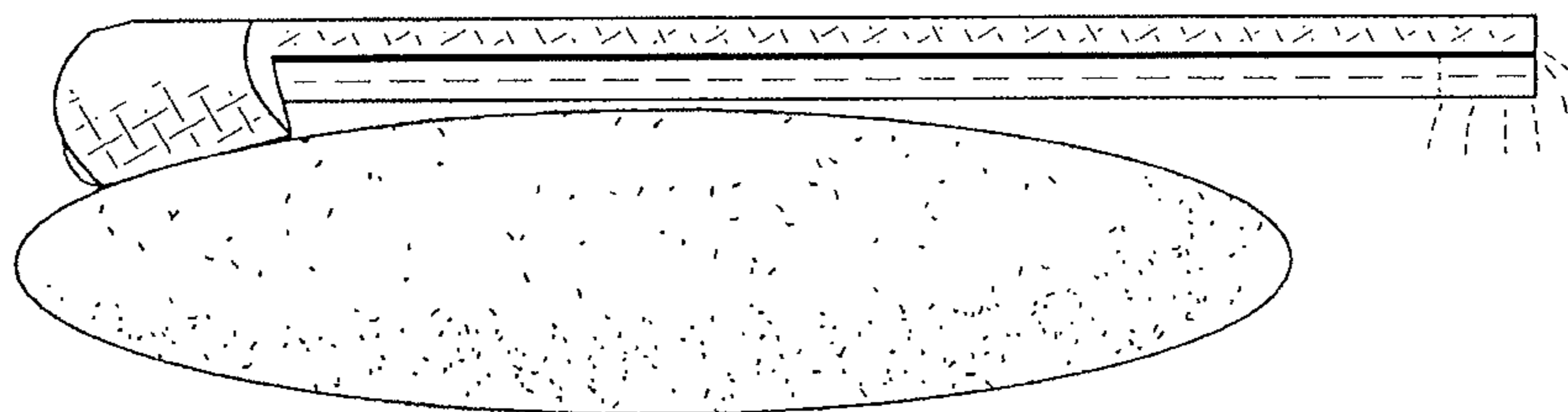

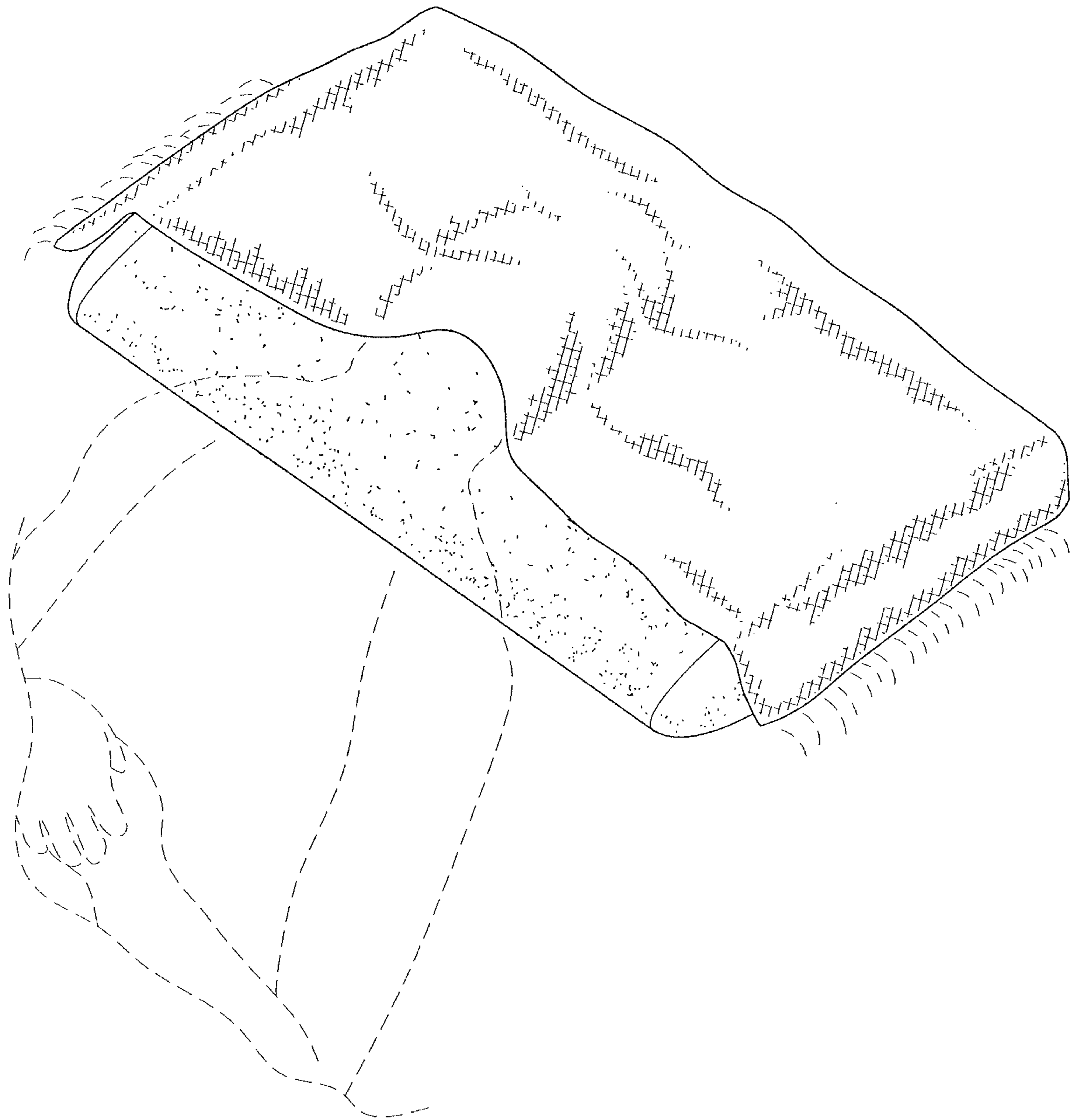
