DESCRIPTION

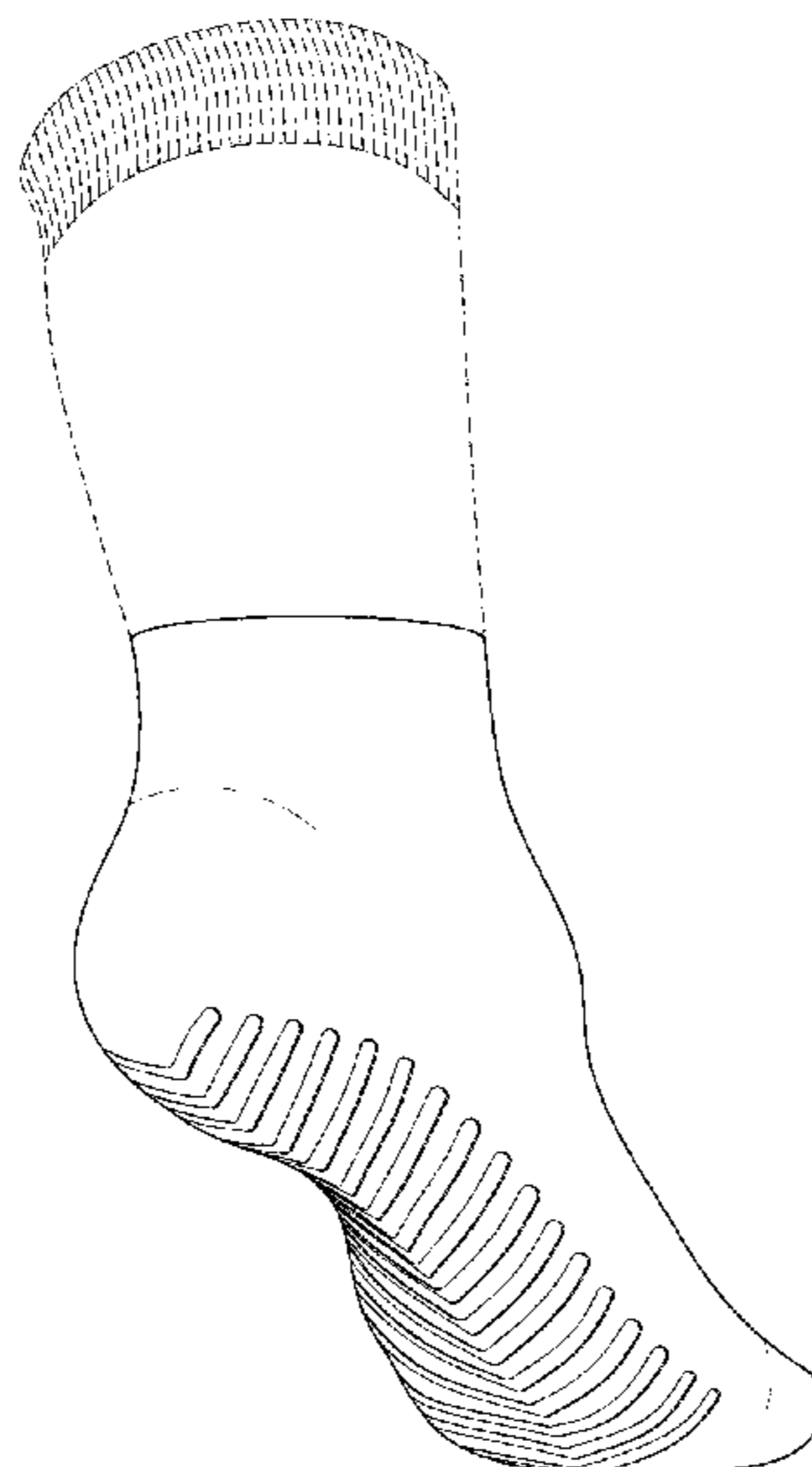
FIG. 1. is a bottom perspective view of a foot sock, showing our new design;

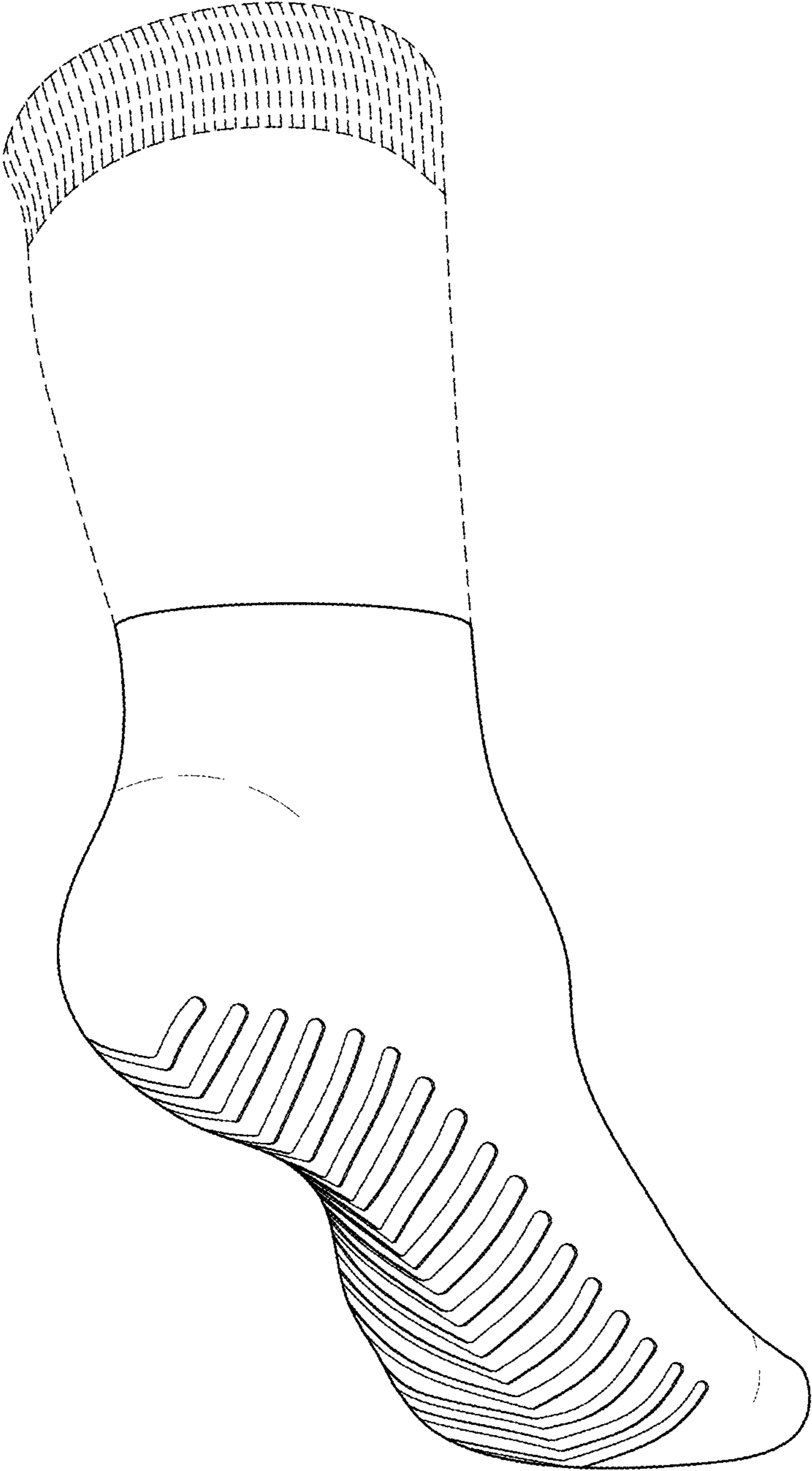

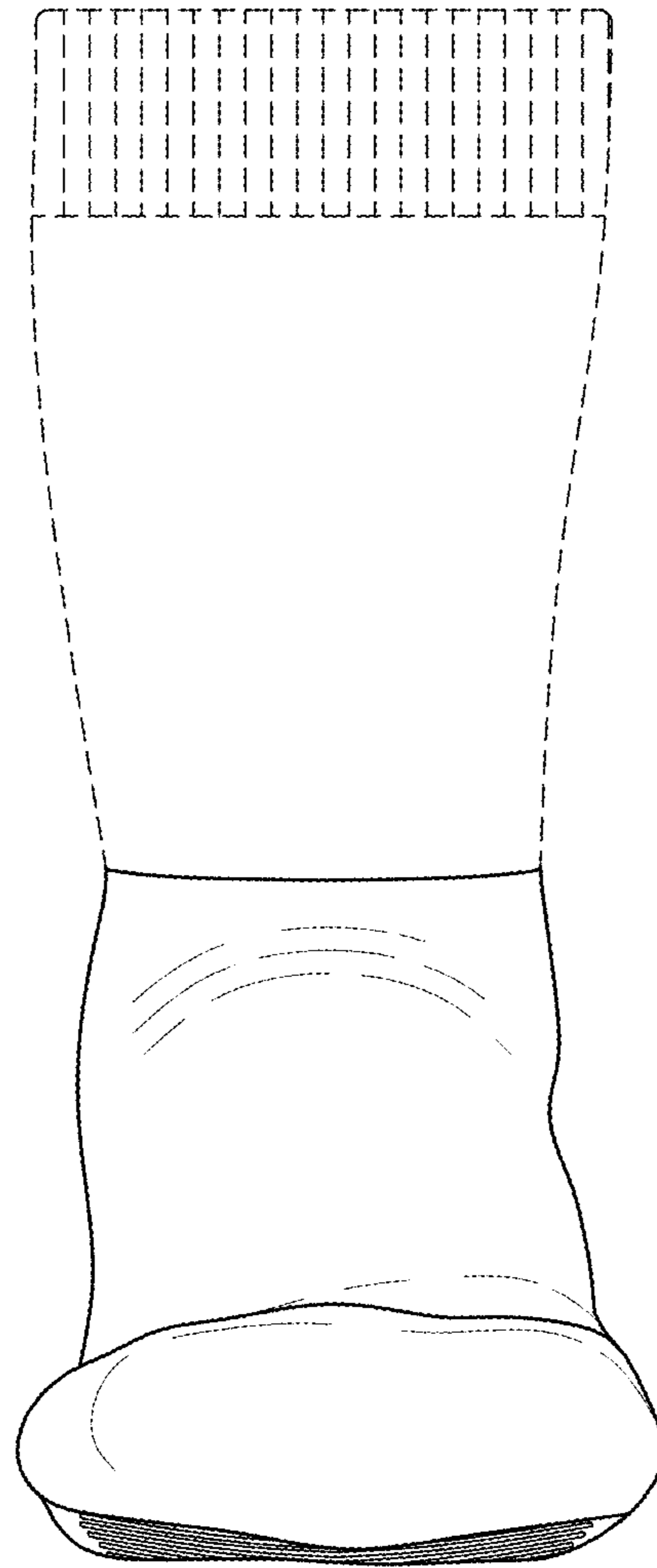

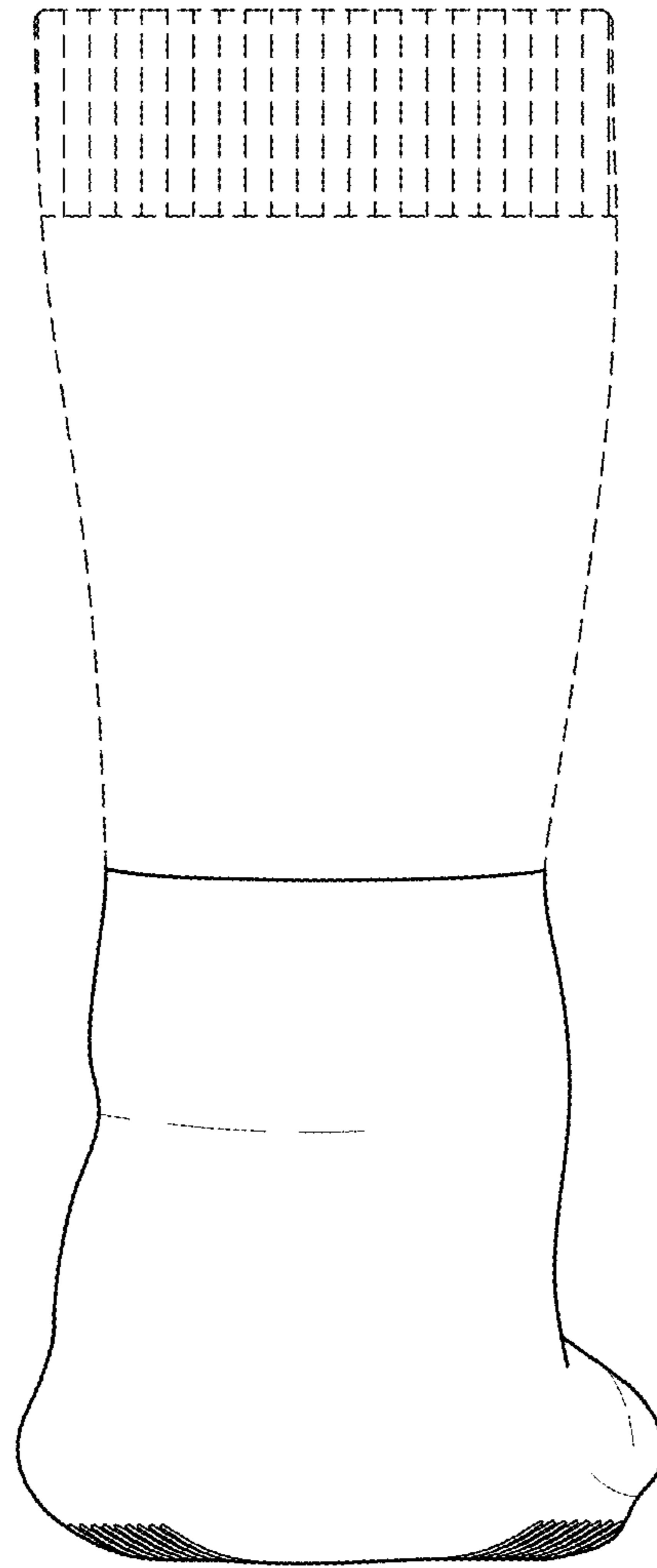

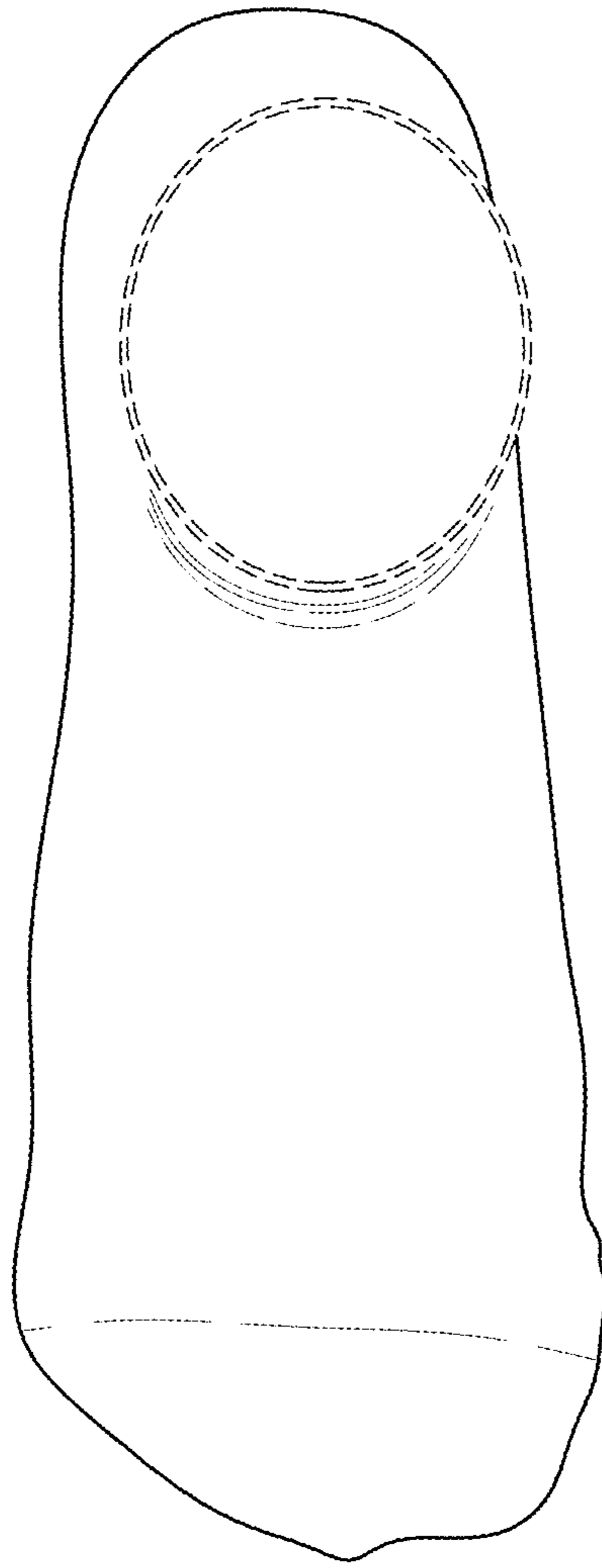

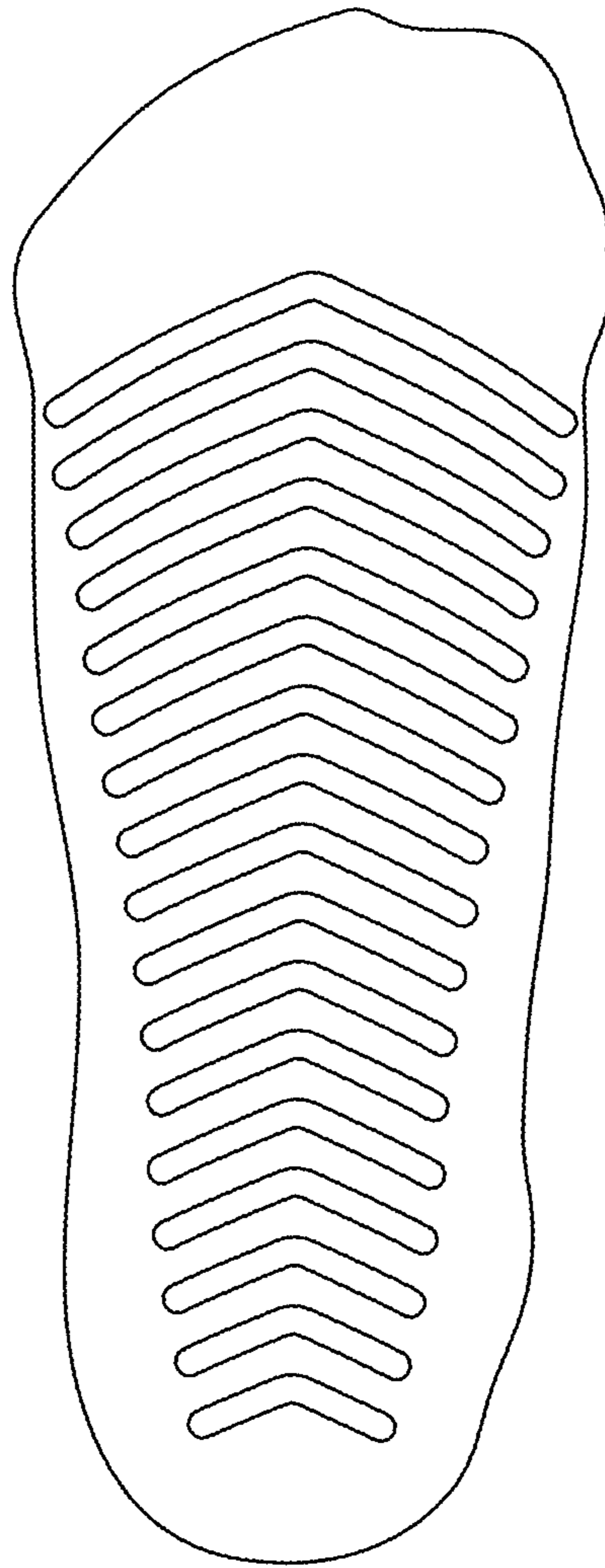
