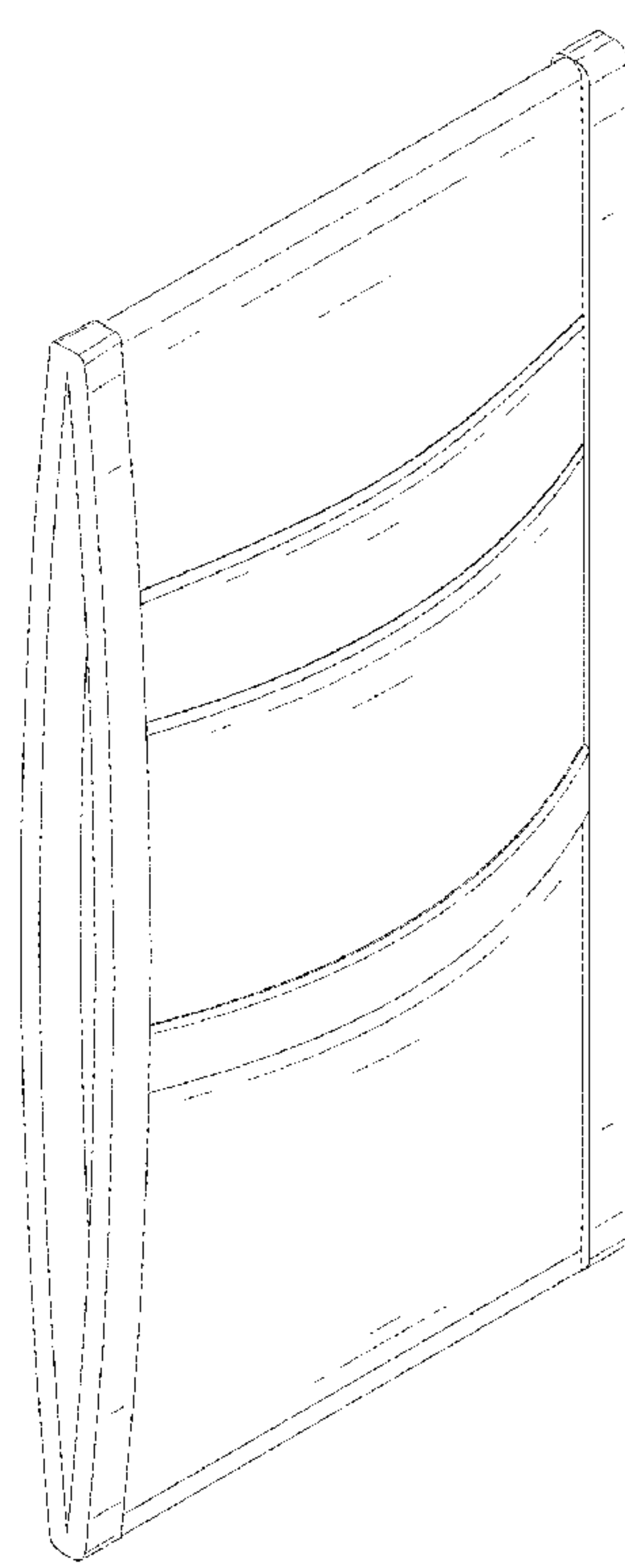

The ornamental design for a pencil case, as shown and described.

DESCRIPTION
FIG. 1 is a front, left side, top perspective view of a pencil case showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a front, left side perspective view thereof when being used.
The broken lines depict environment within which the pencil case is being used and forms no part of the claimed design.

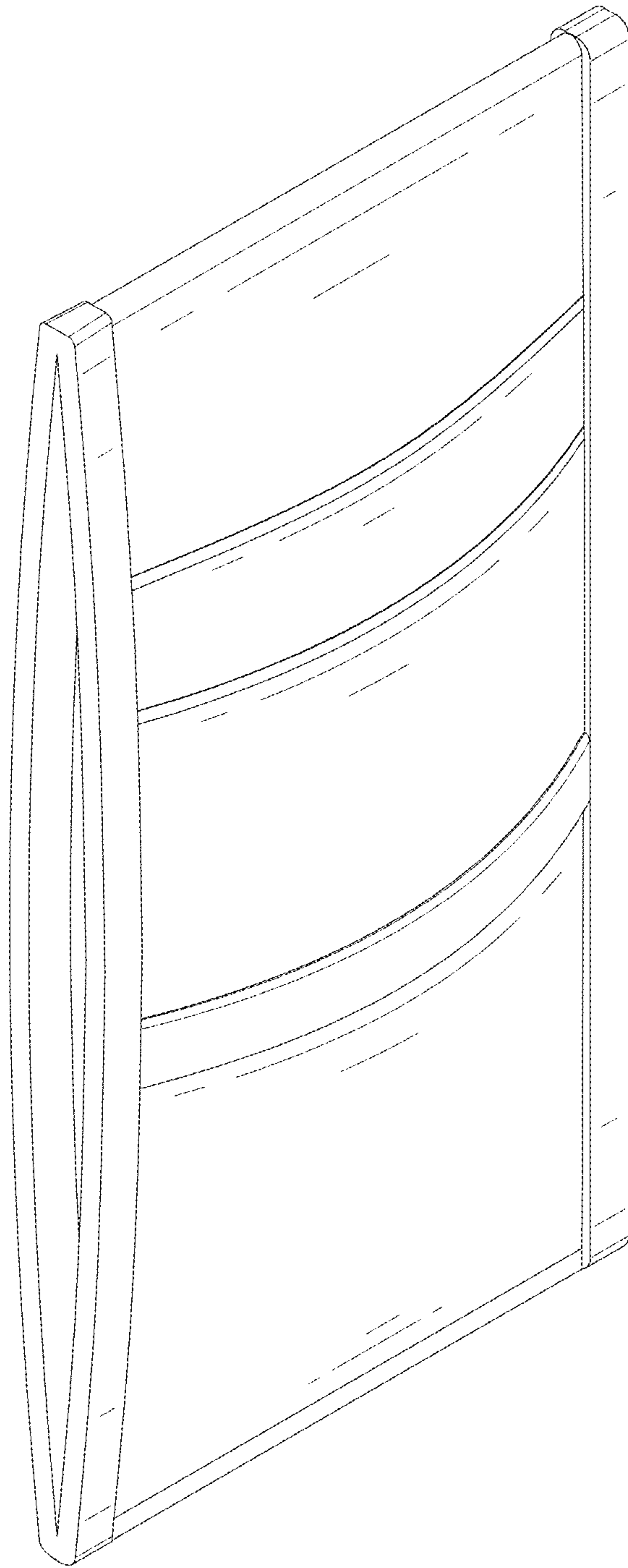

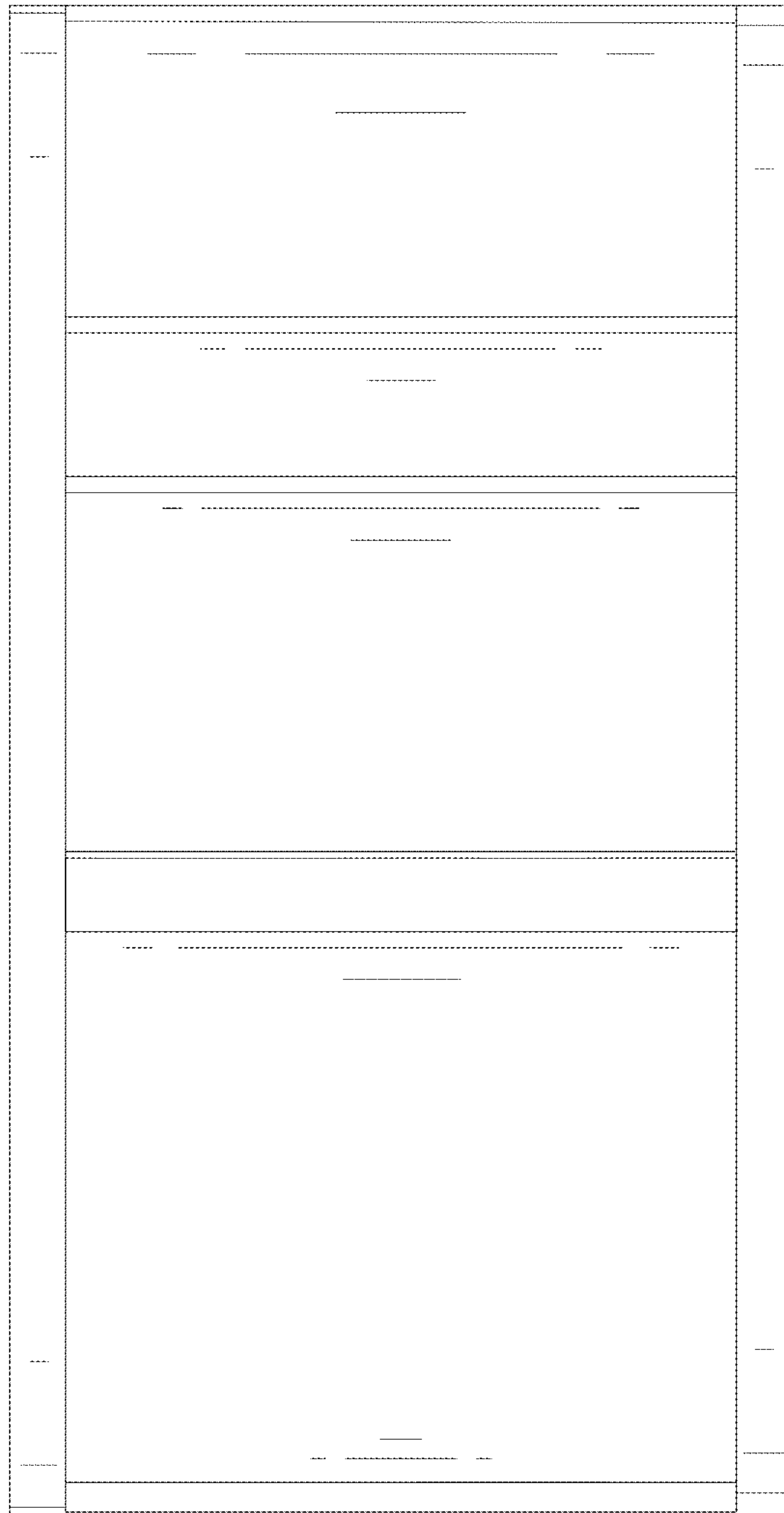

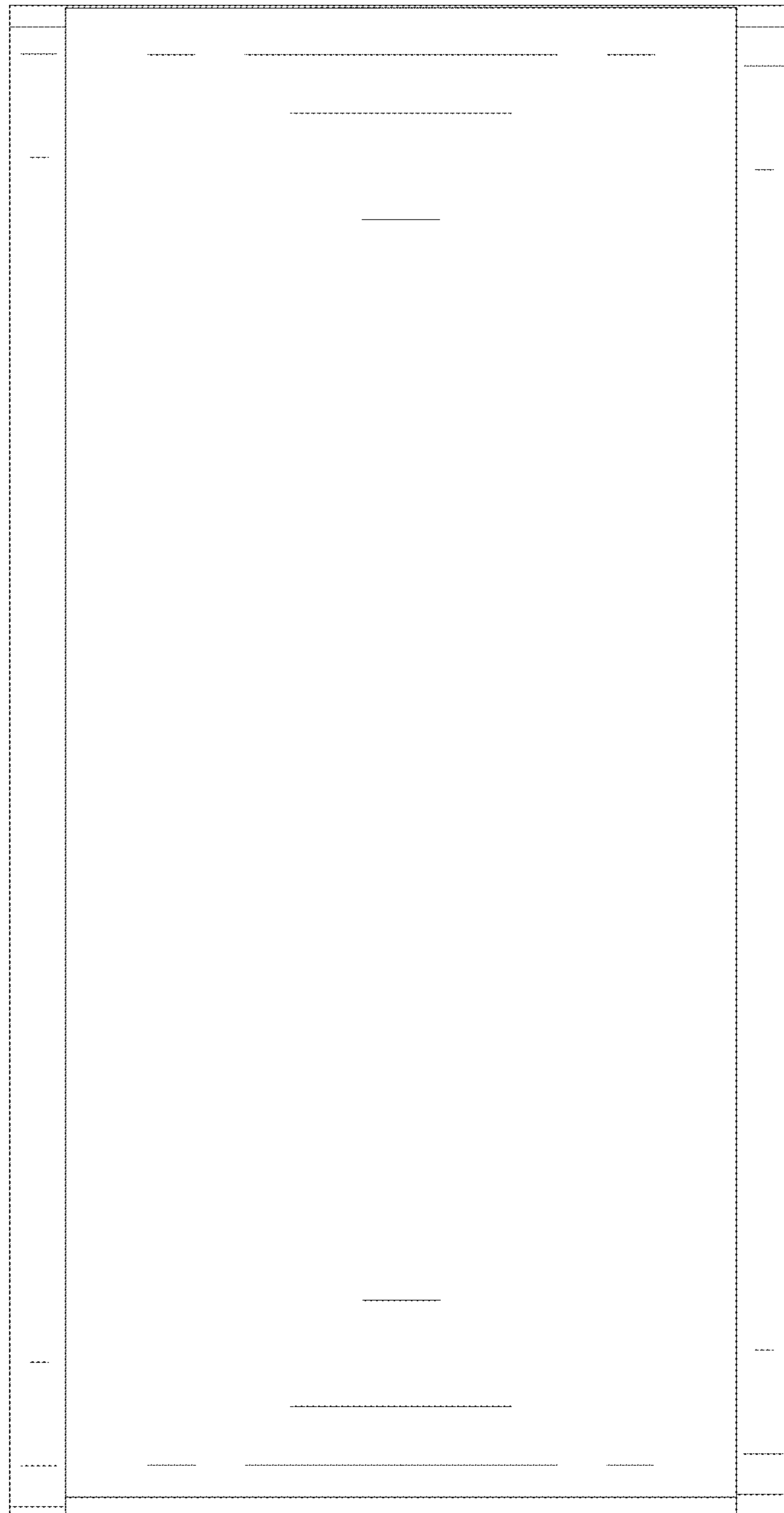

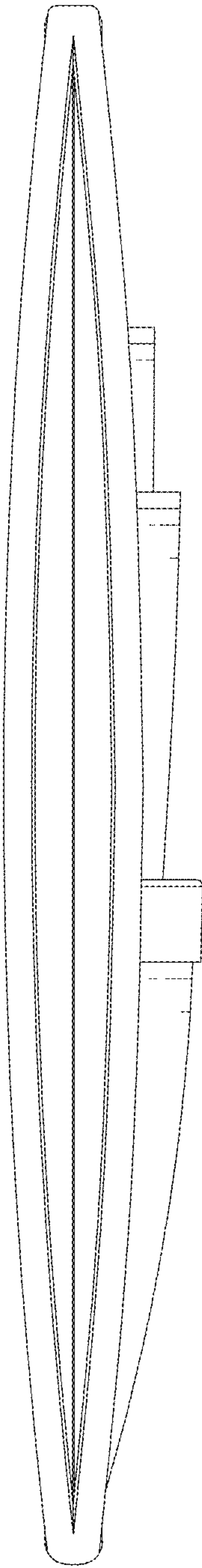

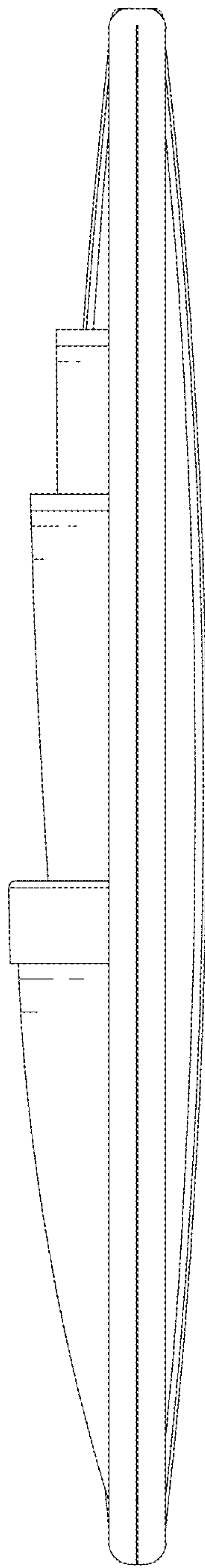

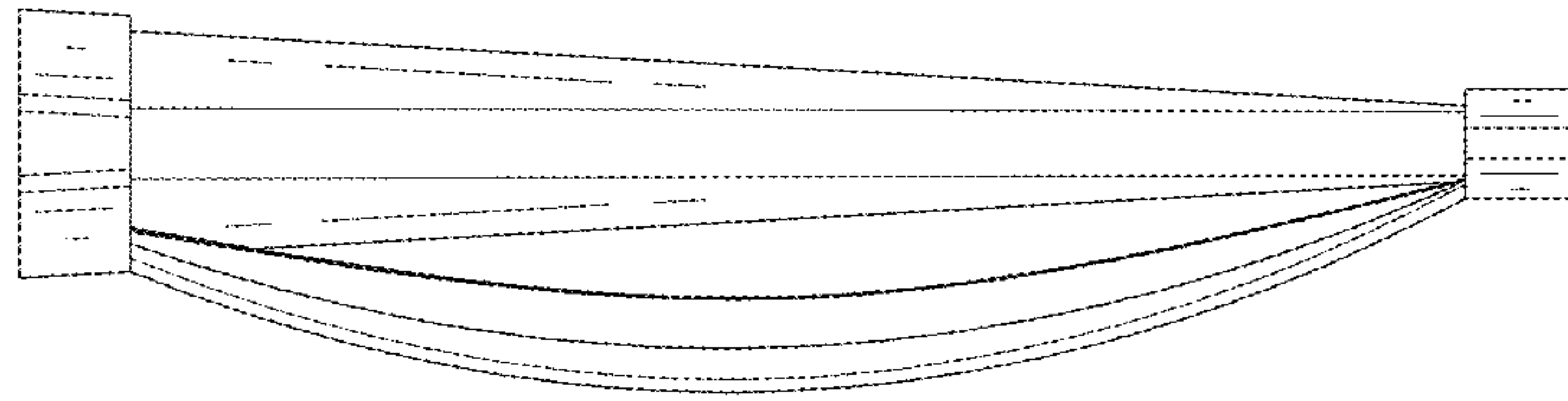

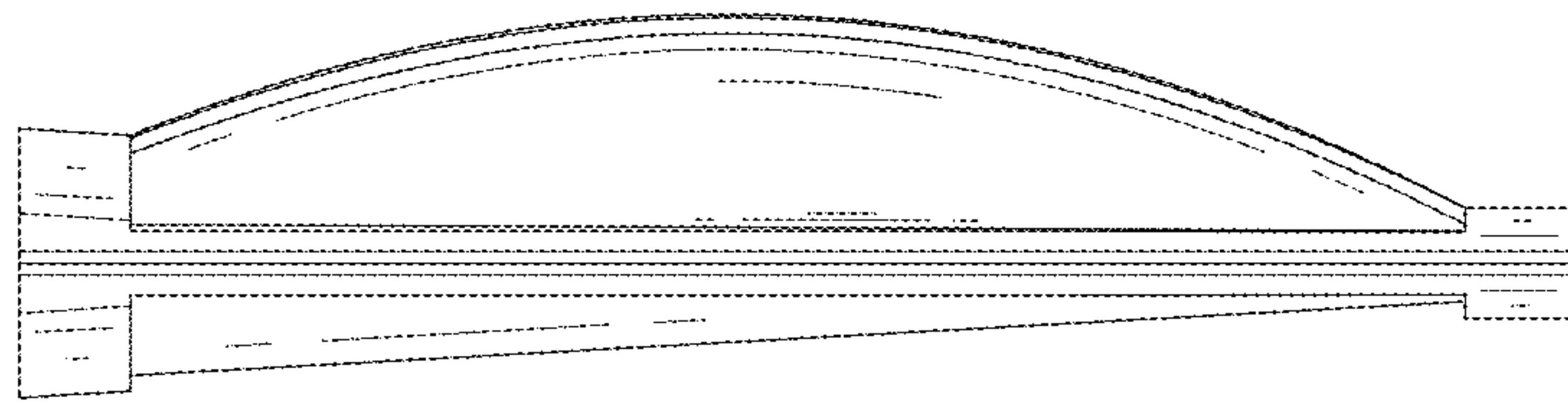

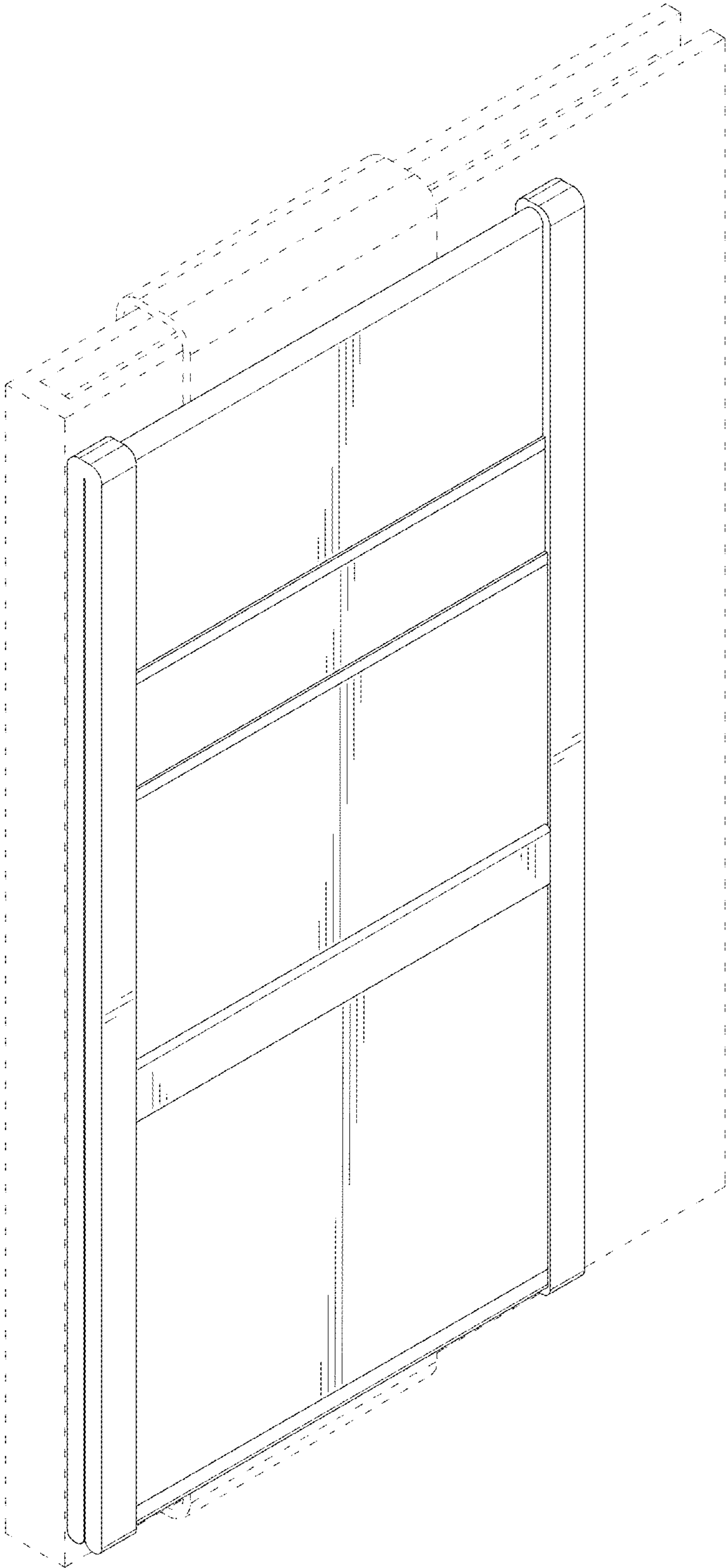
