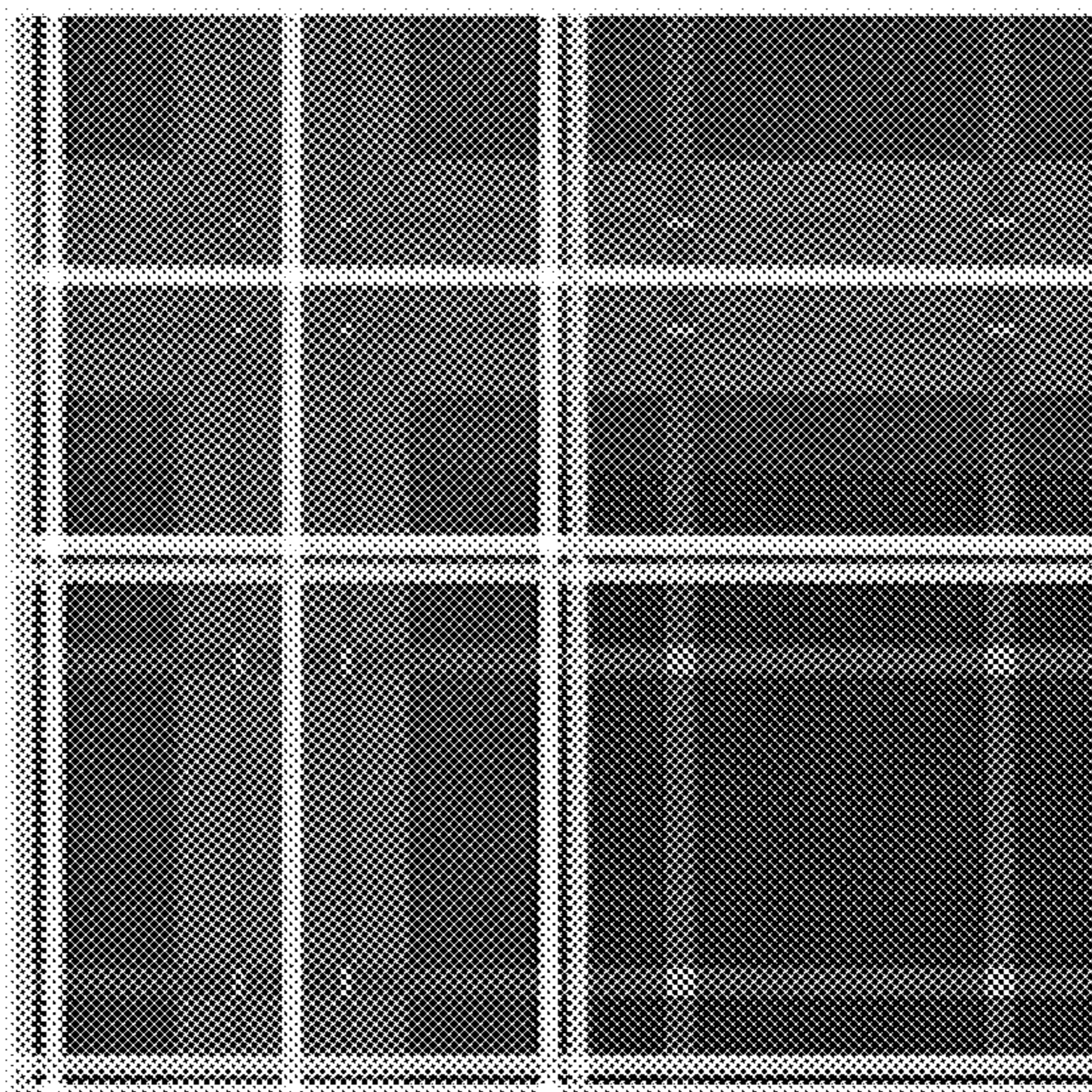
The ornamental design for a fabric with surface patterns, as

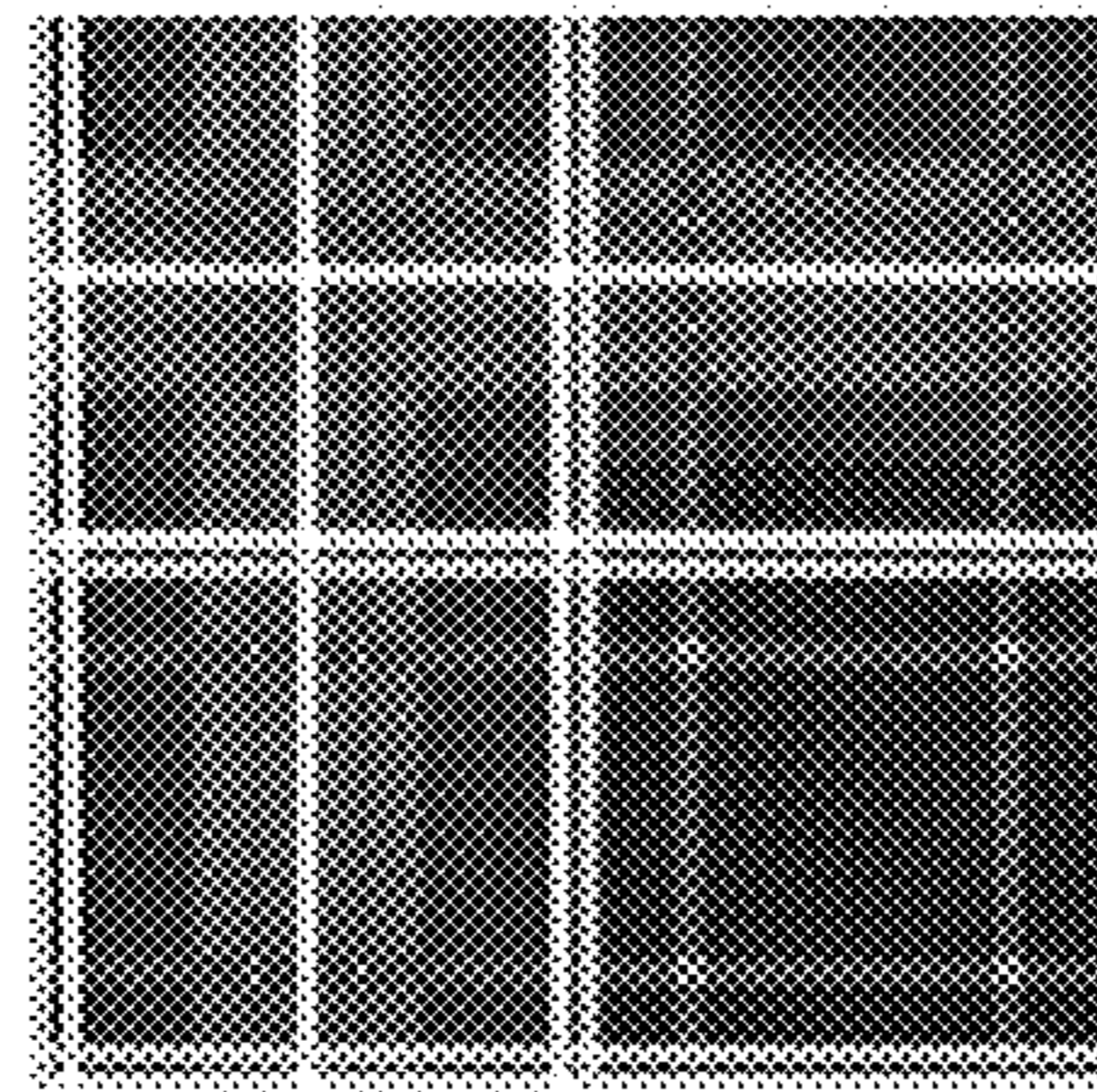

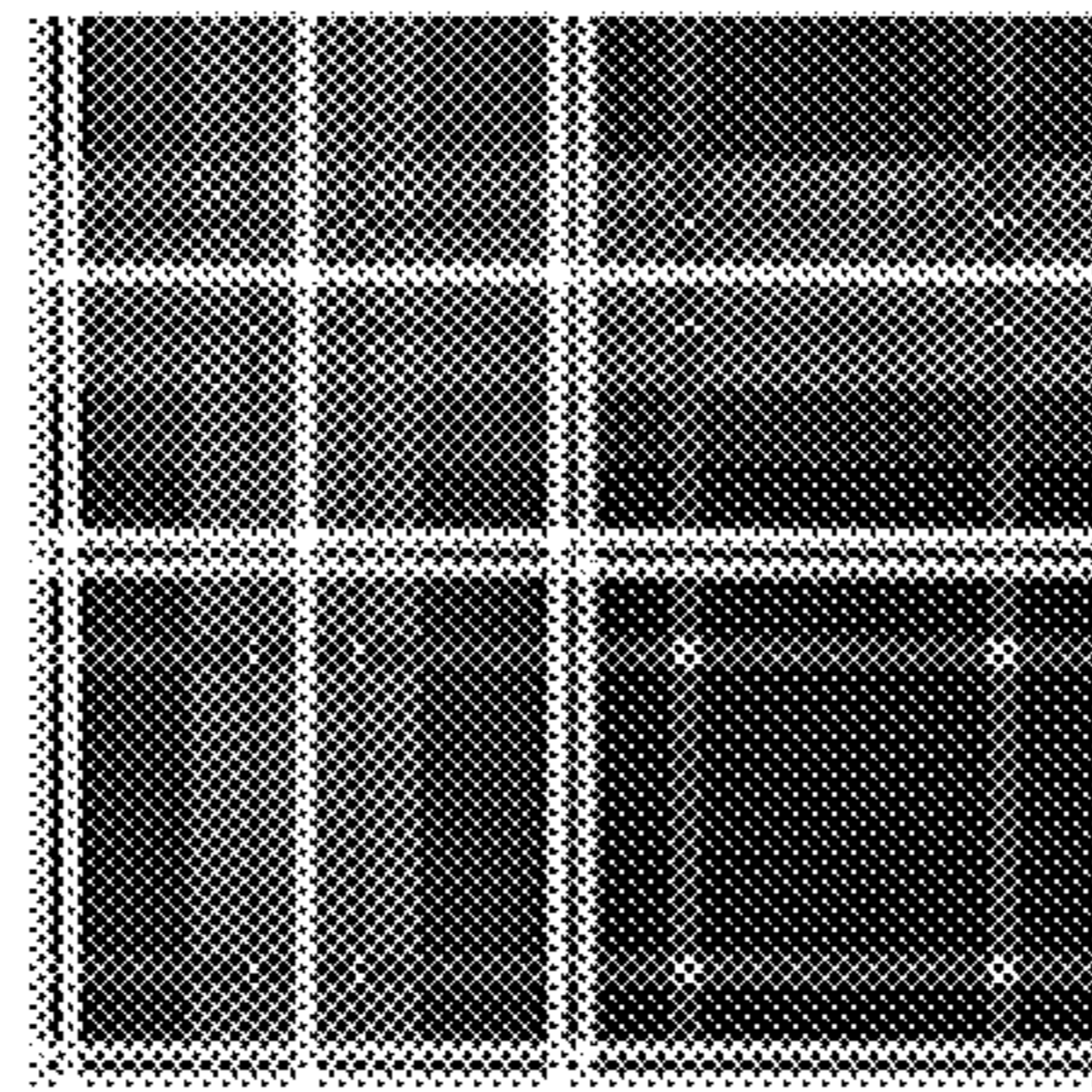
