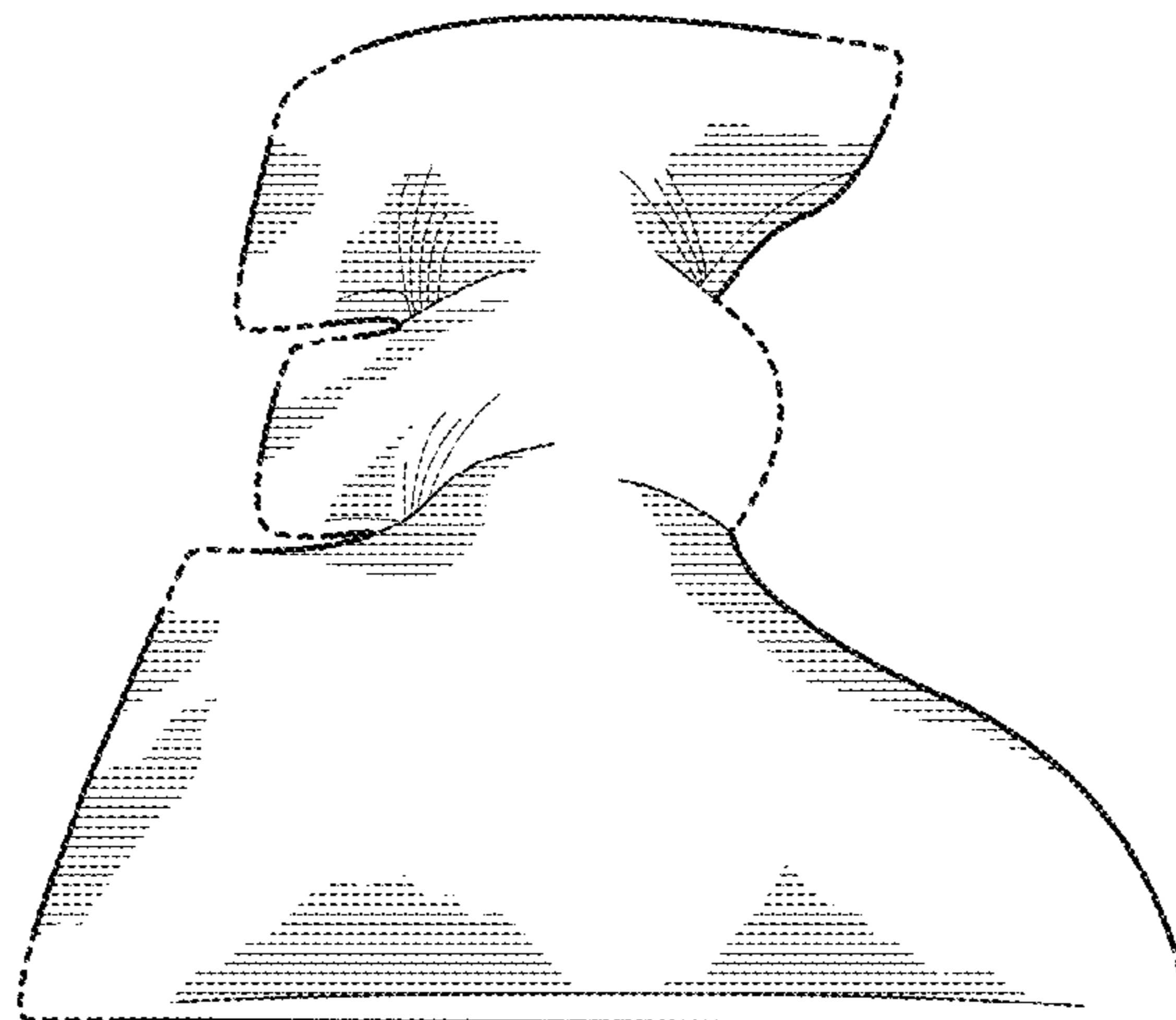
(57) **CLAIM**

The ornamental design for a therapeutic neck and shoulder sleep pillow, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a therapeutic neck and shoulder sleep pillow showing my new design;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a side view thereof;
FIG. 5 is an additional side view thereof;
FIG. 6 is a front view thereof; and,

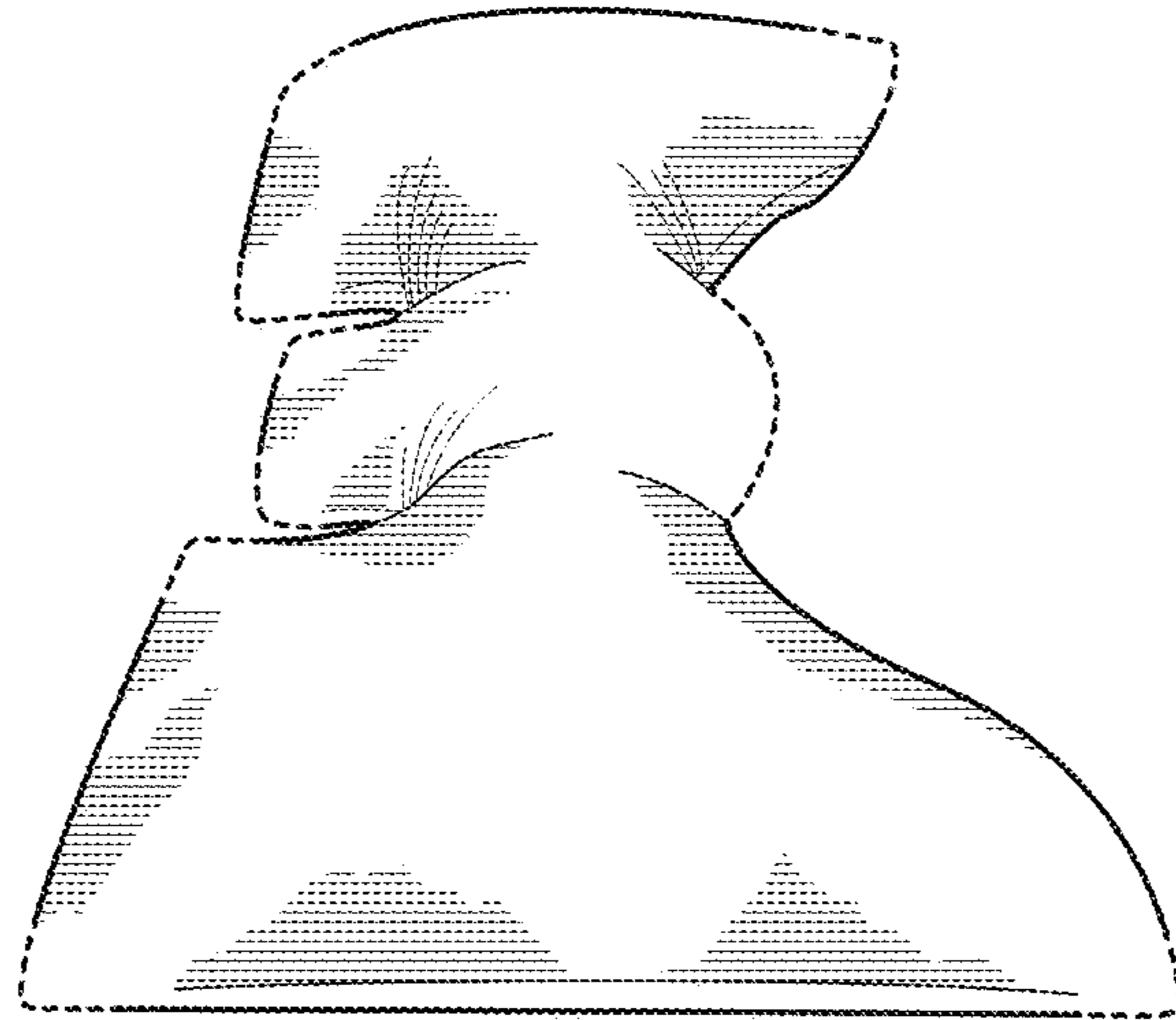

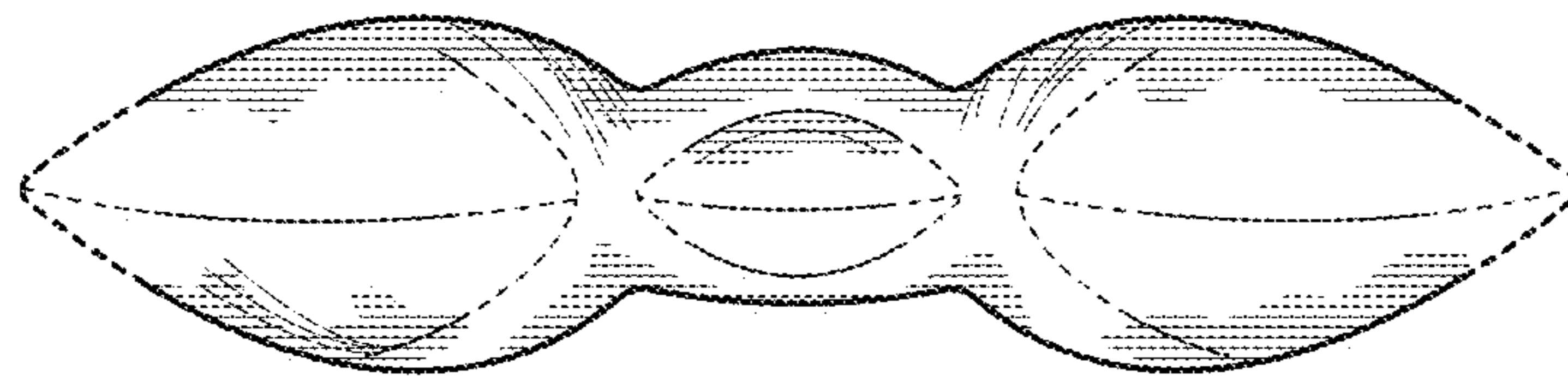

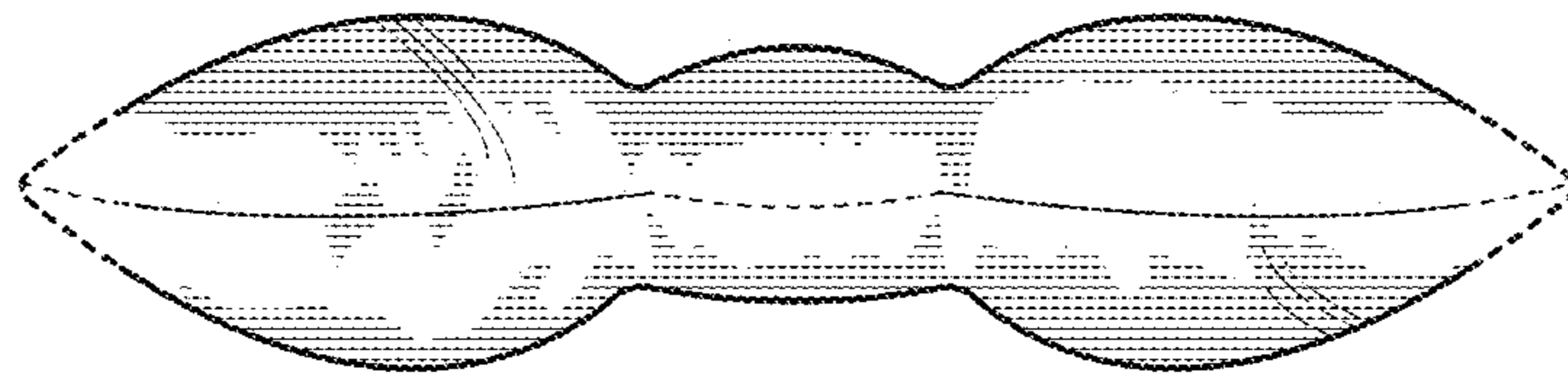

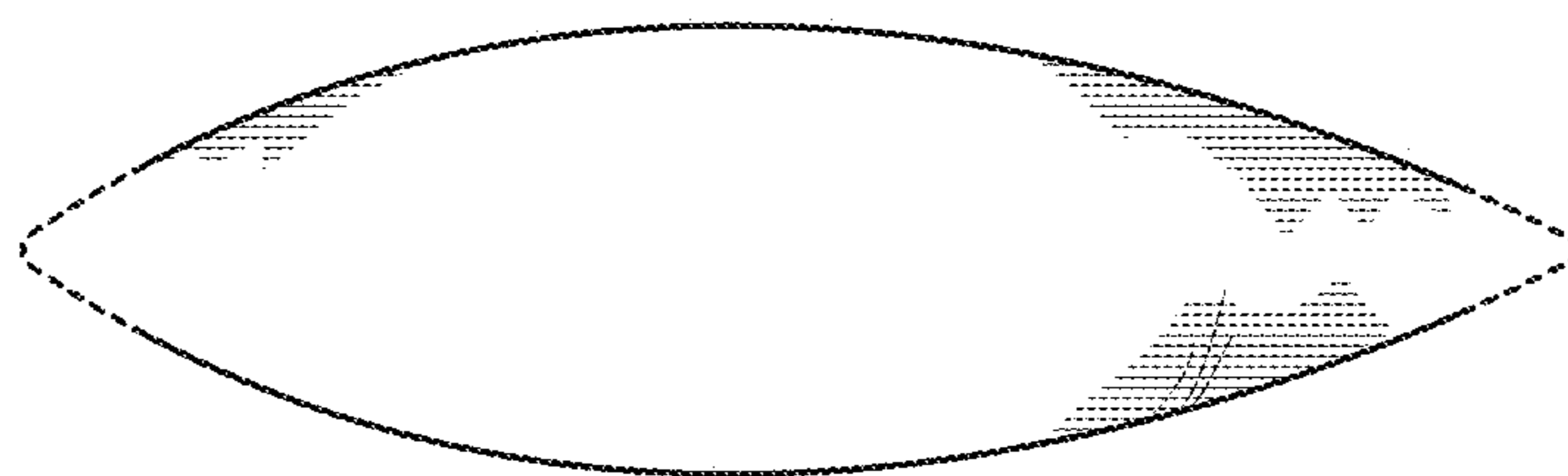

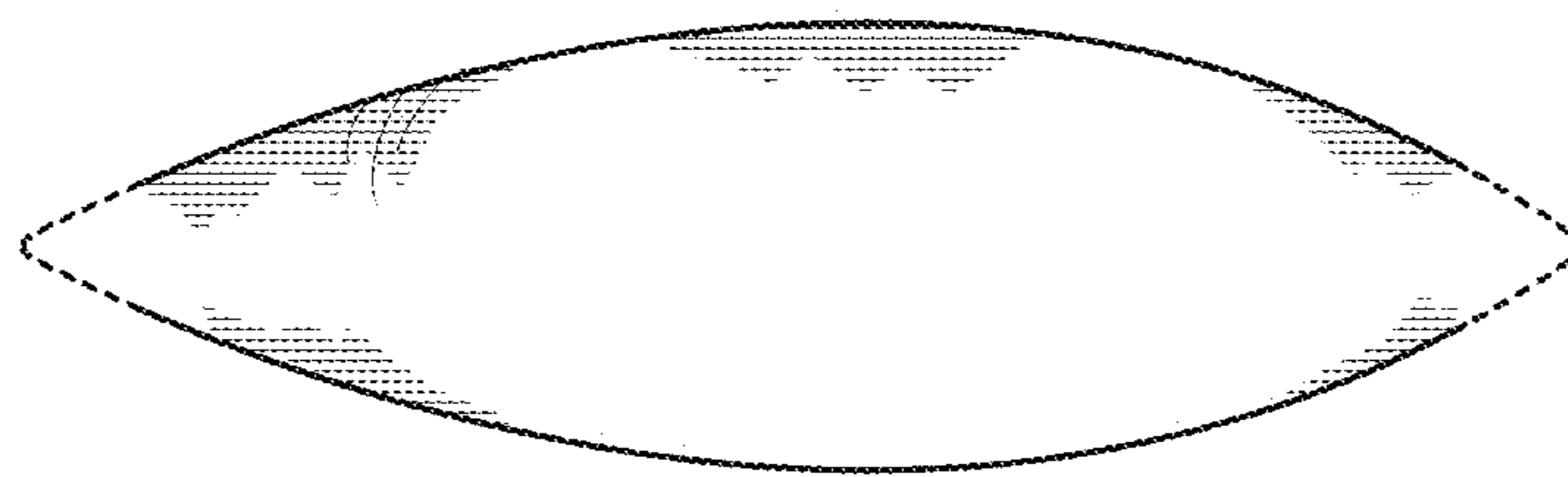

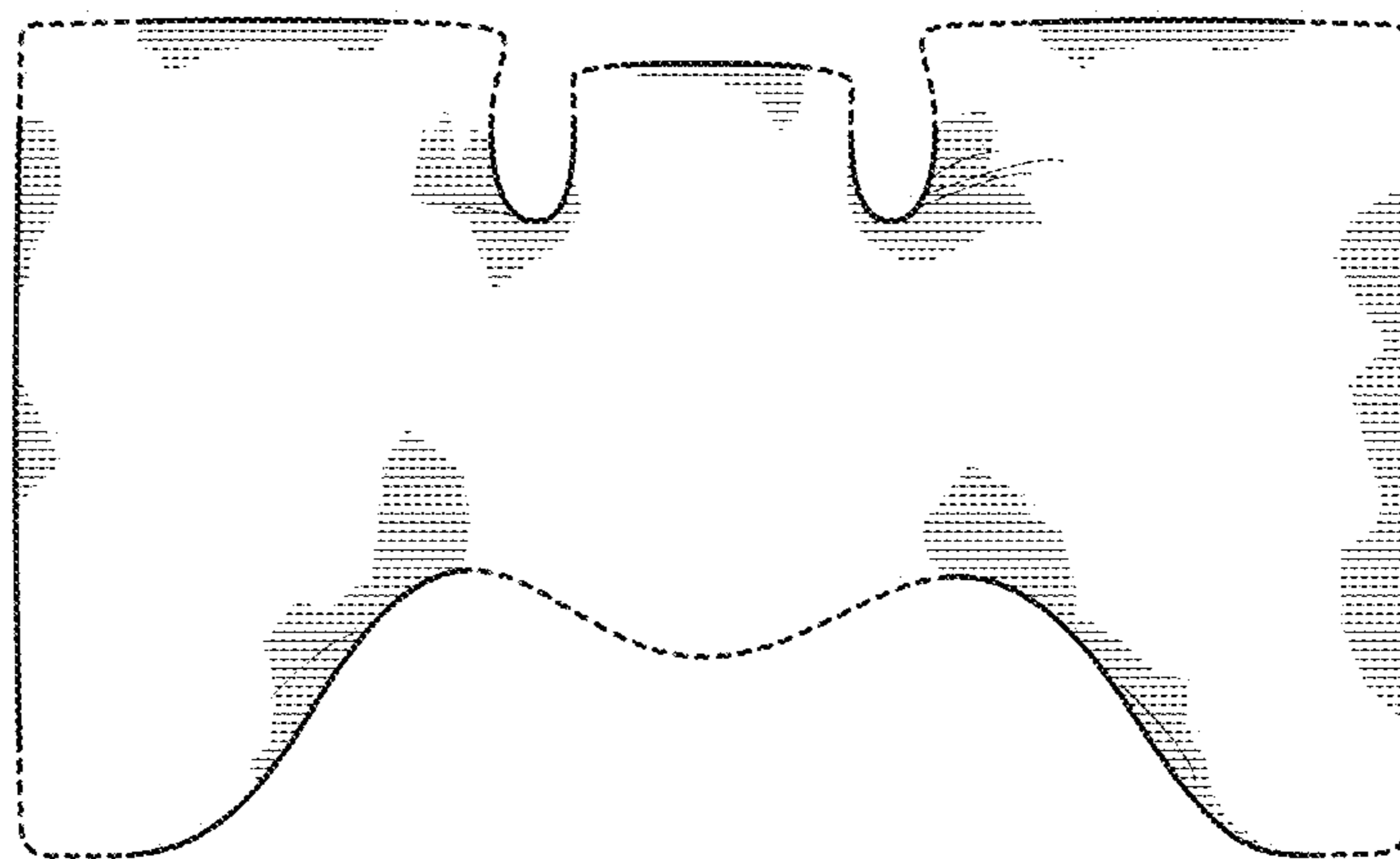

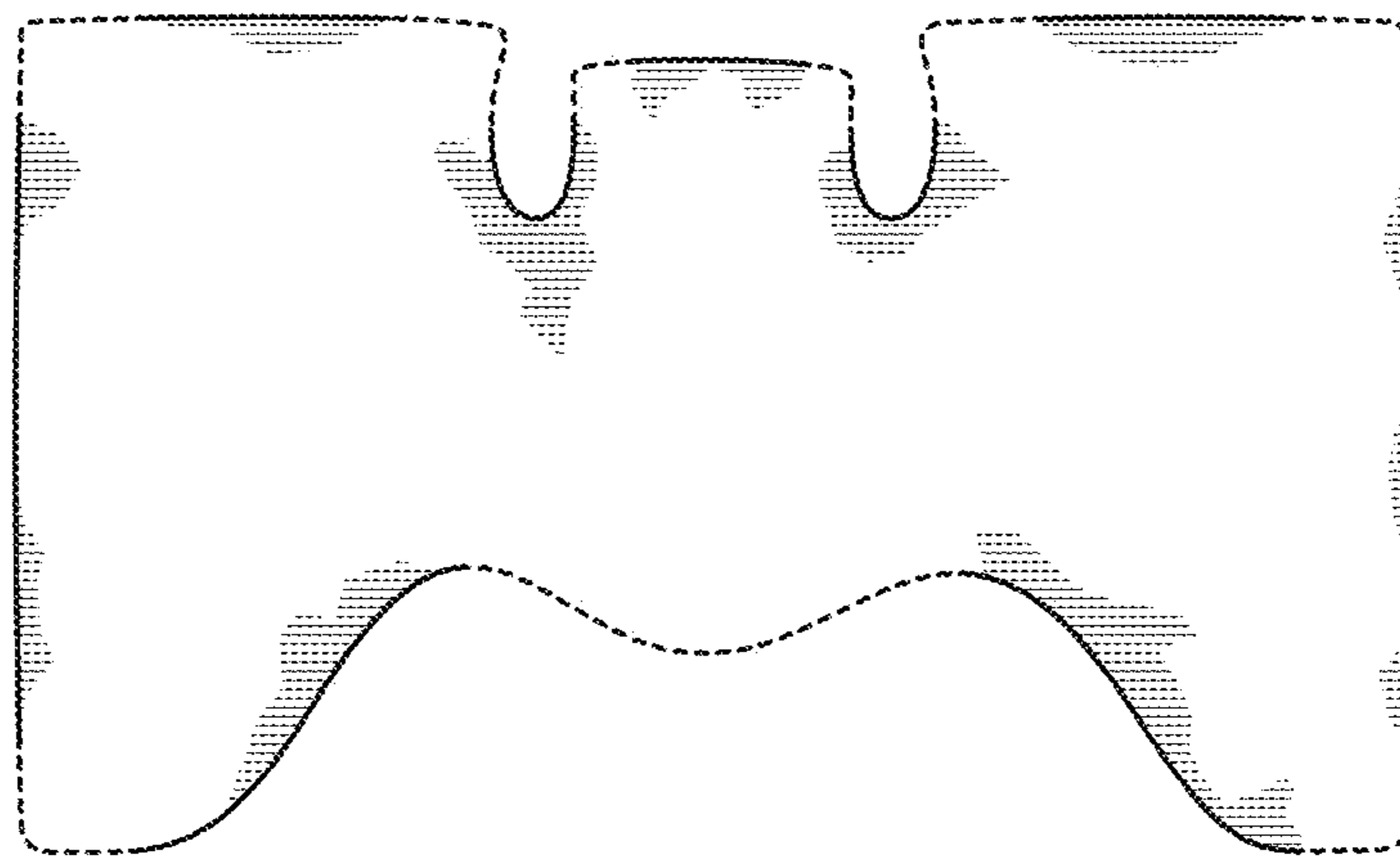
