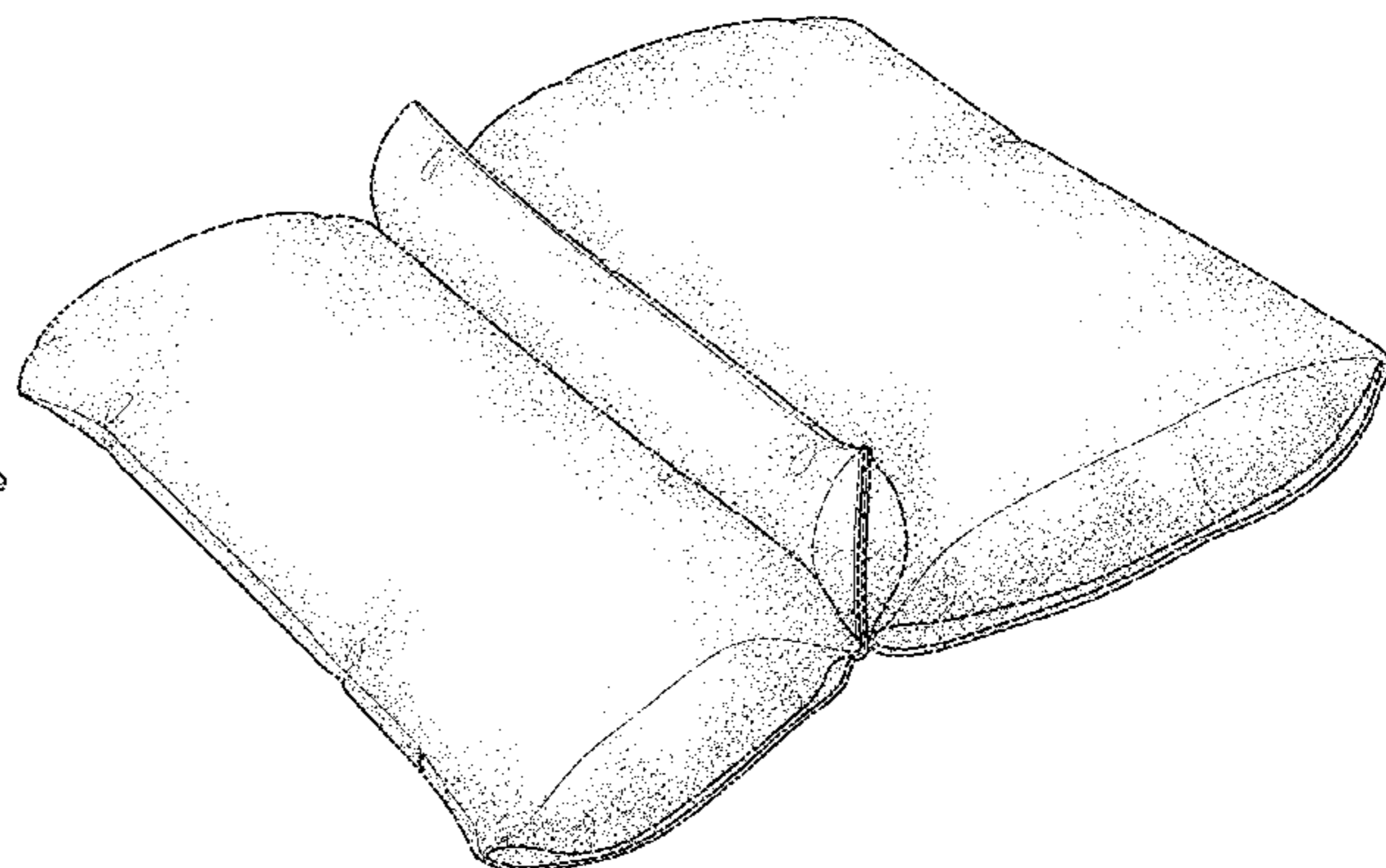
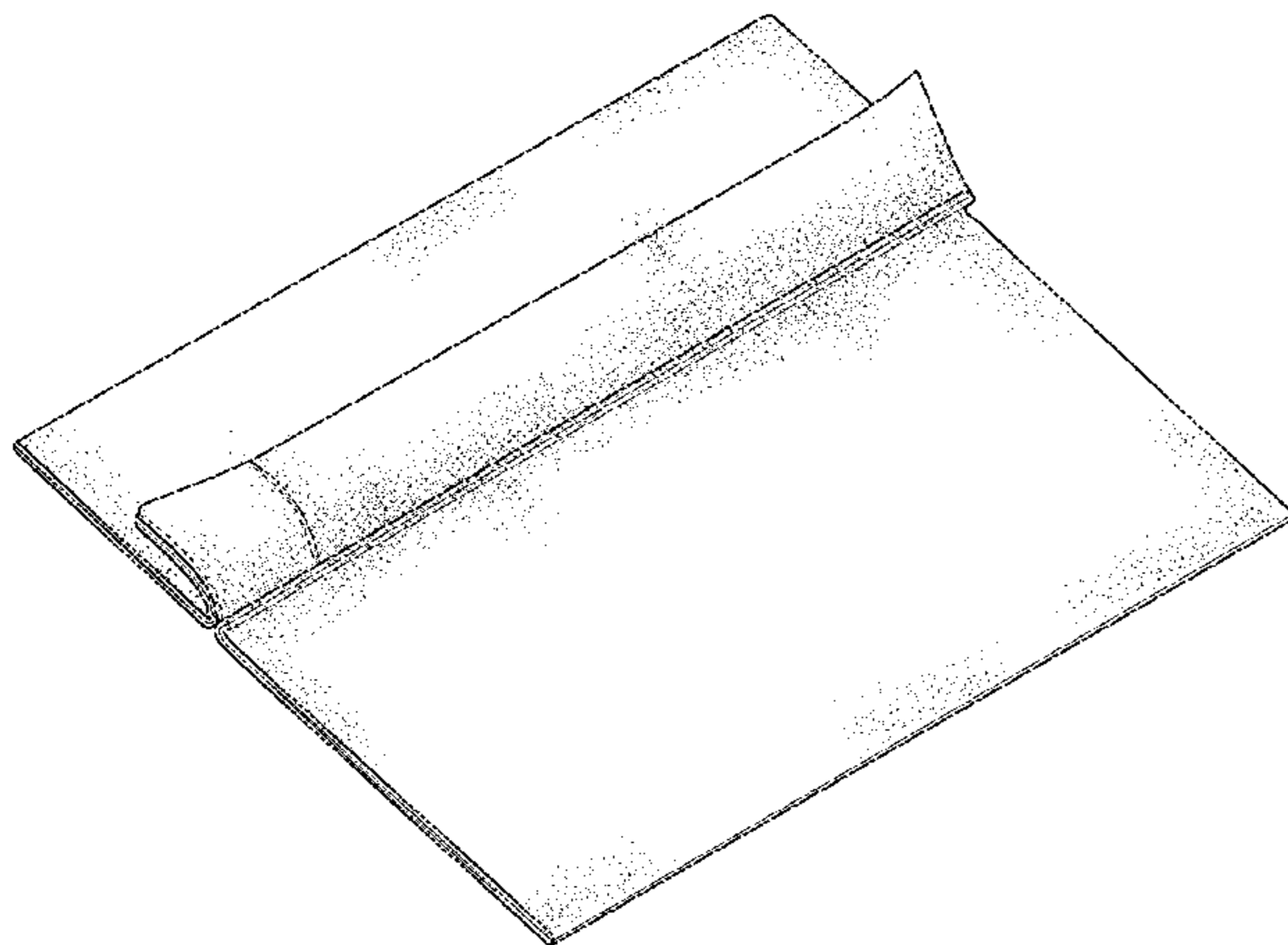
(57) **CLAIM**

I claim the ornamental design for the pillow with removable inserts, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top, and left side perspective view of a pillow with removable inserts, wherein the inserts are removed;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top elevational view thereof;  
FIG. 7 is a bottom elevational view thereof;  
FIG. 8 is a rear, left, and top perspective view of the pillow with removable inserts wherein the two inserts have been inserted into the pockets;  
FIG. 9 is a front elevational view thereof;  
FIG. 10 is a rear elevational view thereof;  
FIG. 11 is a left side elevational view thereof;  
FIG. 12 is a right side elevational view thereof;  
FIG. 13 is a top elevational view thereof; and,  
FIG. 14 is a bottom elevational view thereof.  
The broken lines in the figures illustrate claimed stitching.

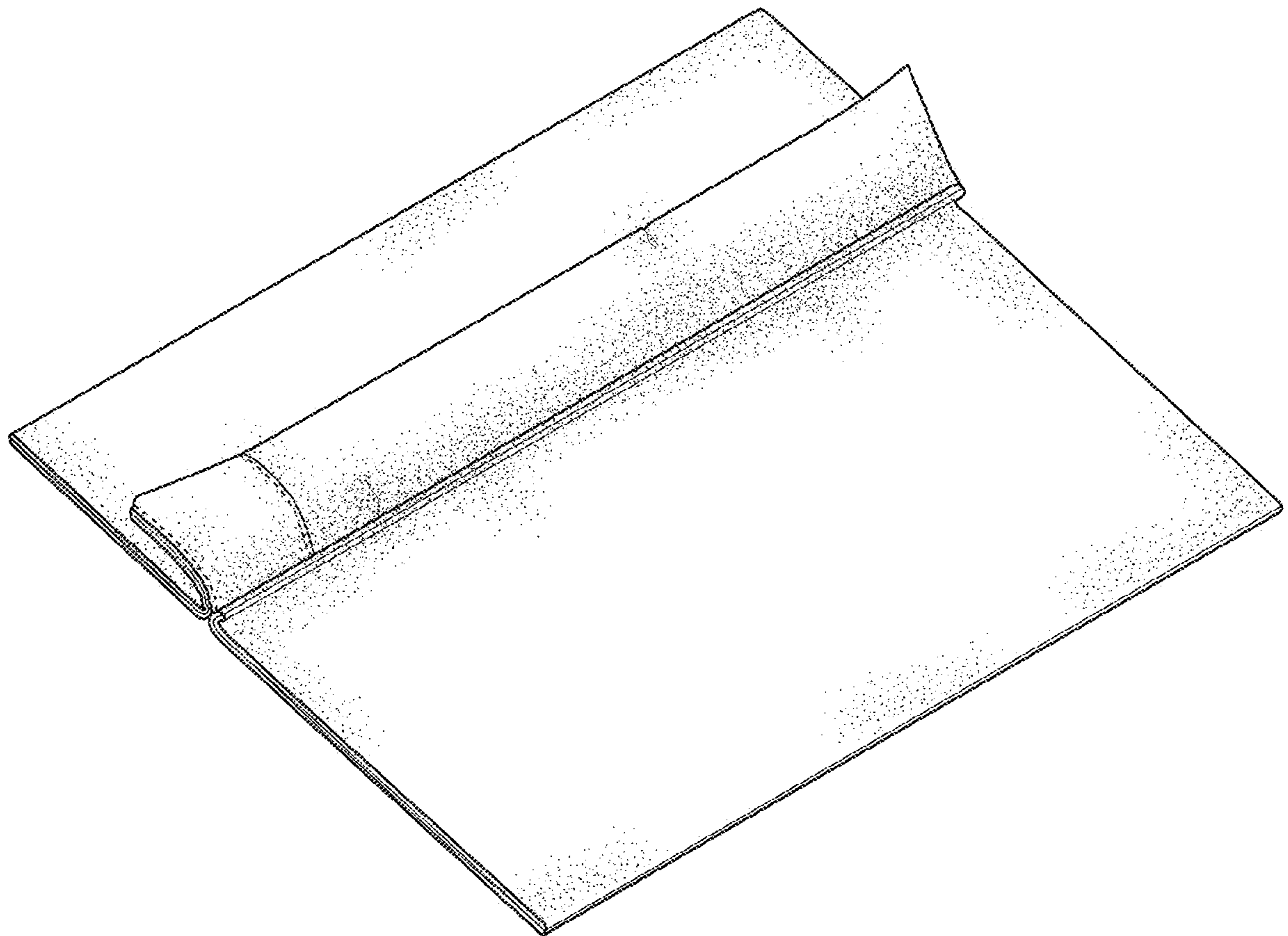

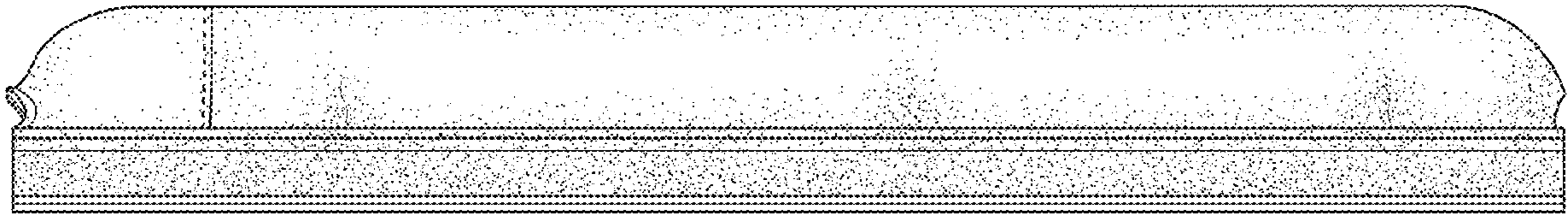

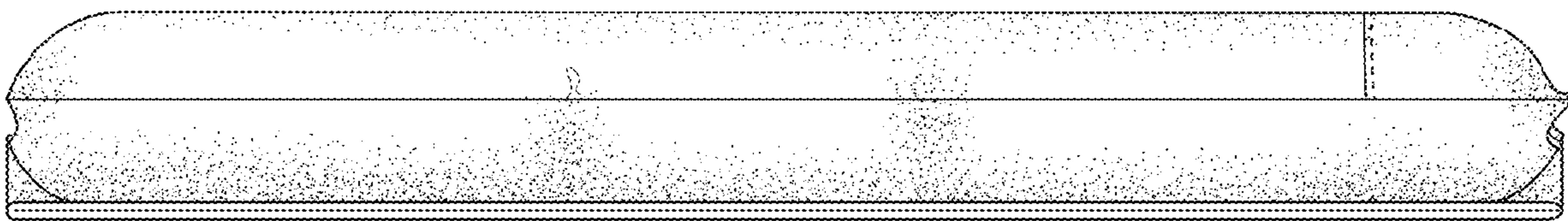

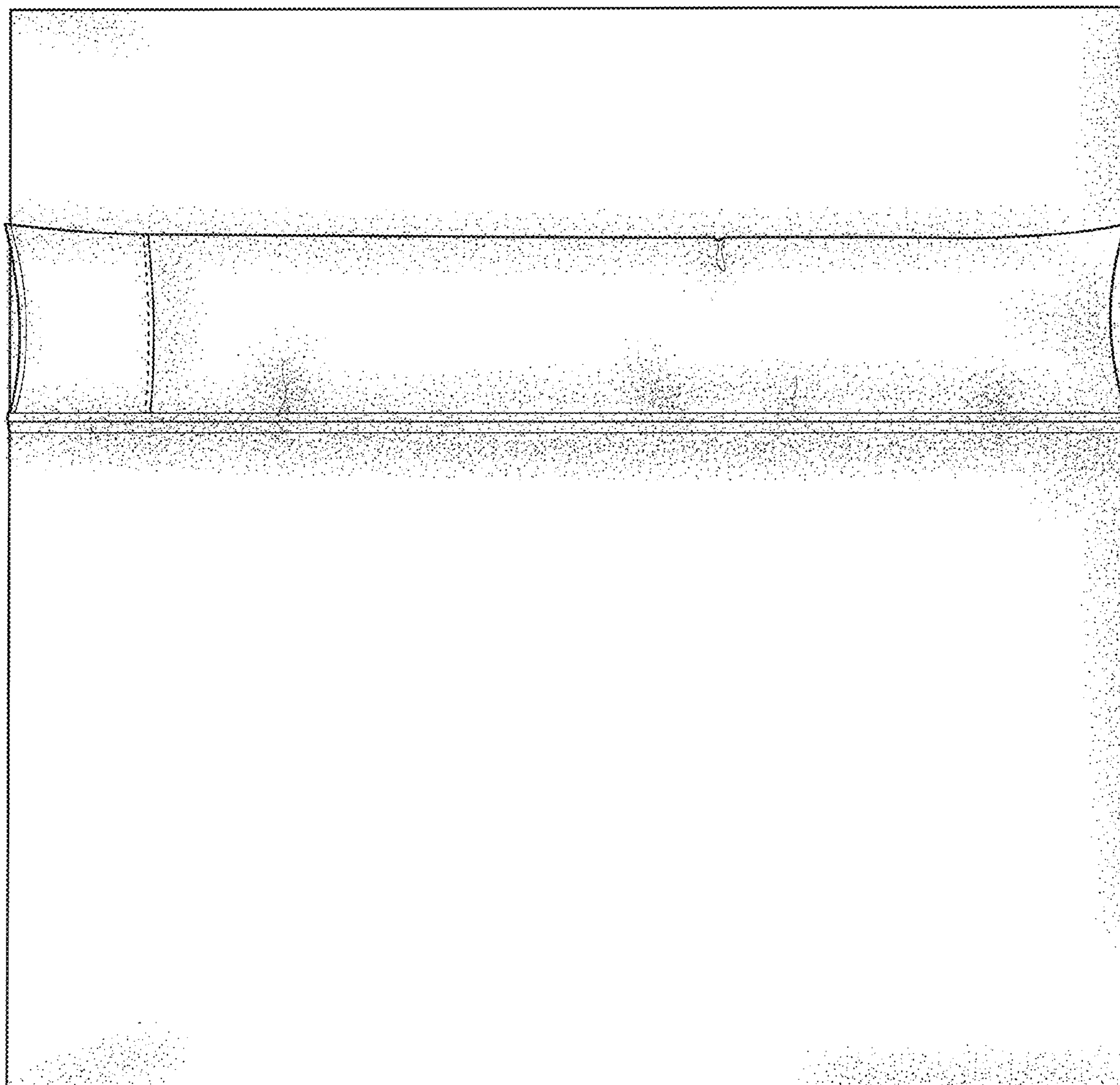

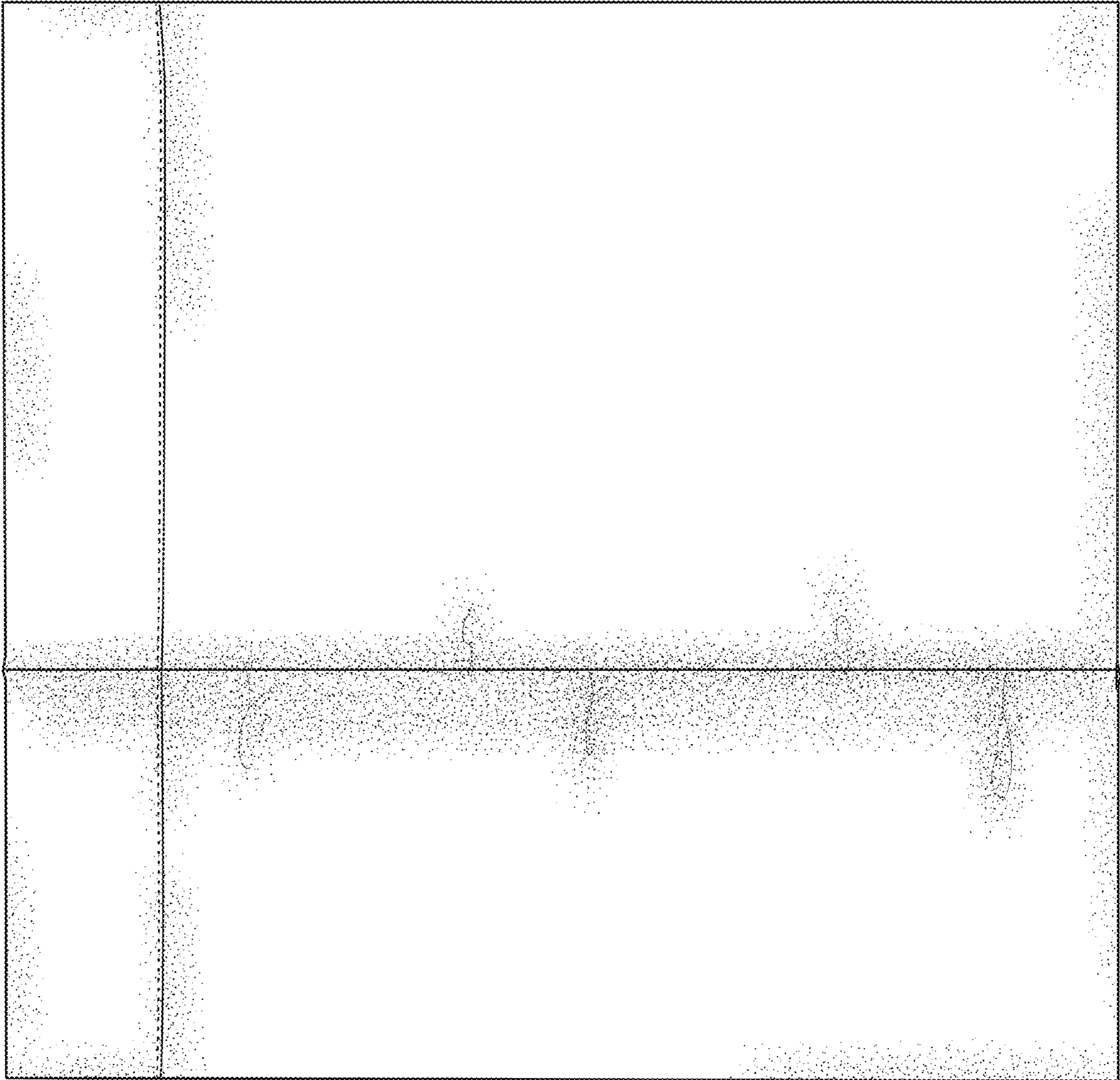

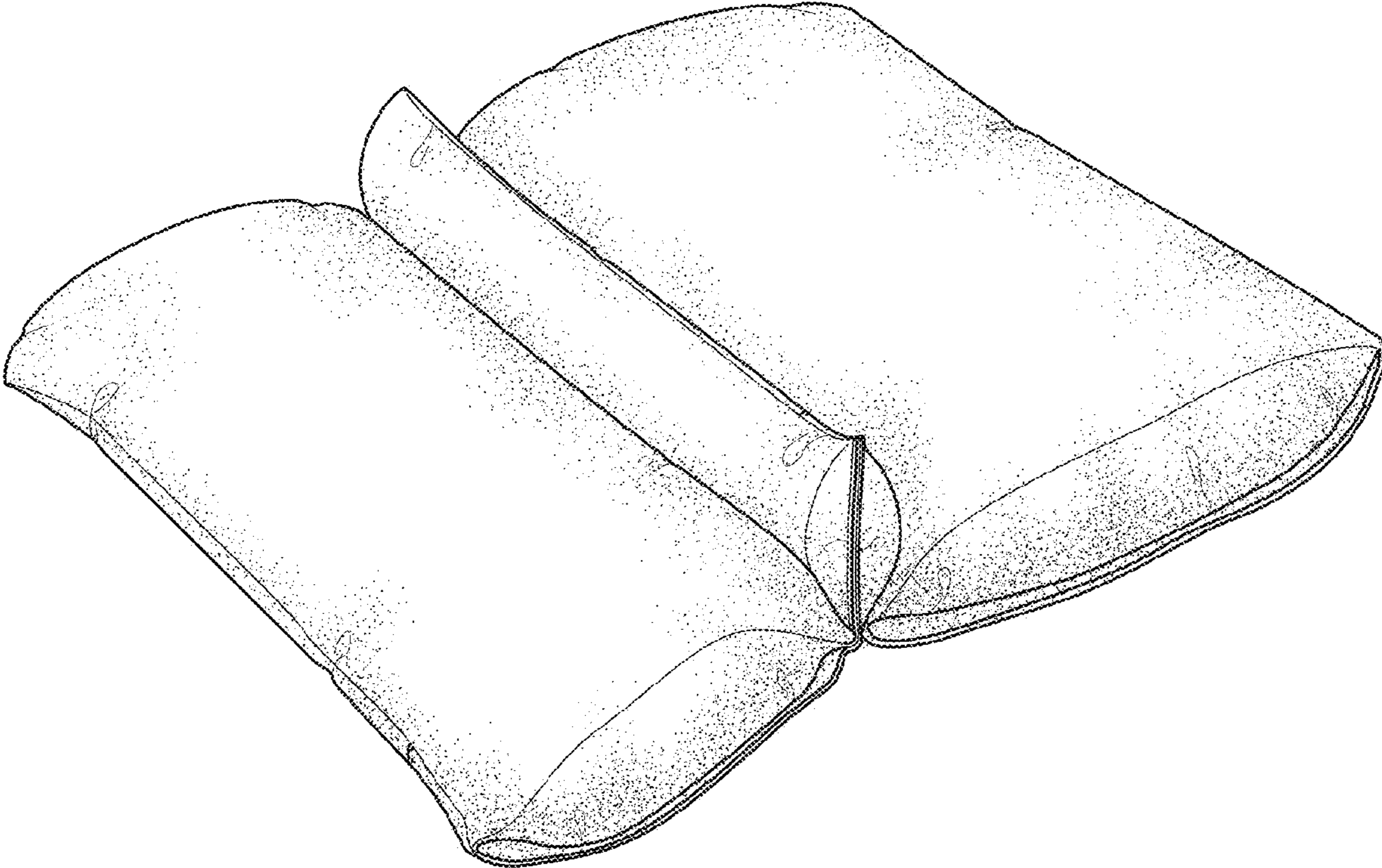

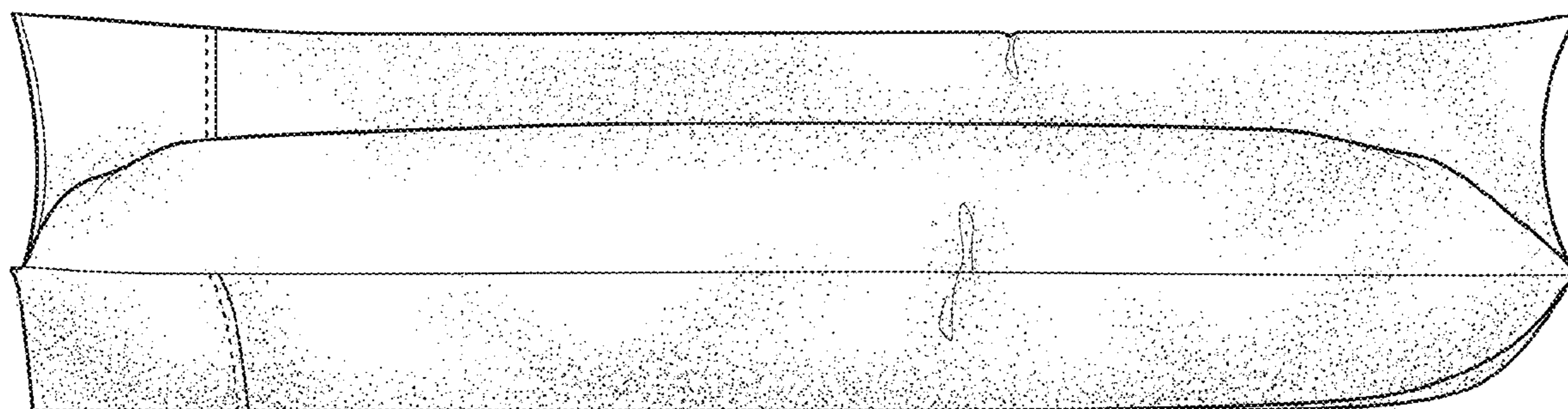

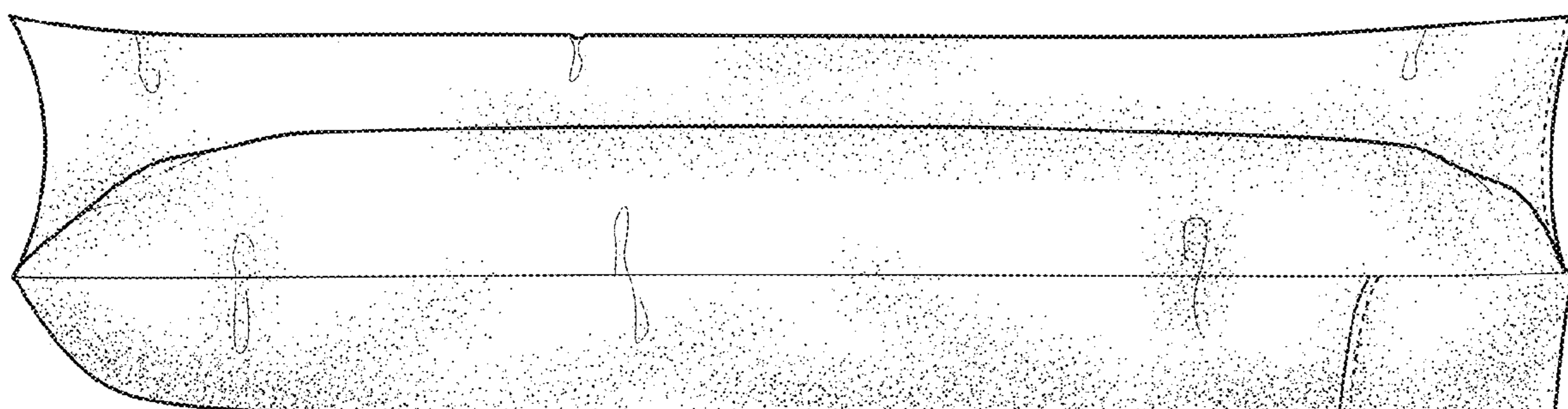

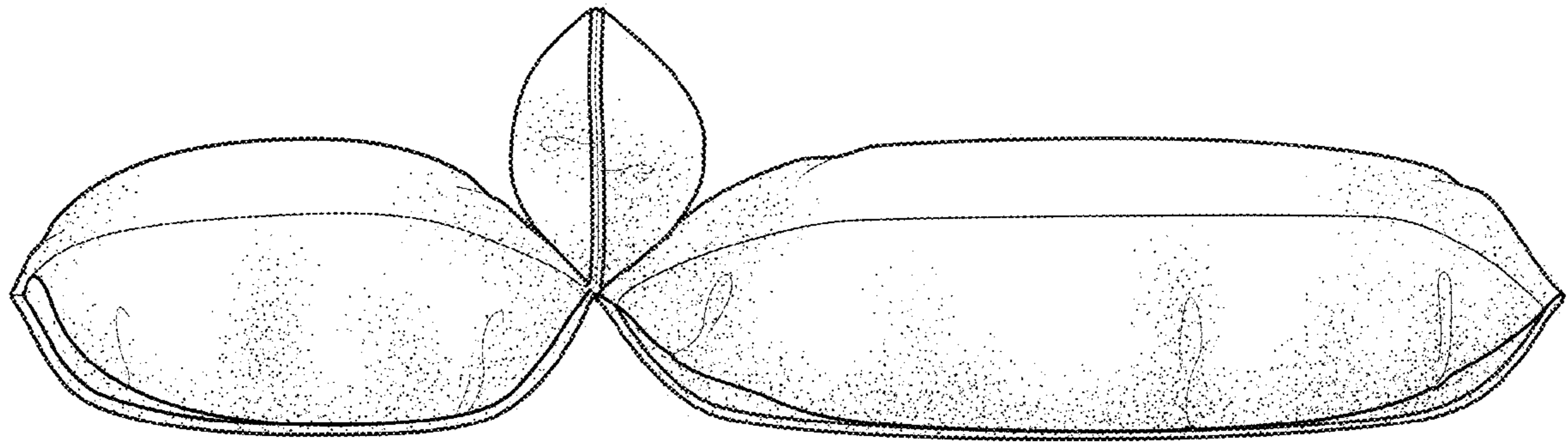

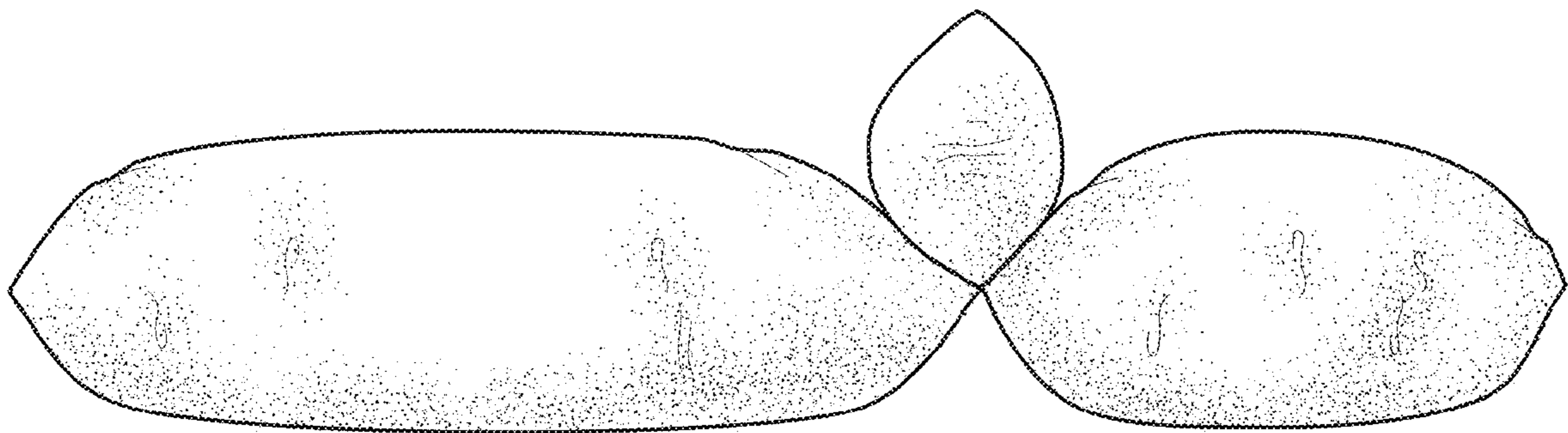

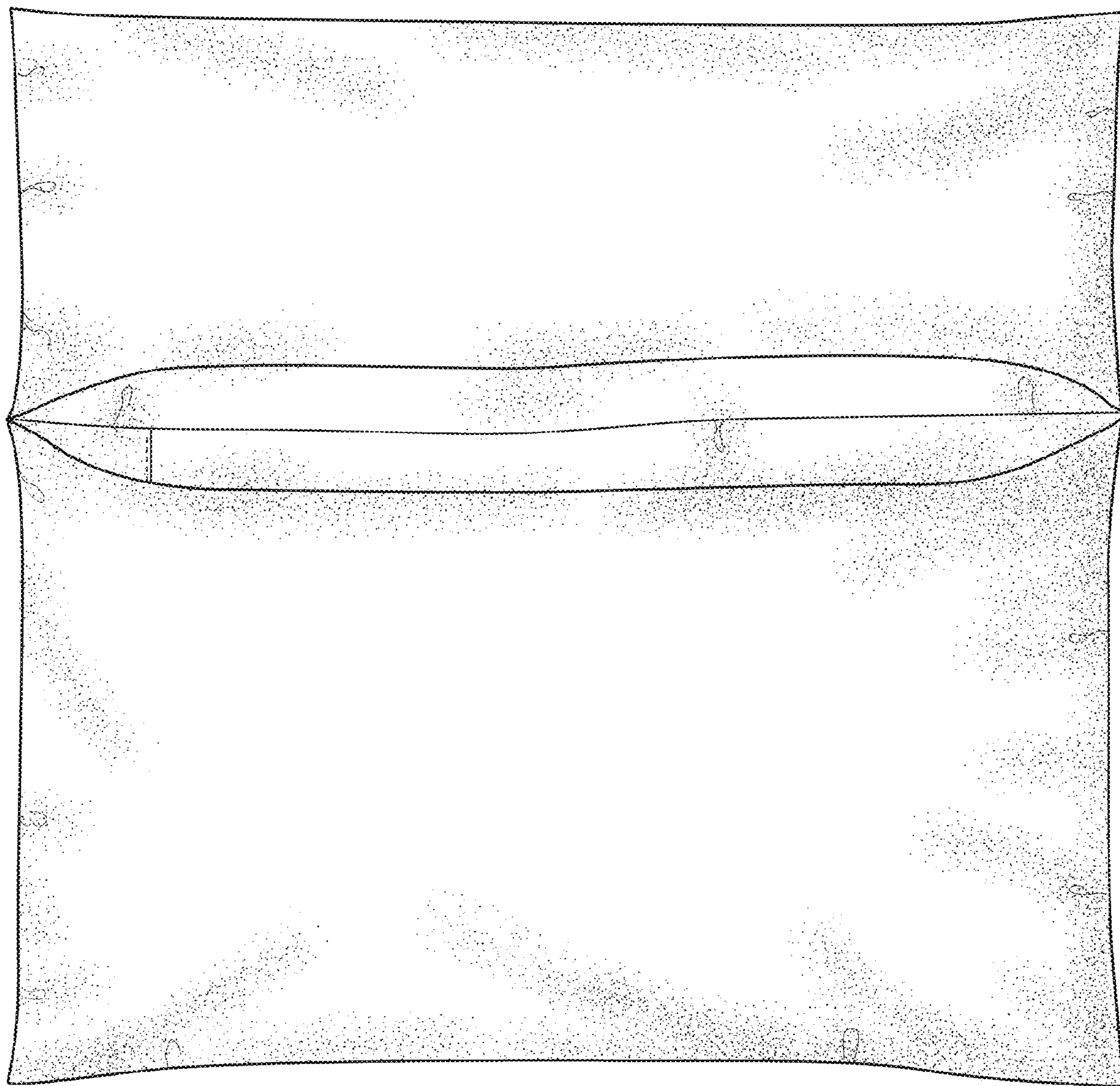

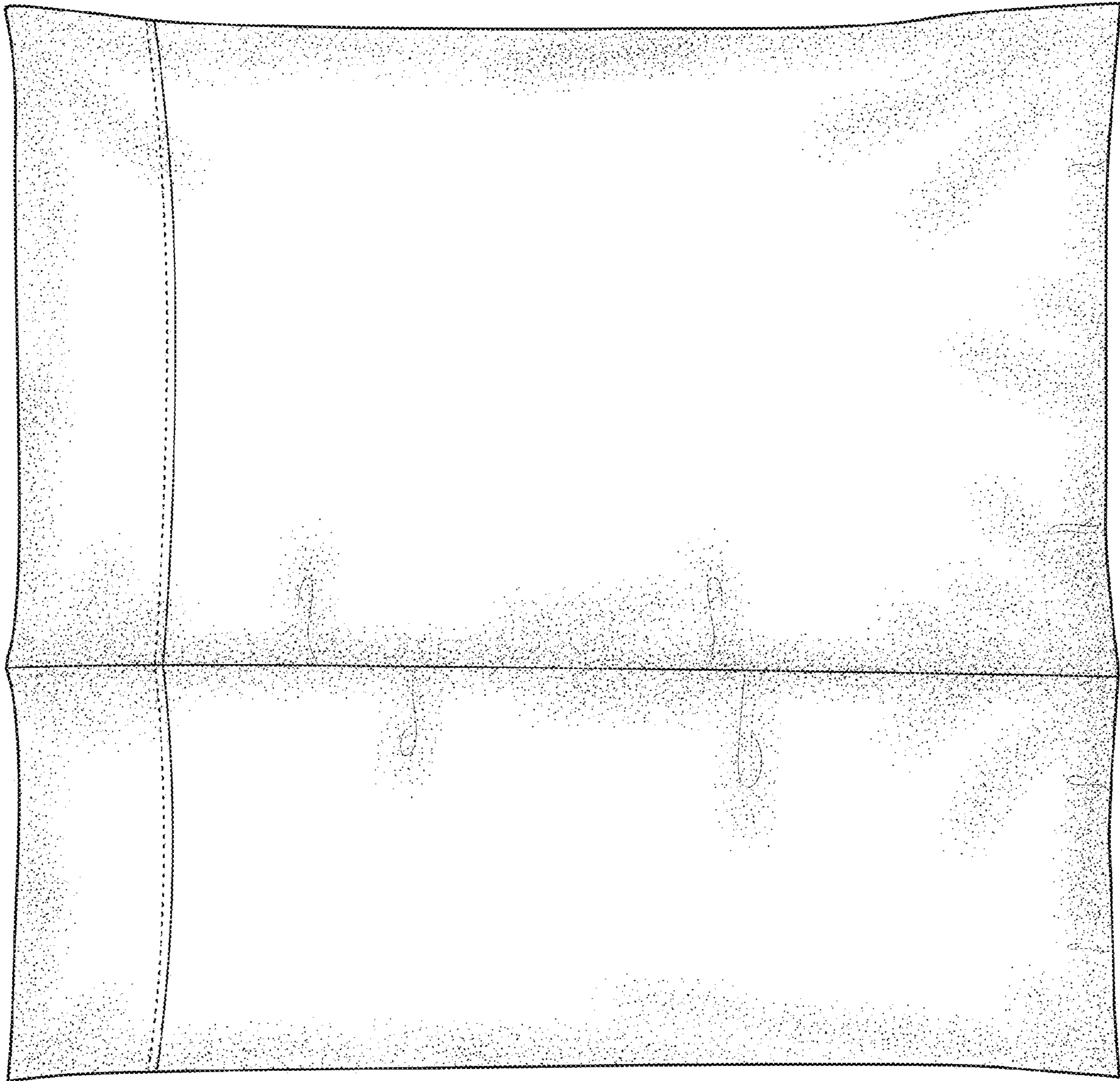
