(57) **CLAIM**

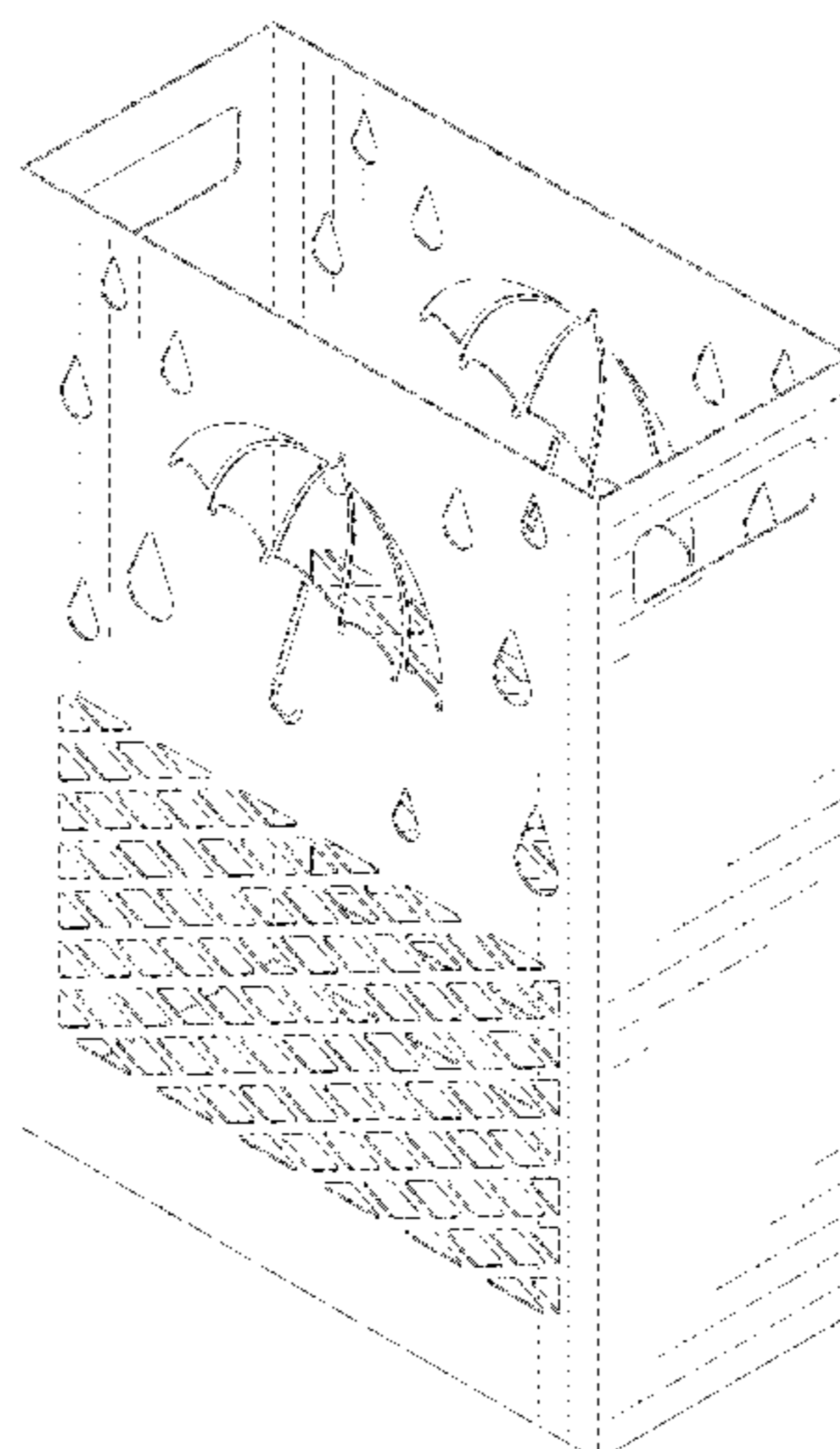
The ornamental design for an umbrella holder, as shown and described.

**DESCRIPTION**

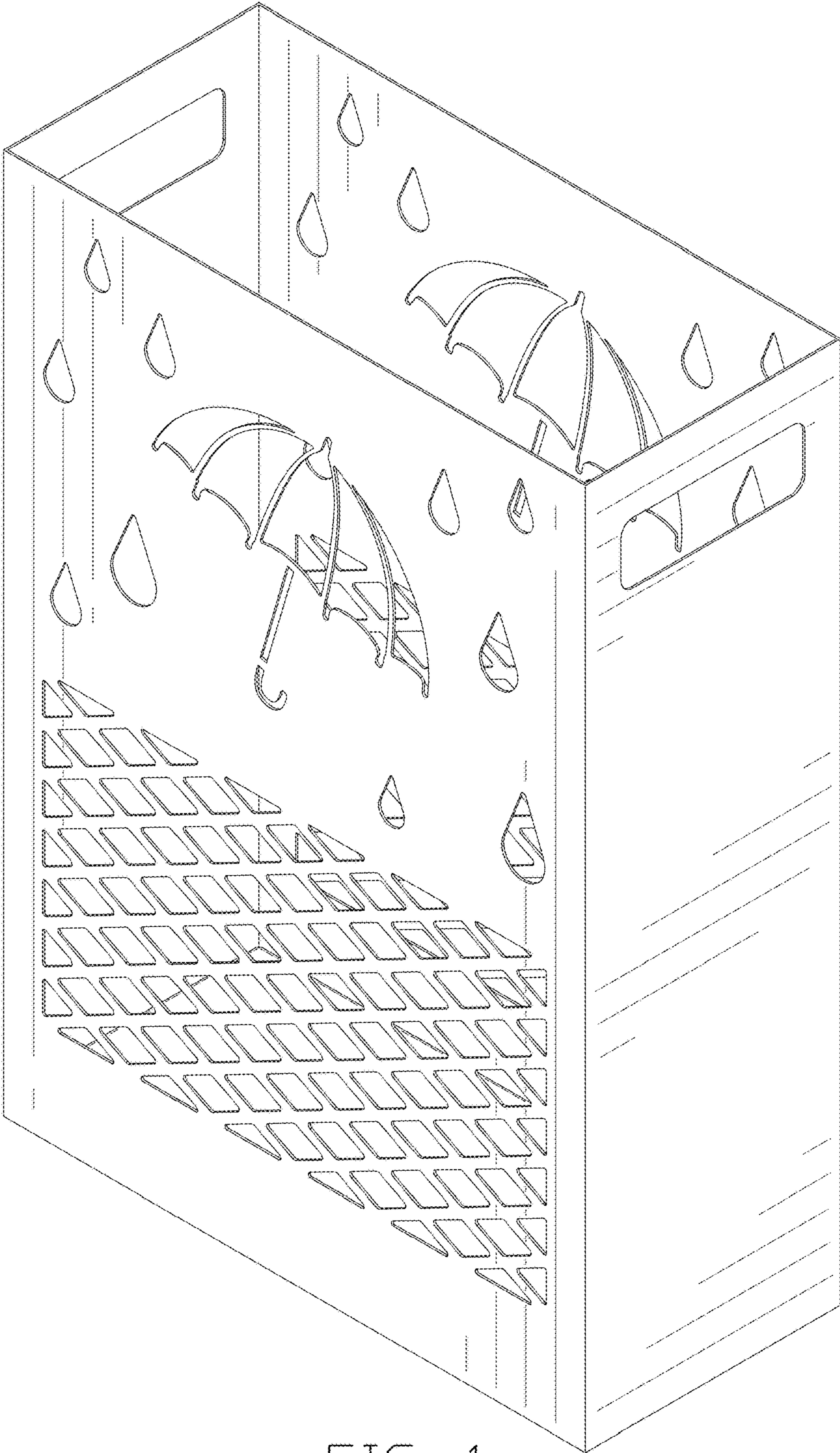

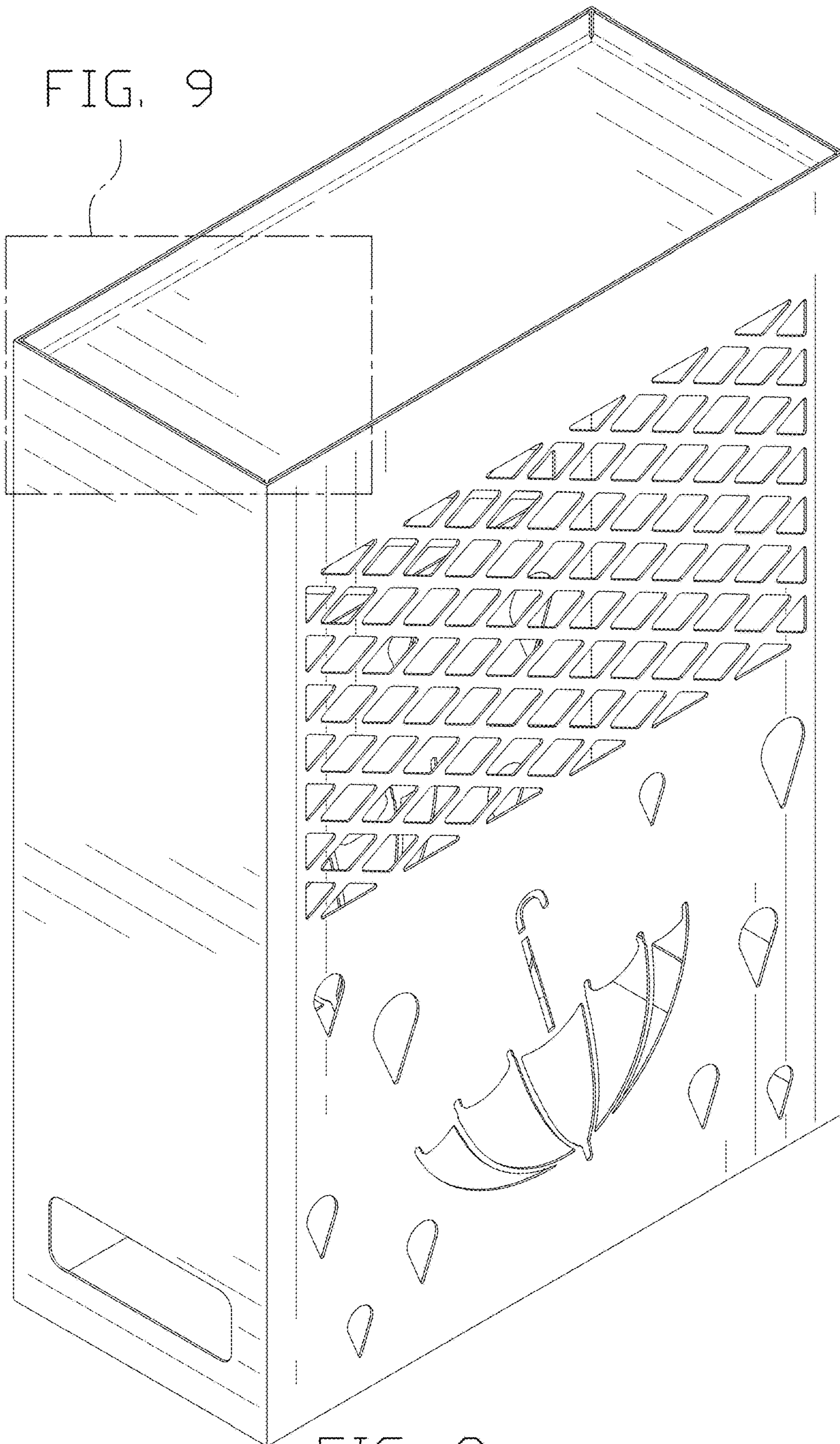

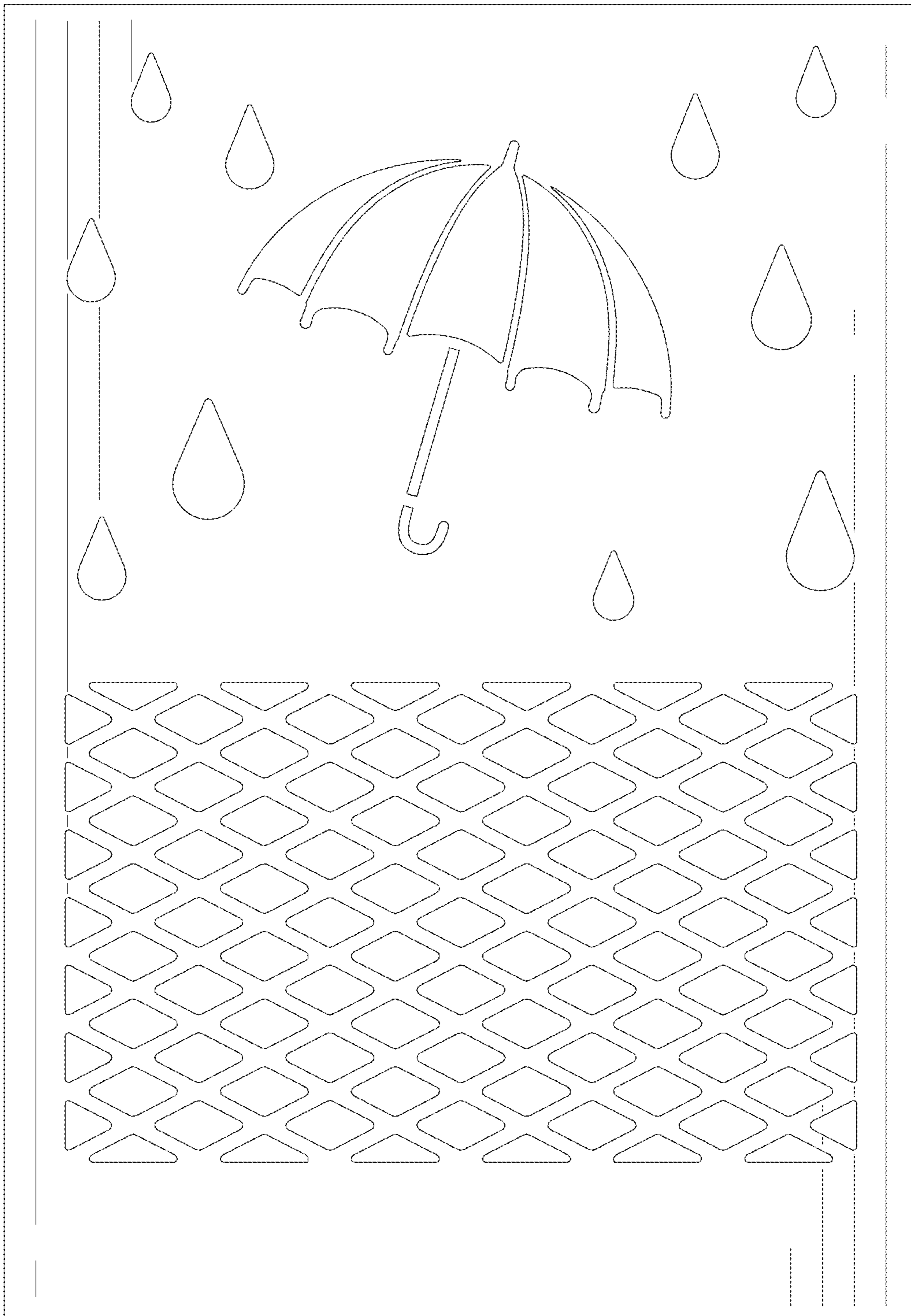

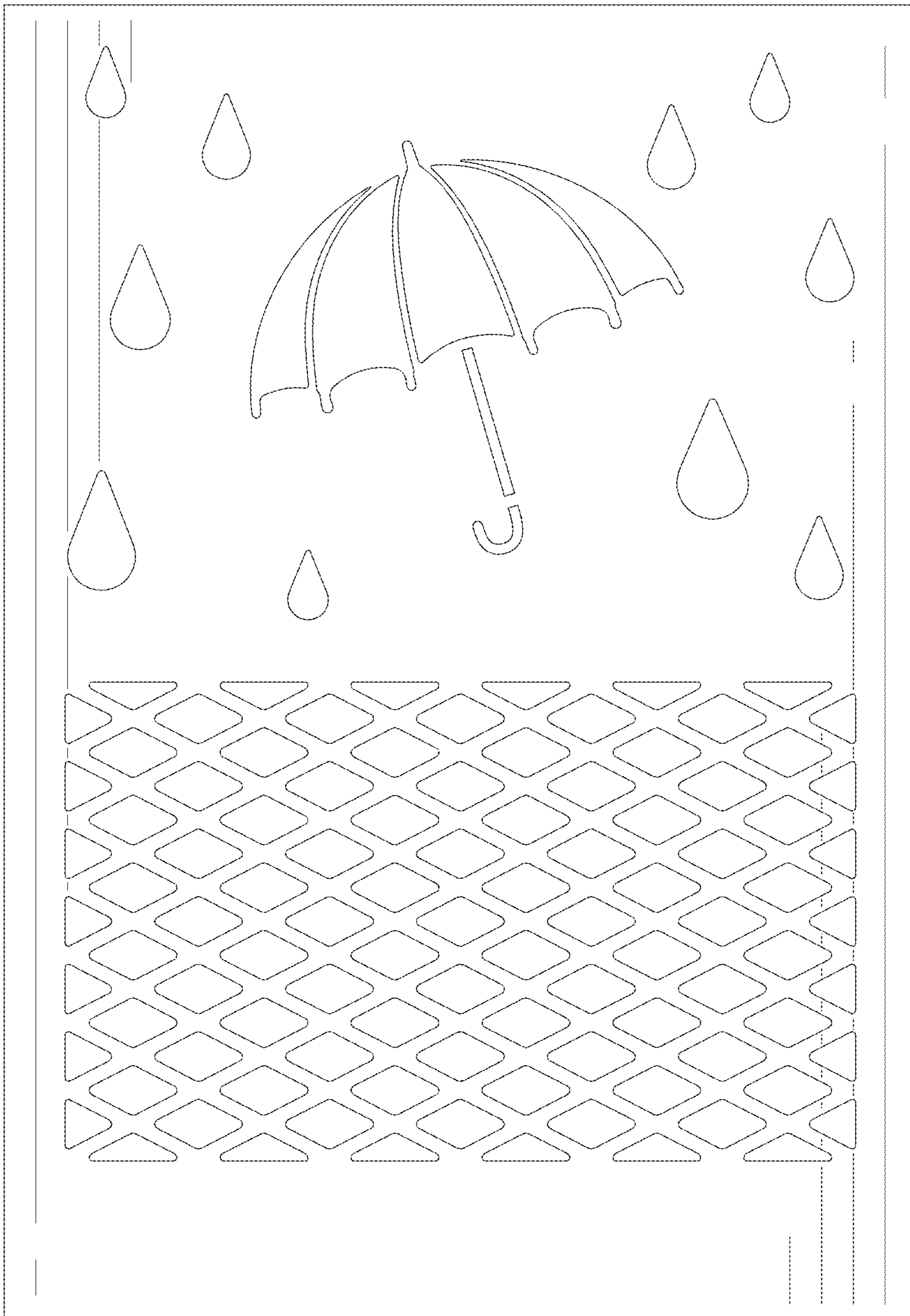

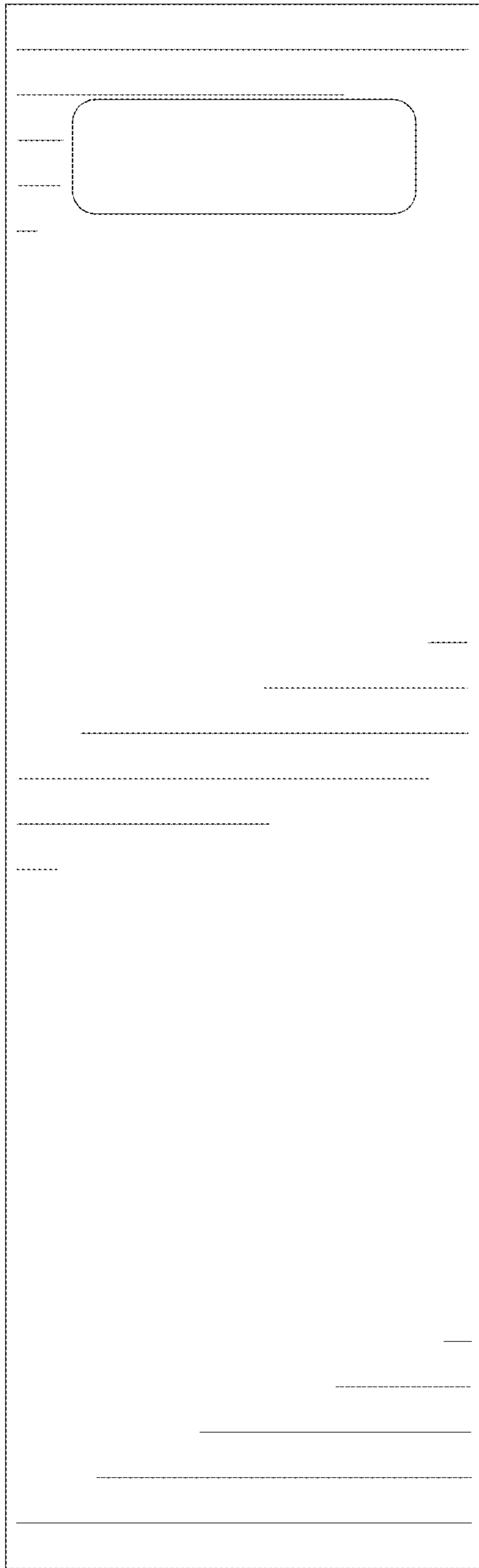

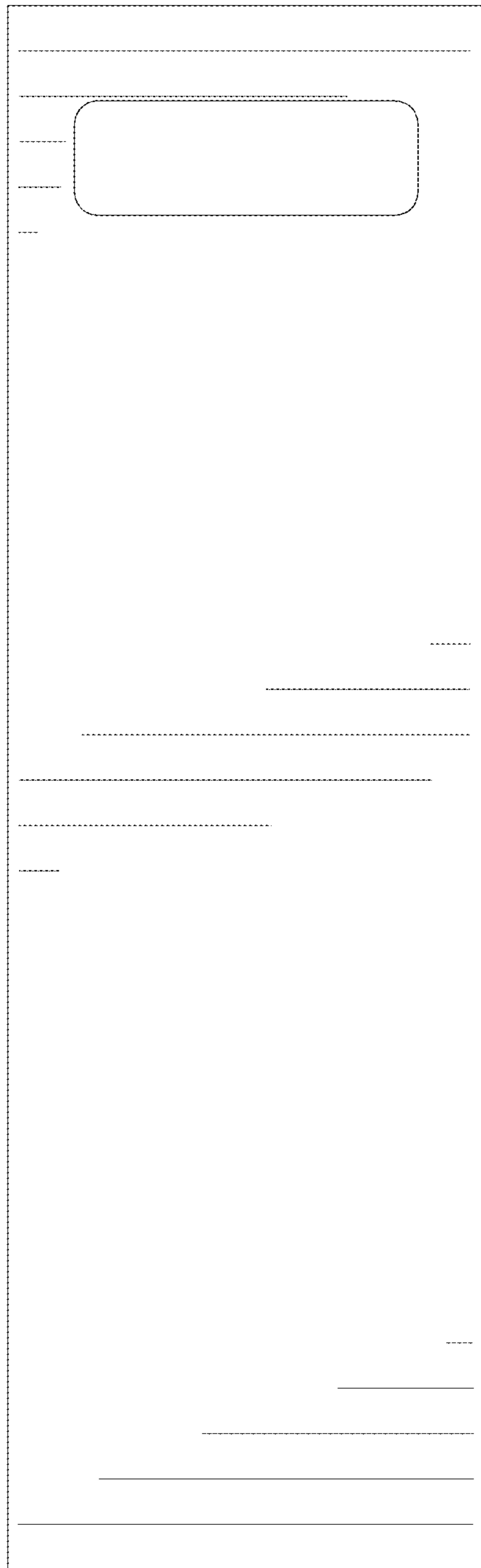

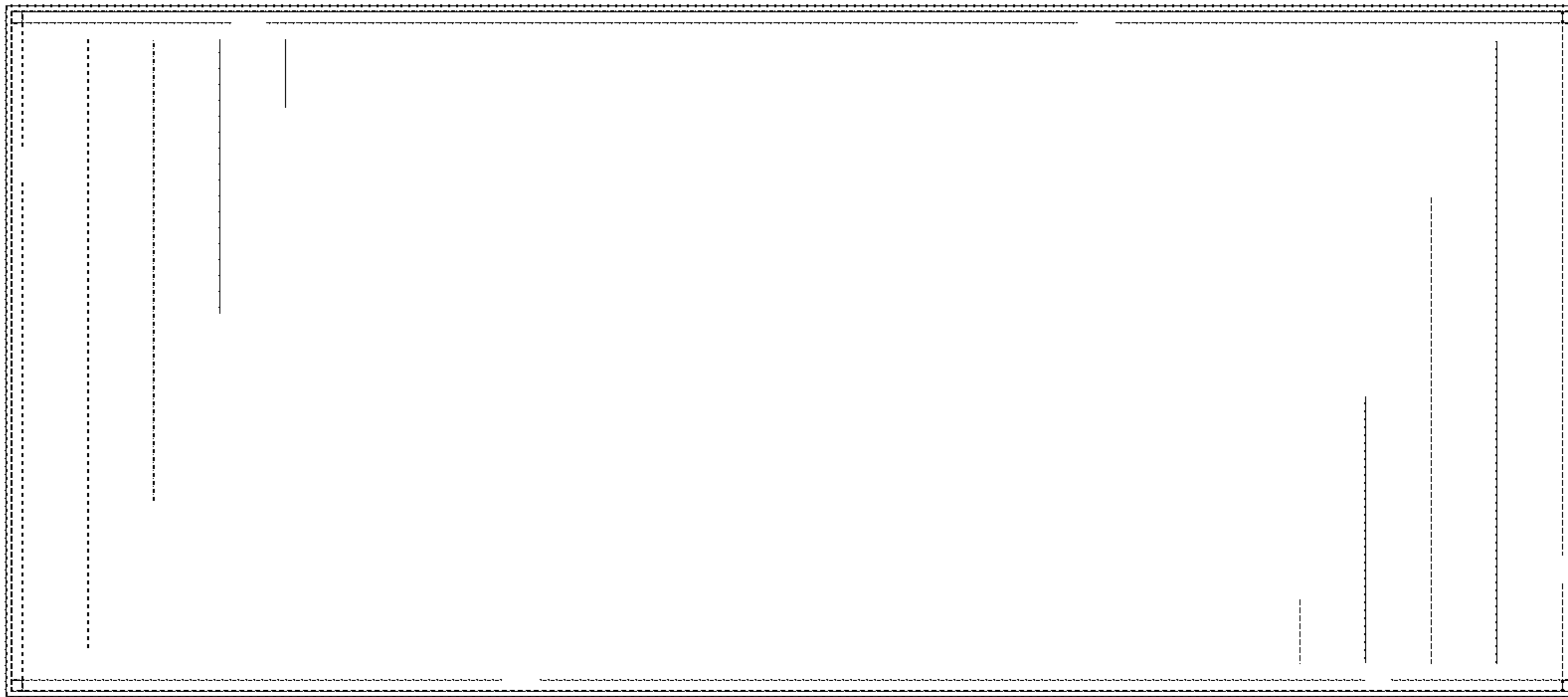

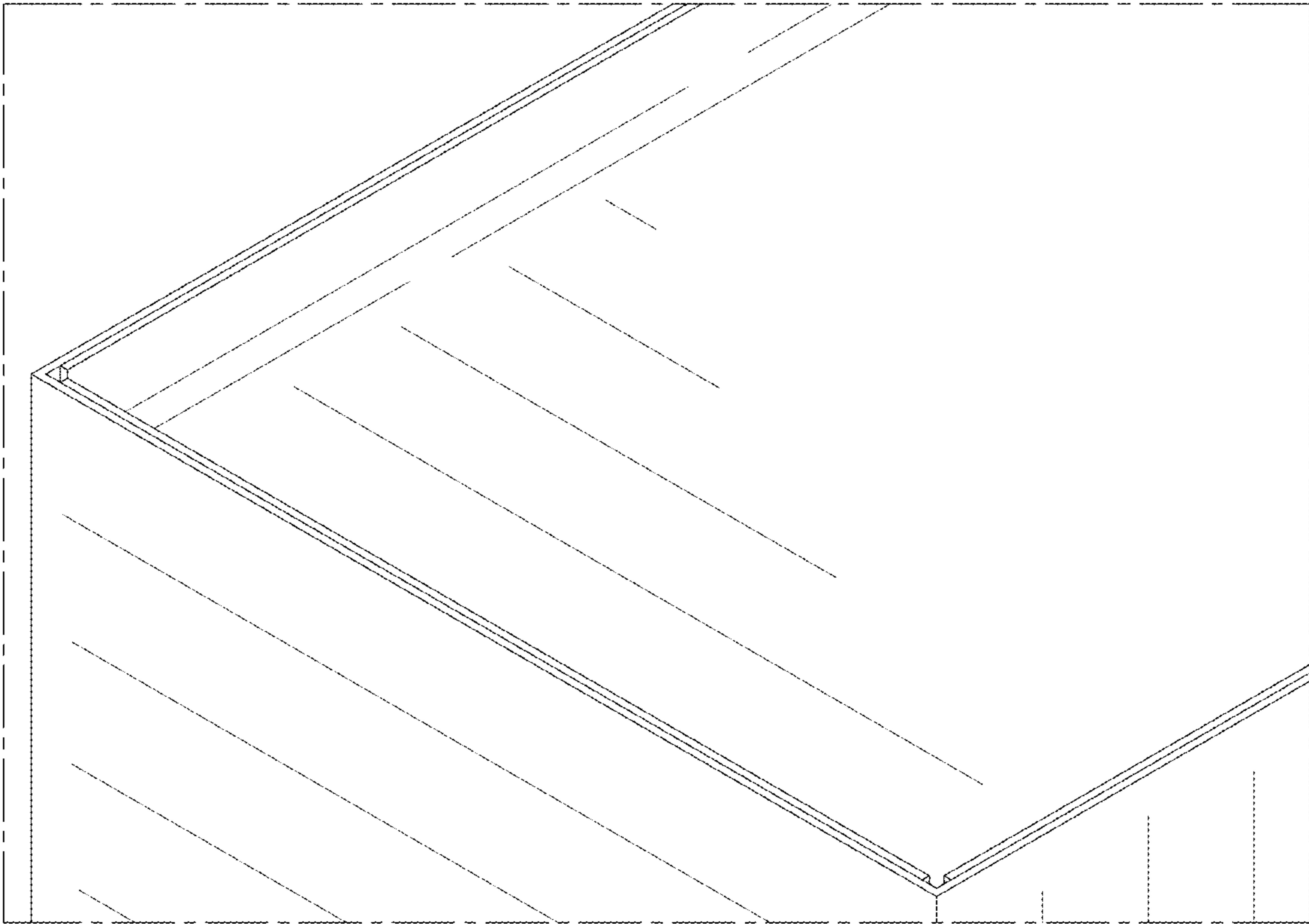
