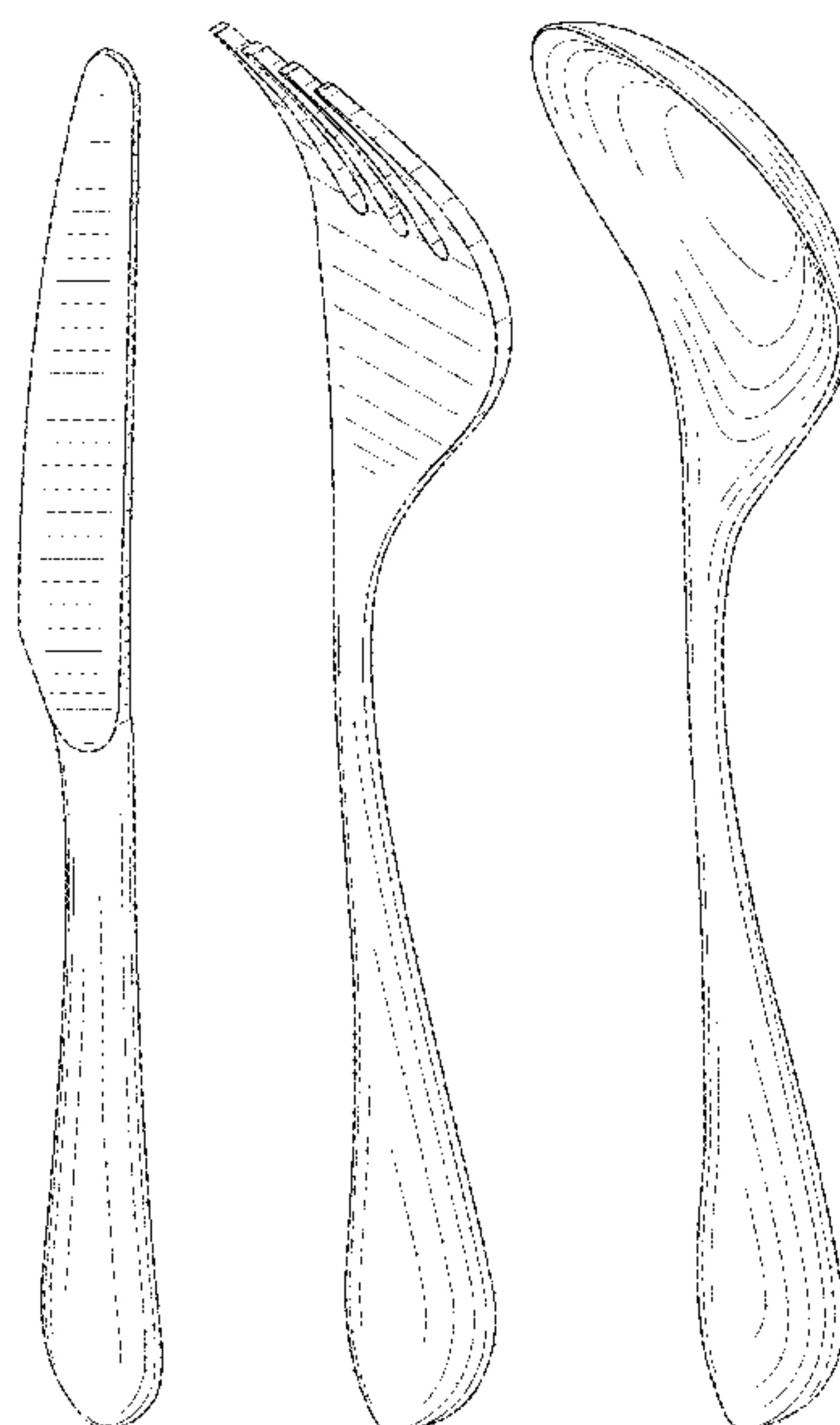
(57) **CLAIM**

The ornamental design for a cutlery set, as shown.

## DESCRIPTION

FIG. 1 is a perspective view of a cutlery set comprising a knife, a fork, and a spoon showing my new design;  
FIG. 2 is a left side view of the knife, the right side view being a mirror image thereof;  
FIG. 3 is a top view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is an end view thereof as seen from the blade end;  
FIG. 6 is an end view thereof as seen from the handle end;  
FIG. 7 is a top view of the fork;  
FIG. 8 is a bottom view thereof;  
FIG. 9 is a left side view thereof, the right side view being a mirror image thereof;  
FIG. 10 is an end view thereof as seen from the fork tines end;  
FIG. 11 is an end view thereof as seen from the handle end;  
FIG. 12 is a top view of the spoon;  
FIG. 13 is a bottom view thereof;  
FIG. 14 is a left side view thereof, the right side view being a mirror image thereof;  
FIG. 15 is an end view thereof as seen from the bowl end;  
and,  
FIG. 16 is an end view thereof as seen from the handle end.

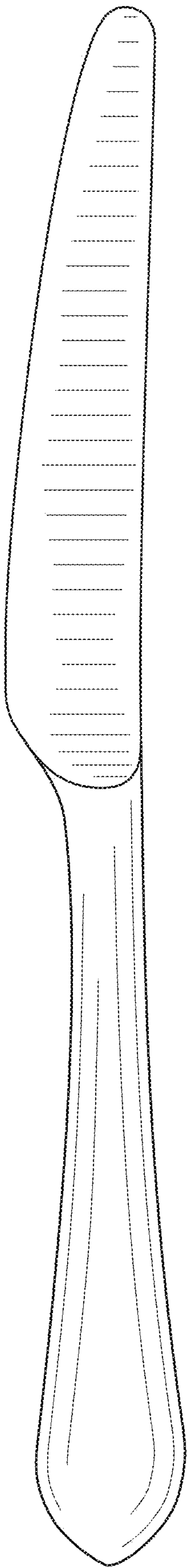

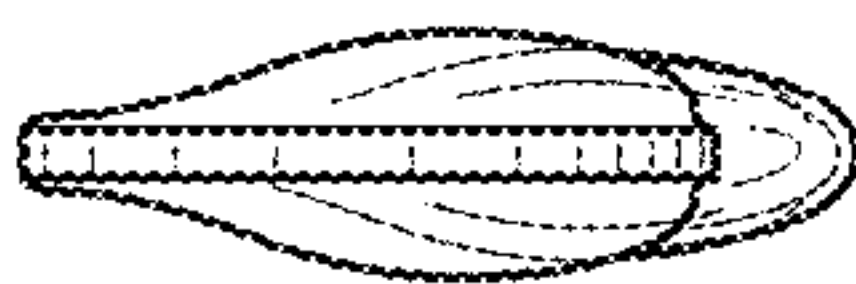

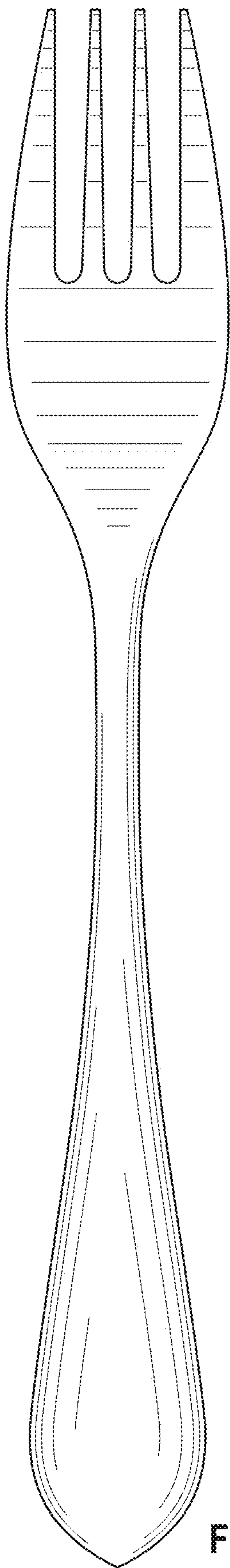

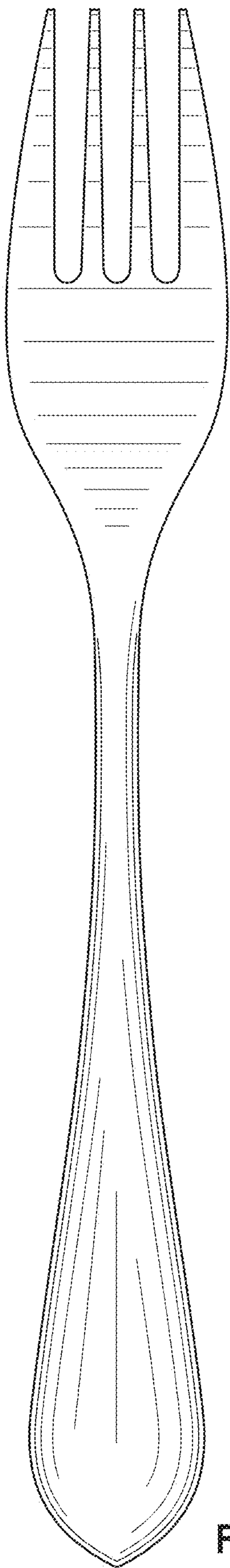

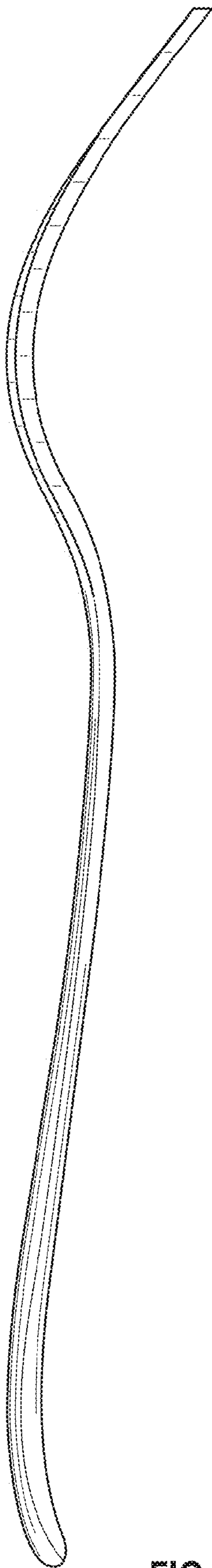

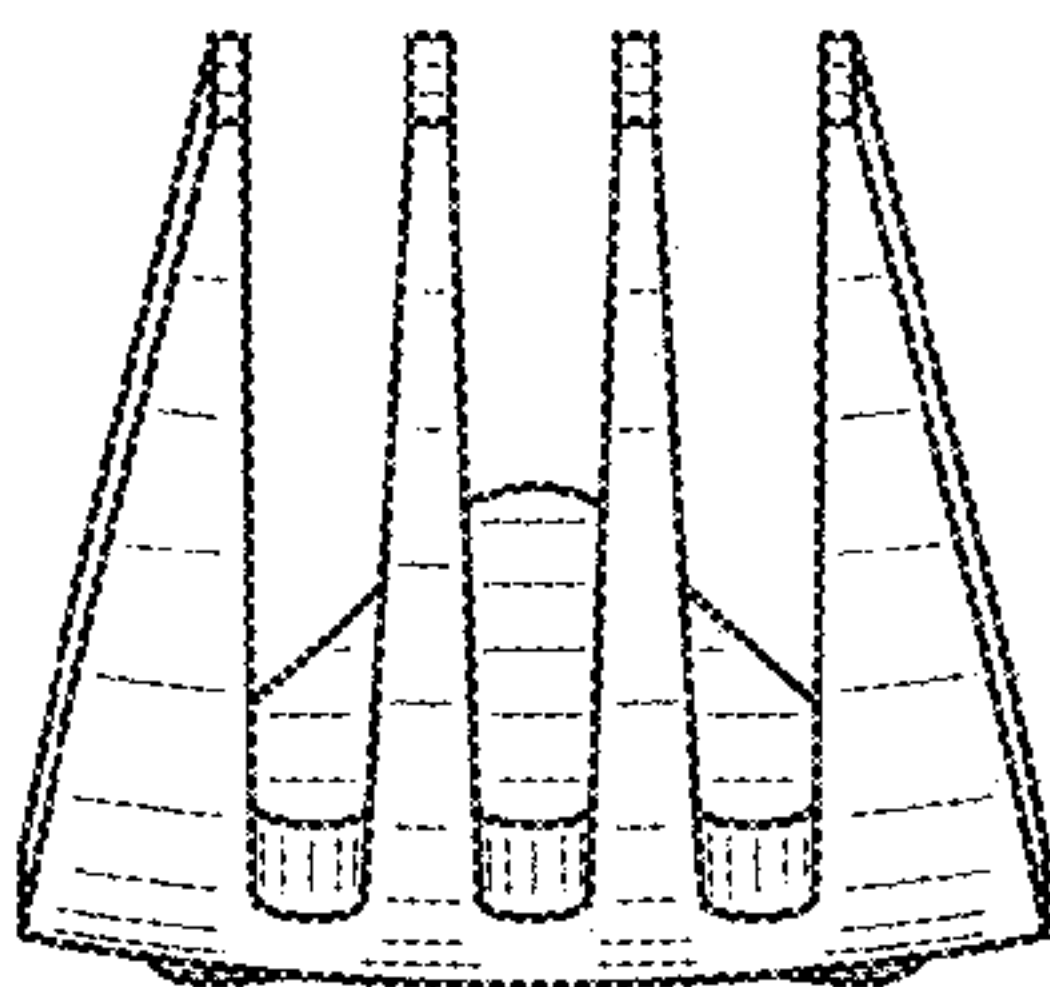

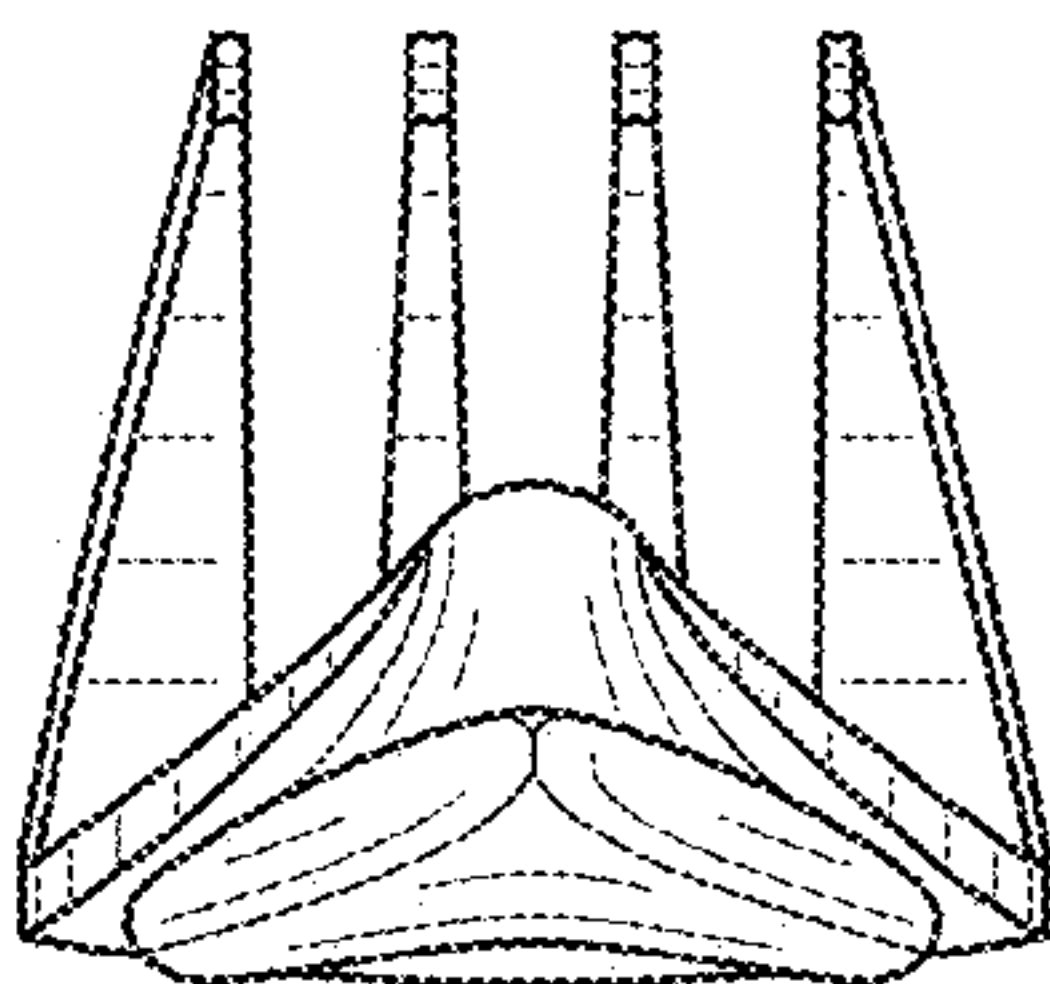

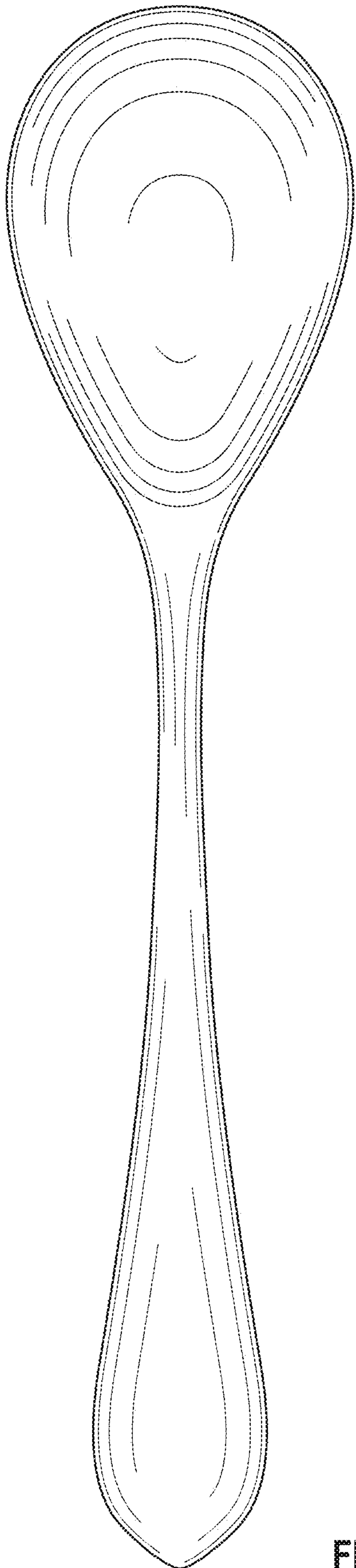

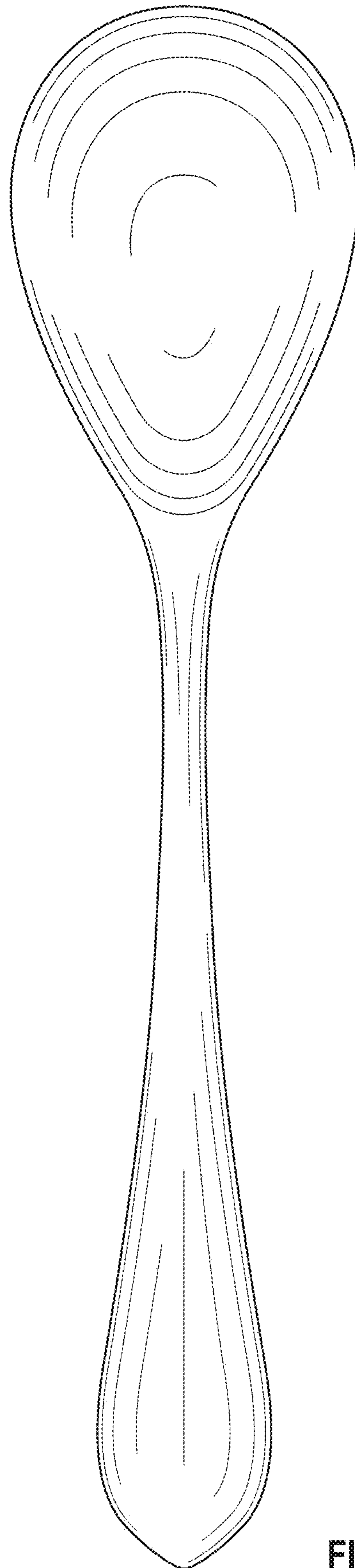

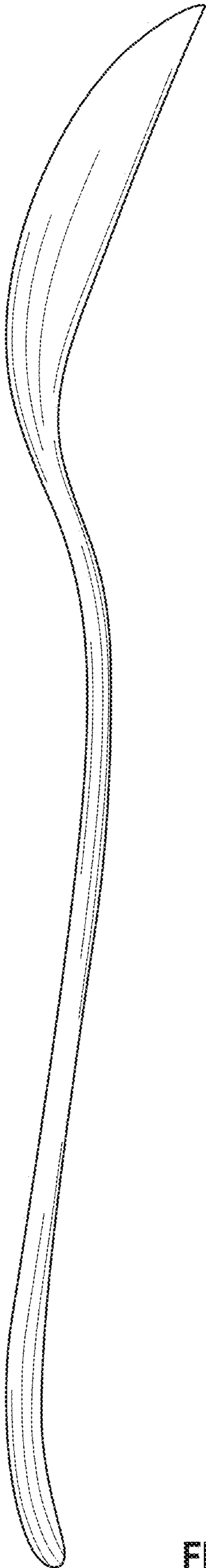

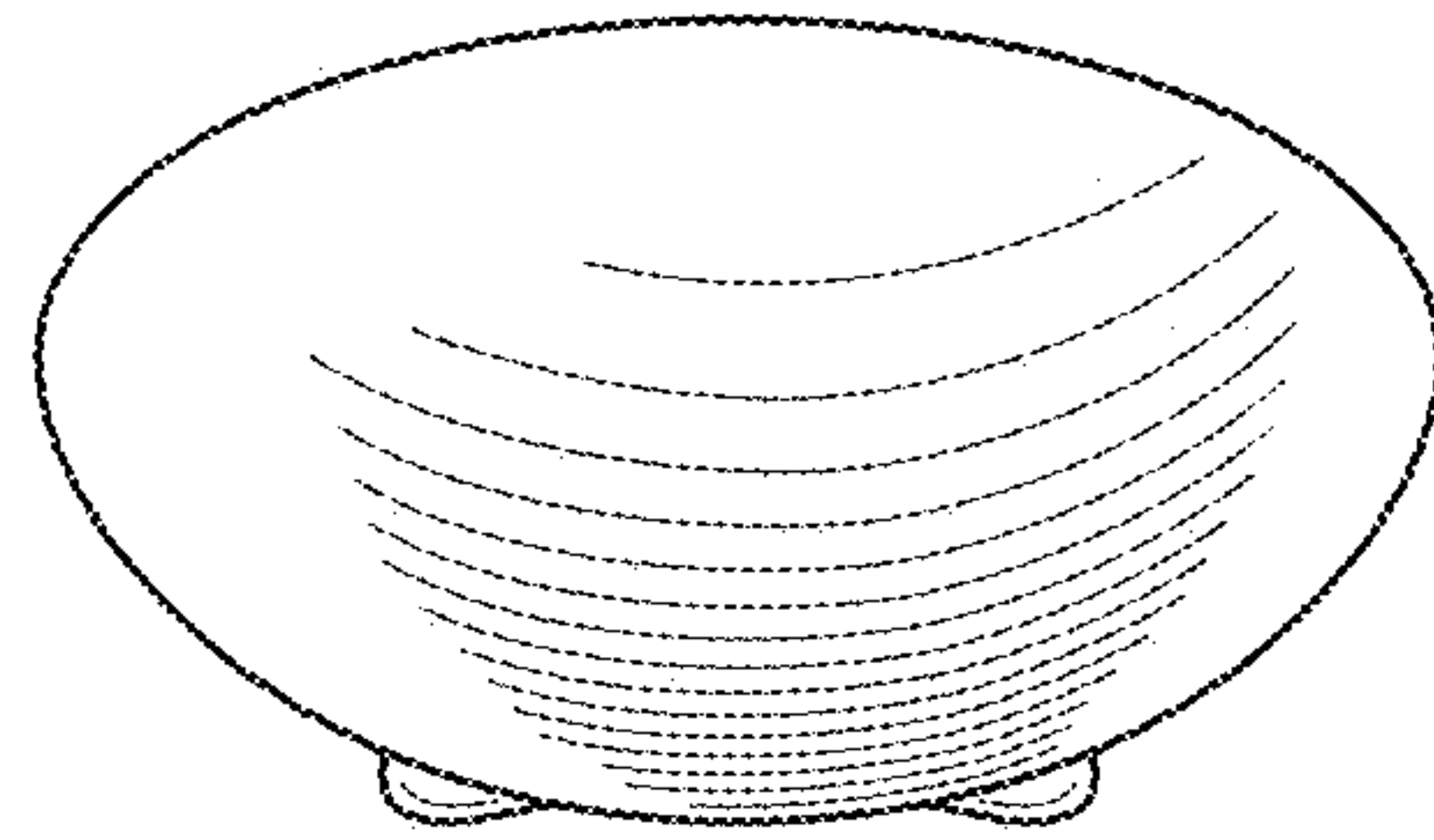

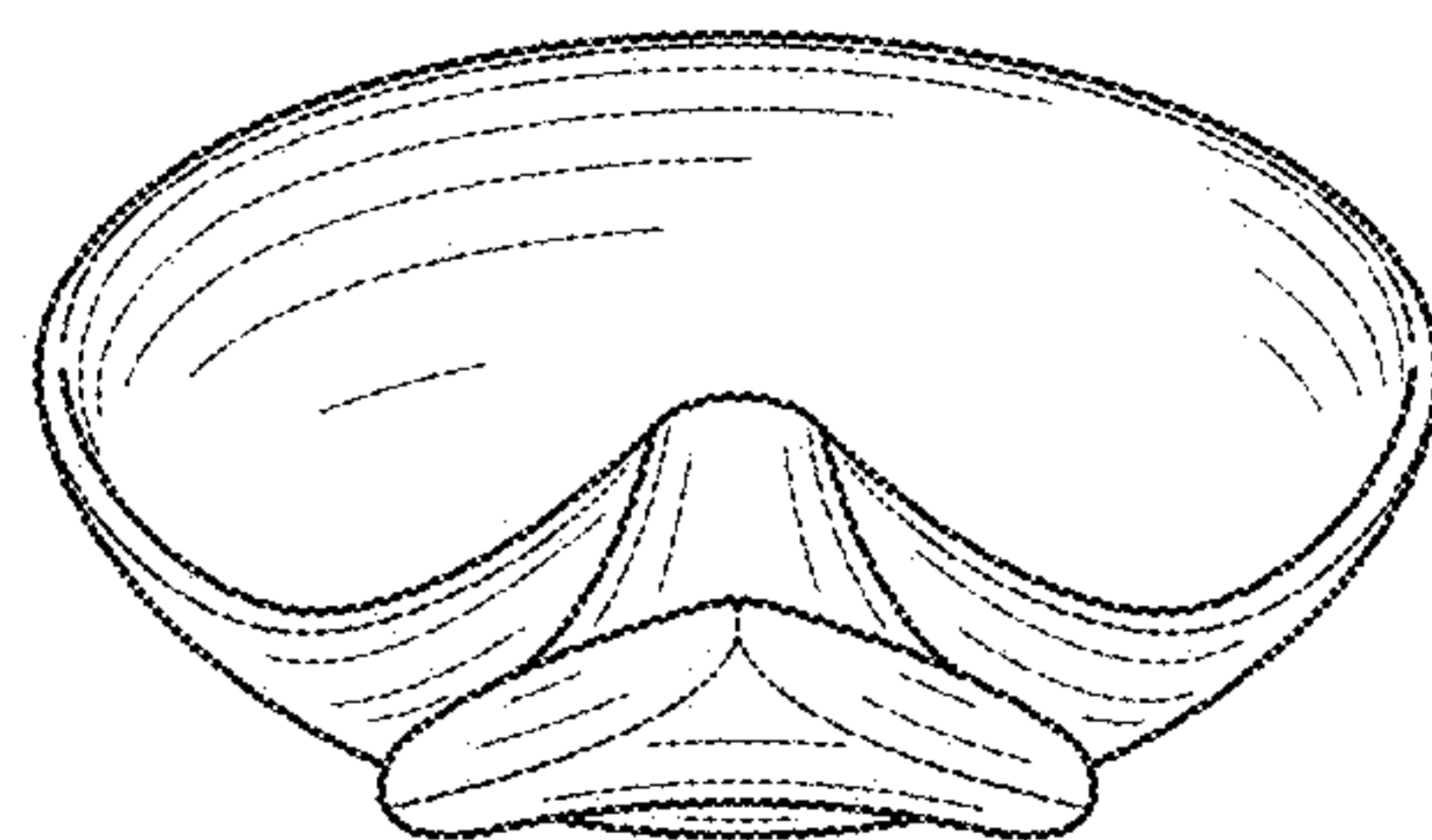
