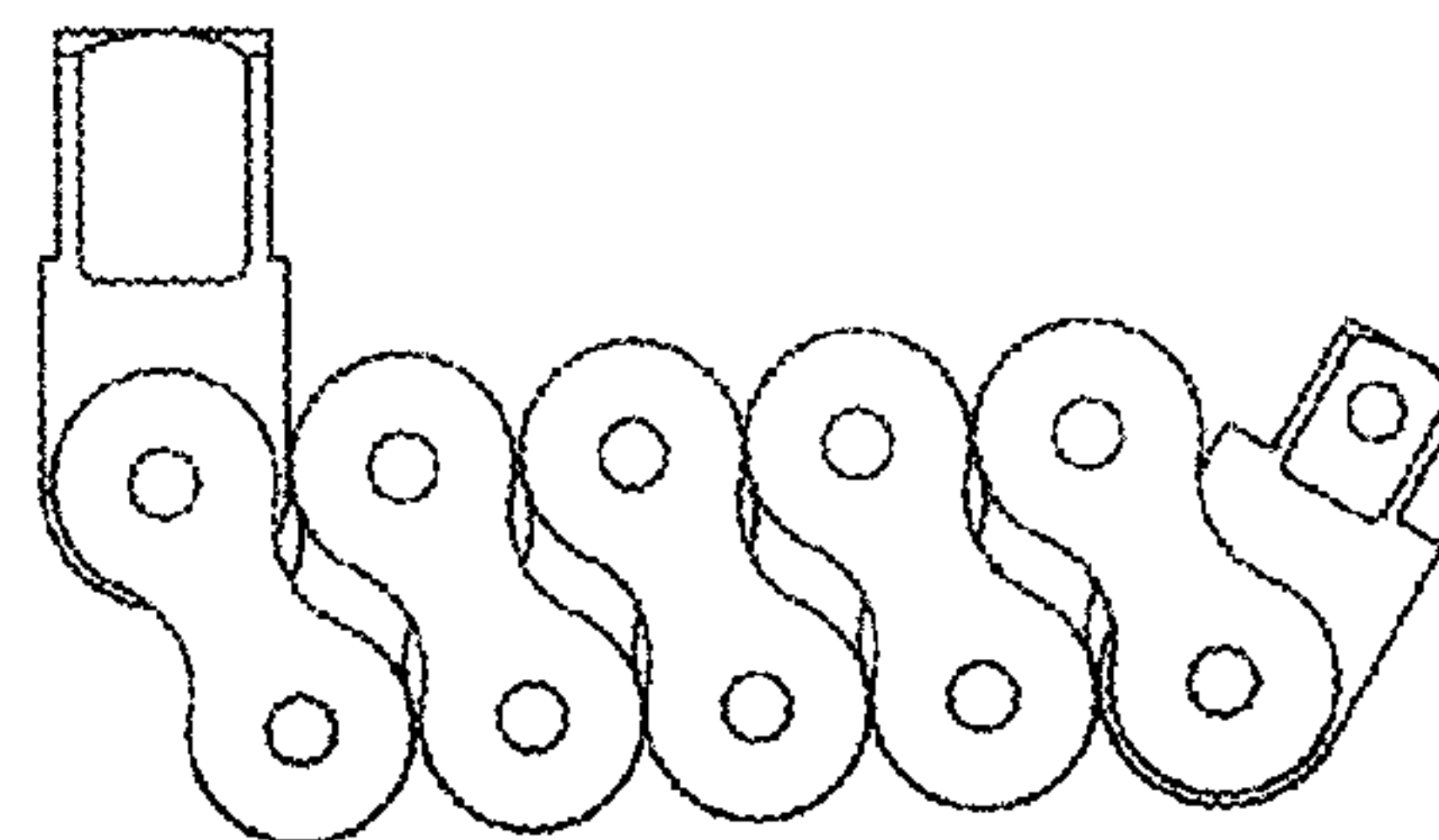
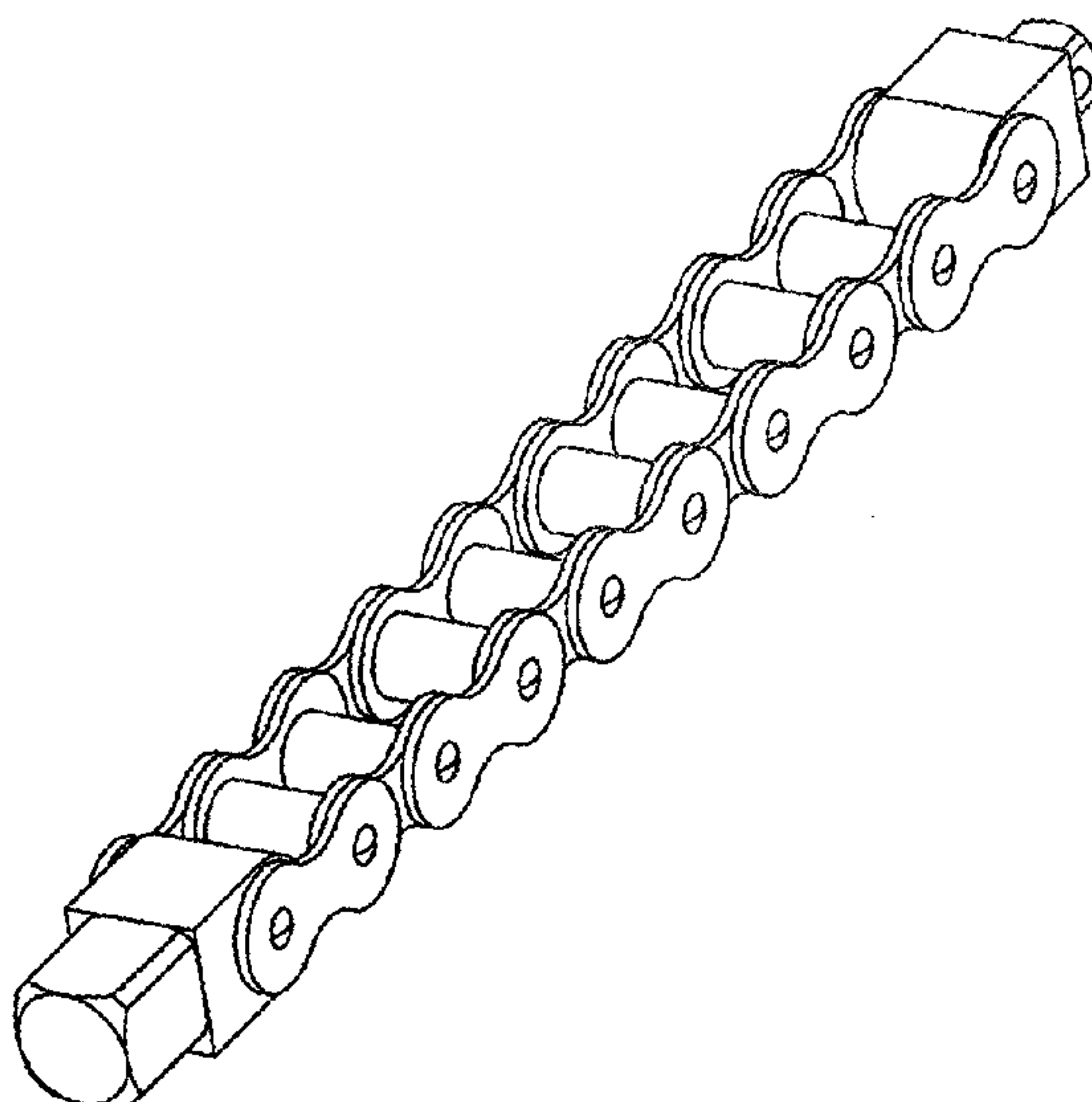
(57) **CLAIM**

The ornamental design for a combined chain and coupler for a chain wrench, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combined chain and coupler for a chain wrench showing my new design;

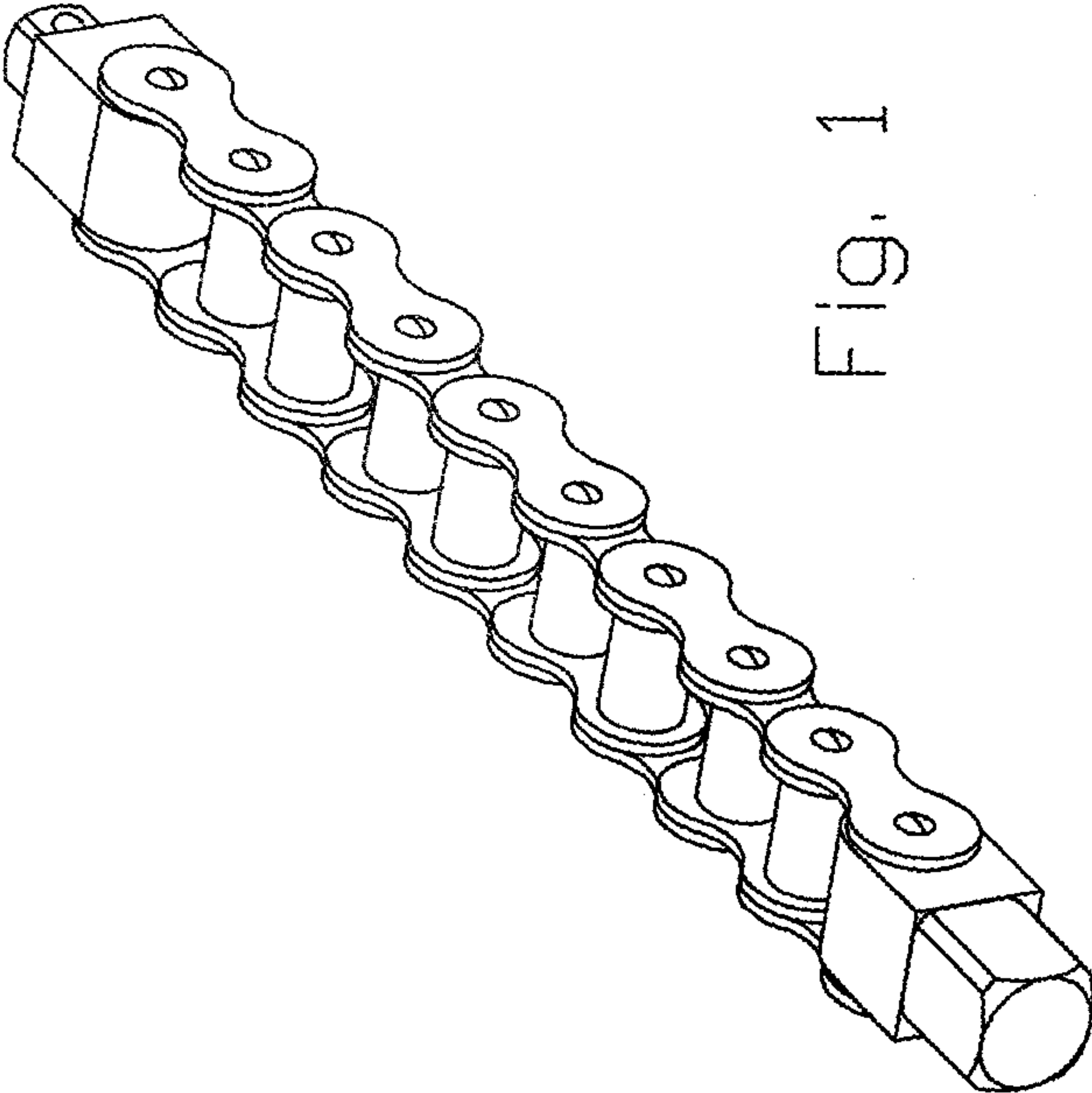

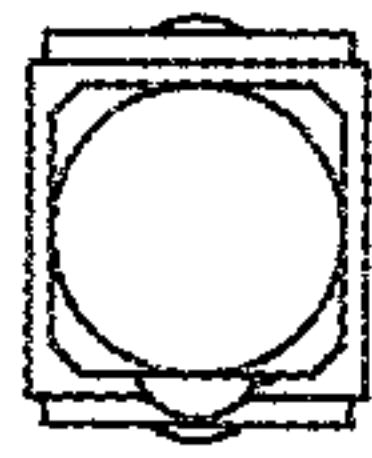

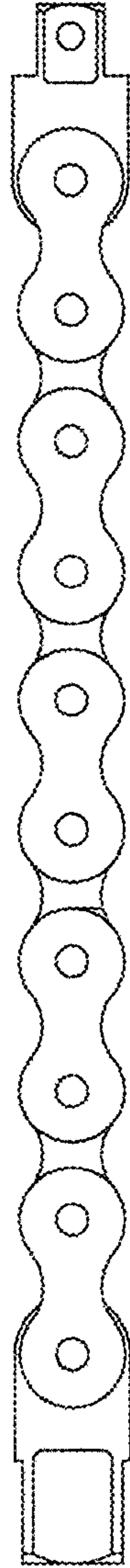

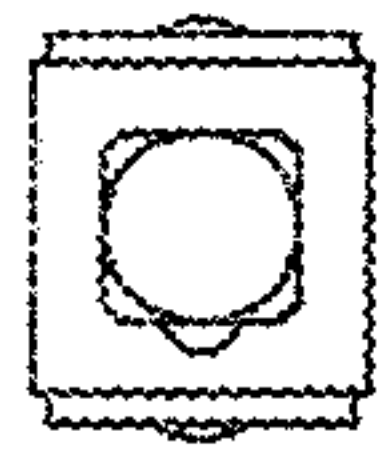

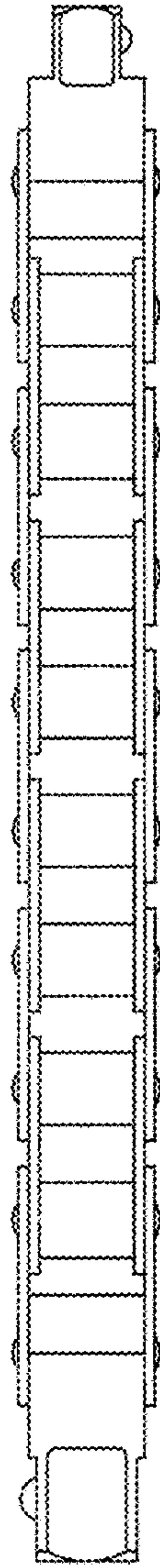

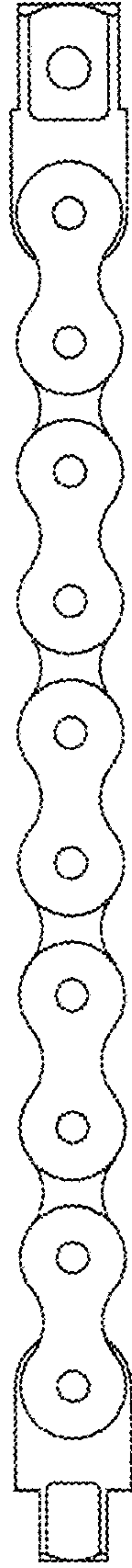

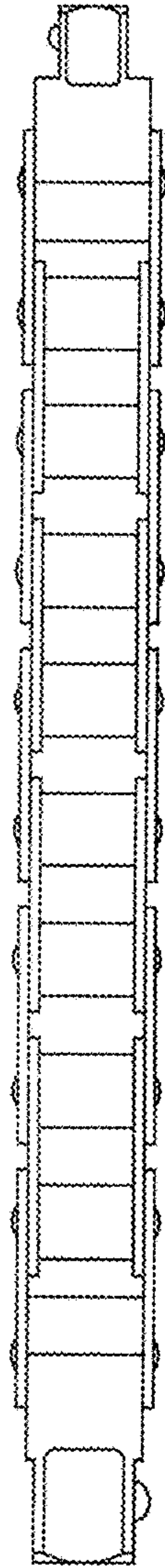

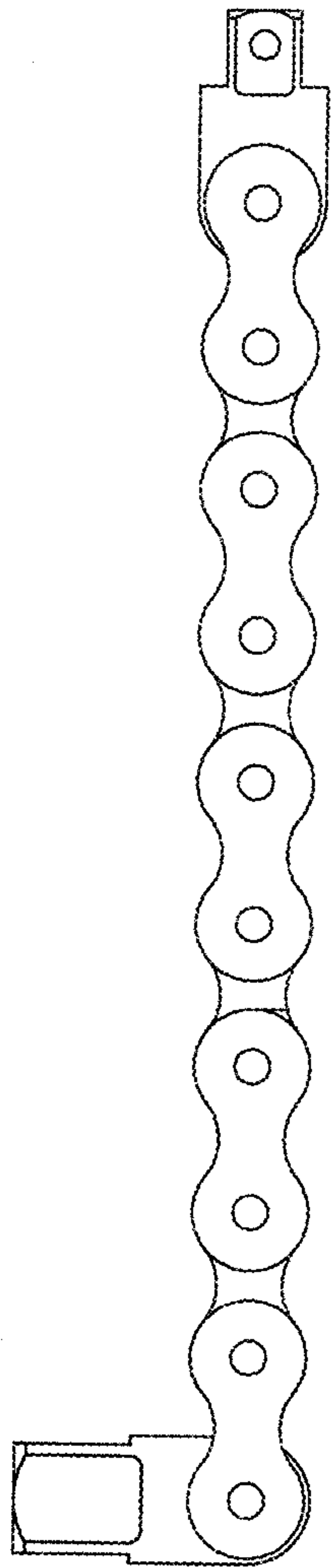

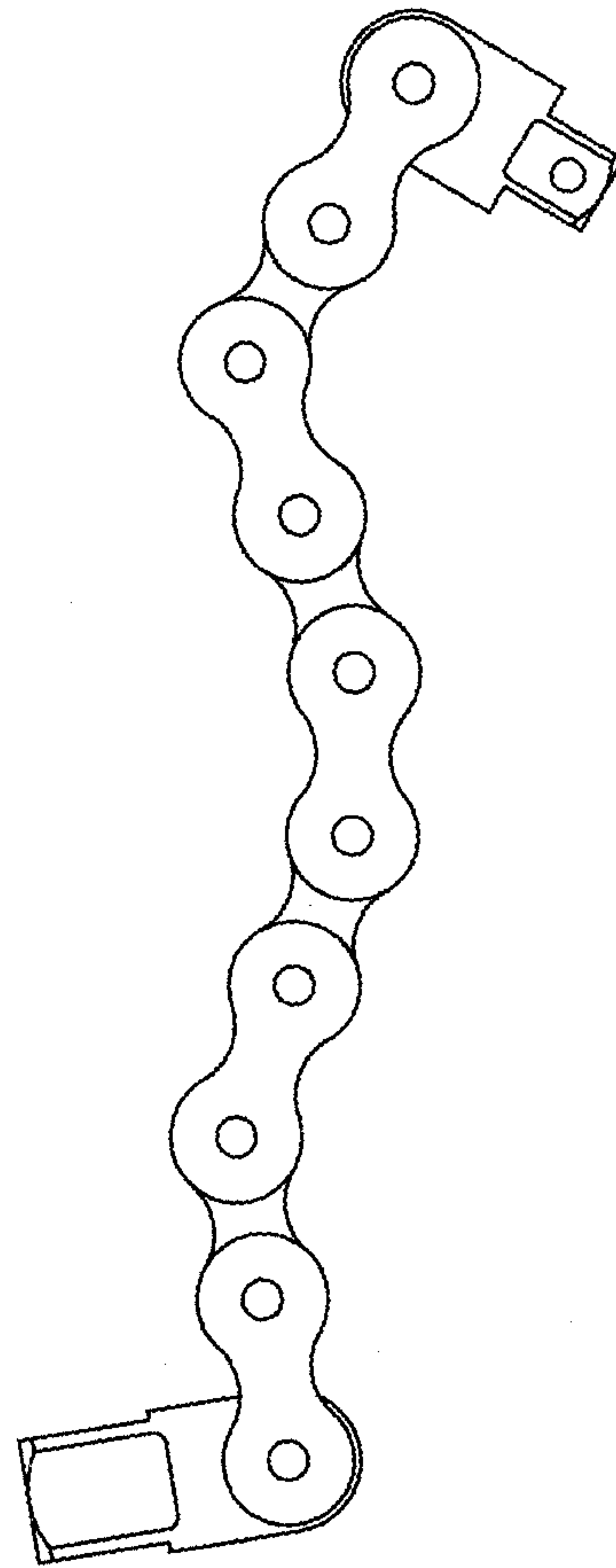

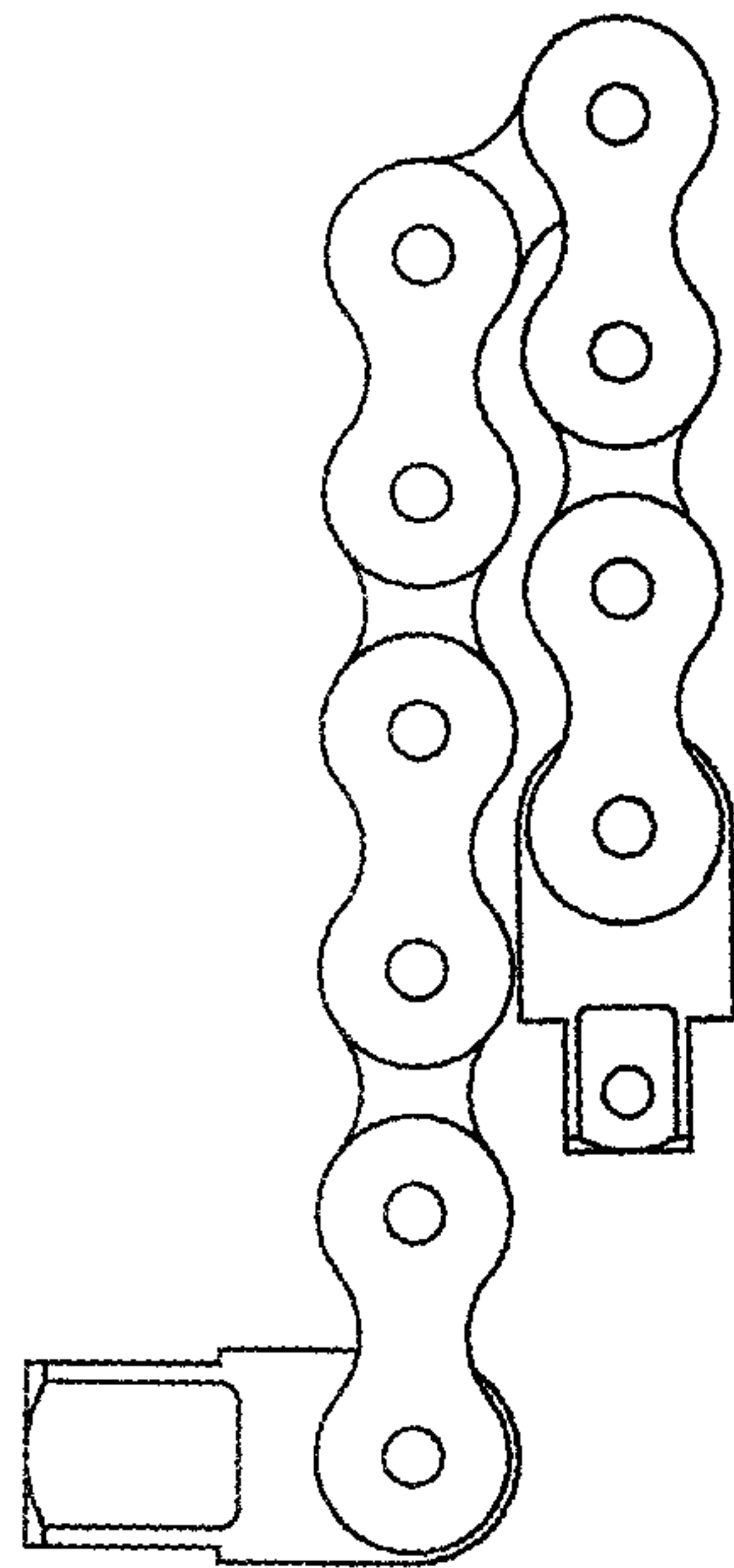

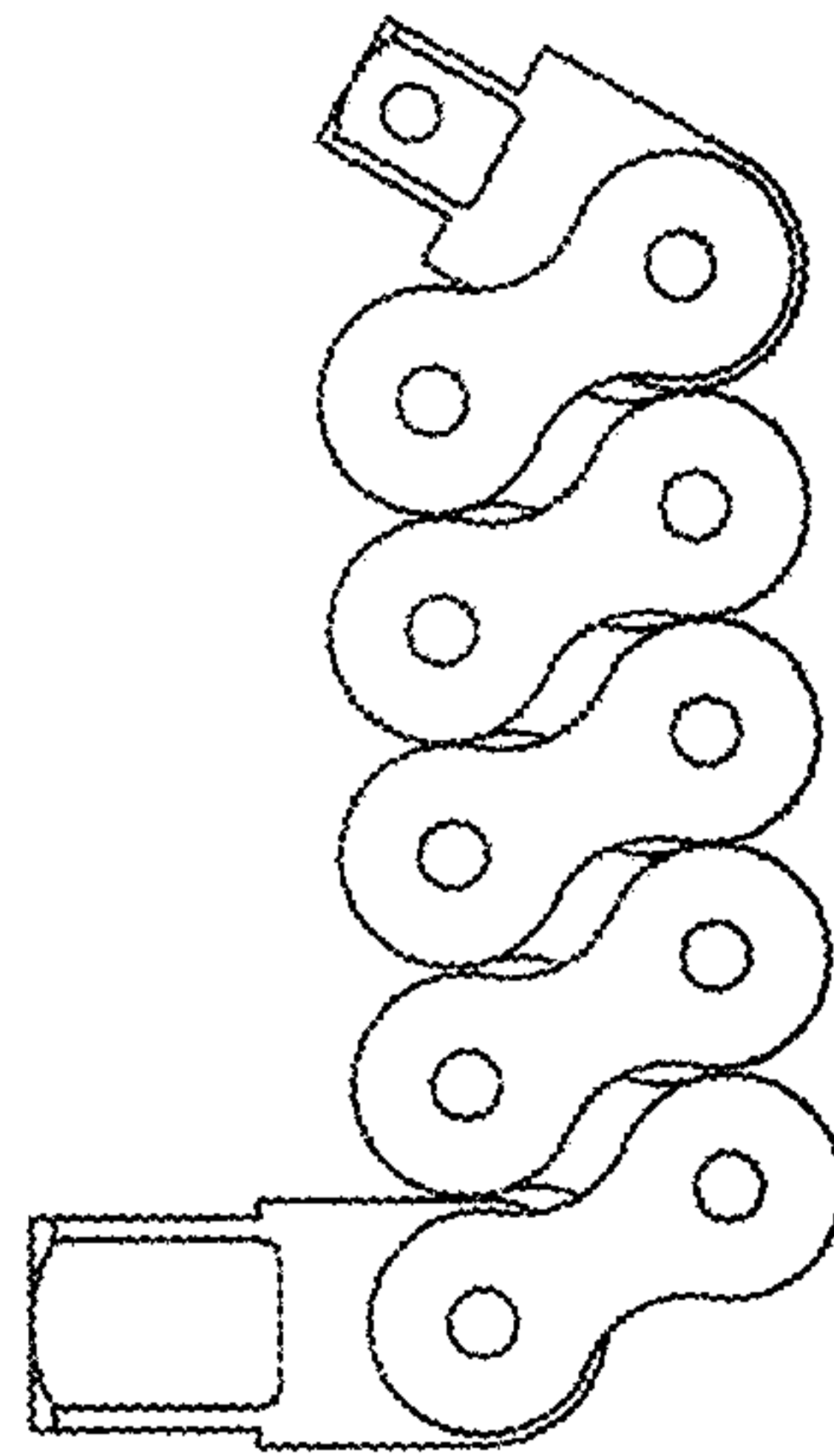

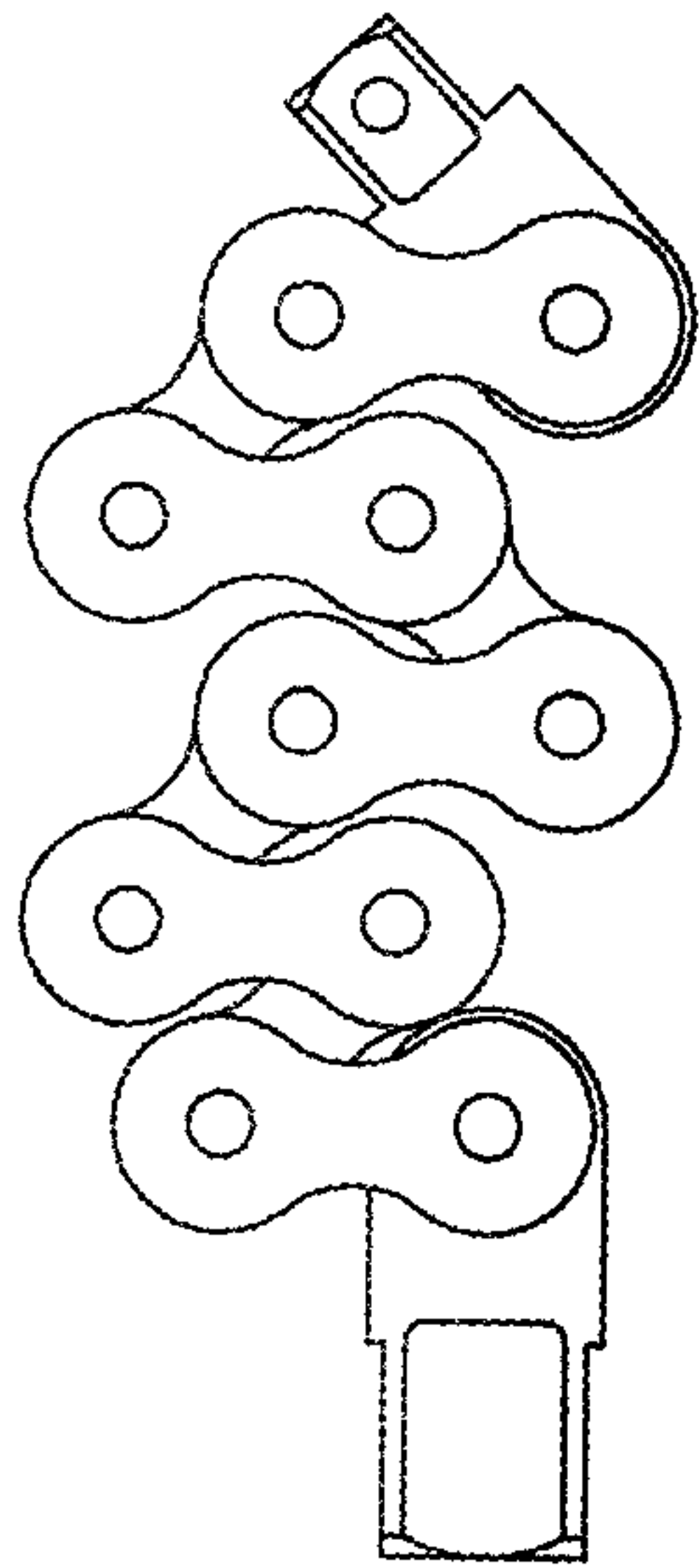
