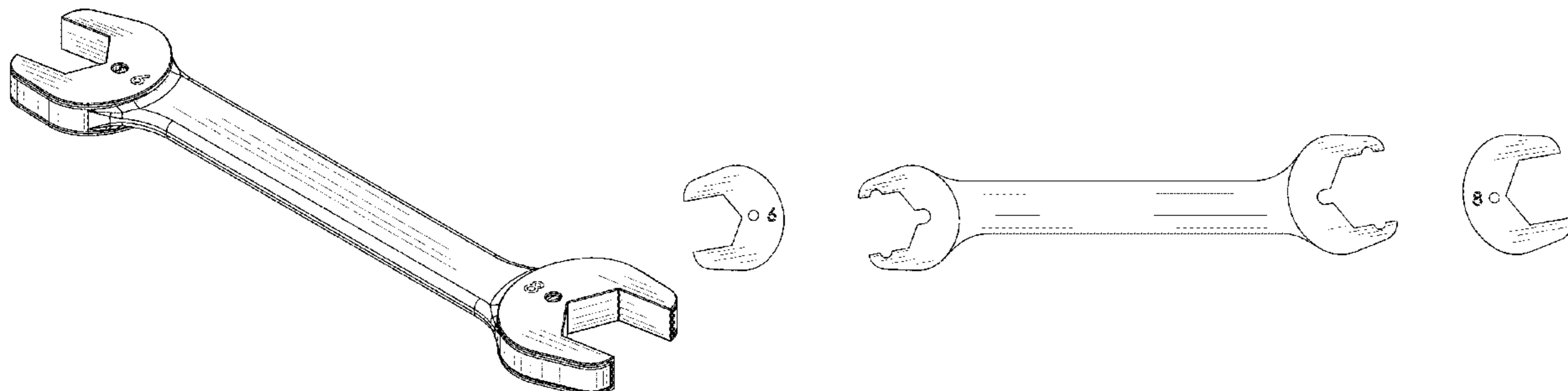


FIG. 14 is a right side view of the first removable jaw insert of FIG. 9.

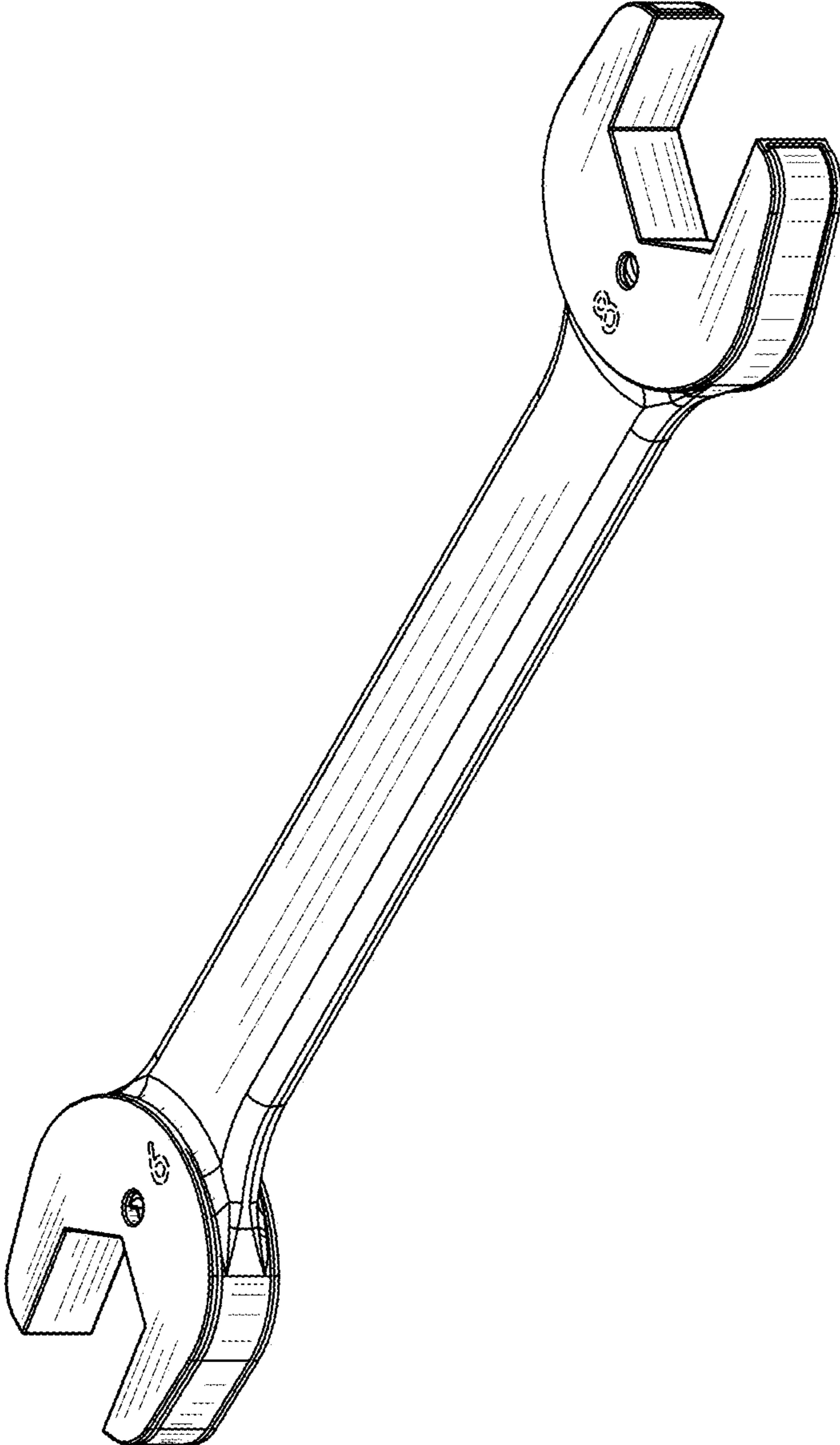

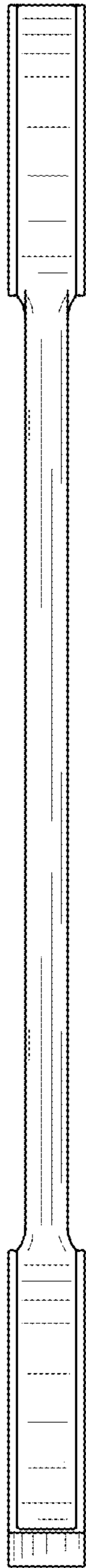

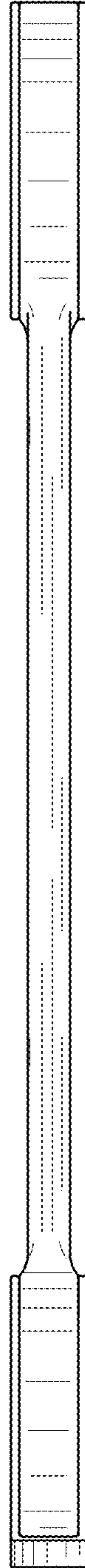

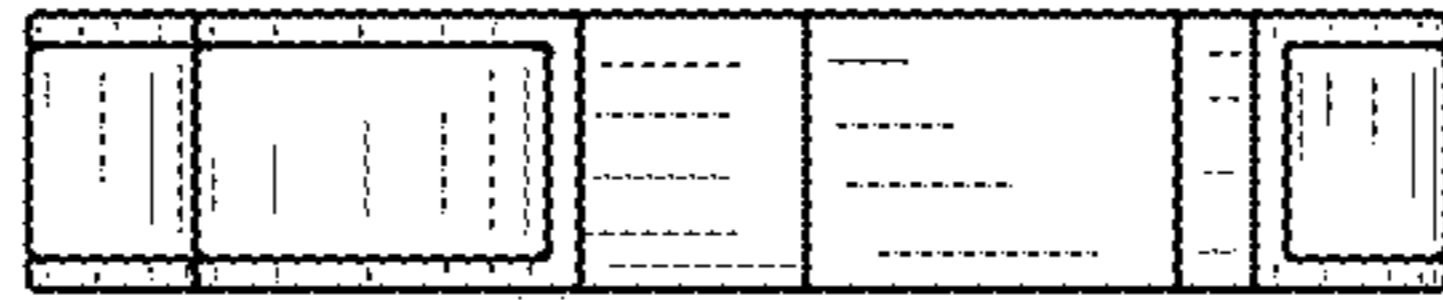

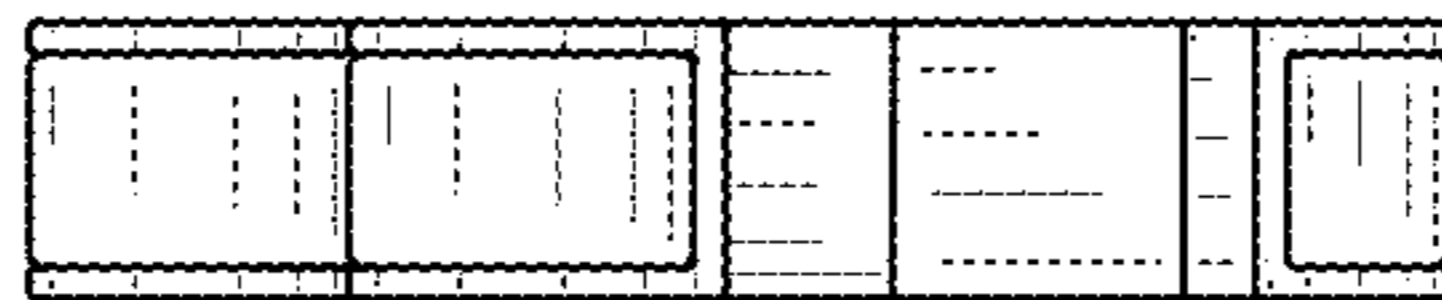

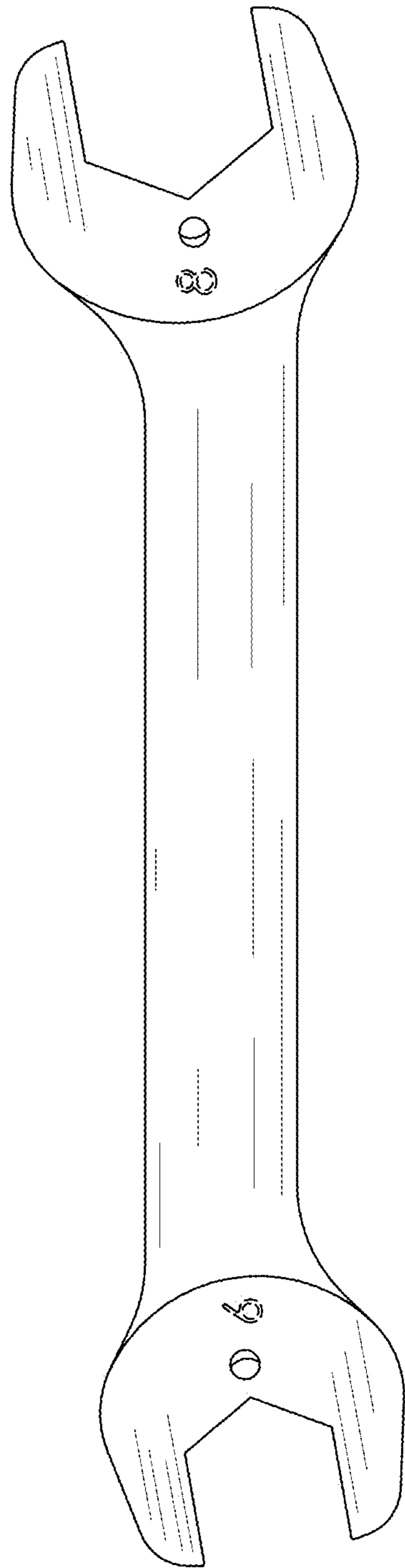

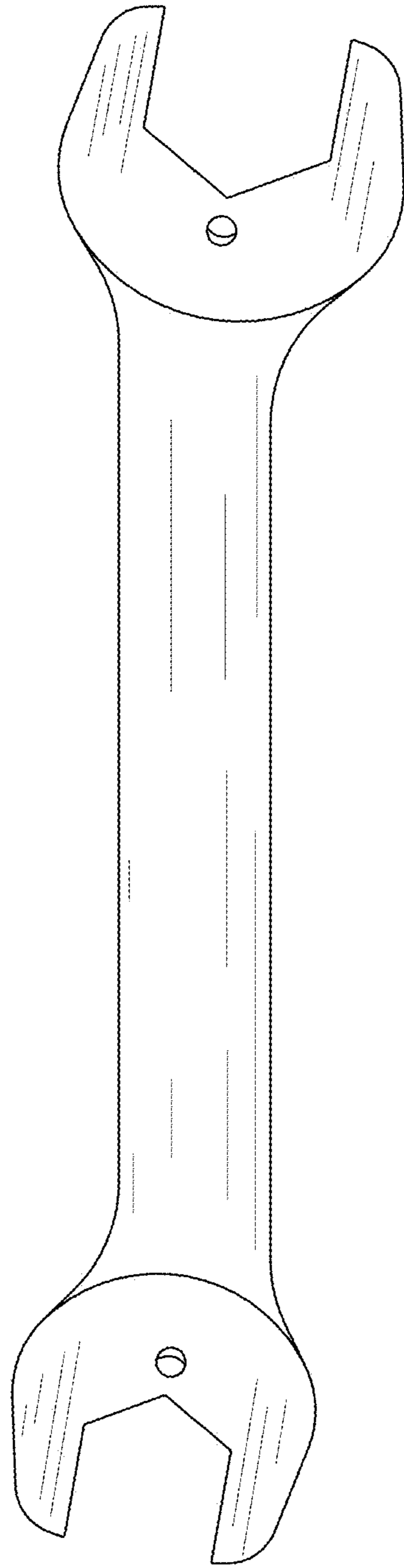

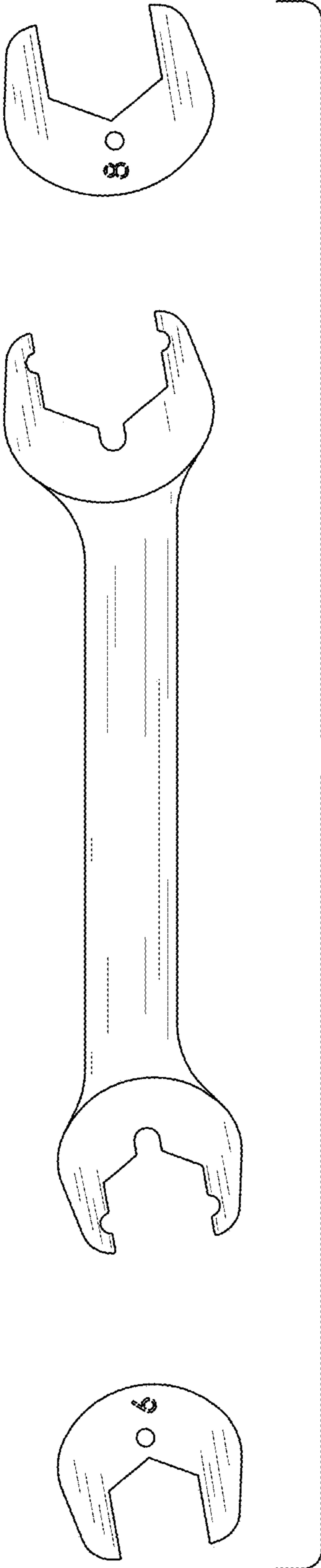

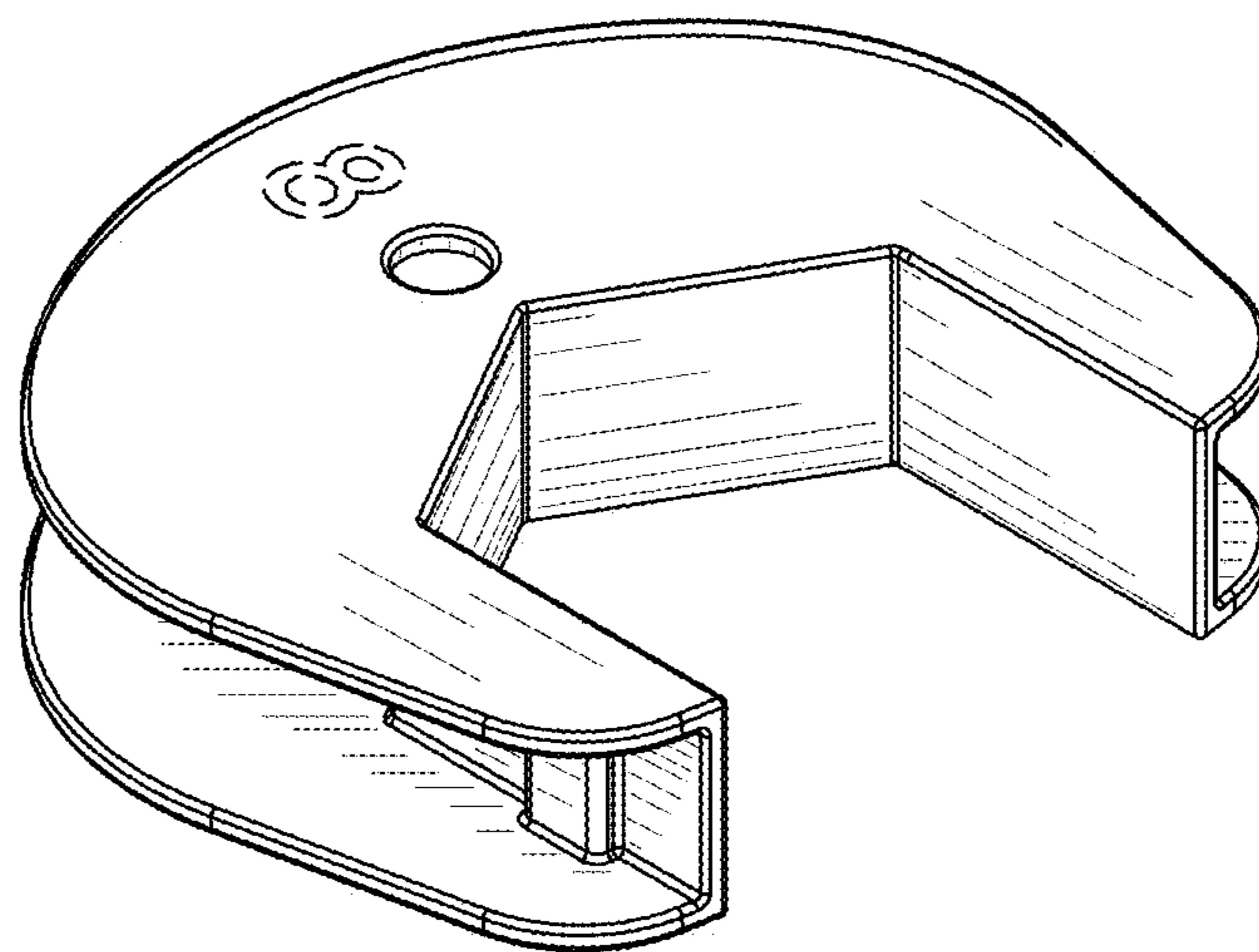

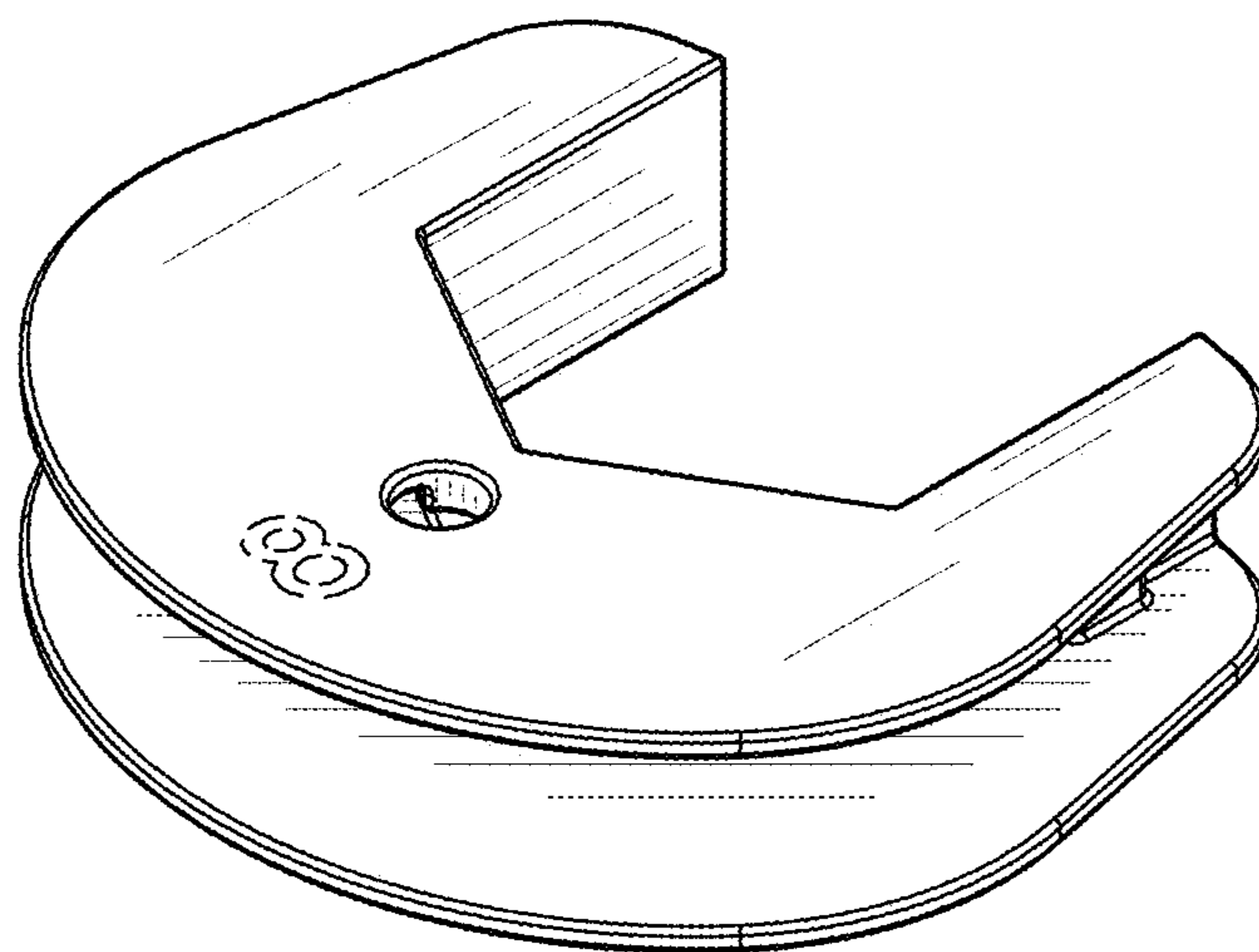

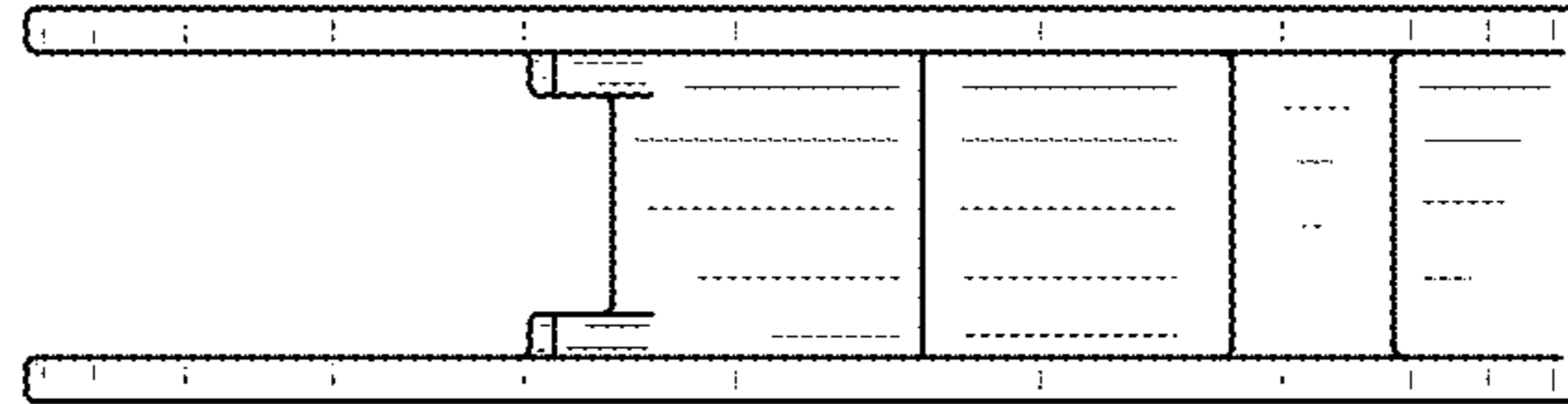

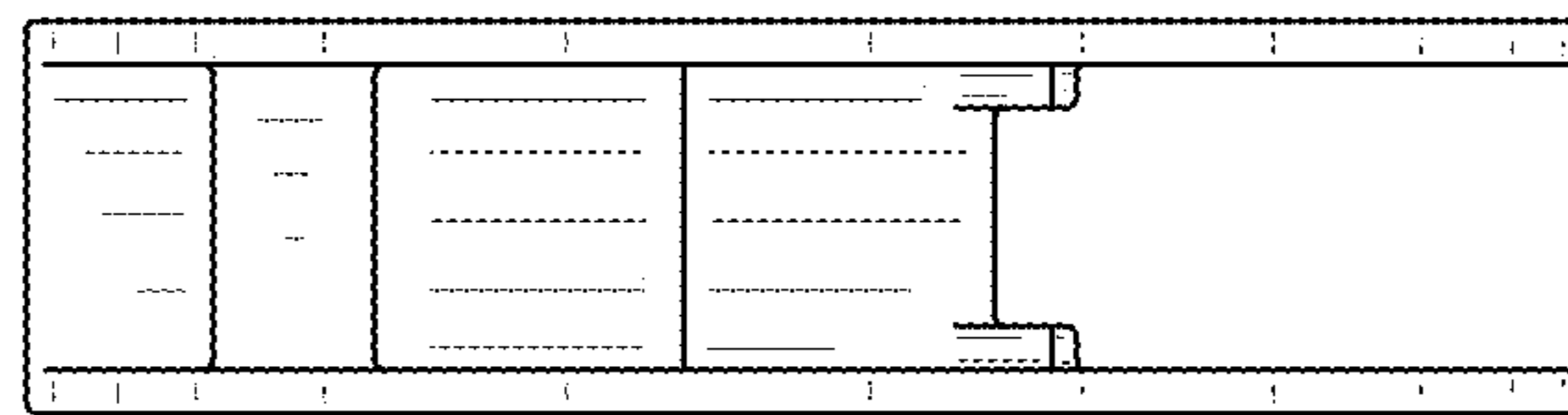

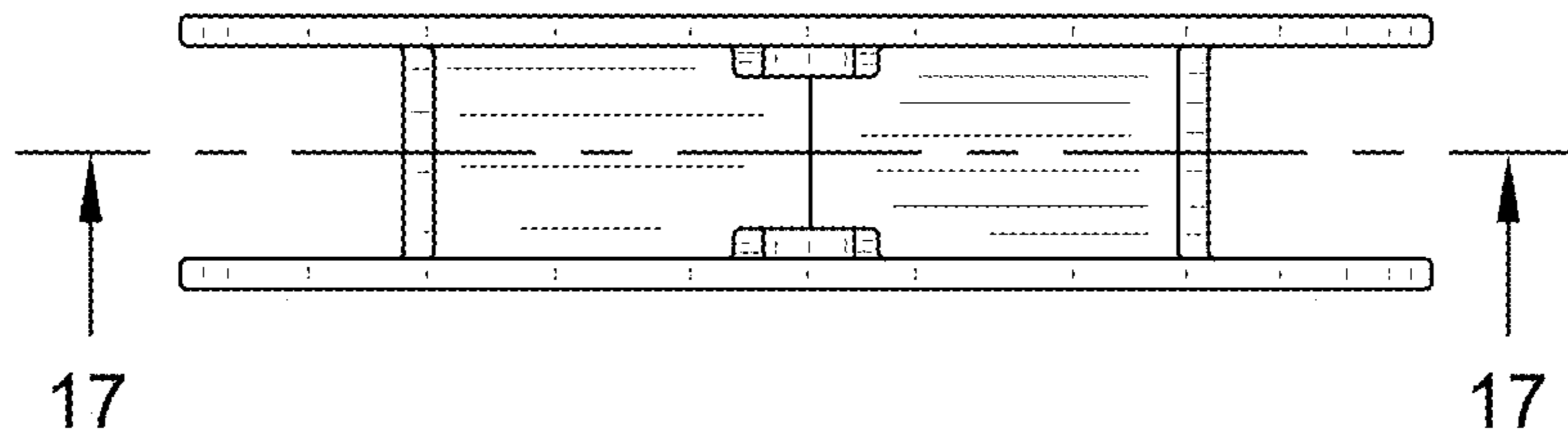

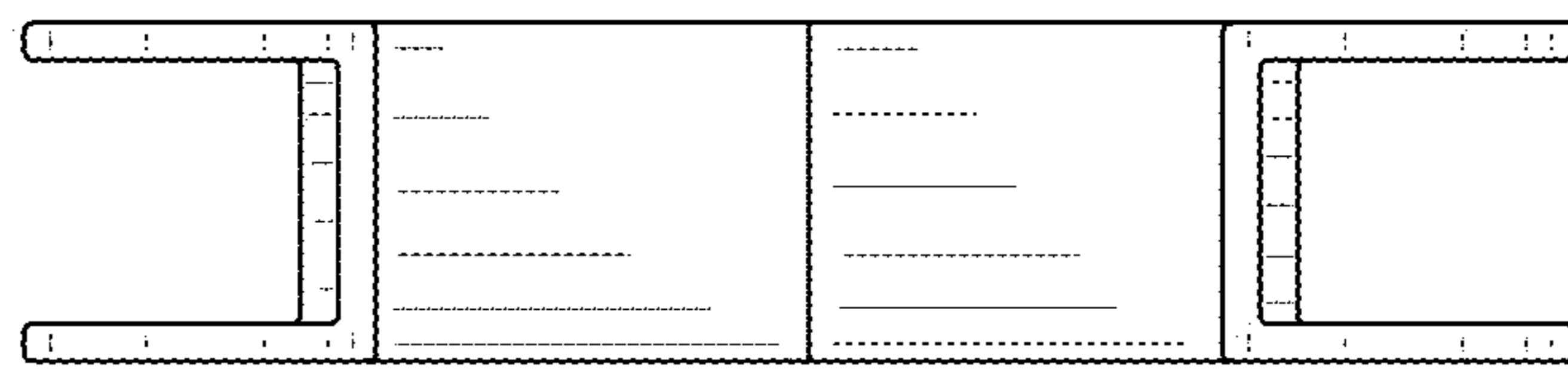

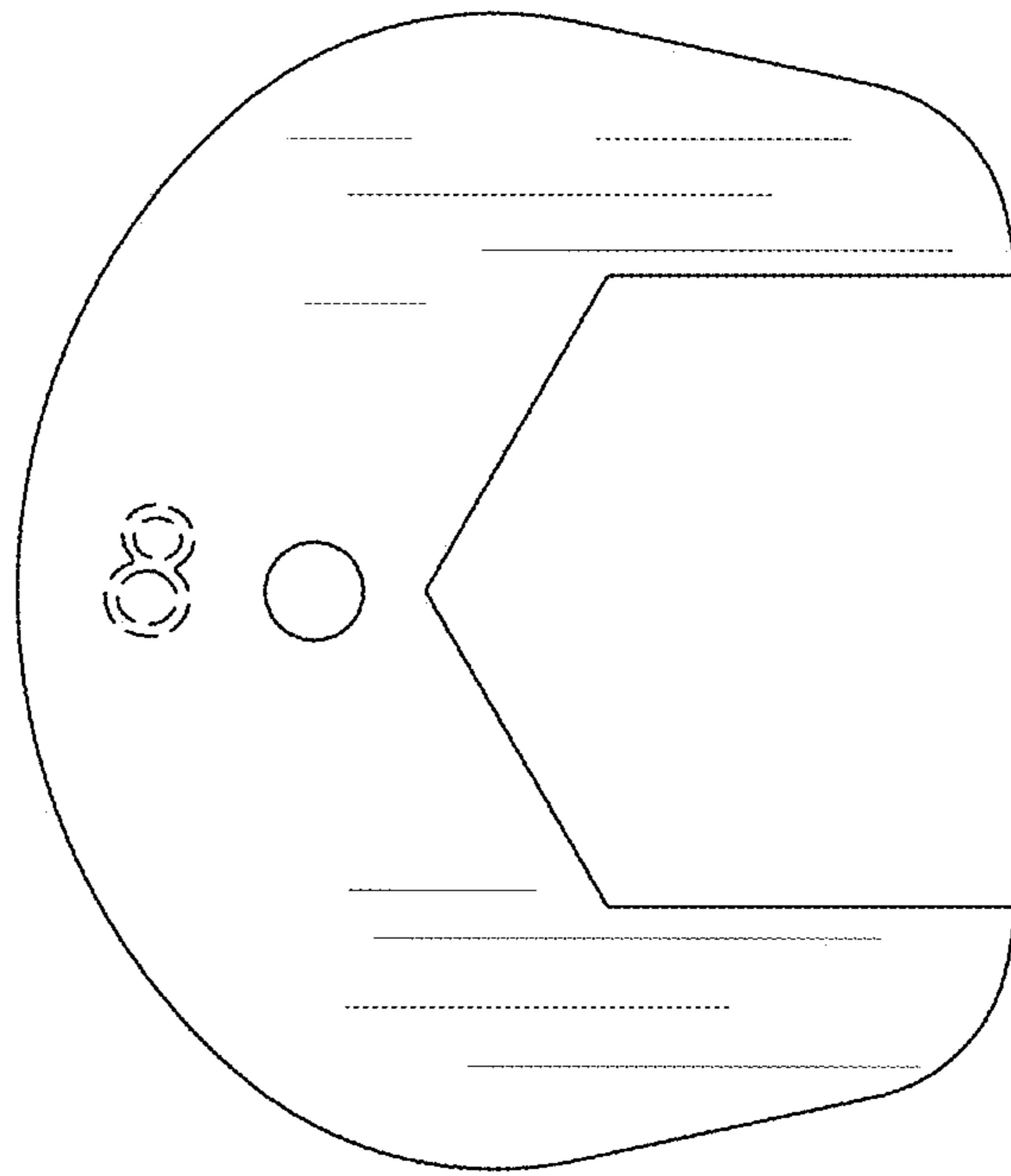

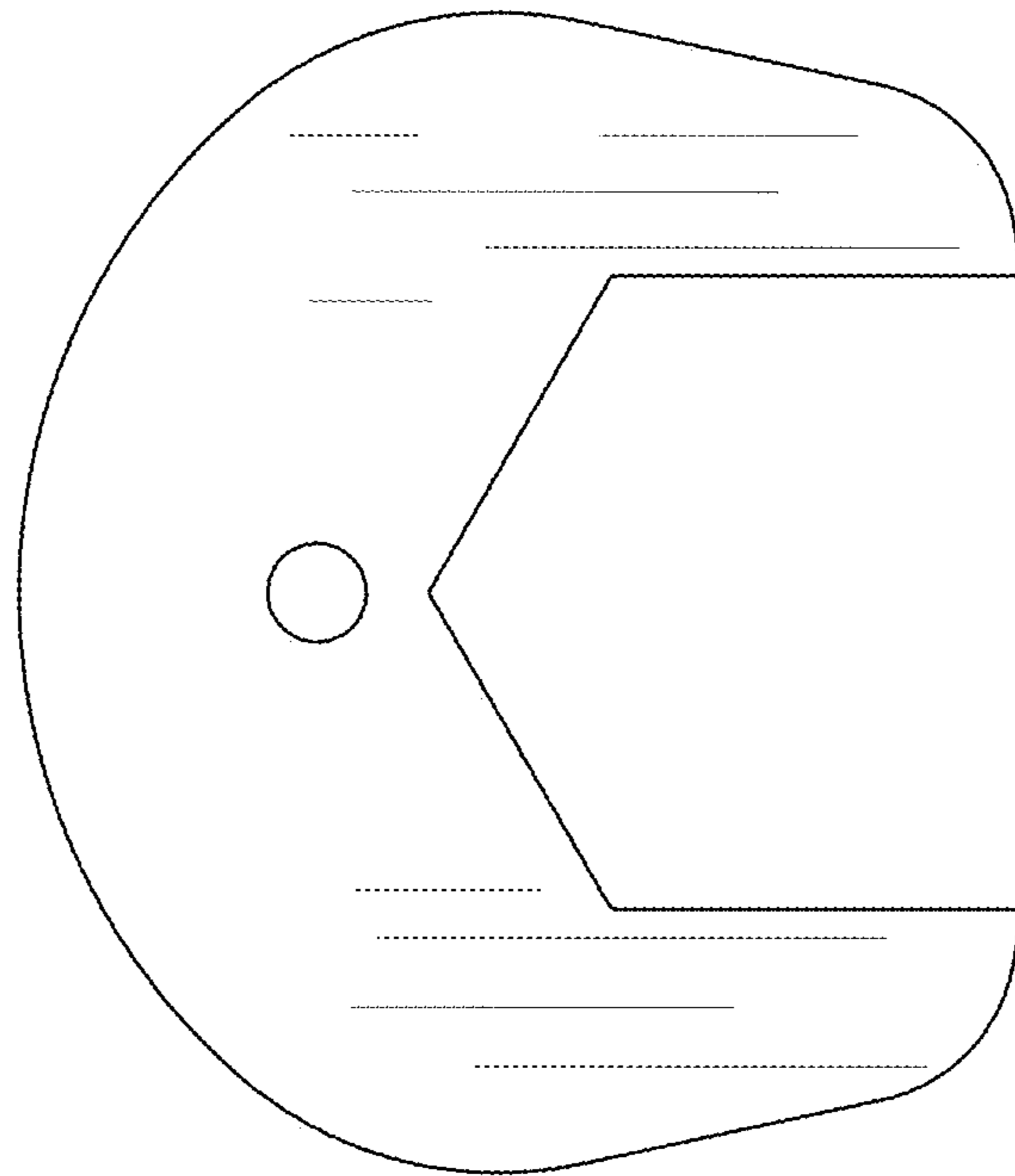

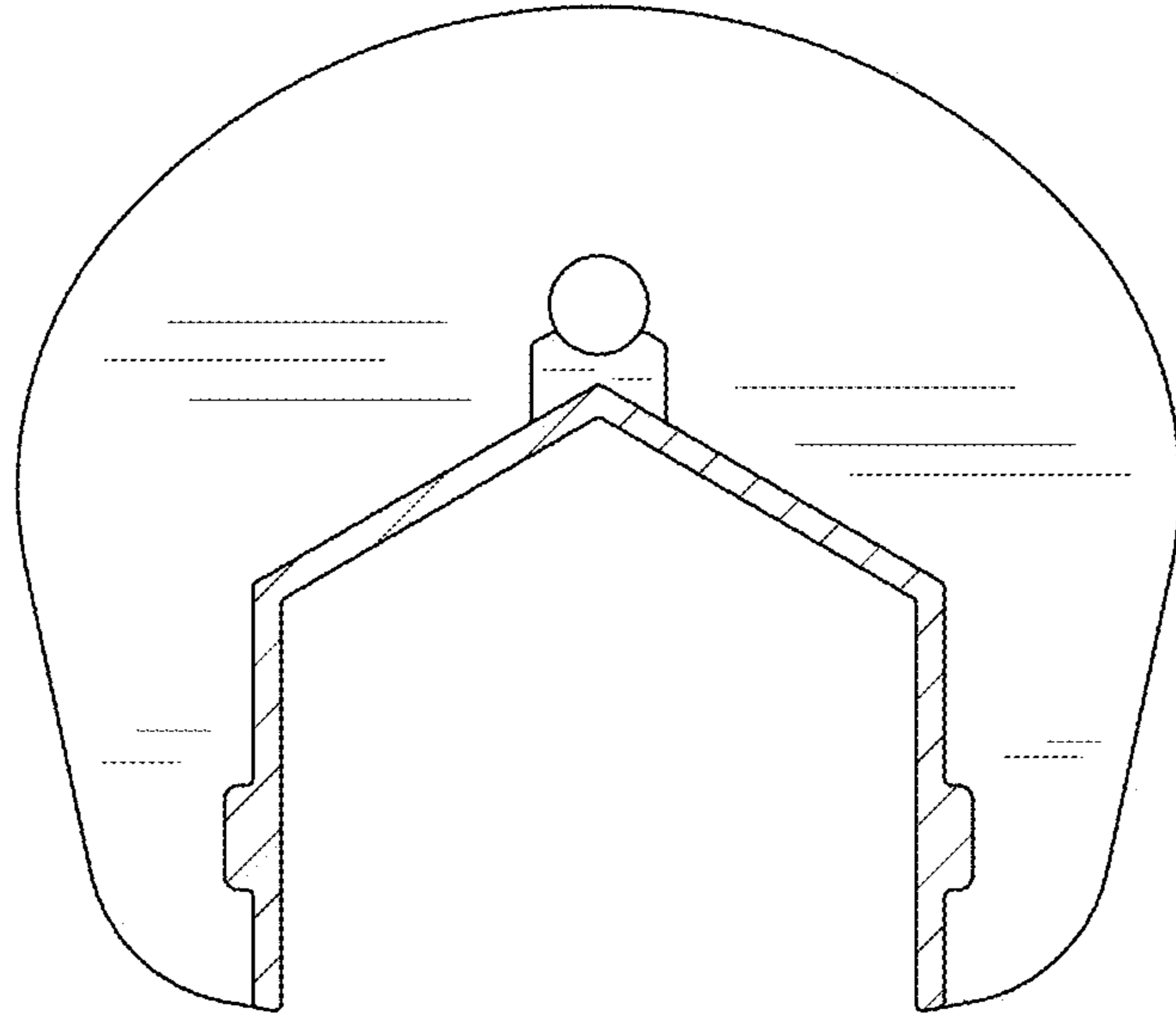

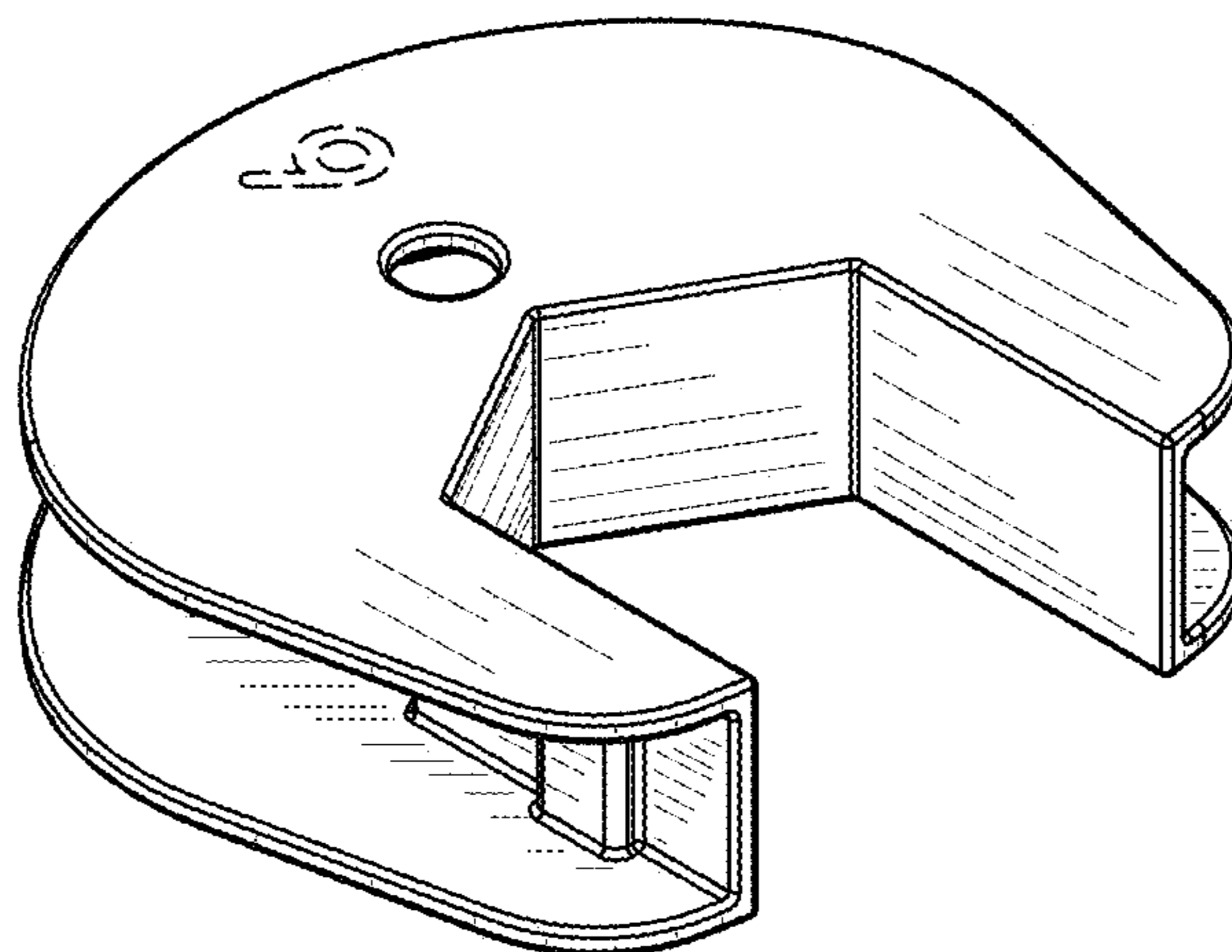

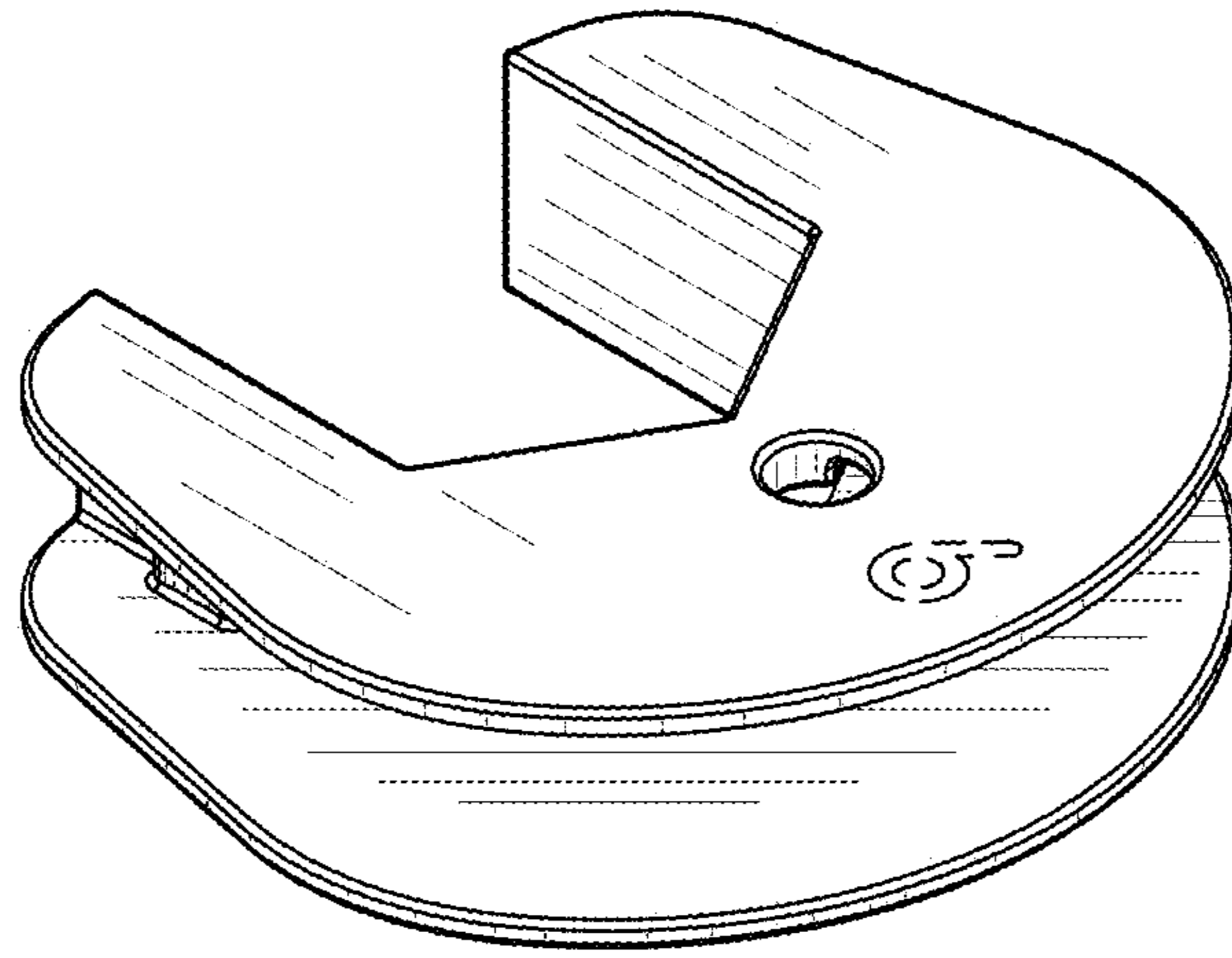

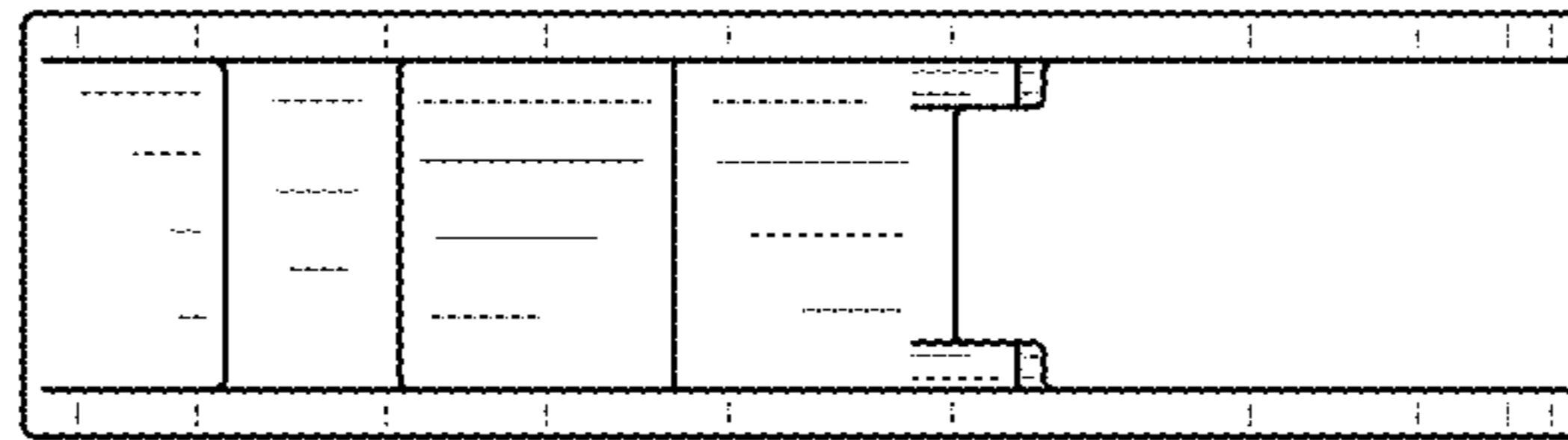

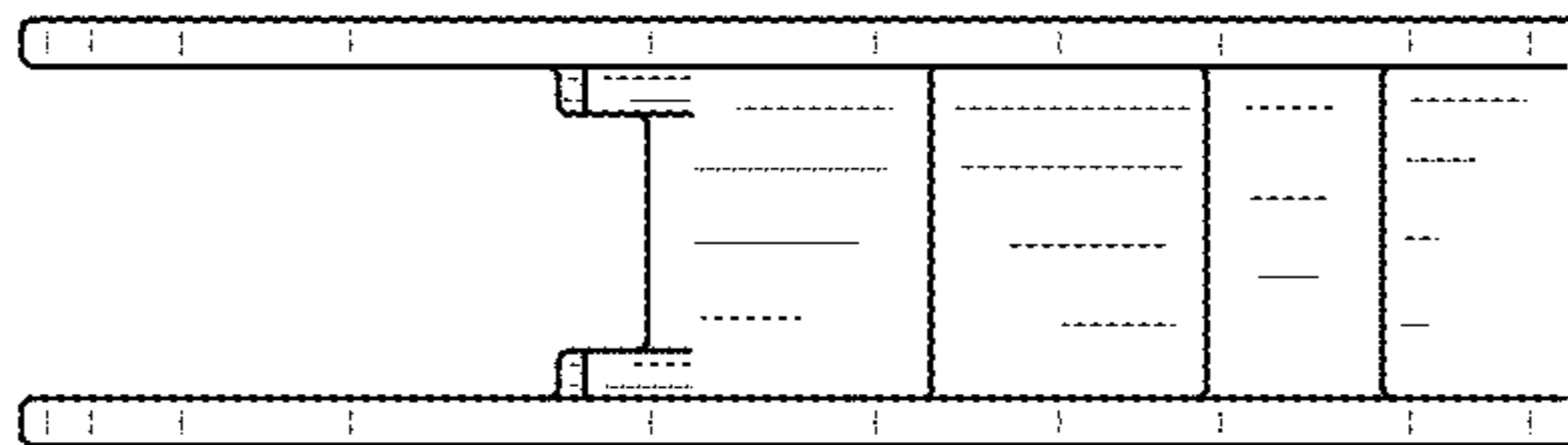

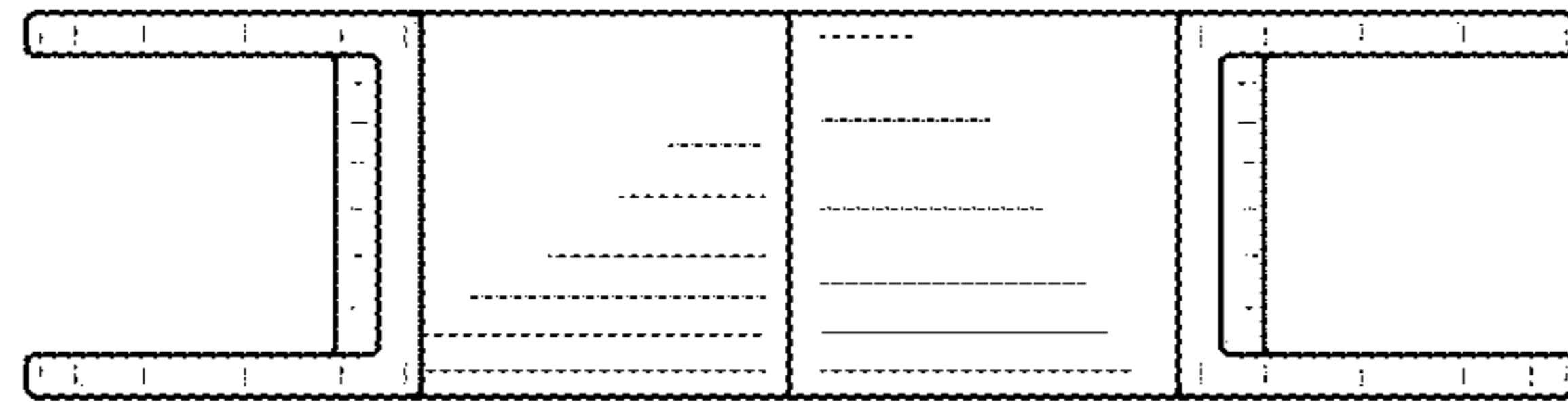

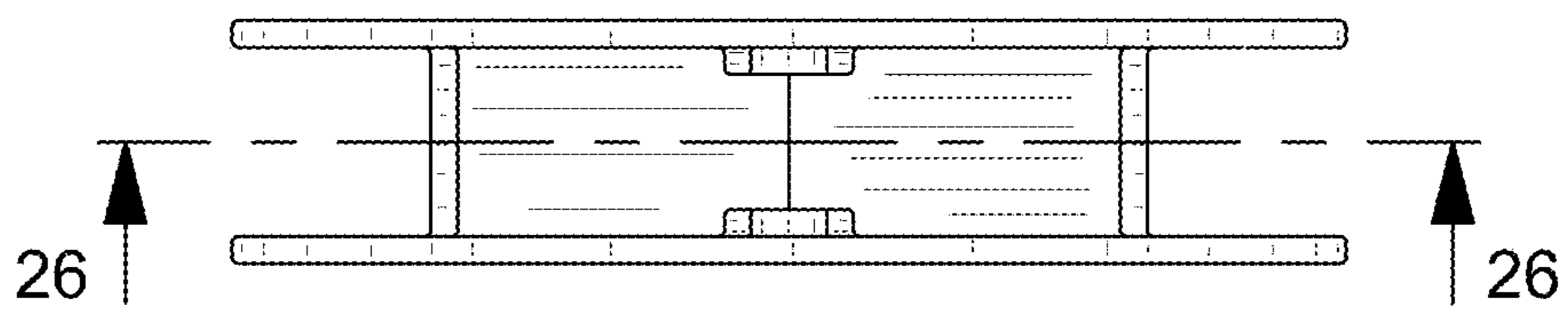

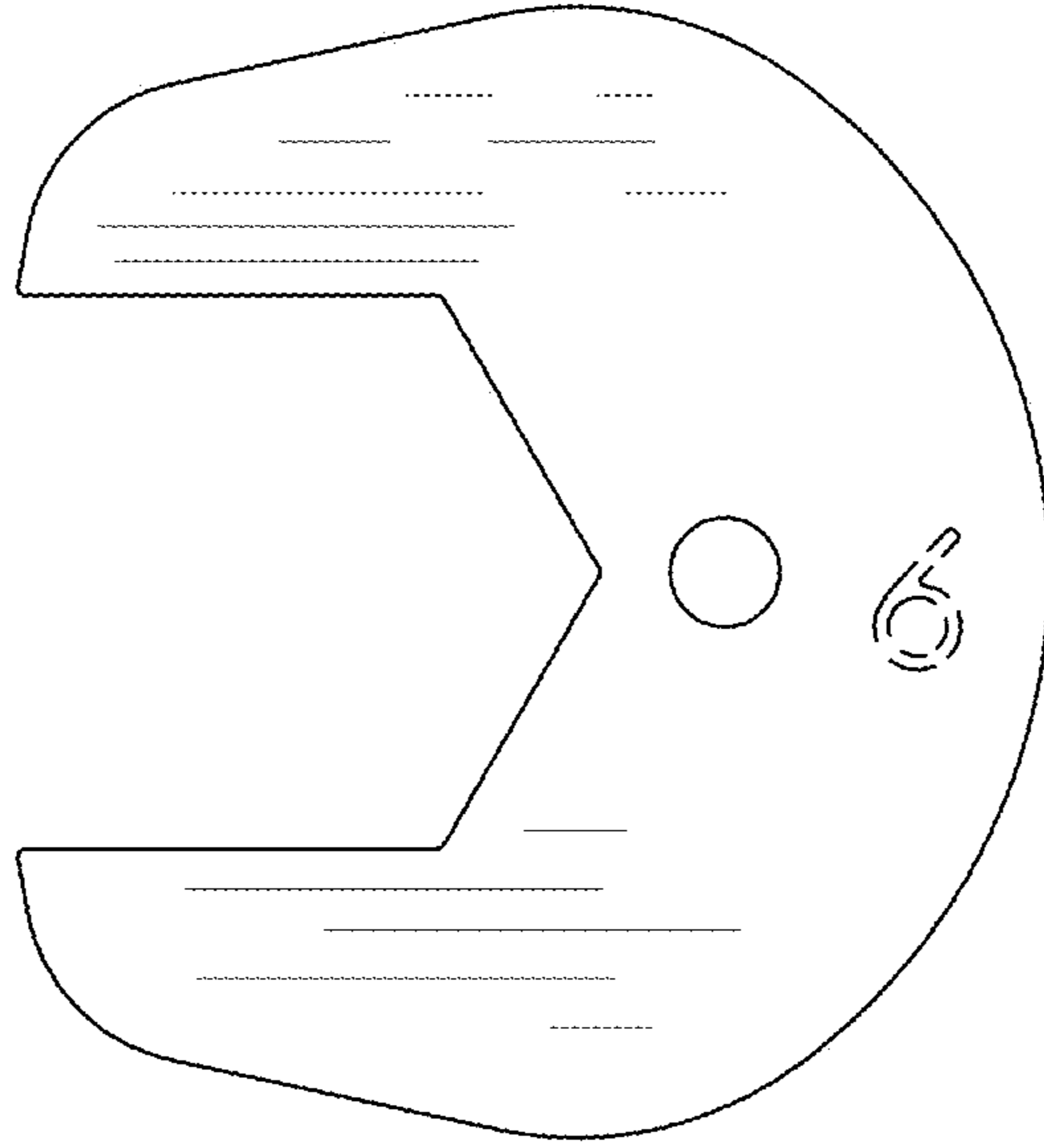

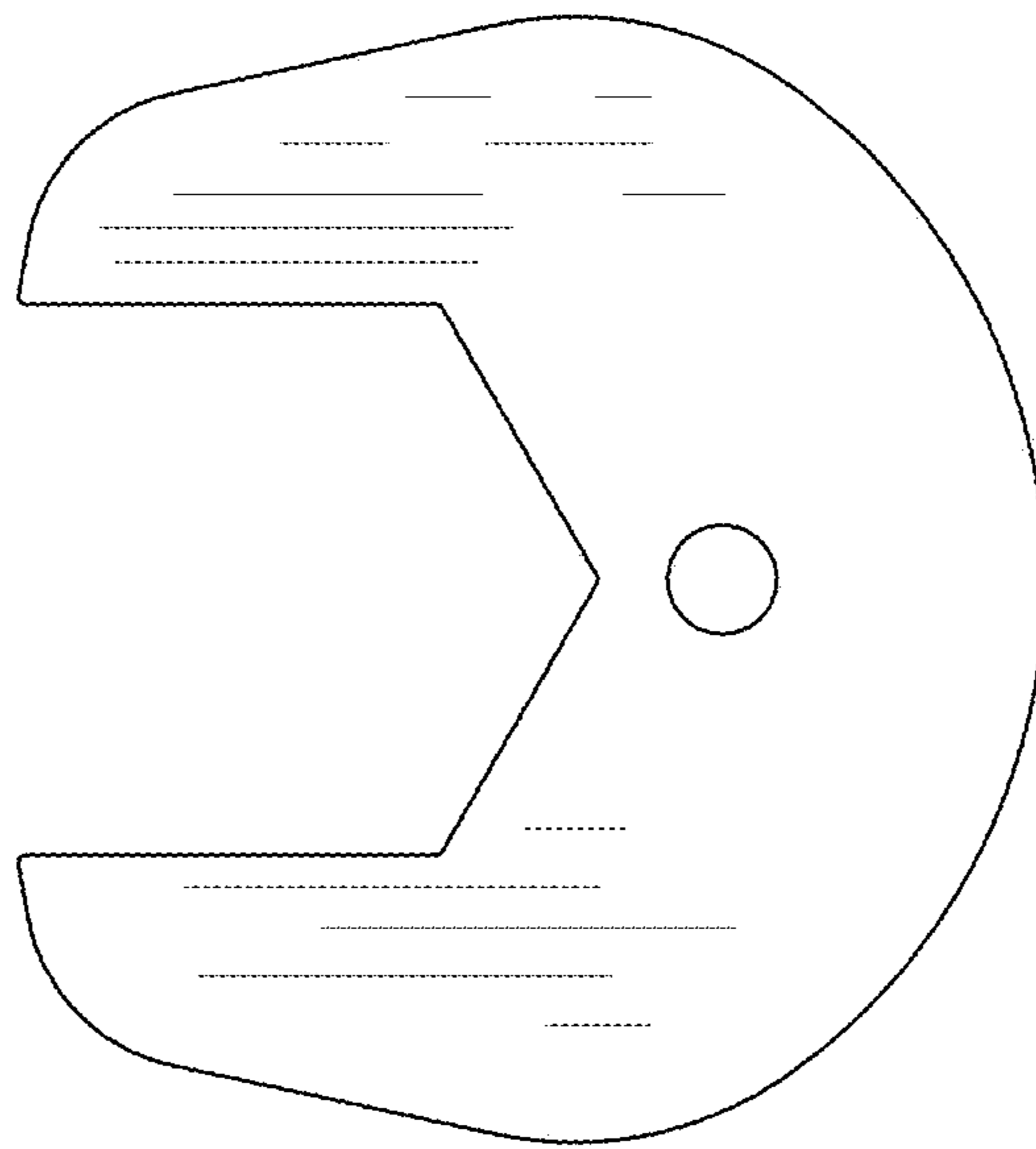

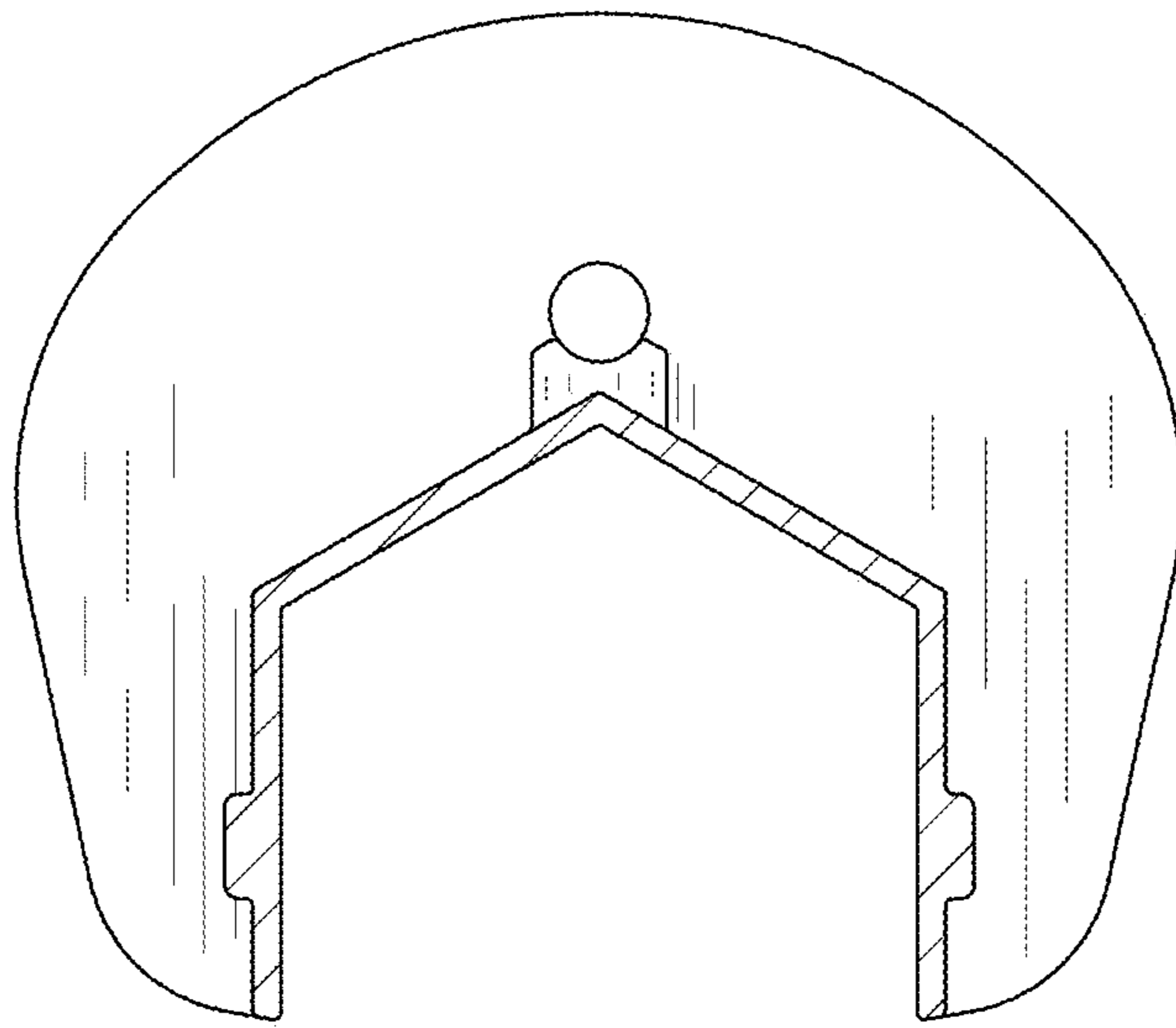
