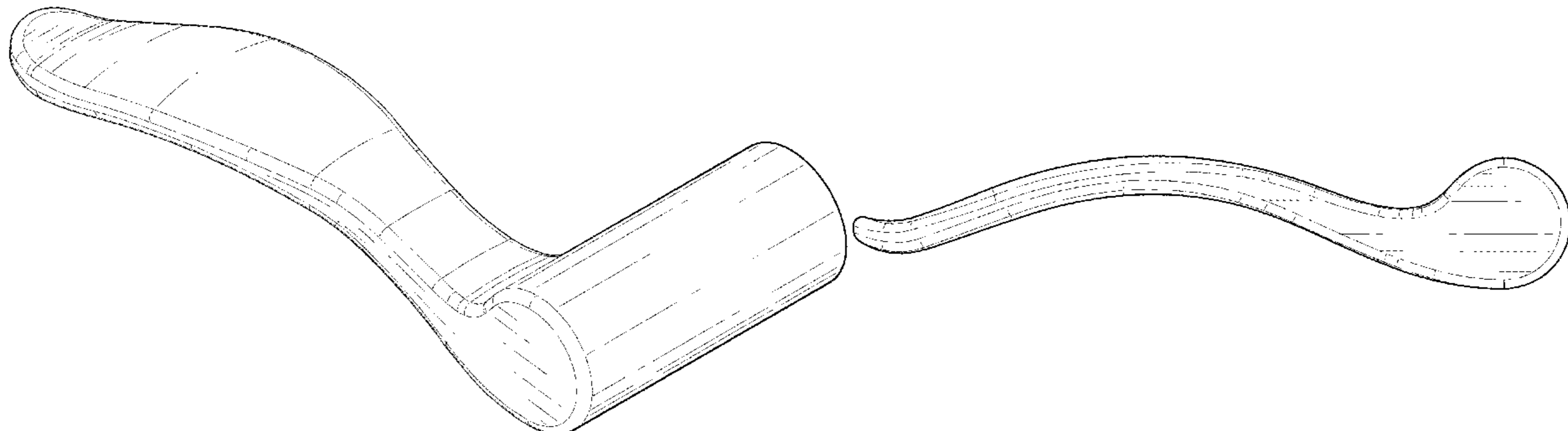
The ornamental design for a door lever, as shown and described.

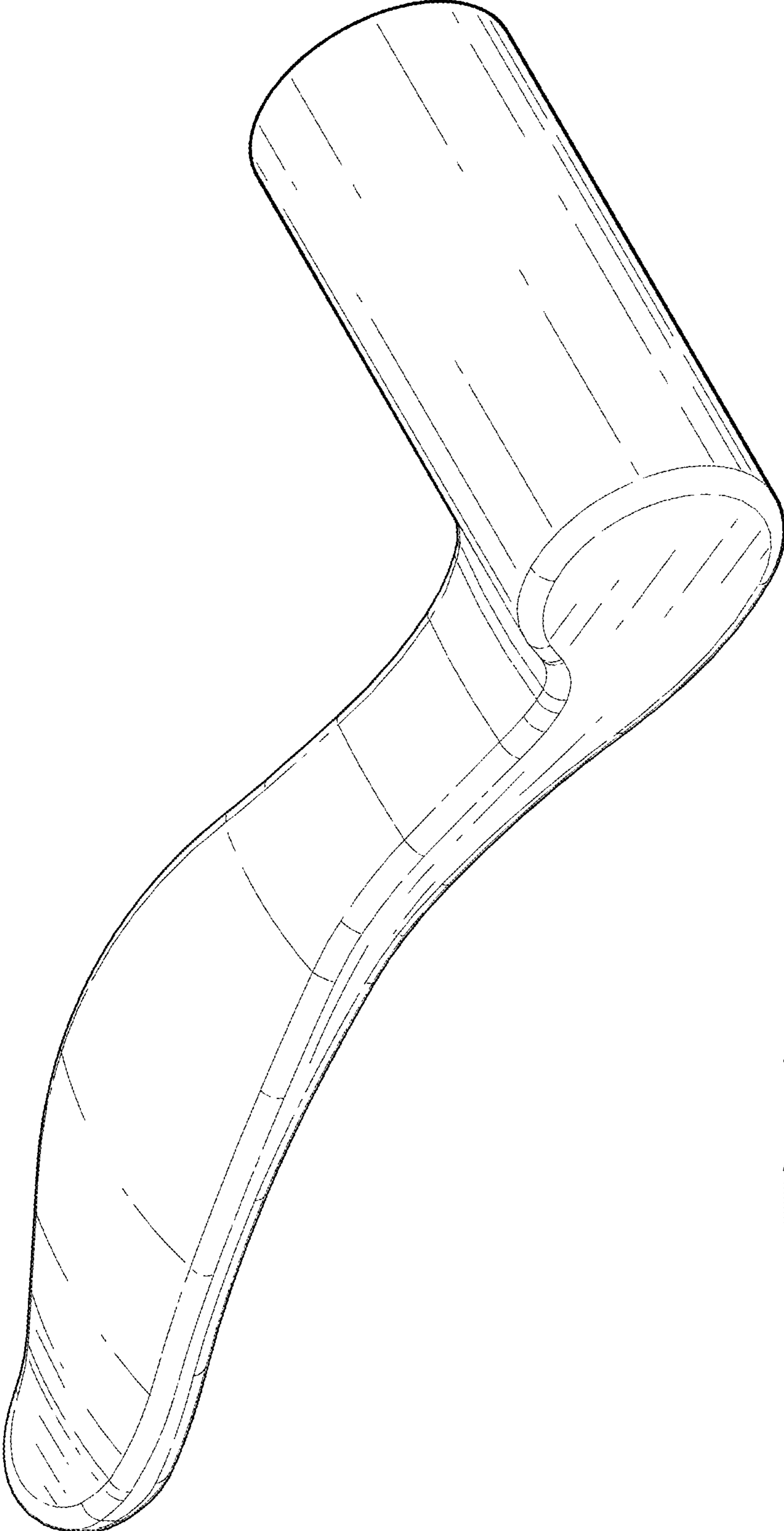

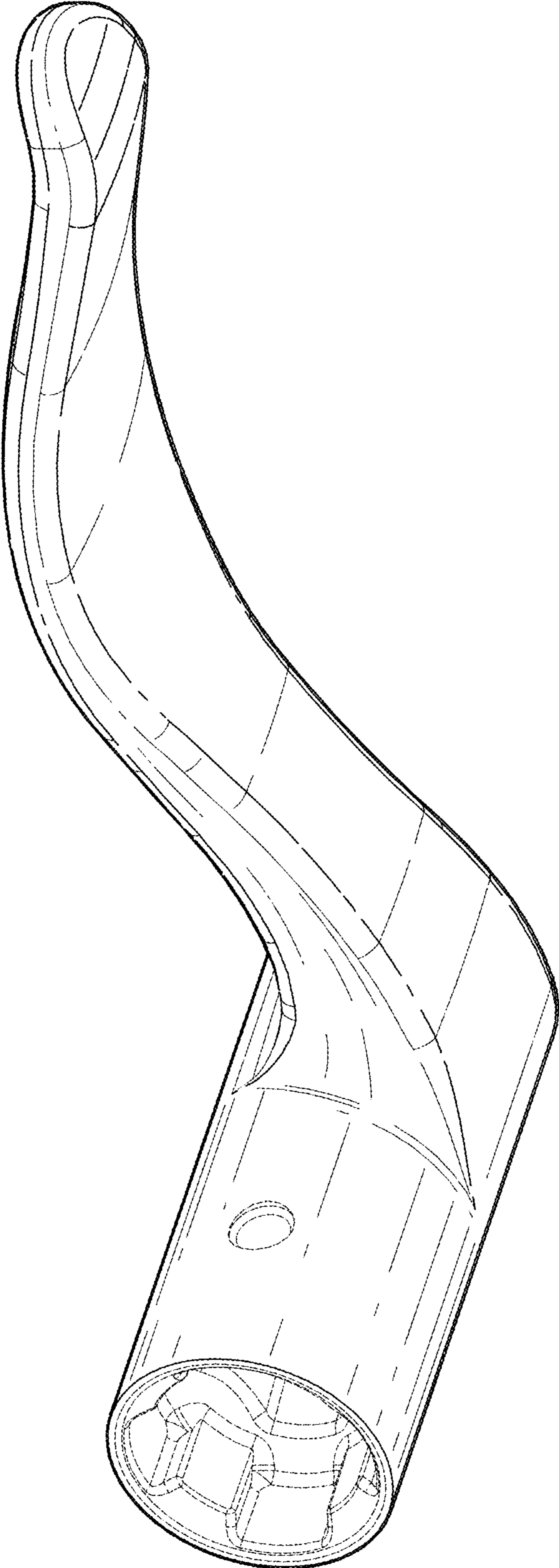

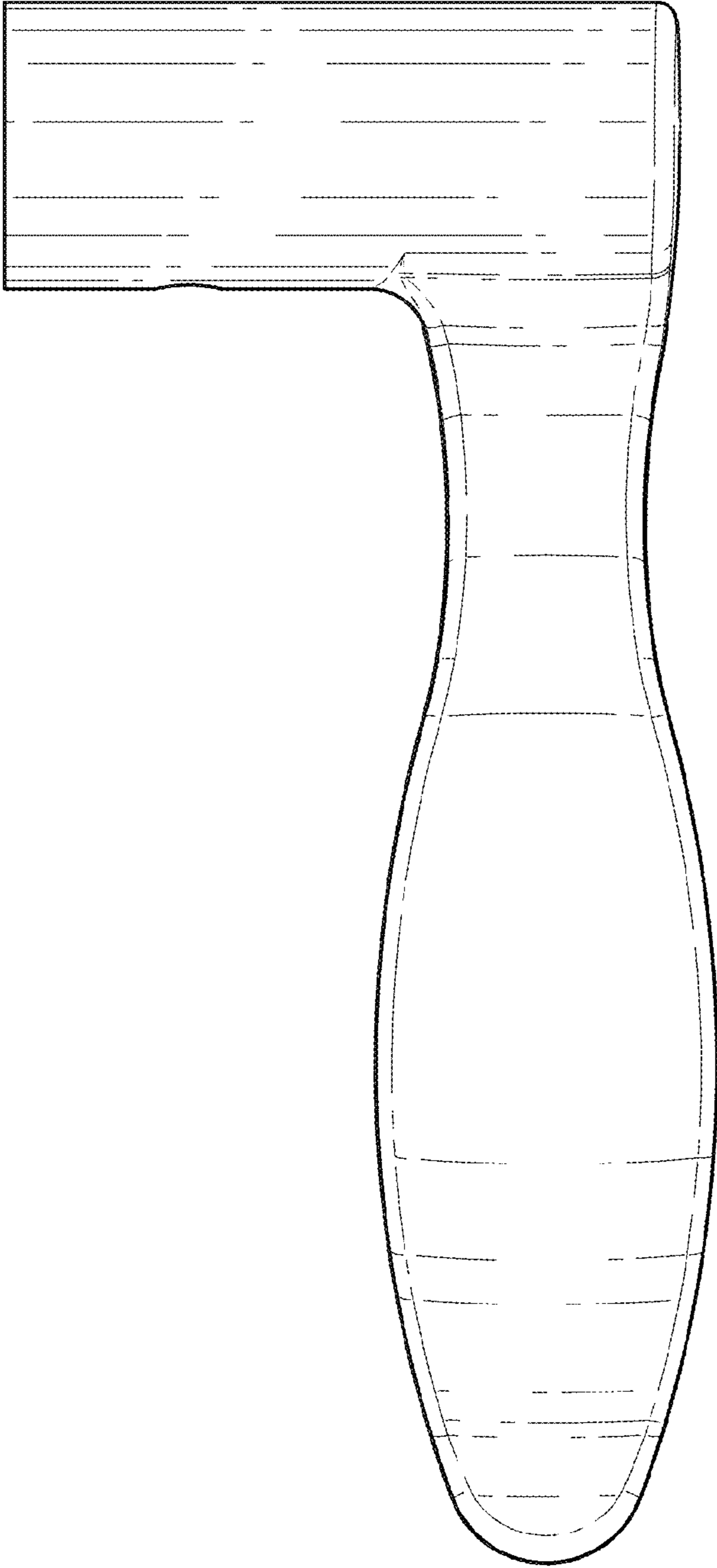

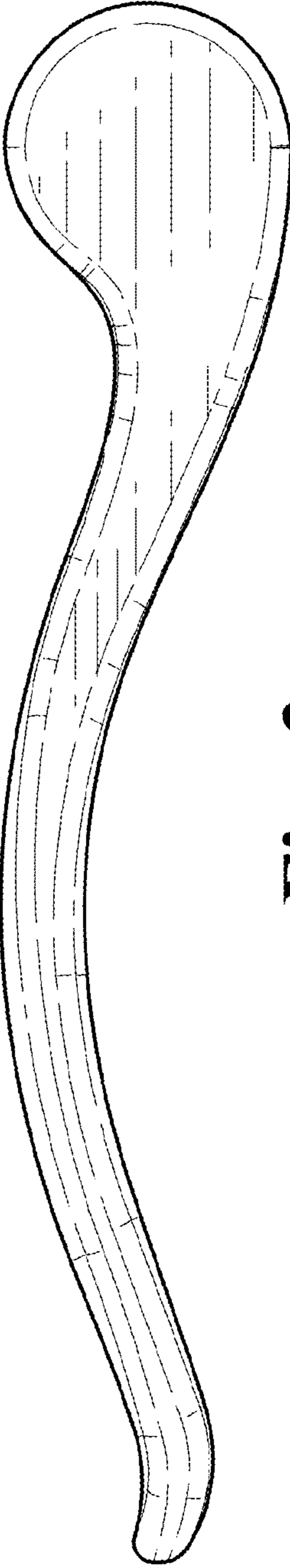

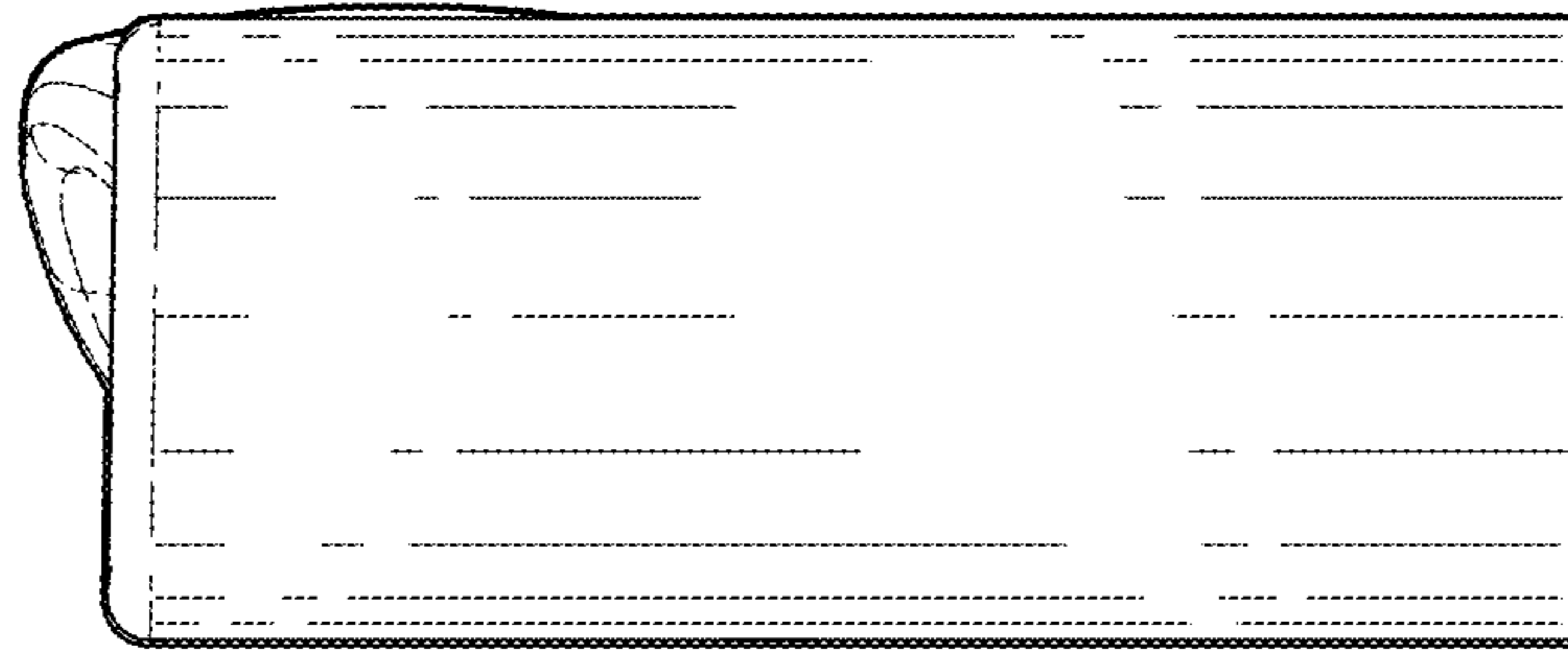

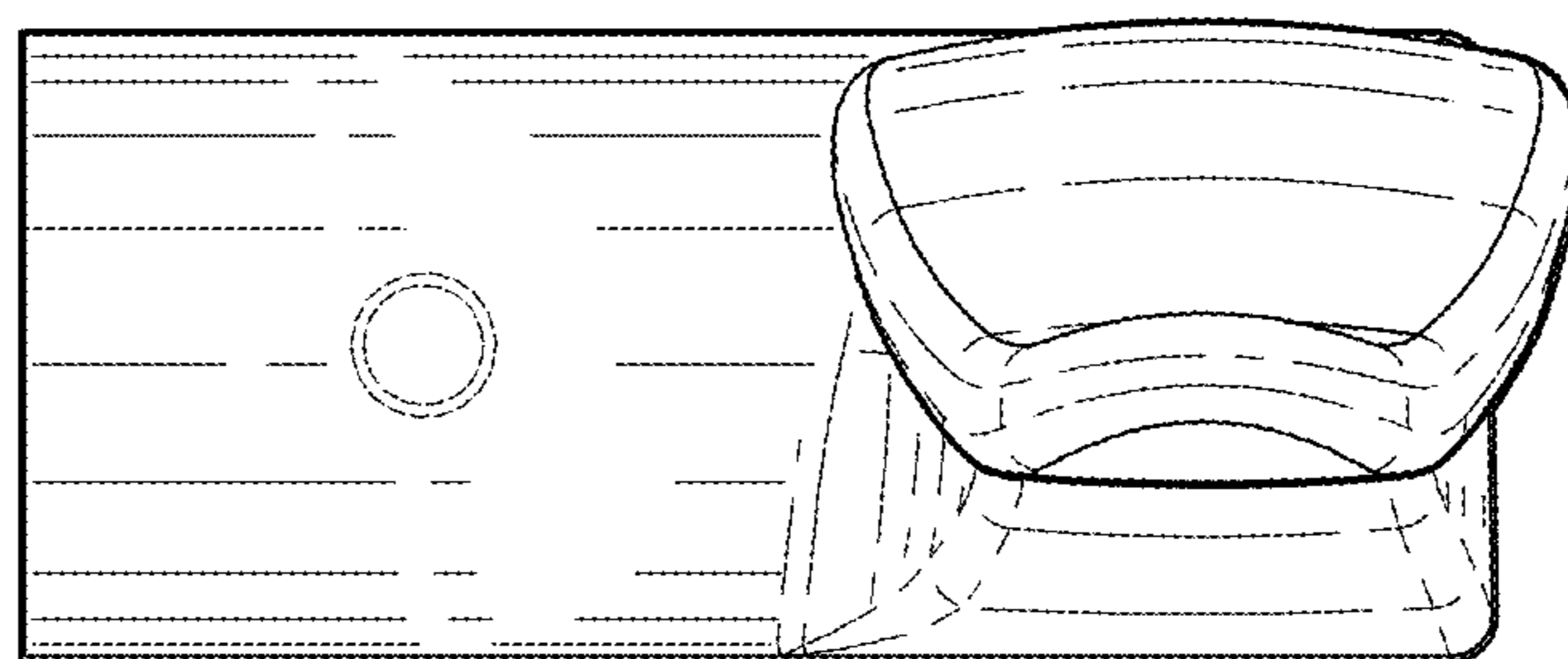

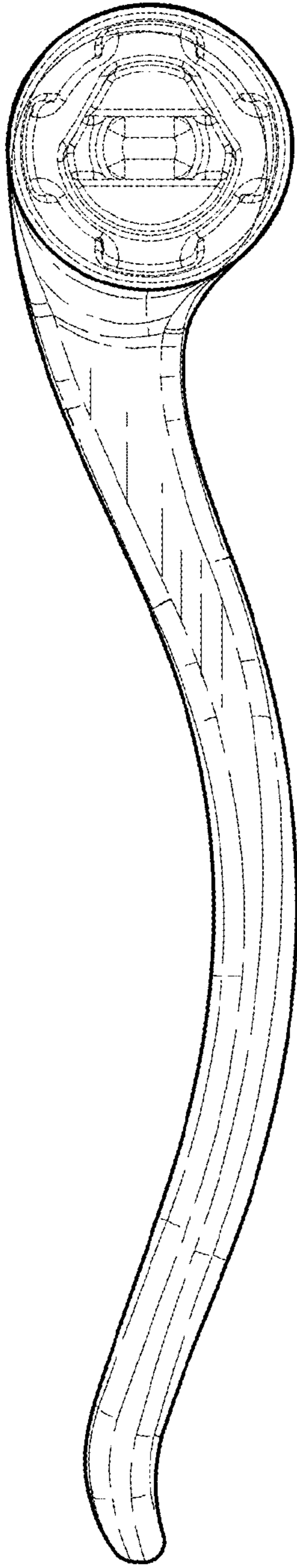

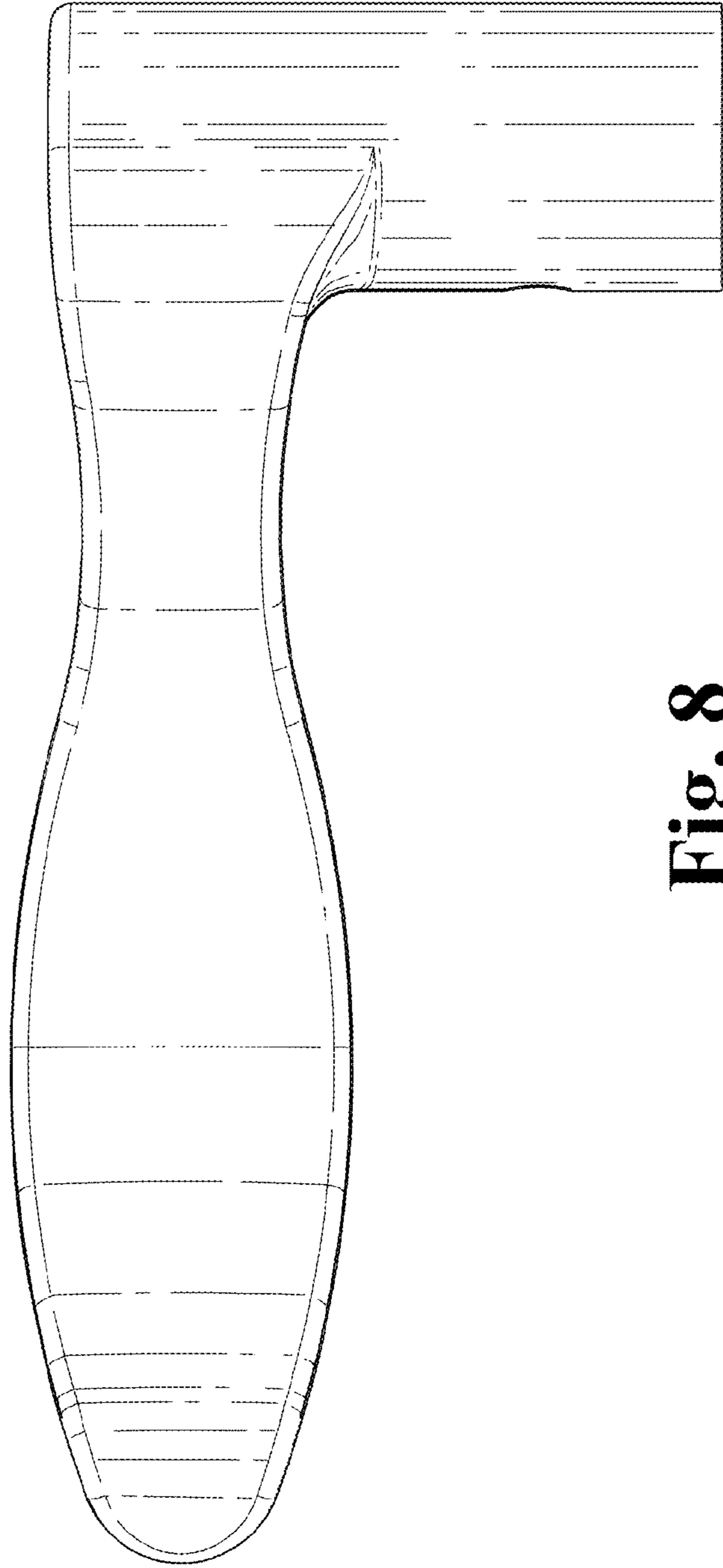
