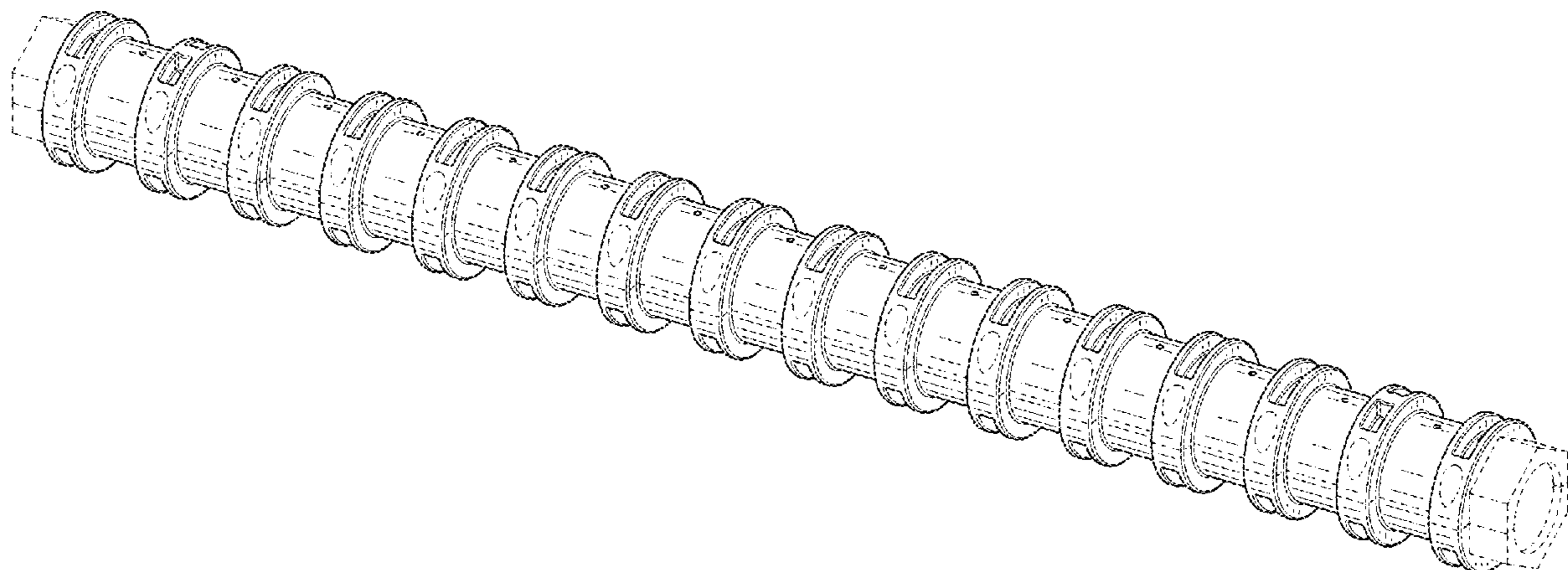
I, claim the ornamental design for an internal winding spool, as shown and described.

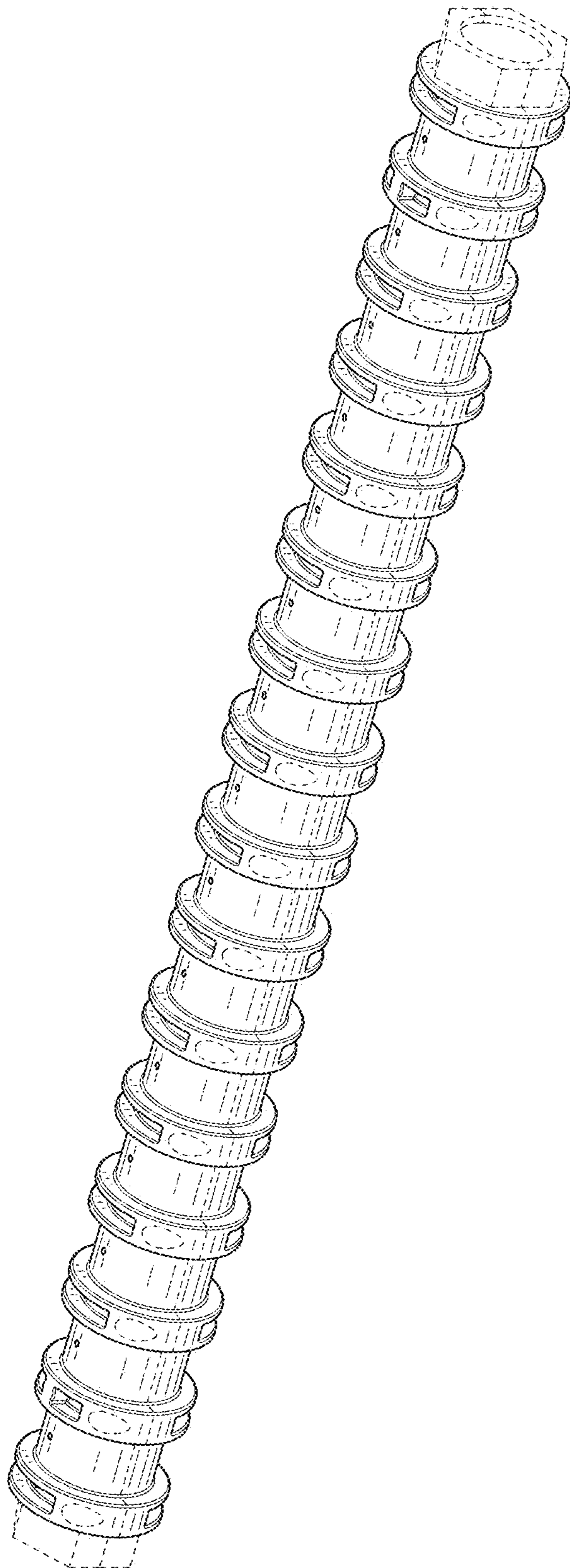

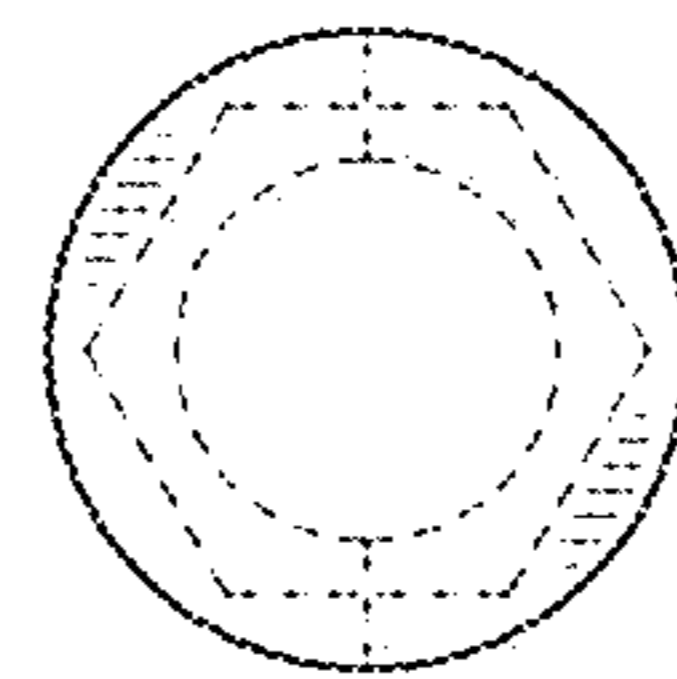

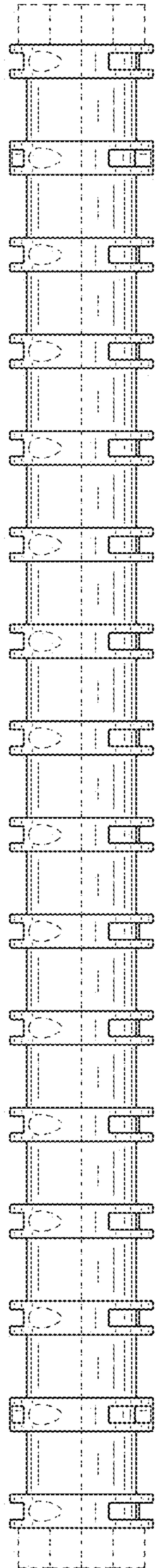

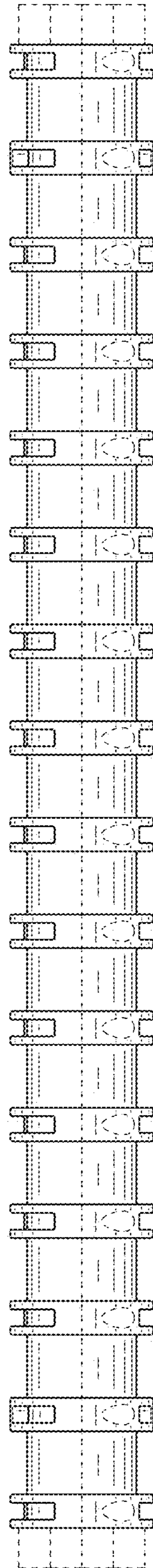

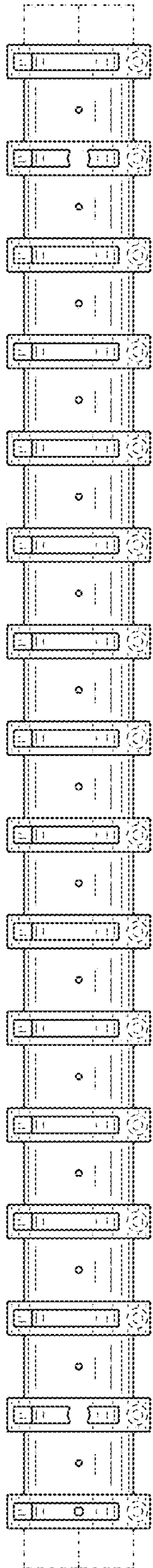

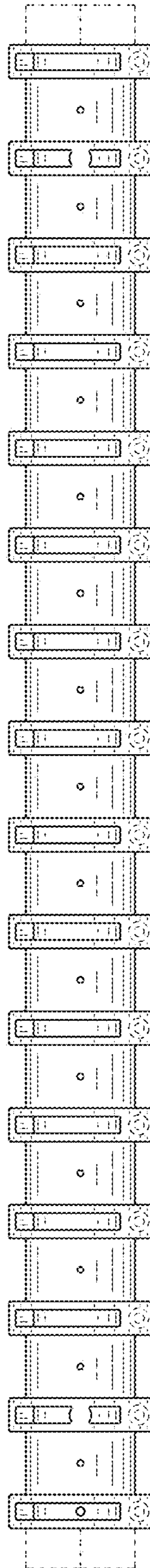
