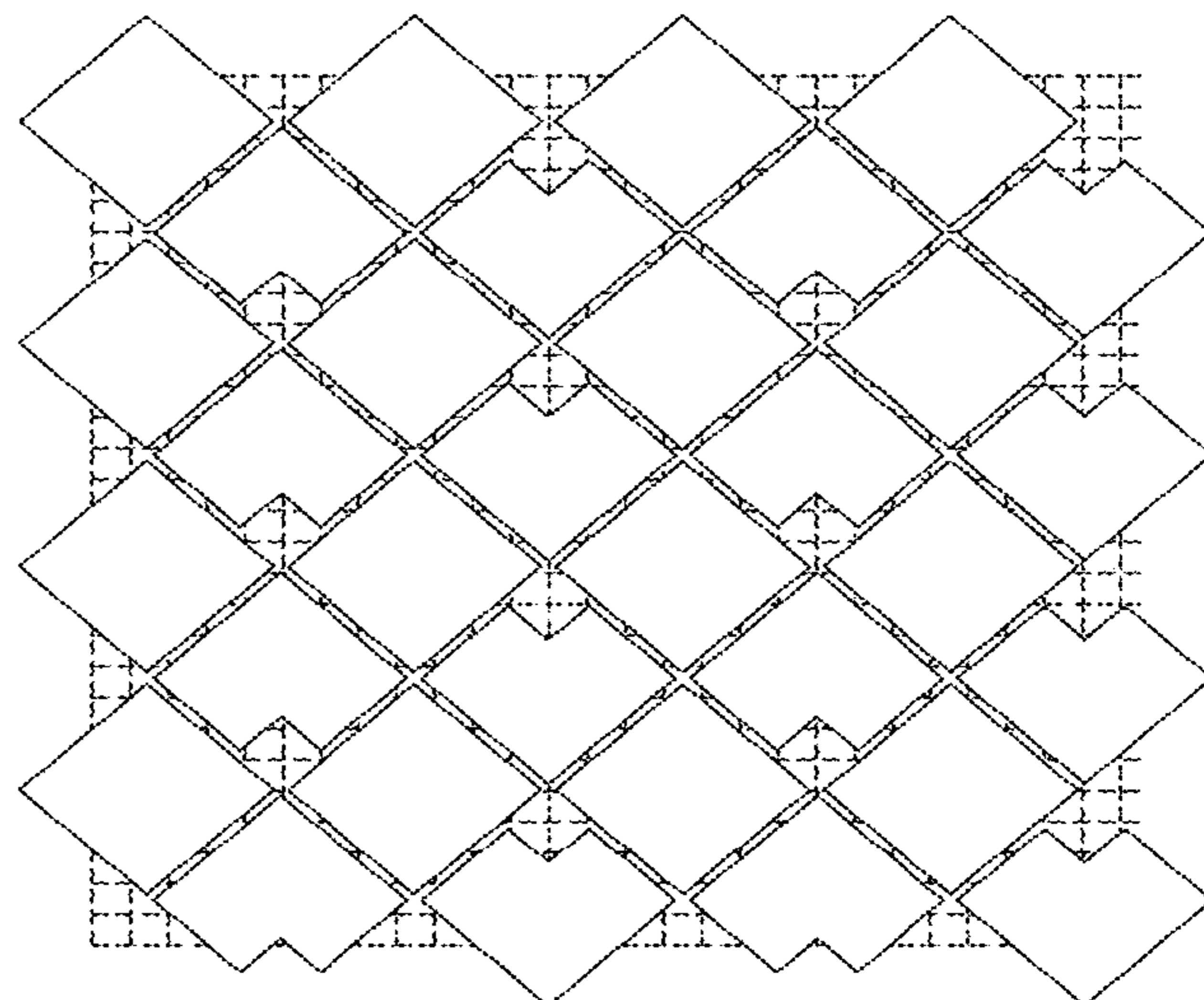
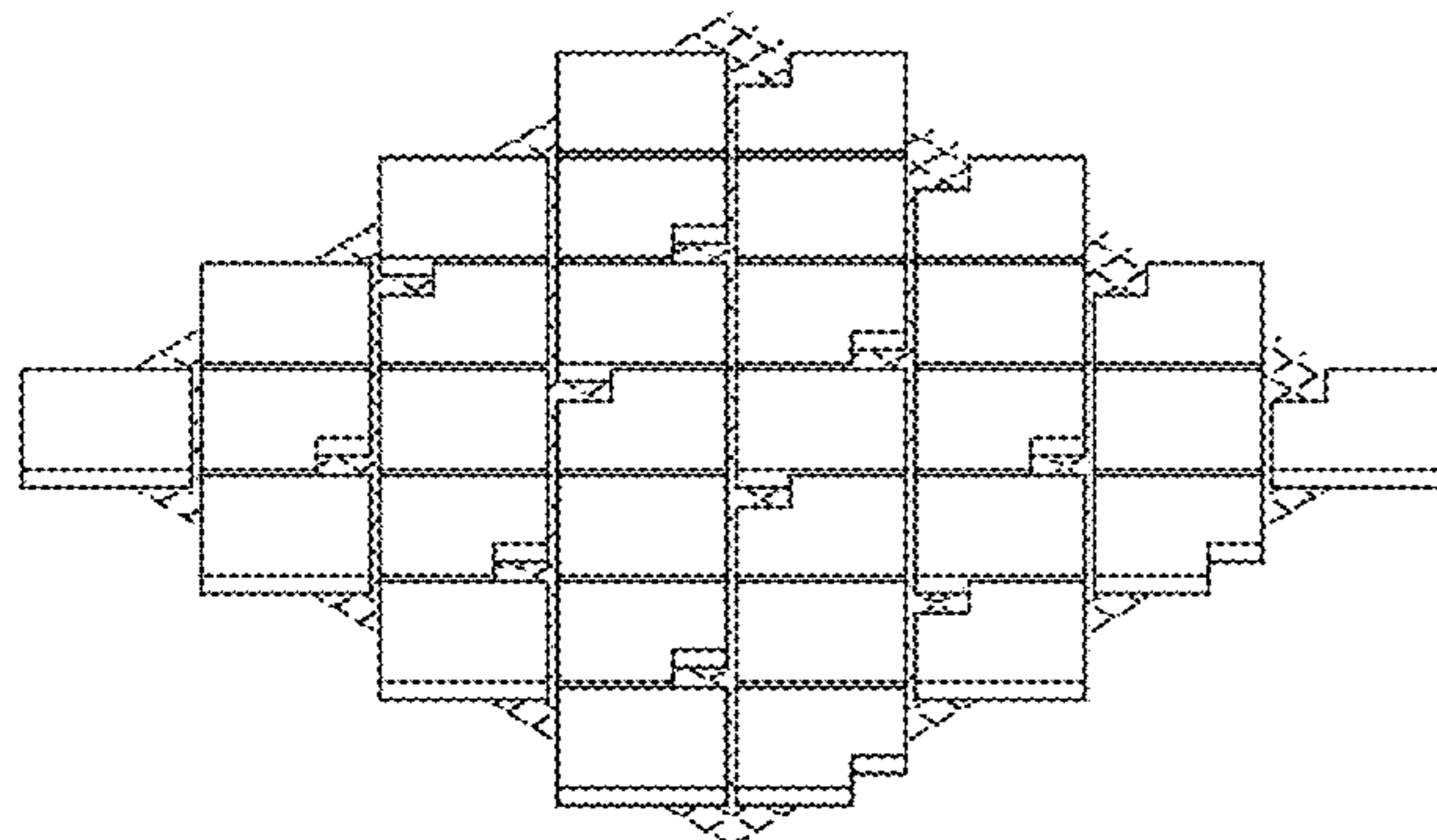
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of the wall ornament showing my new design;  
FIG. 2 is a top view thereof;

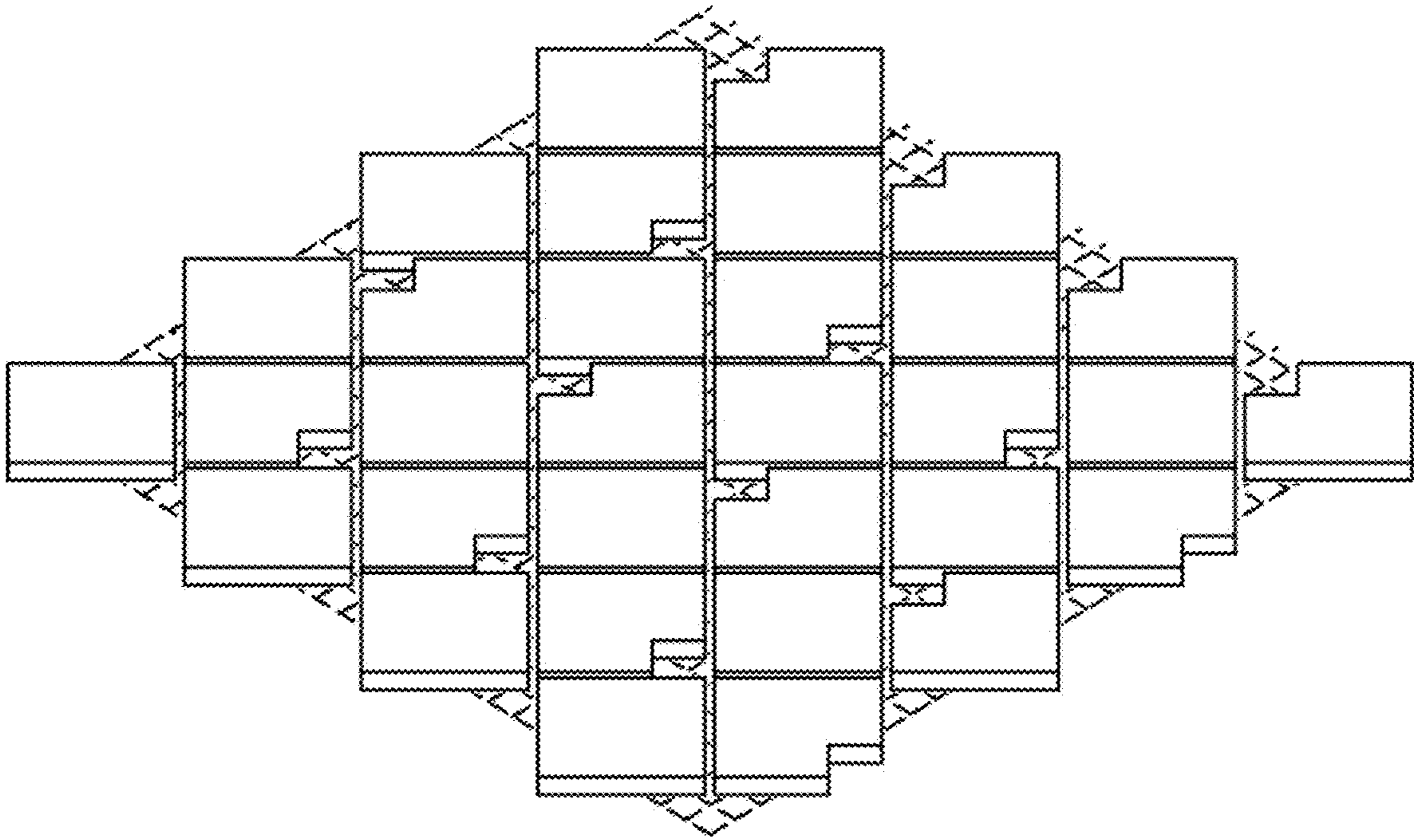

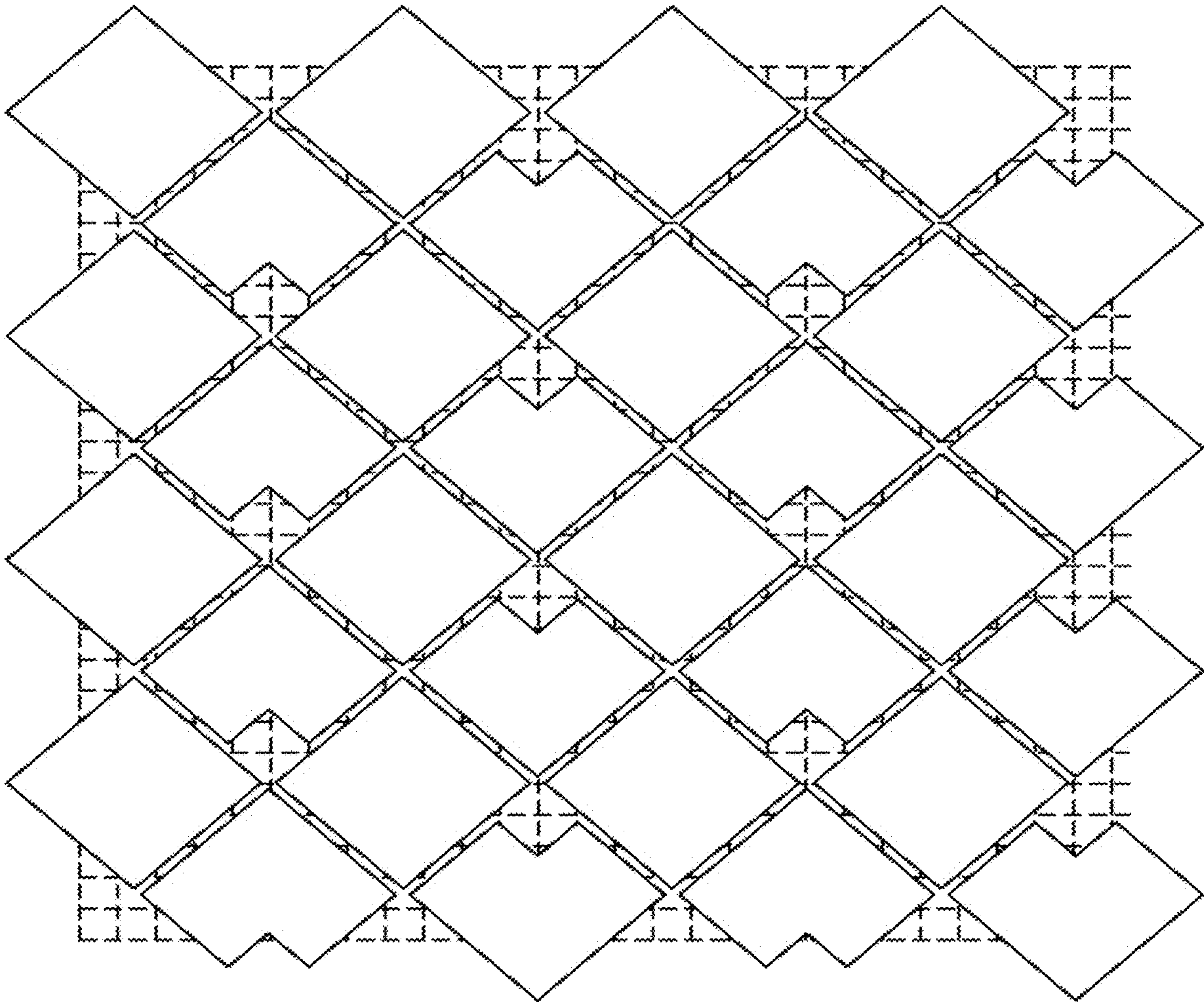

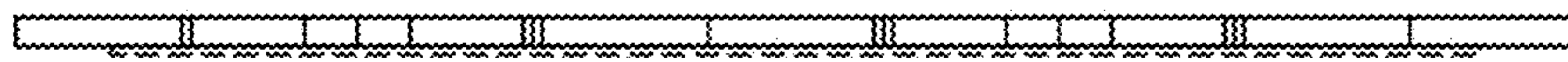

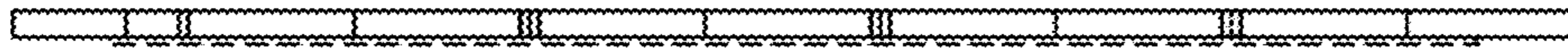

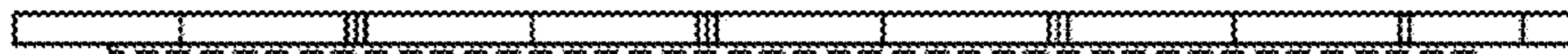

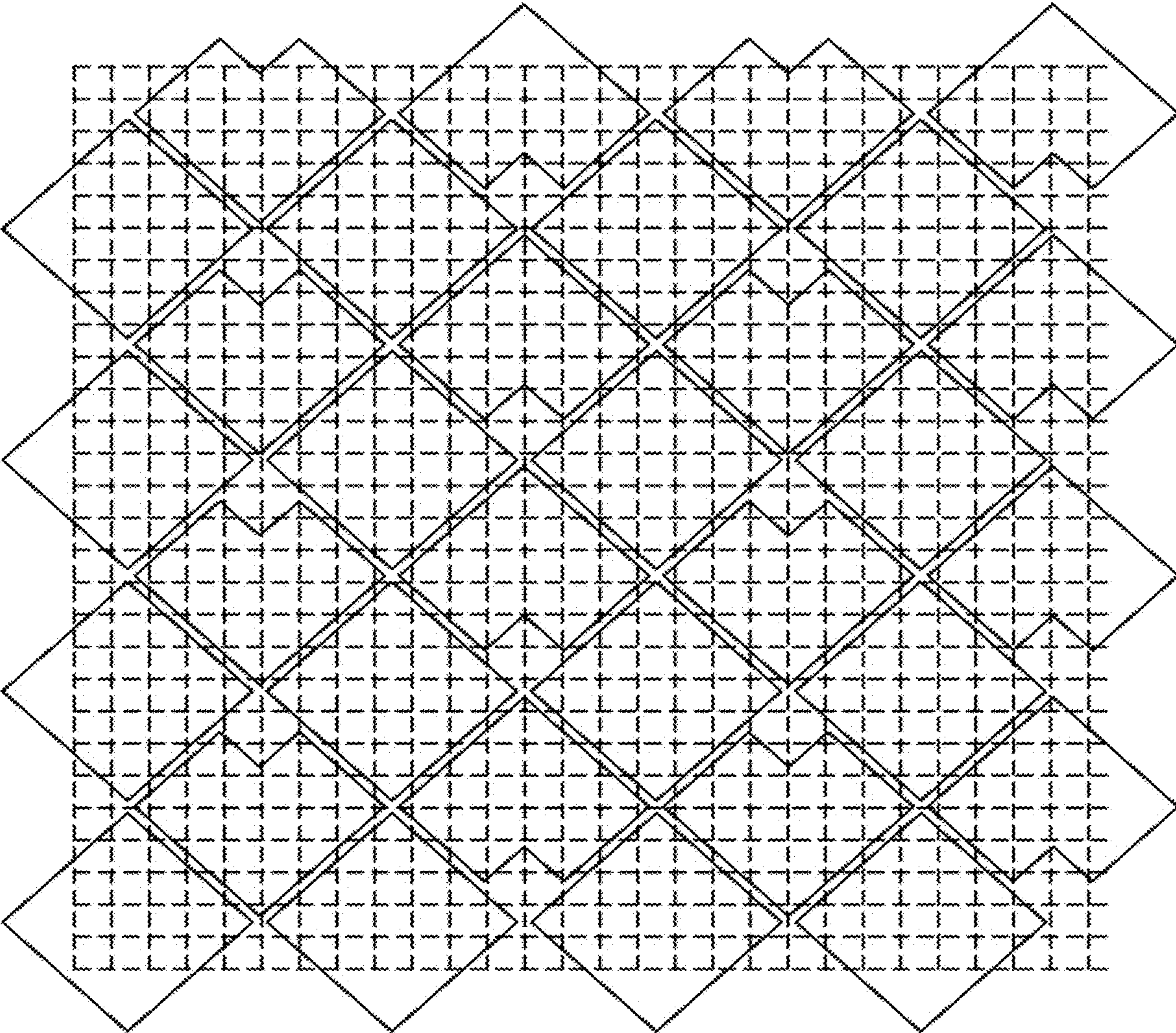
