(57) **CLAIM**

The ornamental design for a folding golf cart rear seat and box kit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a folded up seat for a folding golf cart rear seat and box kit.

FIG. 2 is a right side view of the folded up seat for the folding golf cart rear seat and box kit.

FIG. 11 is a back view of the folded down seat for the folding golf cart rear seat and box kit.

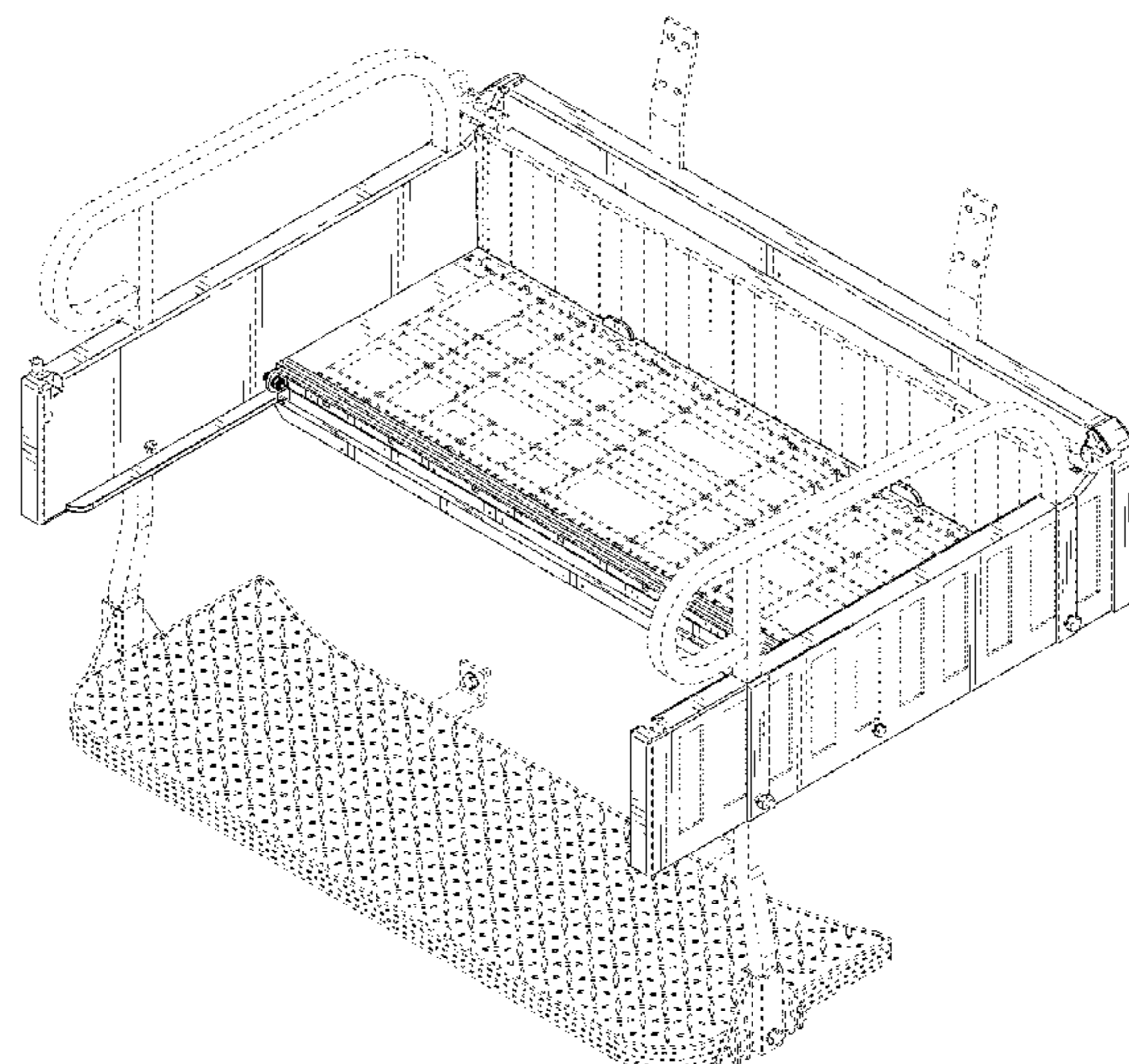
FIG. 12 is a top view of the folded down seat for the folding golf cart rear seat and box kit.

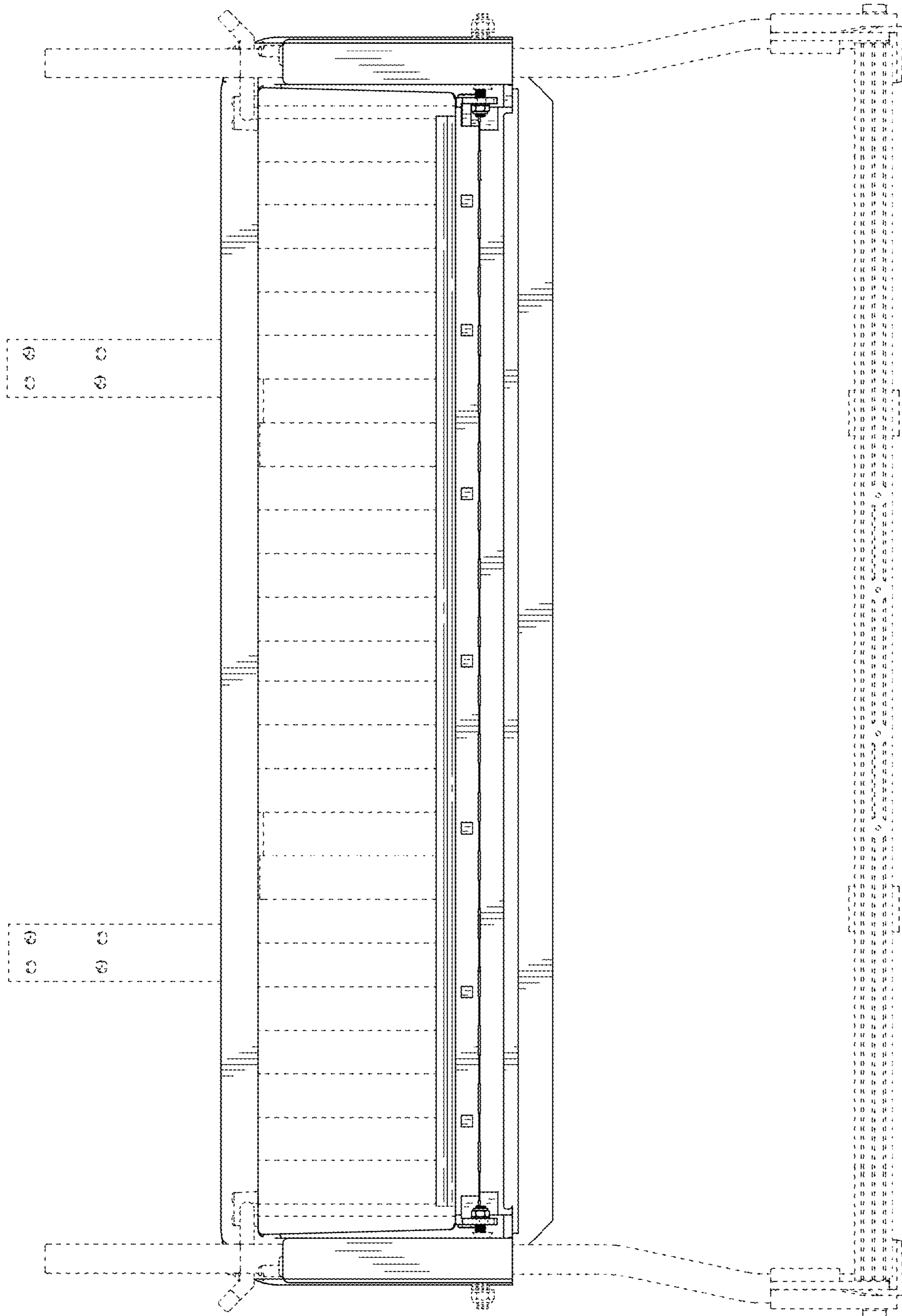

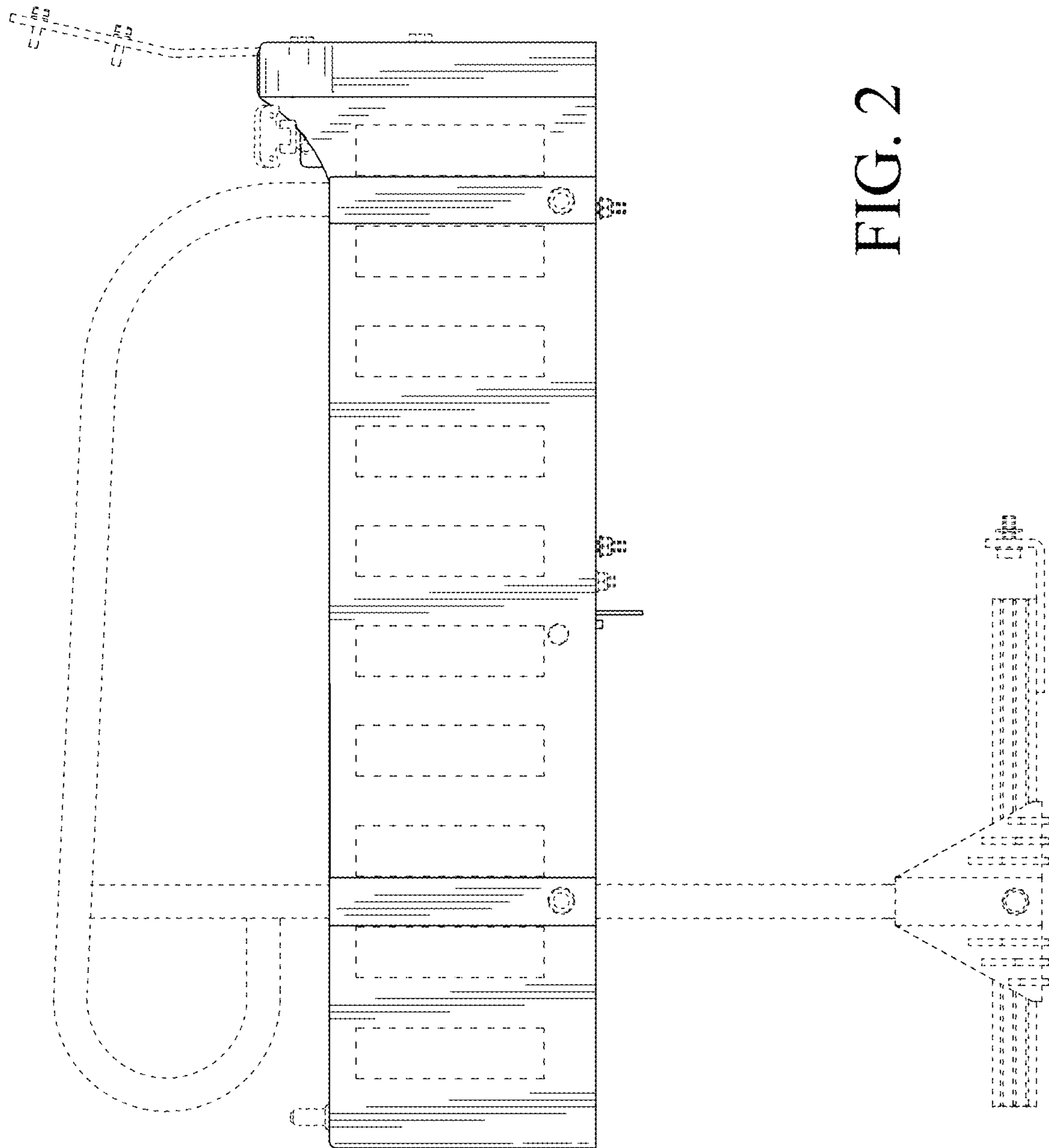

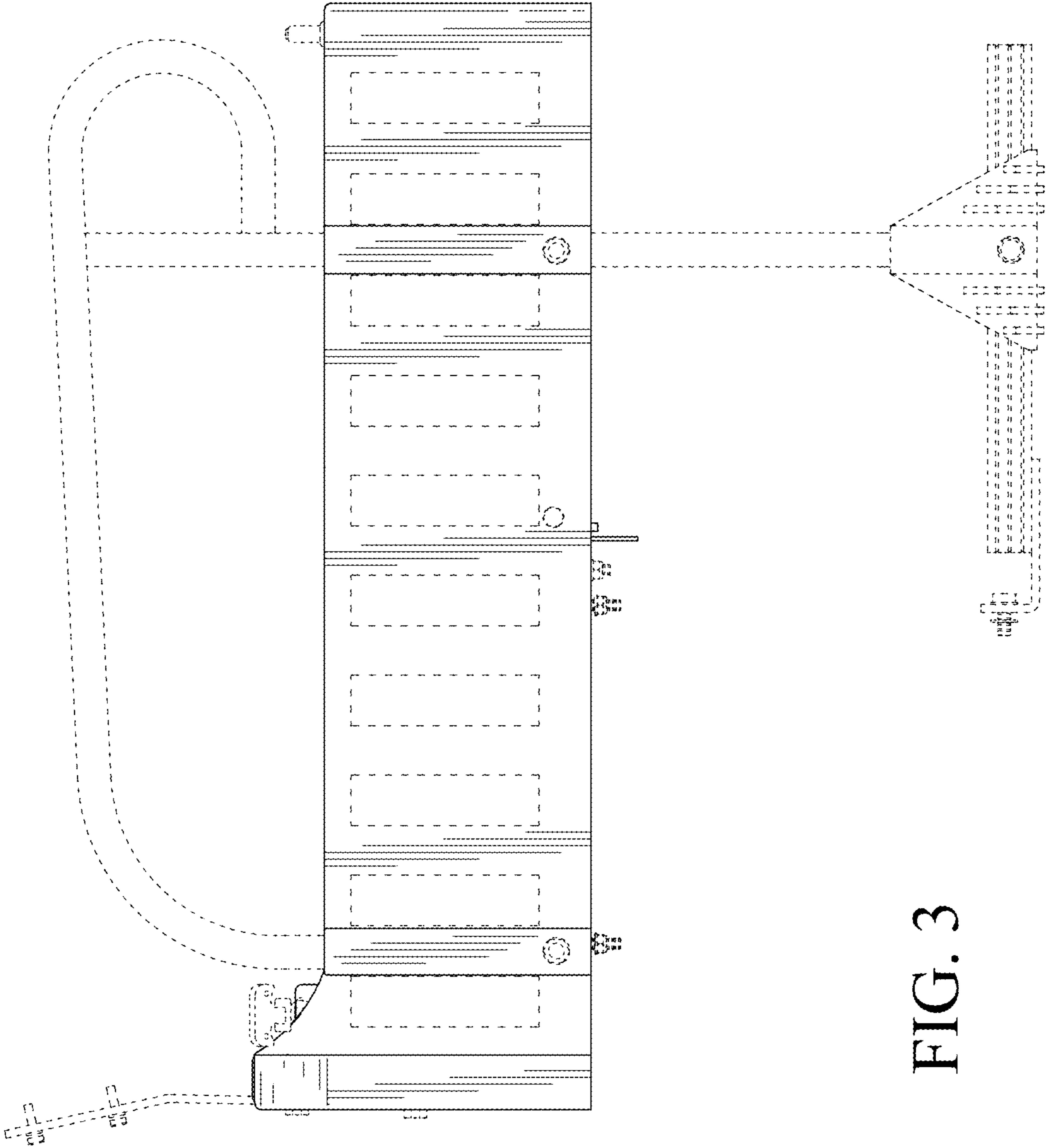

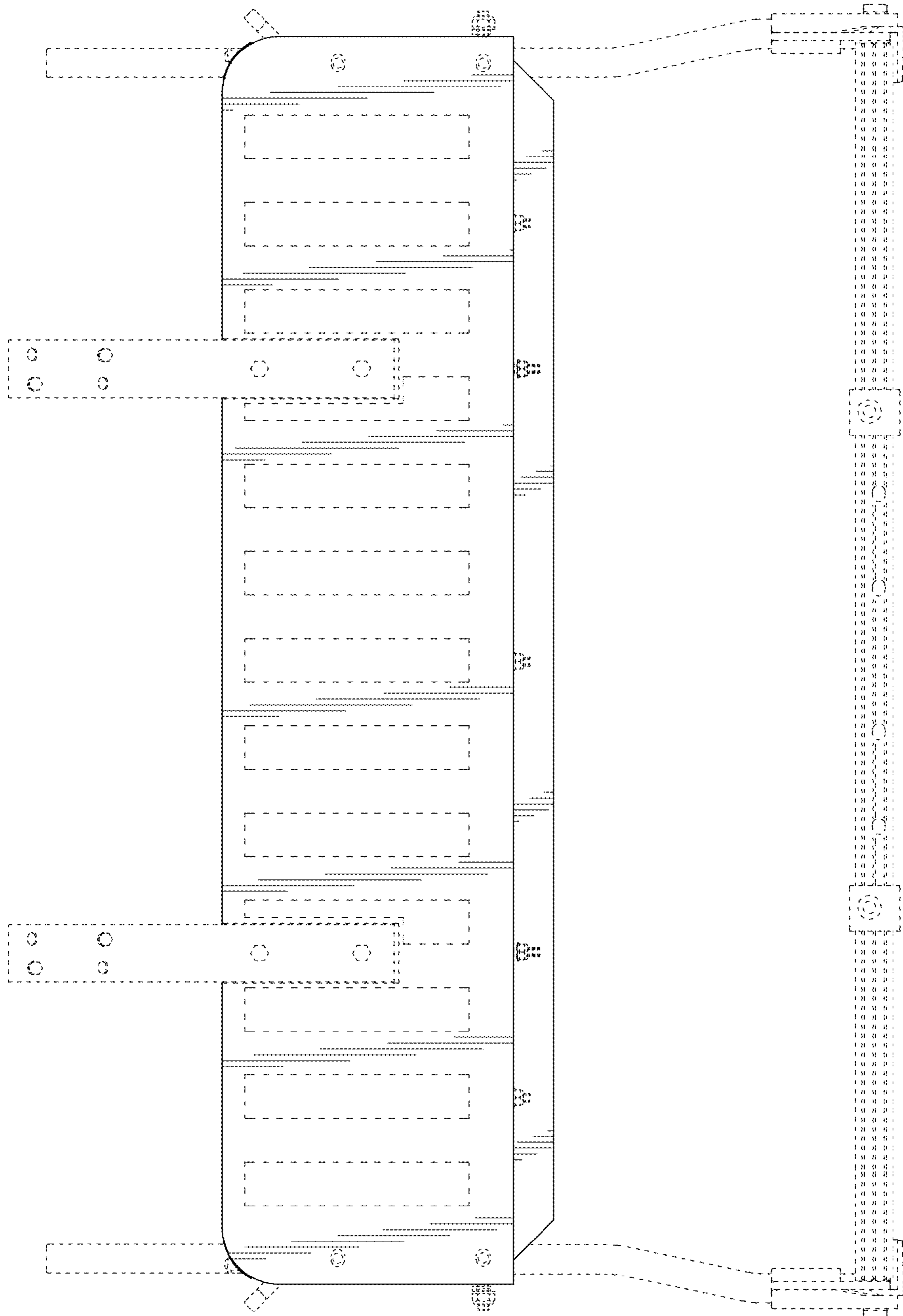

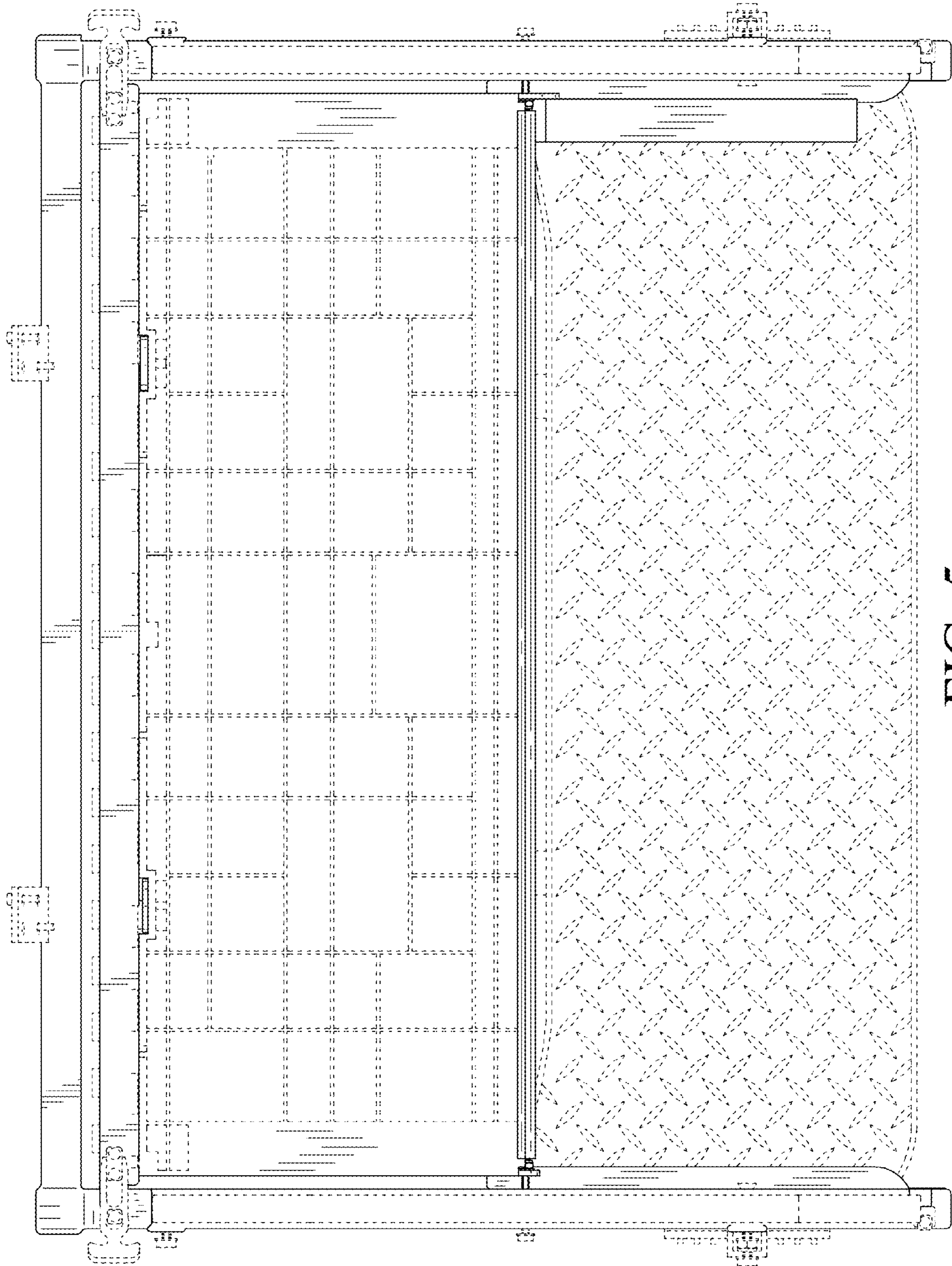

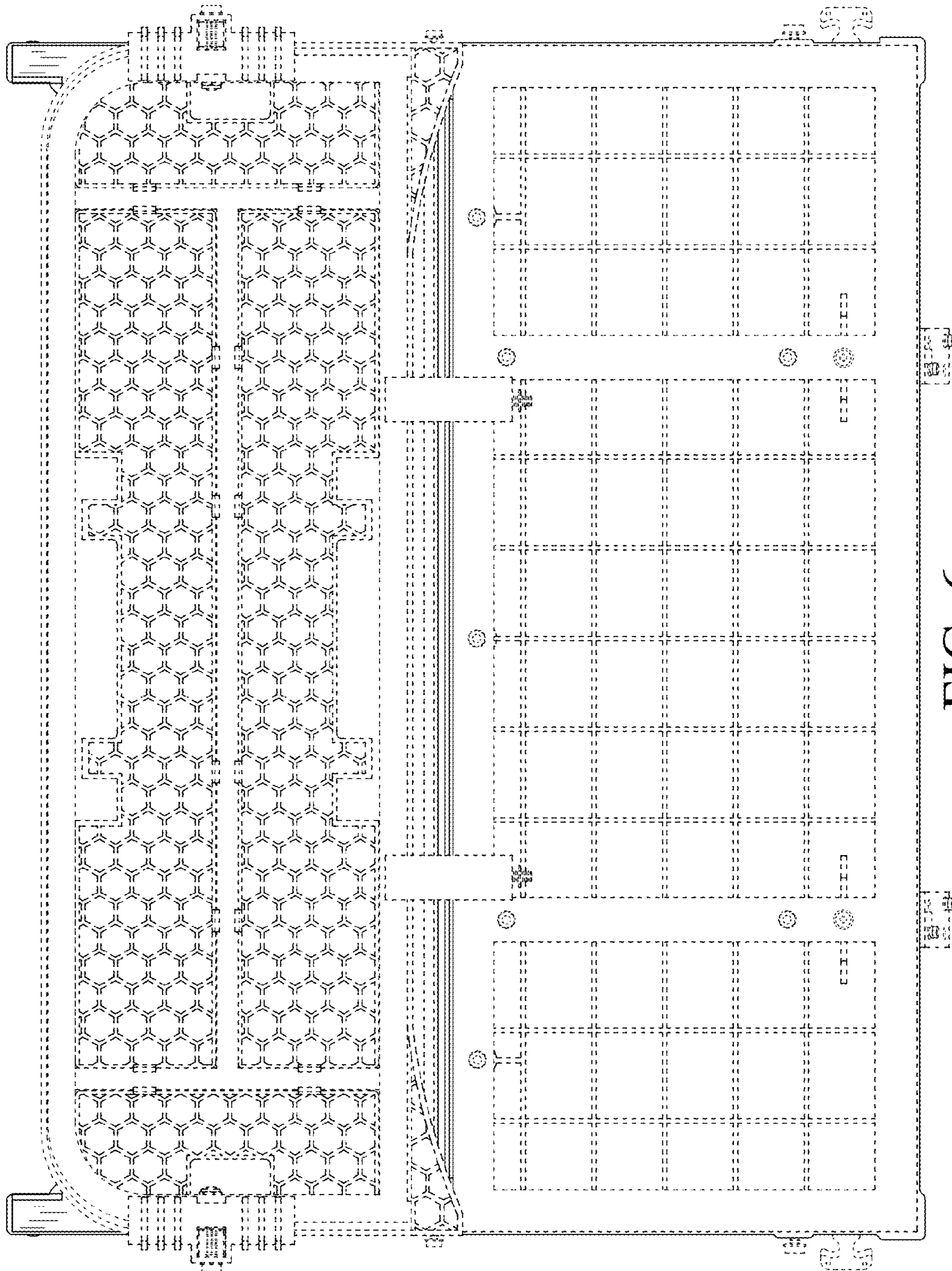

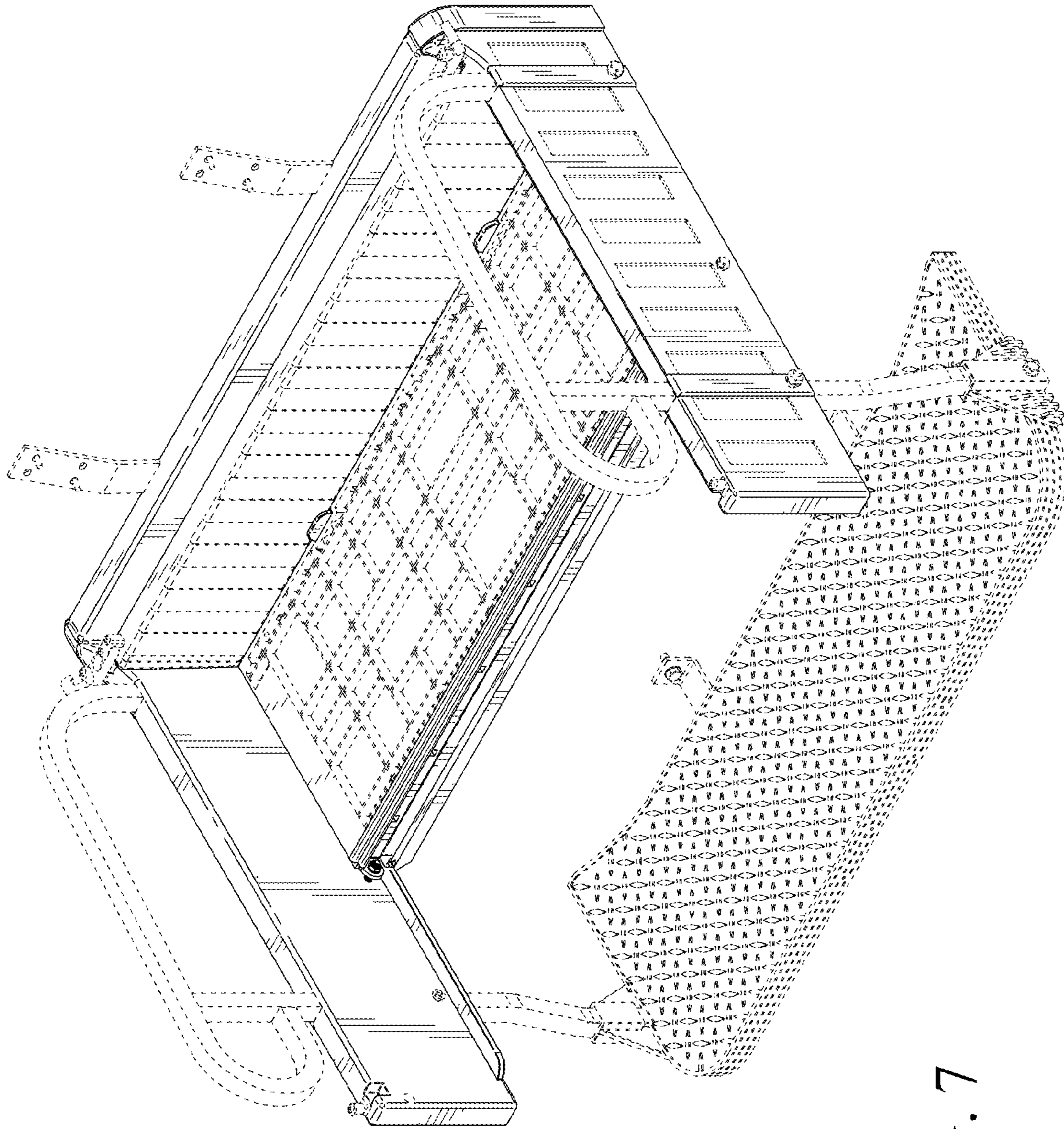

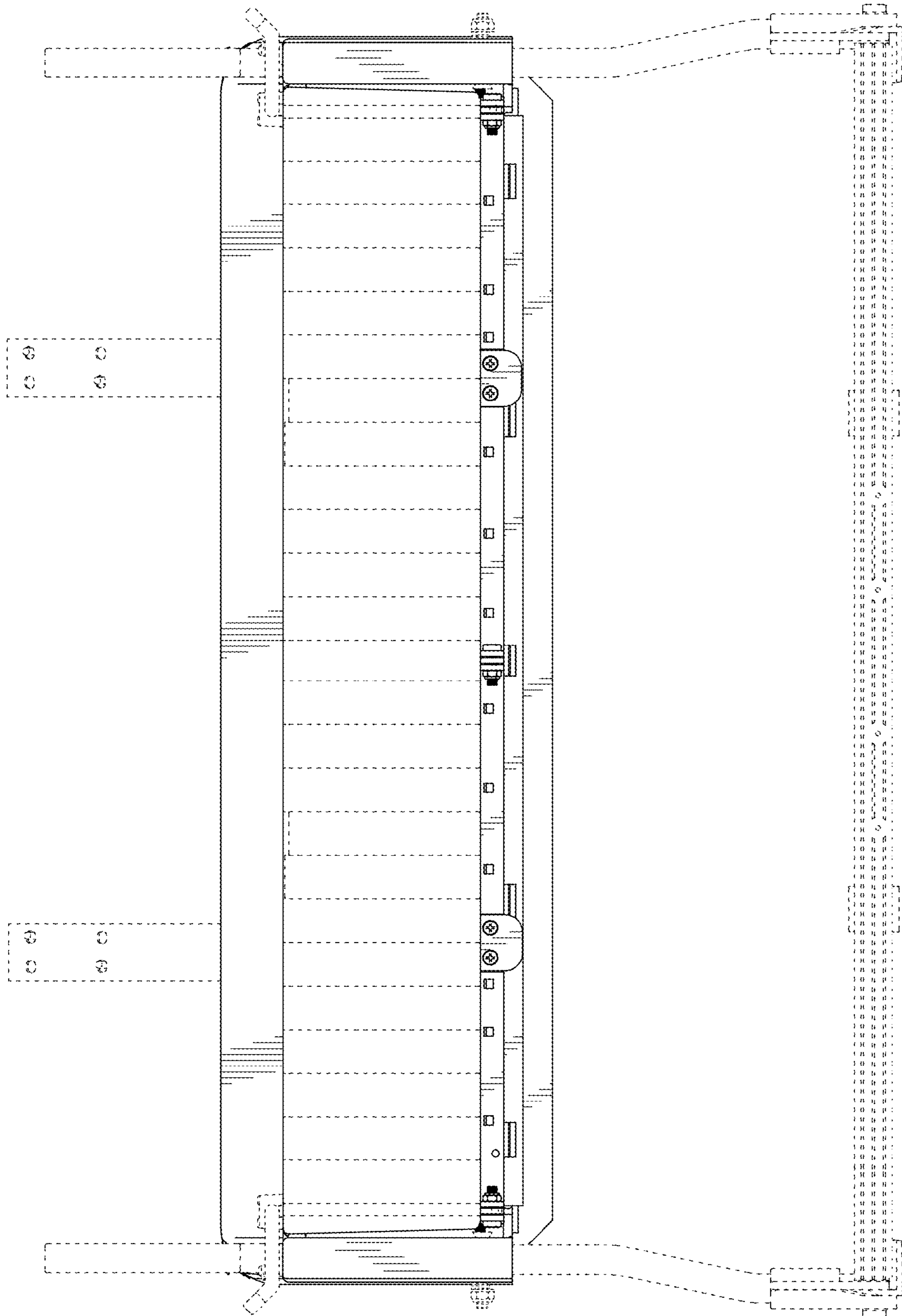

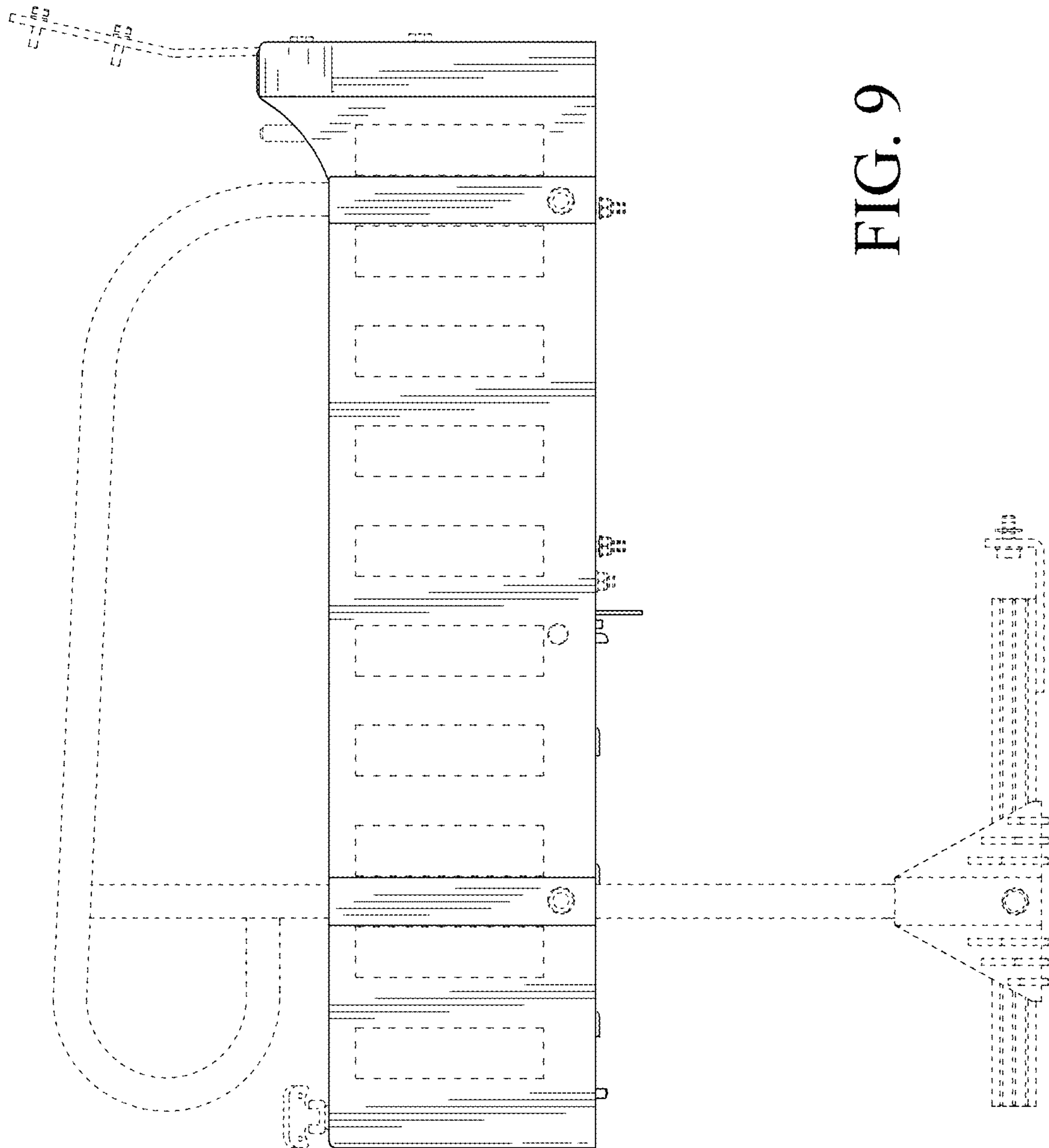

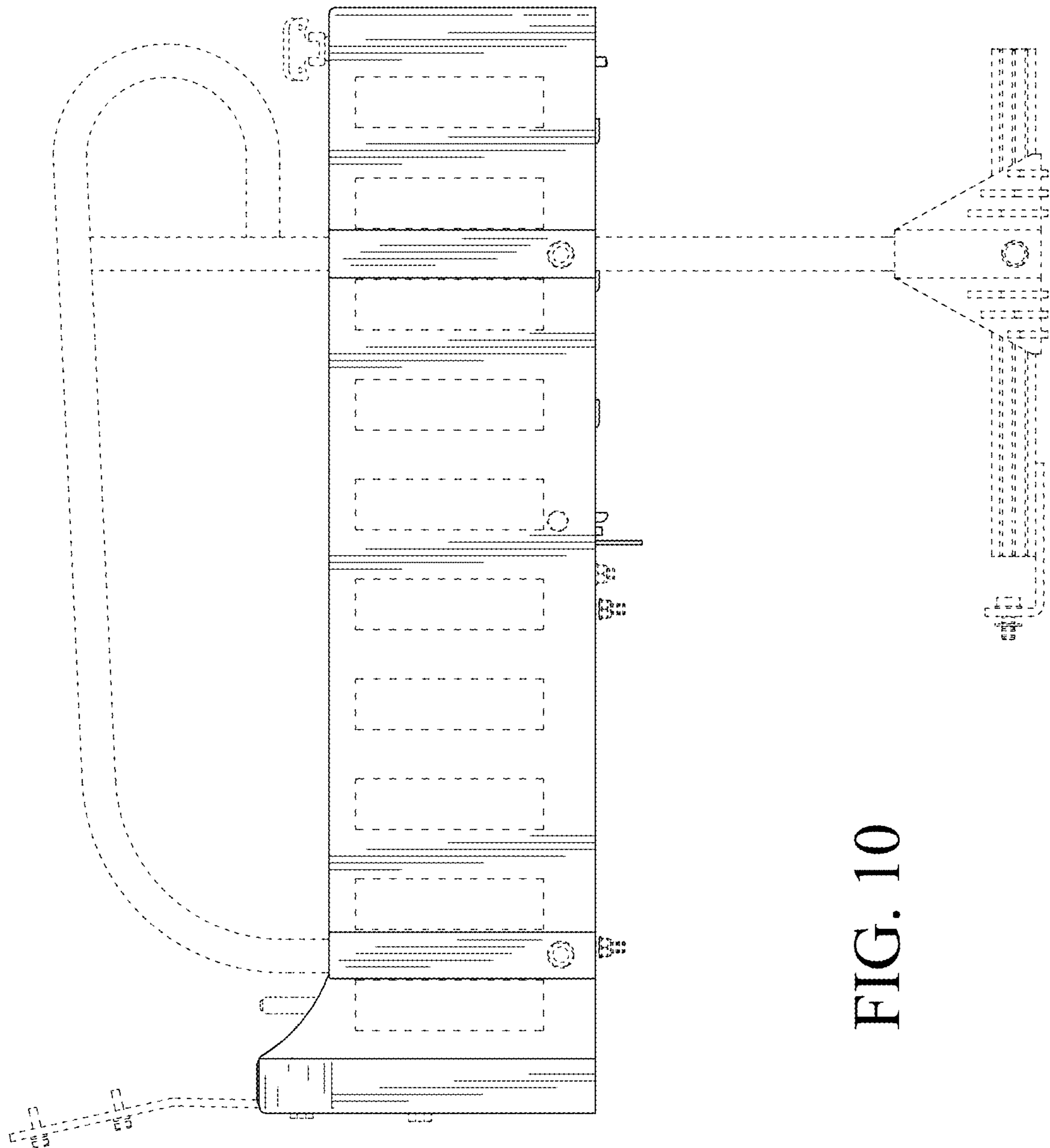

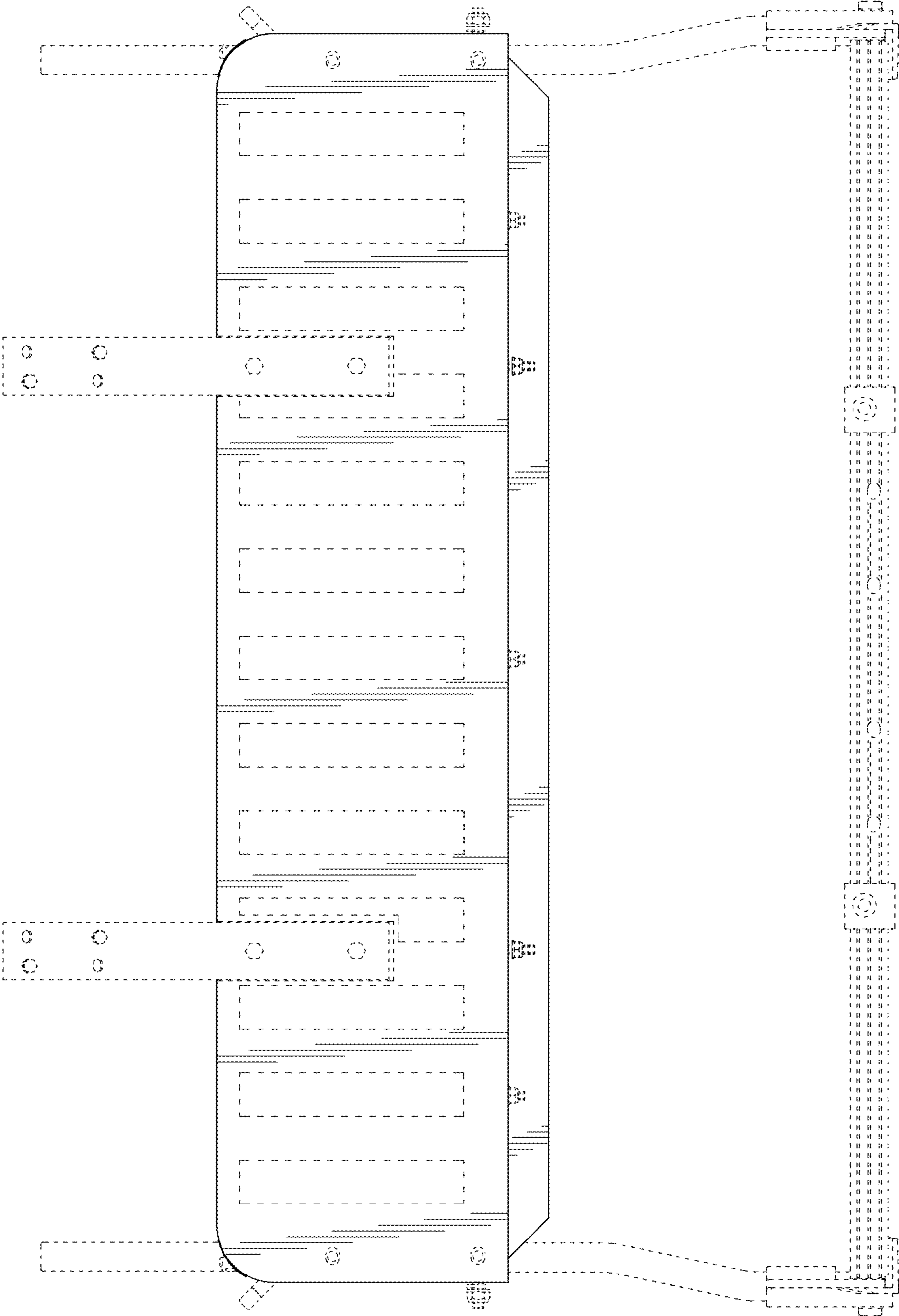

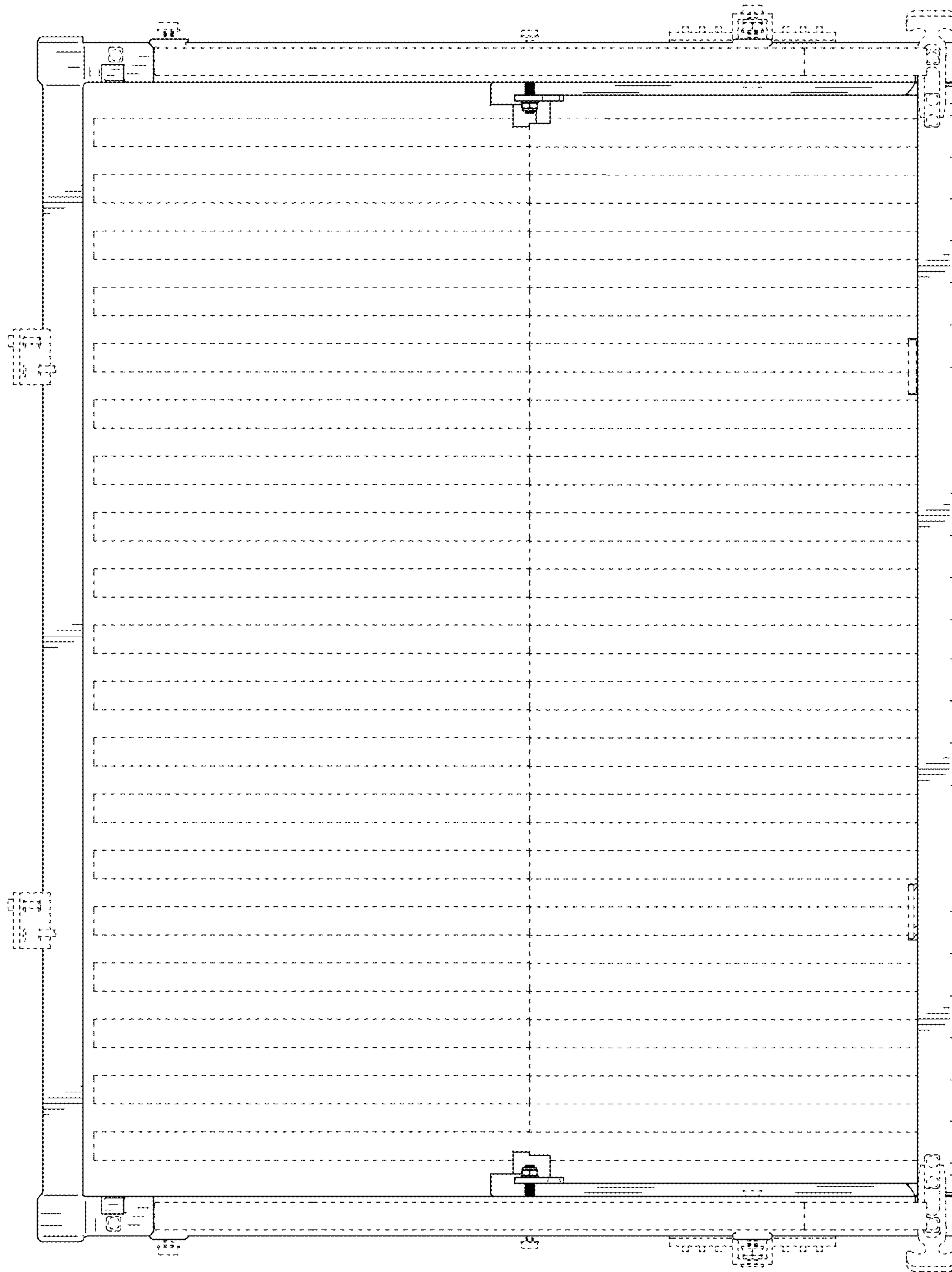

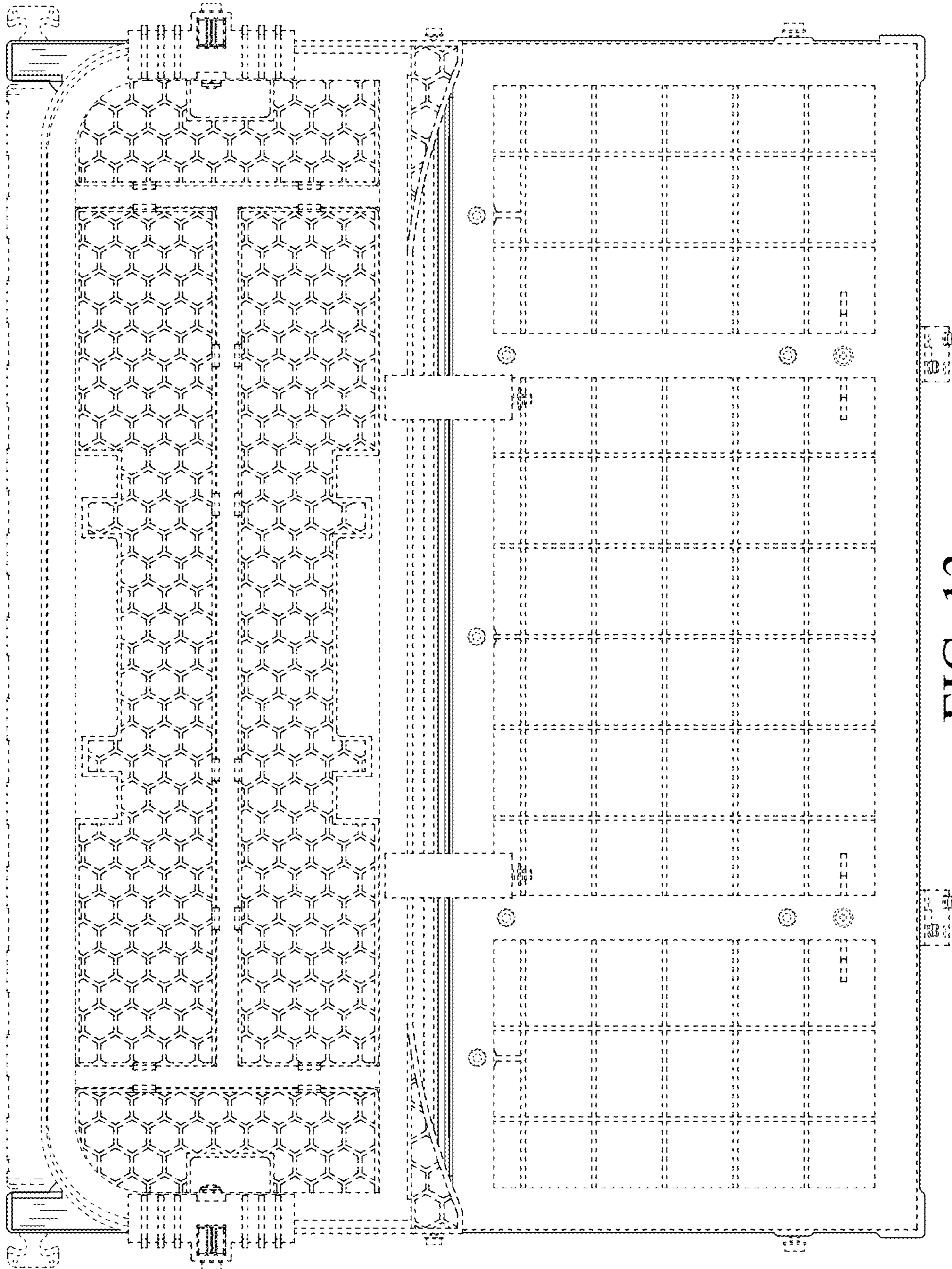

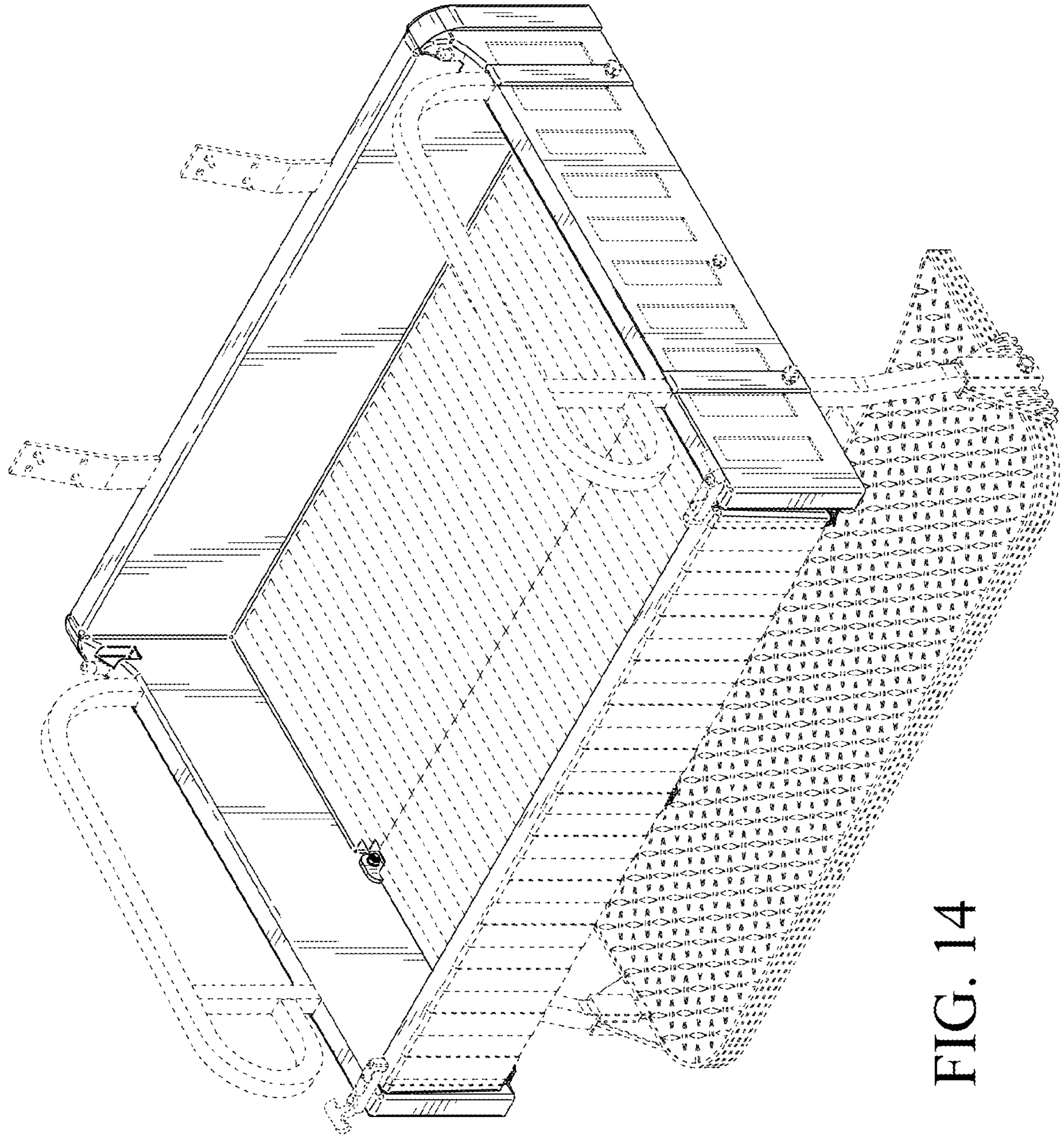
