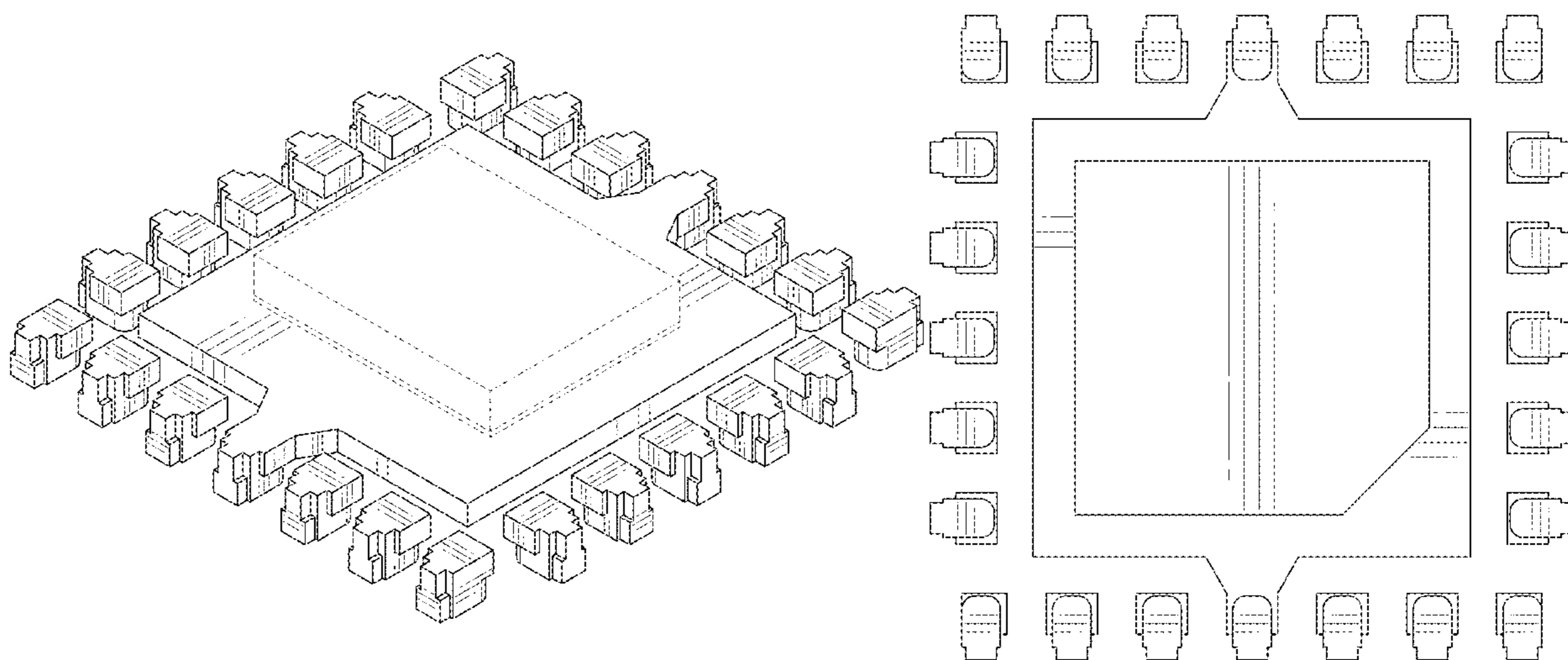
The ornamental design for a leadframe, as shown and described.

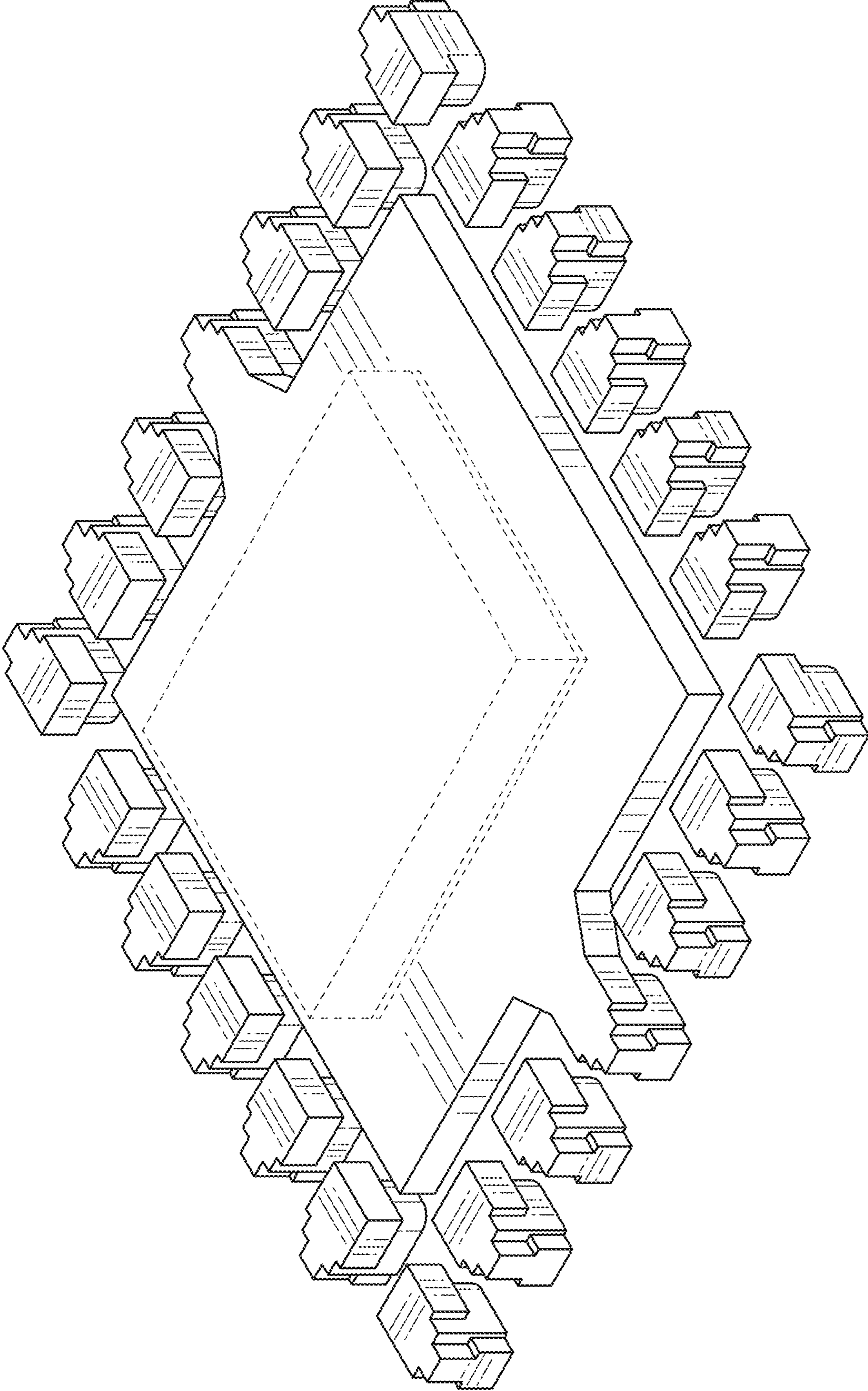

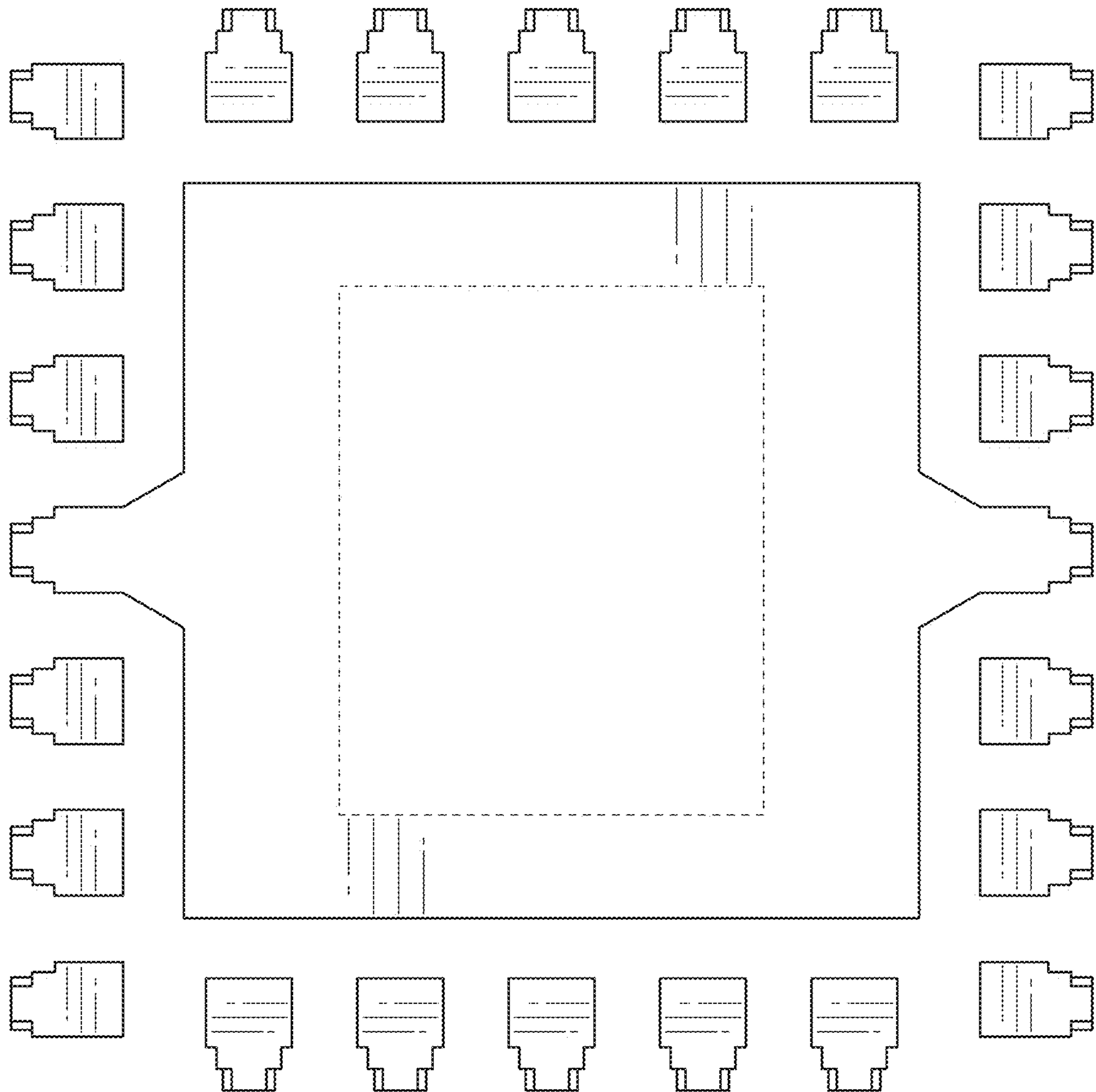

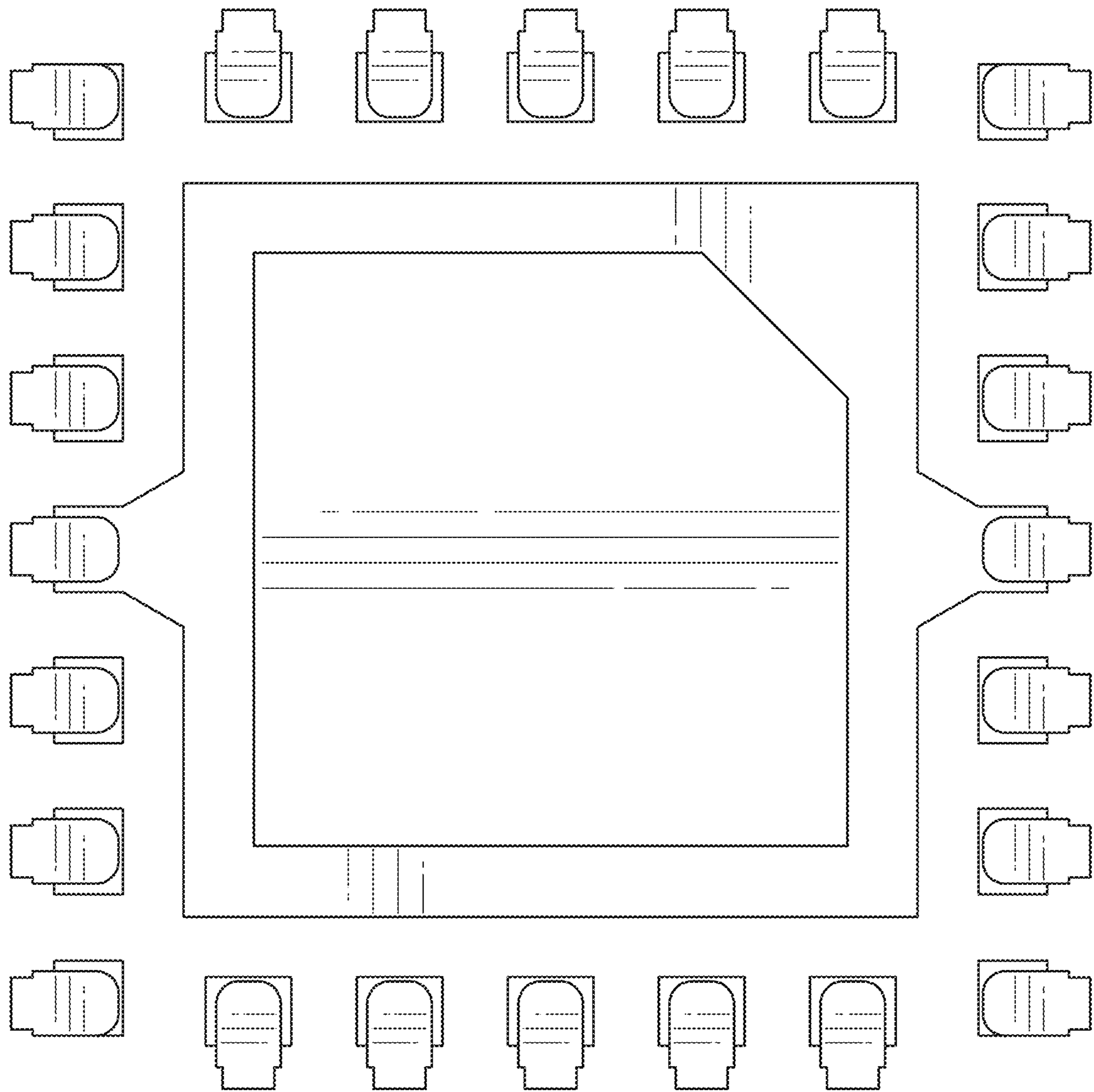

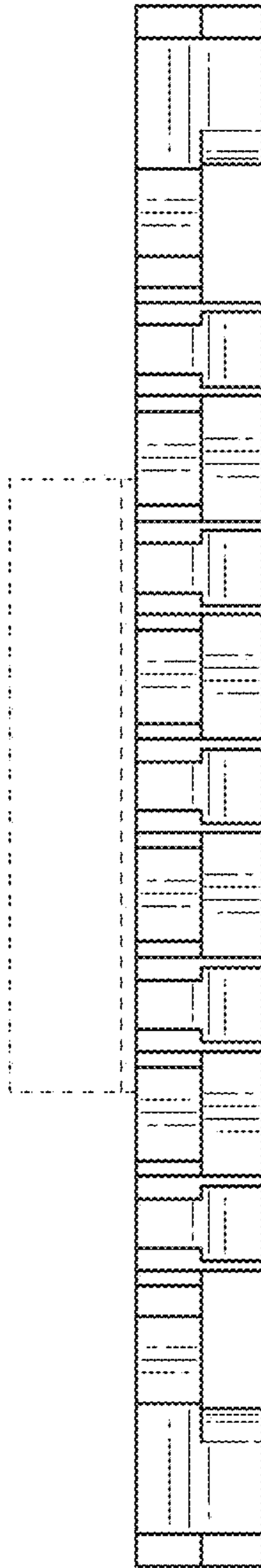

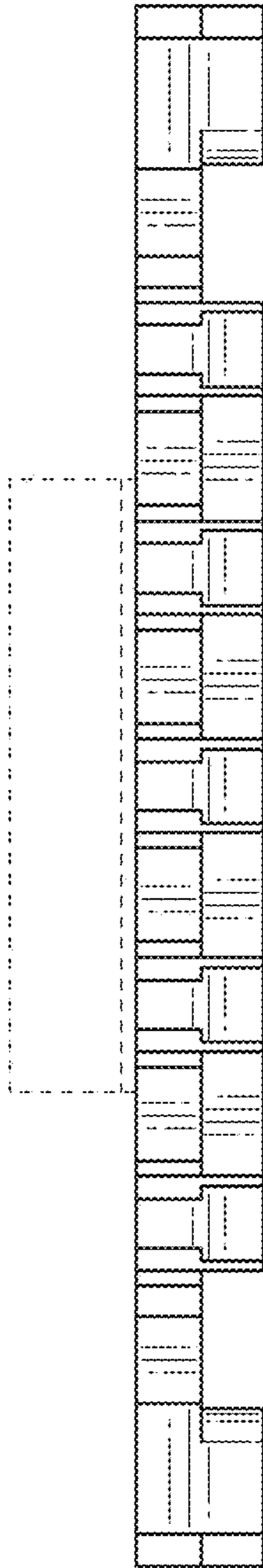

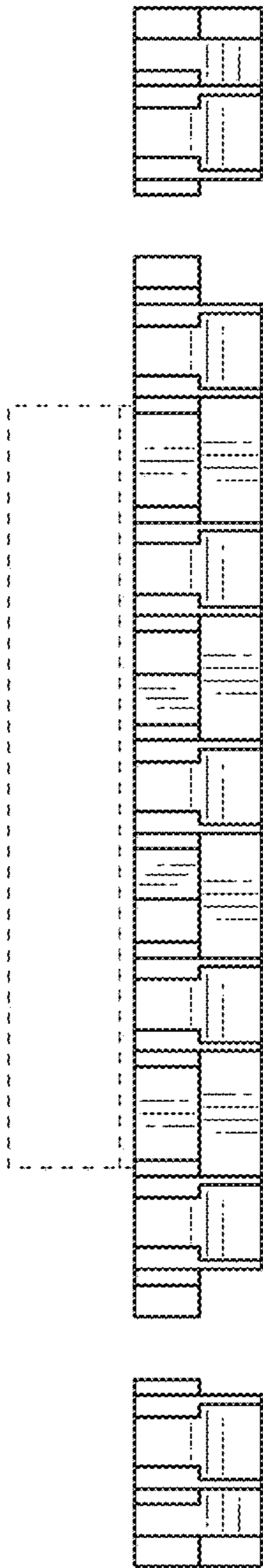

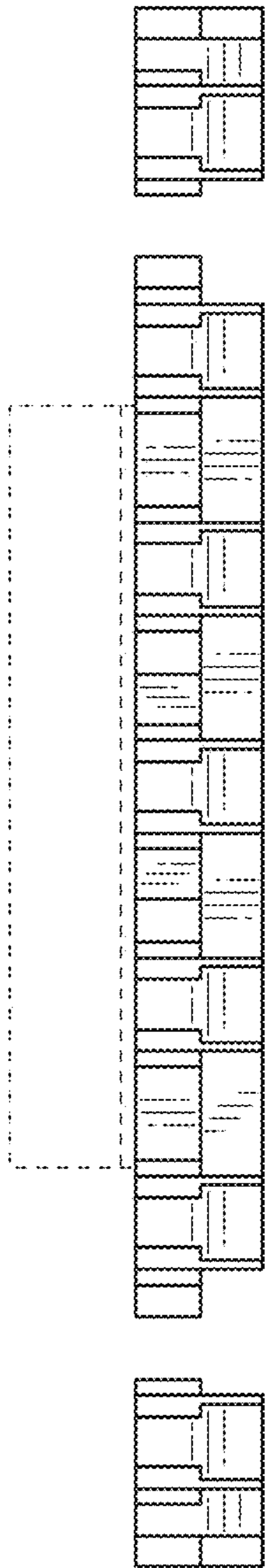
