(57) **CLAIM**

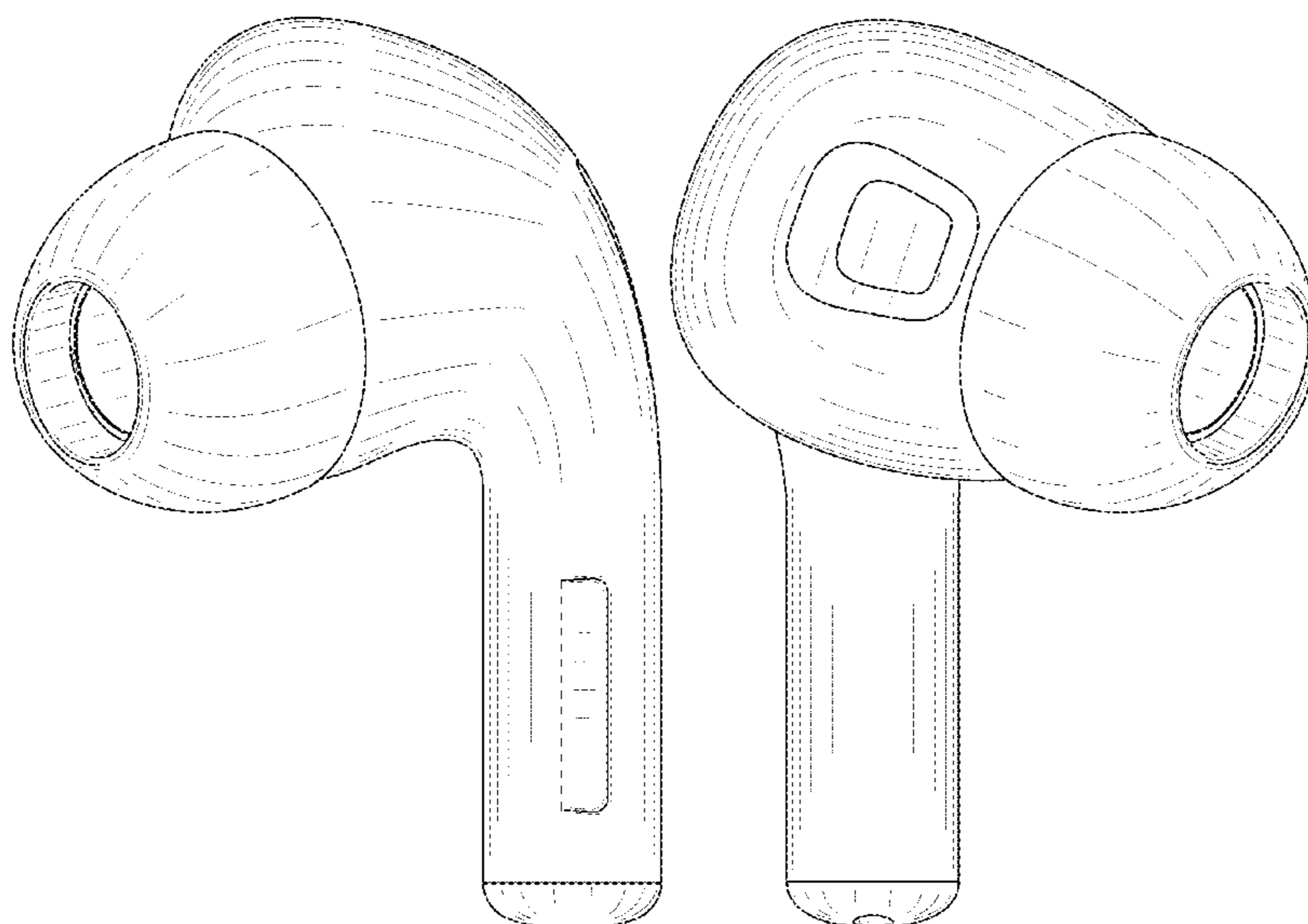
The ornamental design for an pair of earphones, as shown and described.

**DESCRIPTION**

FIG. 1 is a right, bottom perspective view of the left earphone of a pair of earphones in accordance with the design, the right earphone being a mirror image thereof; FIG. 2 is a right side elevation view thereof, the right earphone being a mirror image thereof; FIG. 3 is a rear elevation view thereof, the right earphone being a mirror image thereof; FIG. 4 is a left side elevation view thereof, the right earphone being a mirror image thereof; FIG. 5 is a front elevation view thereof, the right earphone being a mirror image thereof; FIG. 6 is a bottom plan view thereof, the right earphone being a mirror image thereof; and, FIG. 7 is a top plan view thereof, the right earphone being a mirror image thereof.

The broken lines shown in FIGS. 1-3 illustrate portions of the pair of earphones that form no part of the claimed design.

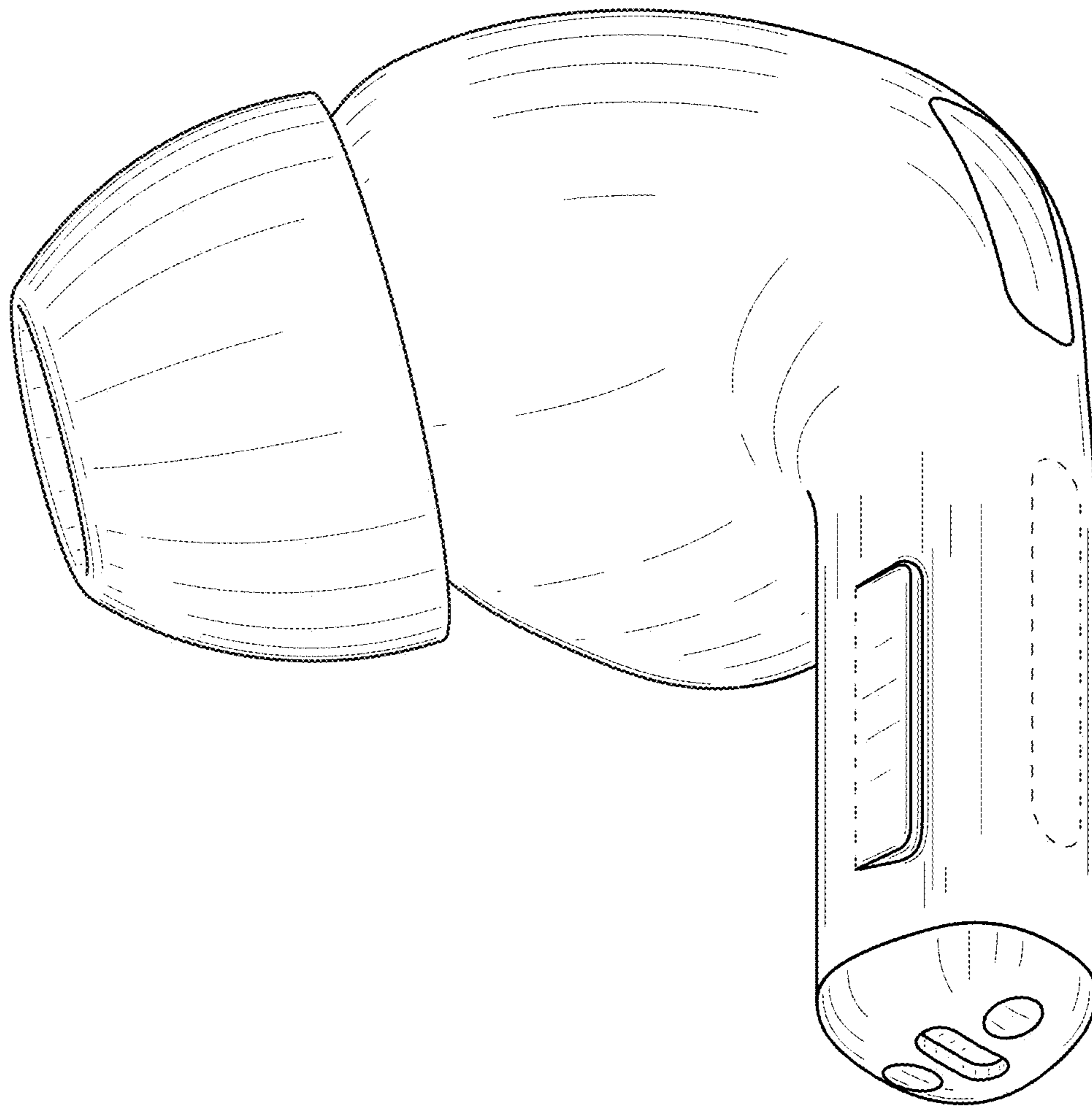

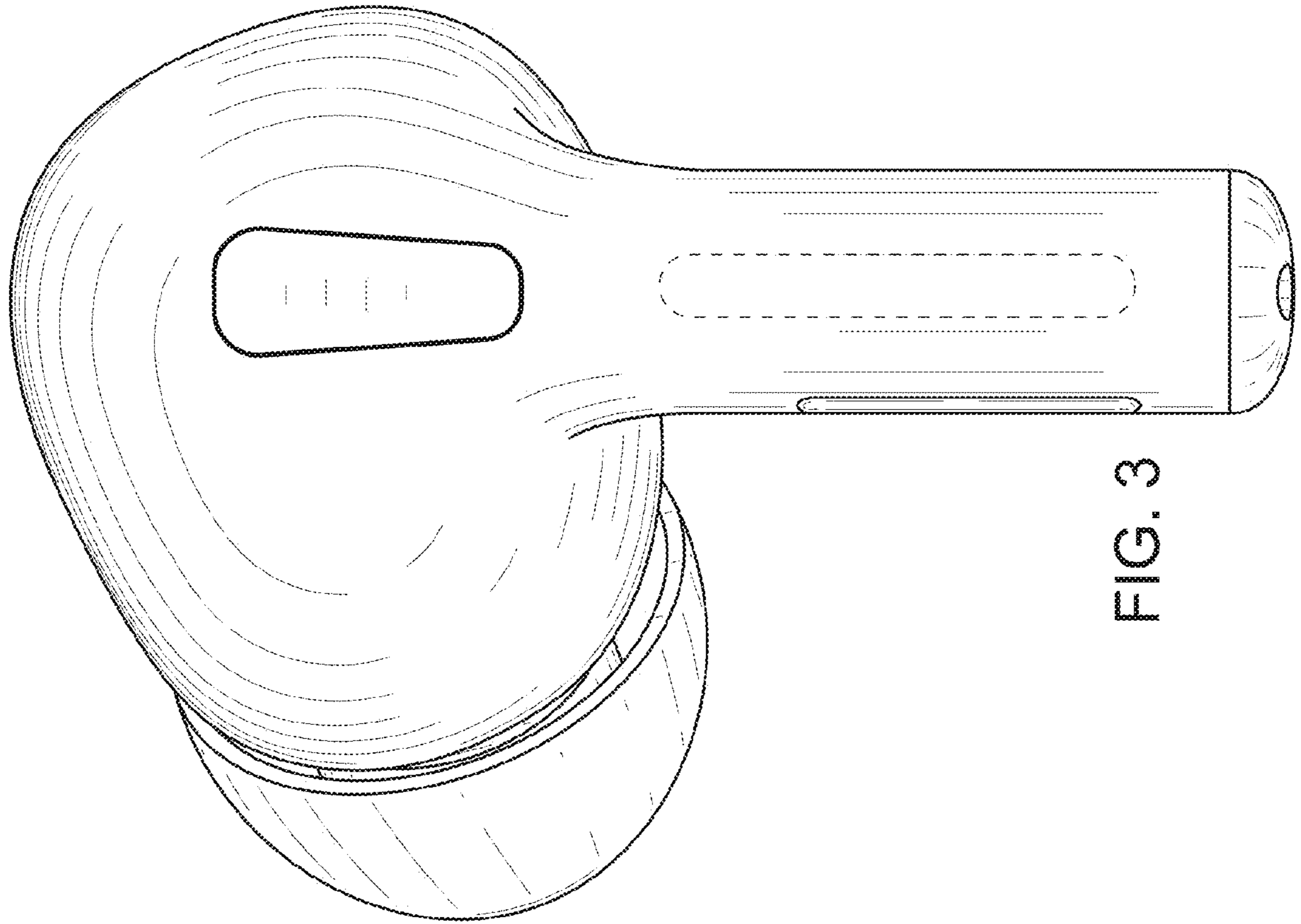

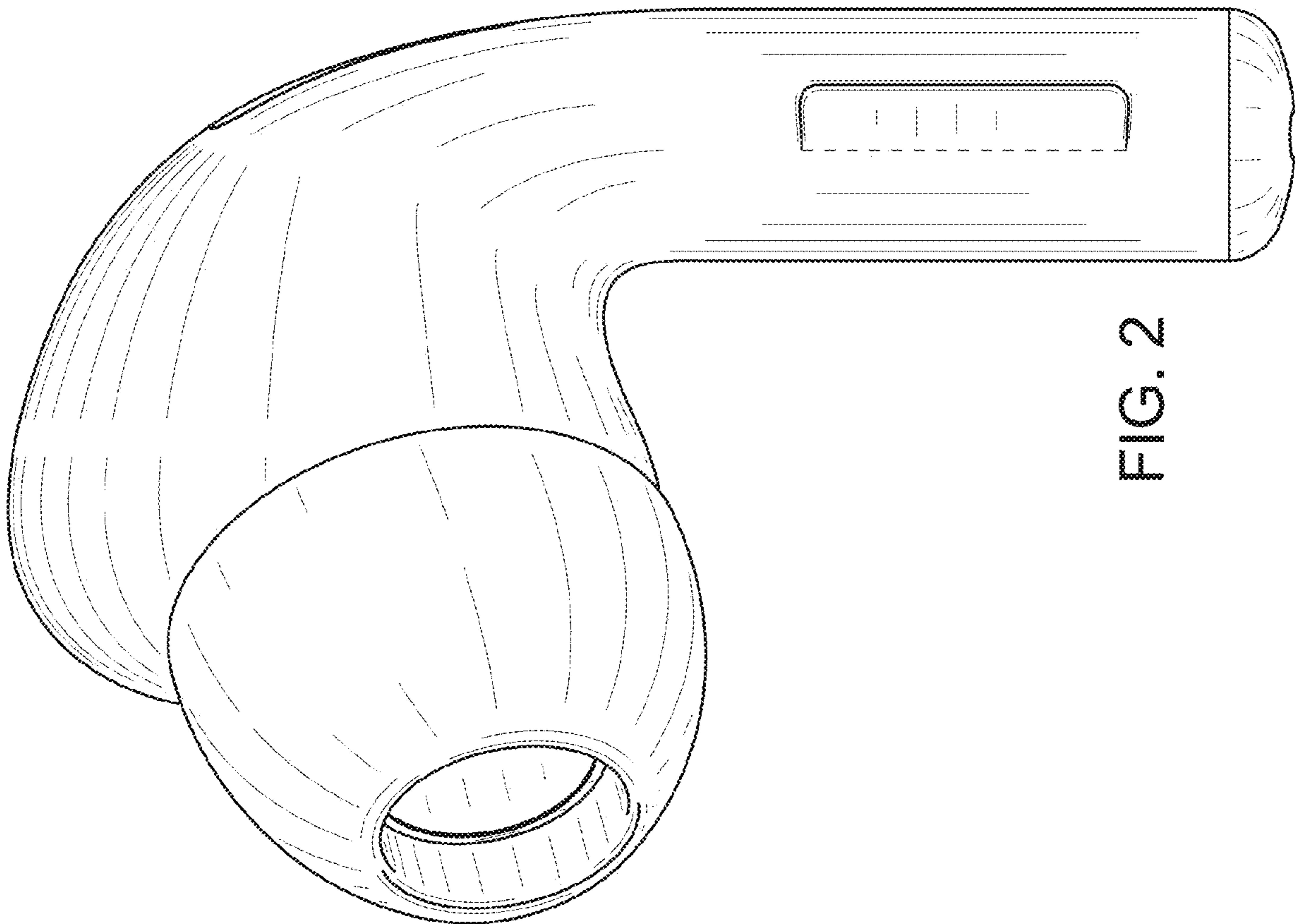

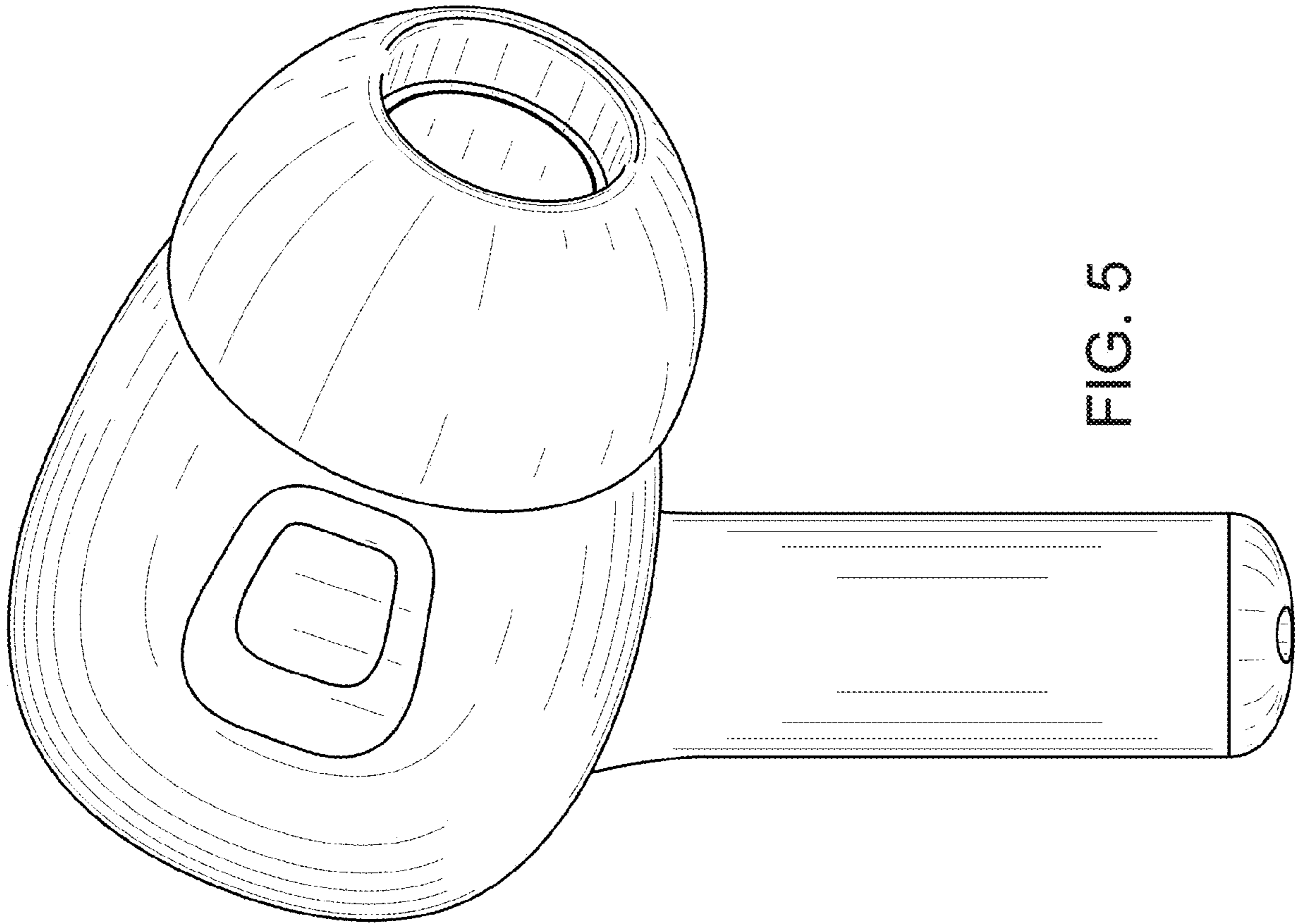

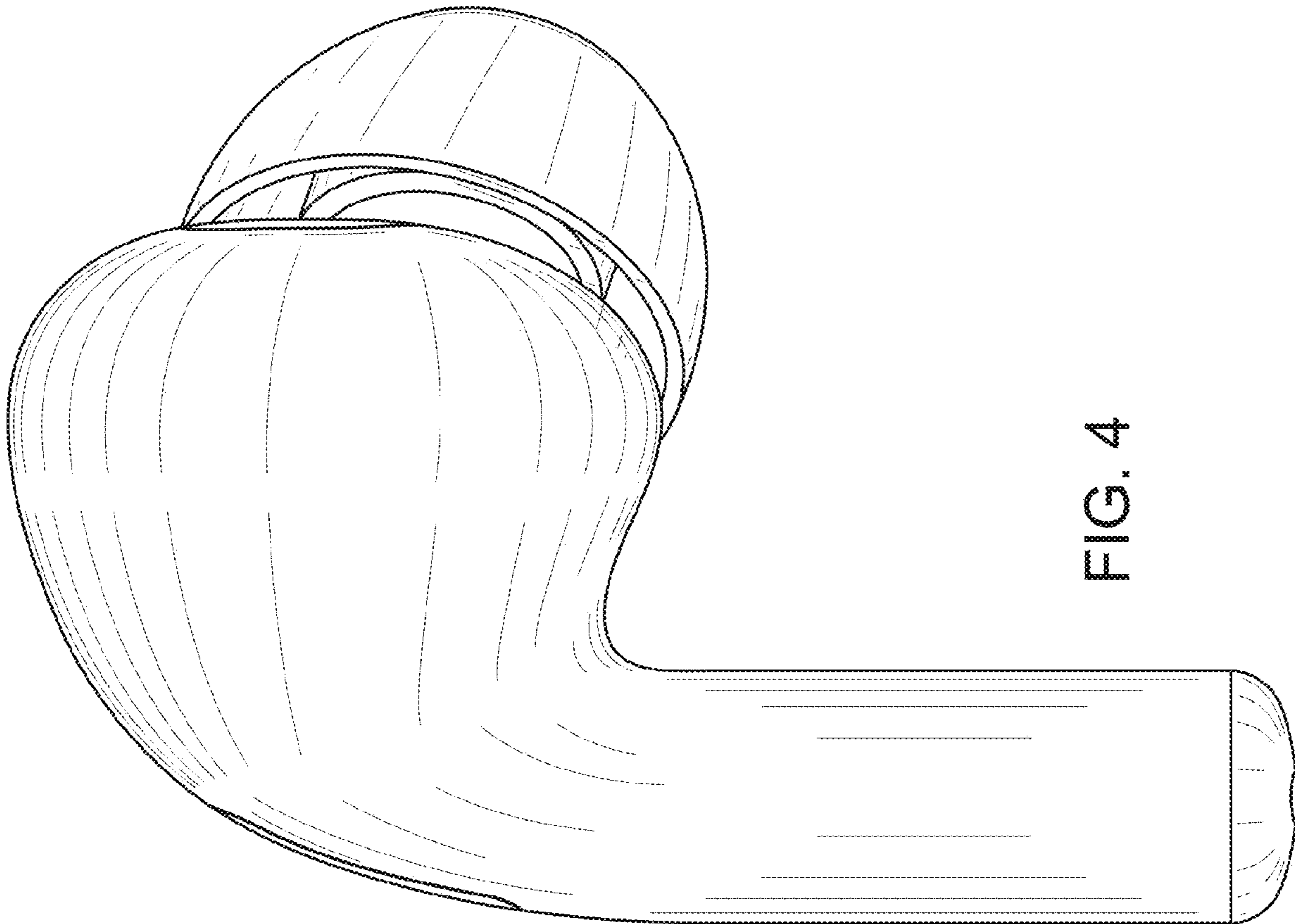

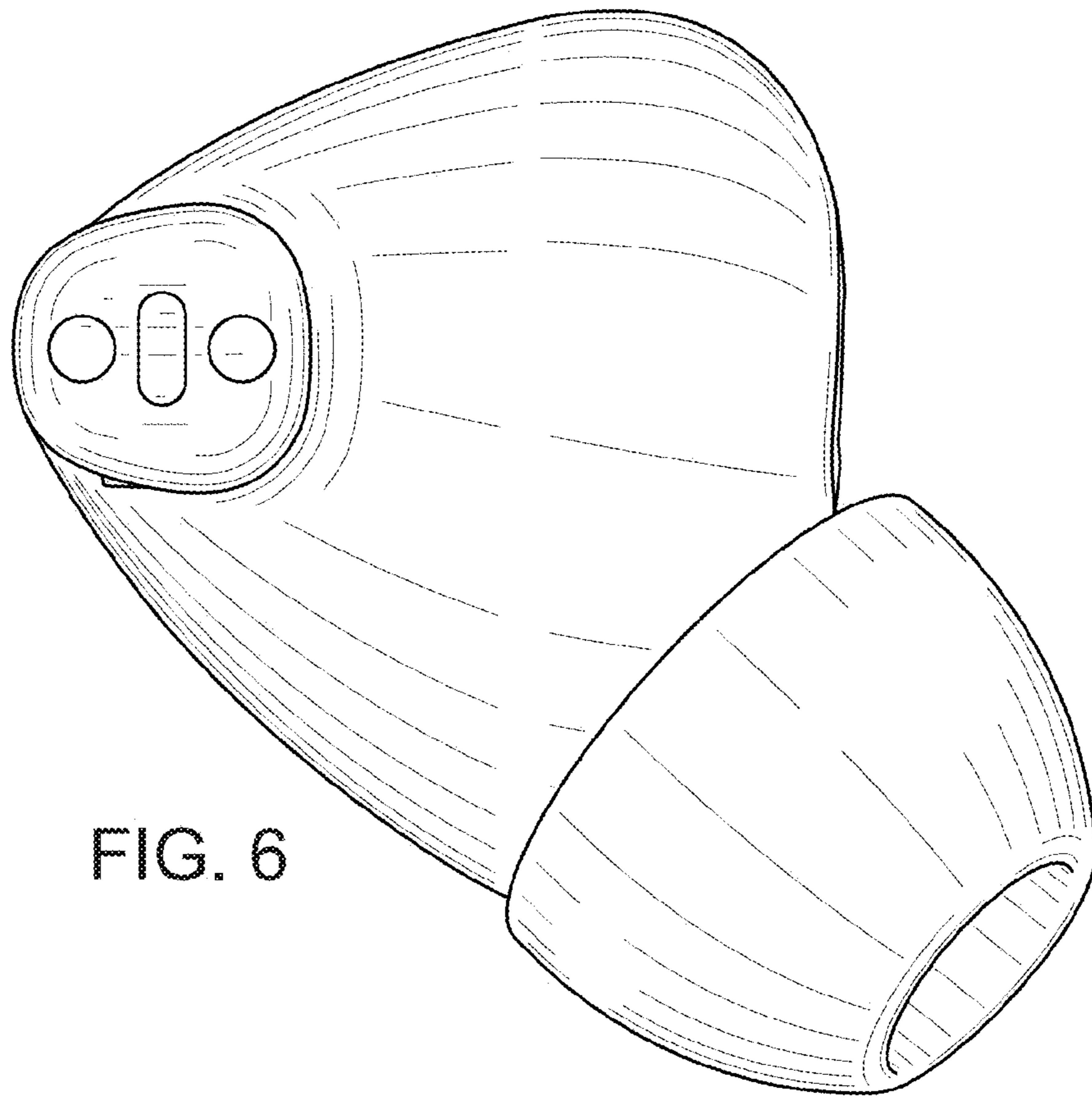

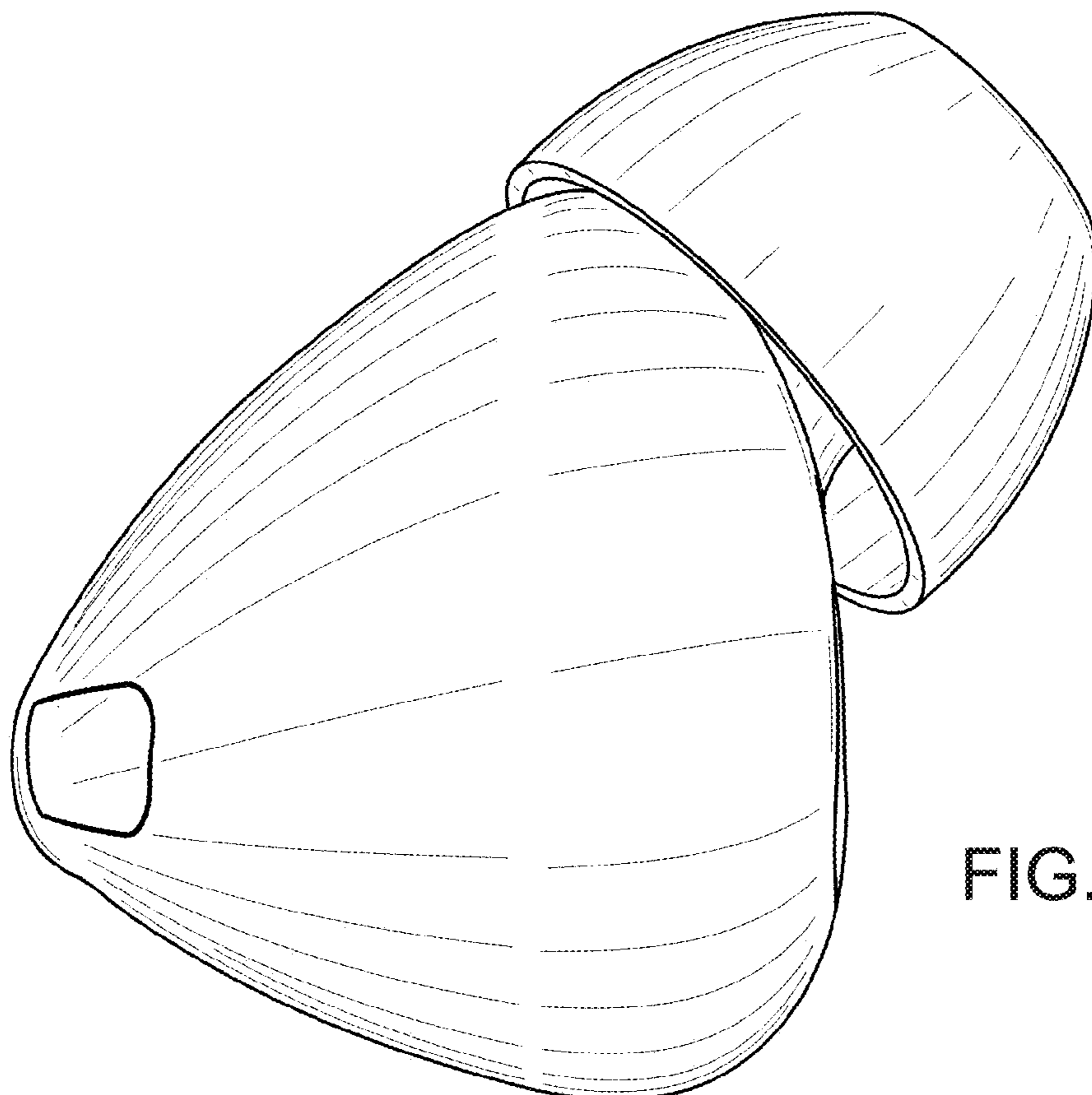
