(57) **CLAIM**

The ornamental design for display screen or portion thereof with transitional graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a display screen or portion thereof with animated graphical user interface showing a first image in a sequence showing our new design;

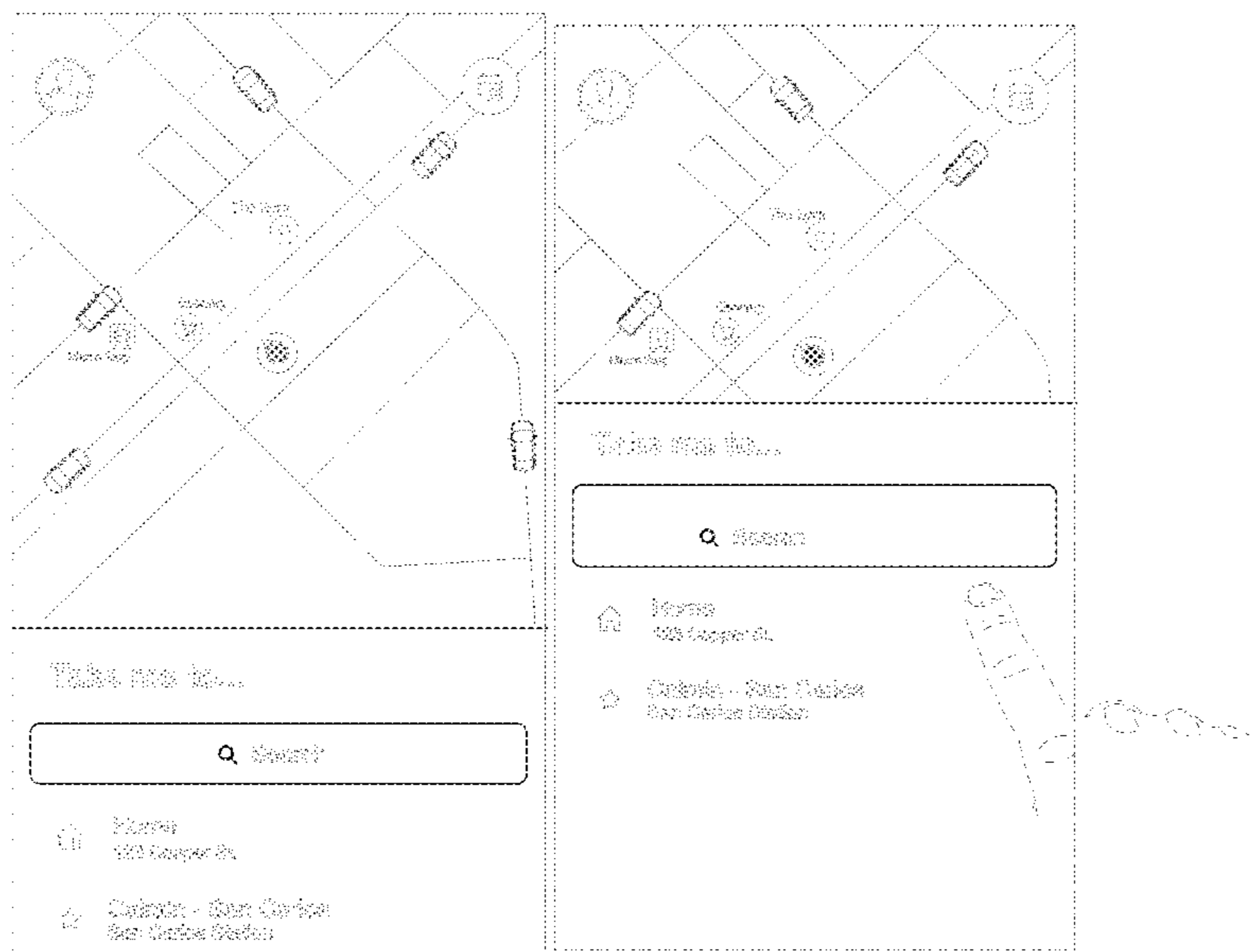
FIG. 2 is a second image thereof;

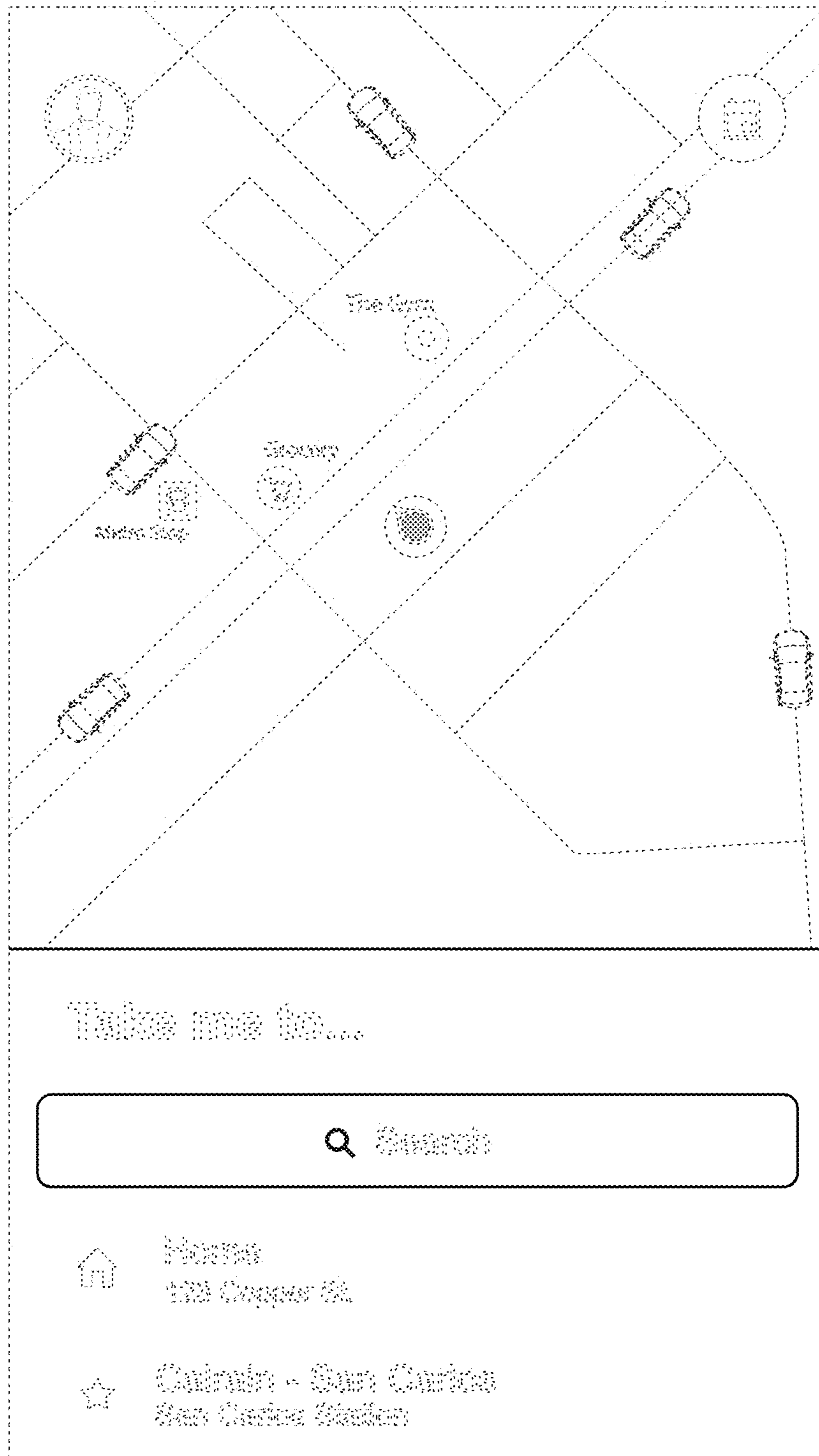
FIG. 3 is a third image thereof; and,

The remaining broken lines show elements of the graphical user interface that form no part of the claimed design. The solid greyscale circular element forms no part of the claimed design. The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-4. The process or period in which one image transitions to another forms no part of the claimed design.

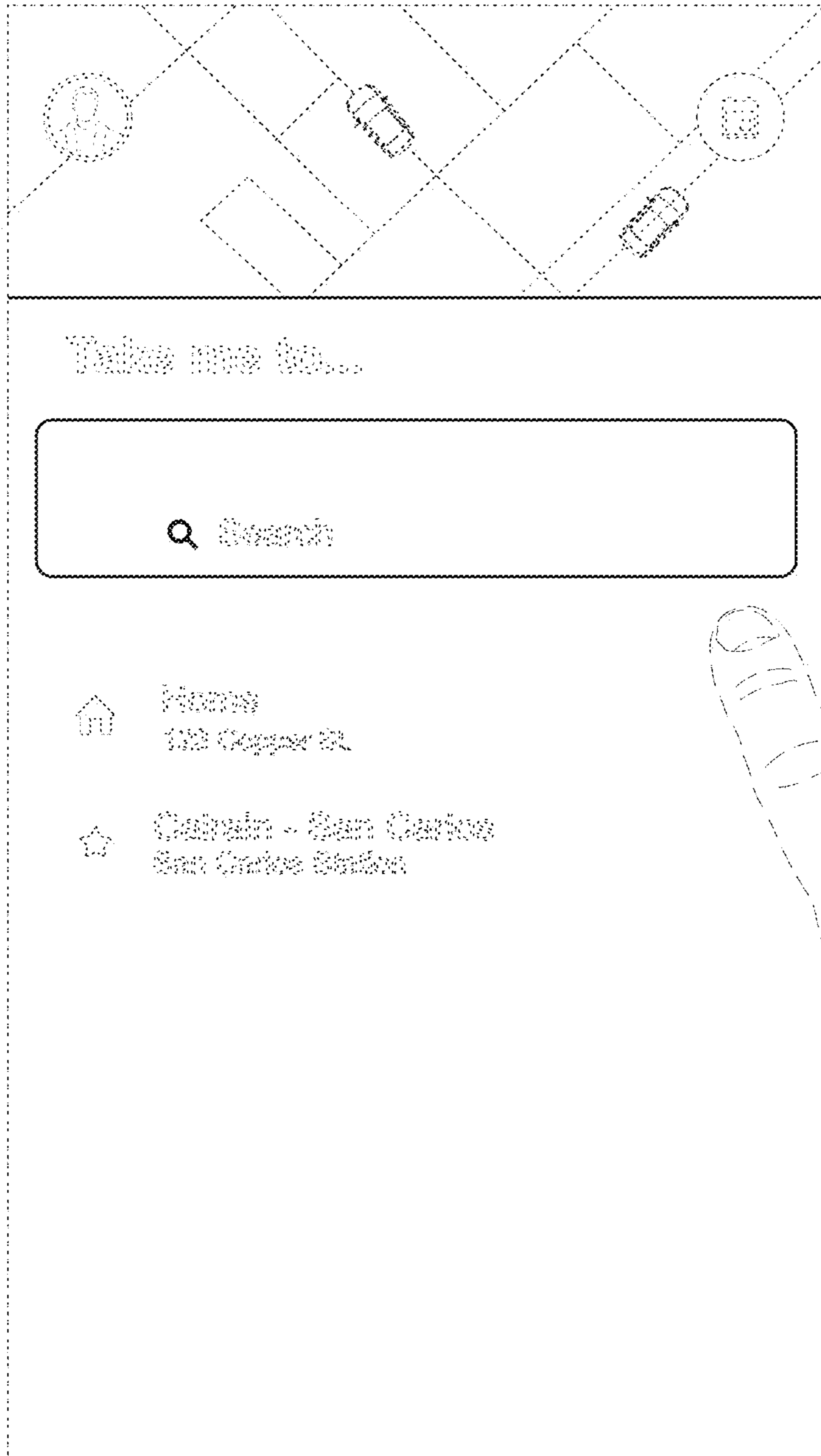




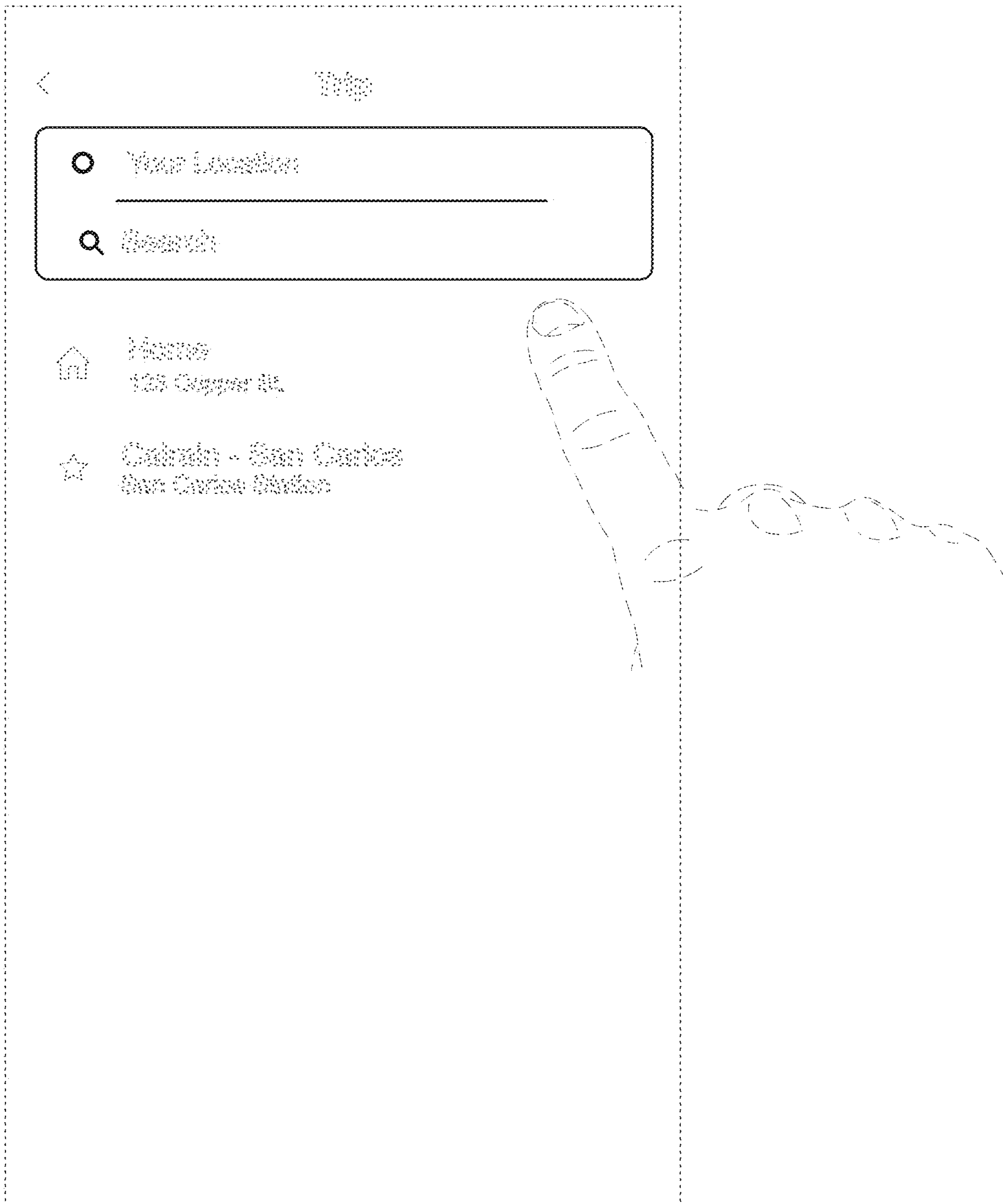
