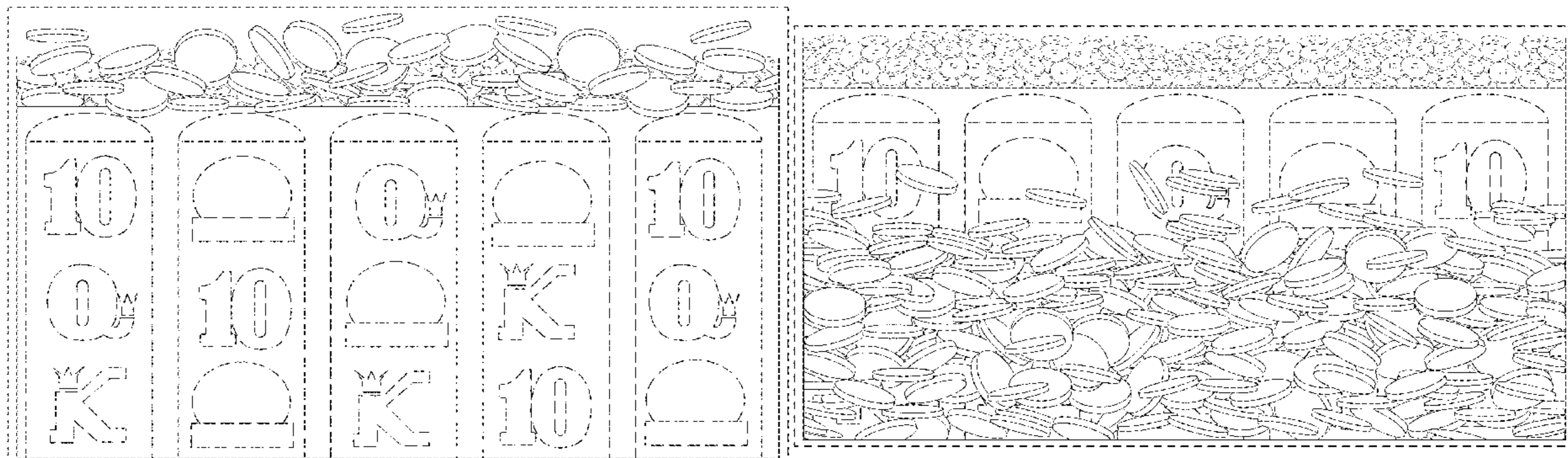
(57) **CLAIM**

We claim the ornamental design for a display screen with an animated graphical interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the first image in a sequence for a display screen with an animated graphical interface; FIG. 2 is a front view of the second image of a display screen with an animated graphical interface shown in FIG. 1; FIG. 3 is a front view of the third image of a display screen with an animated graphical interface shown in FIG. 1; FIG. 4 is a front view of the fourth image of a display screen with an animated graphical interface shown in FIG. 1; FIG. 5 is a front view of the fifth image of a display screen with an animated graphical interface shown in FIG. 1; and, FIG. 6 is a front view of the sixth image of a display screen with an animated graphical interface shown in FIG. 1. The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1 through 6. The process or period in which one image transitions to another image forms no part of the claimed design. The outermost broken lines in each figure illustrate a portion of the display screen. The remaining broken lines illustrate portions of the graphical user interface. None of the broken lines form part of the claimed design.

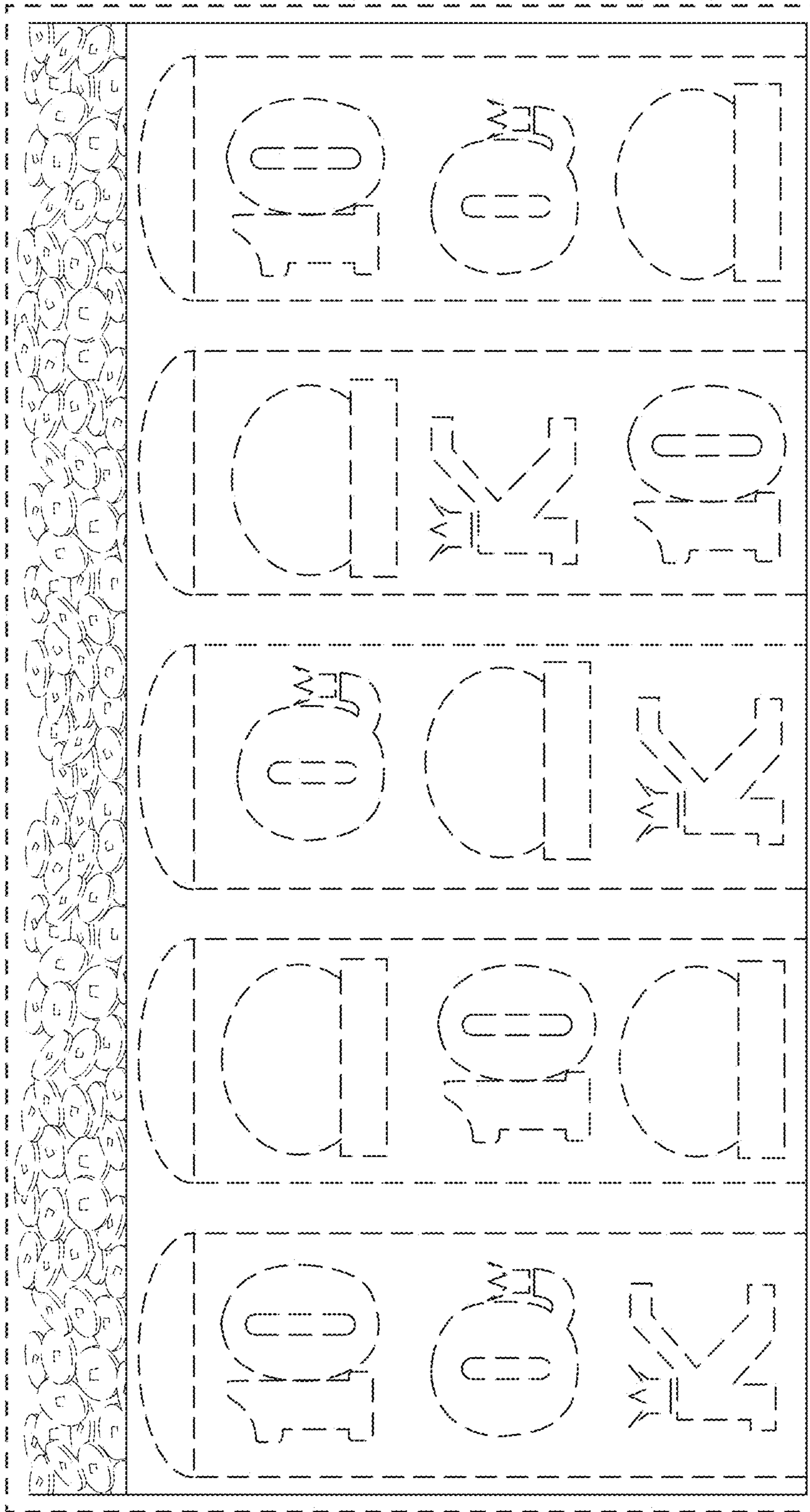

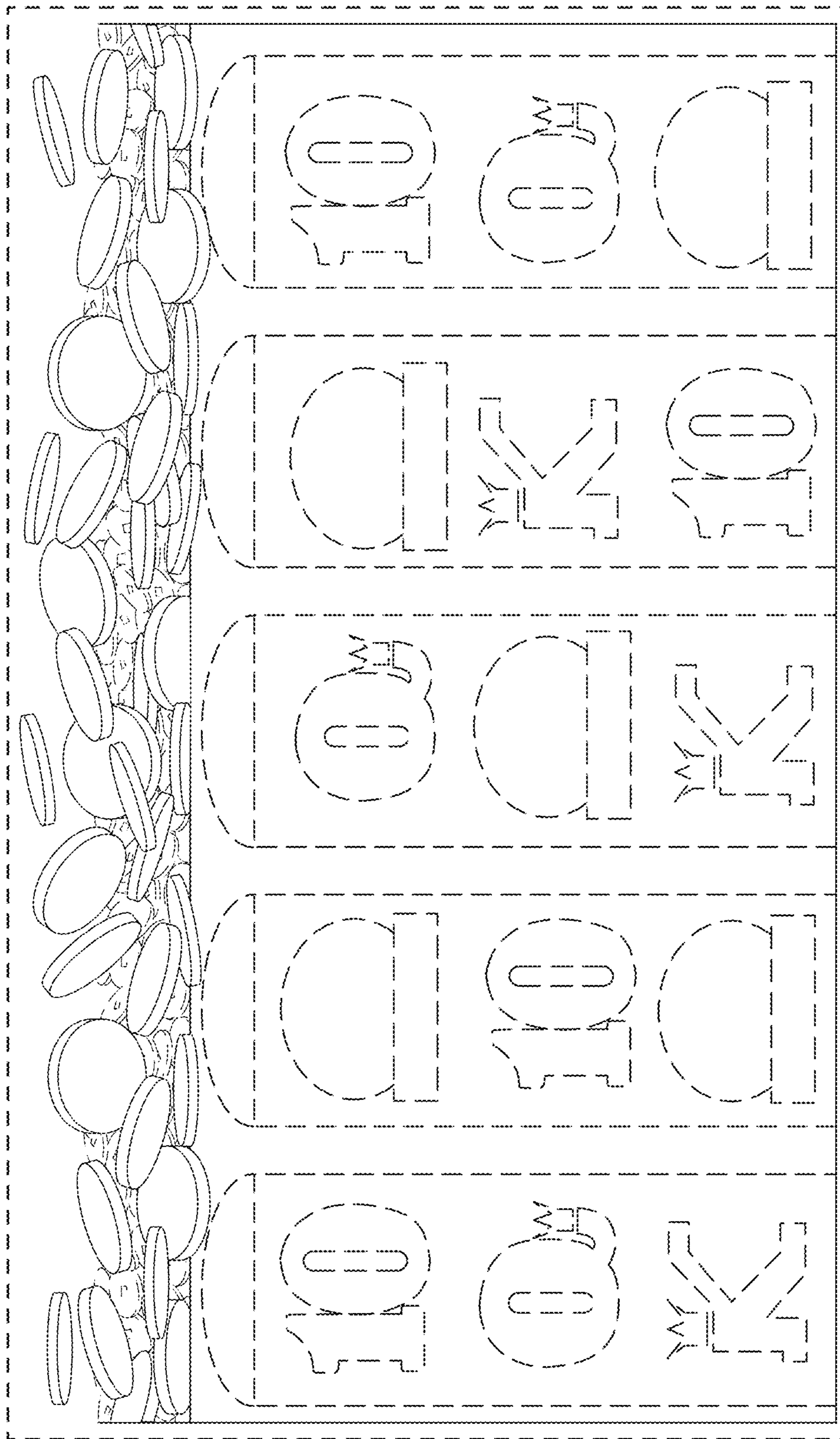

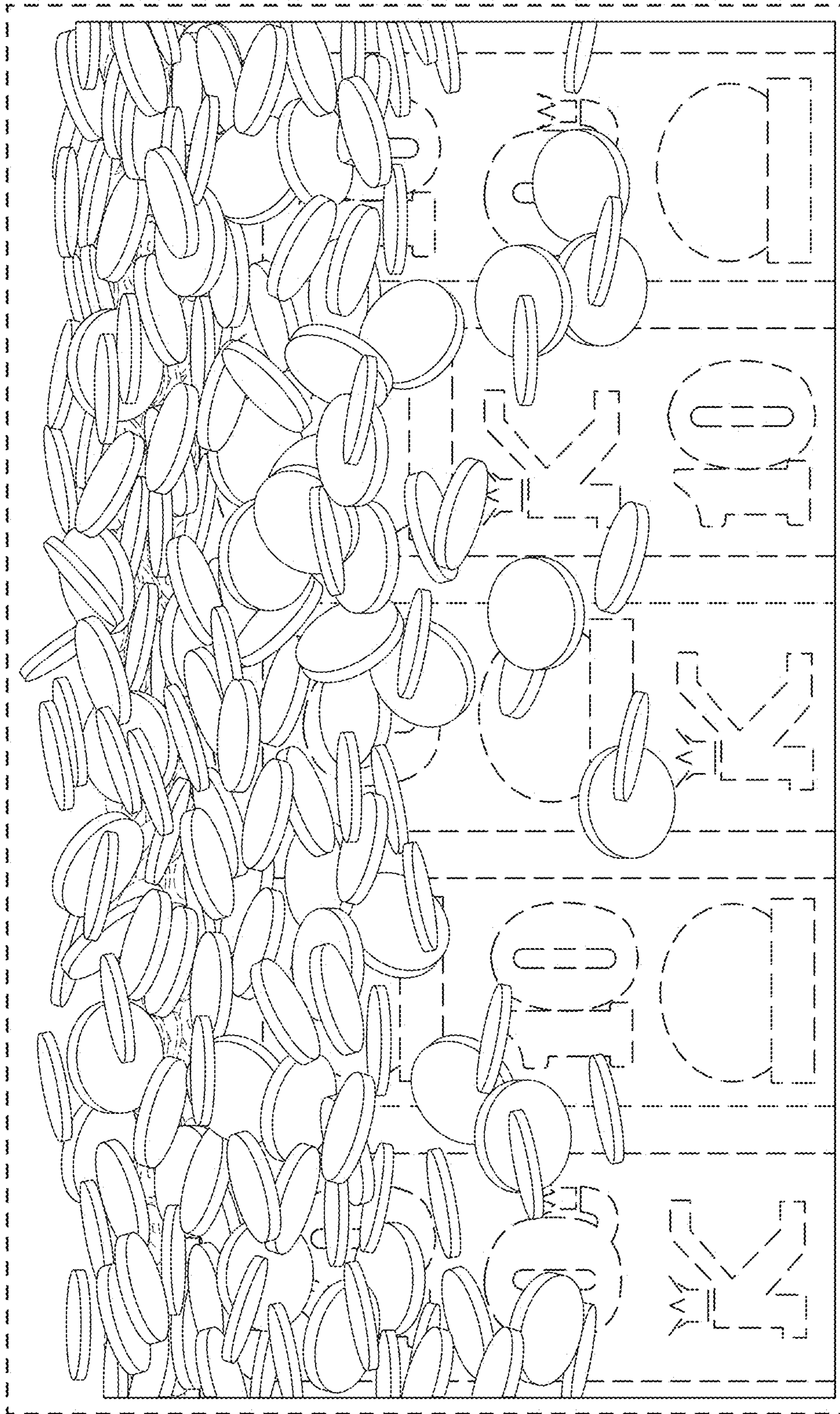

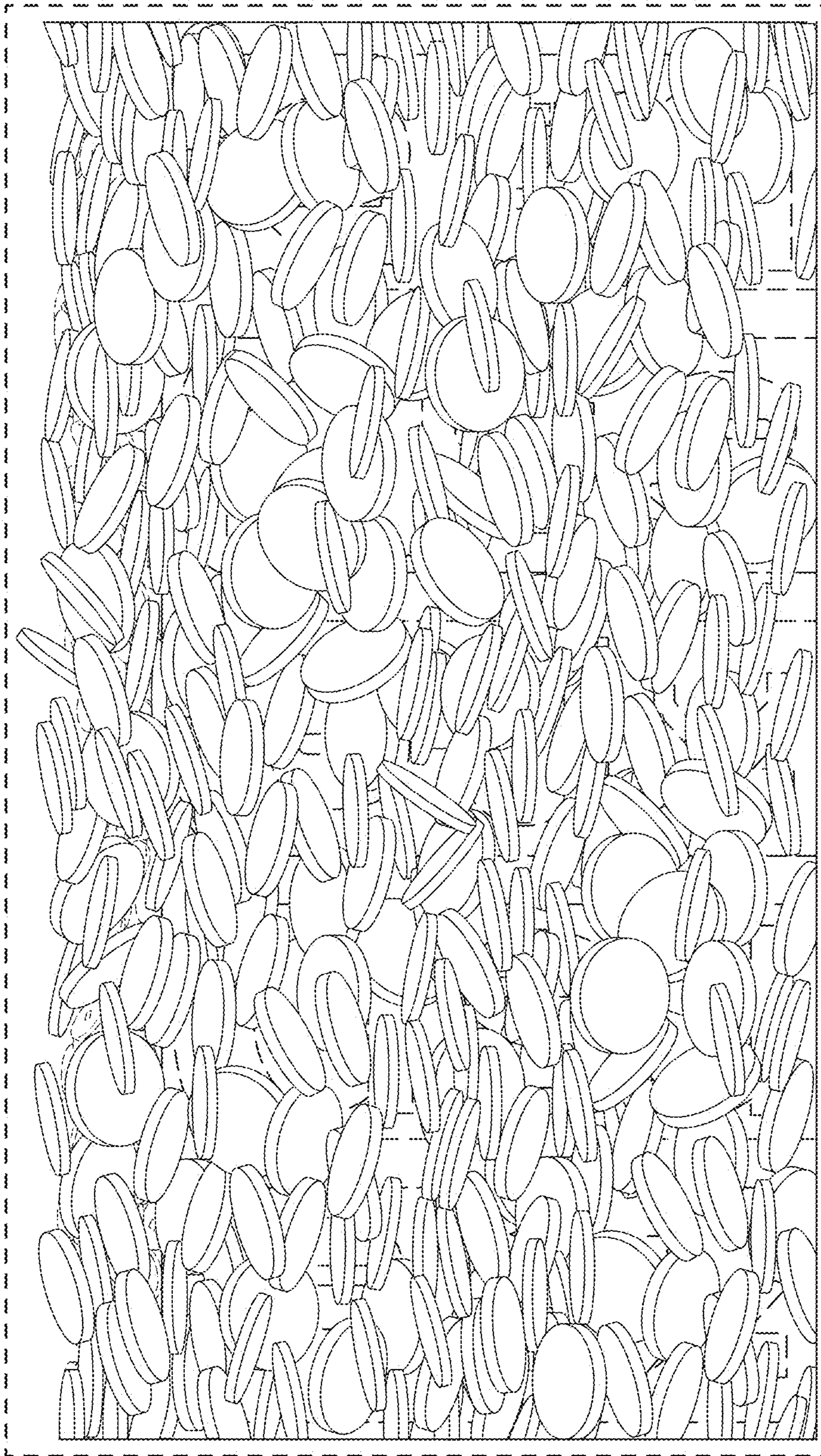

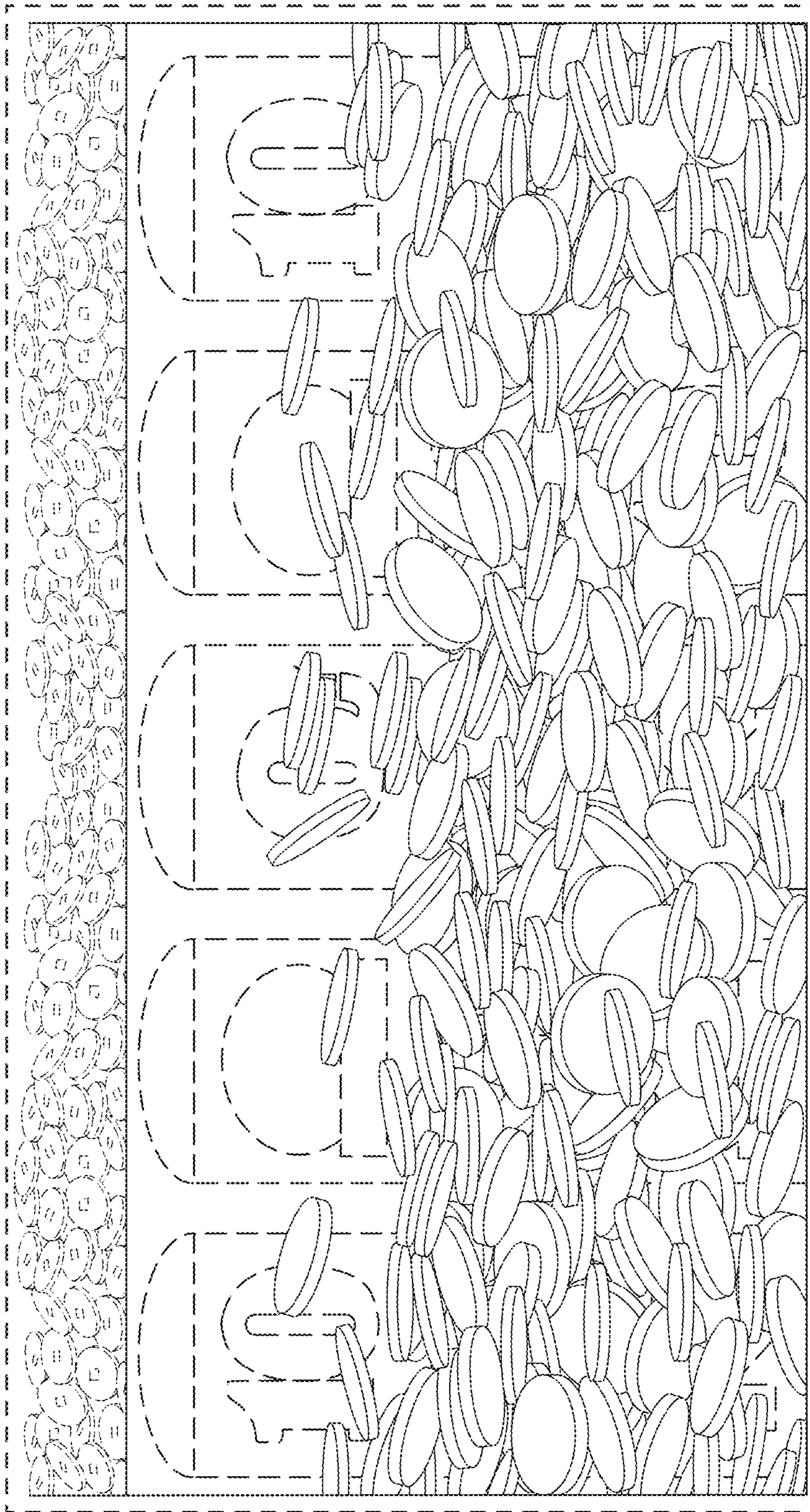

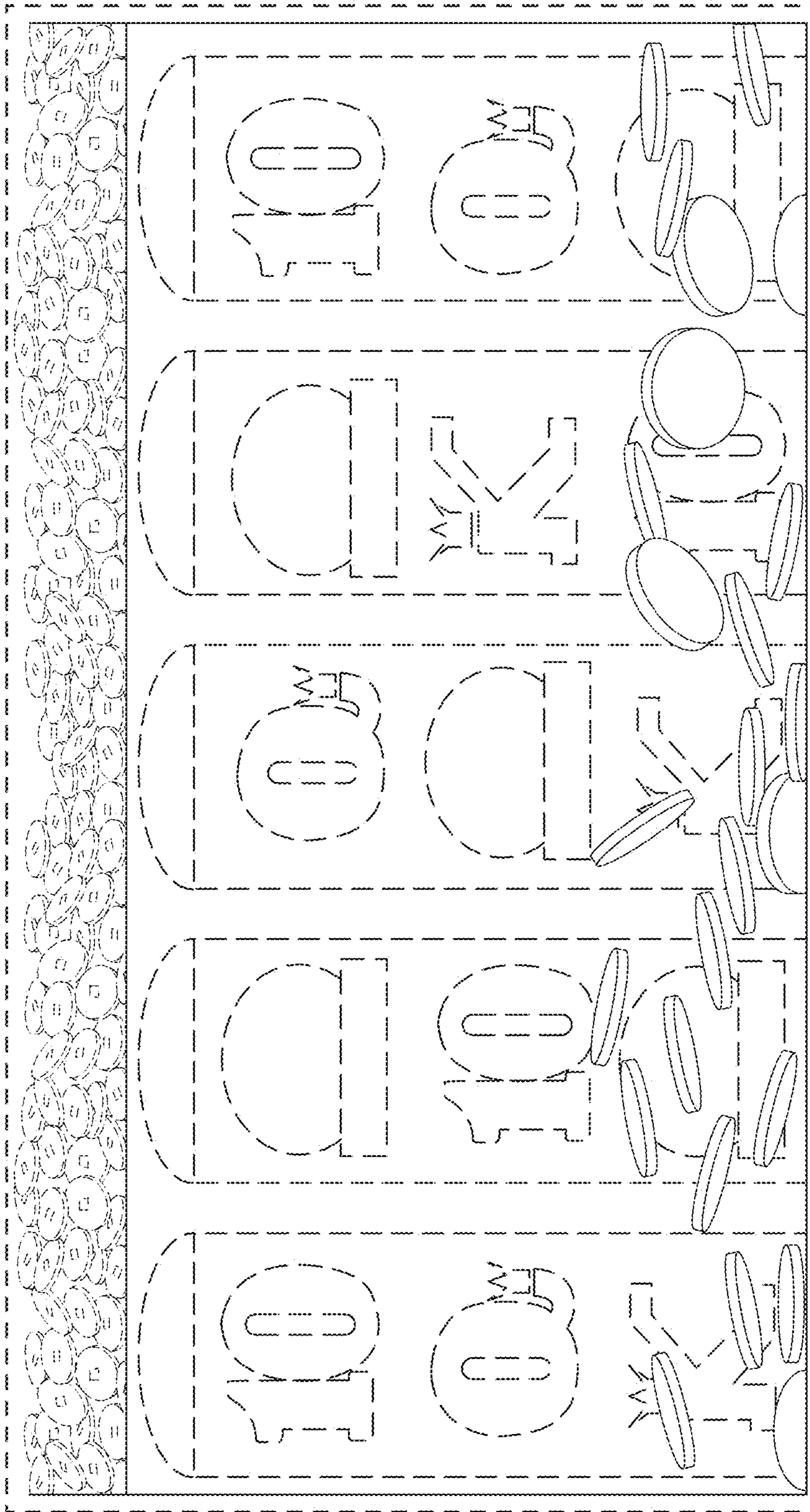
