The broken lines in the figures depict a display screen or portion thereof and form no part of the claimed design.

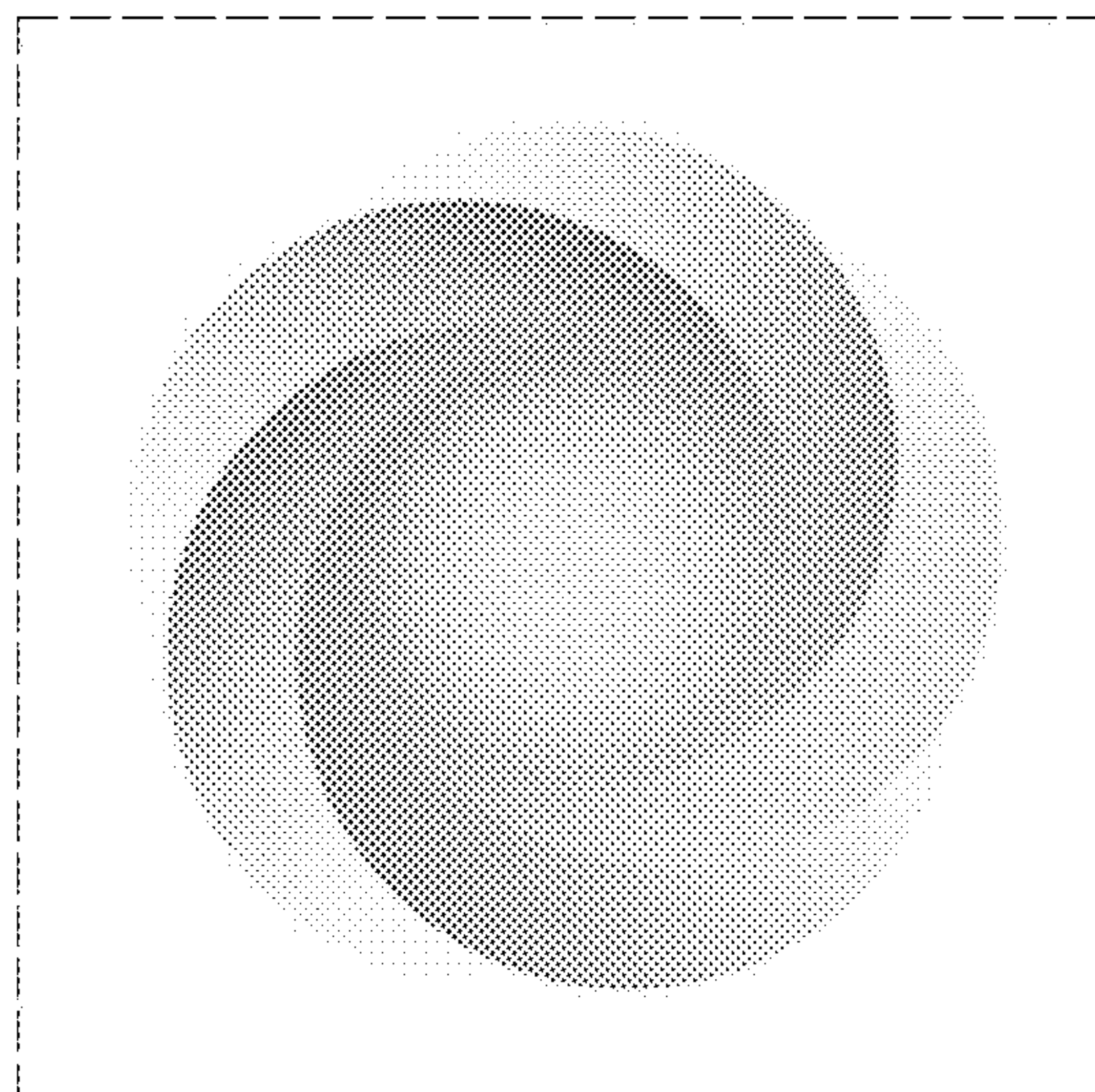

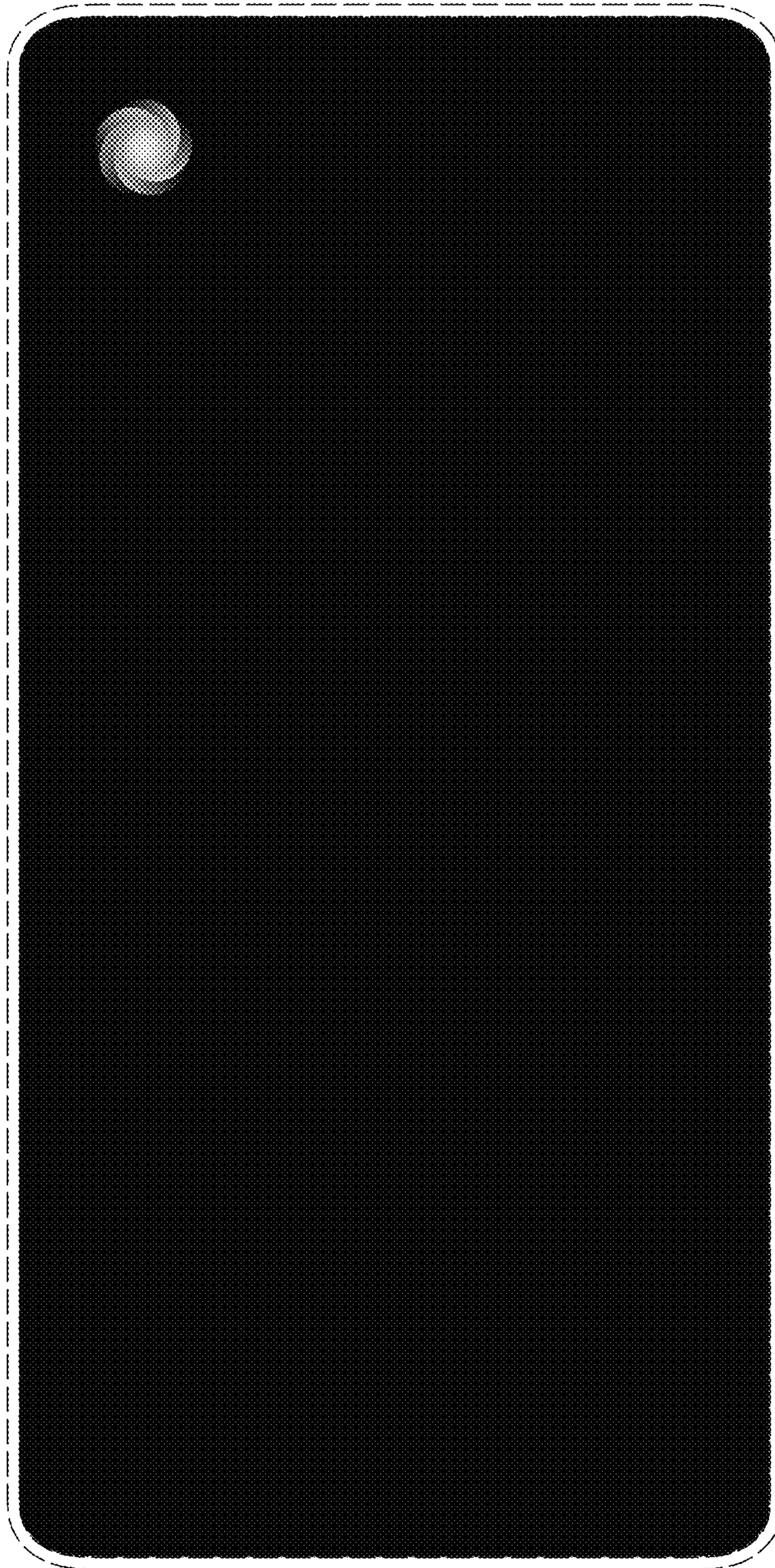

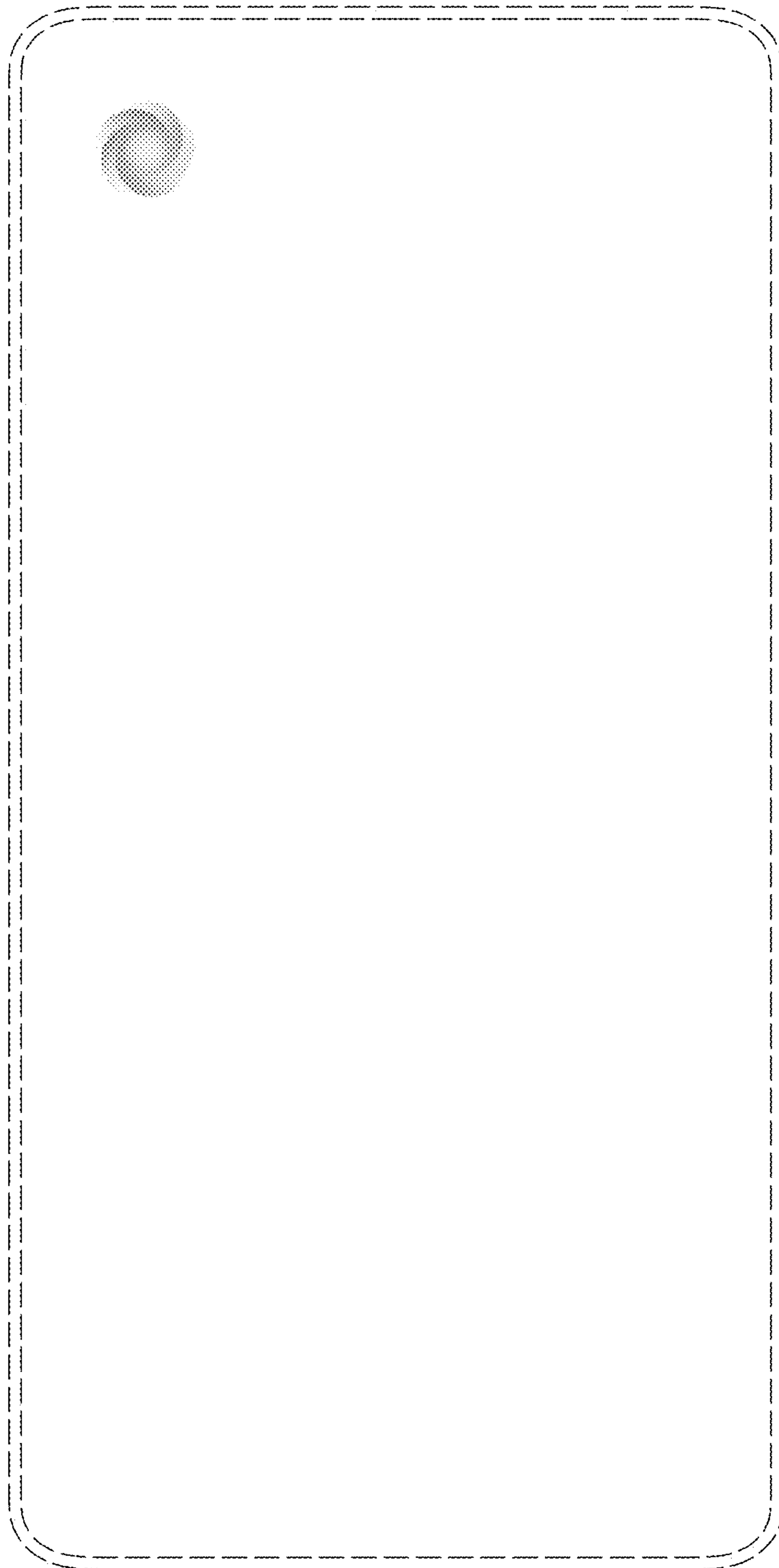

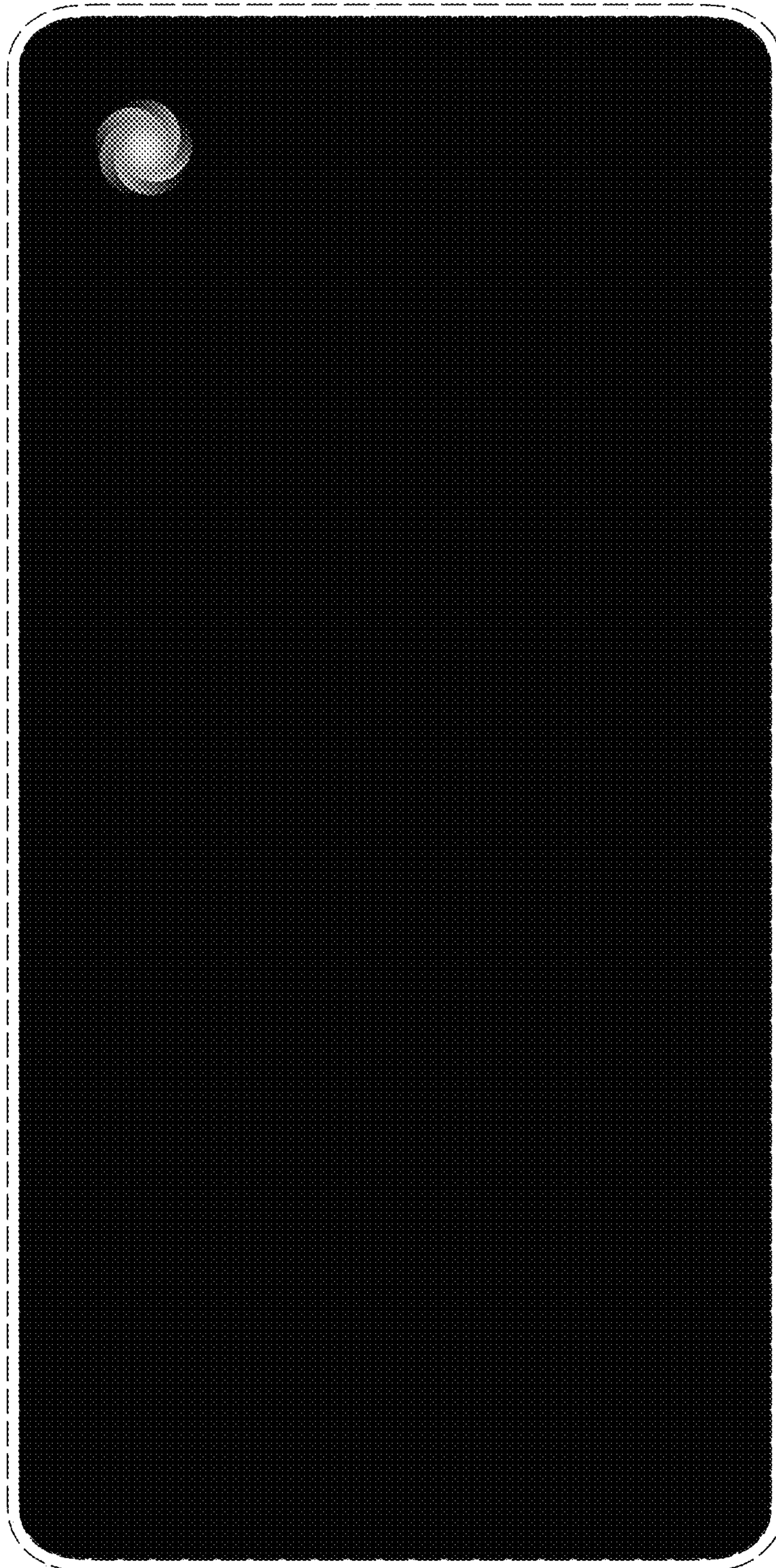

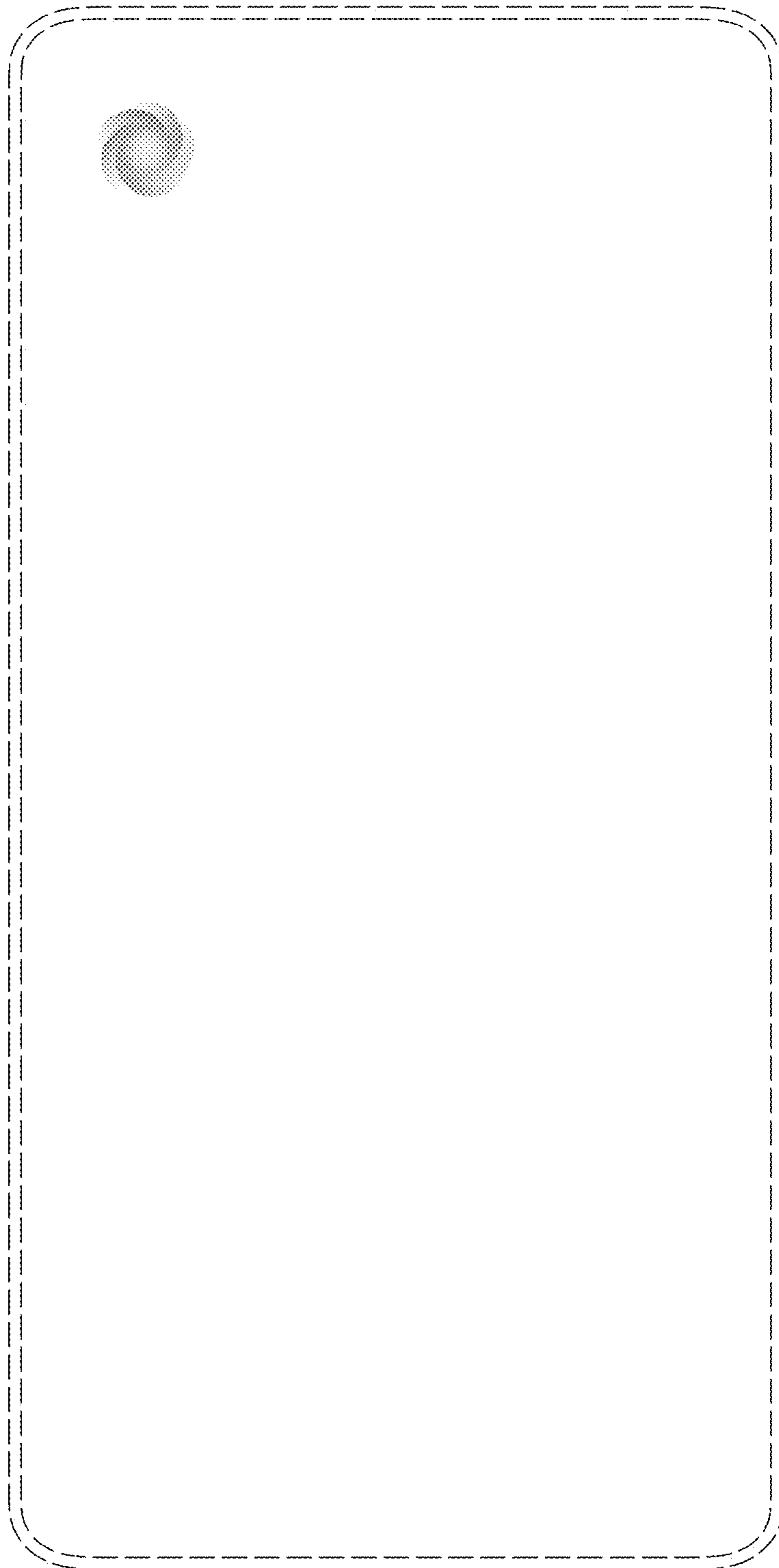

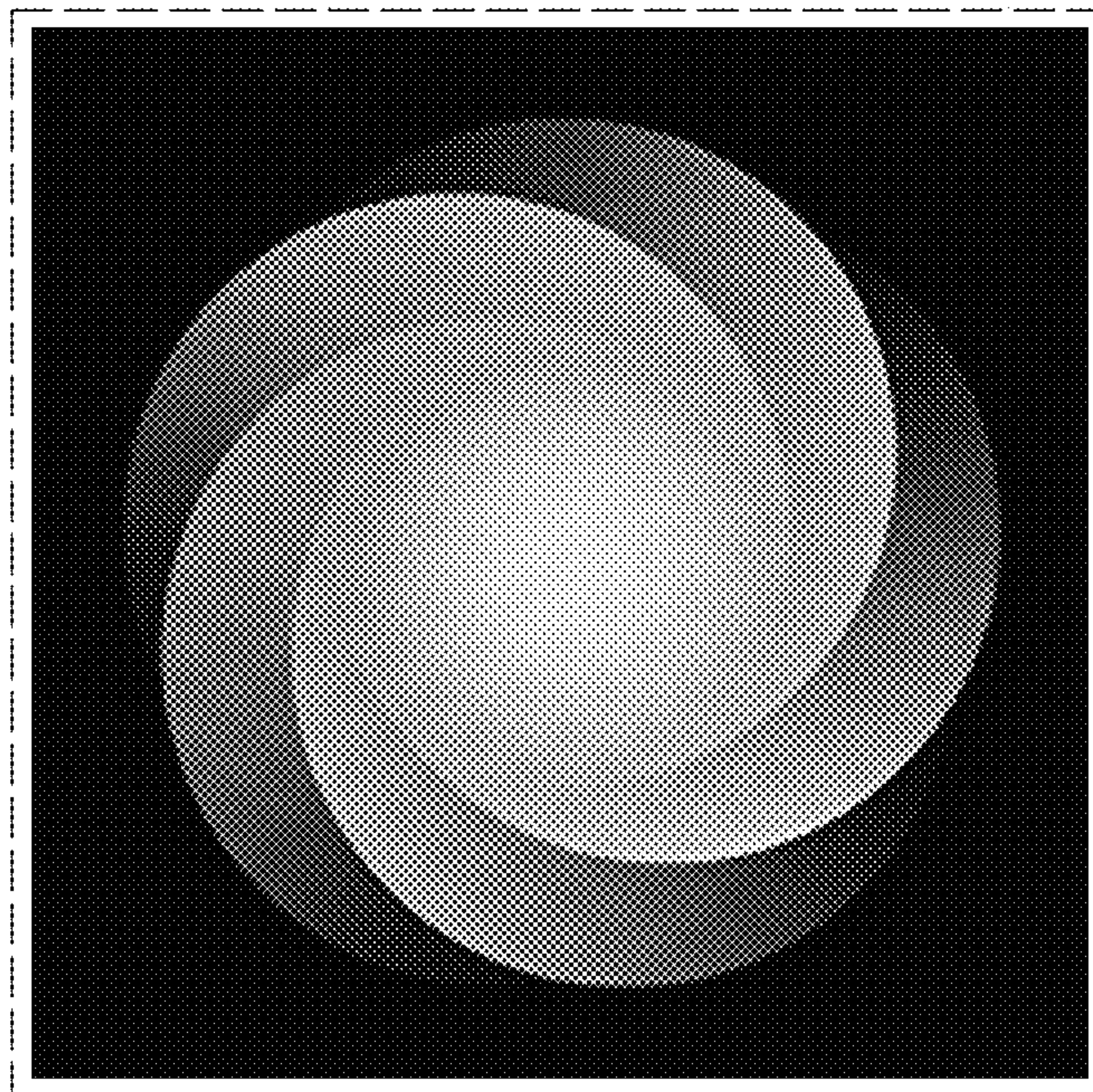

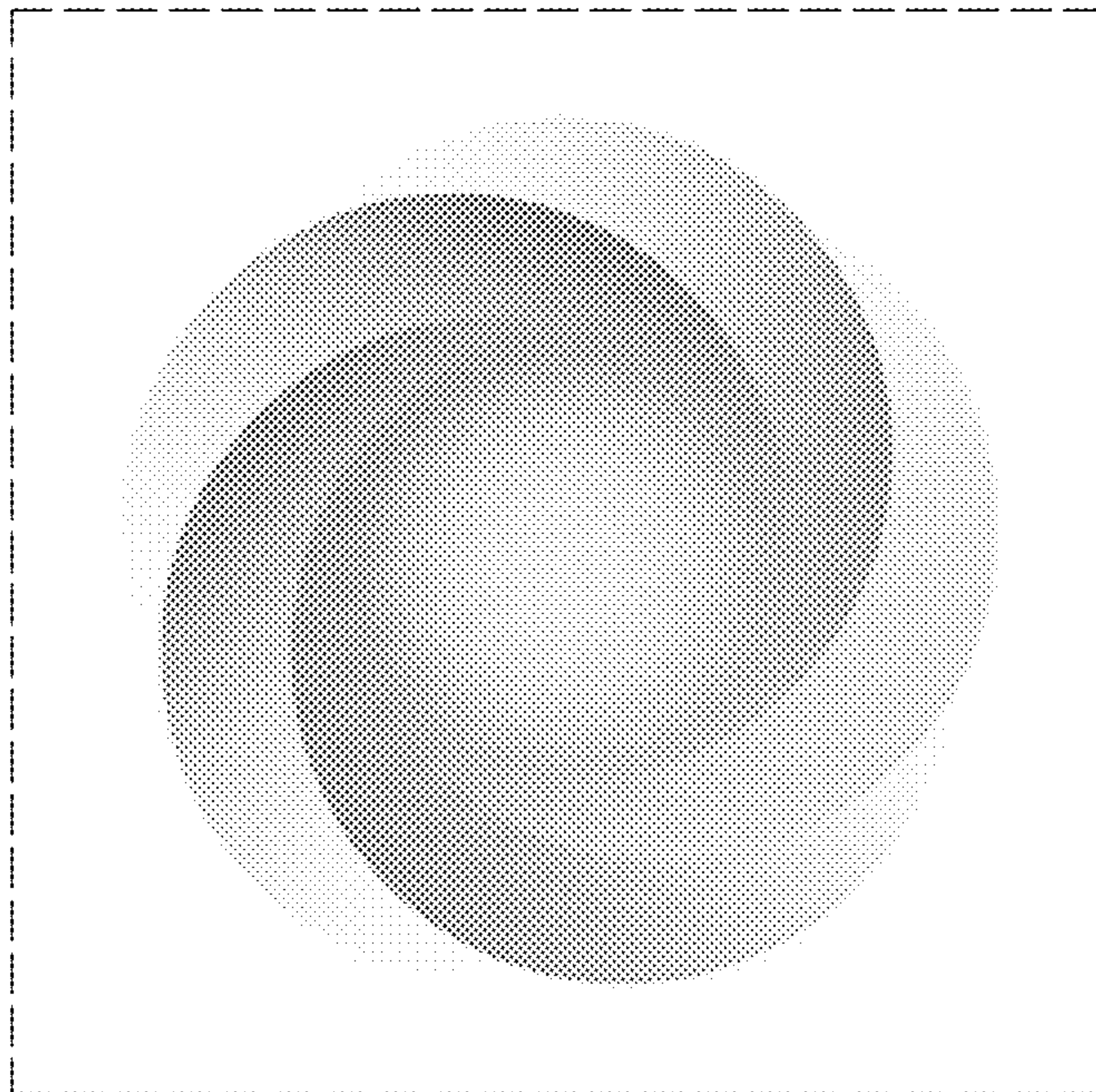

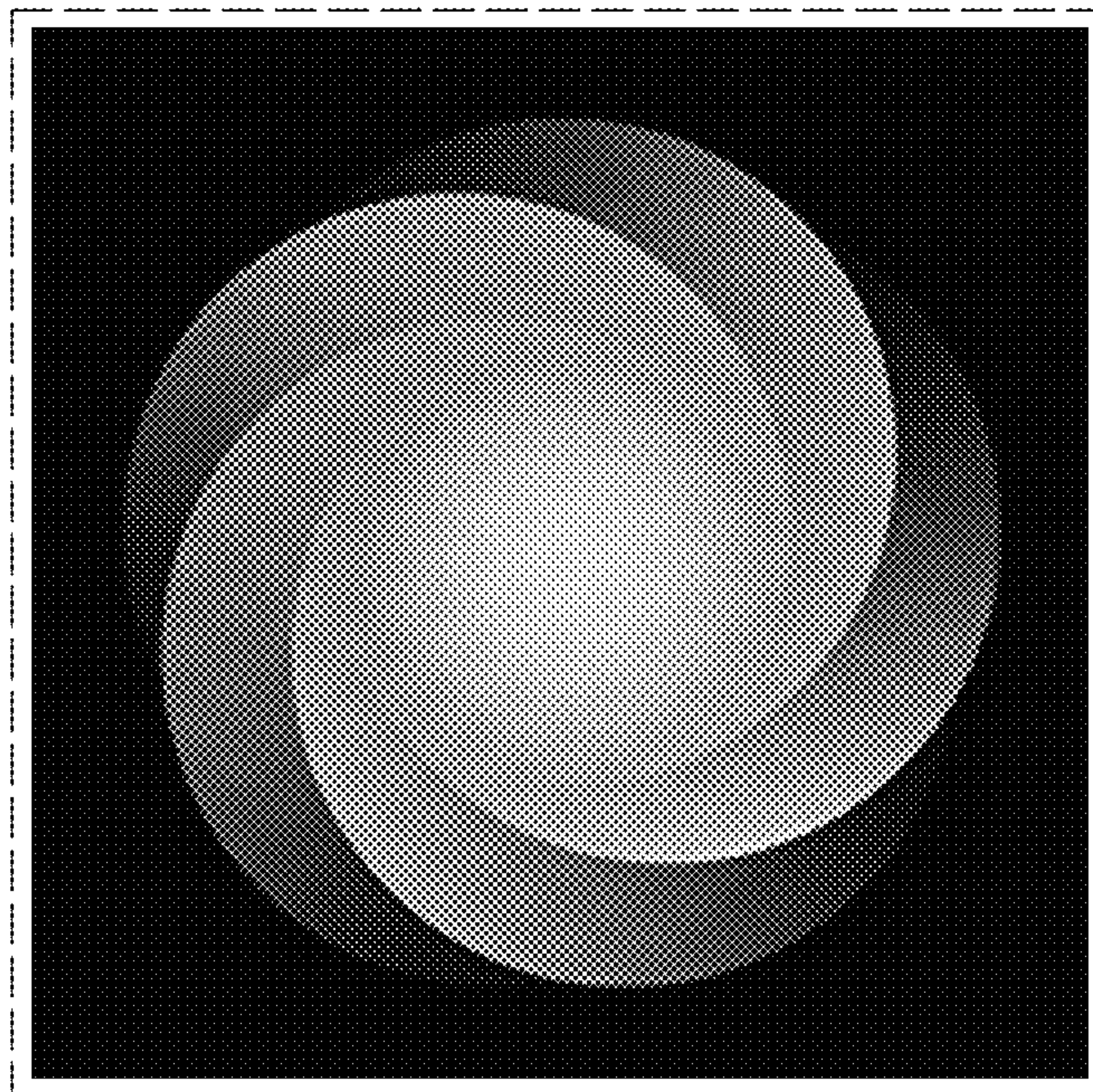
