FIG. 4 is an exploded isometric rear view thereof along line 2-2.

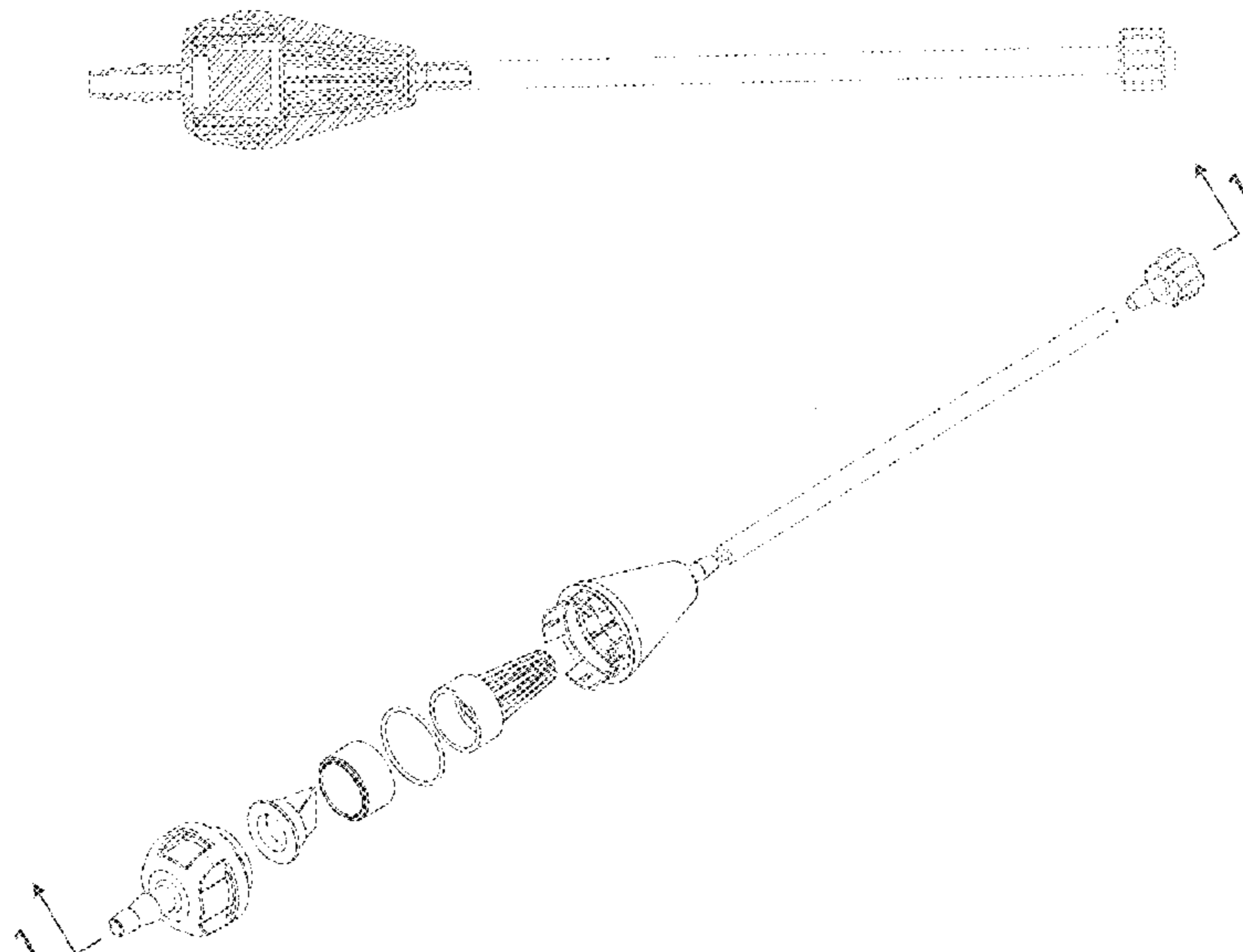
The broken lines represent environment and form no part of the claimed design.

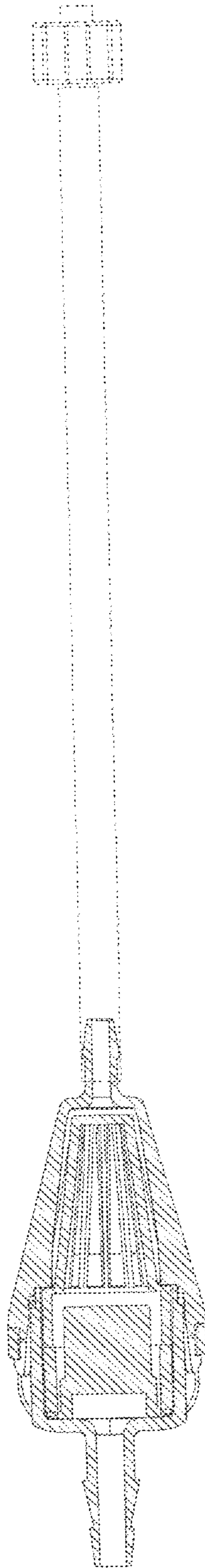

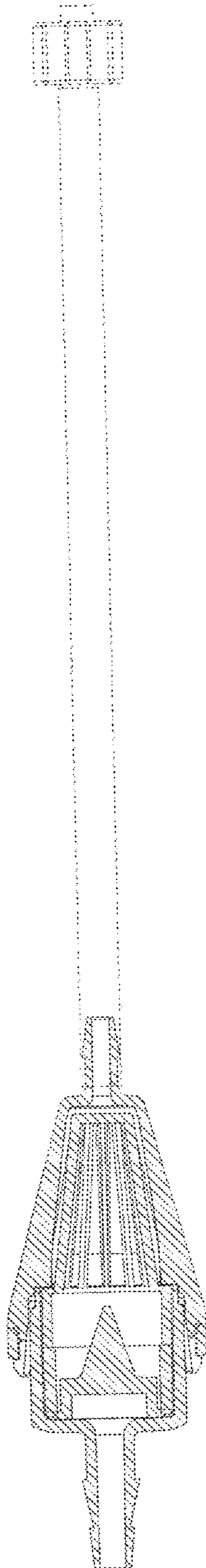

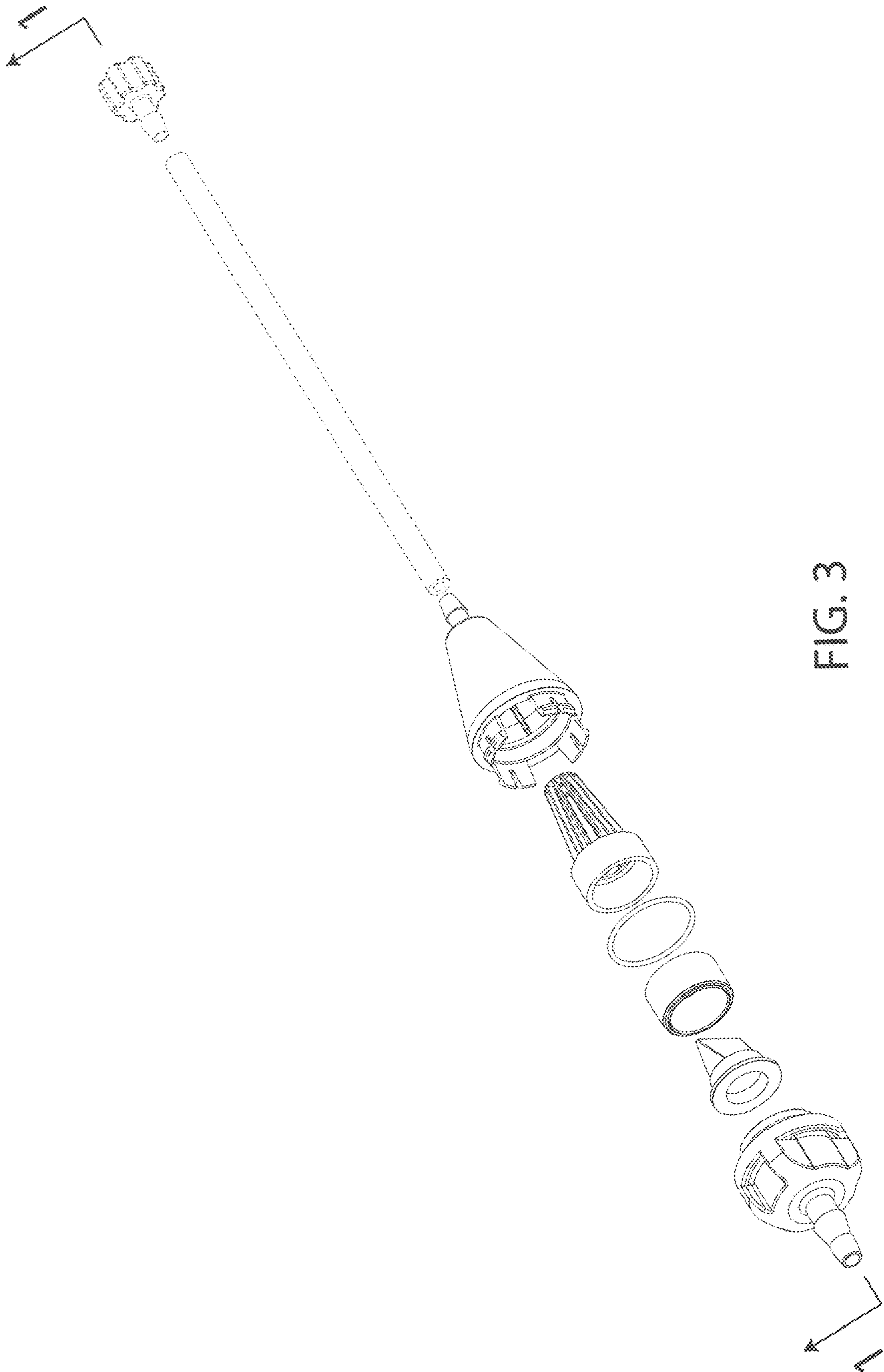

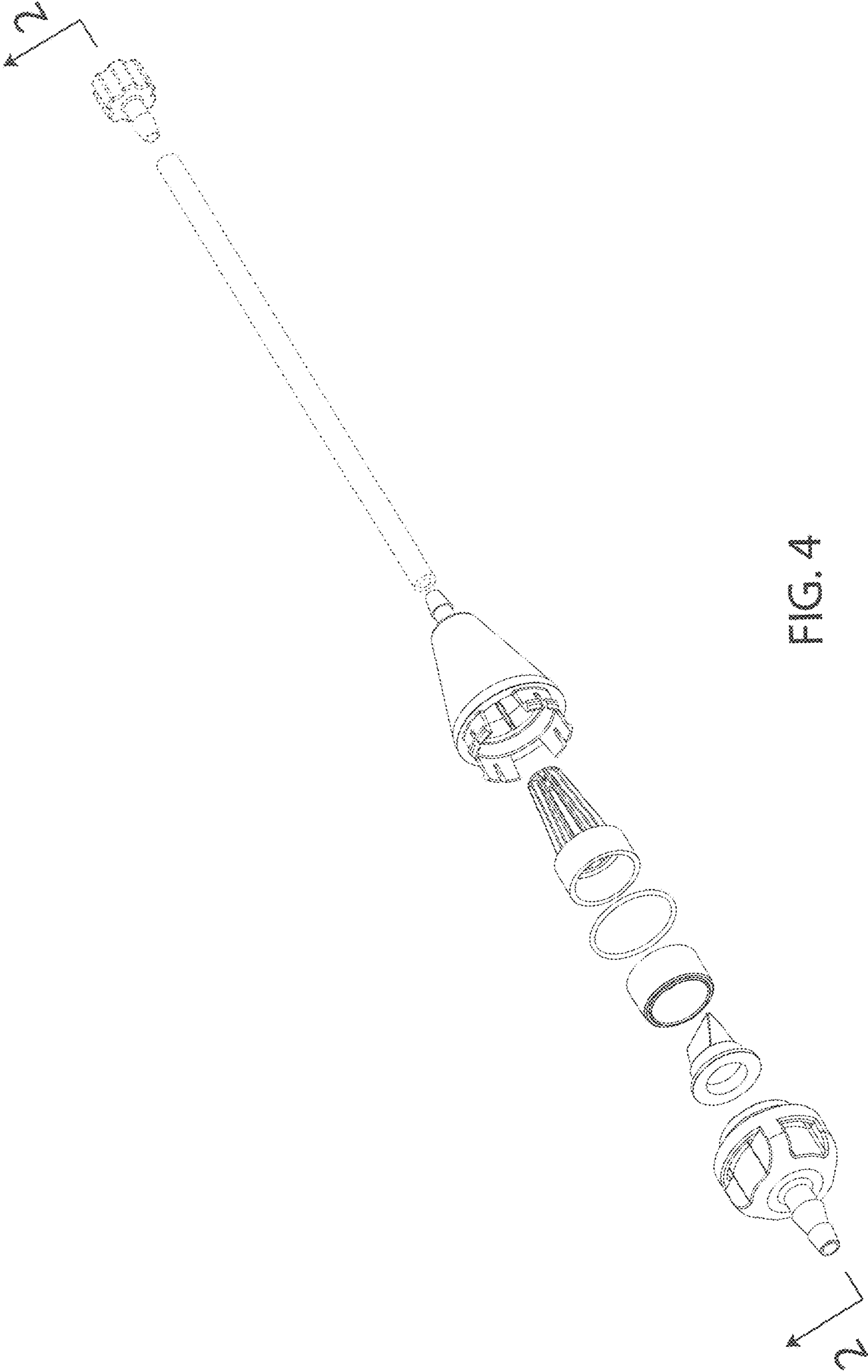
